DESCRIPTION

FIG. 1 is an inverted rear elevational view of an apron showing my new design;

 FIG. 6 is a right side elevational view of FIG. 3.

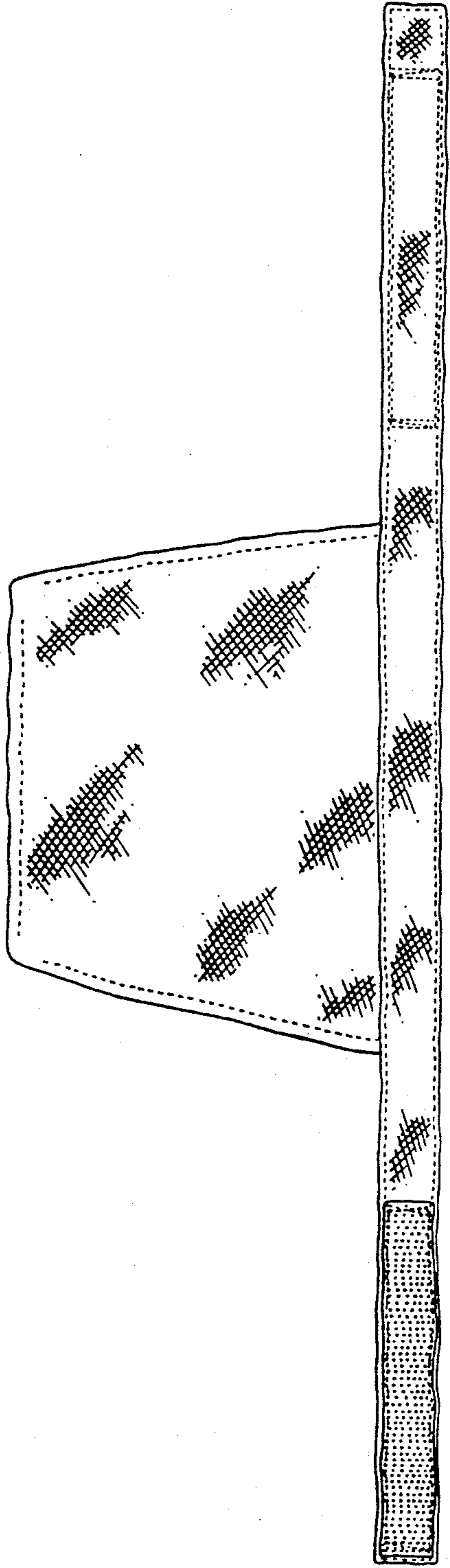

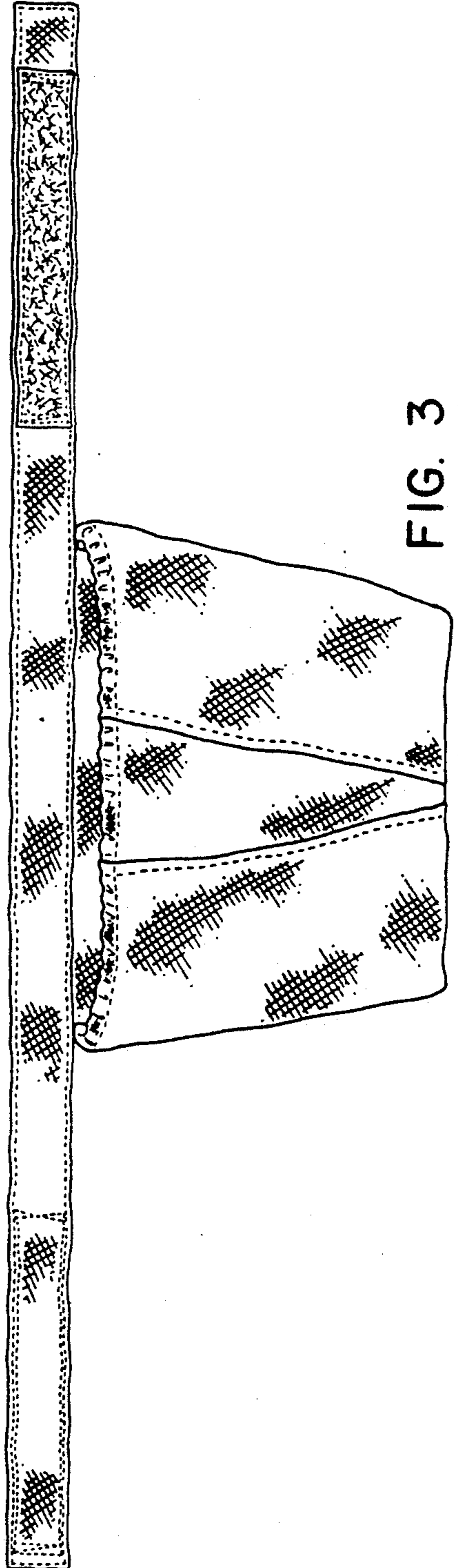

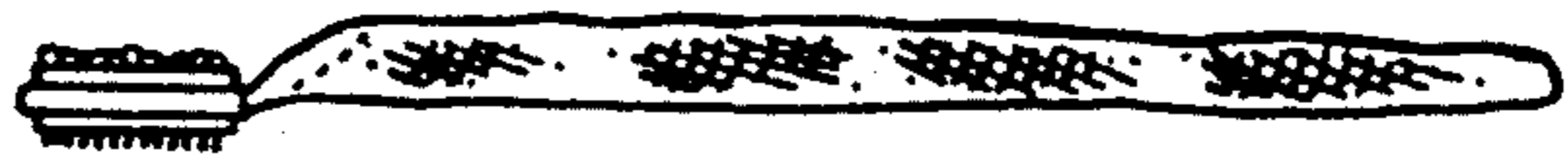
