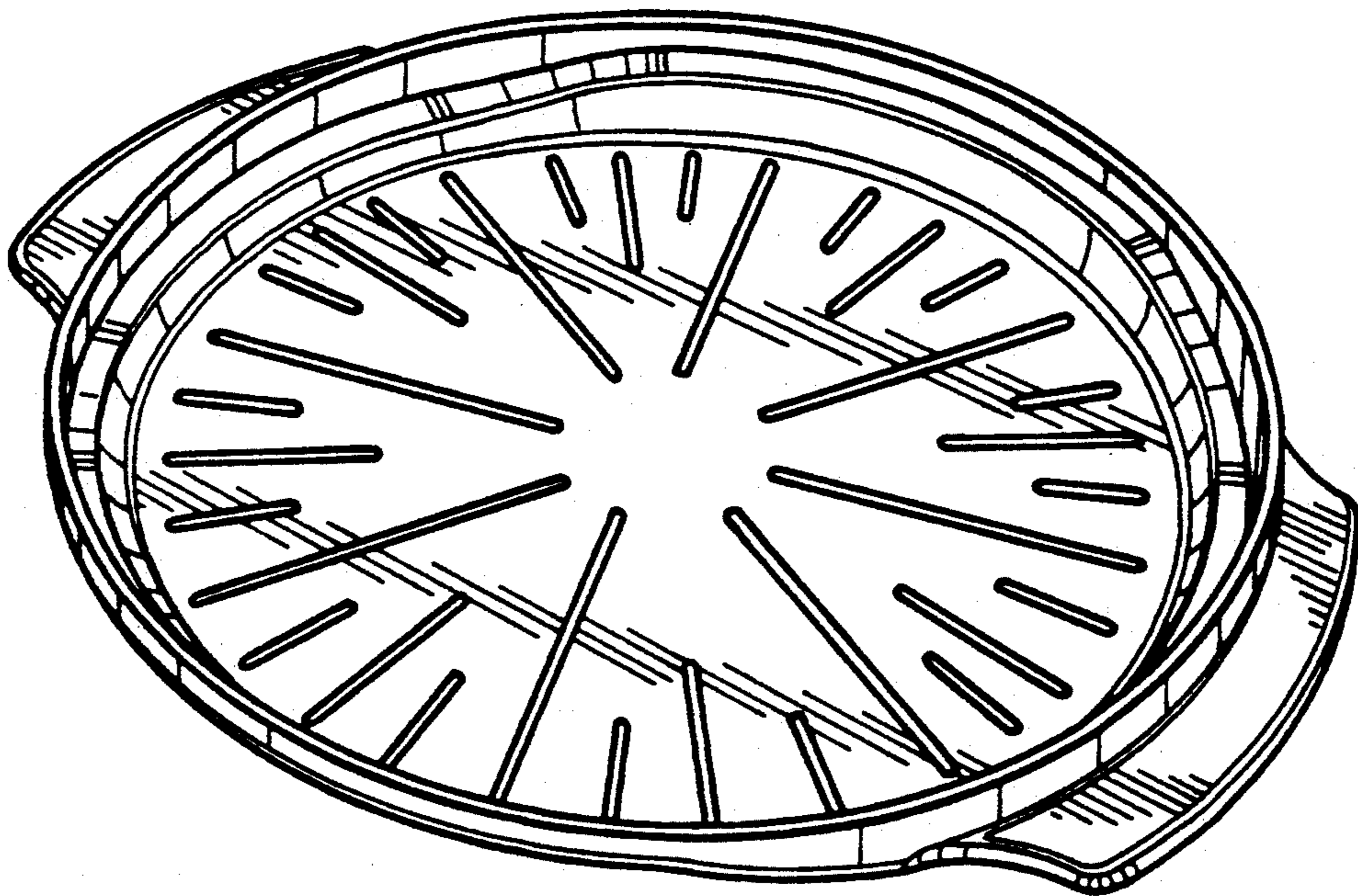

[57] CLAIM

The ornamental design for a slotted dish, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a slotted dish showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side elevational view, the right side elevational view being a mirror image thereof;  
FIG. 5 is a front elevational view, the rear elevational view being a mirror image thereof;  
FIG. 6 is a cross-sectional view thereof taken along line 6—6 of FIG. 2; and,  
FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 2.



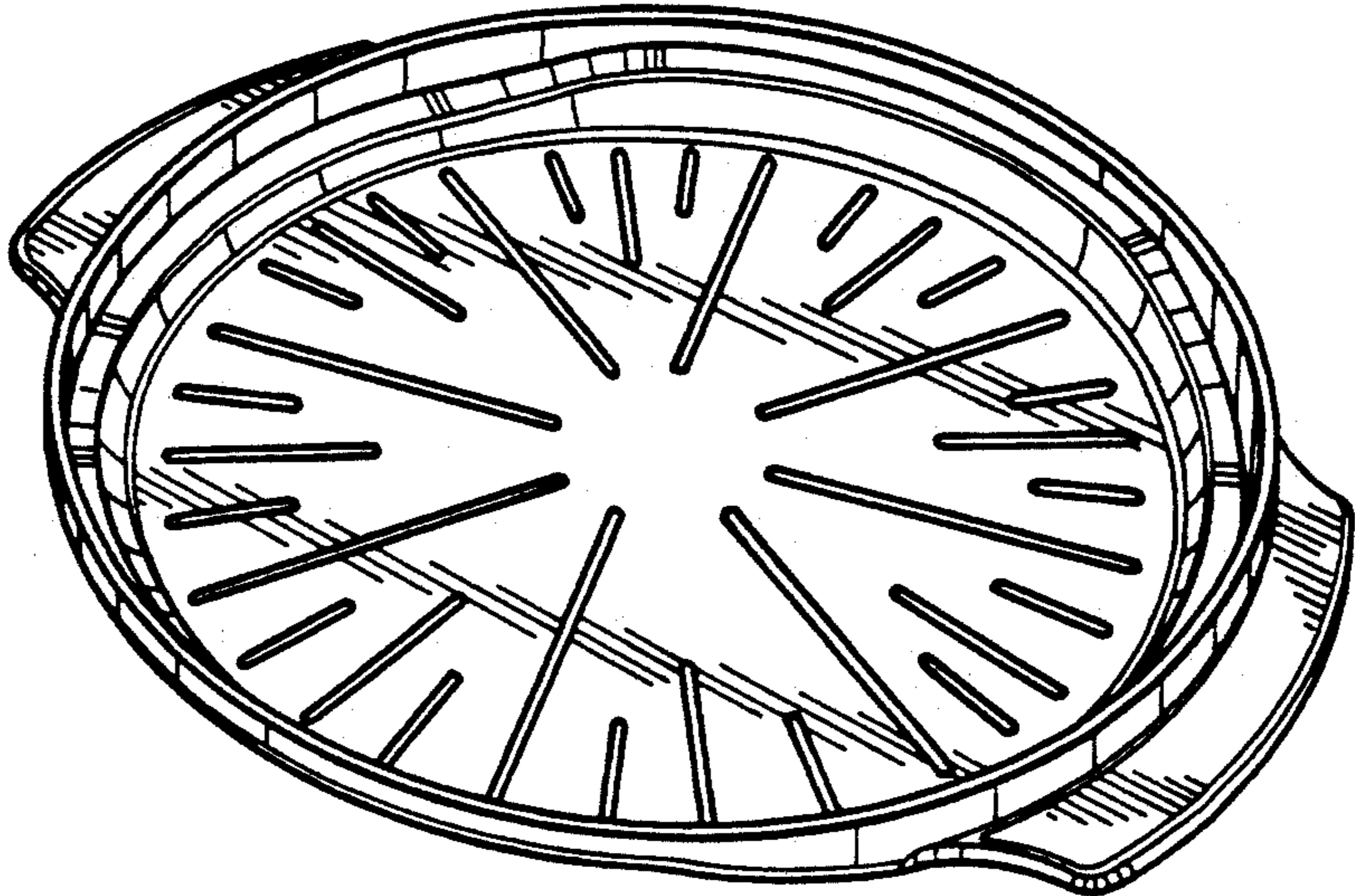

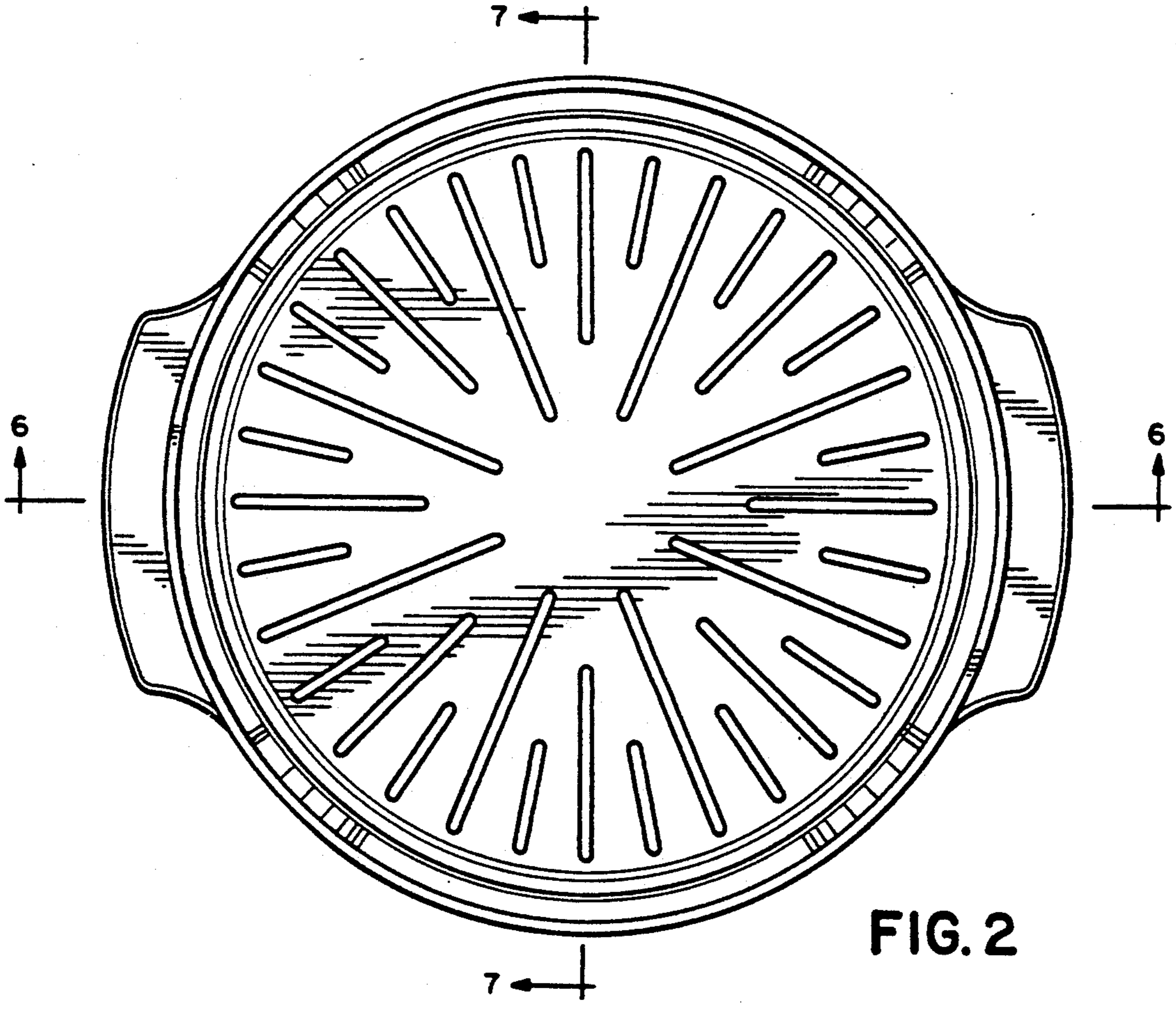

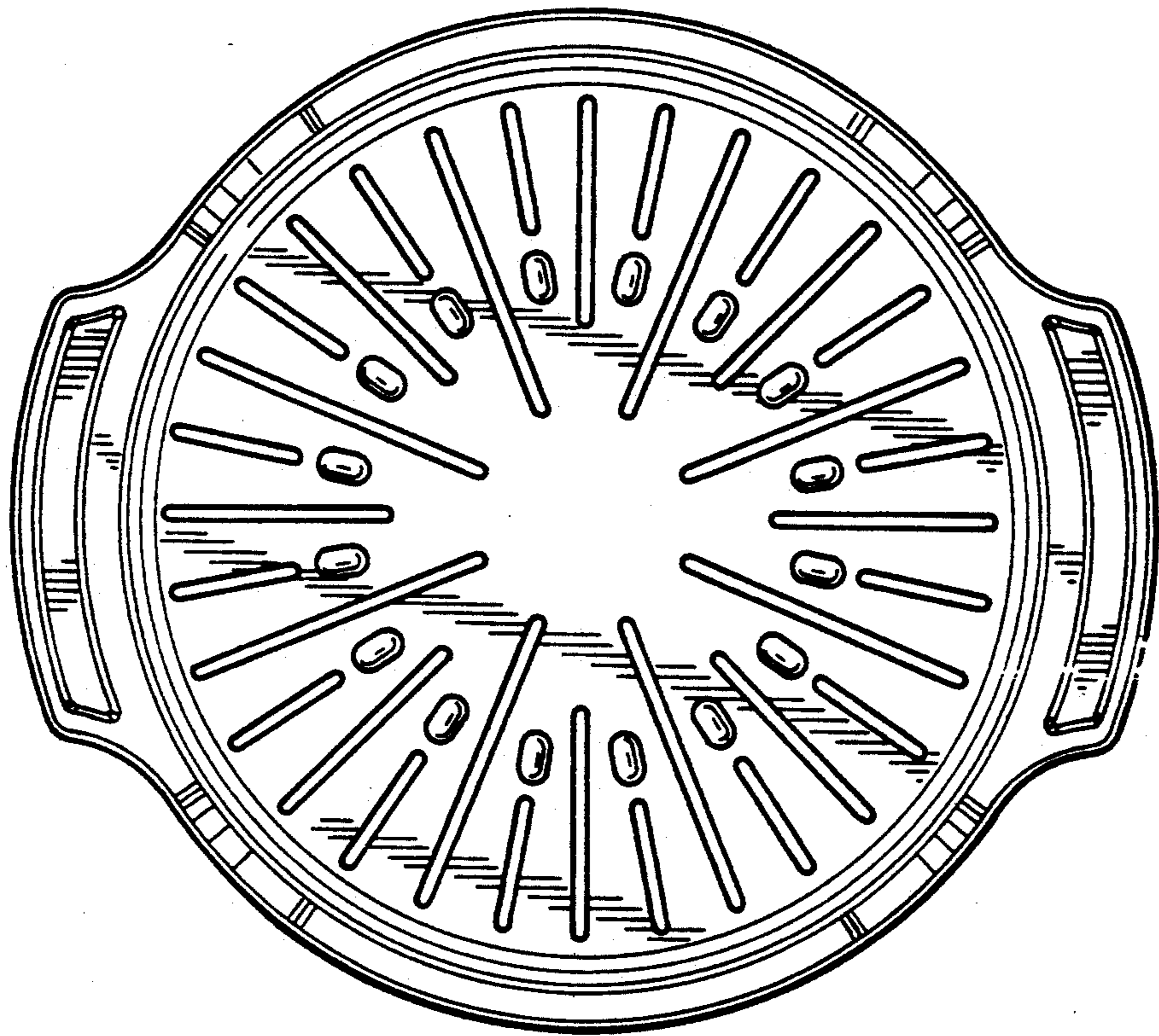

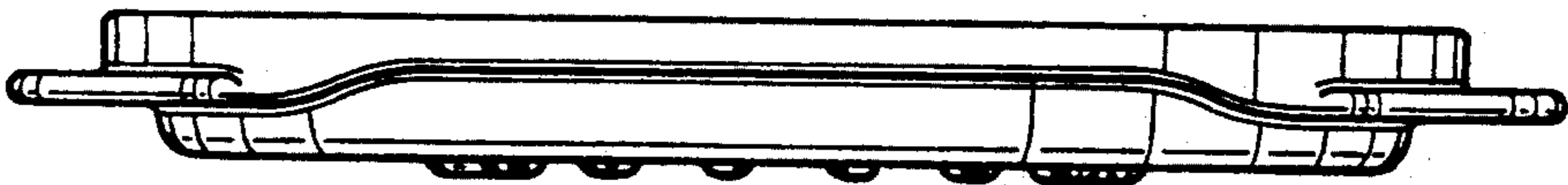

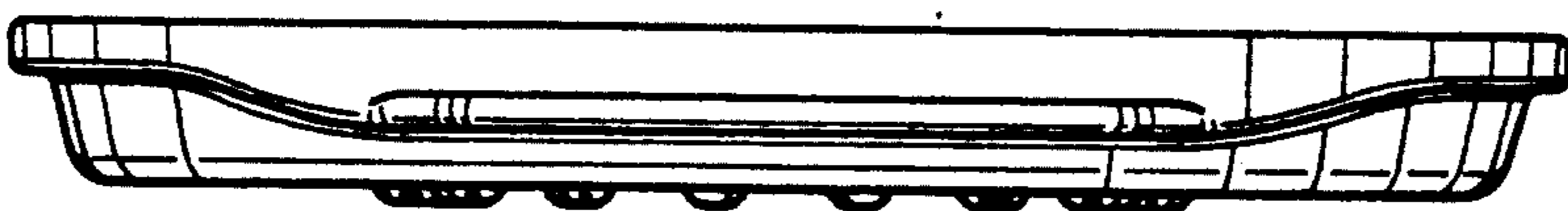

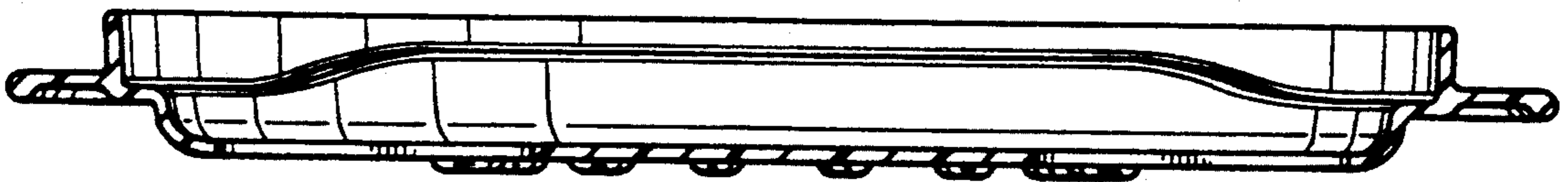

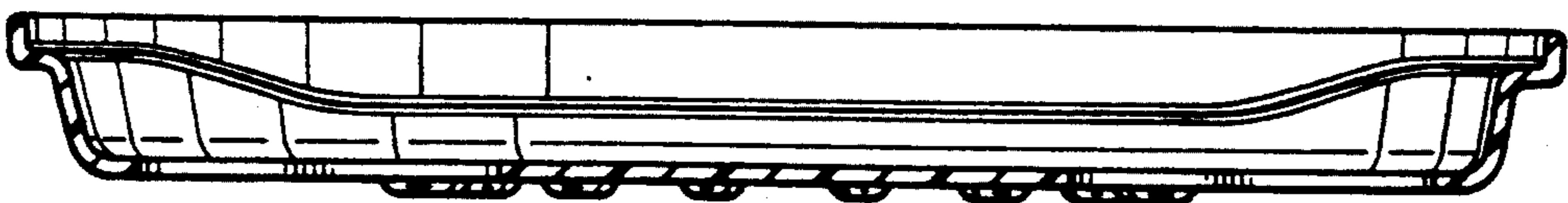
