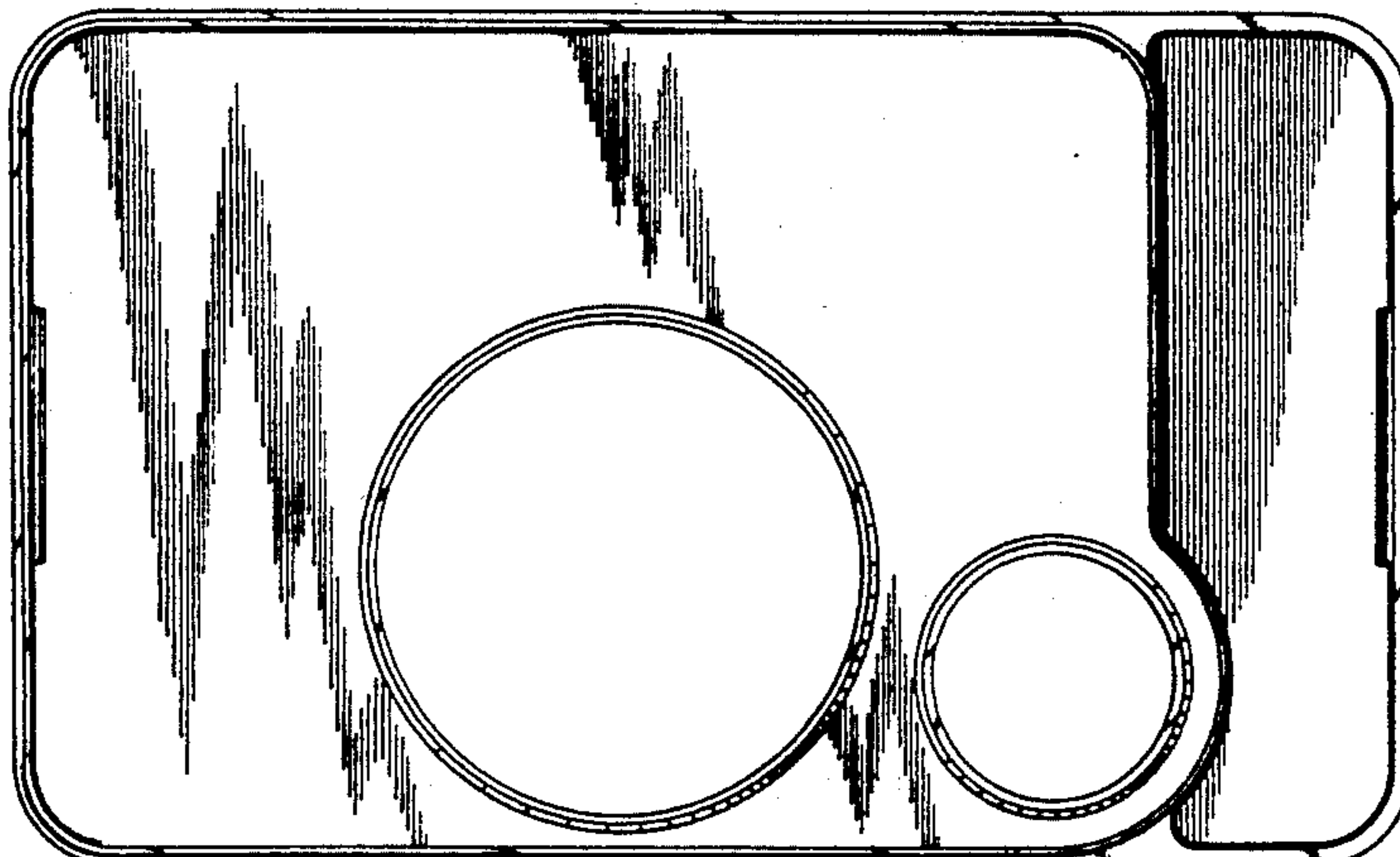

[57] CLAIM

The ornamental design for a tray, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a tray showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof; and,
 FIG. 7 is a top plan view of a tray showing a second embodiment of my new design. The bottom plan view and the front, rear, left, and right side elevational views of the second embodiment being substantially the same as that shown in the first embodiment, the only difference being the added circular element.

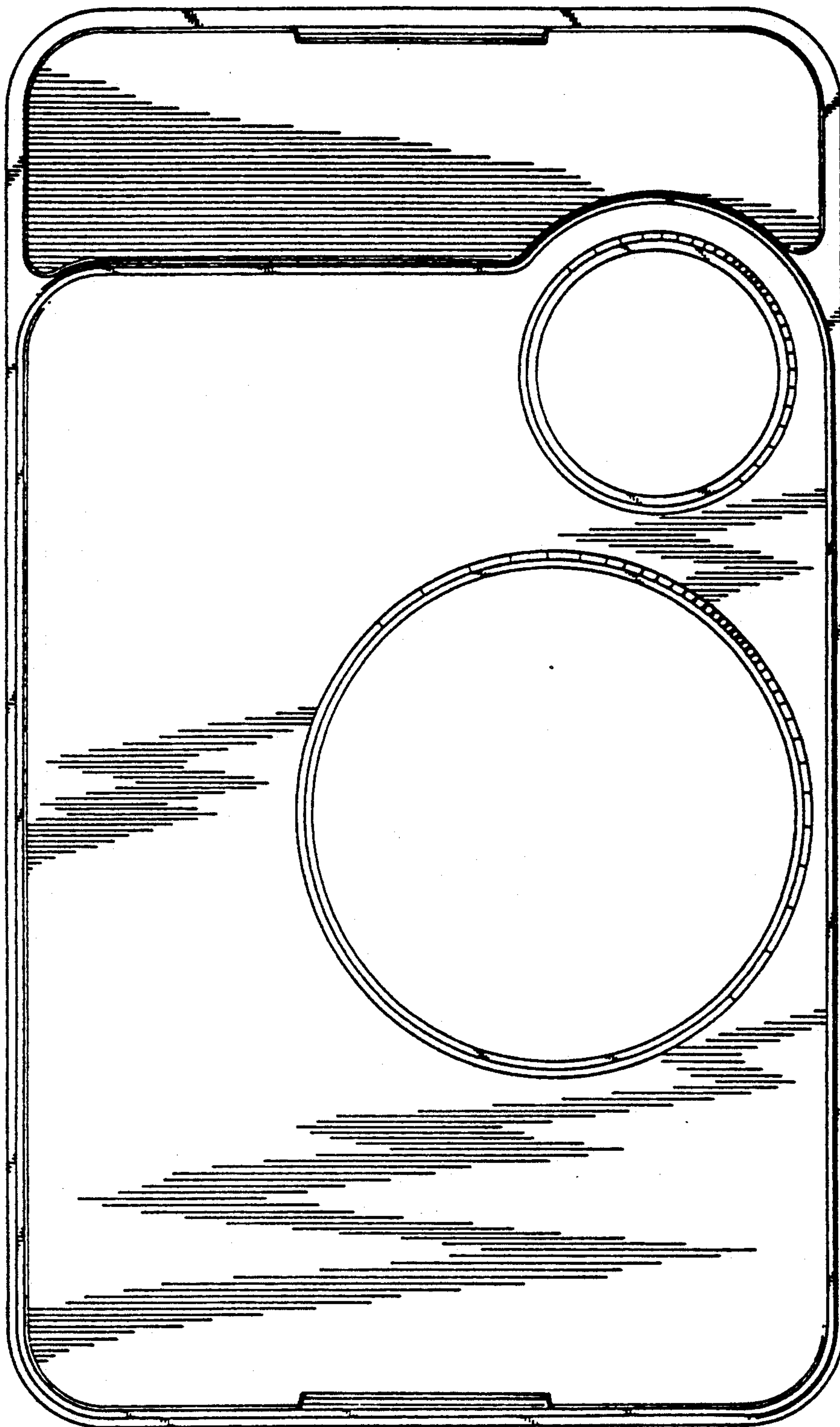

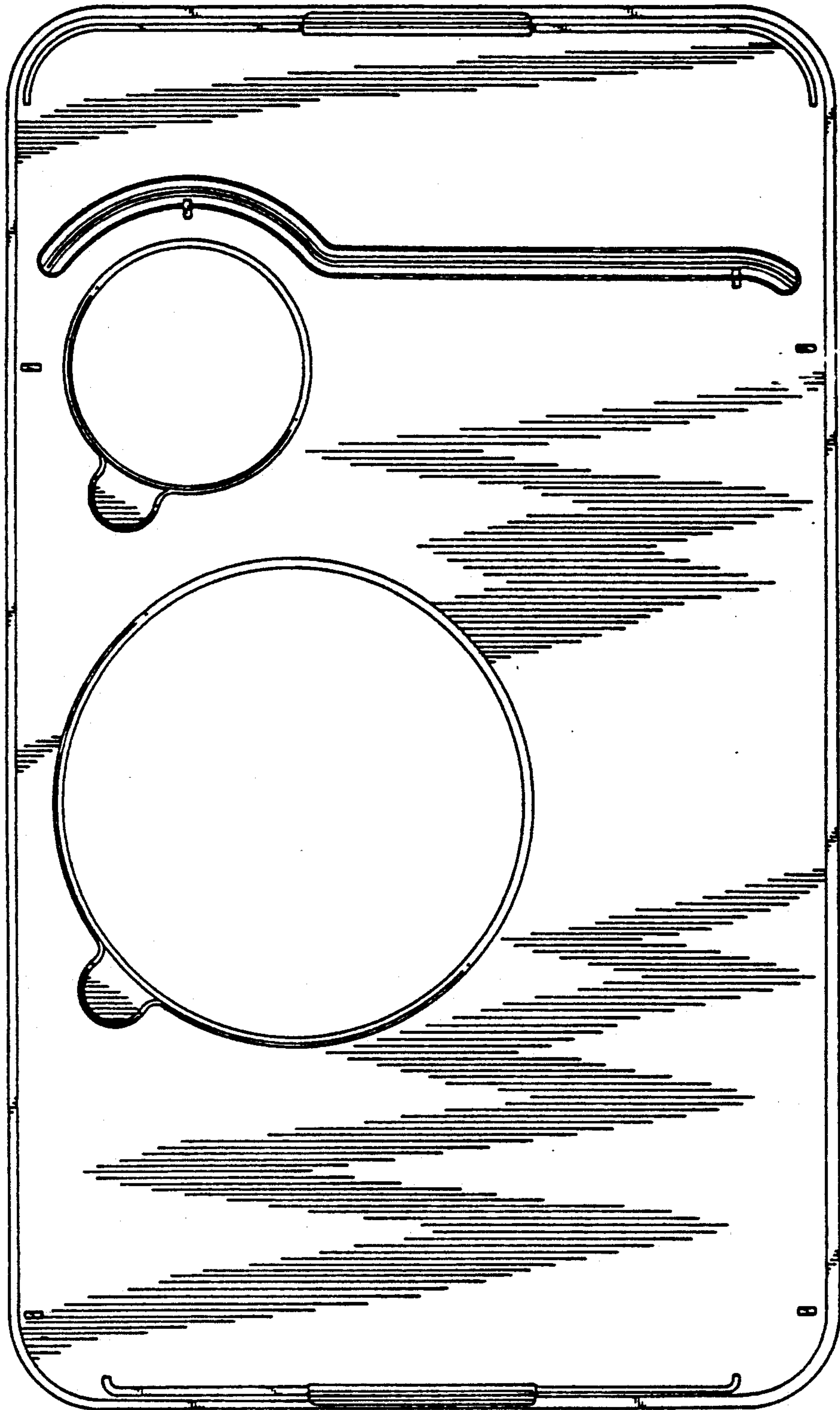

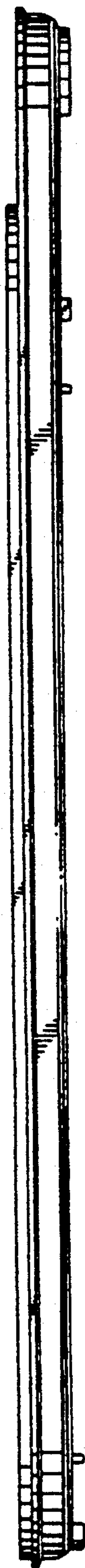

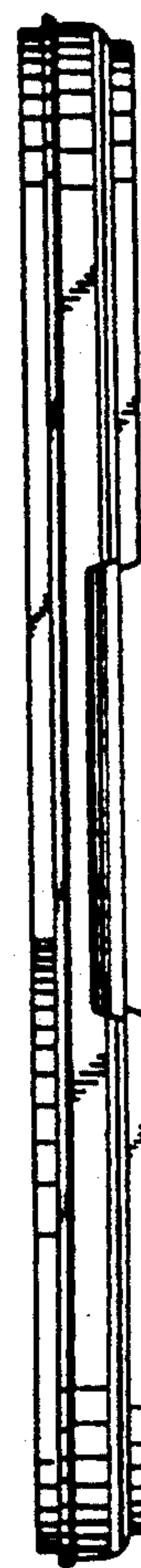
