The ornamental design for a nozzle for dispensing adhesives, sealants and caulks, as shown and described.

**DESCRIPTION**

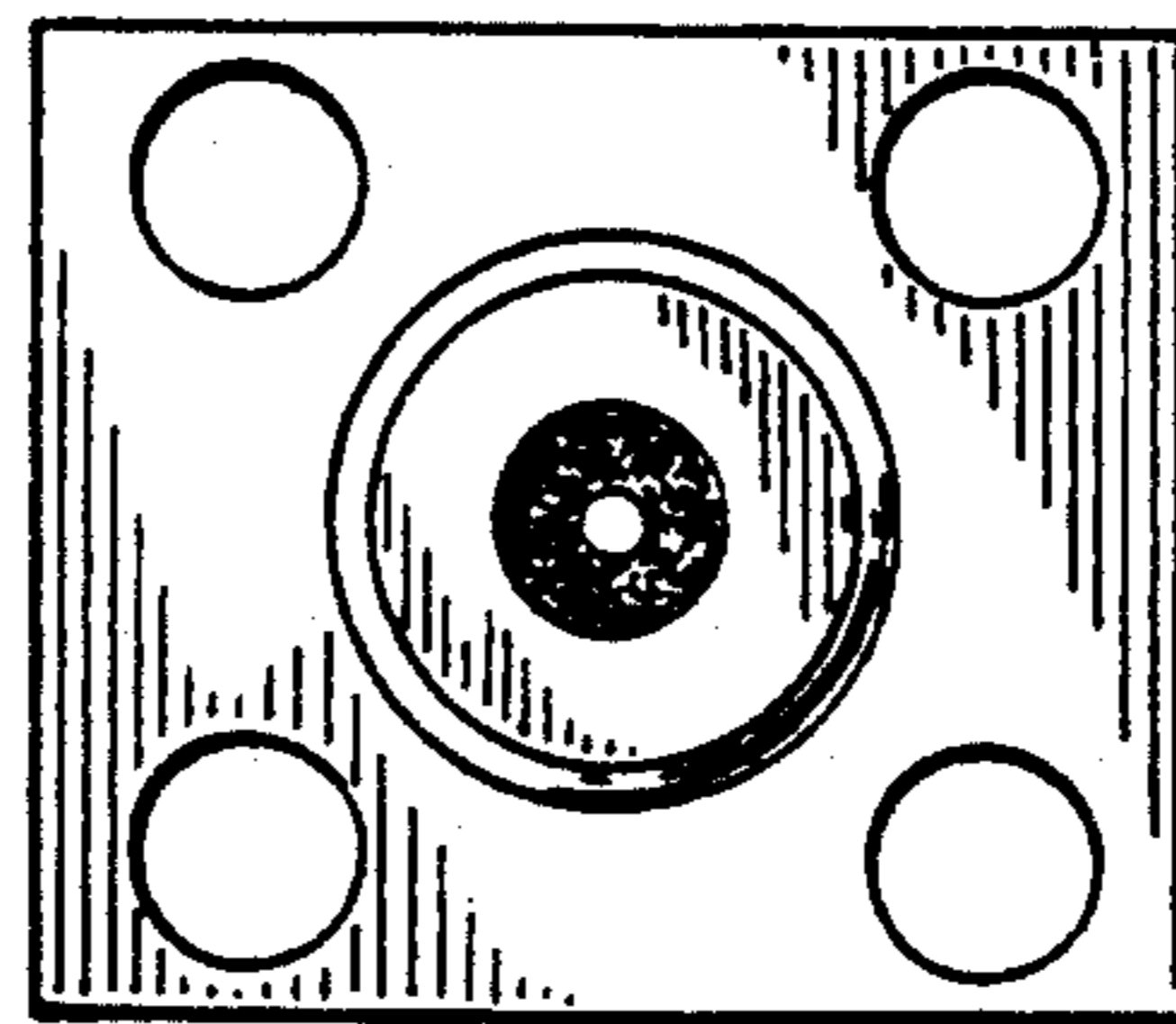
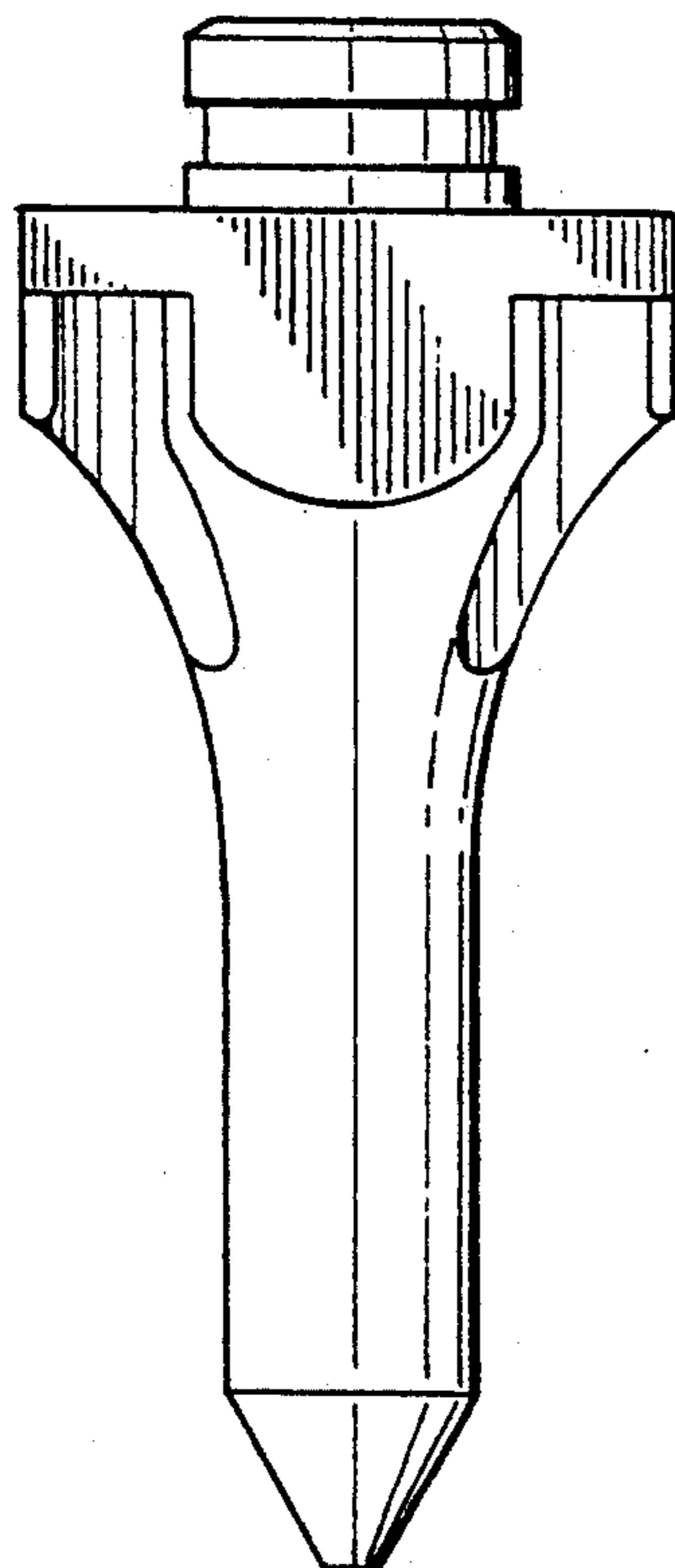
FIG. 1 is a front, elevational view of a new design for a nozzle for dispensing adhesives, sealants and caulks shown in solid lines, the dot-dashed ghost lines representing a dispensing module, such as a hot melt dispenser, are shown for the purpose of illustrating the environment only;

FIG. 2 is an enlarged, front, elevational view of the nozzle, the rear view being a mirror image thereof.

FIG. 3 is a top plan view;

FIG. 4 is a bottom plan view; and,

FIG. 5 is a side, elevational view, the opposite side being a mirror image thereof.



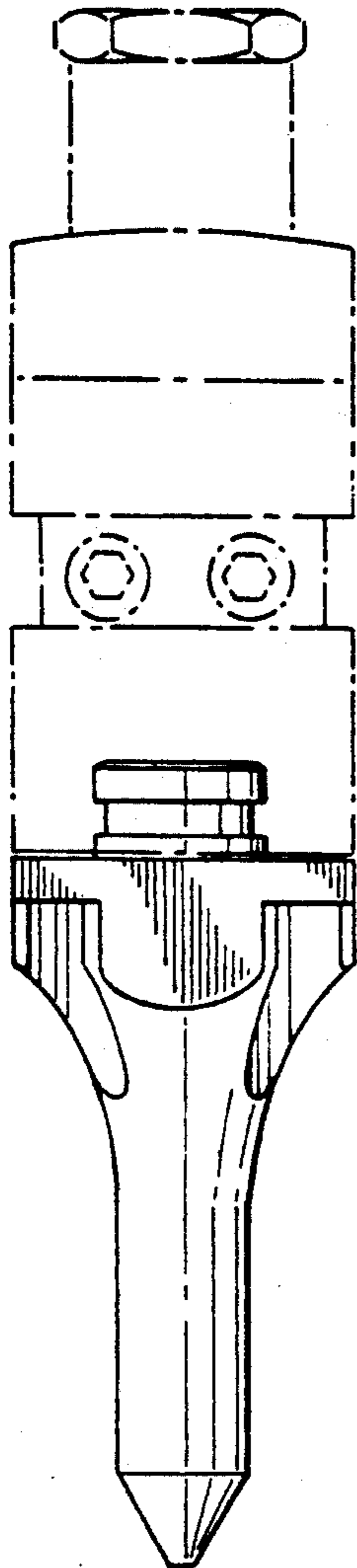

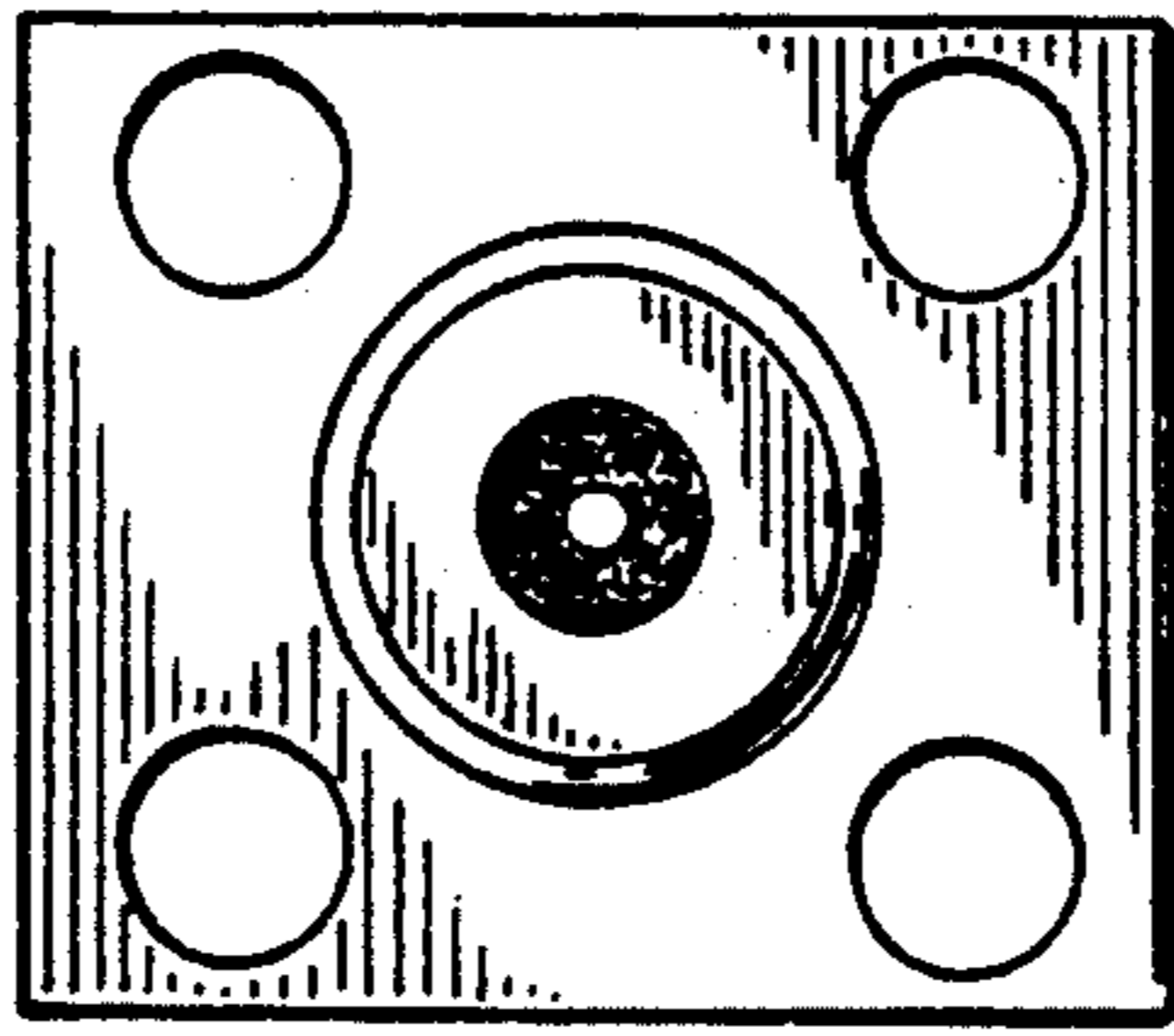

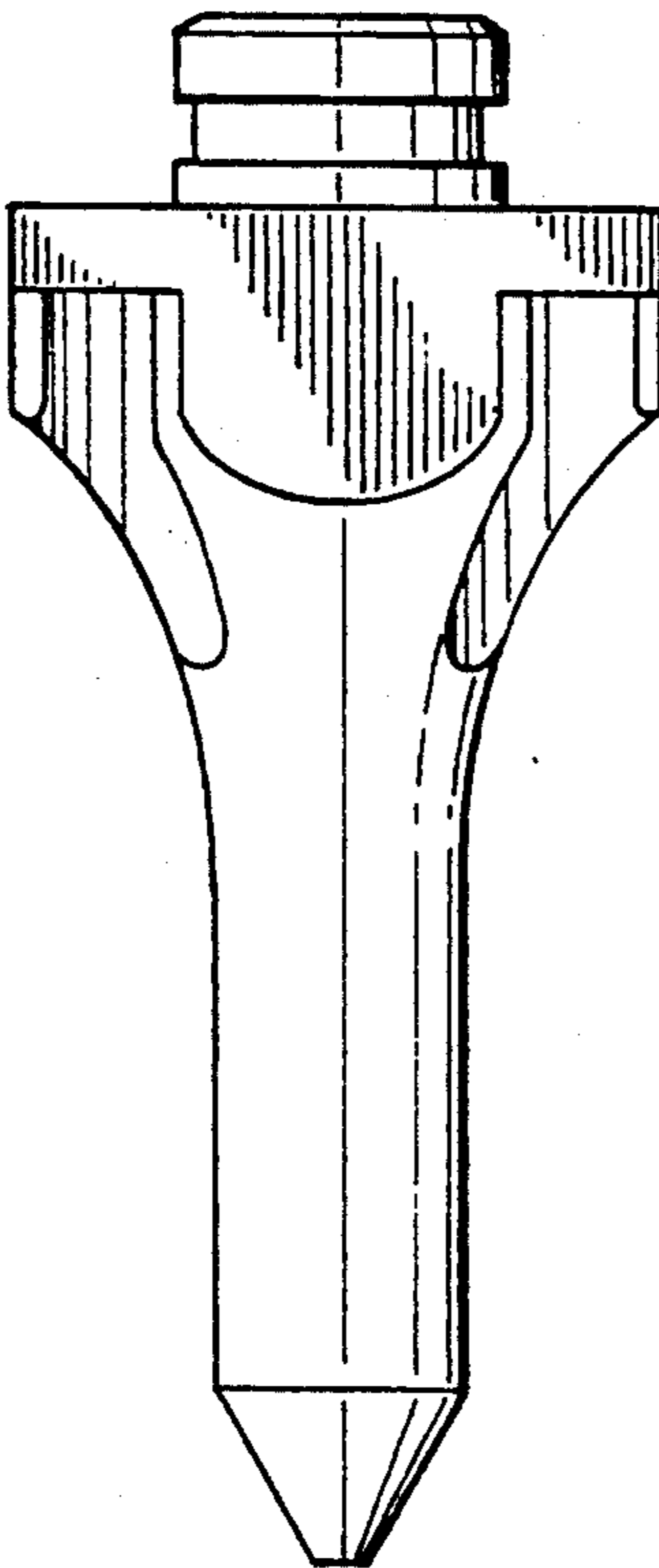

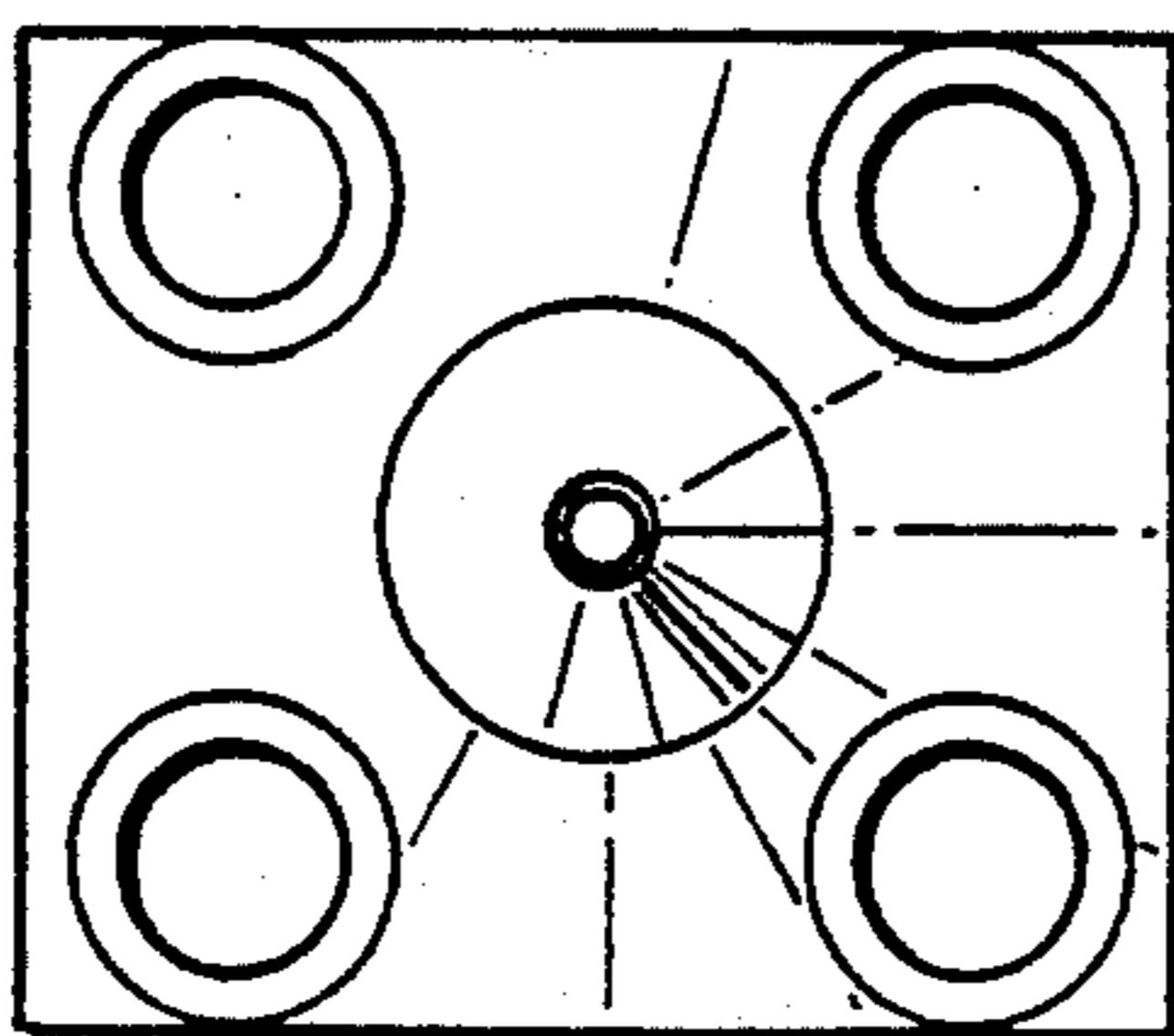

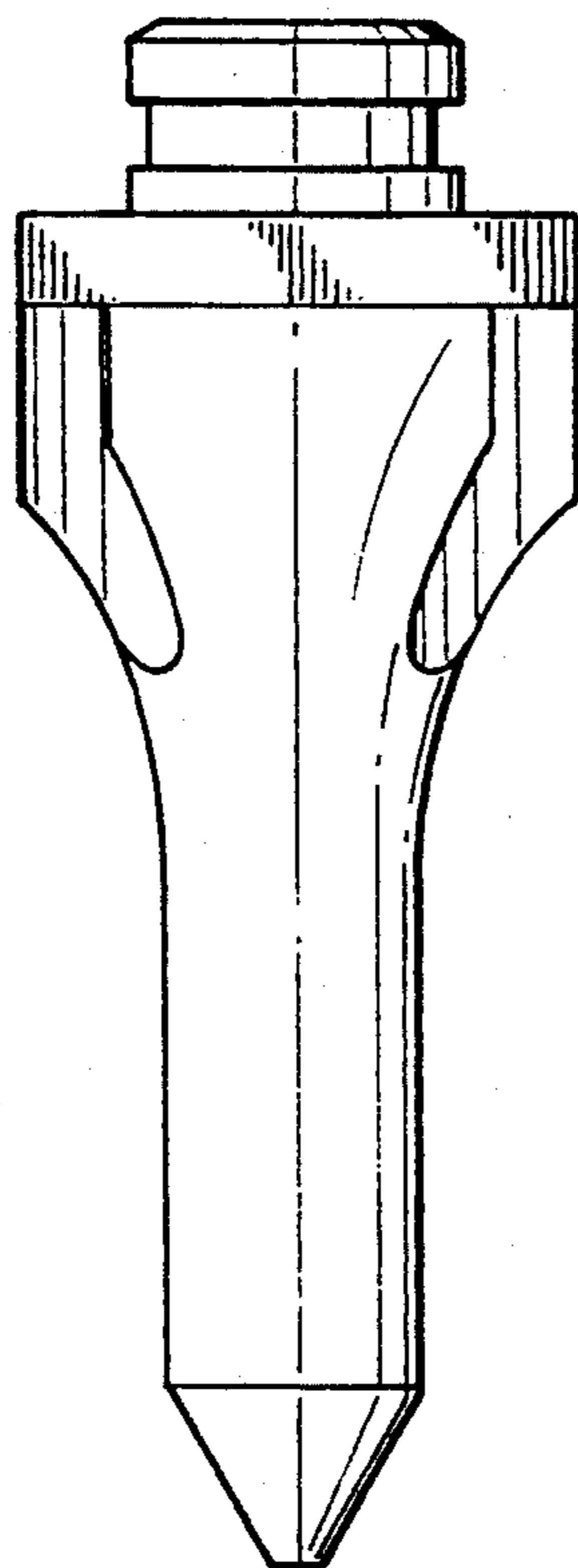
