 FIG. 9 is a sectional view taken along the lines 9—9 of FIG. 7;
 FIG. 10 is a partial sectional view taken along the lines 10—10 of FIG. 7;
 FIG. 11 is a top plan view of a jewelry chain showing a third embodiment of my new design;
 FIG. 12 is a partial enlarged top plan view of FIG. 11;
 FIG. 13 is a side elevational view of FIG. 12;
 FIG. 14 is a sectional view taken along the lines 14—14 of FIG. 12; and,
 FIG. 15 is sectional view taken along the lines 15—15 of FIG. 12.
 The opposite side views of the jewelry chains of FIGS. 2, 7, and 12 are identical to the side views 3, 8, and 13, respectively, of the jewelry rope chain.

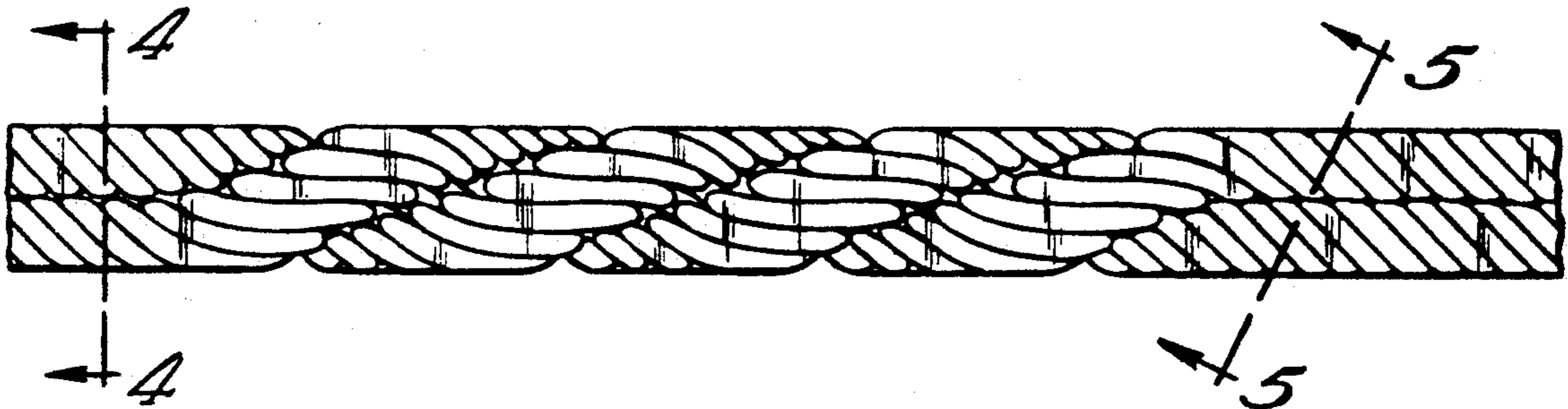

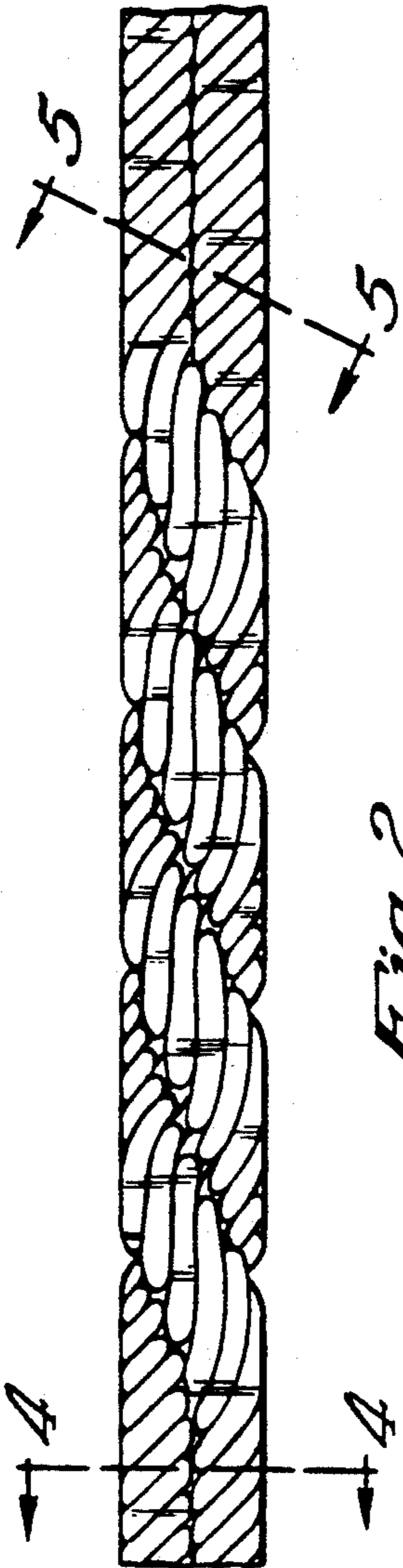

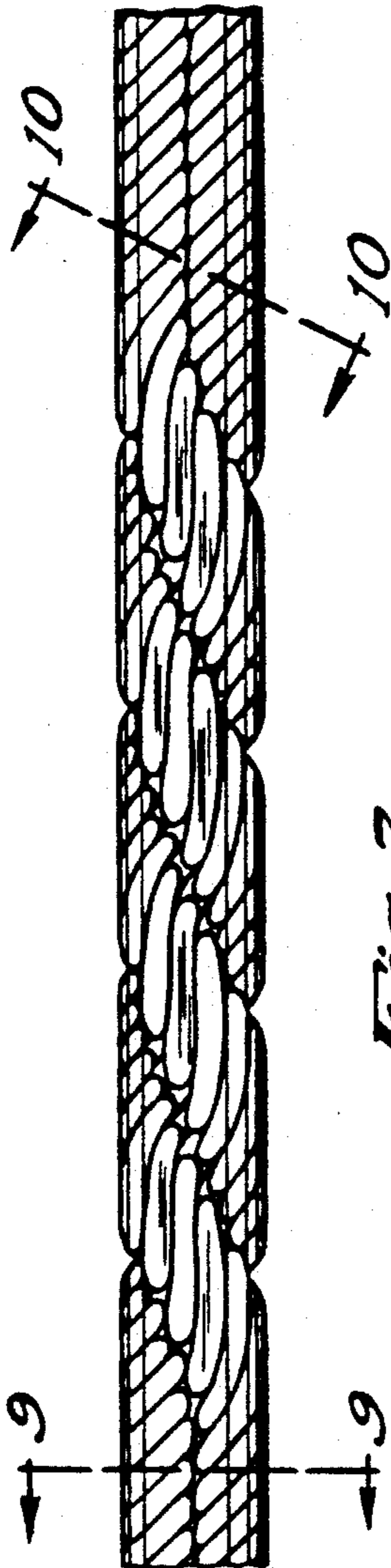

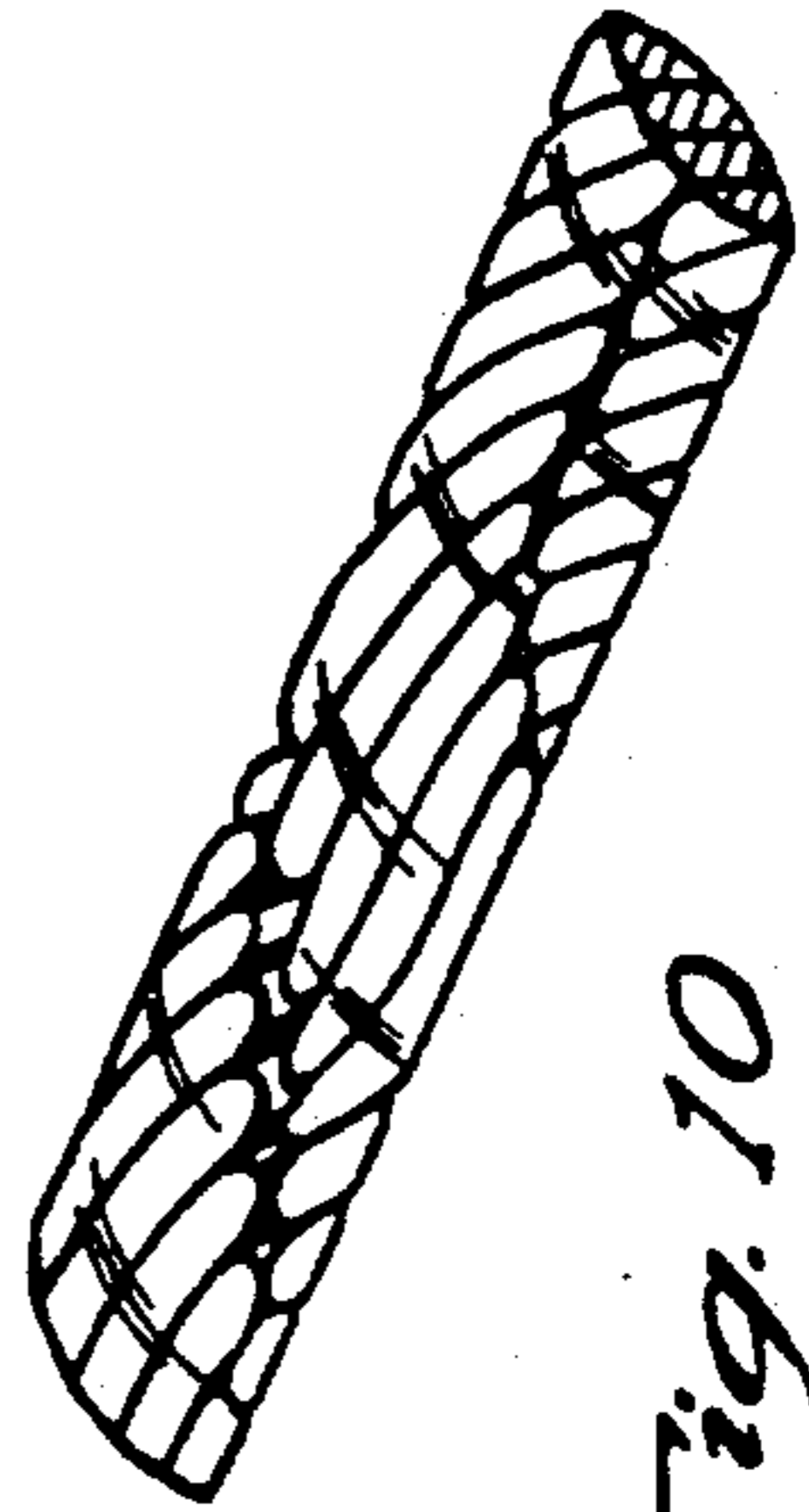

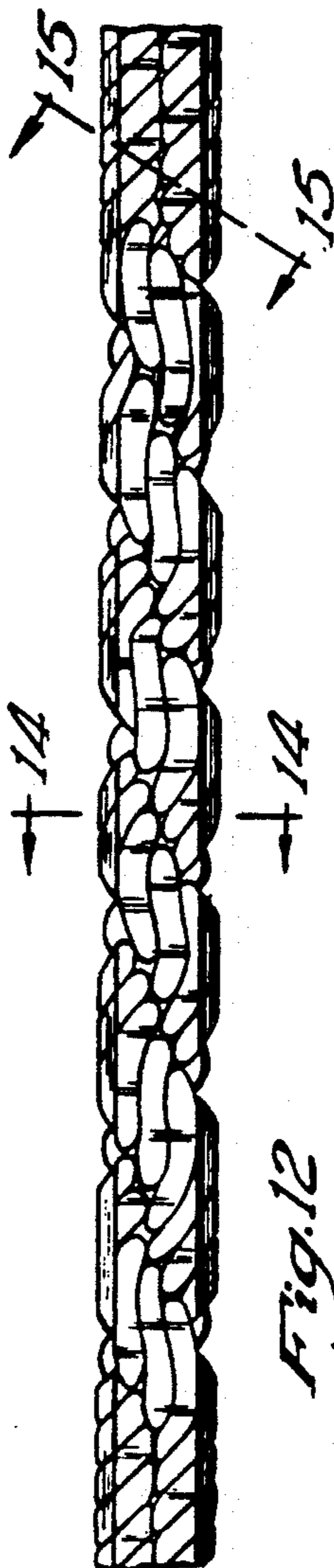
