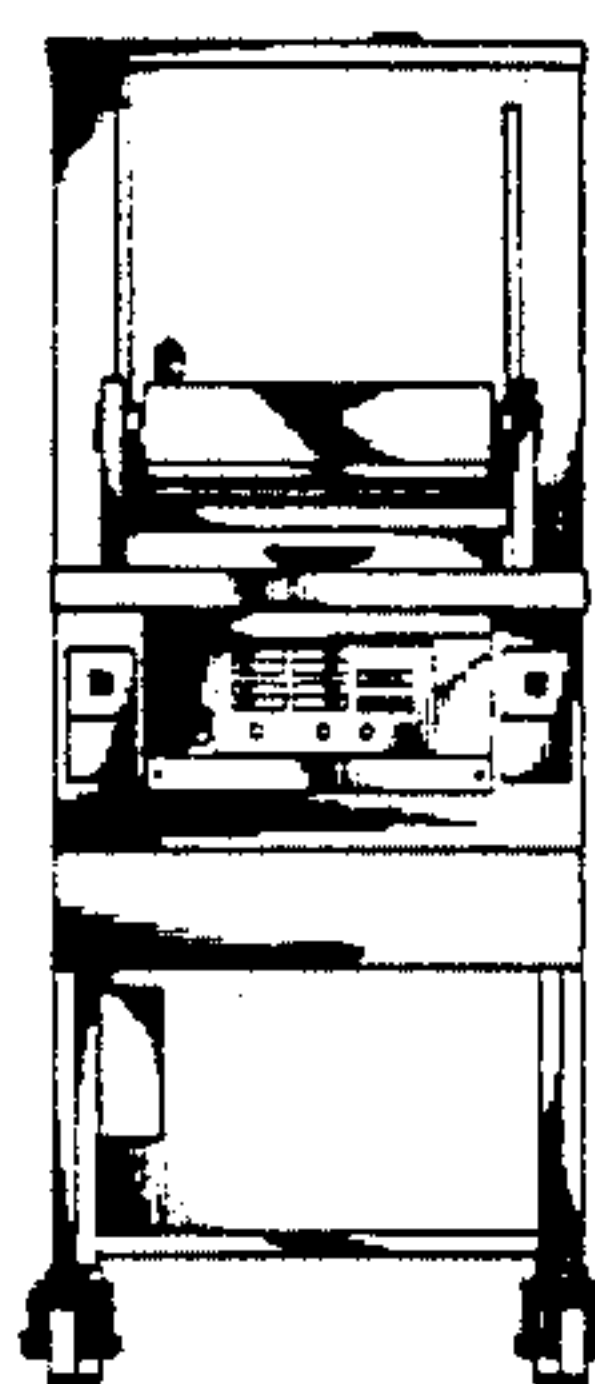
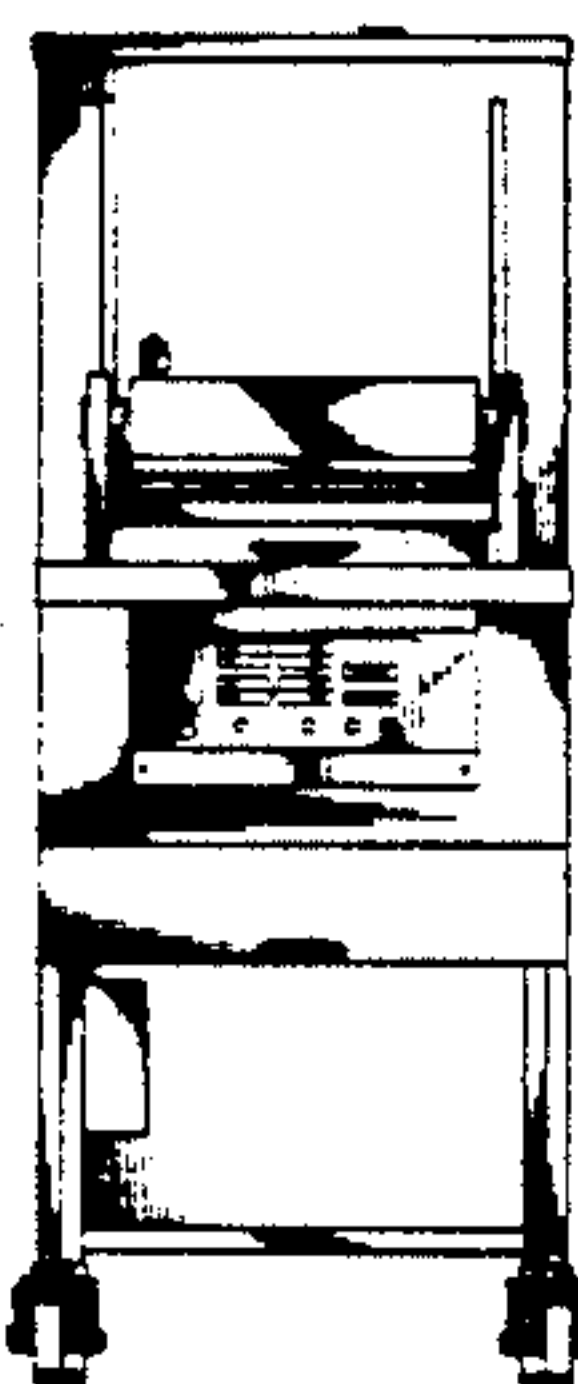
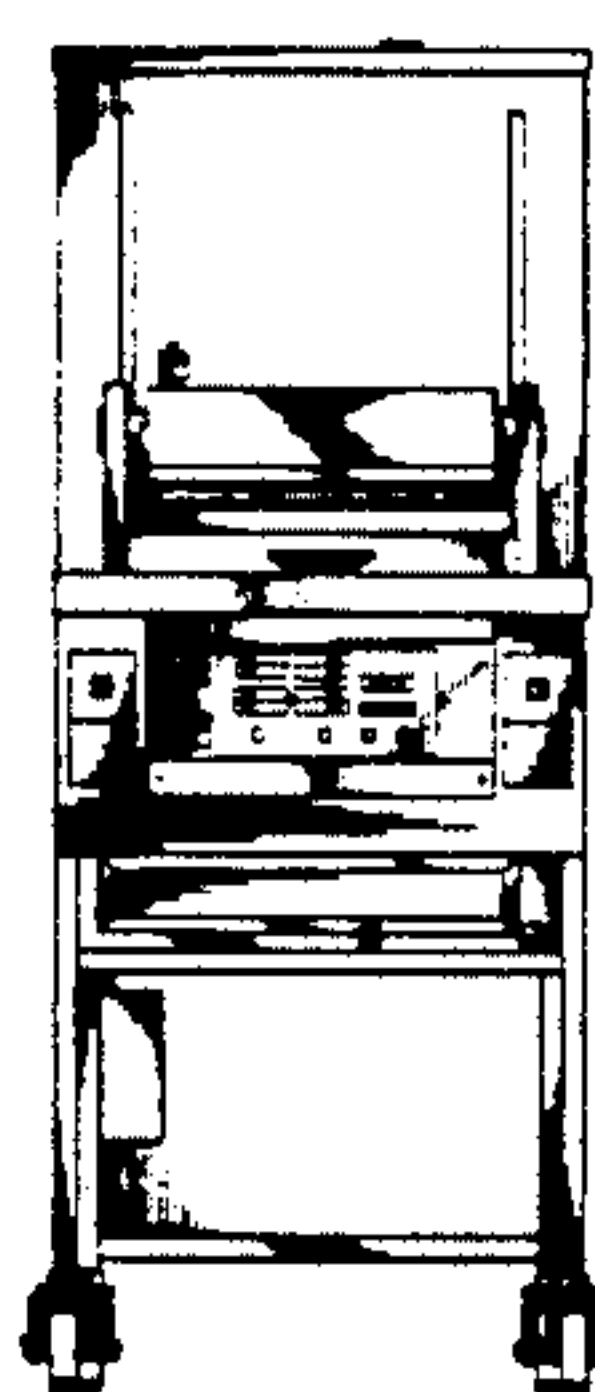
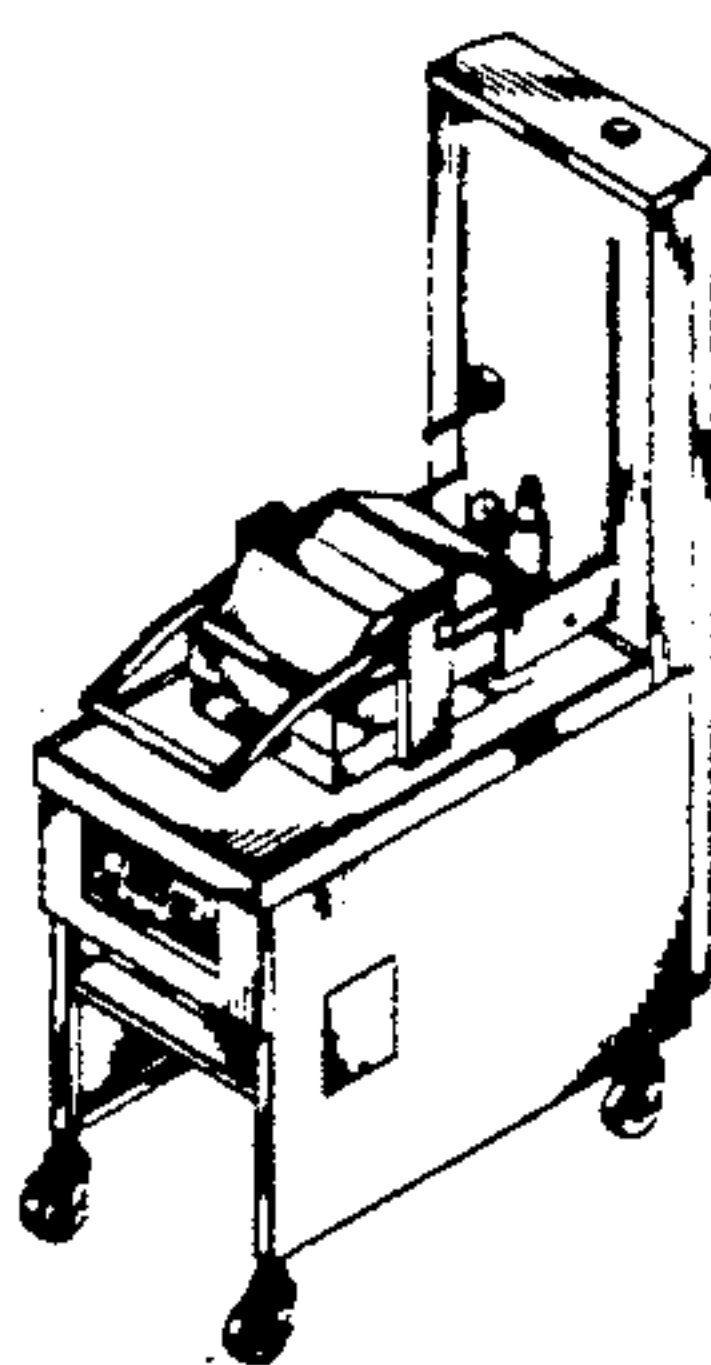
[57] **CLAIM**

The ornamental design for a large capacity pressure cooker, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a large capacity pressure cooker showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top, front and right side perspective view thereof; FIG. 7 is a front elevational view of a second embodiment thereof; FIG. 8 is a left side elevational view thereof; FIG. 9 is a right side elevational view thereof; FIG. 10 is a top plan view thereof; FIG. 11 is a front elevational view of a third embodiment thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a right side elevational view thereof; FIG. 14 is a top plan view thereof; FIG. 15 is a front elevational view of a fourth embodiment thereof; FIG. 16 is a left side elevational view thereof; FIG. 17 is a right side elevational view thereof; and, FIG. 18 is a top plan view thereof.

The undisclosed rear view for the second, third and fourth embodiments is the same as FIG. 5.



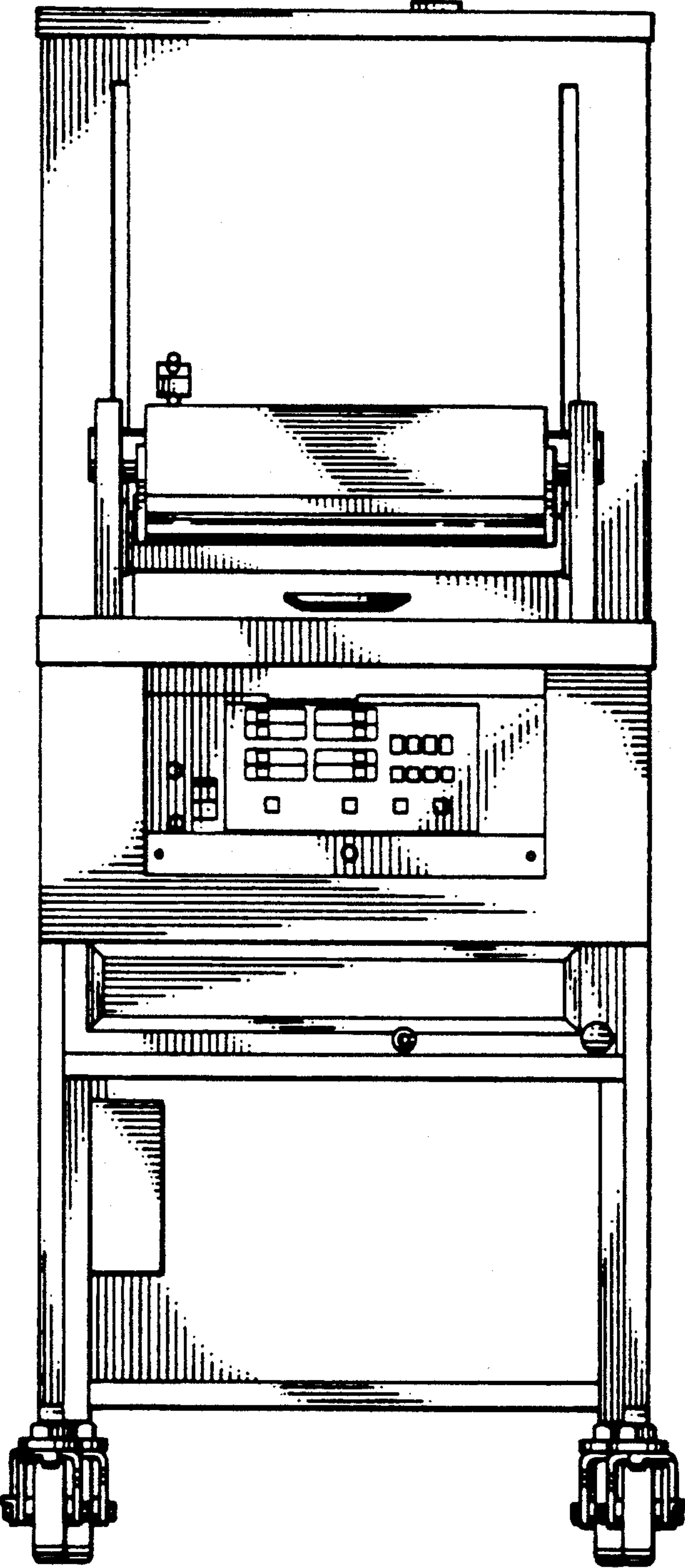

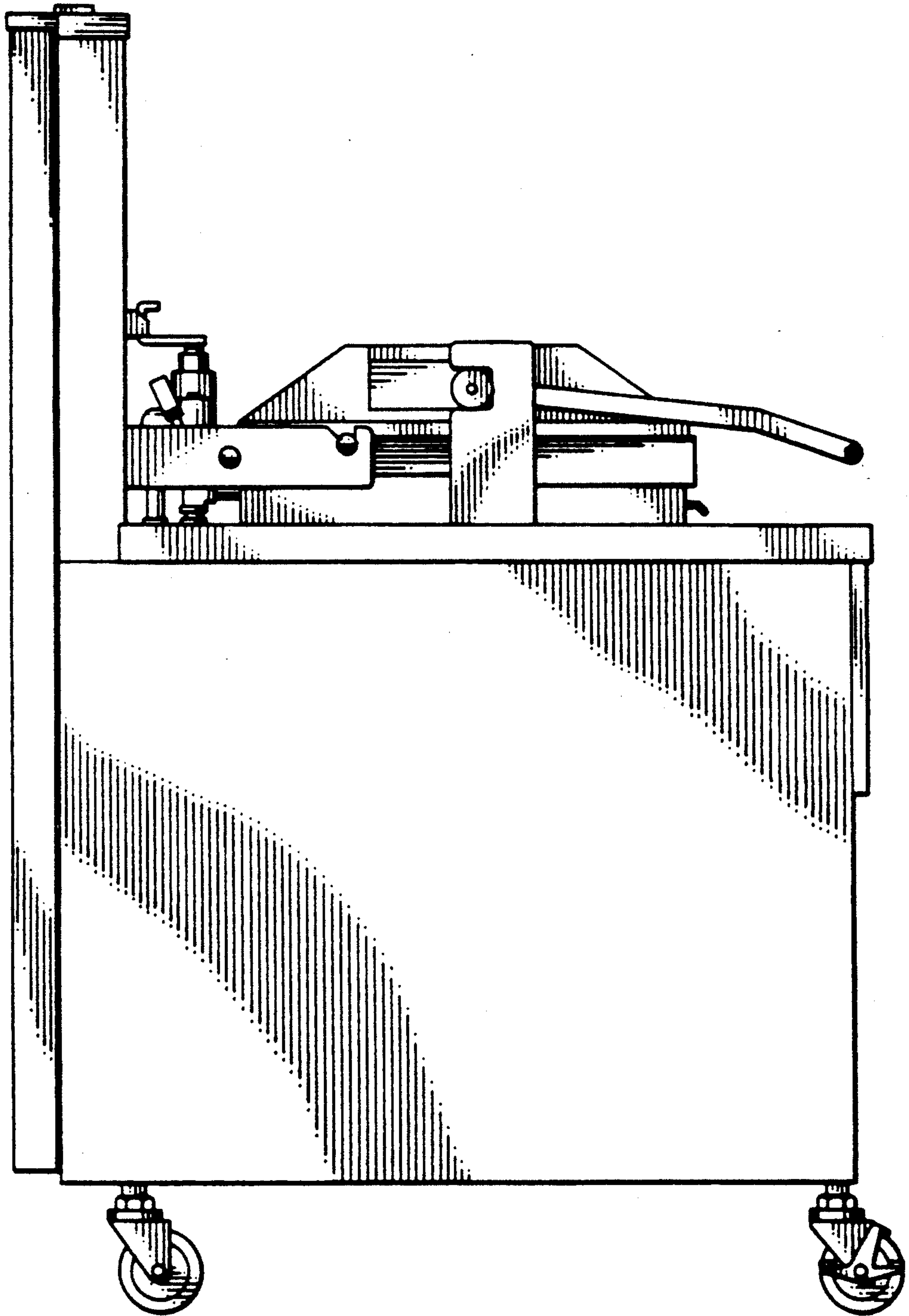

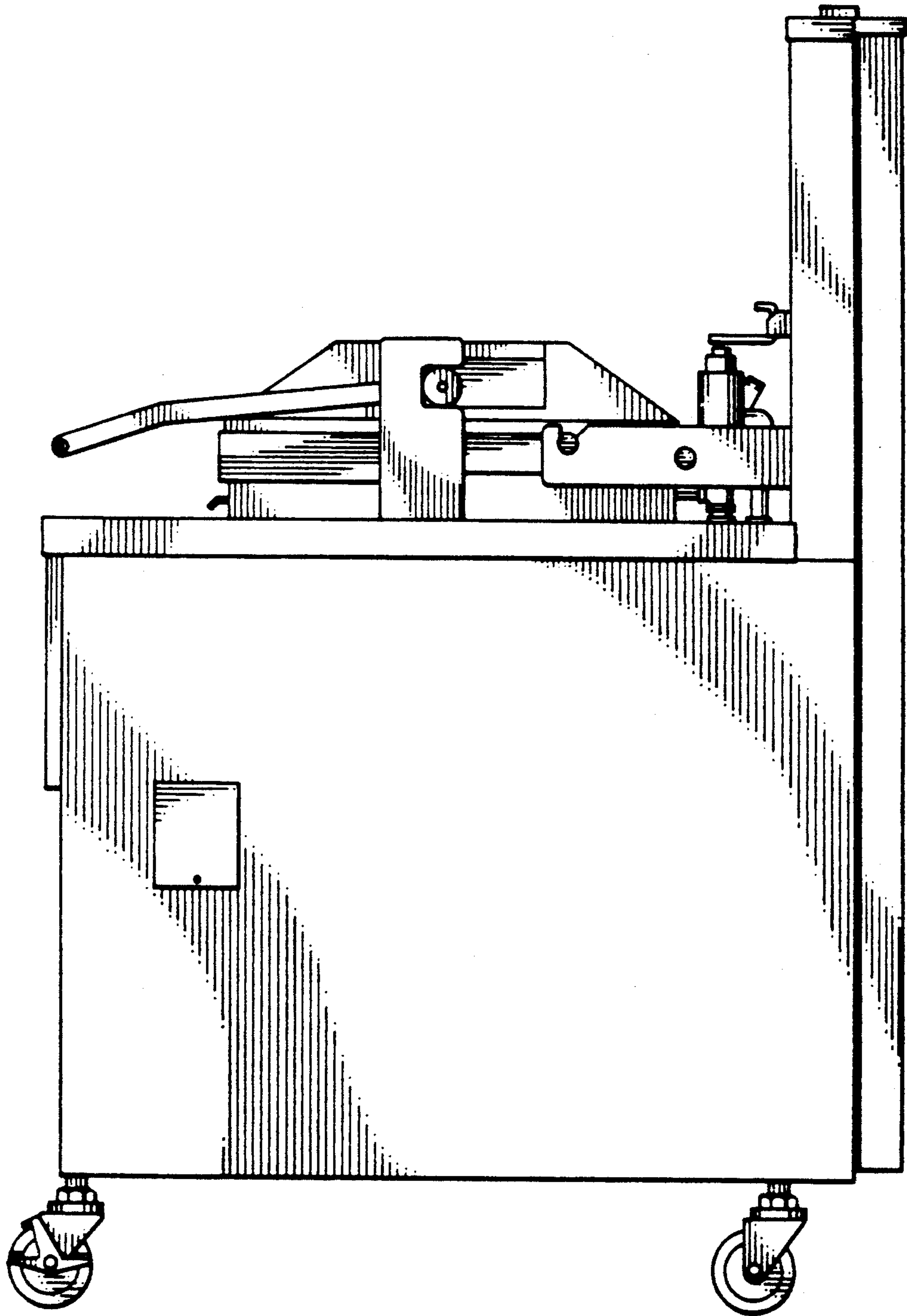

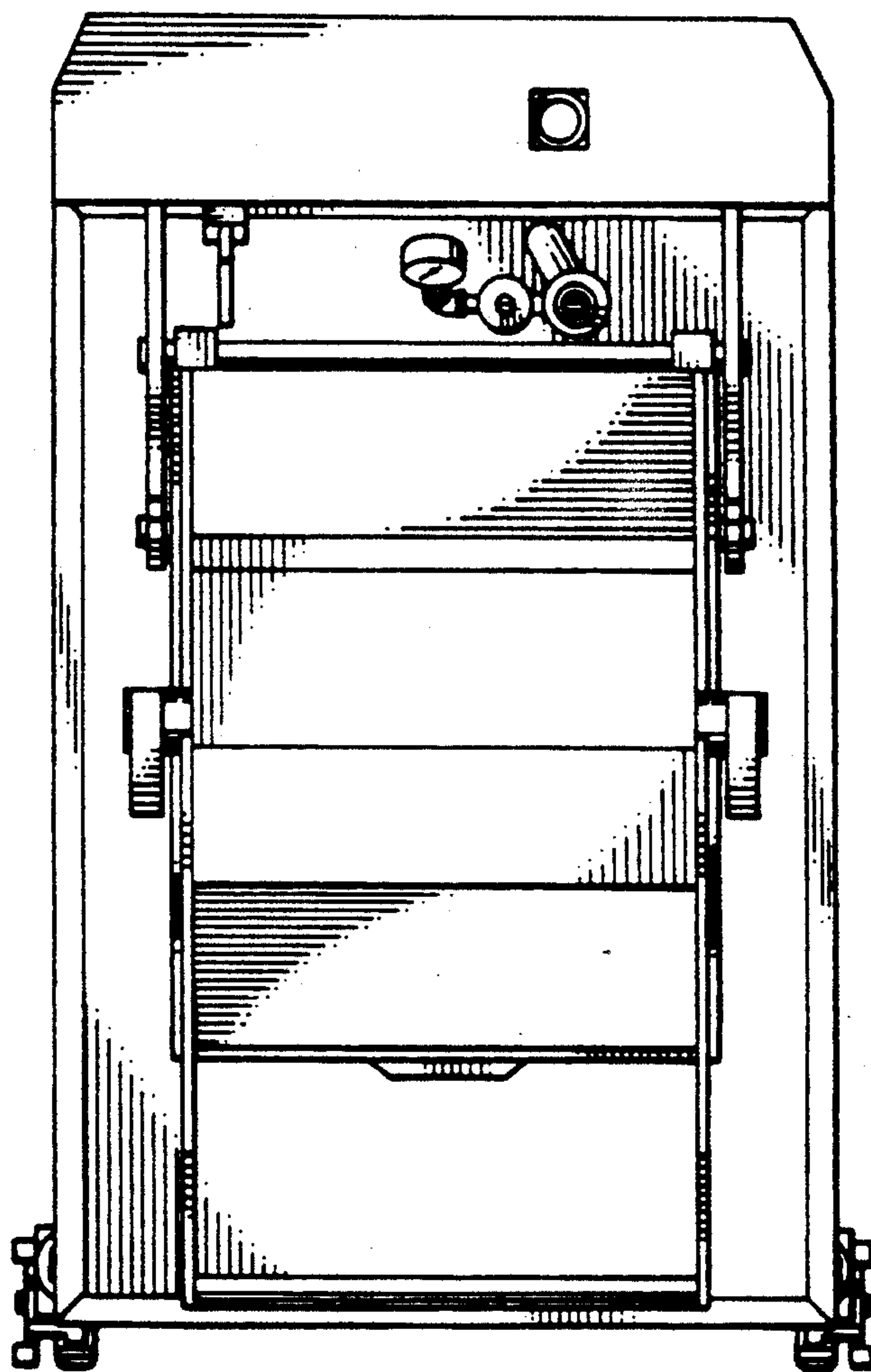

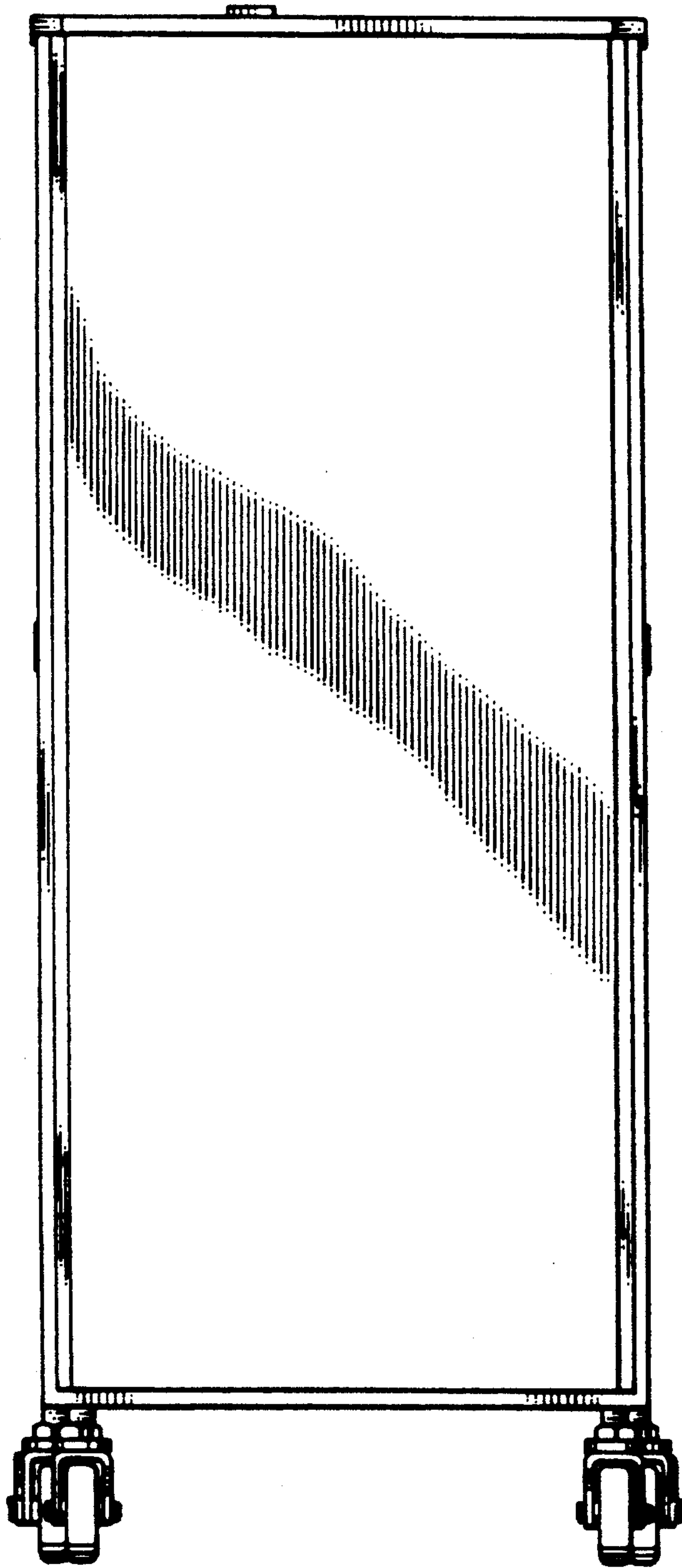

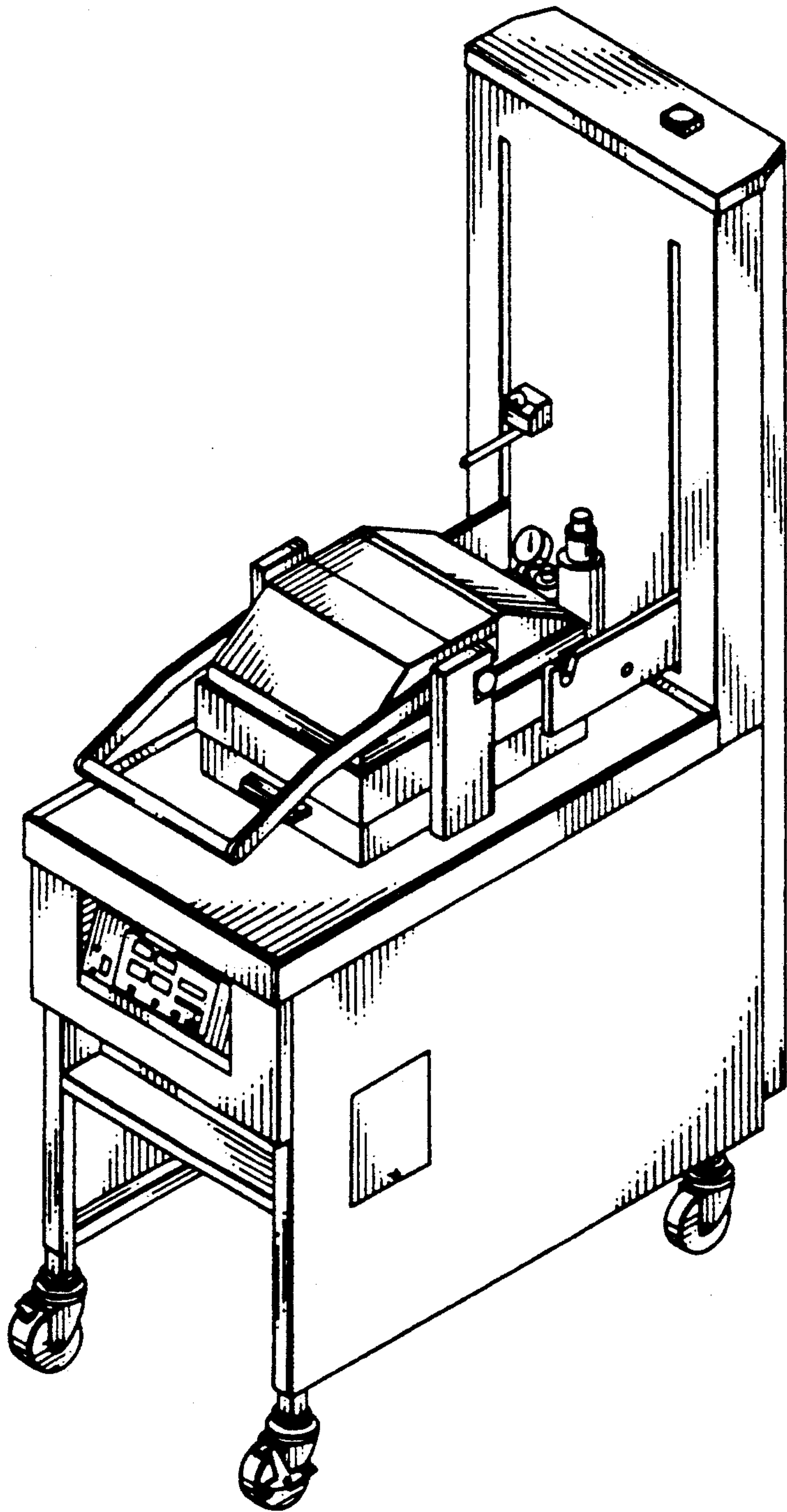

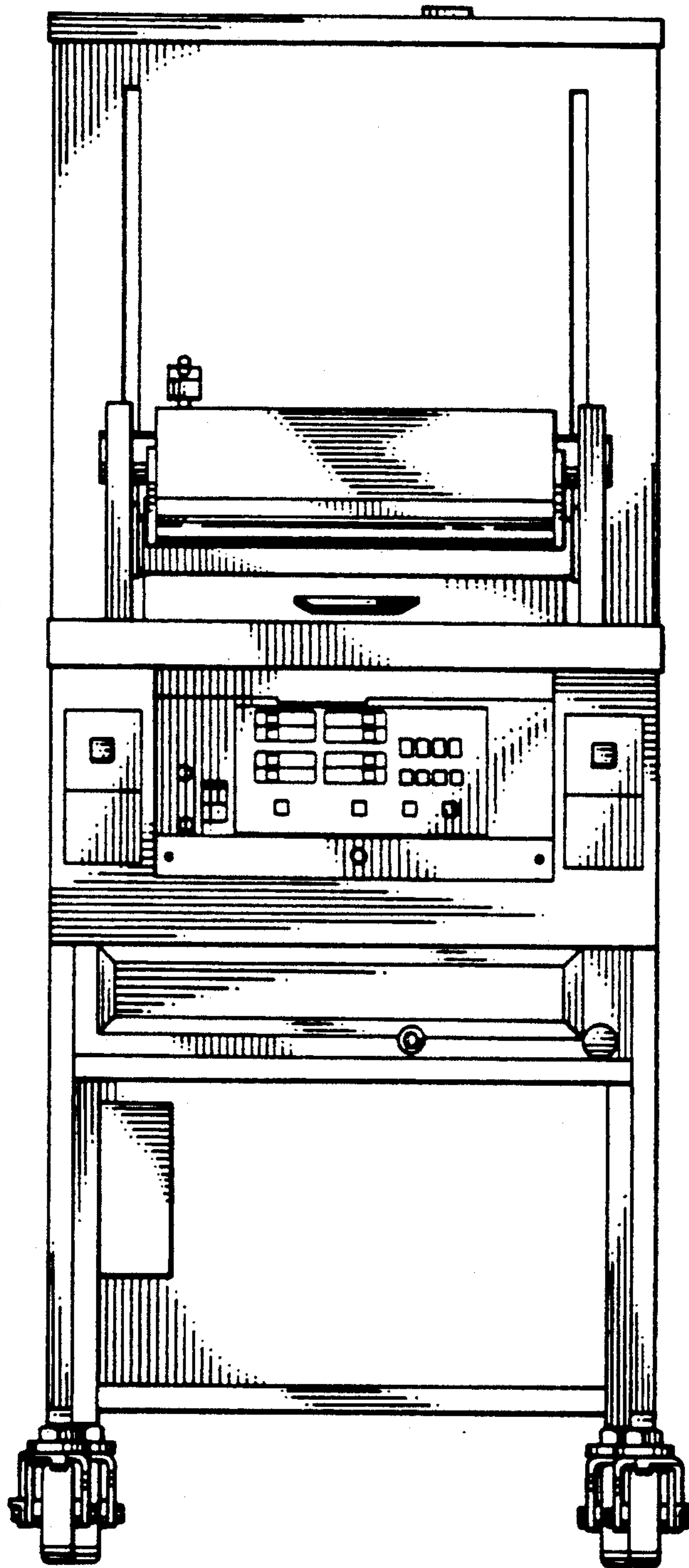

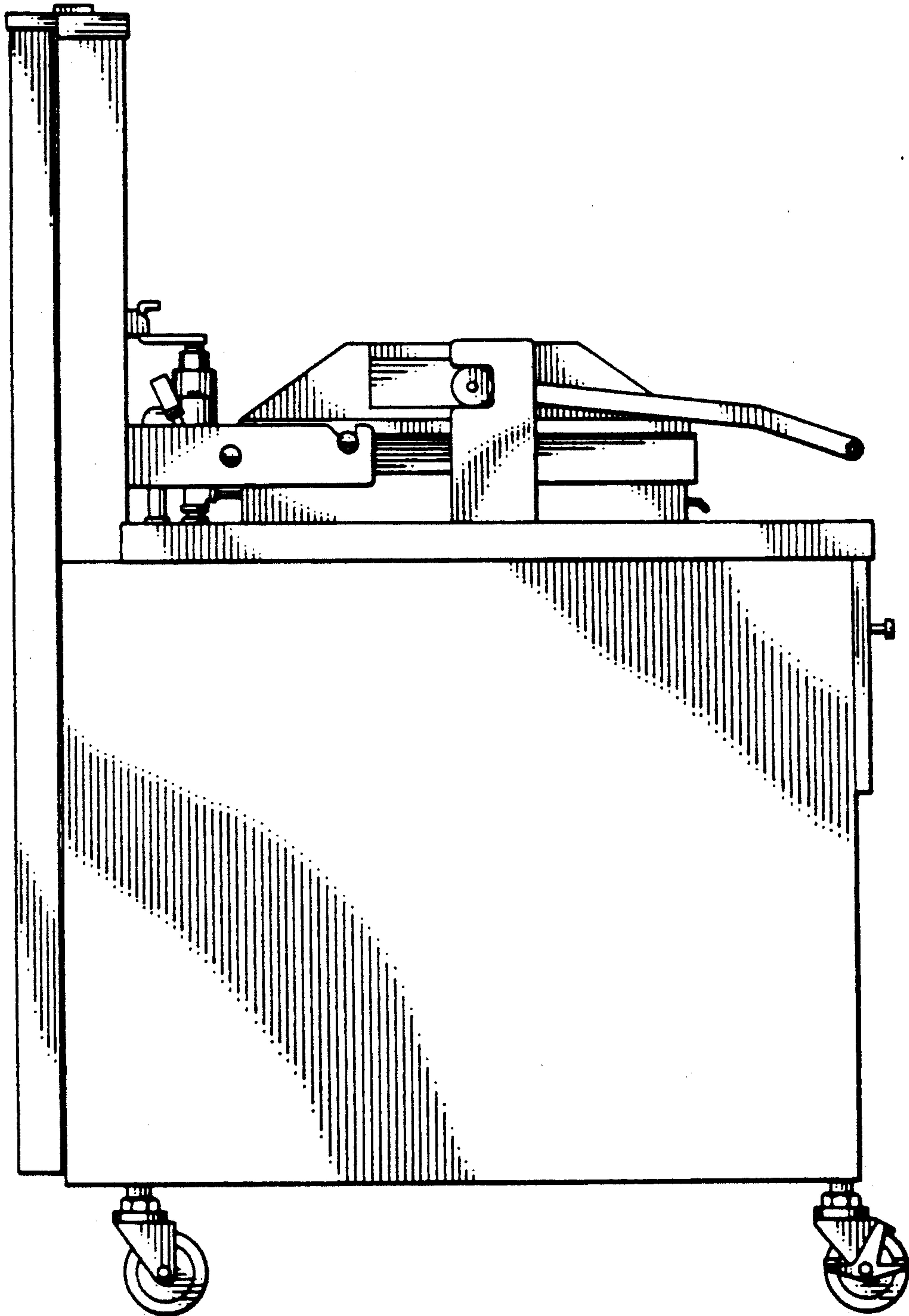

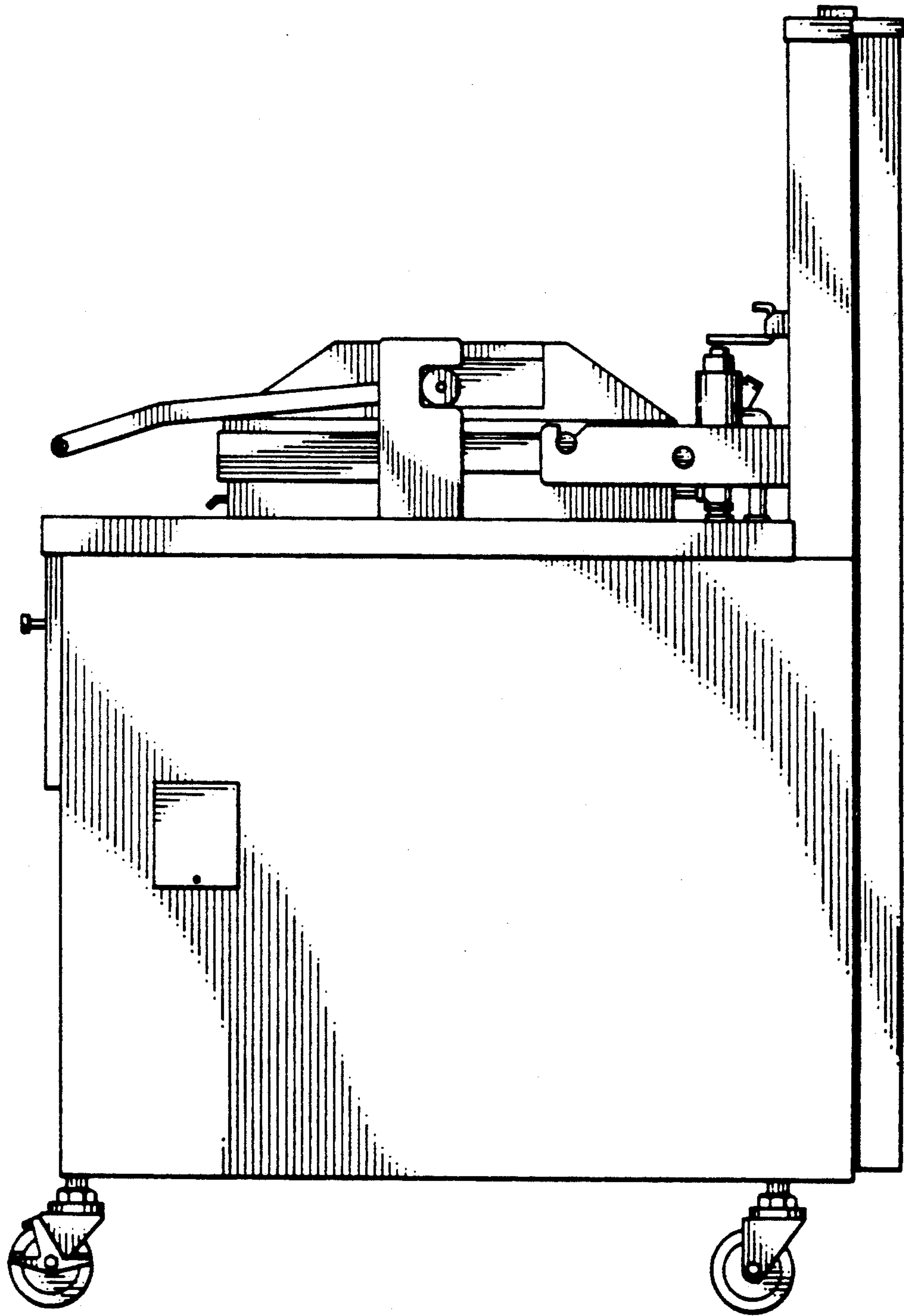

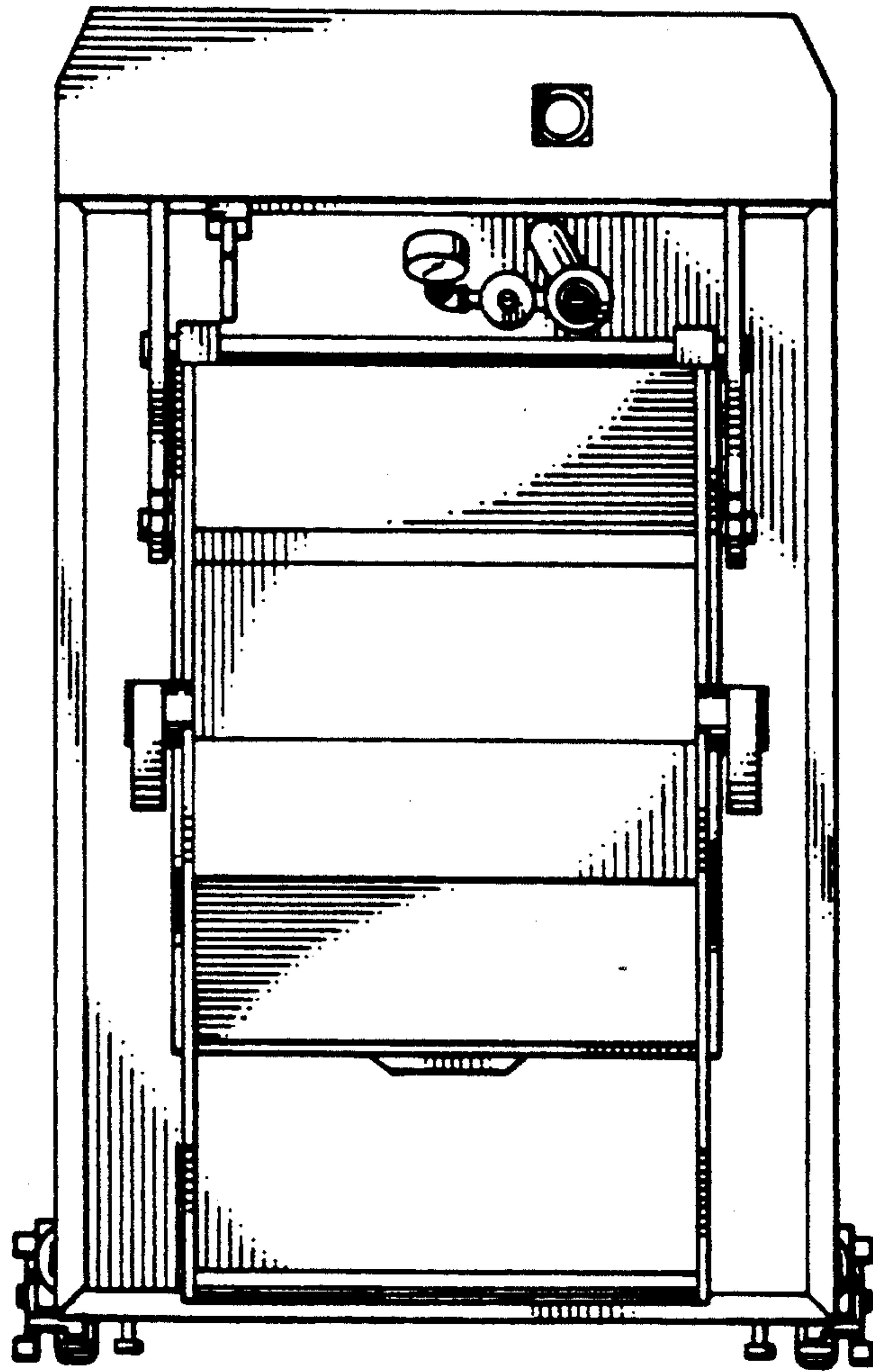

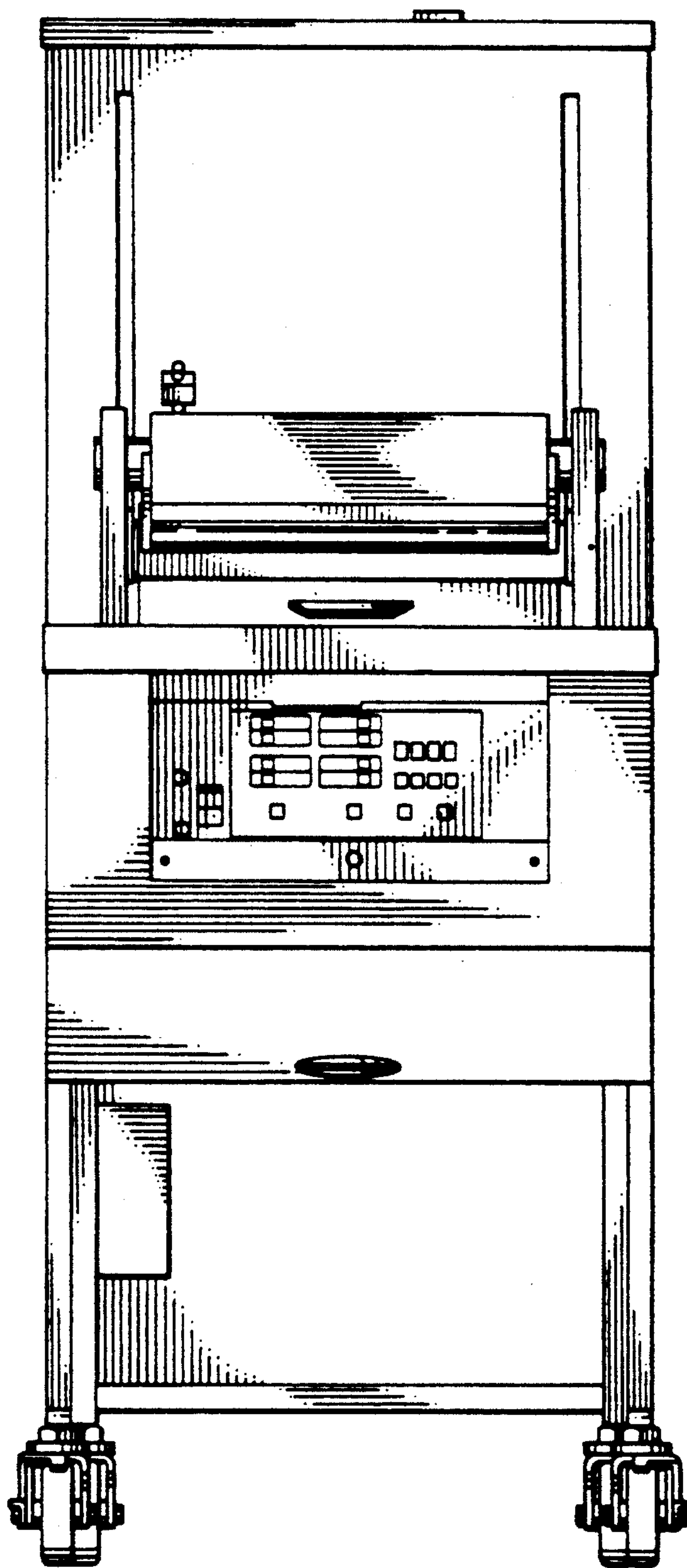

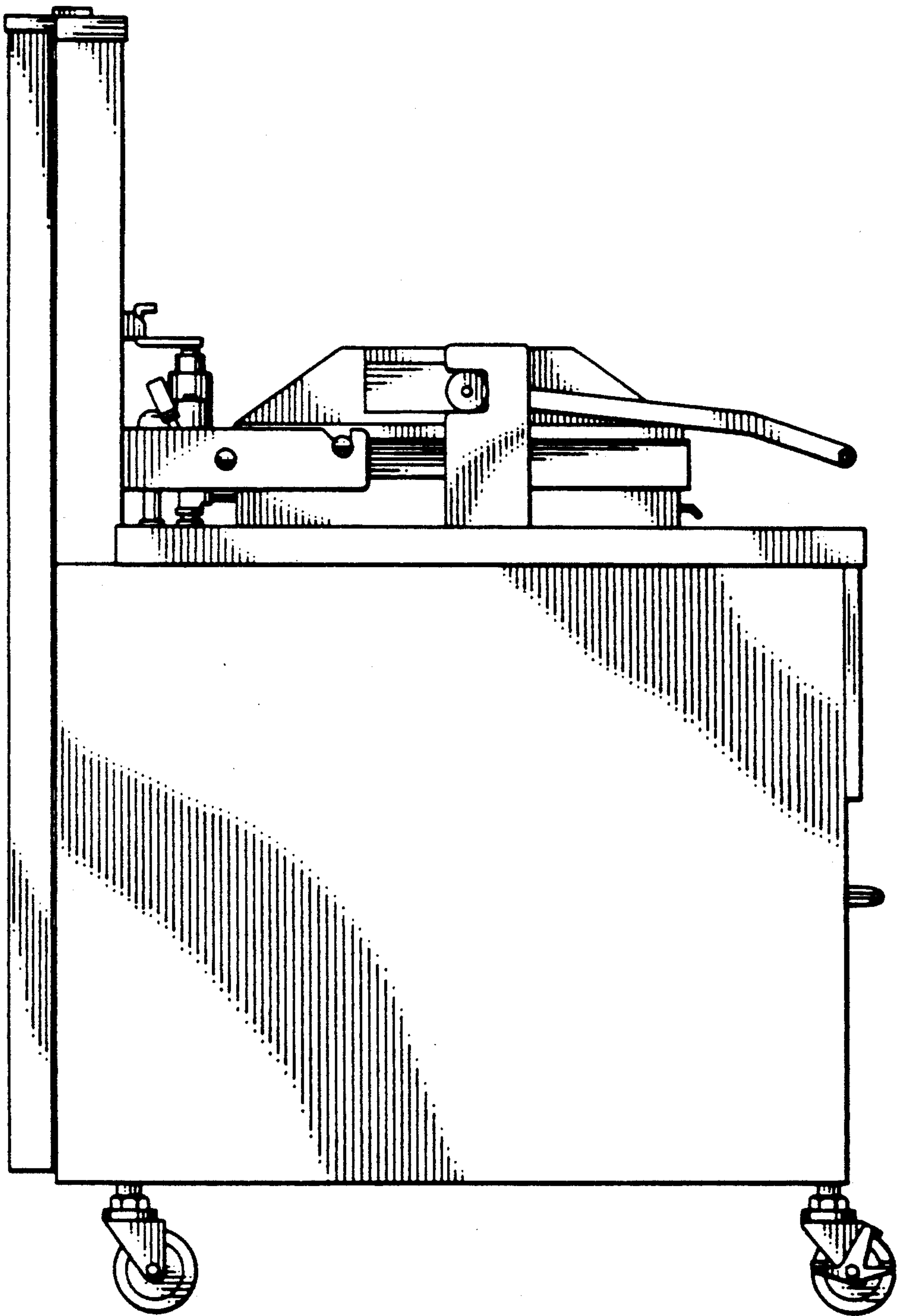

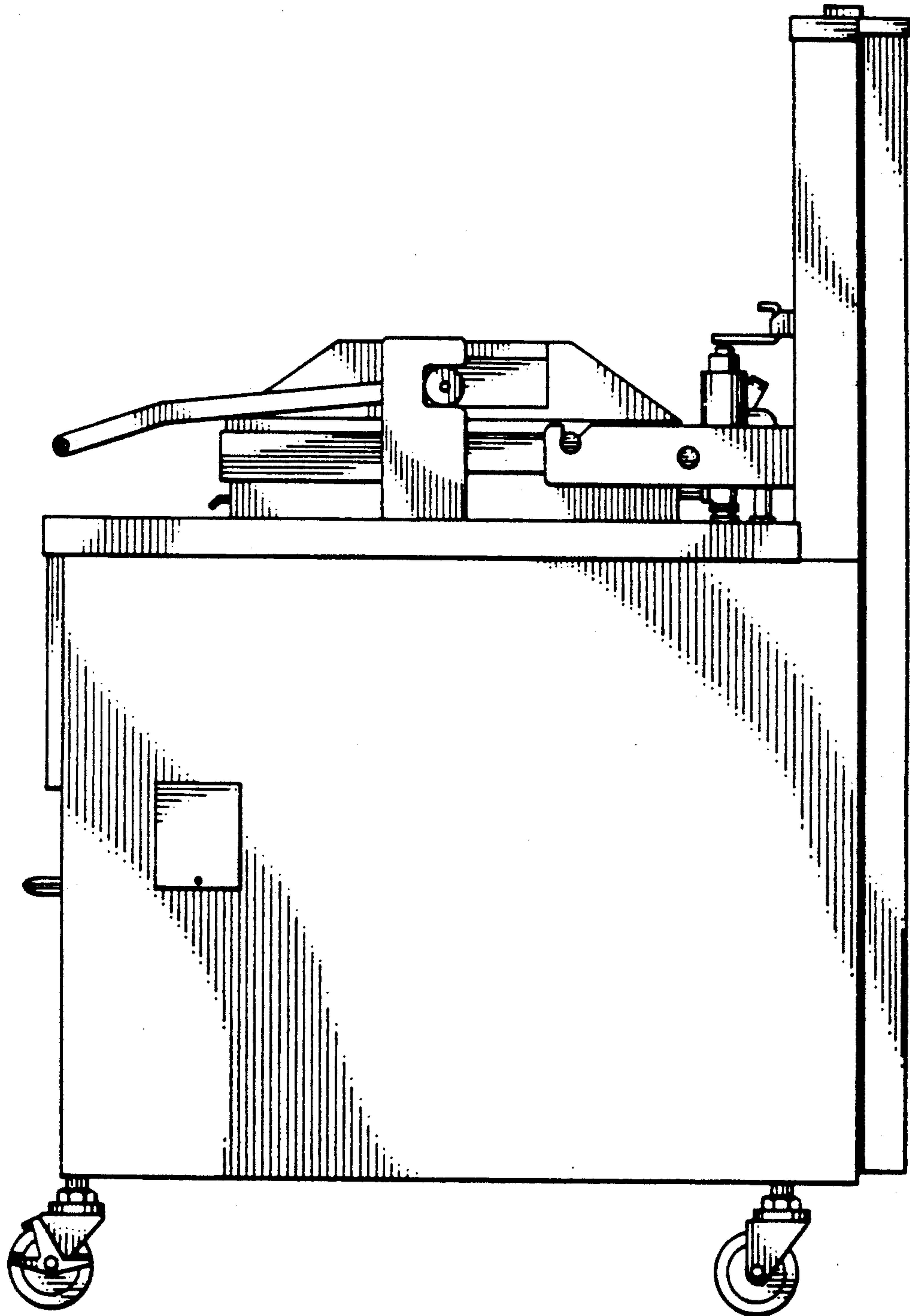

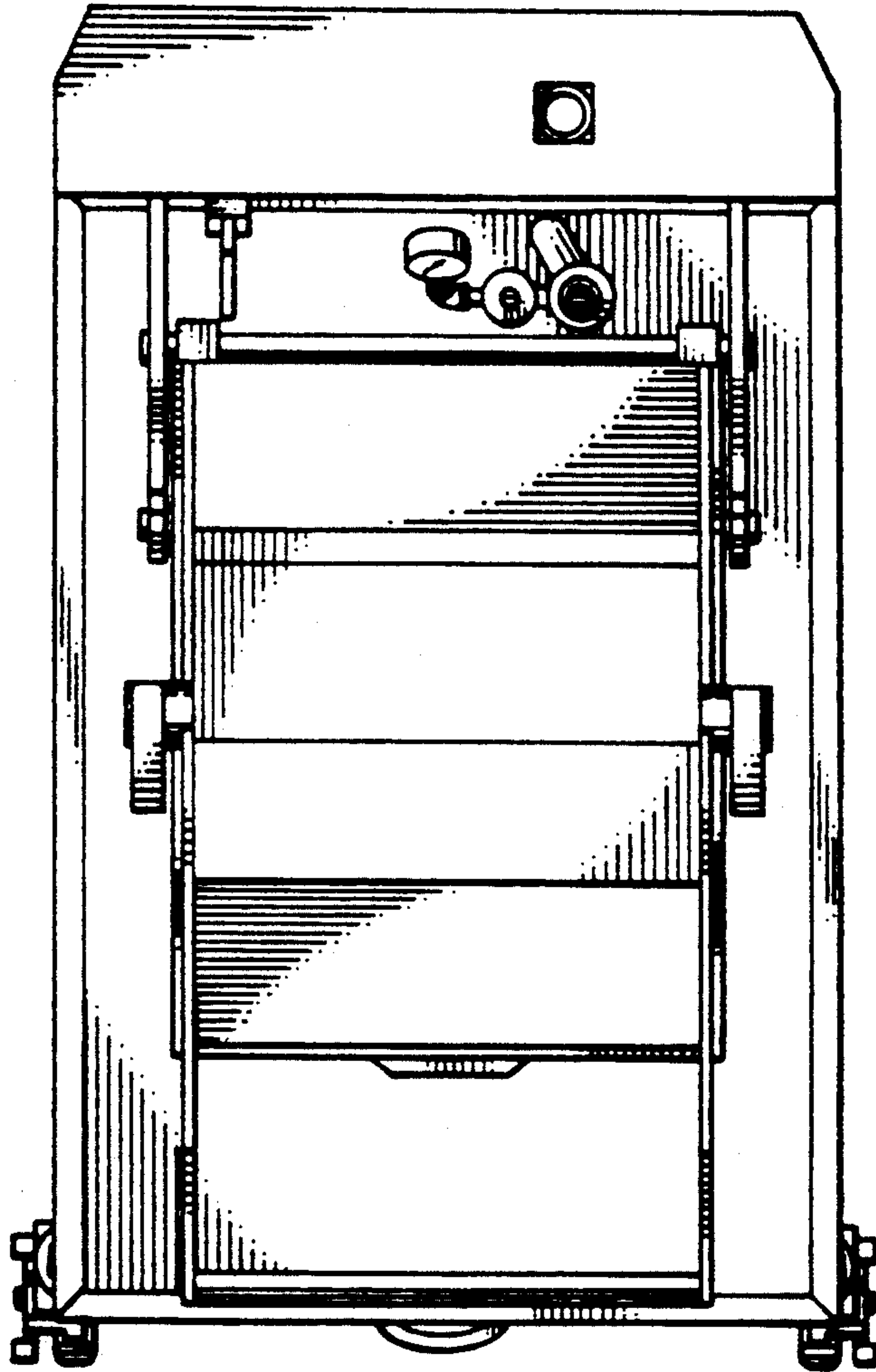

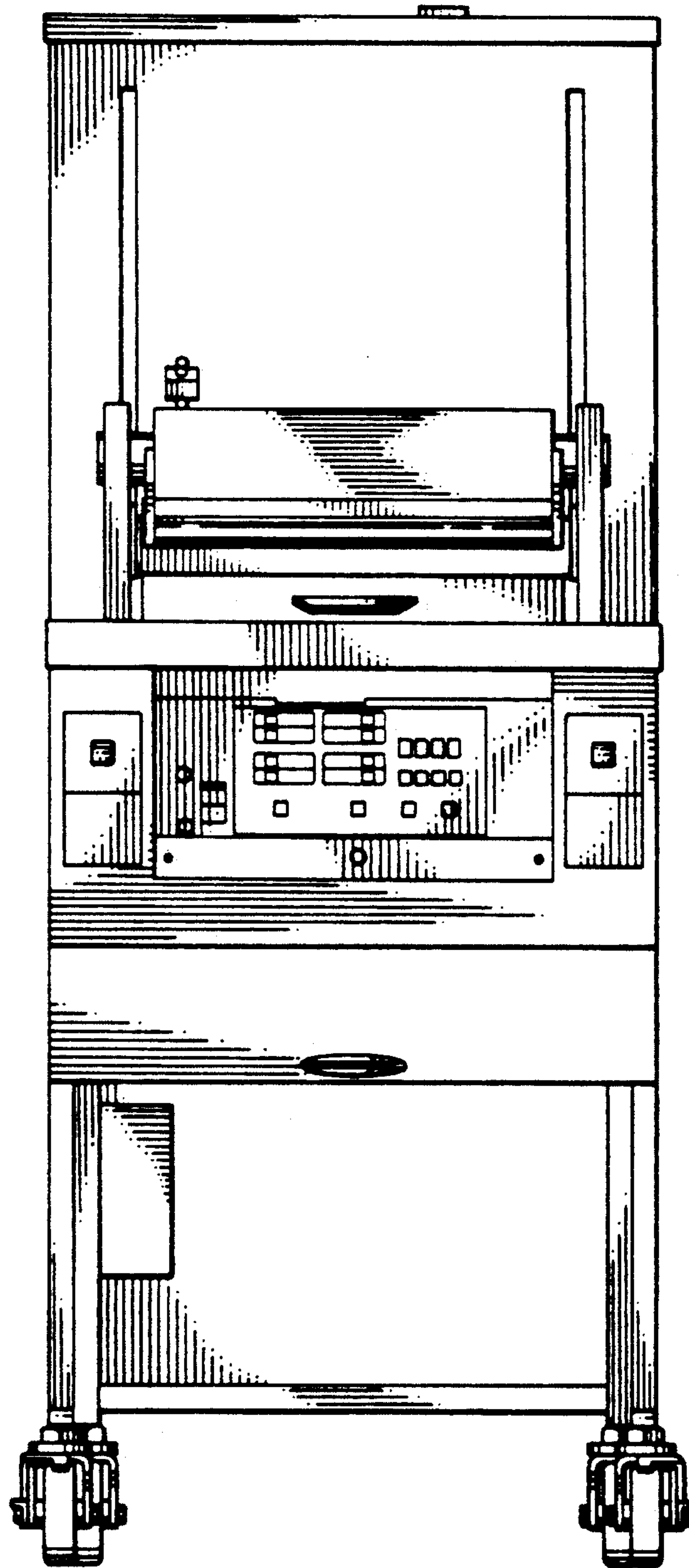

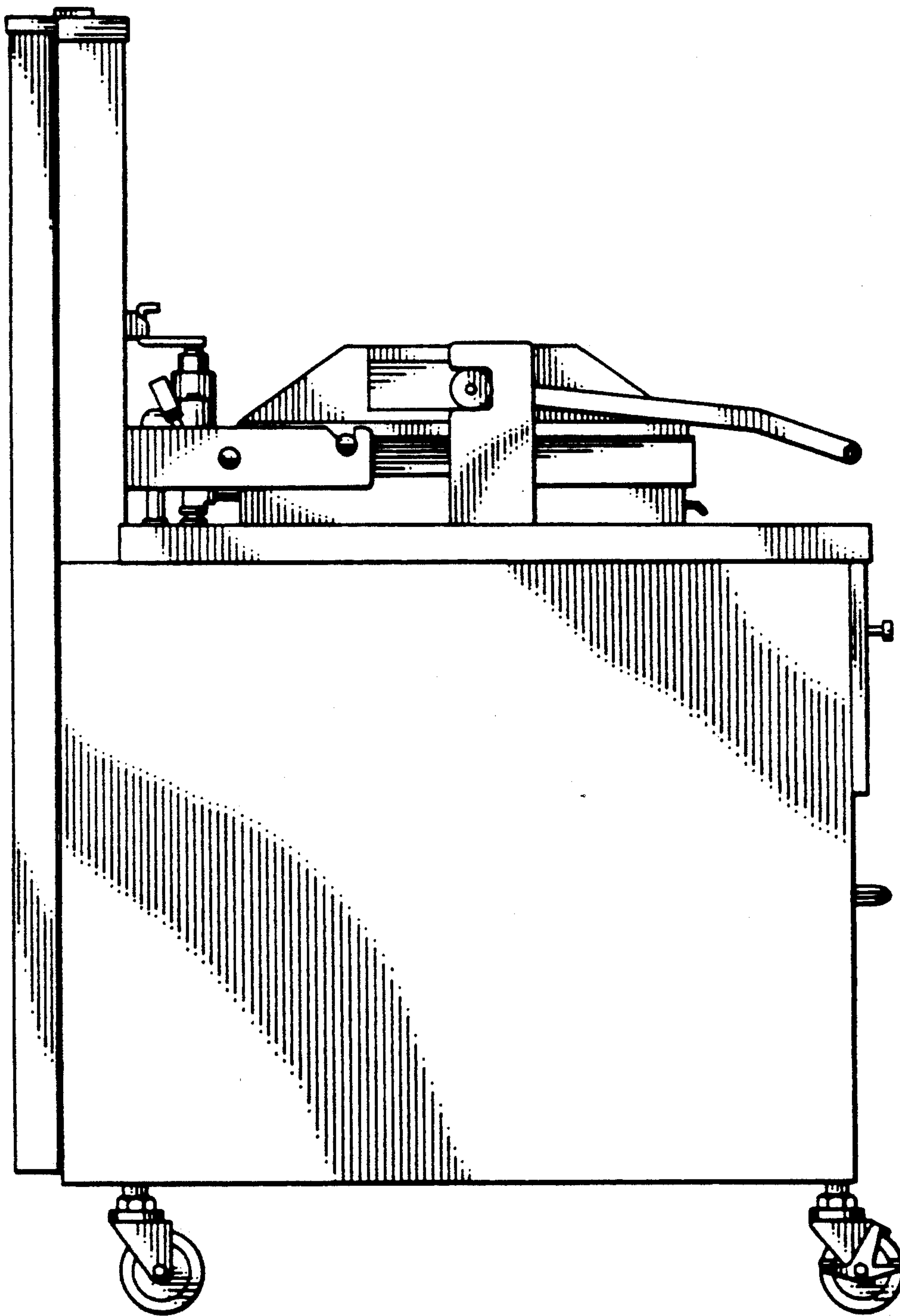

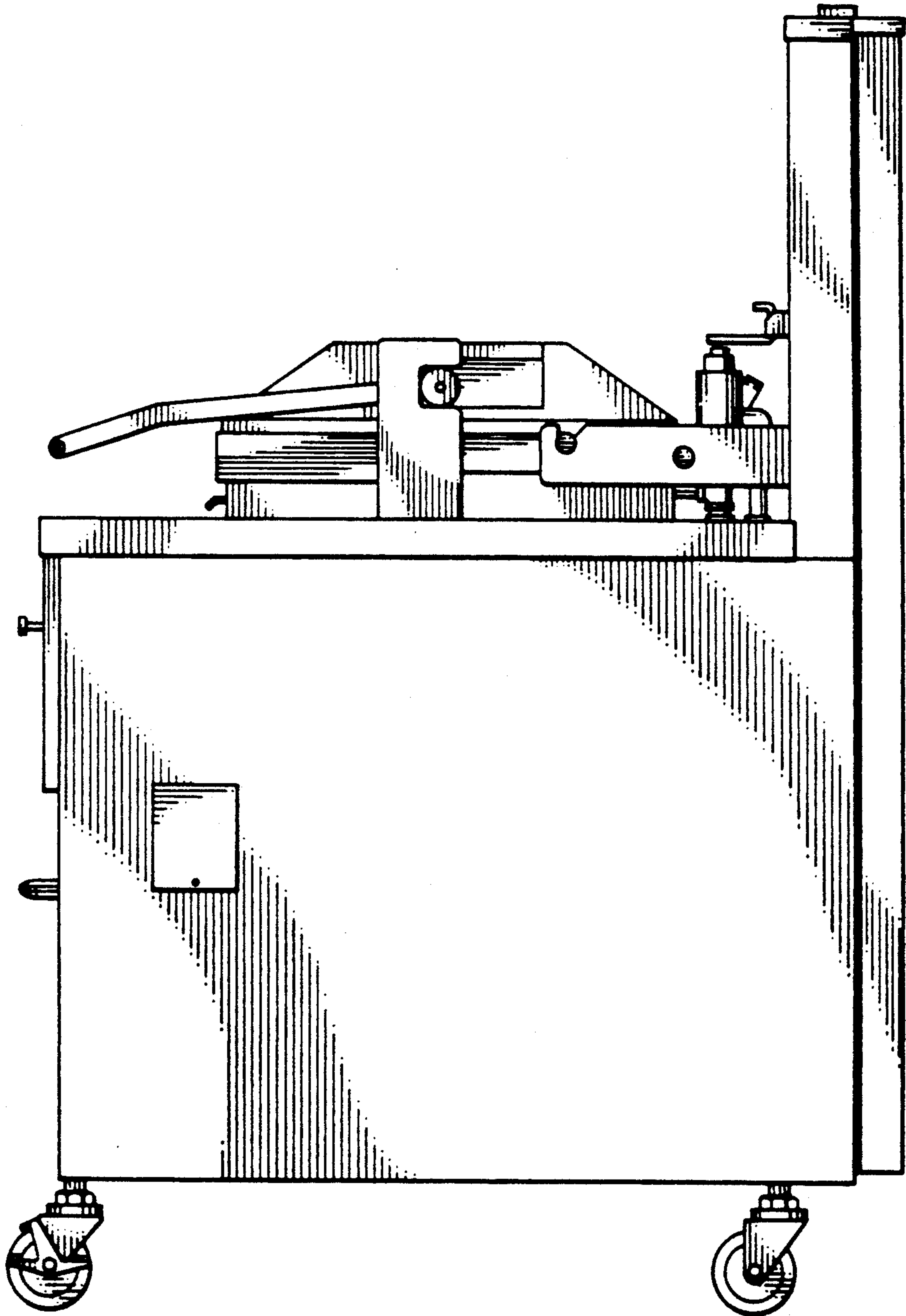

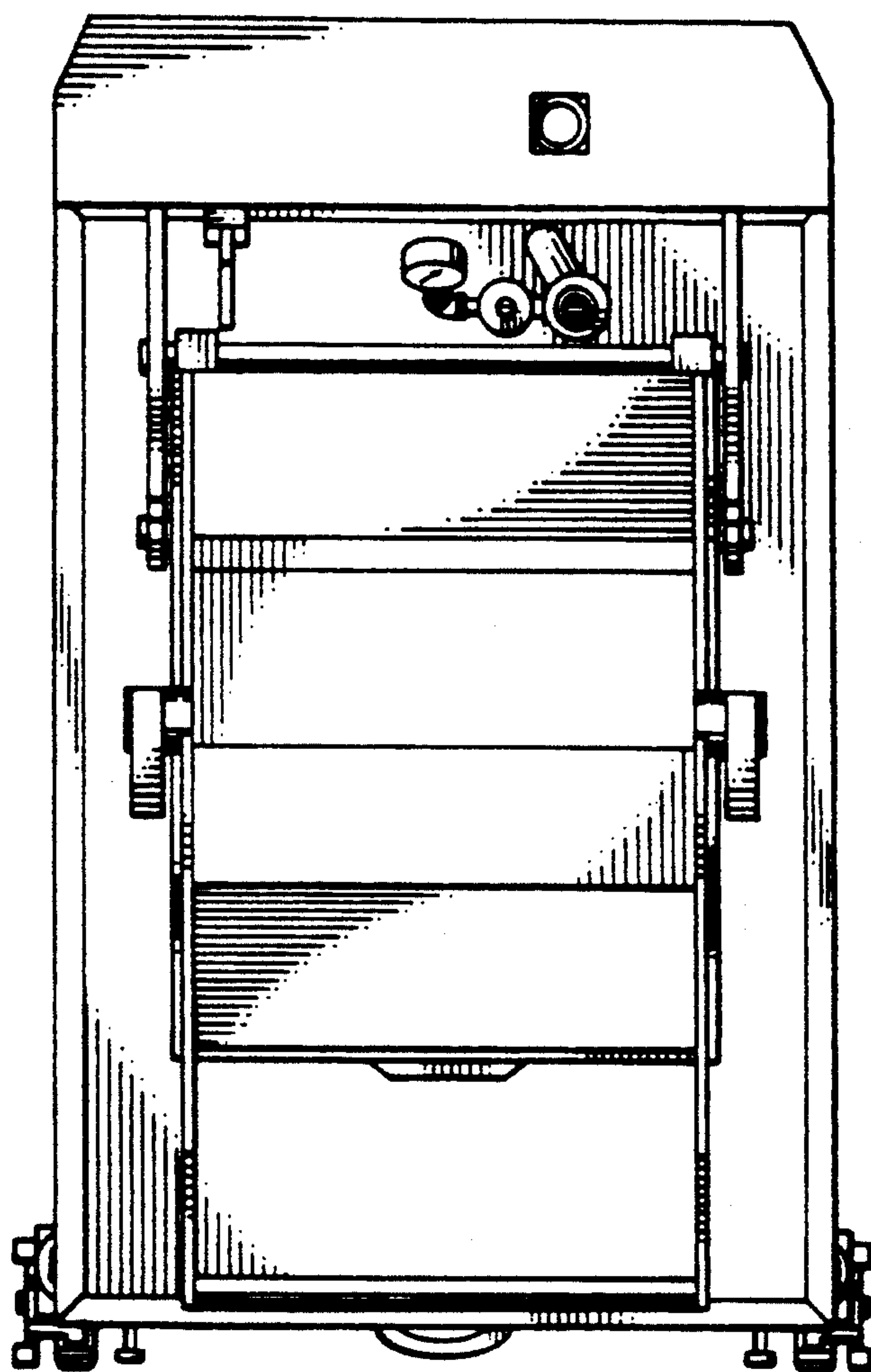
