[57] **CLAIM**

The ornamental design for a package for photographic film cassette, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a package for photographic film cassette showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a sectional elevational view thereof taken along line 8—8 of FIG. 2; and FIG. 9 is an exploded perspective view thereof; FIG. 10 is a perspective view of a second embodiment of FIG. 1; FIG. 11 is a front elevational view of FIG. 10; FIG. 12 is a rear elevational view of FIG. 10; FIG. 13 is a top plan view of FIG. 10; FIG. 14 is a bottom plan view of FIG. 10; FIG. 15 is a left side elevational view of FIG. 10; FIG. 16 is a right side elevational view of FIG. 10; FIG. 17 is a sectional elevational view taken along line 17—17 of FIG. 11; and, FIG. 18 is an exploded perspective view of FIG. 10. The broken line showing of a film cassette in FIGS. 9 and 18 is for illustrative purposes only and forms no part of the claim.

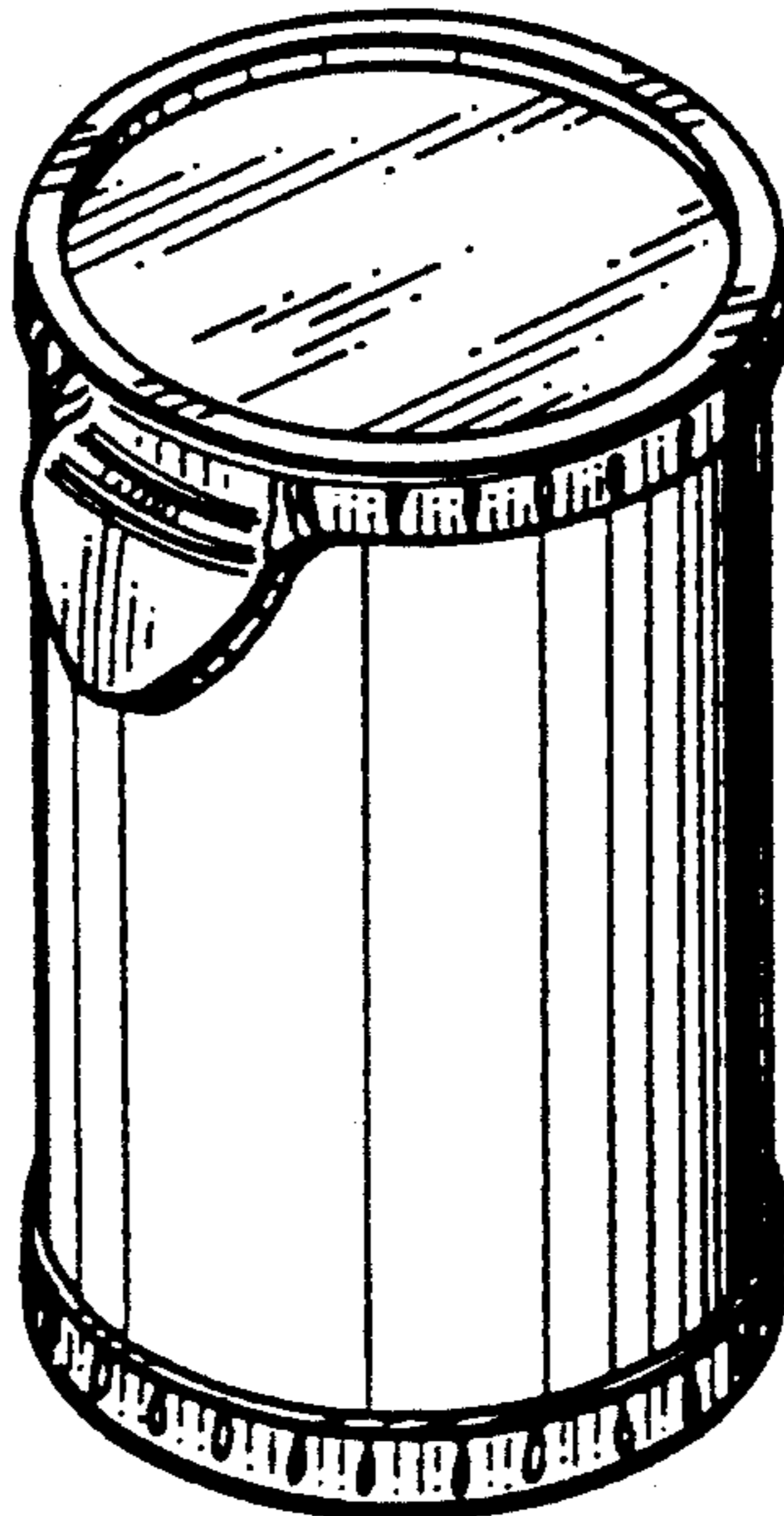

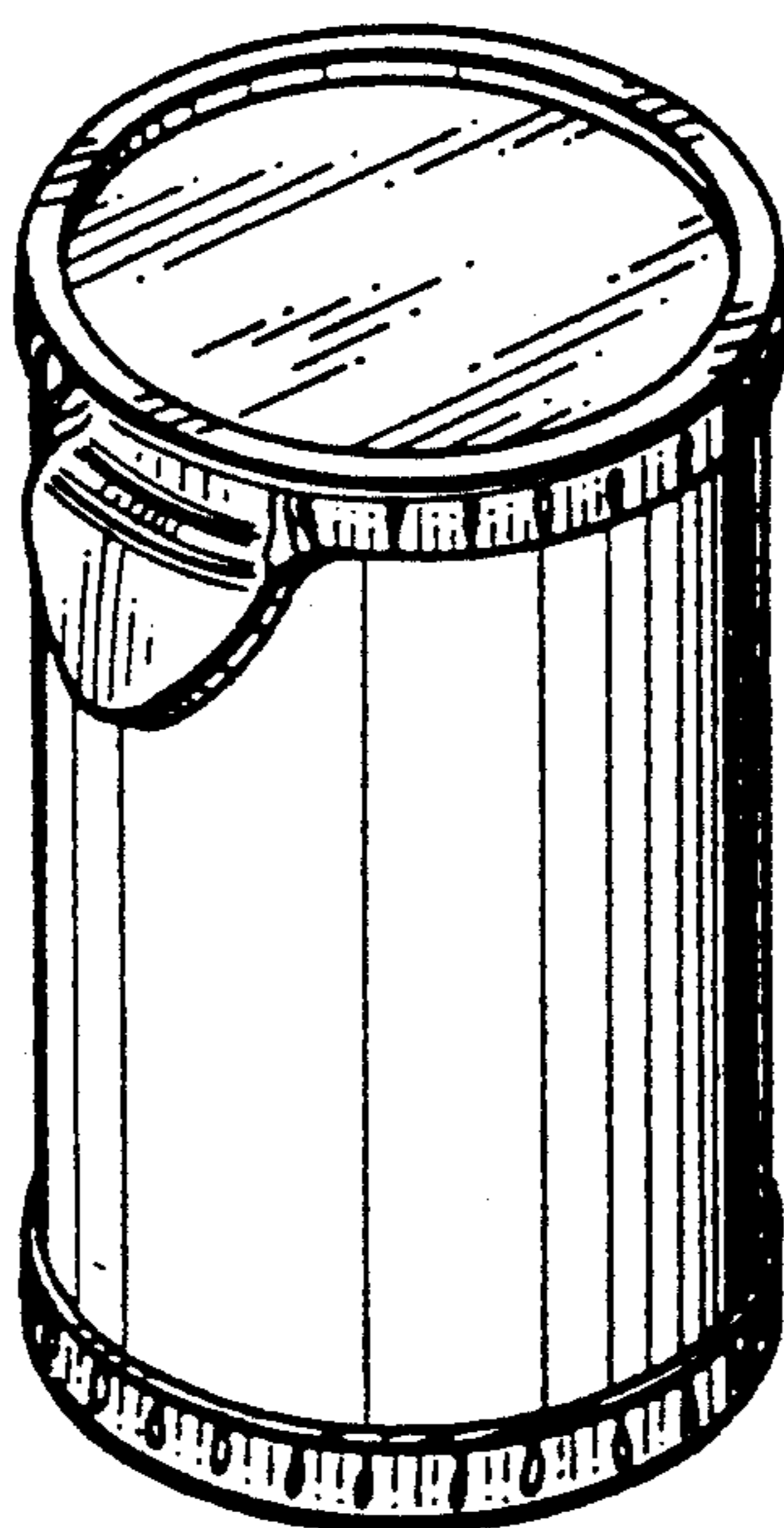

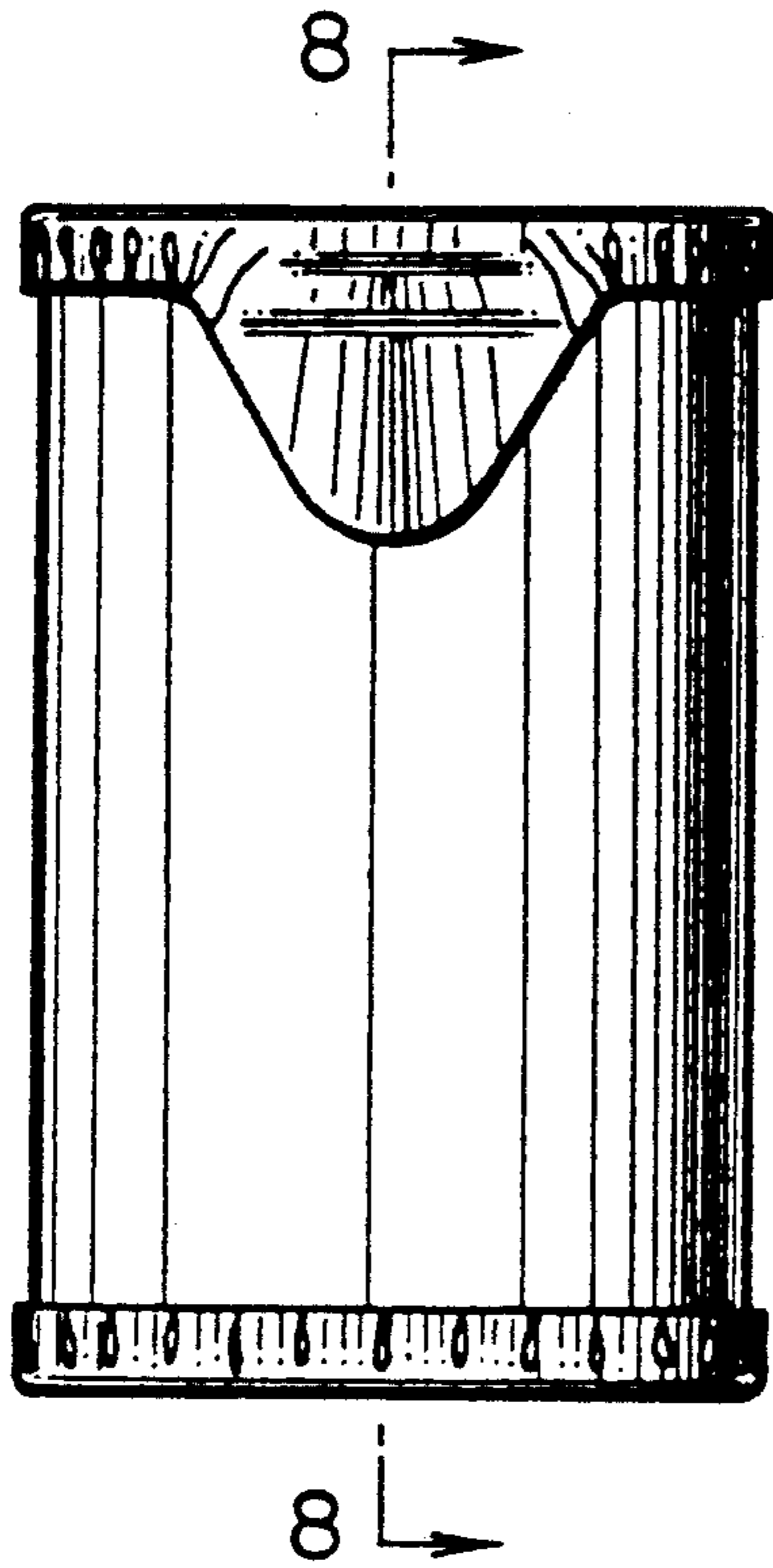

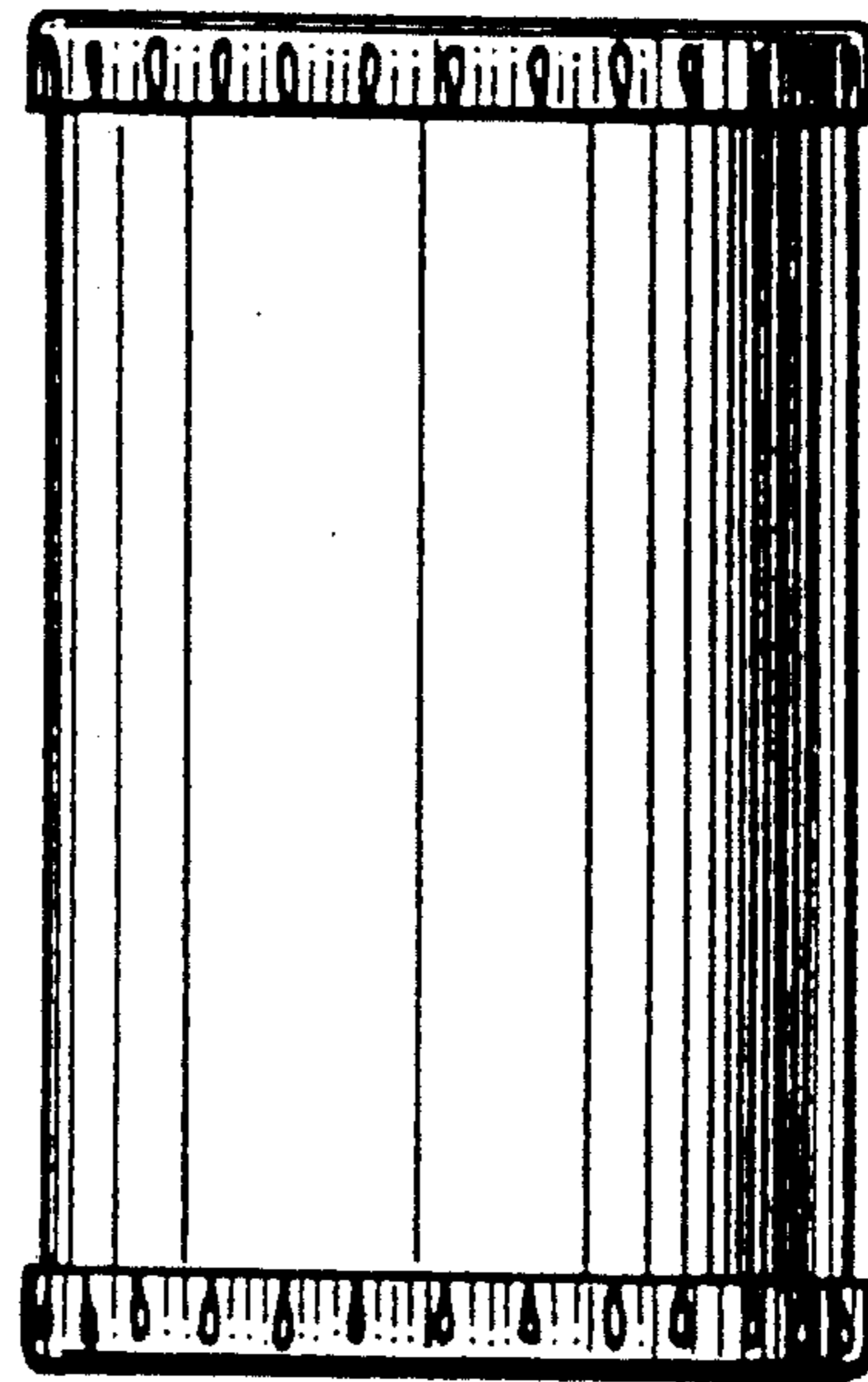

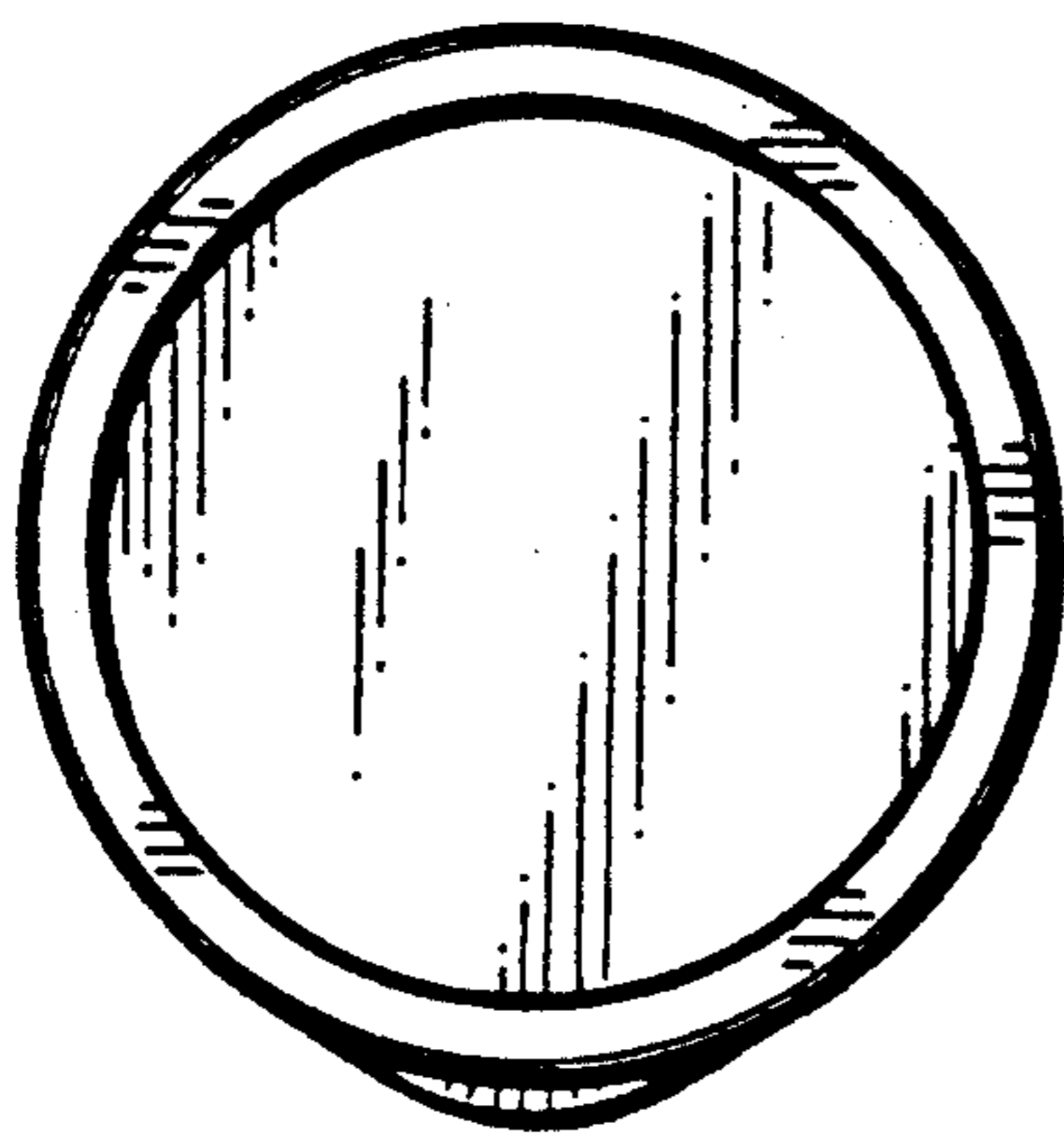

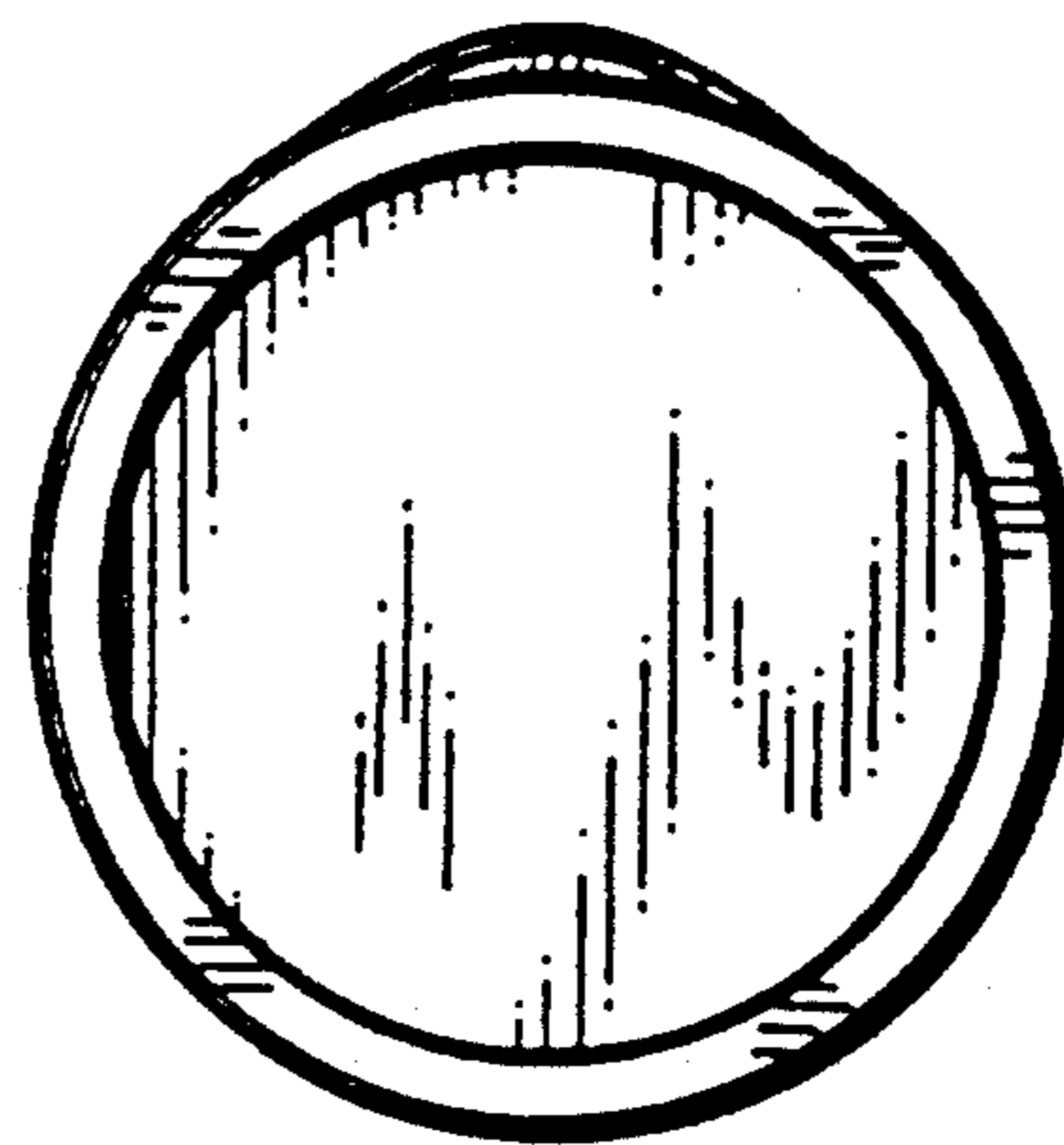

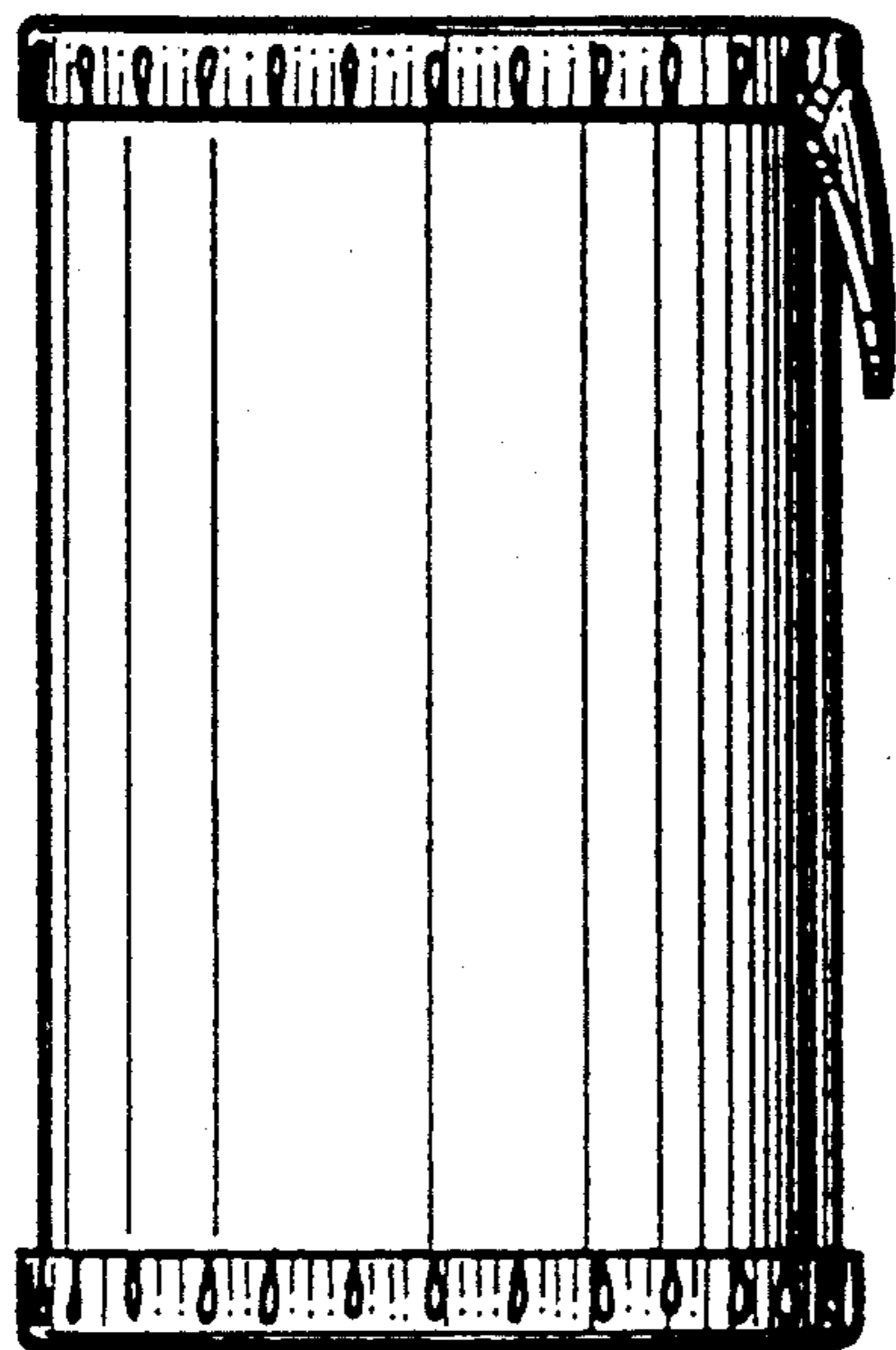

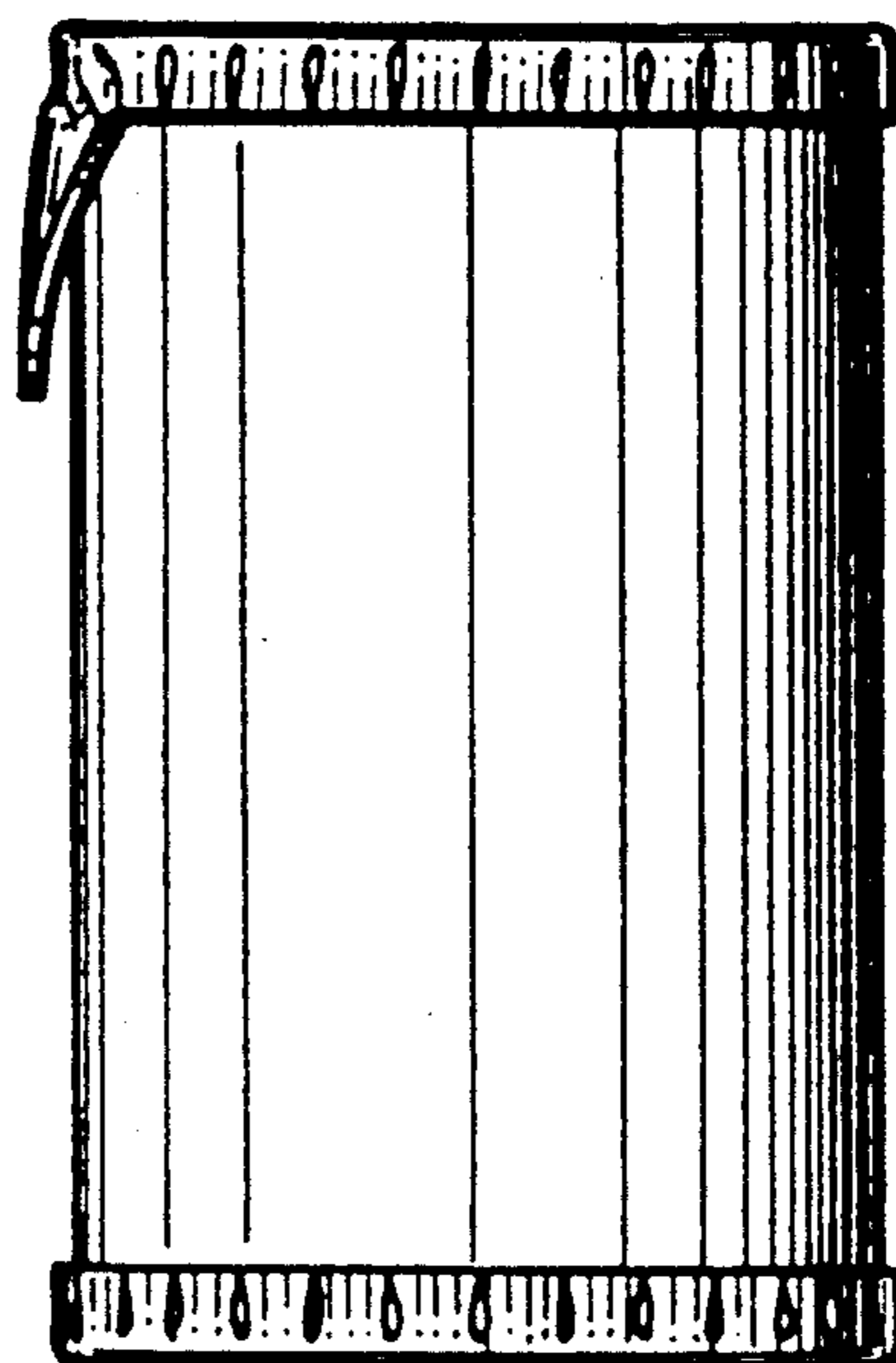

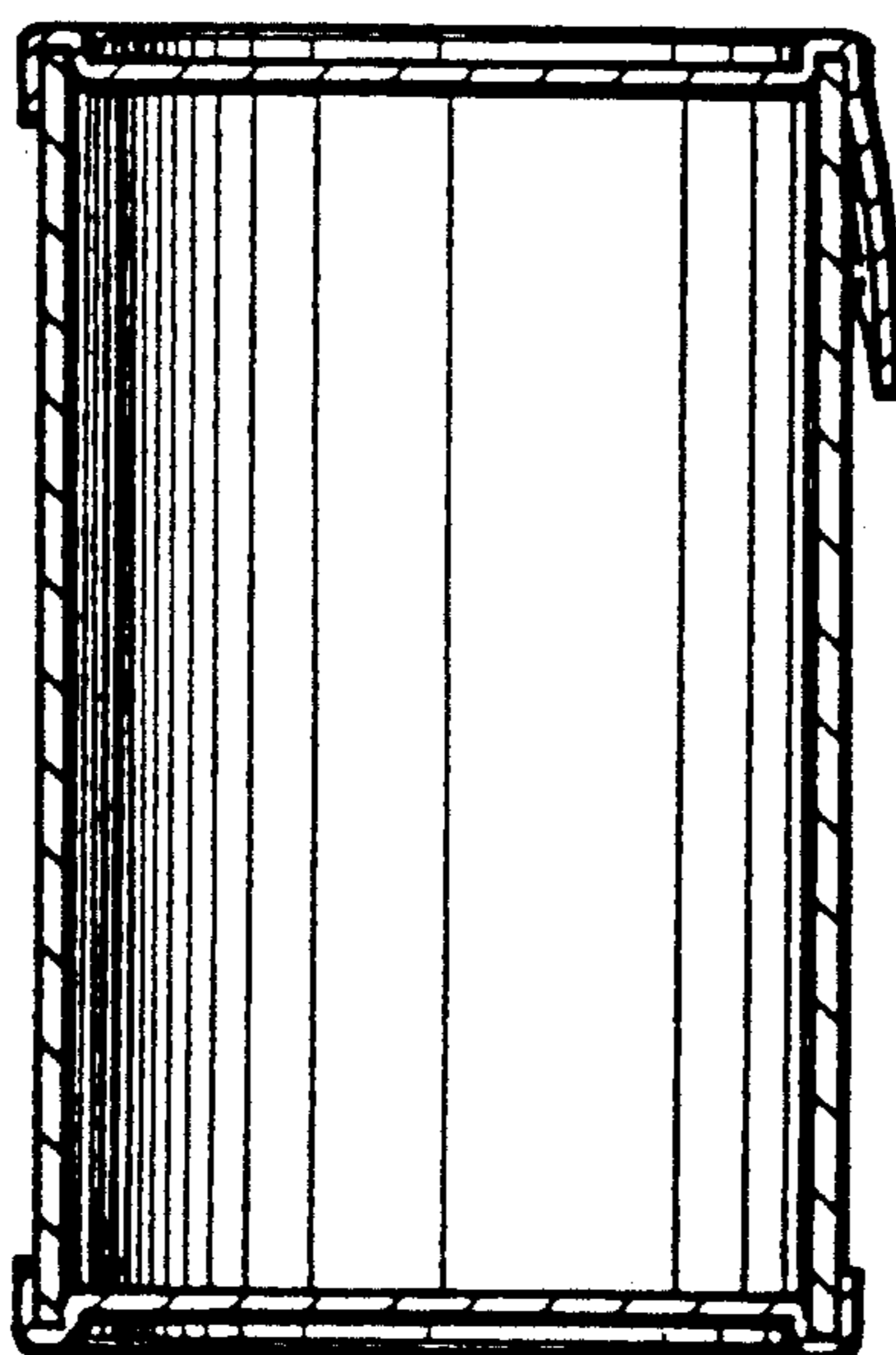

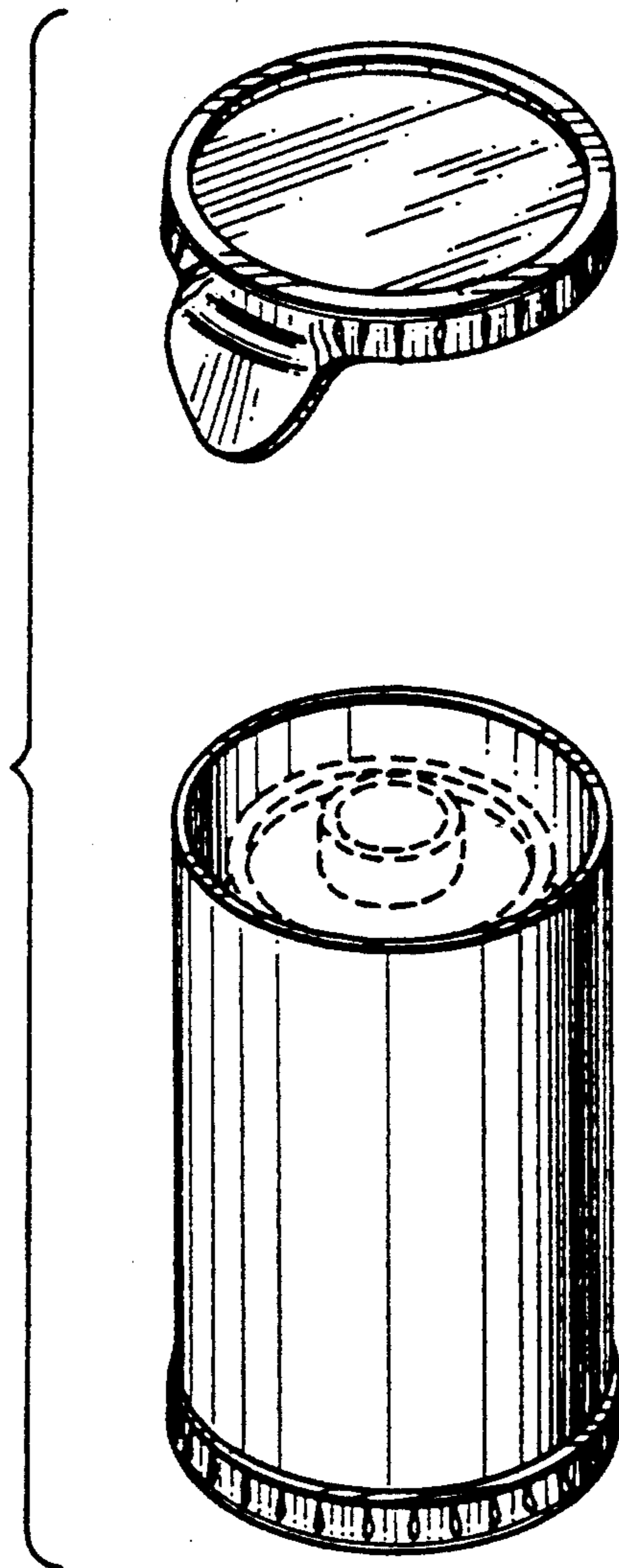

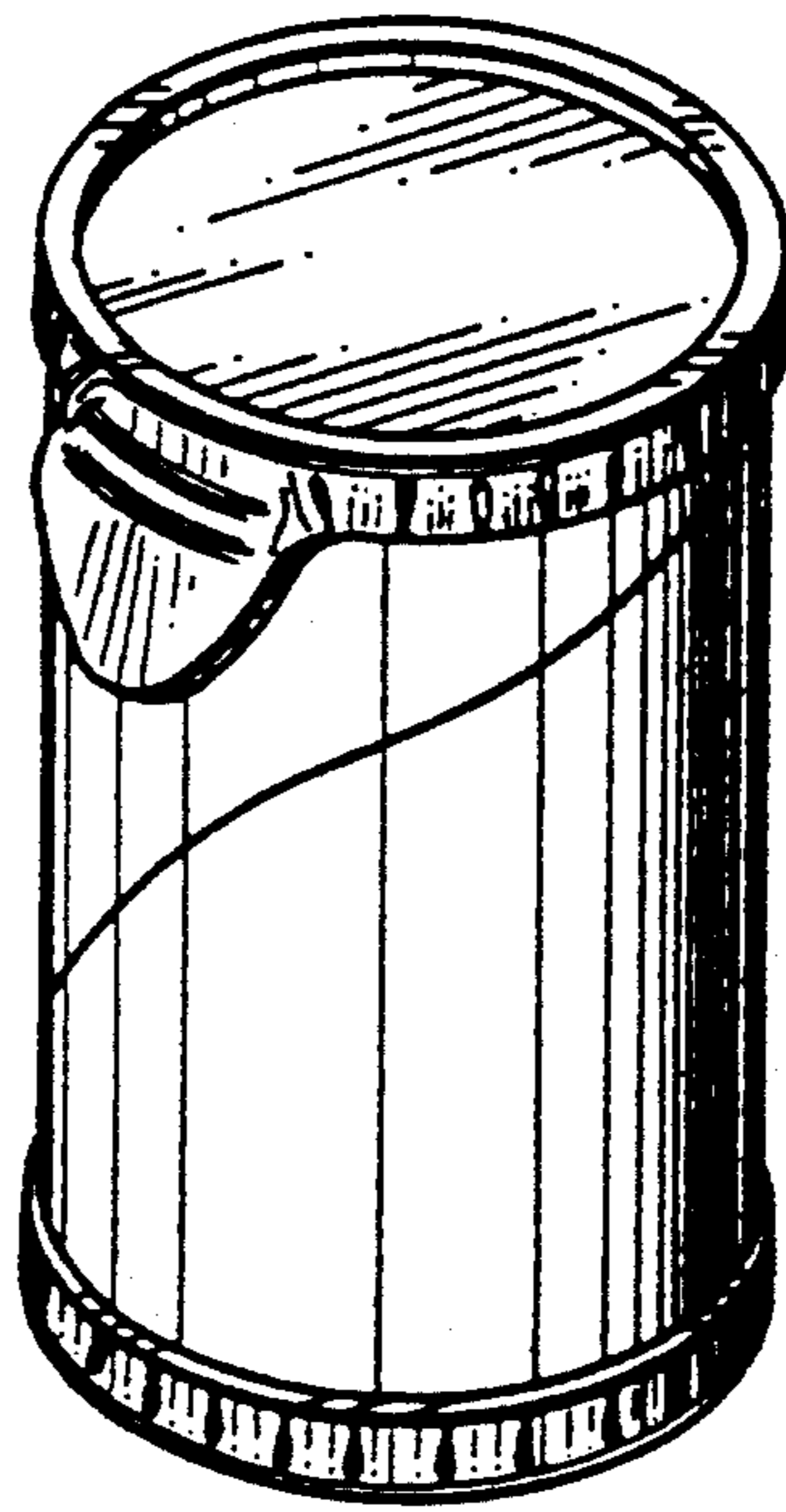

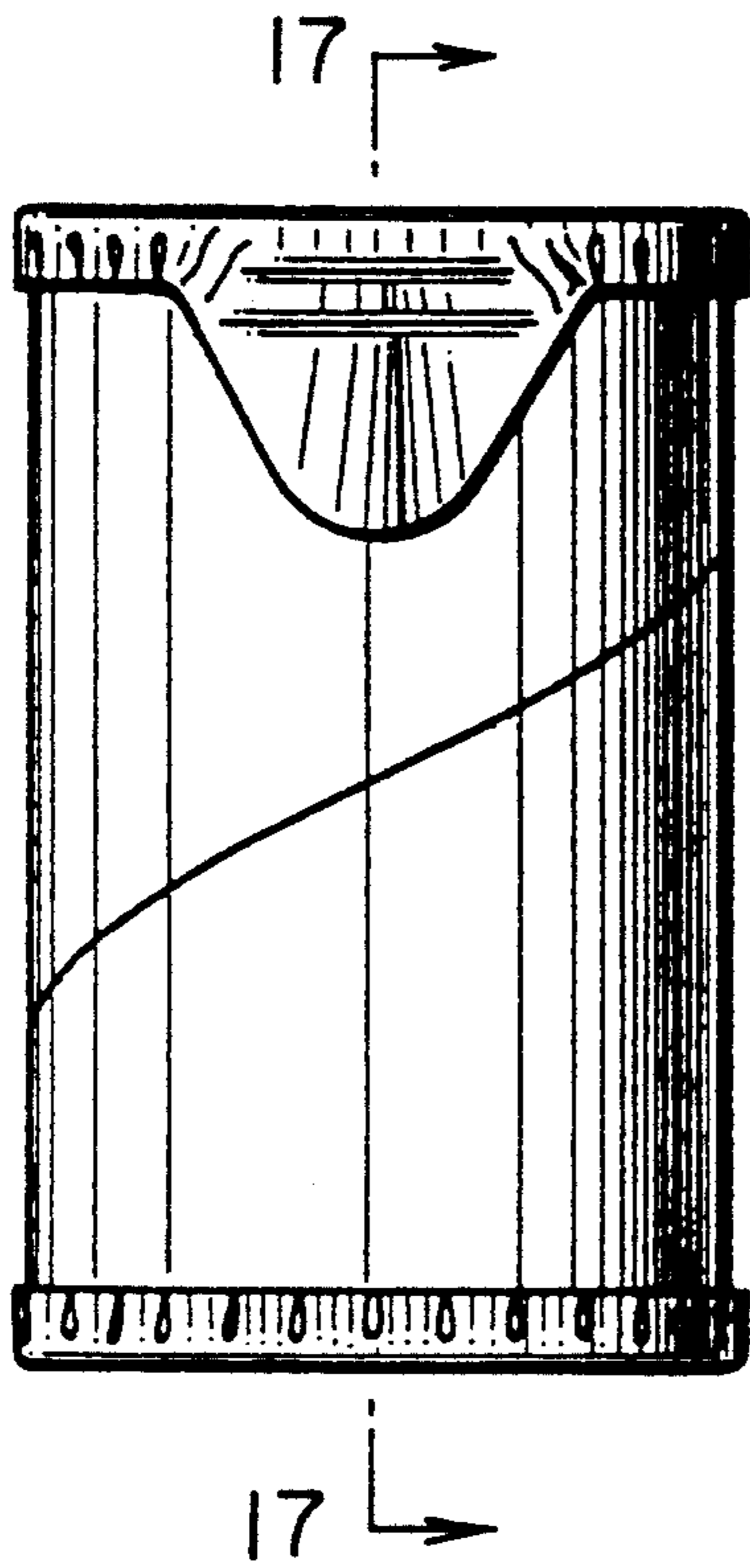

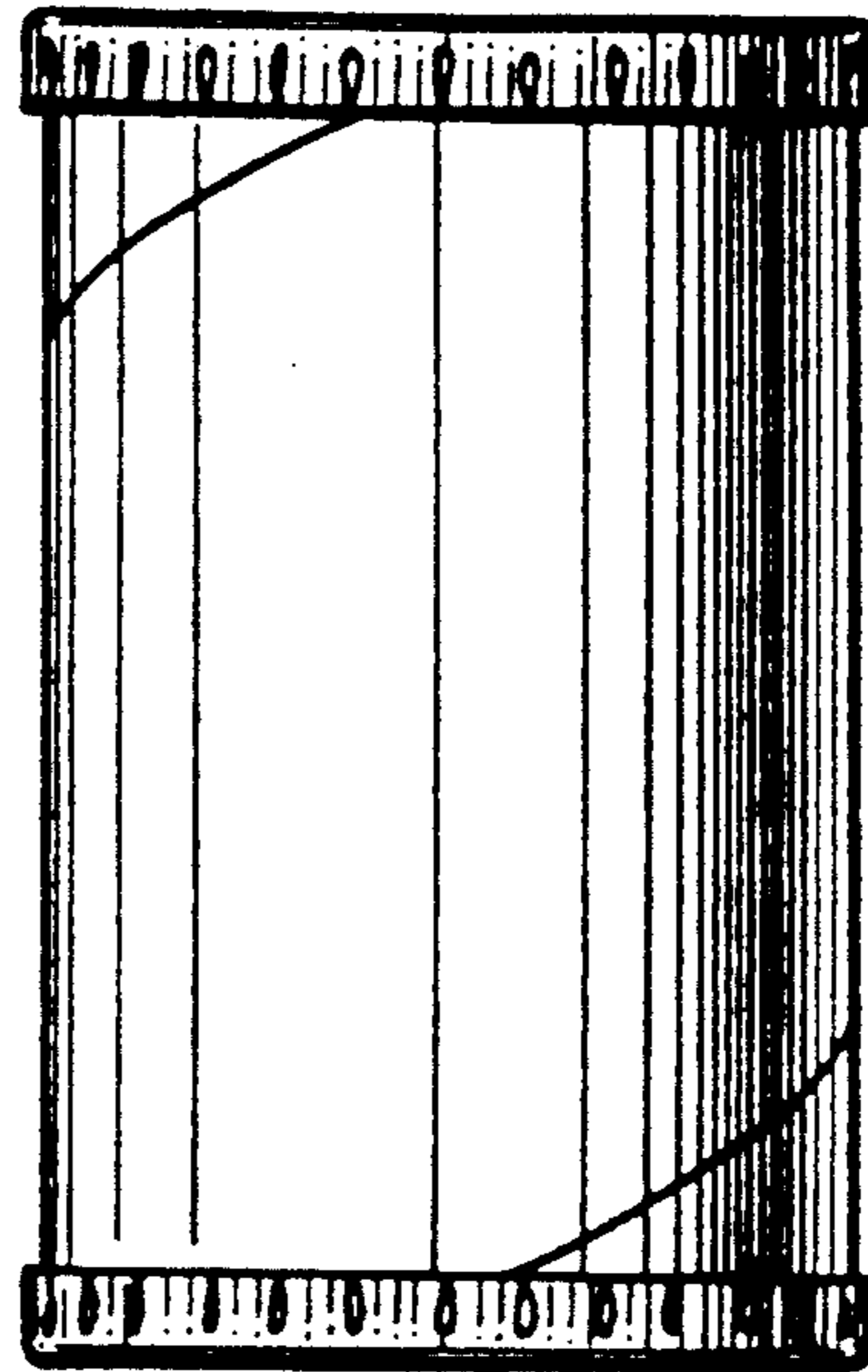

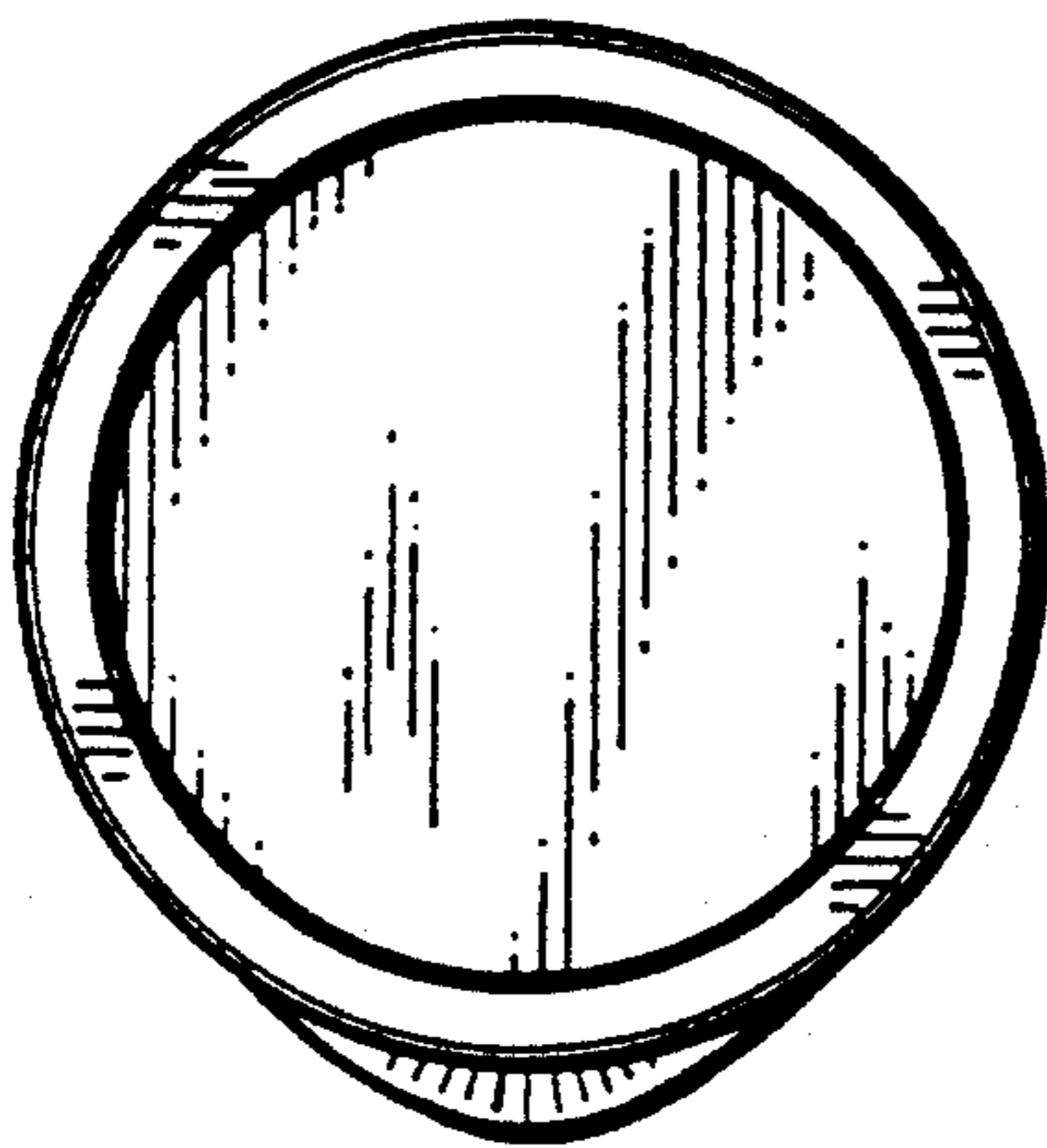

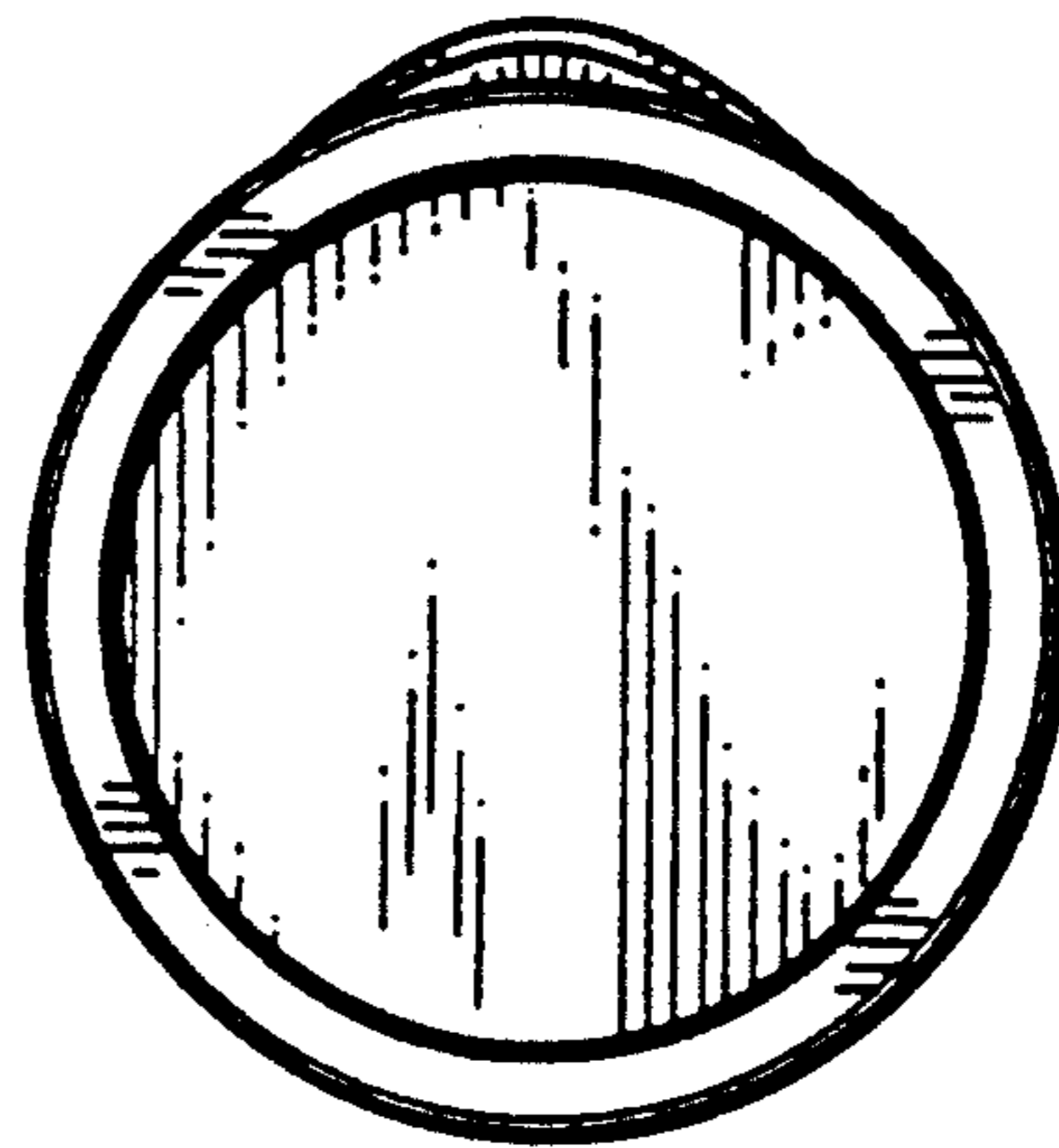

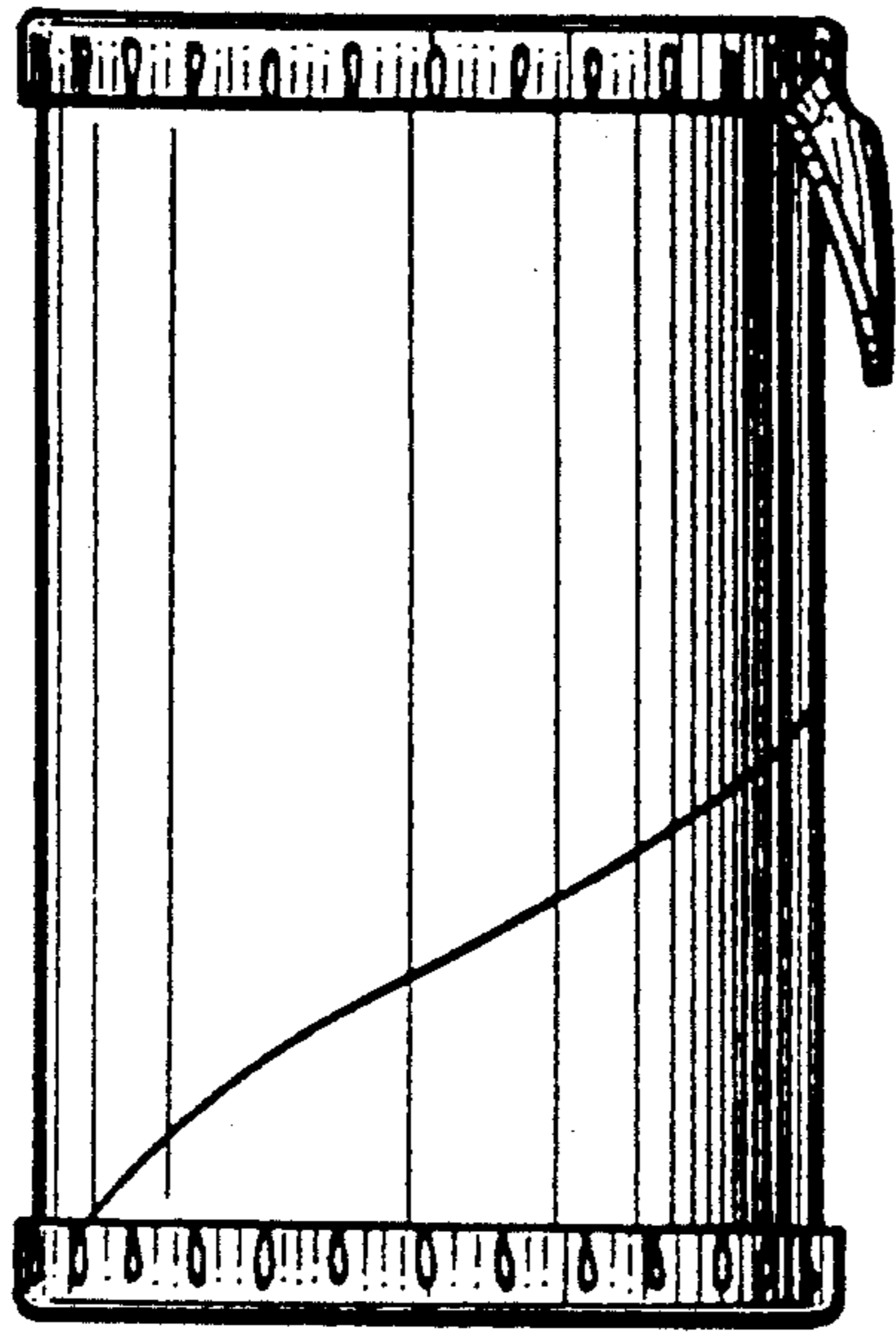

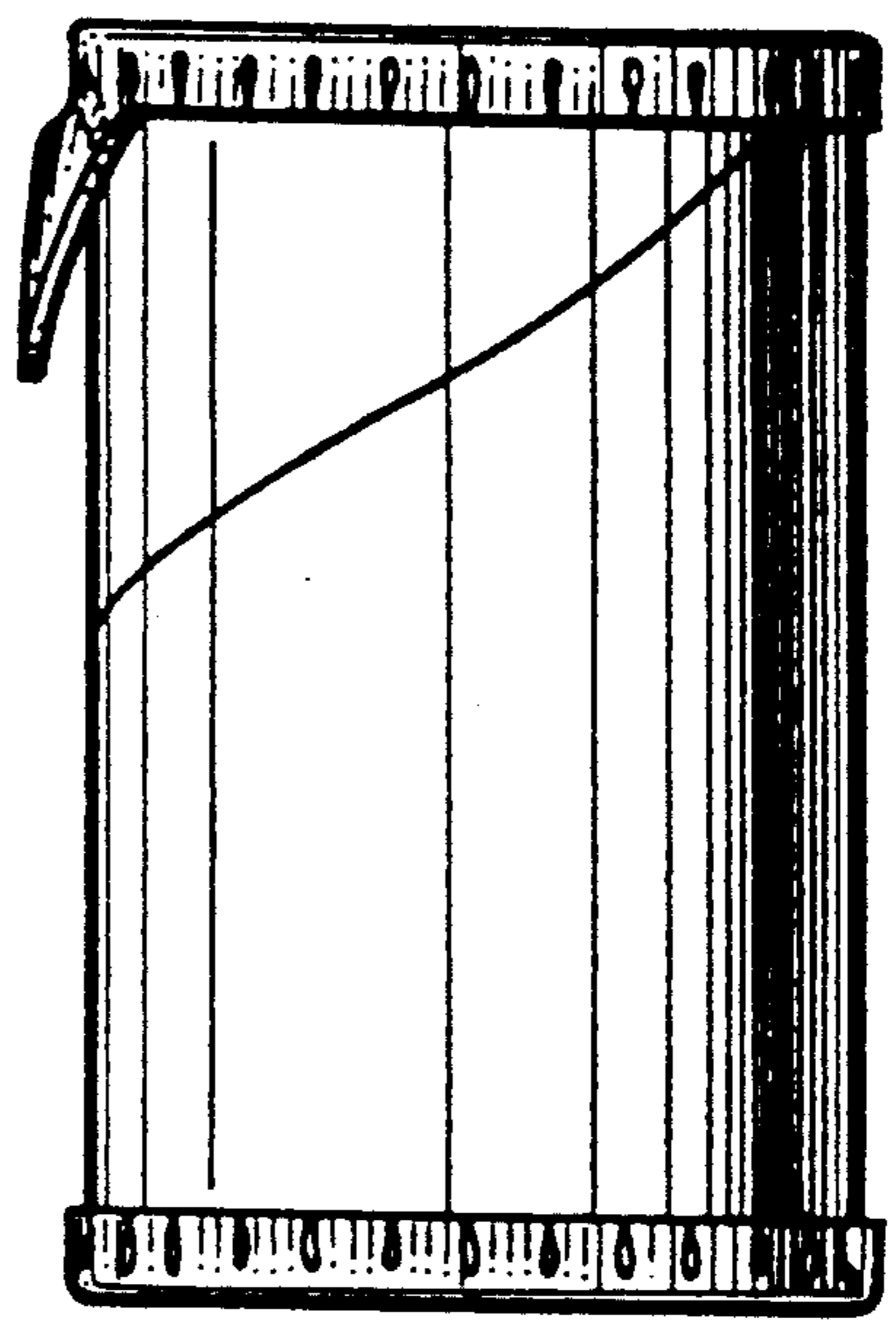

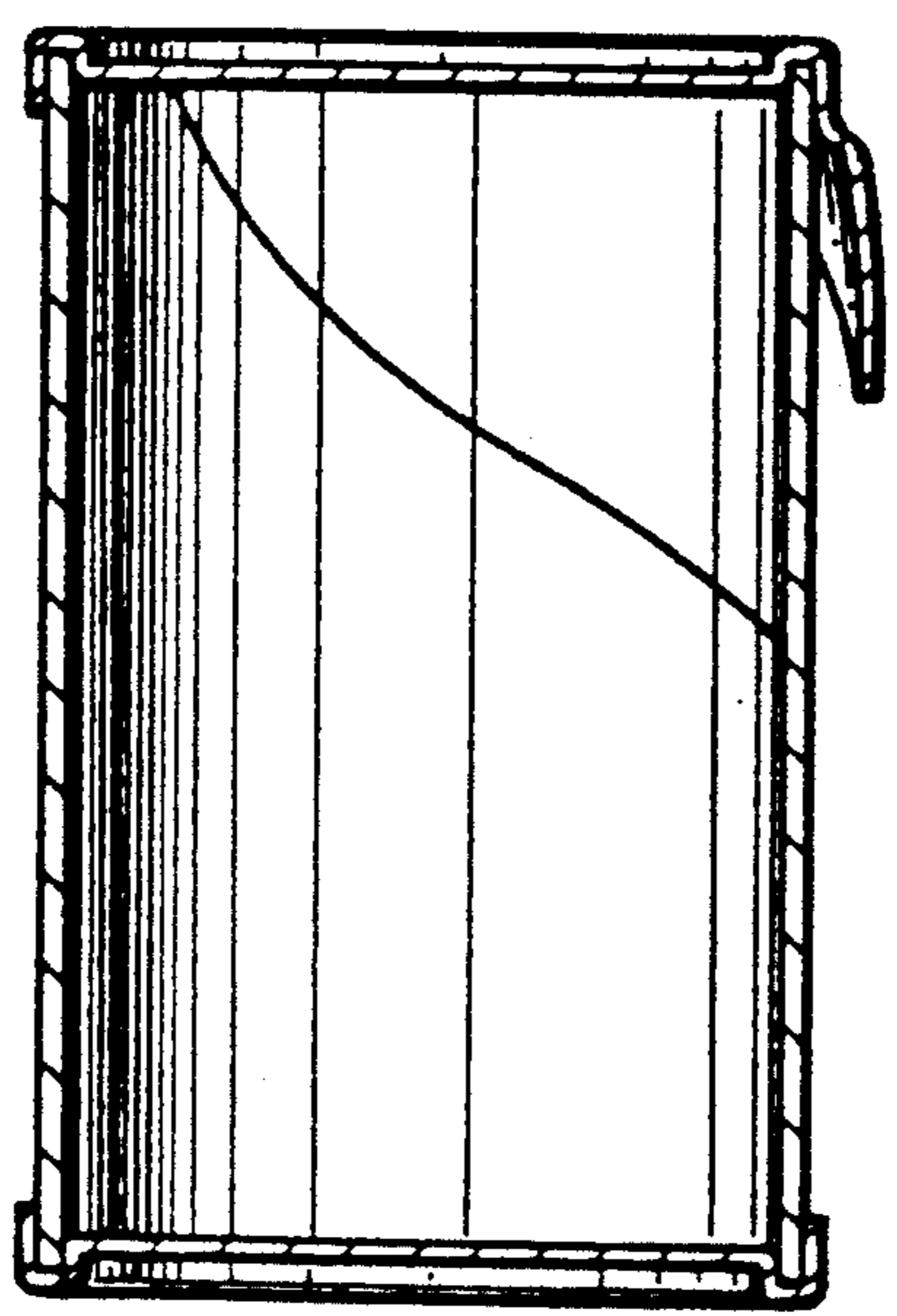
