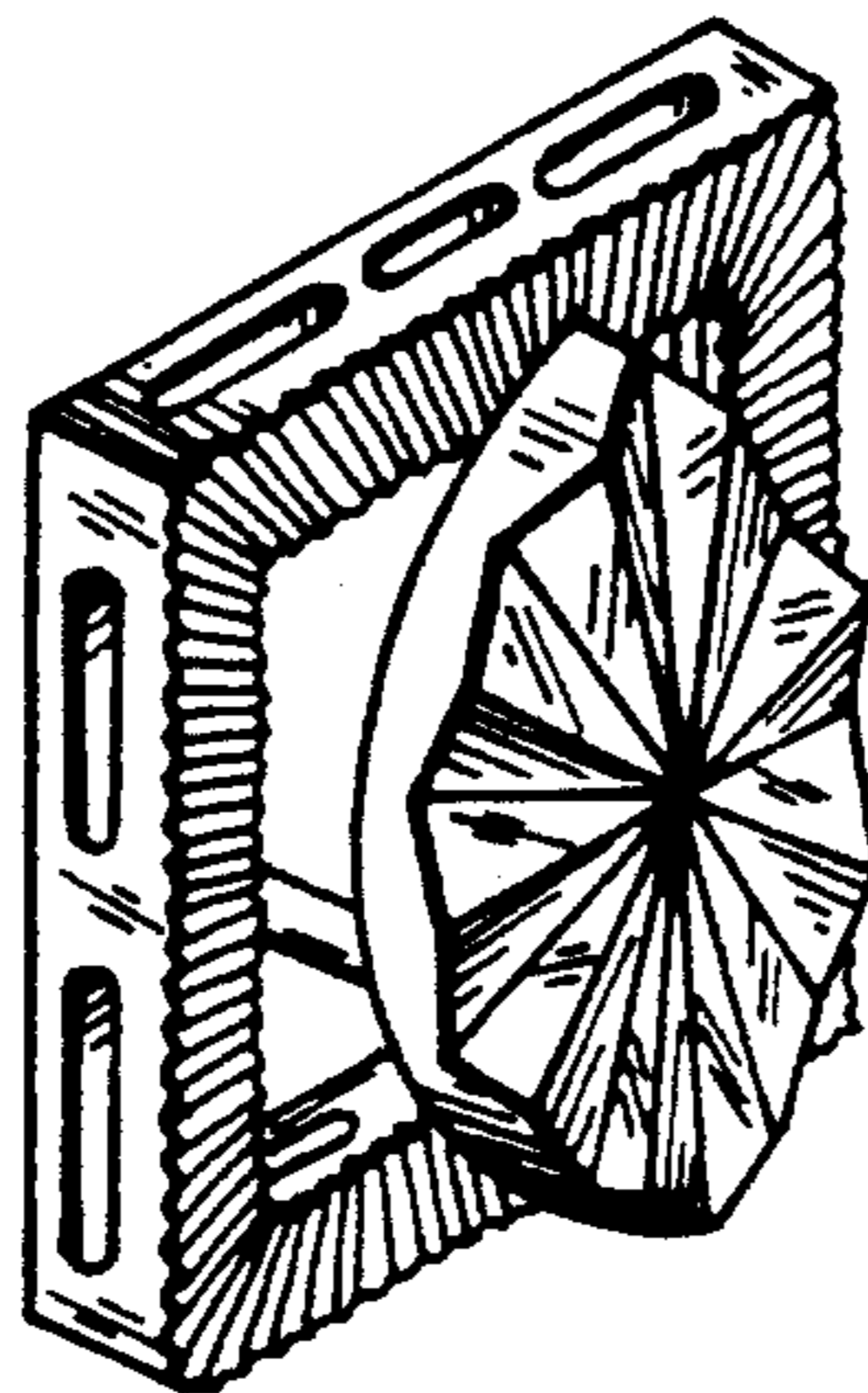


FIG. 22 is a perspective view of a jewelry link showing a fourth embodiment of my new design;

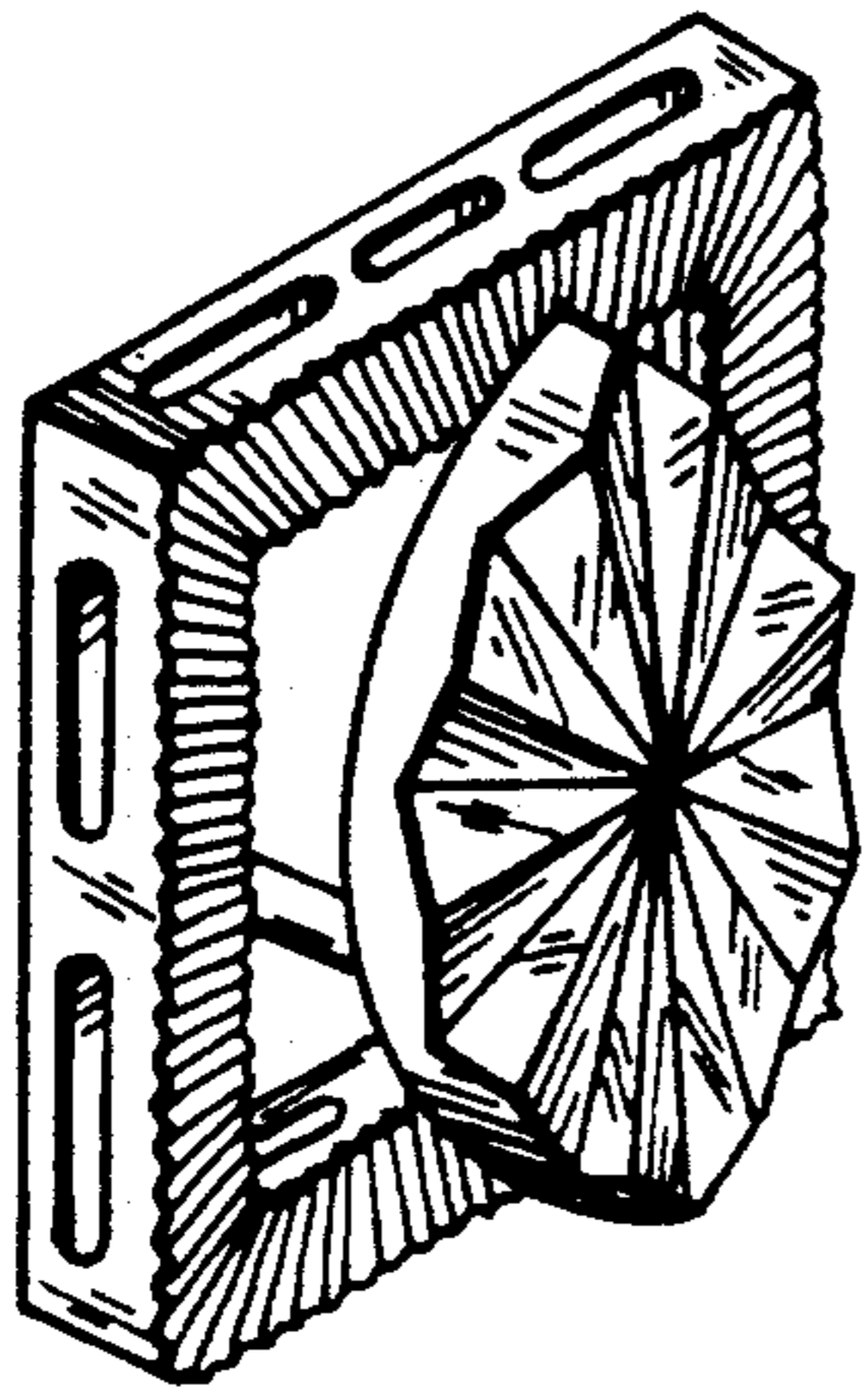

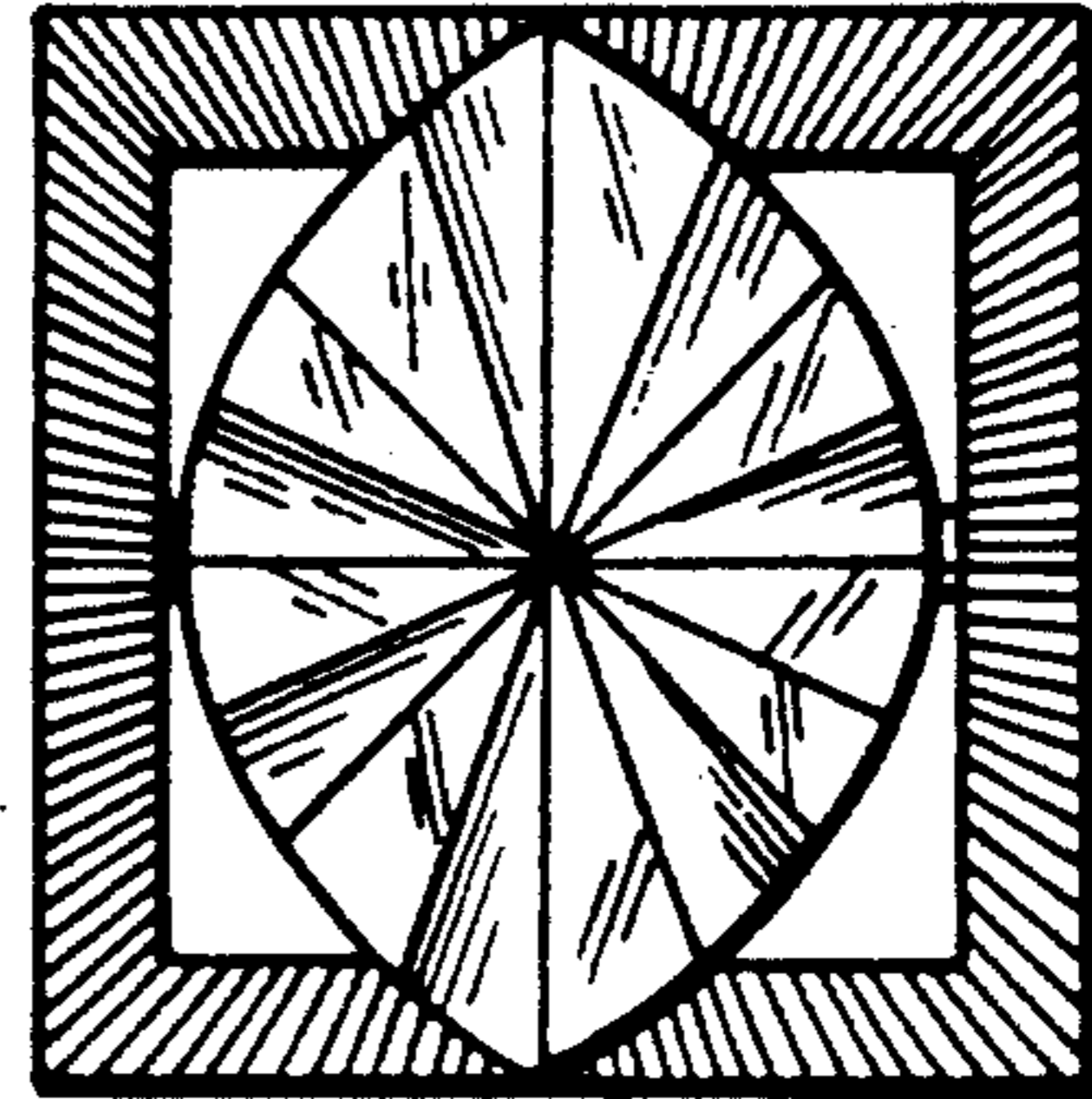

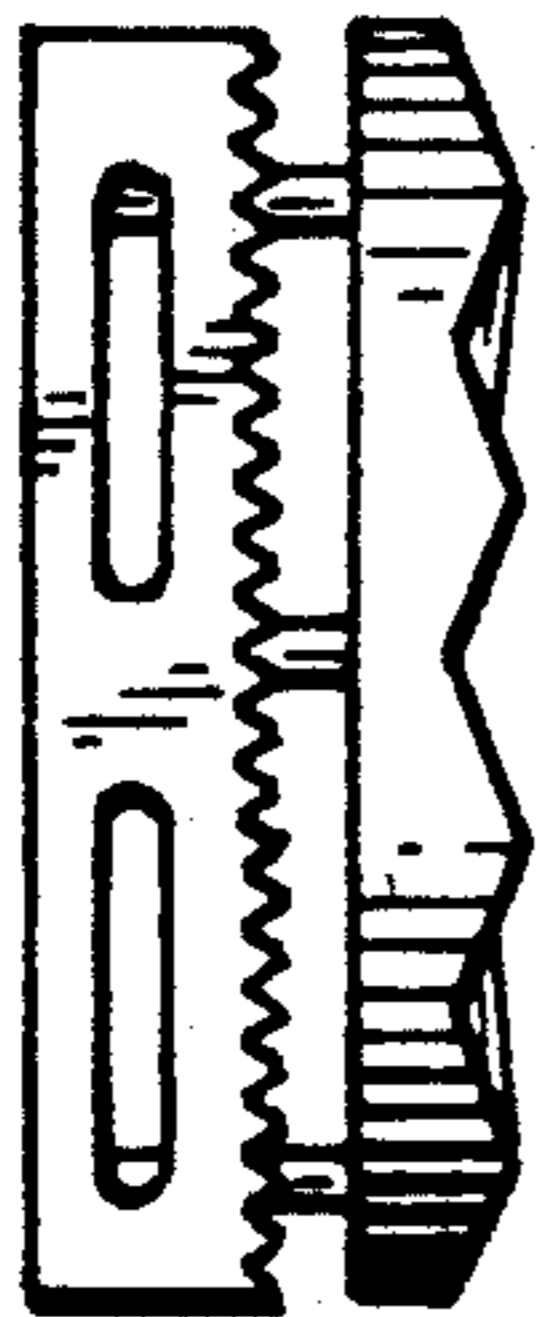

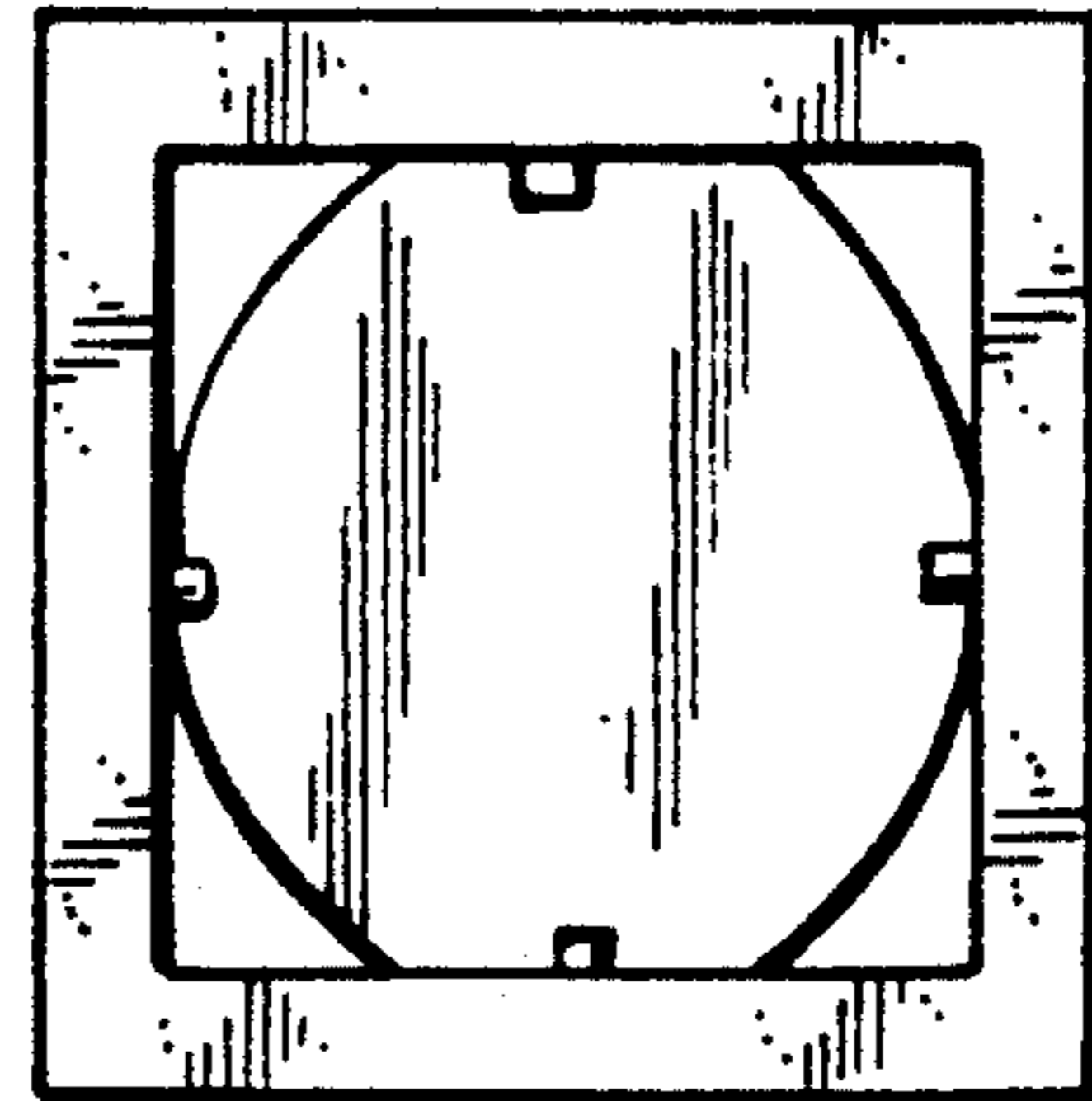

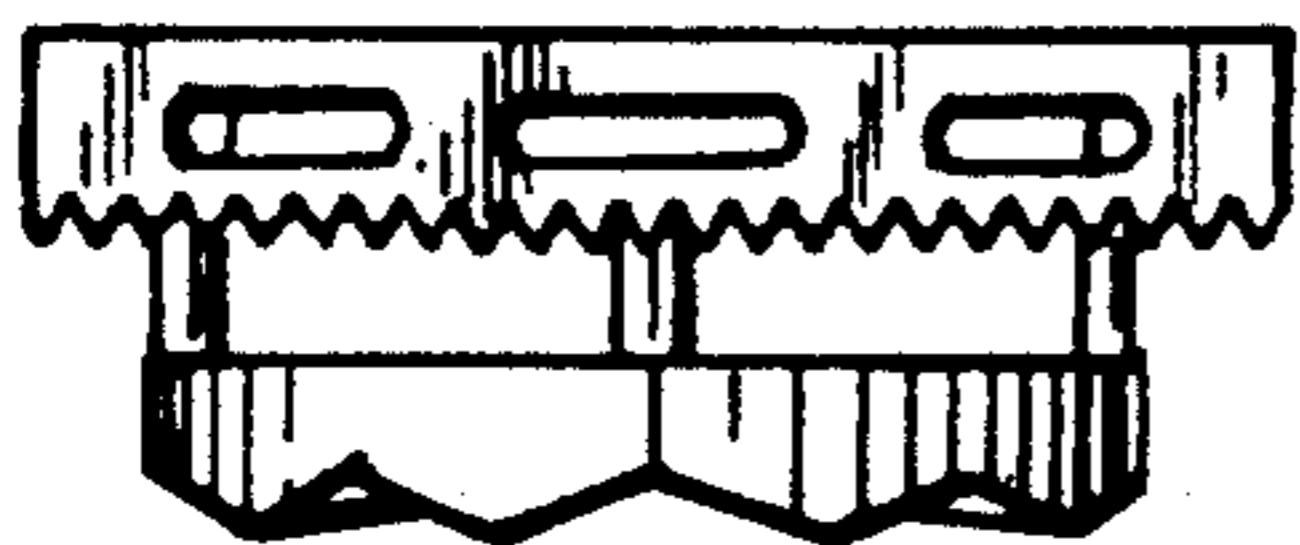

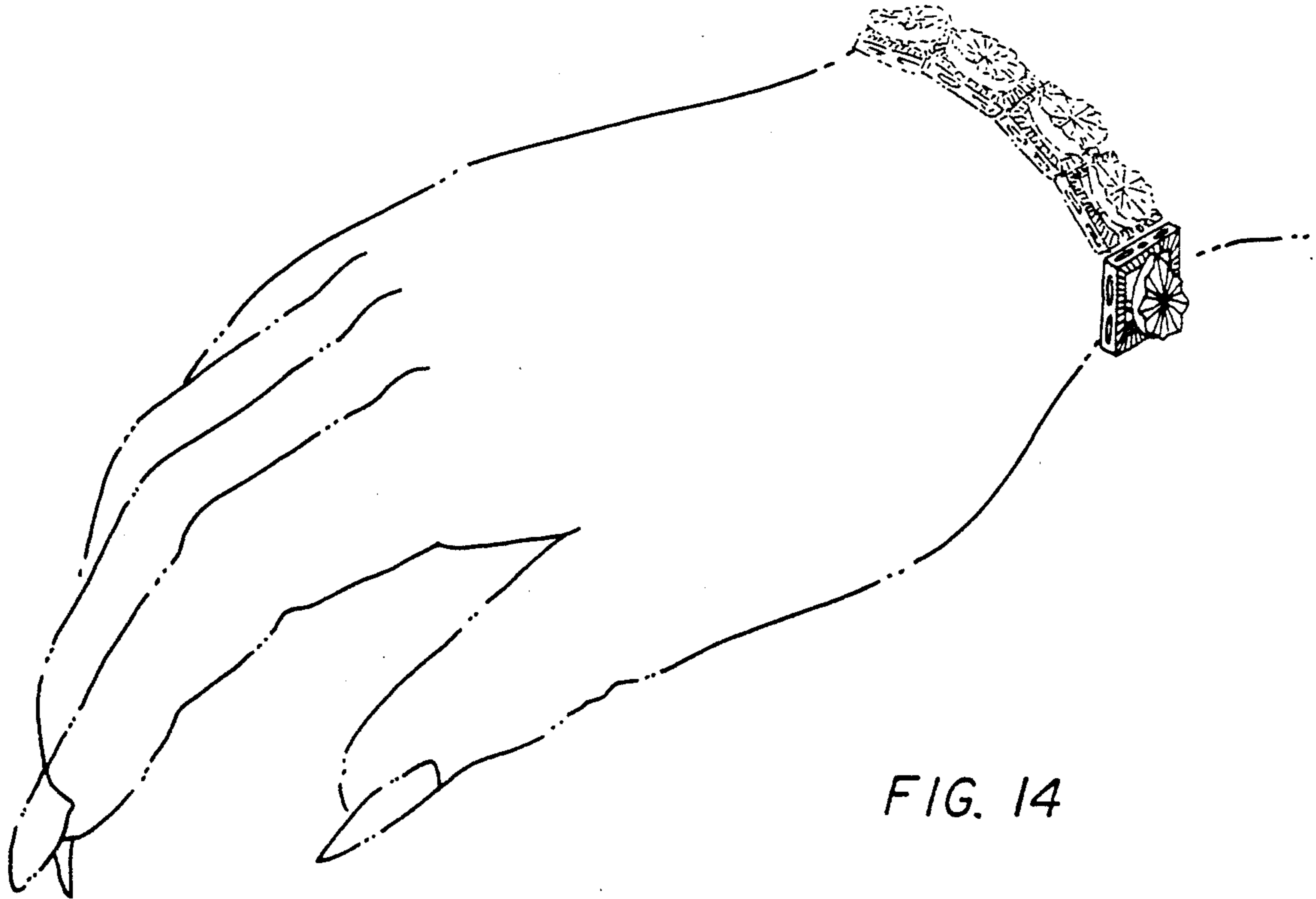
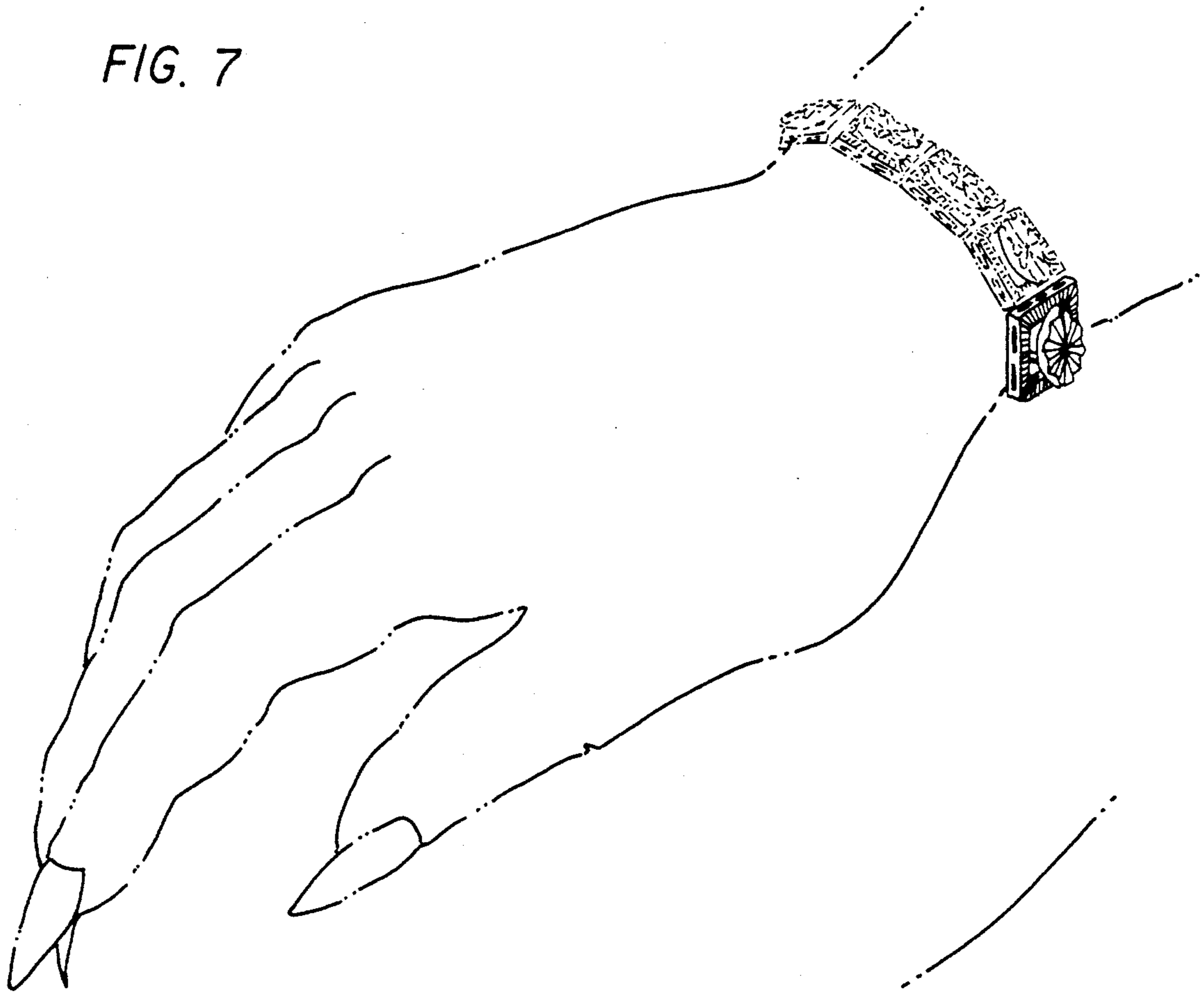
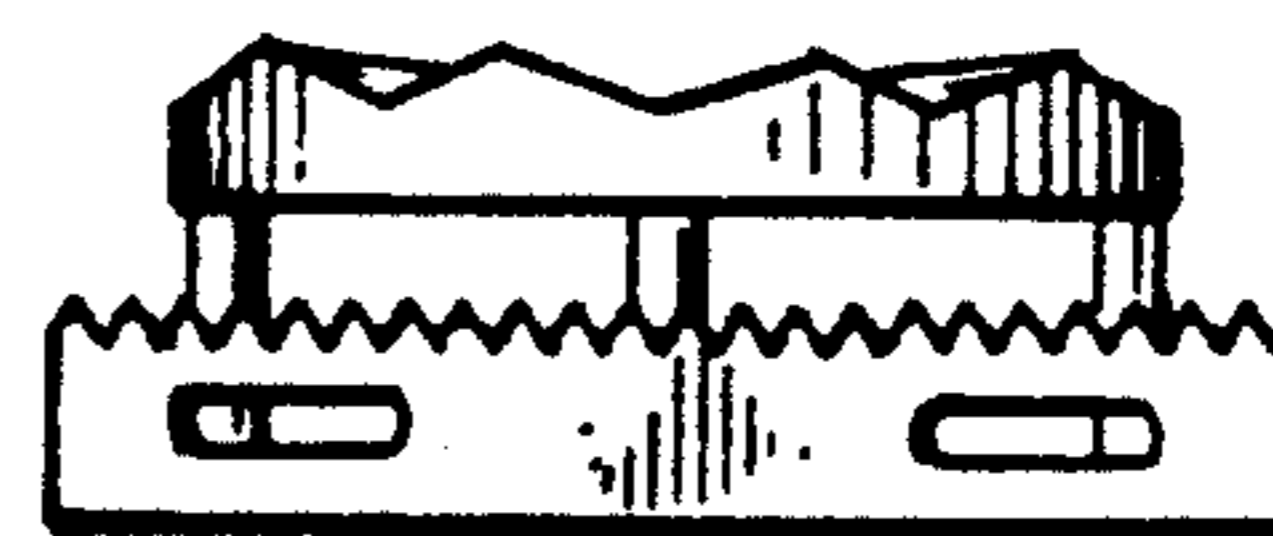
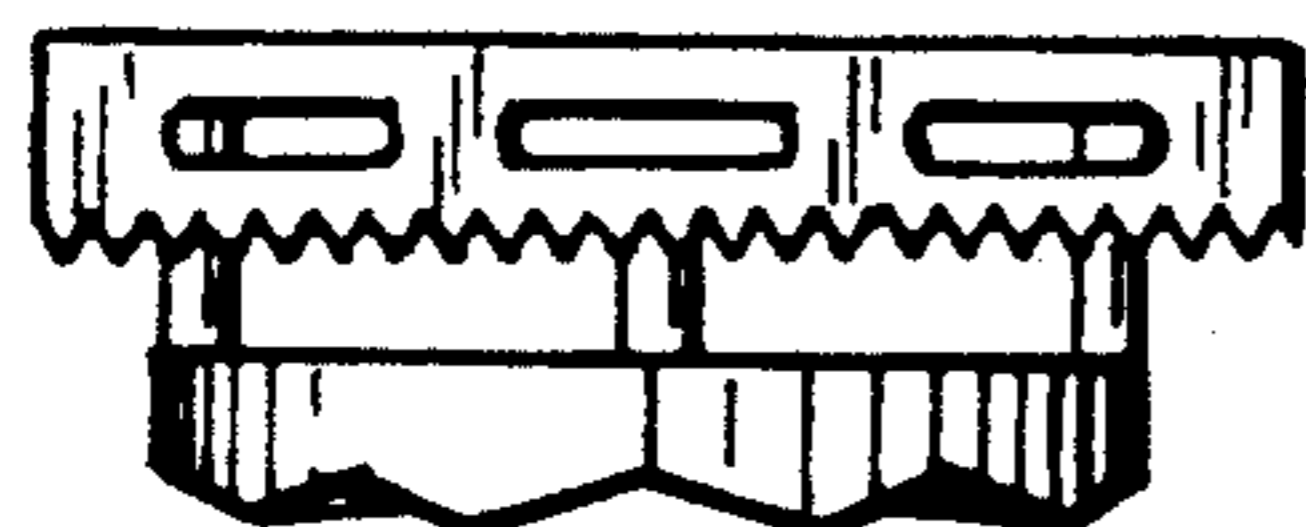
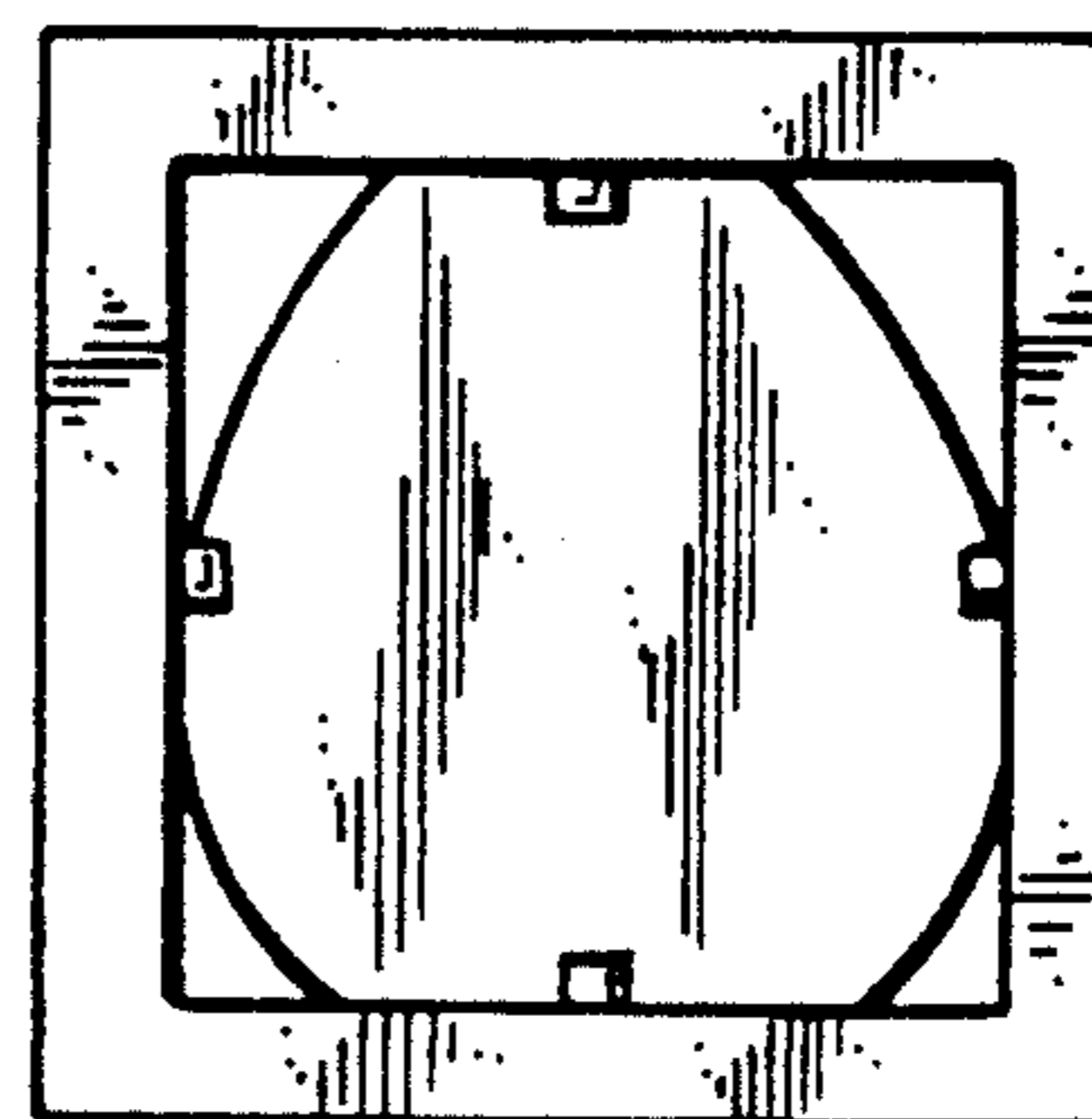
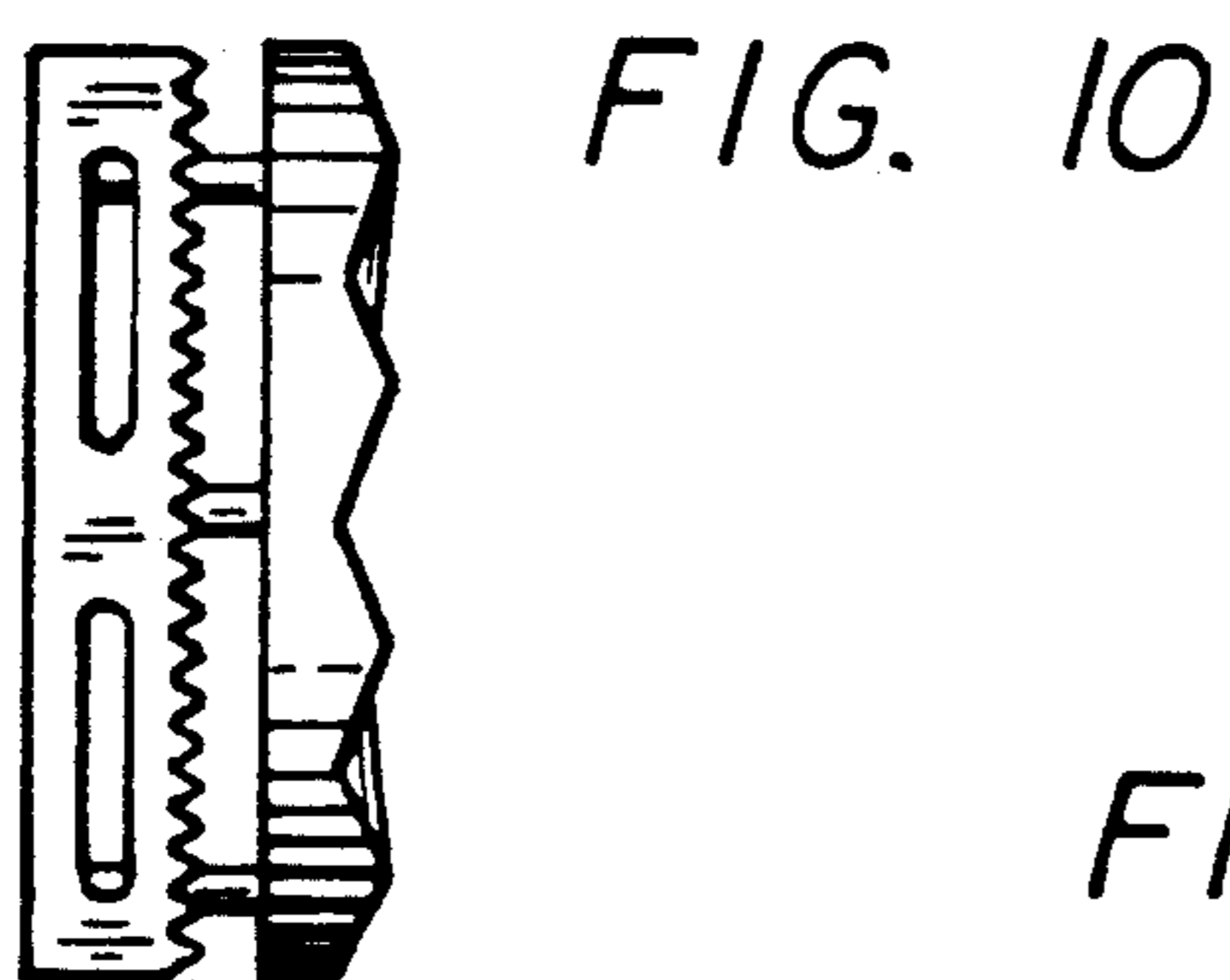
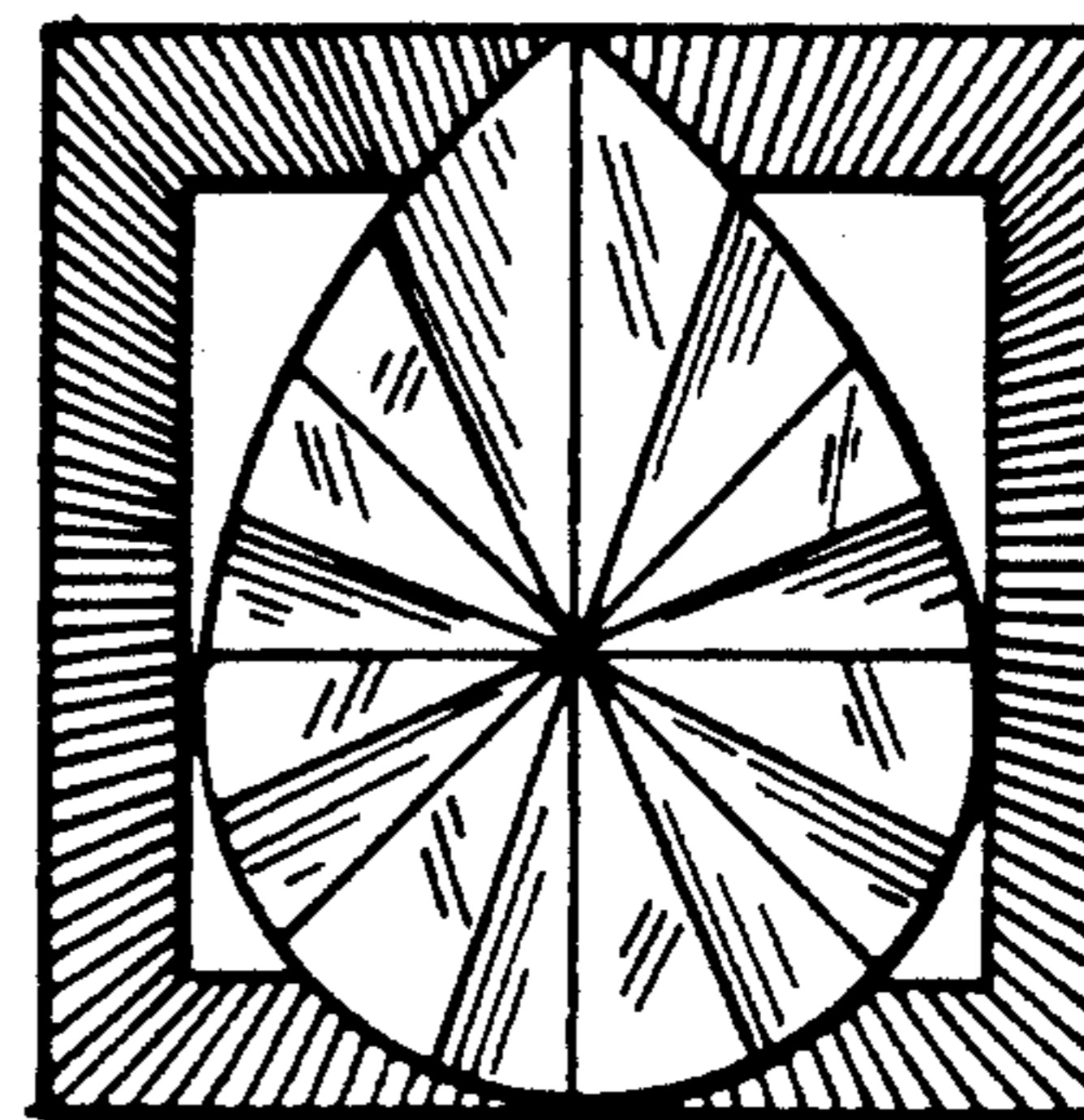
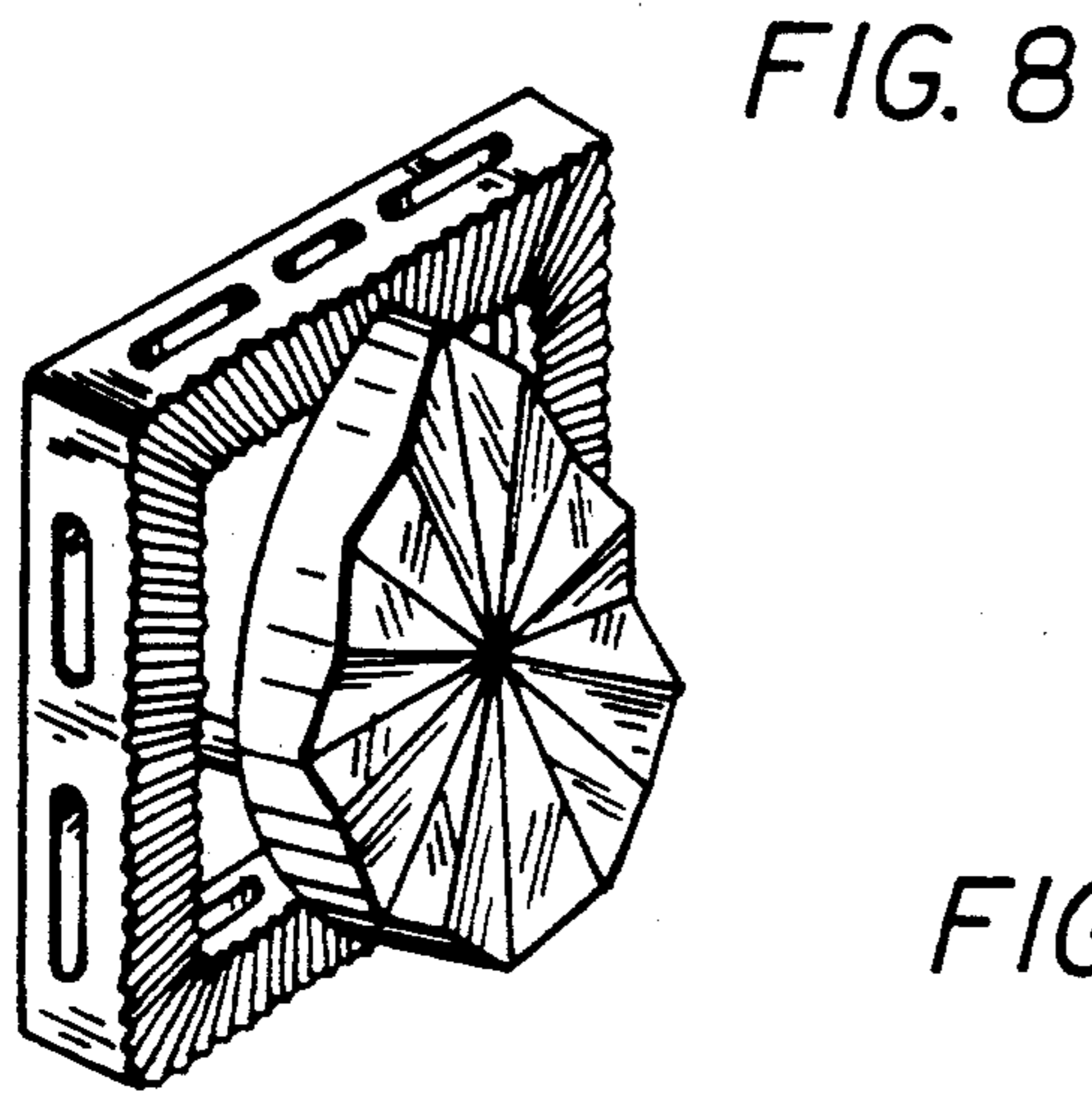

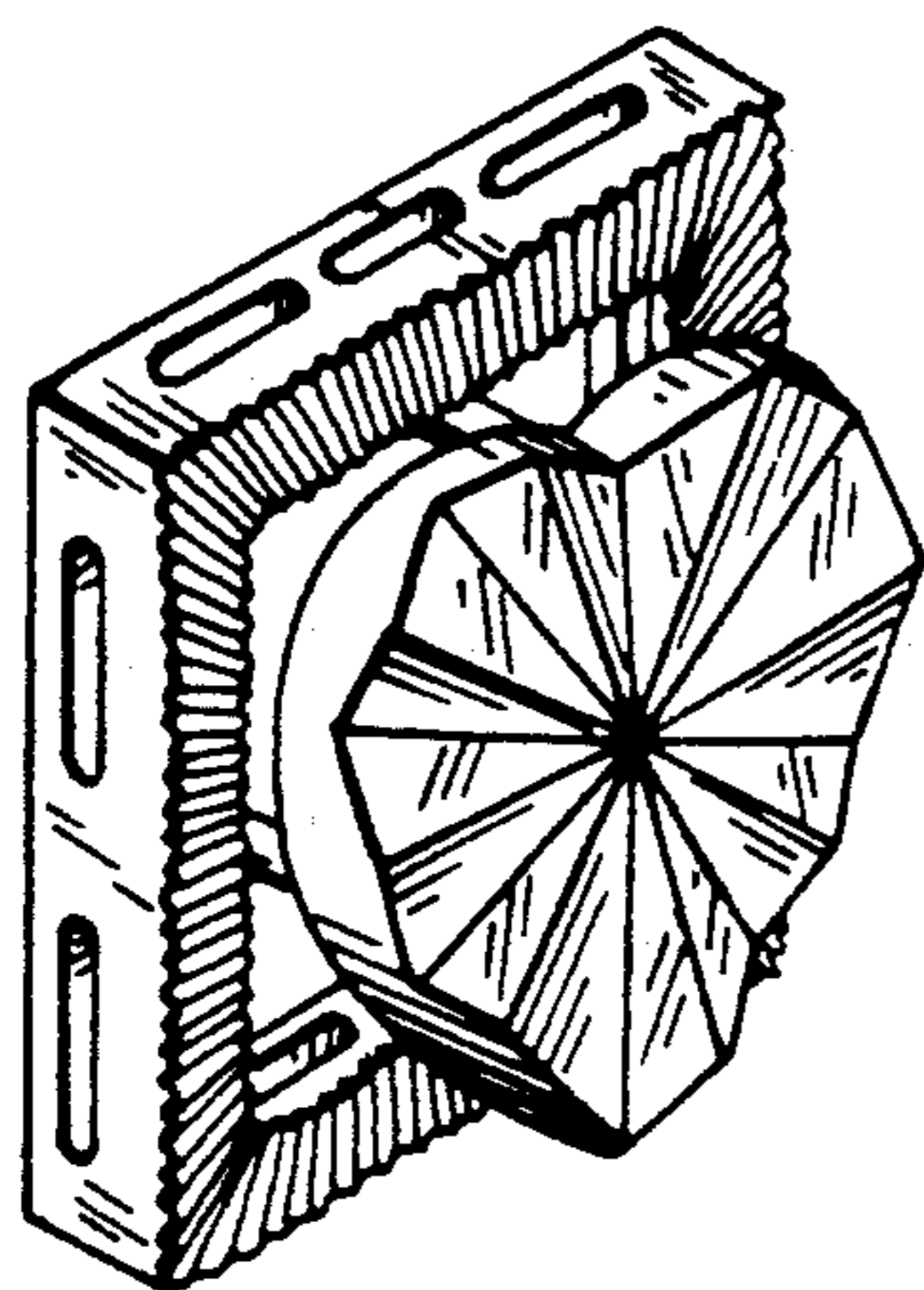

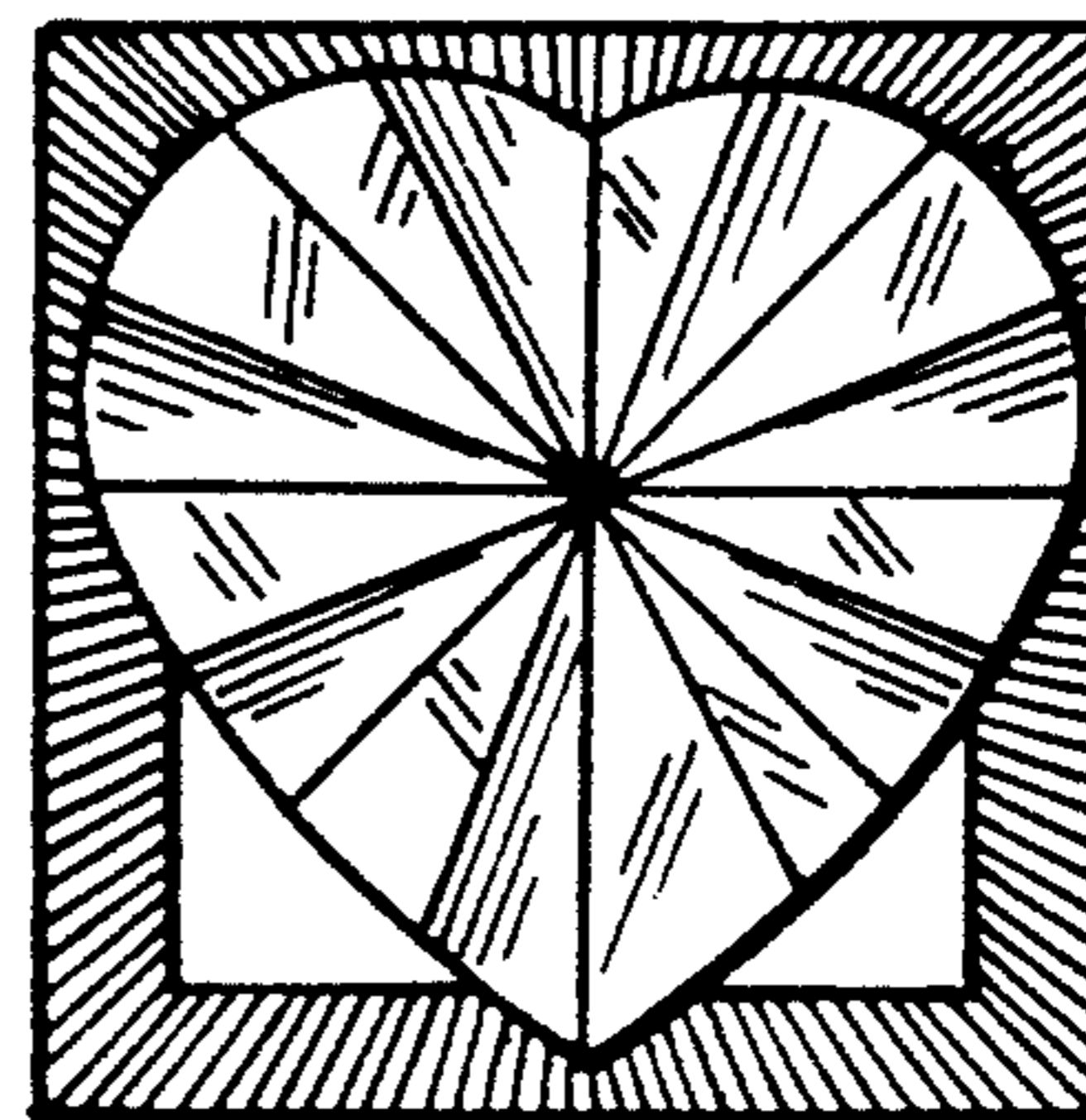

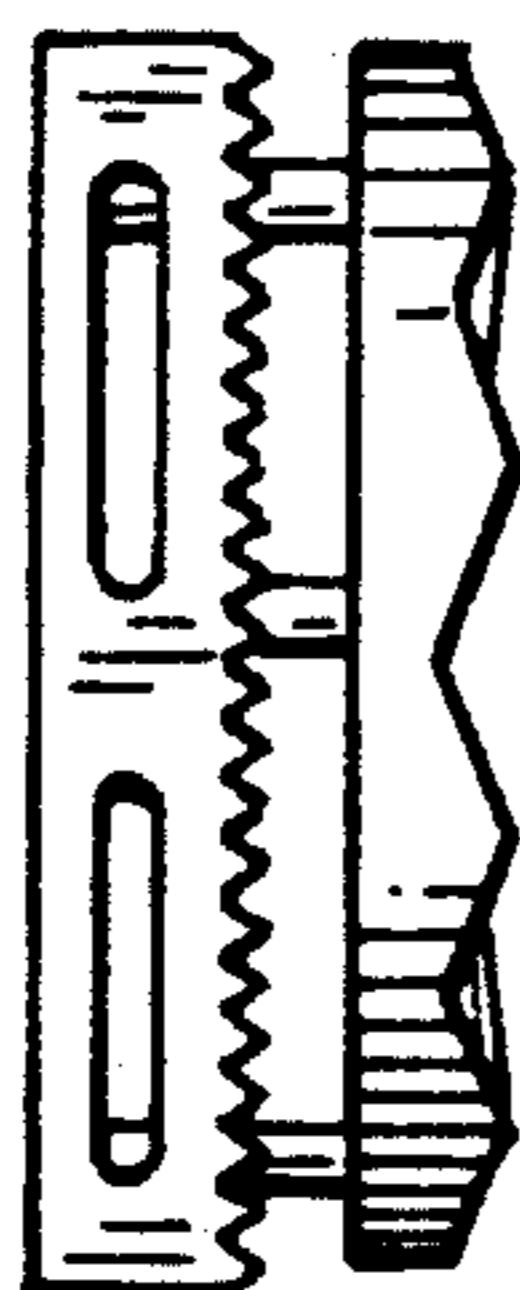

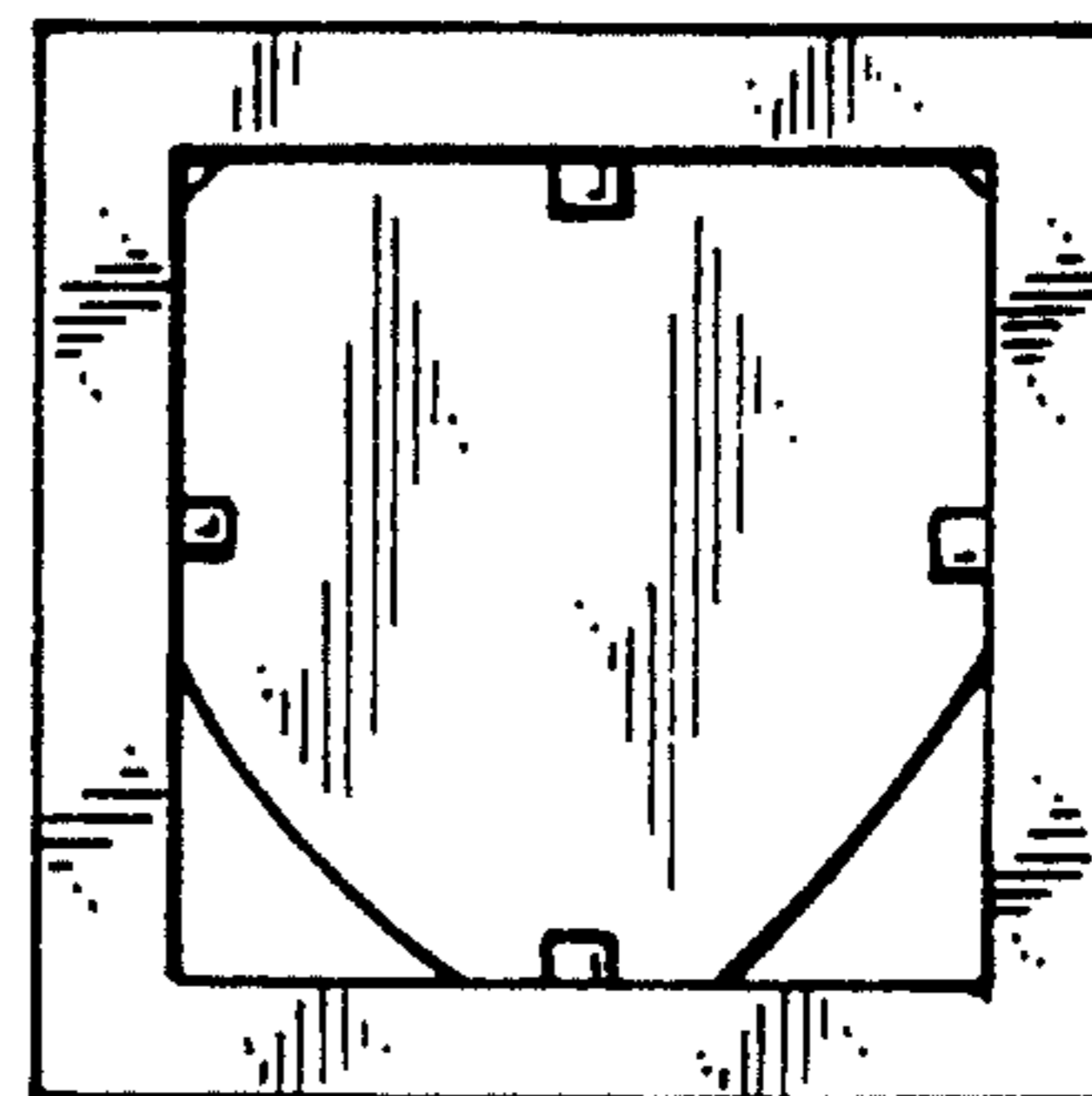

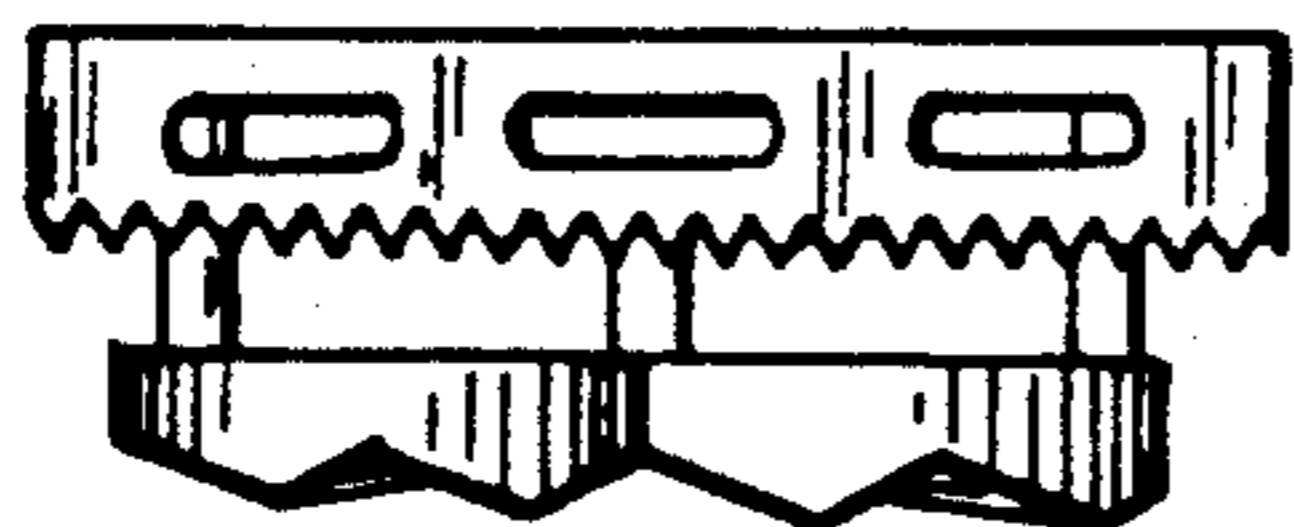

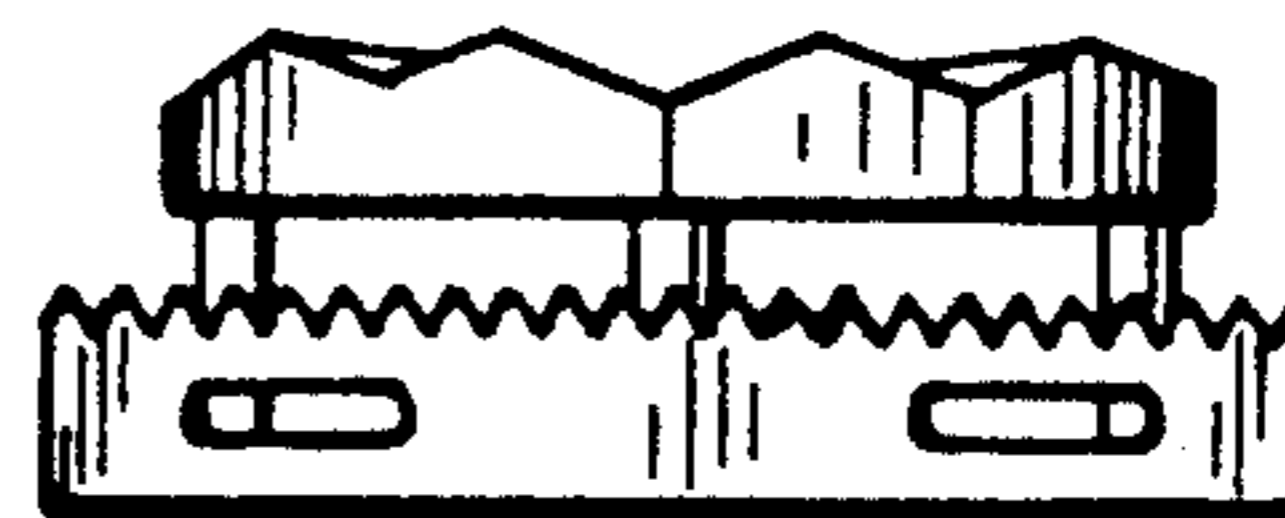

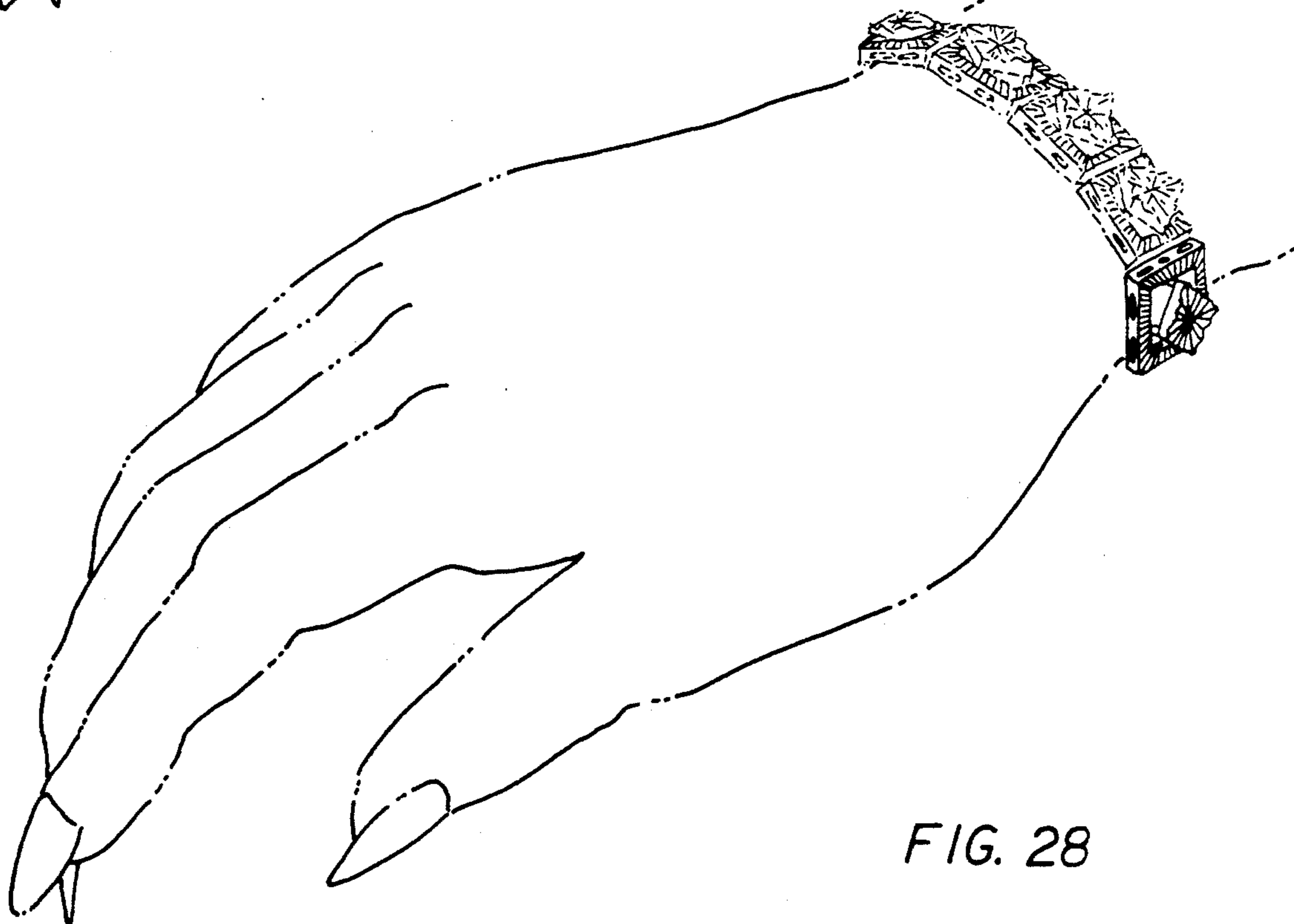
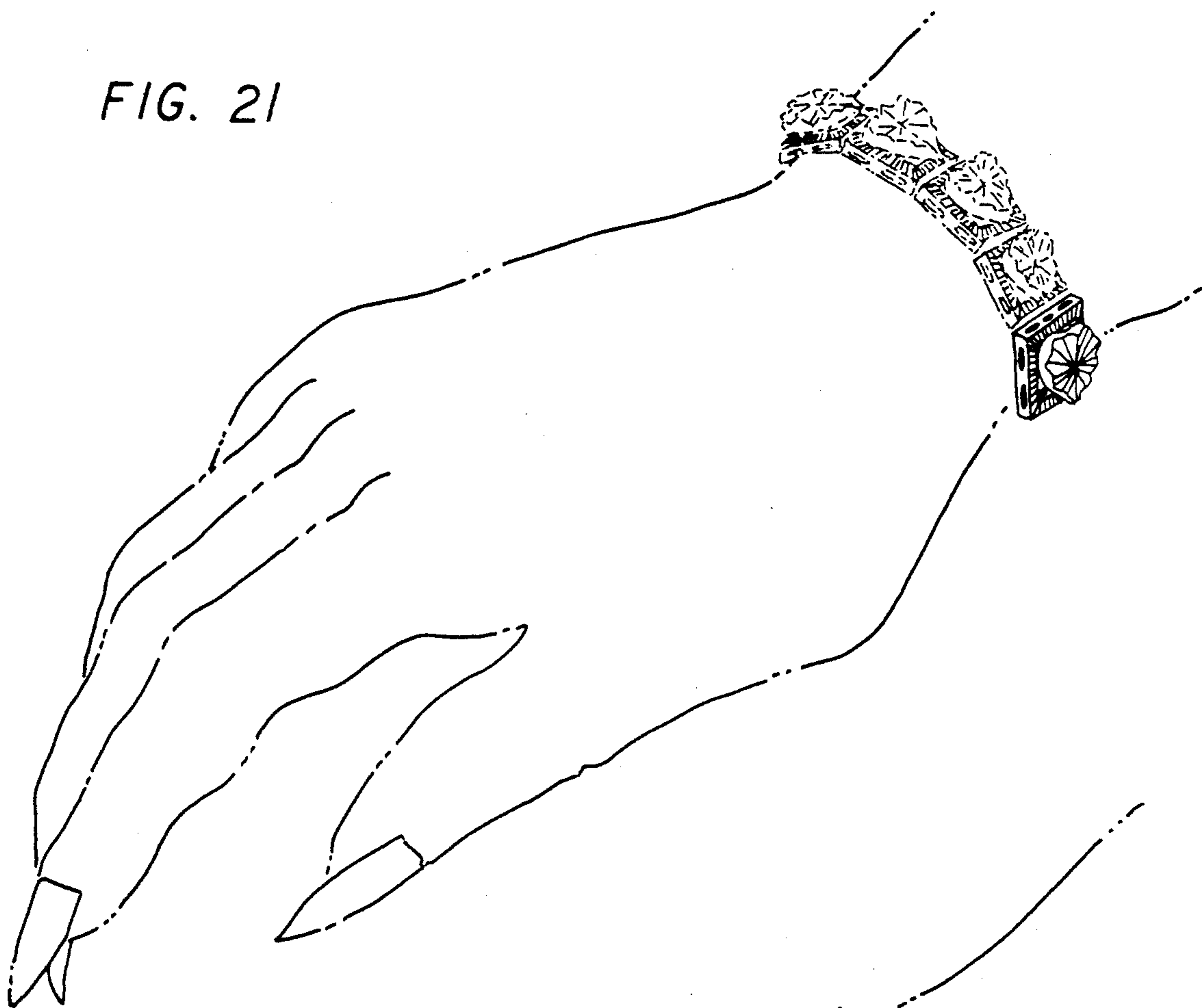

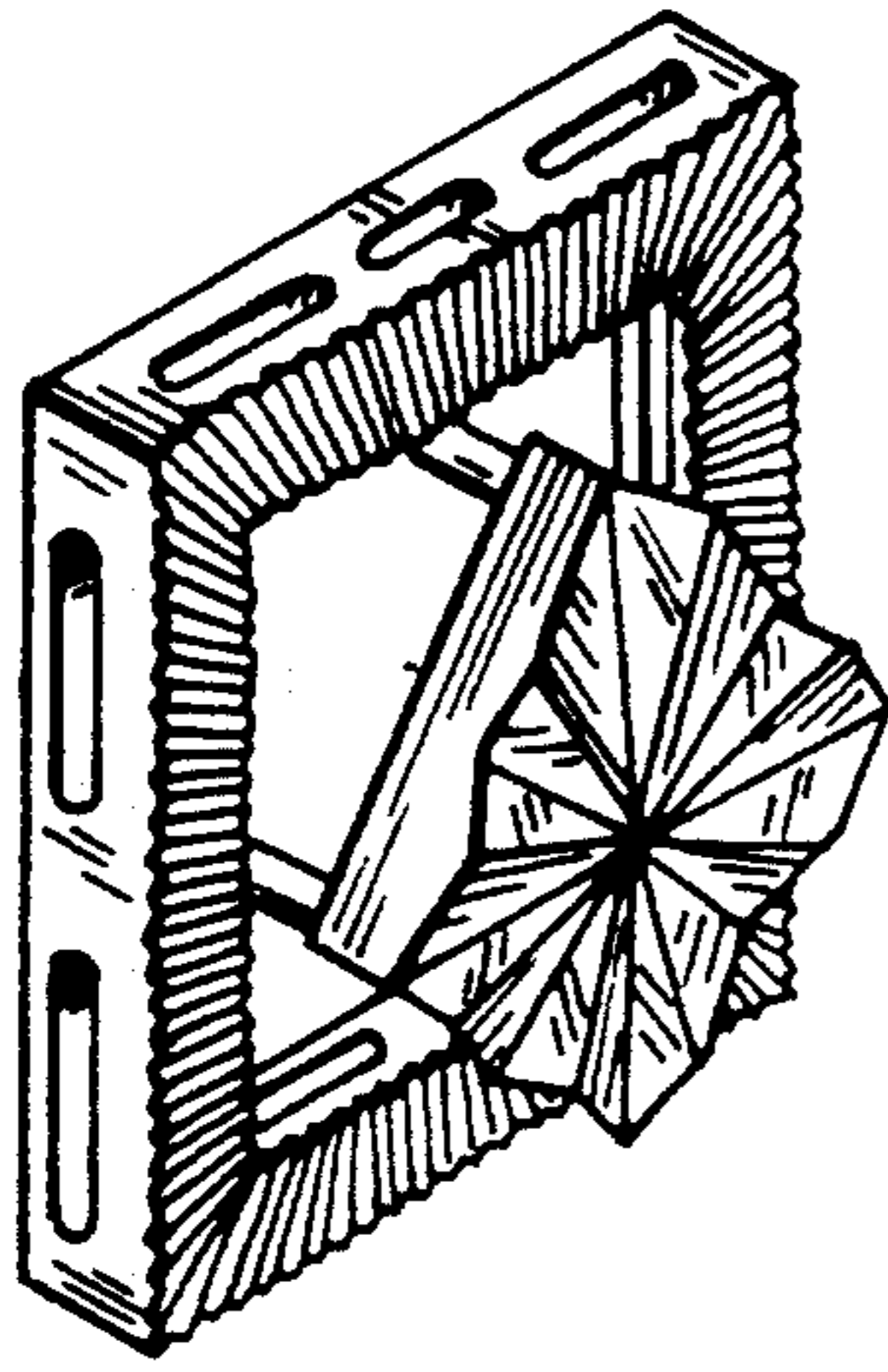

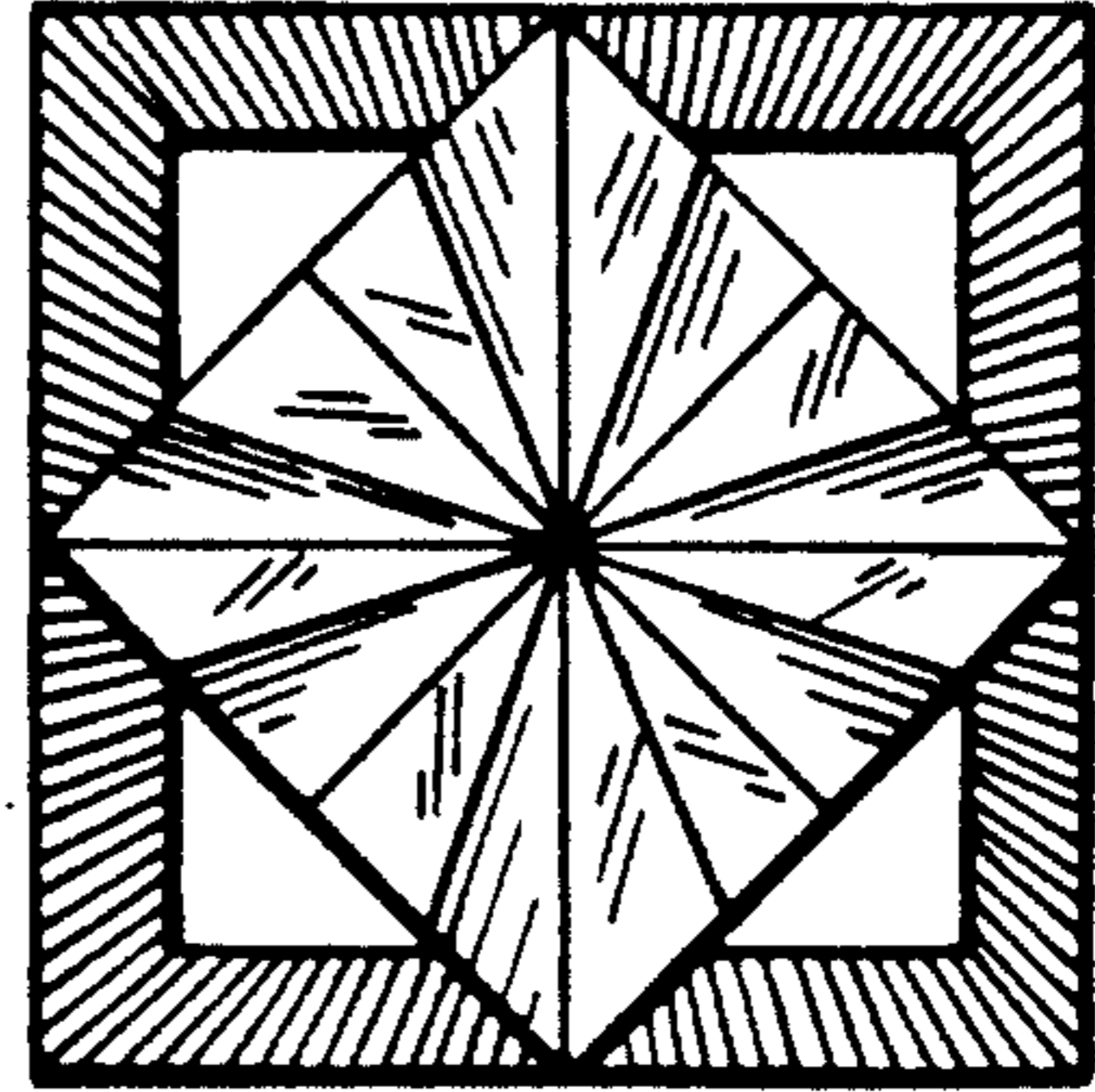

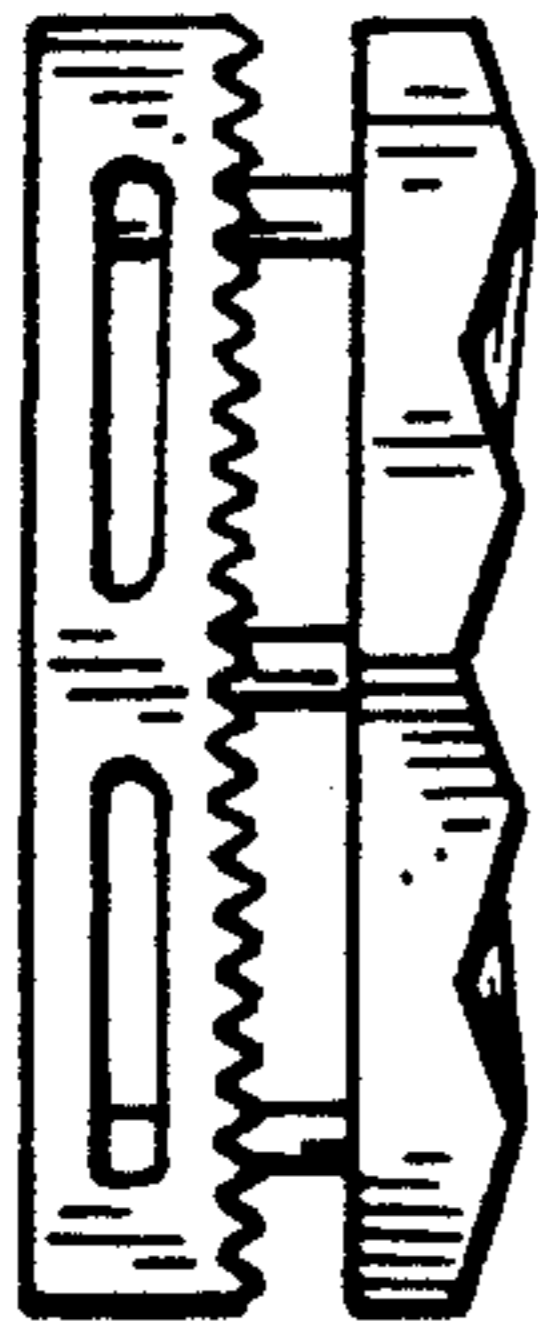

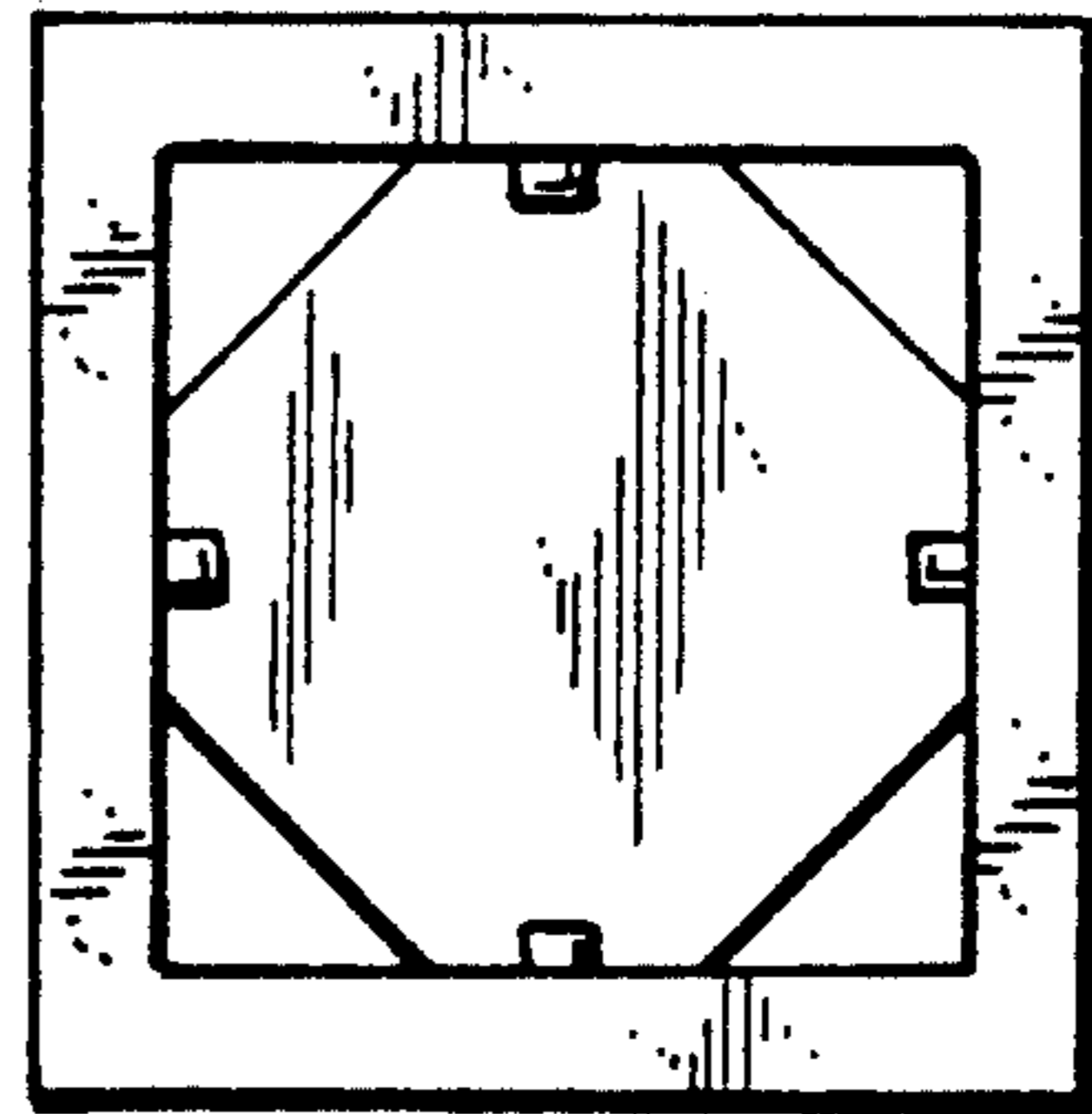

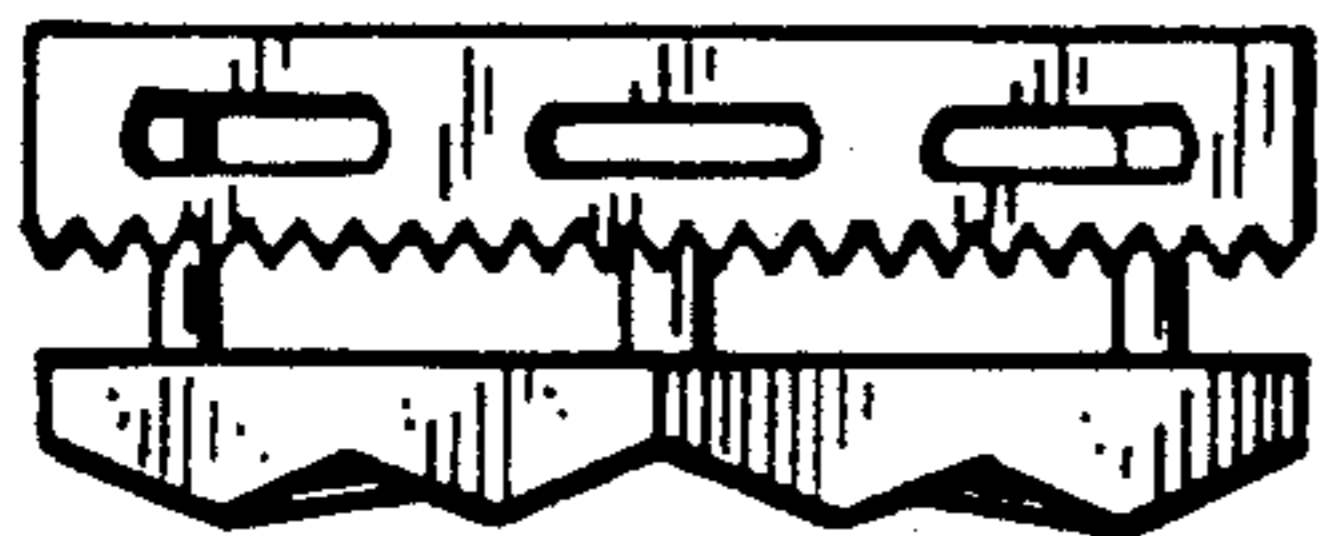

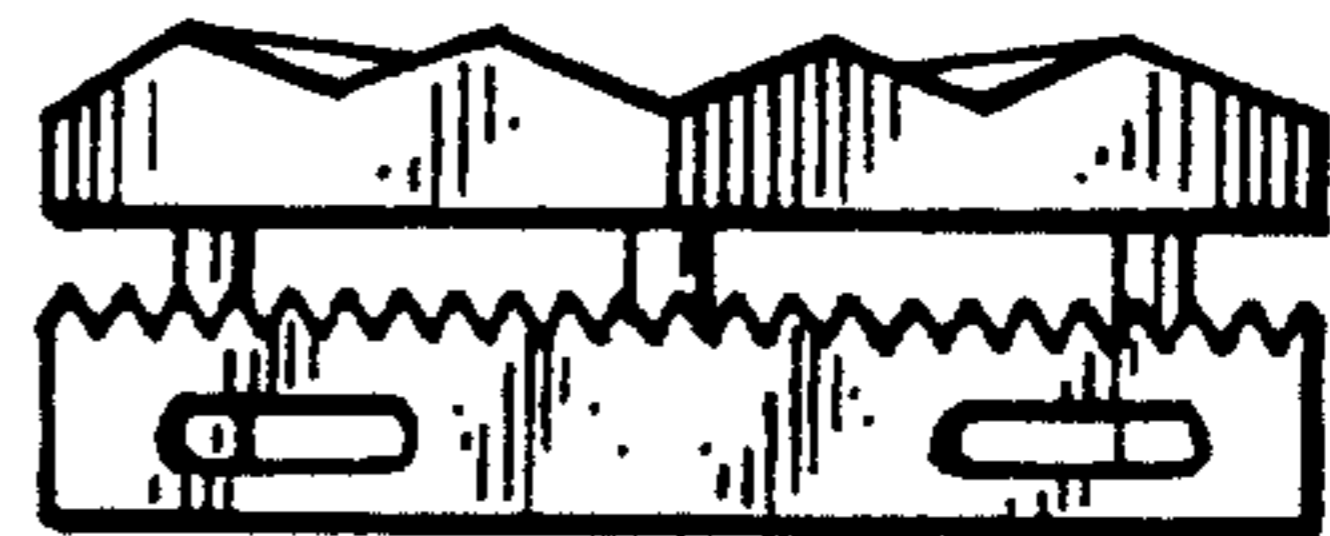

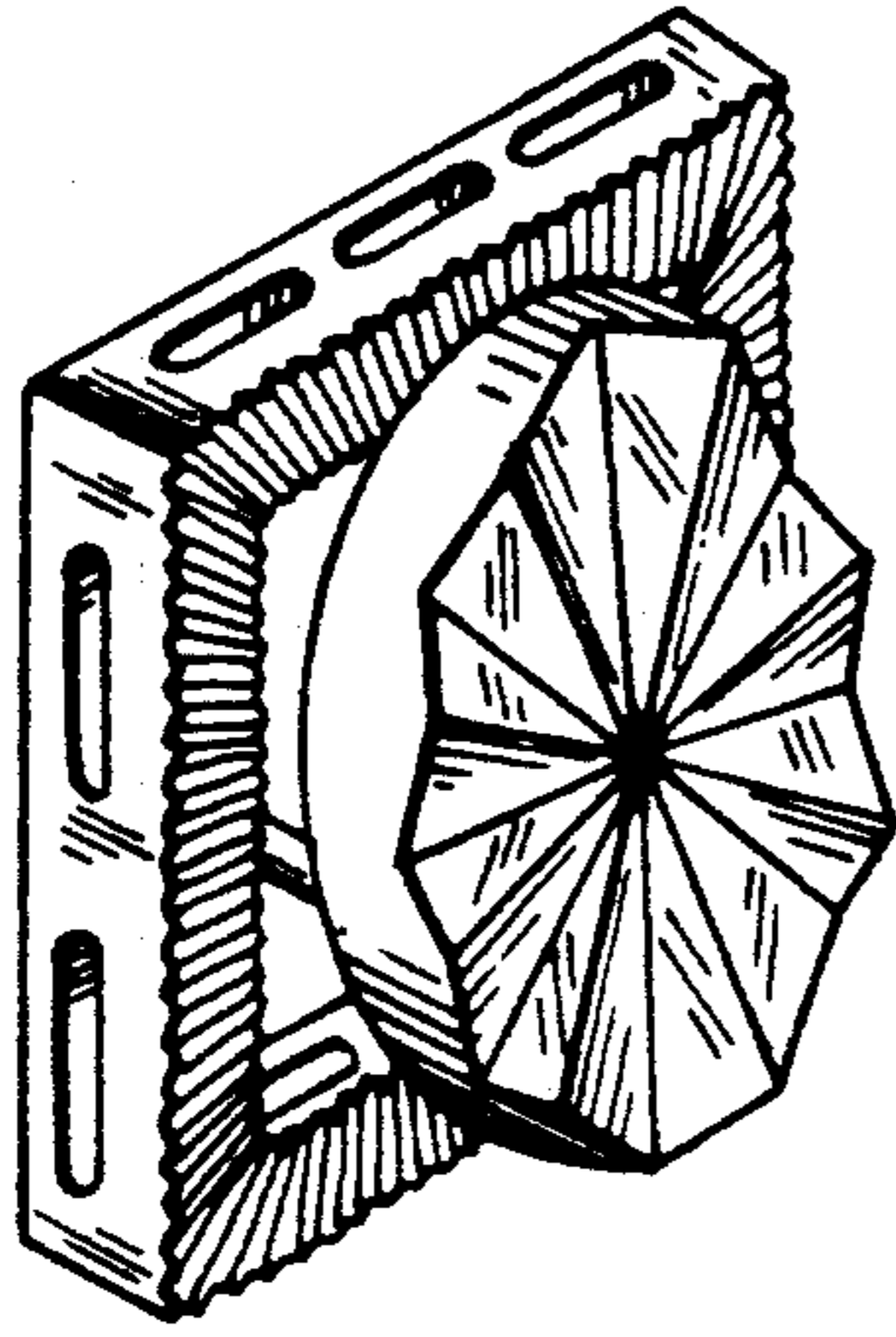

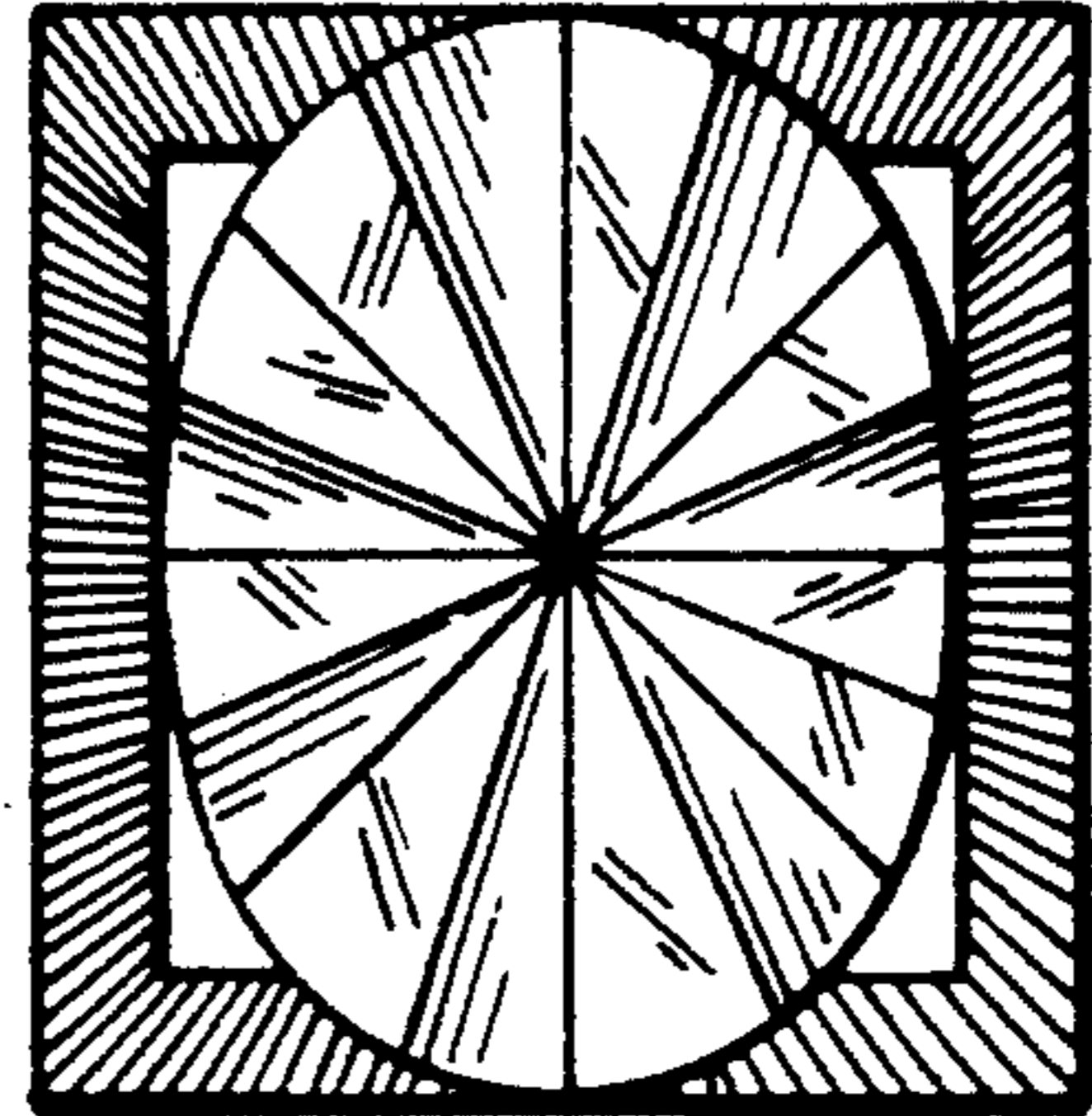

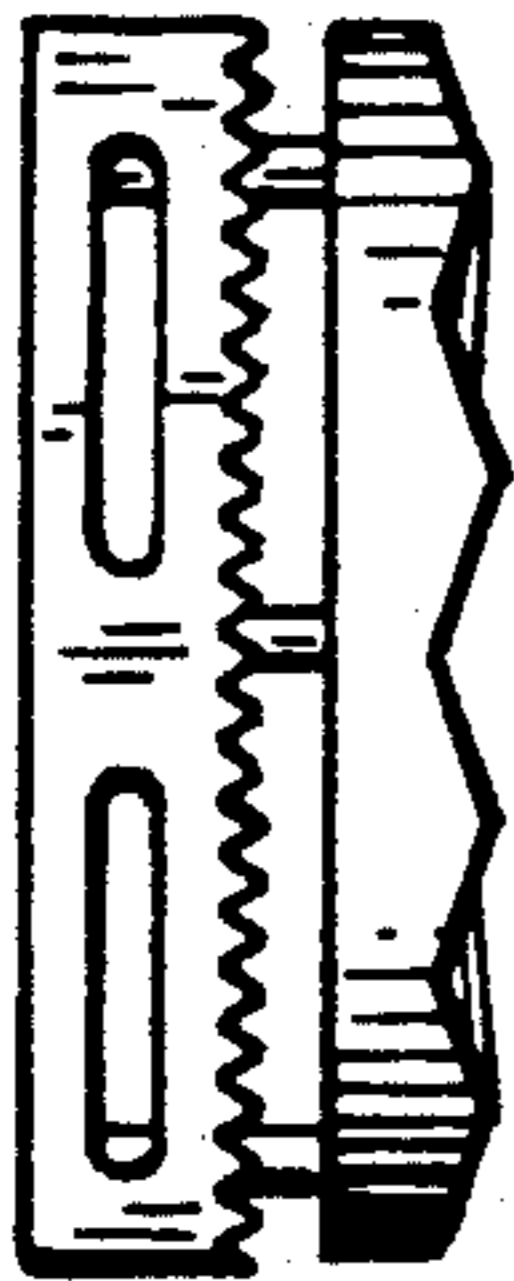

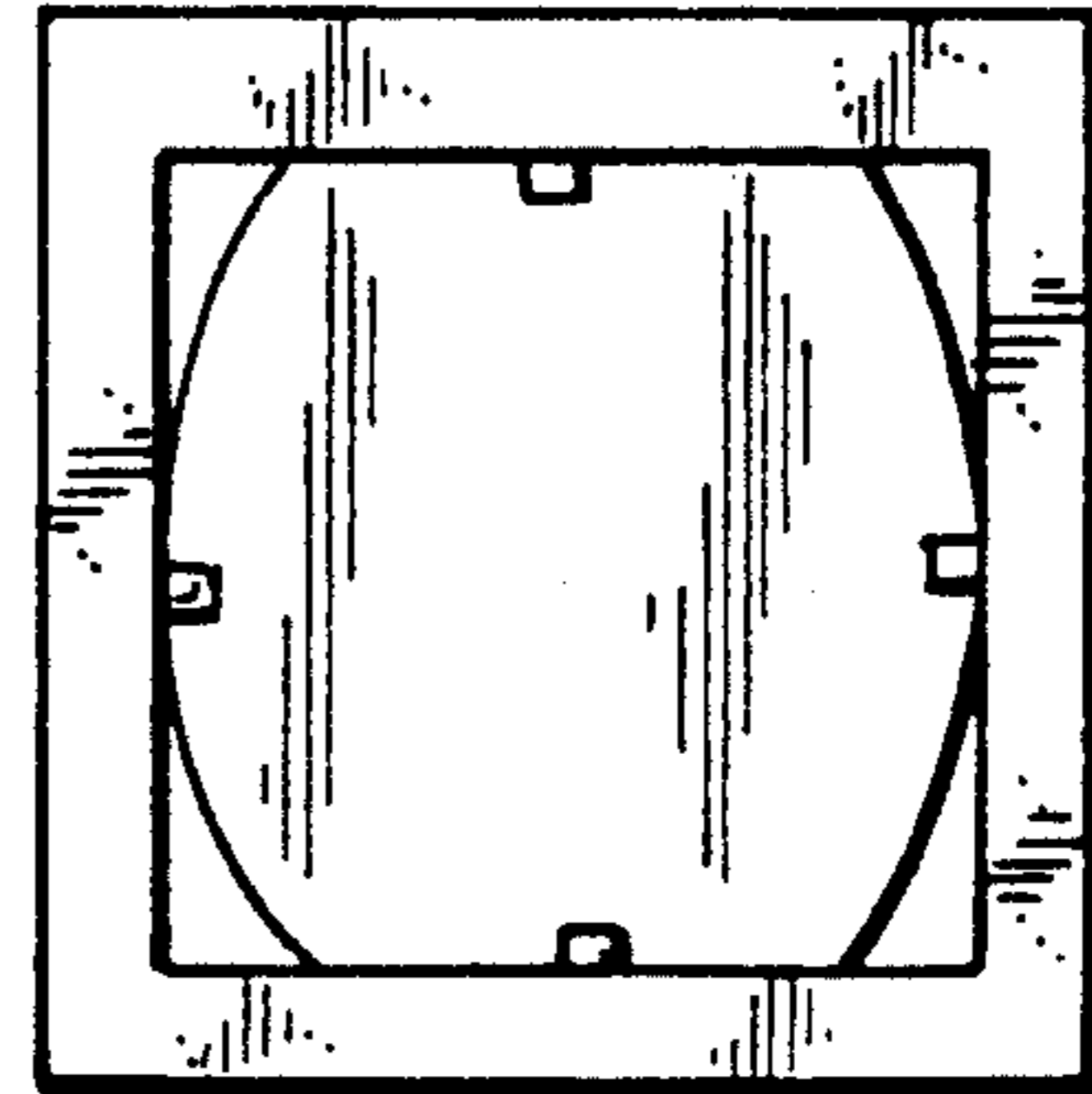

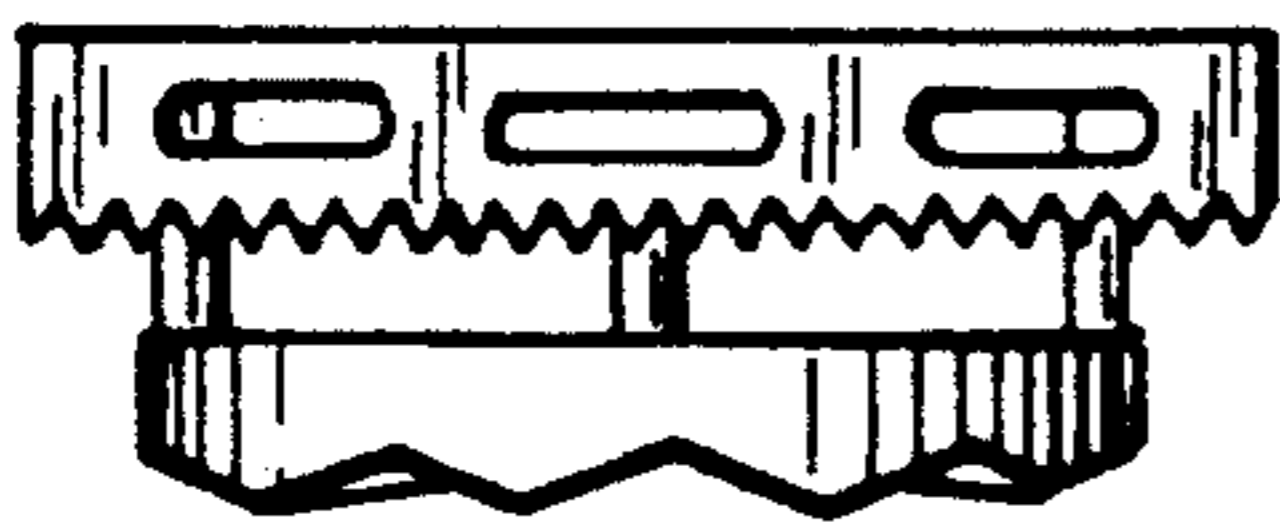

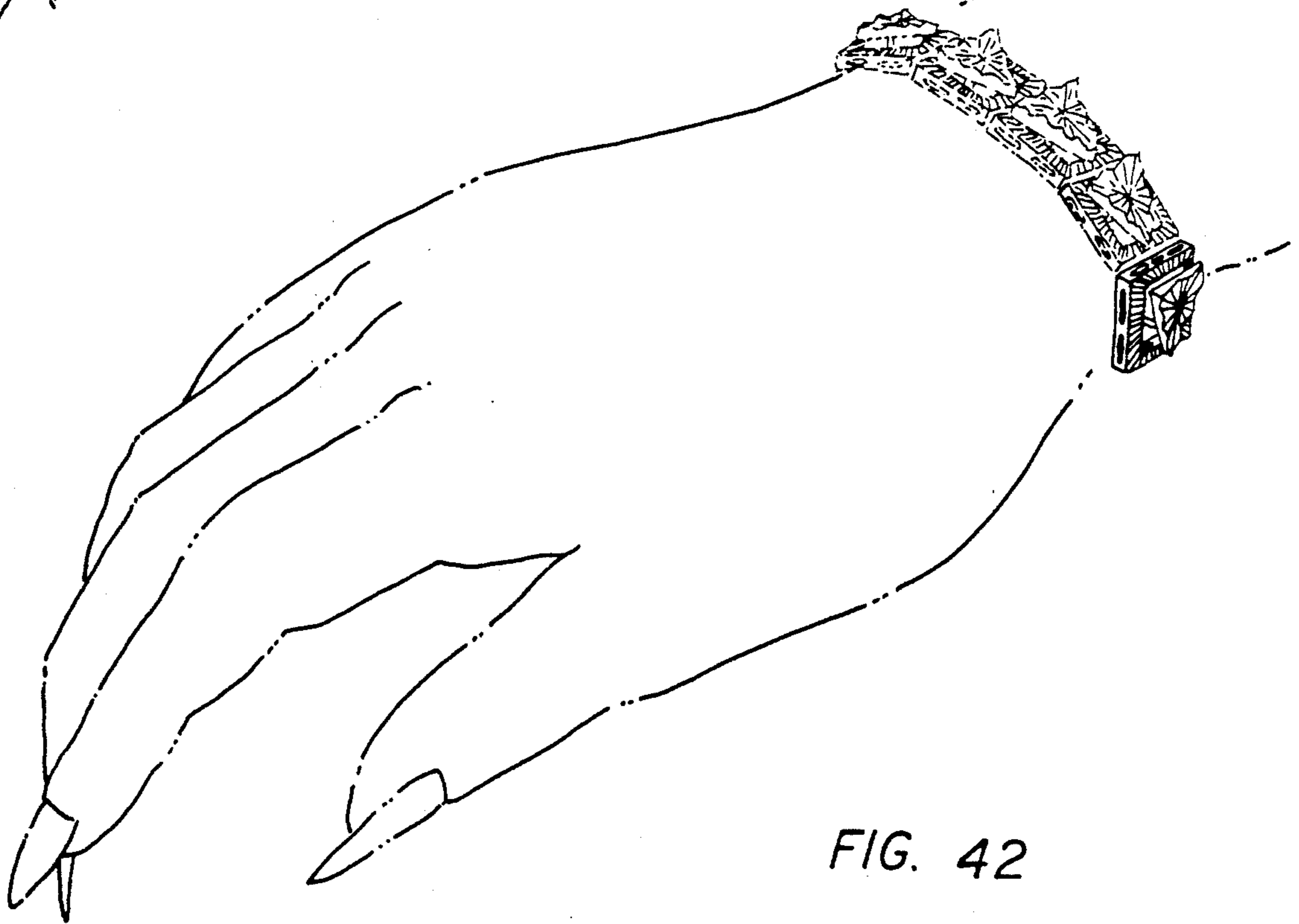
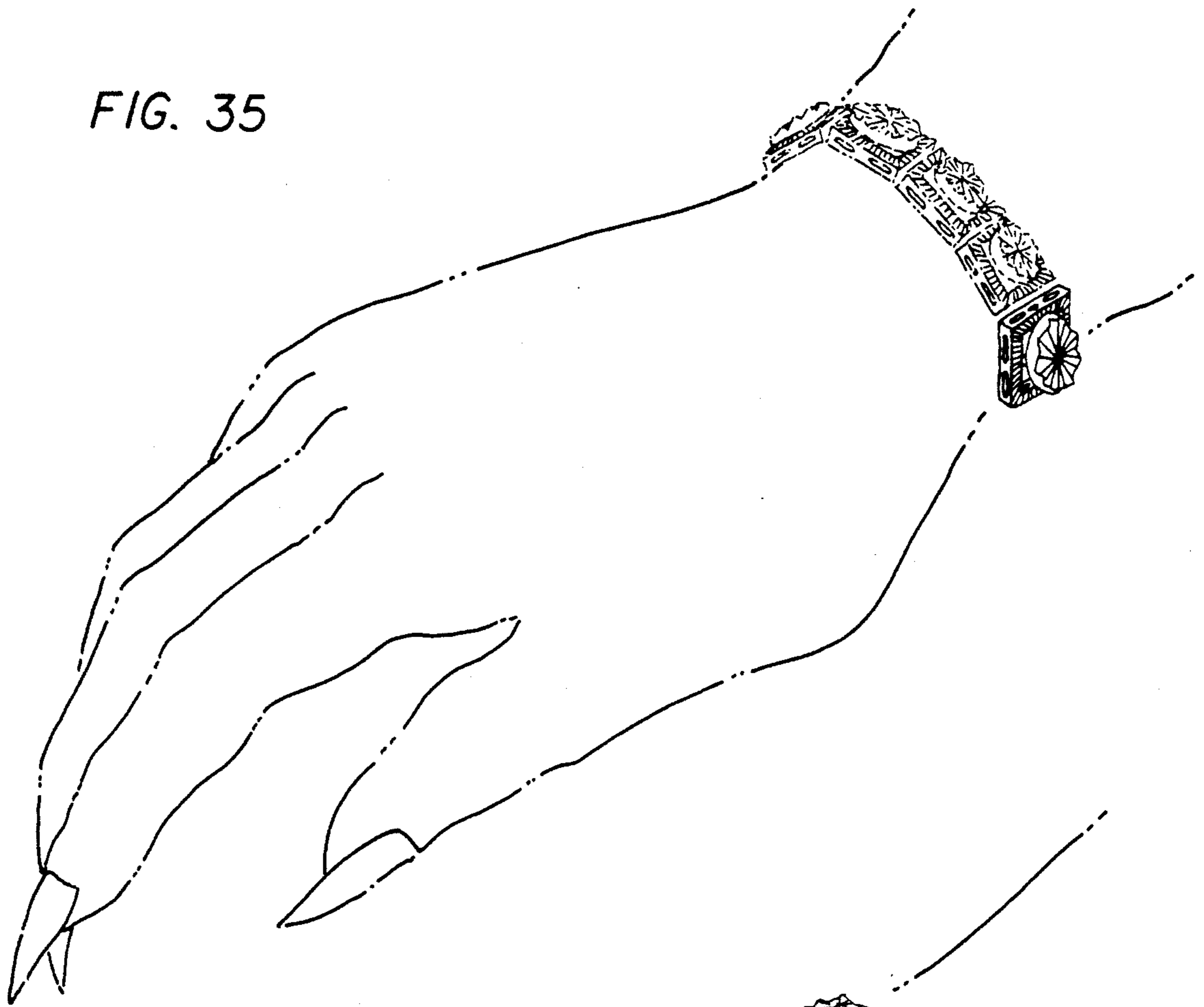

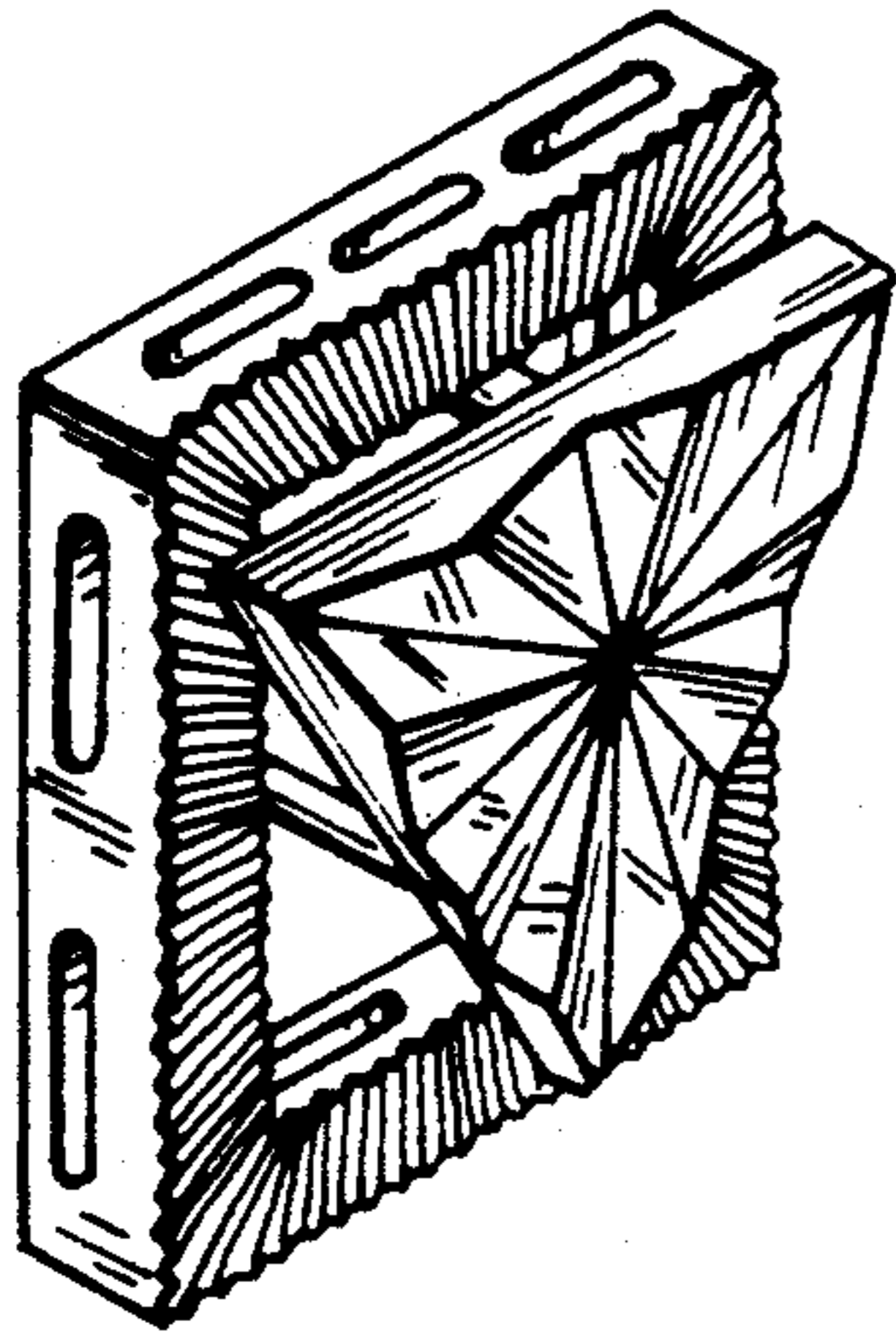

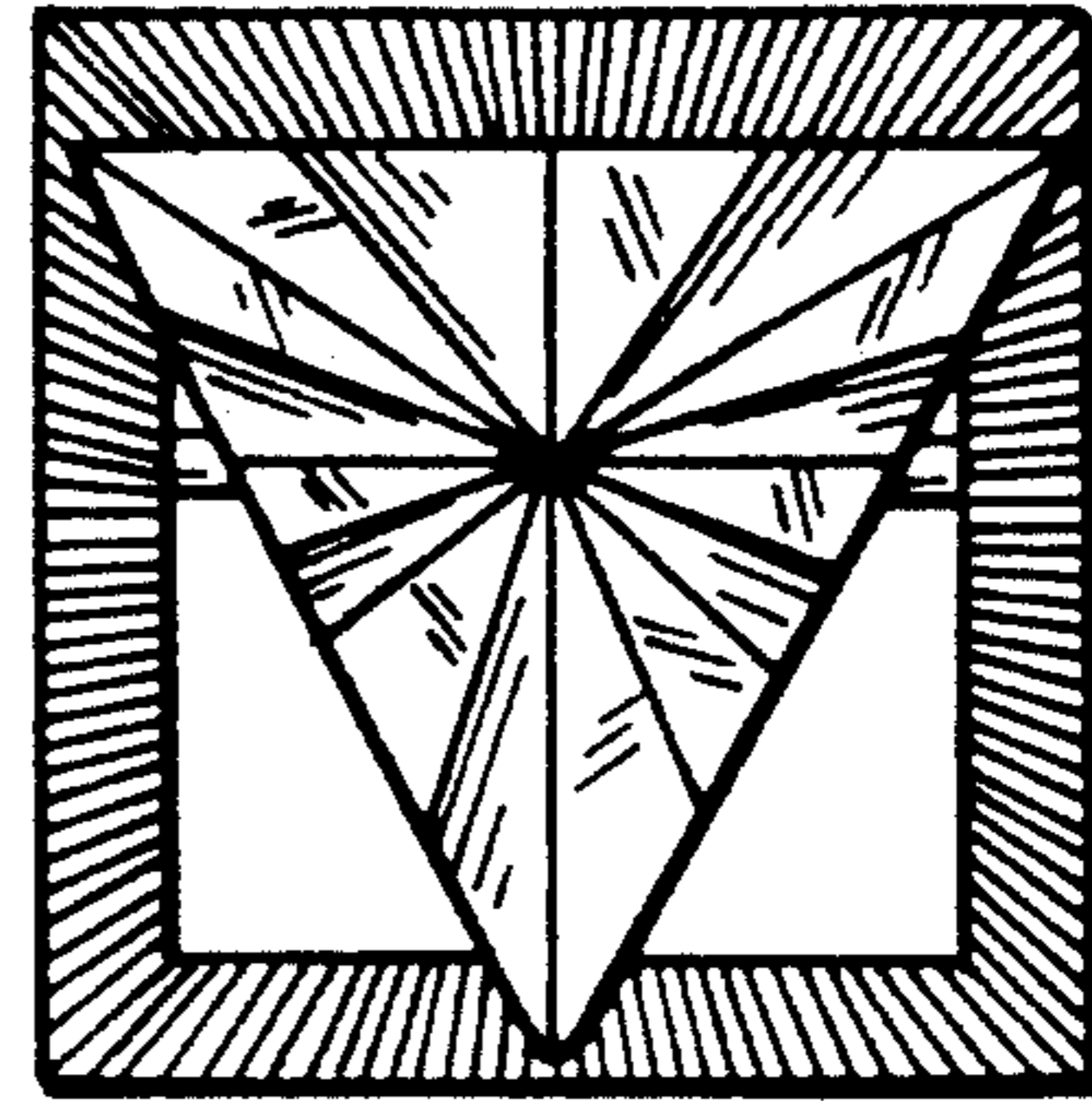

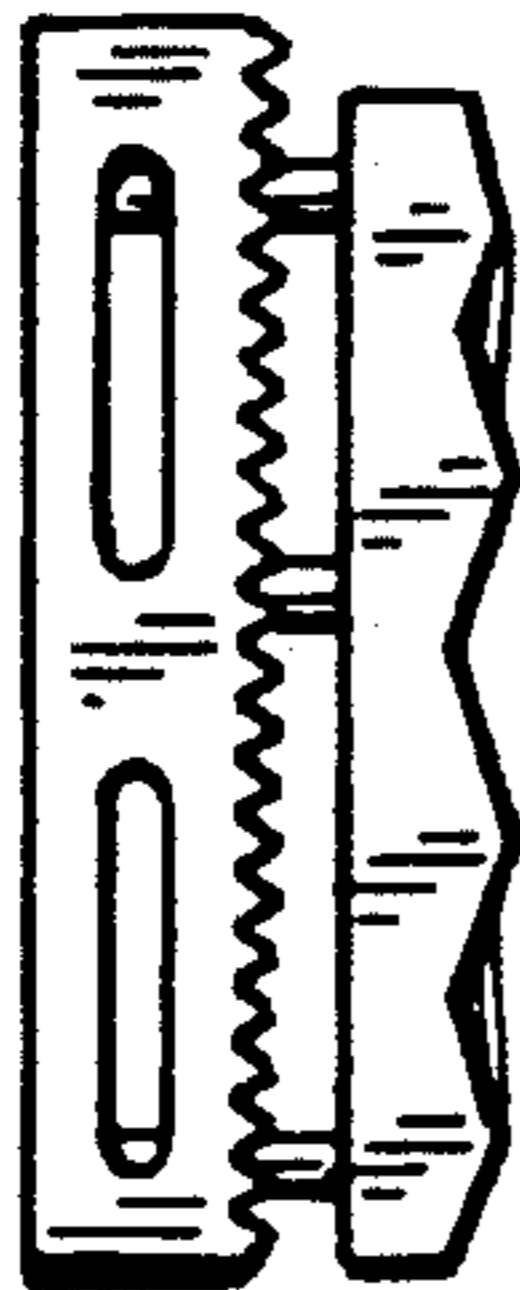

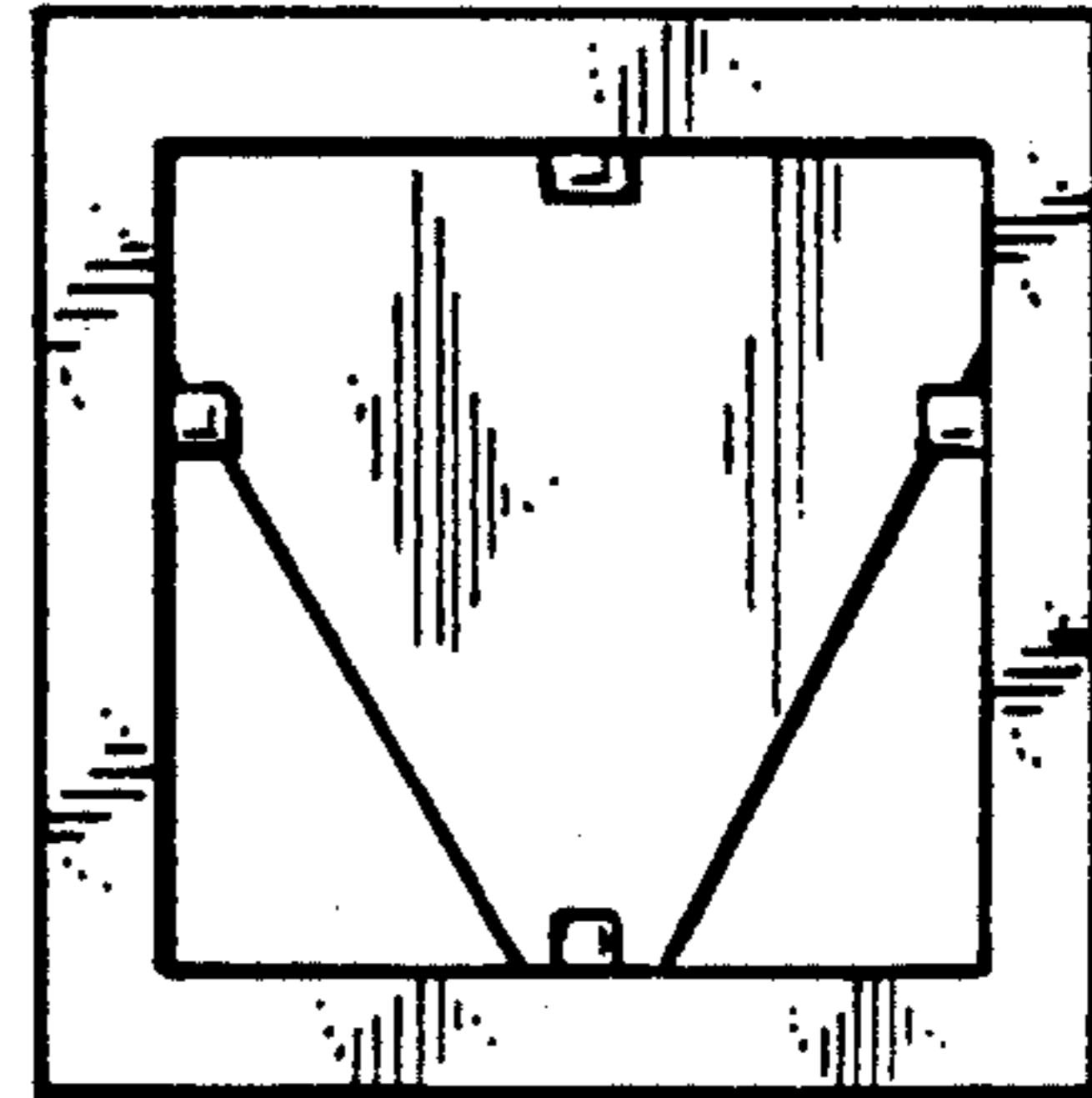

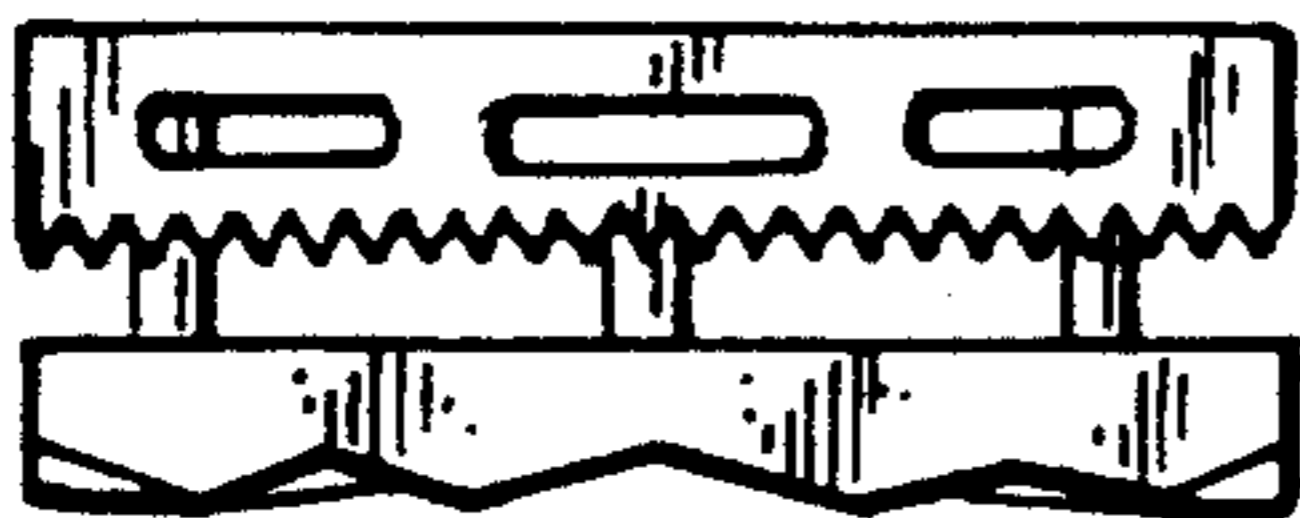
