The ornamental design for a golf bag accessory belt, as shown and described.

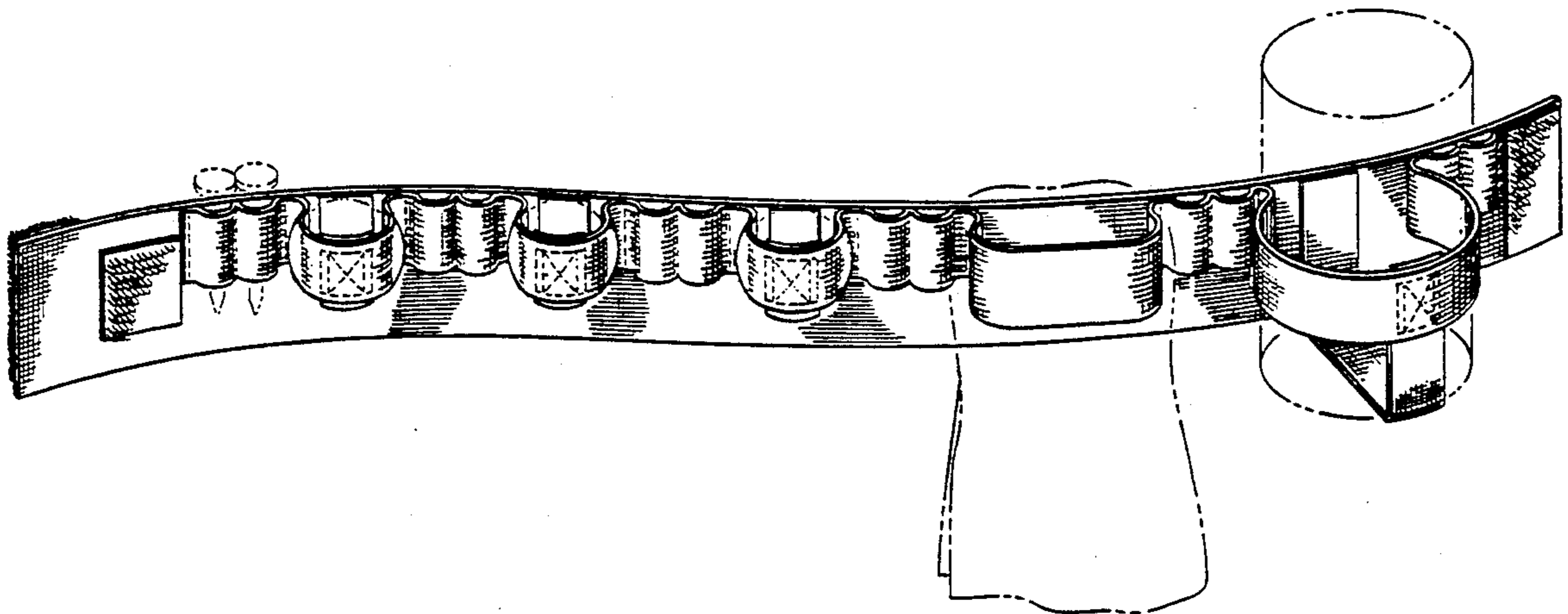
**DESCRIPTION**

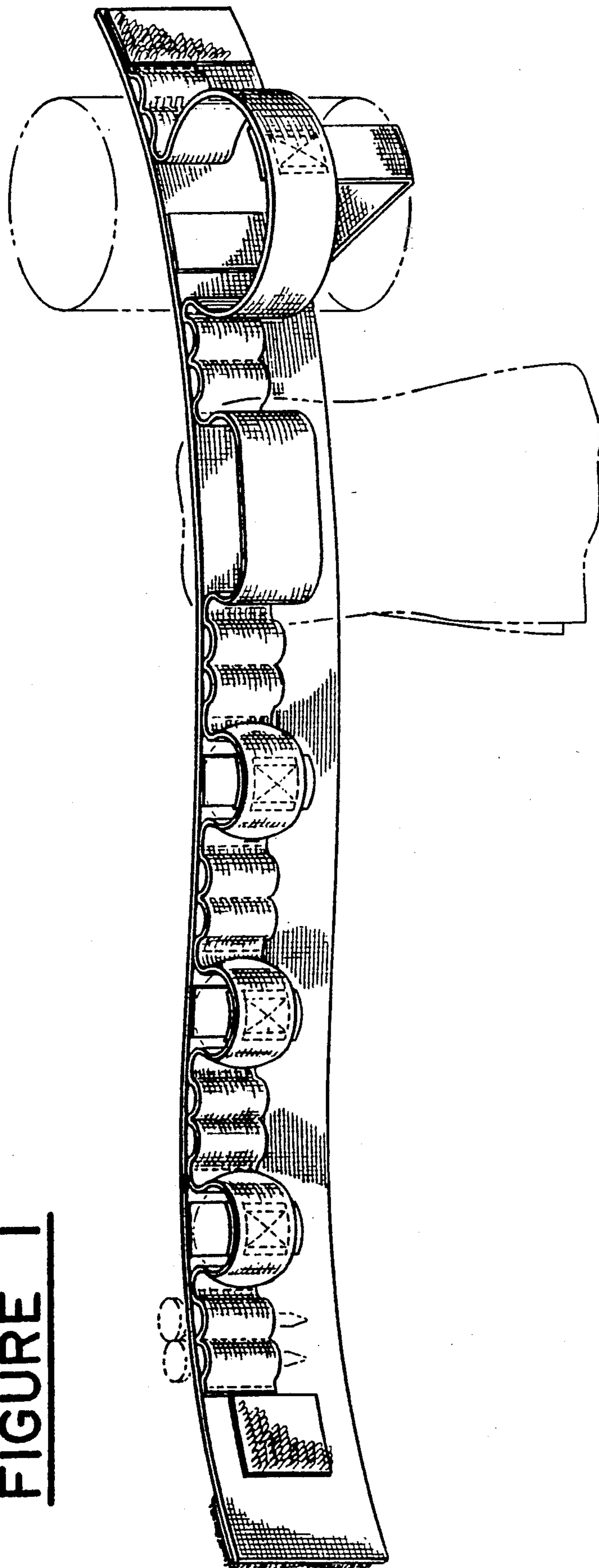

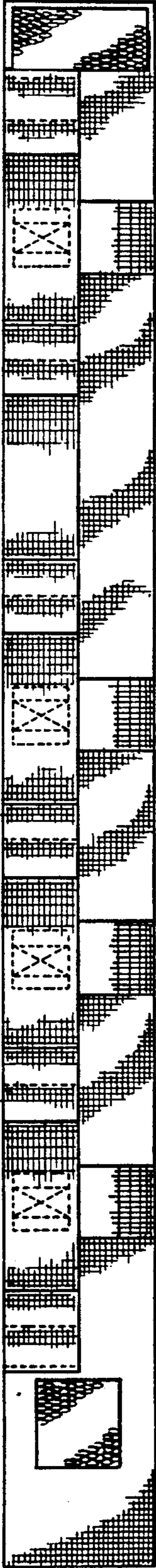

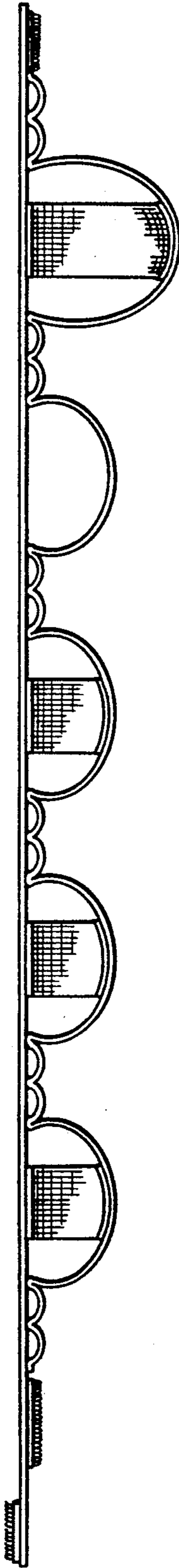

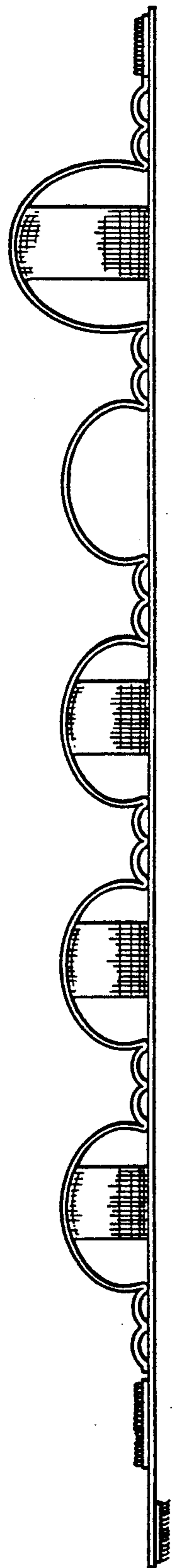

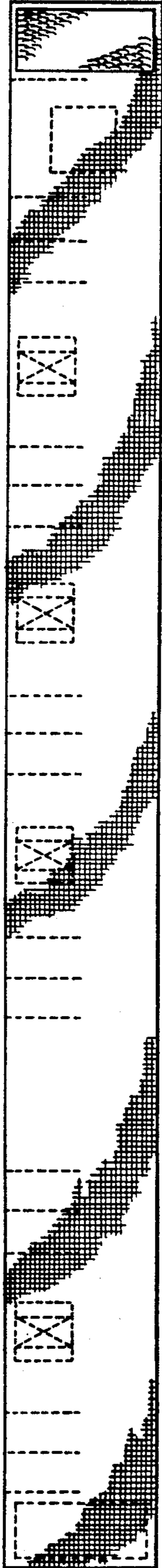

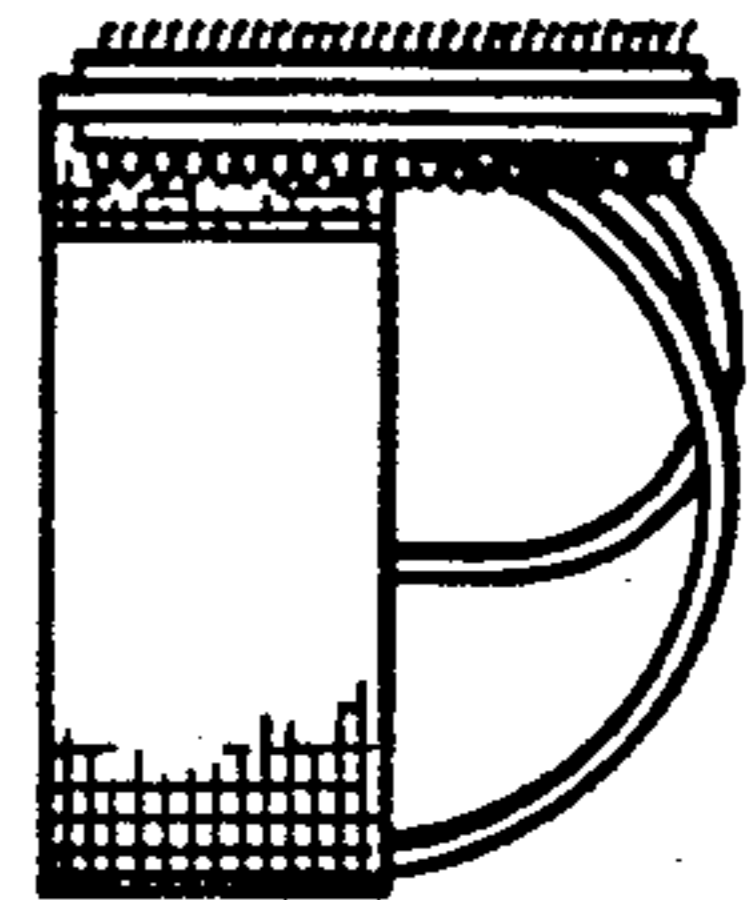

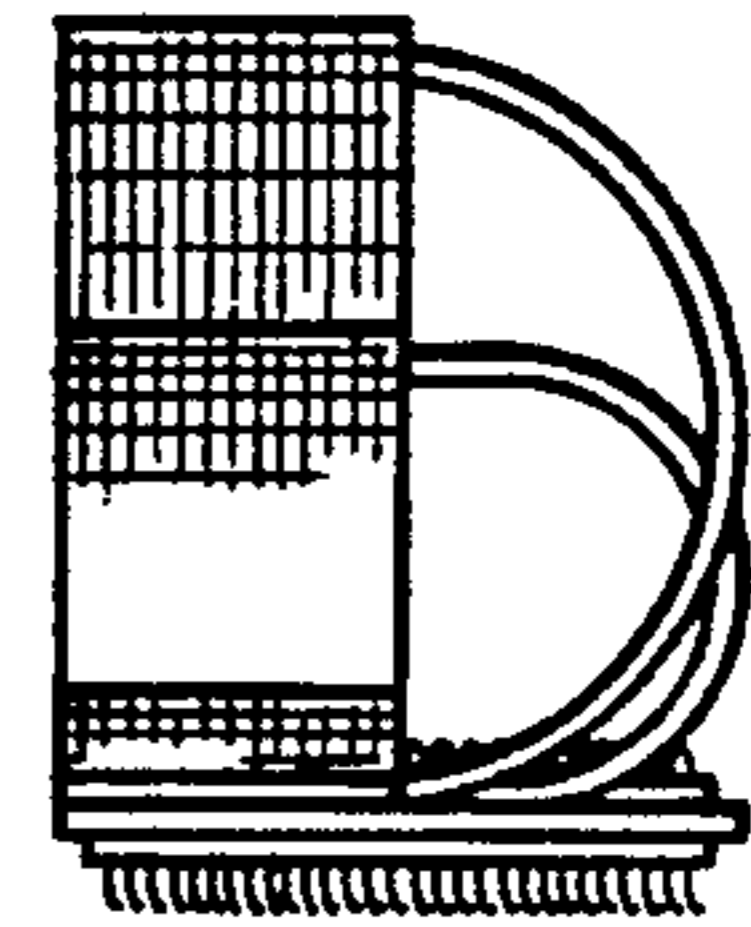

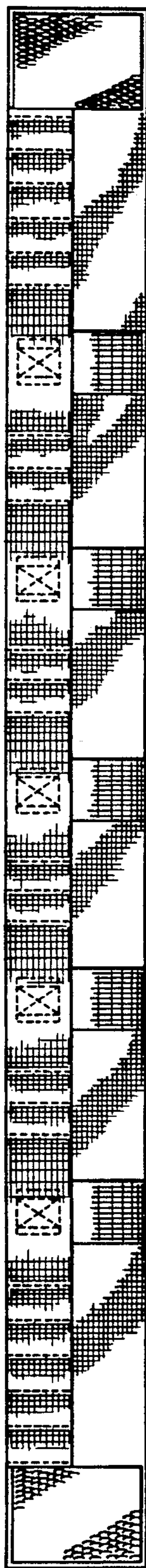

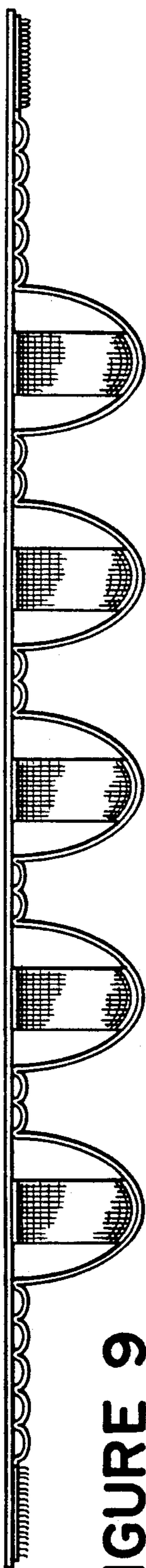

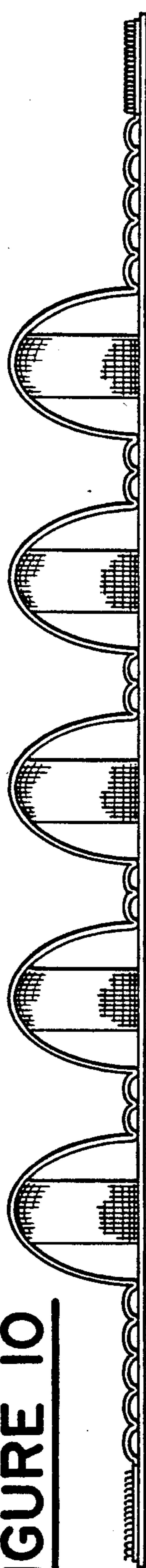
