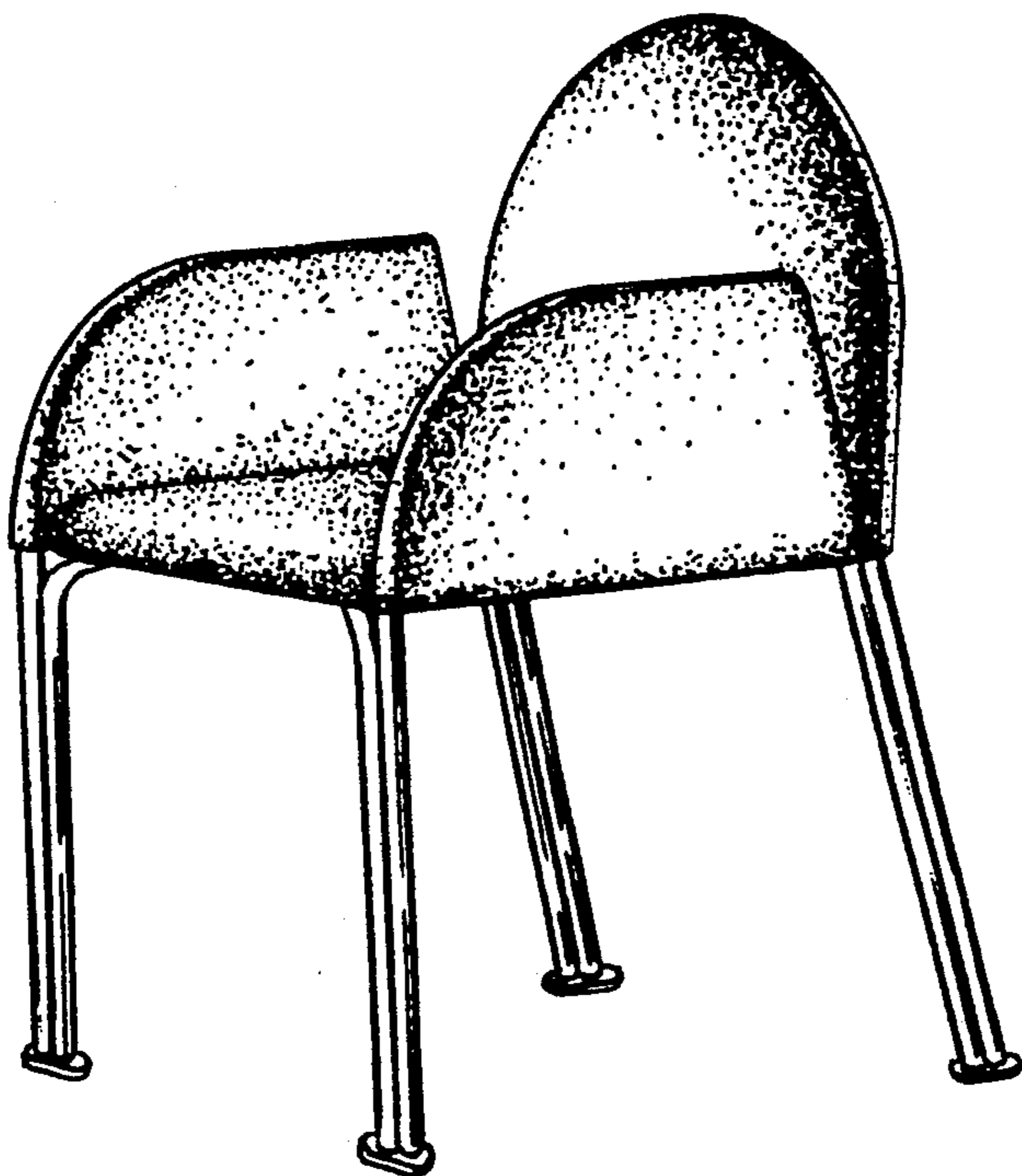

DESCRIPTION

FIG. 1 is a right-front perspective view of a chair showing my new design;

FIG. 7 is a bottom plan view thereof.



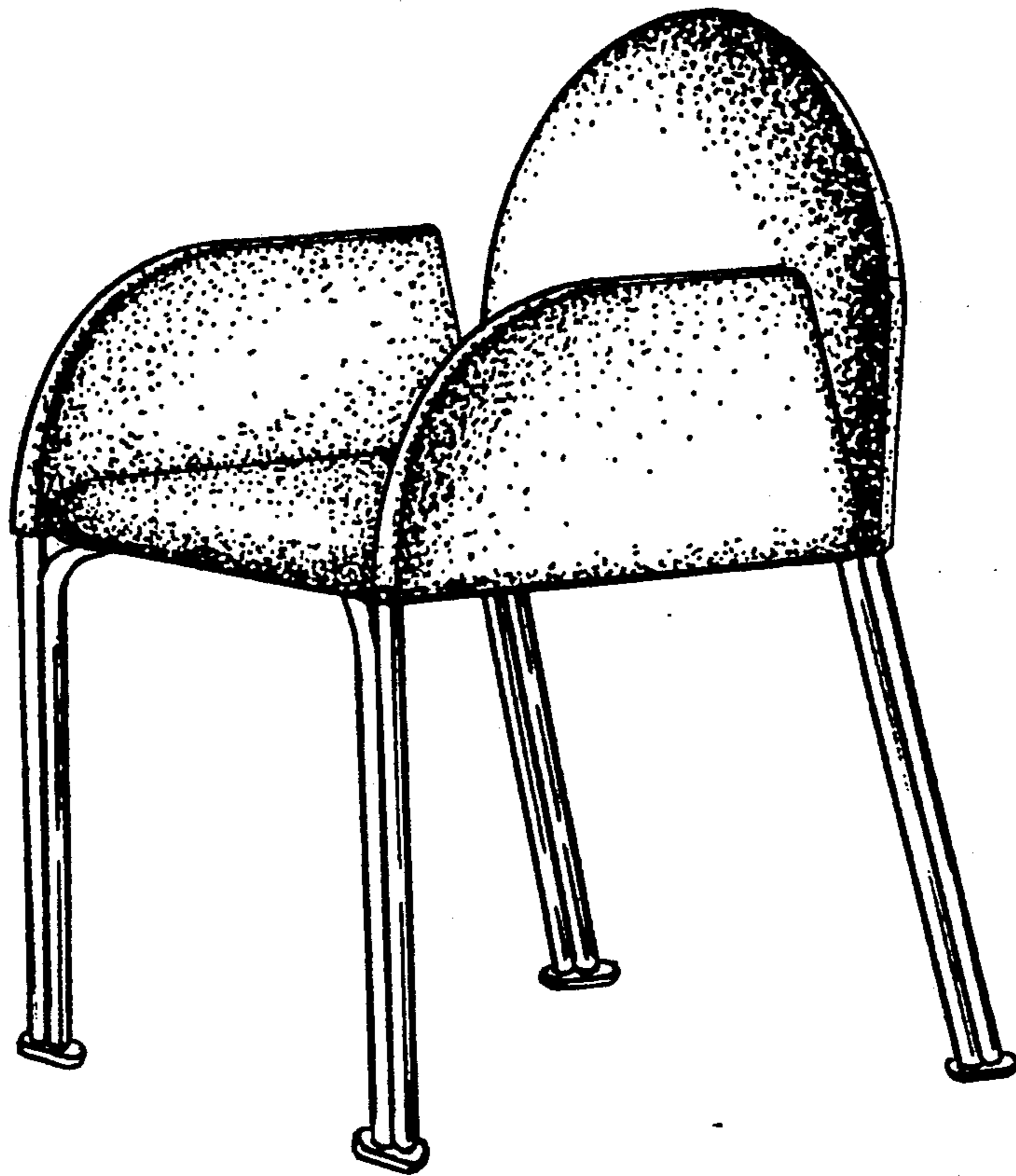

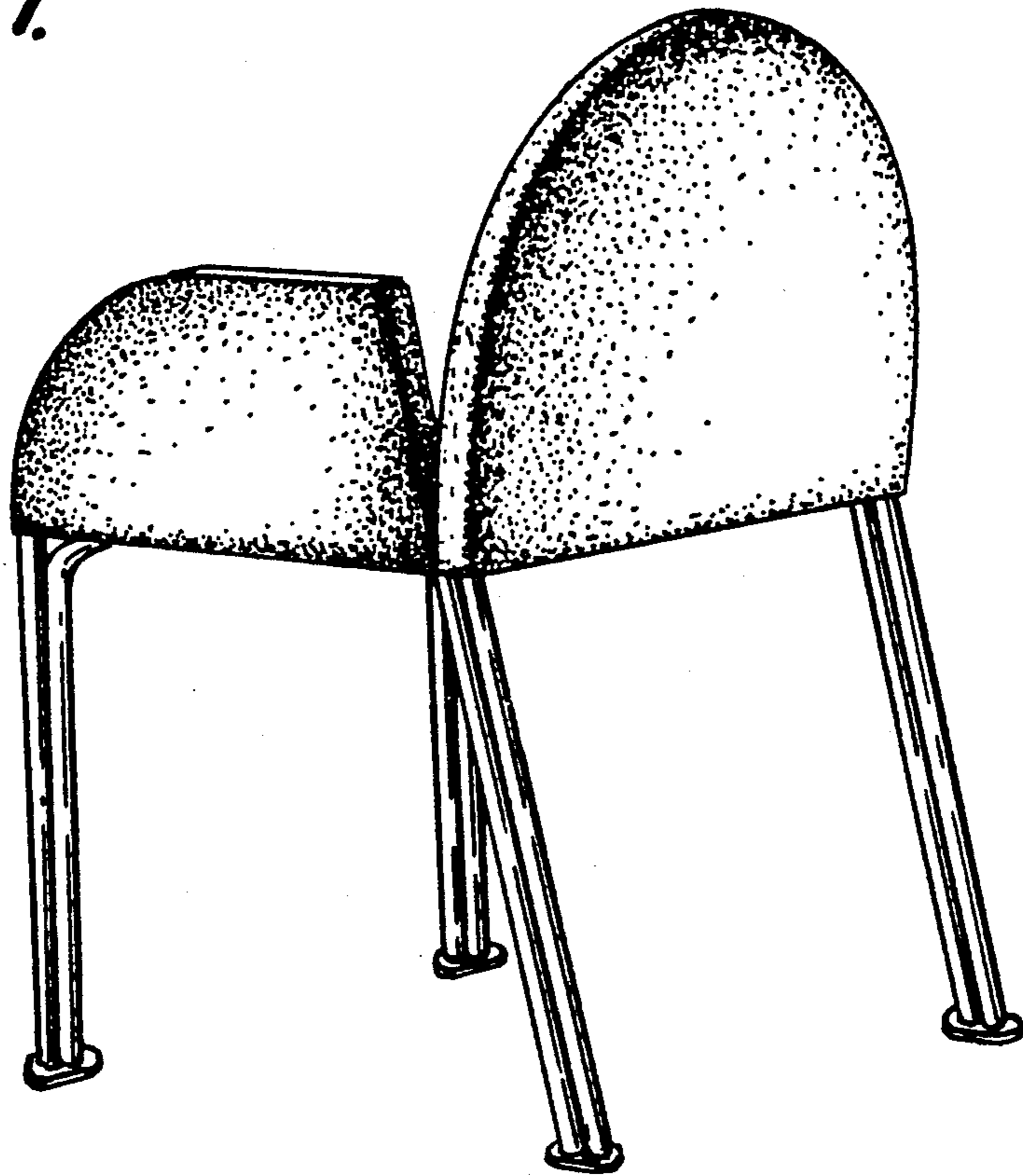

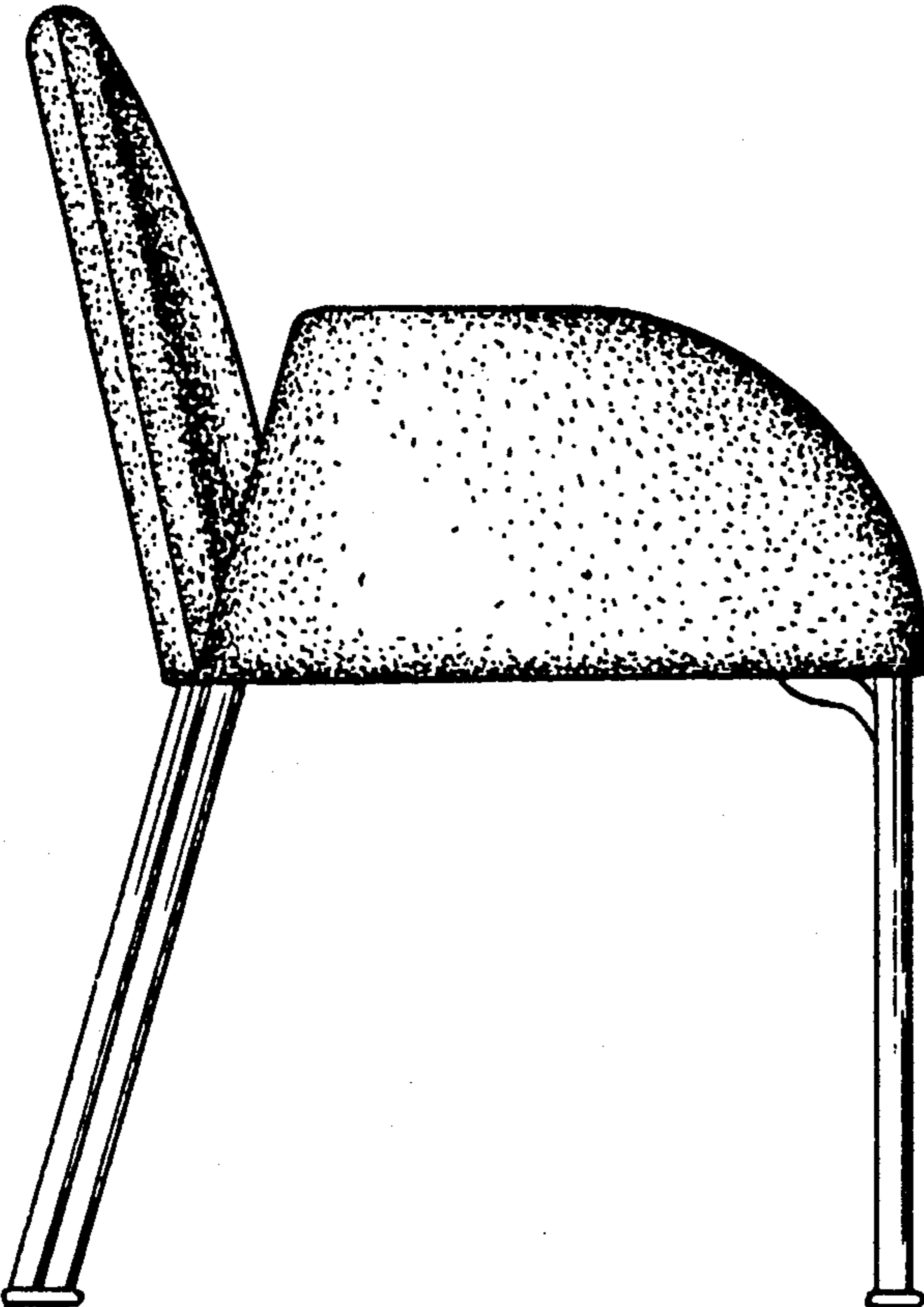

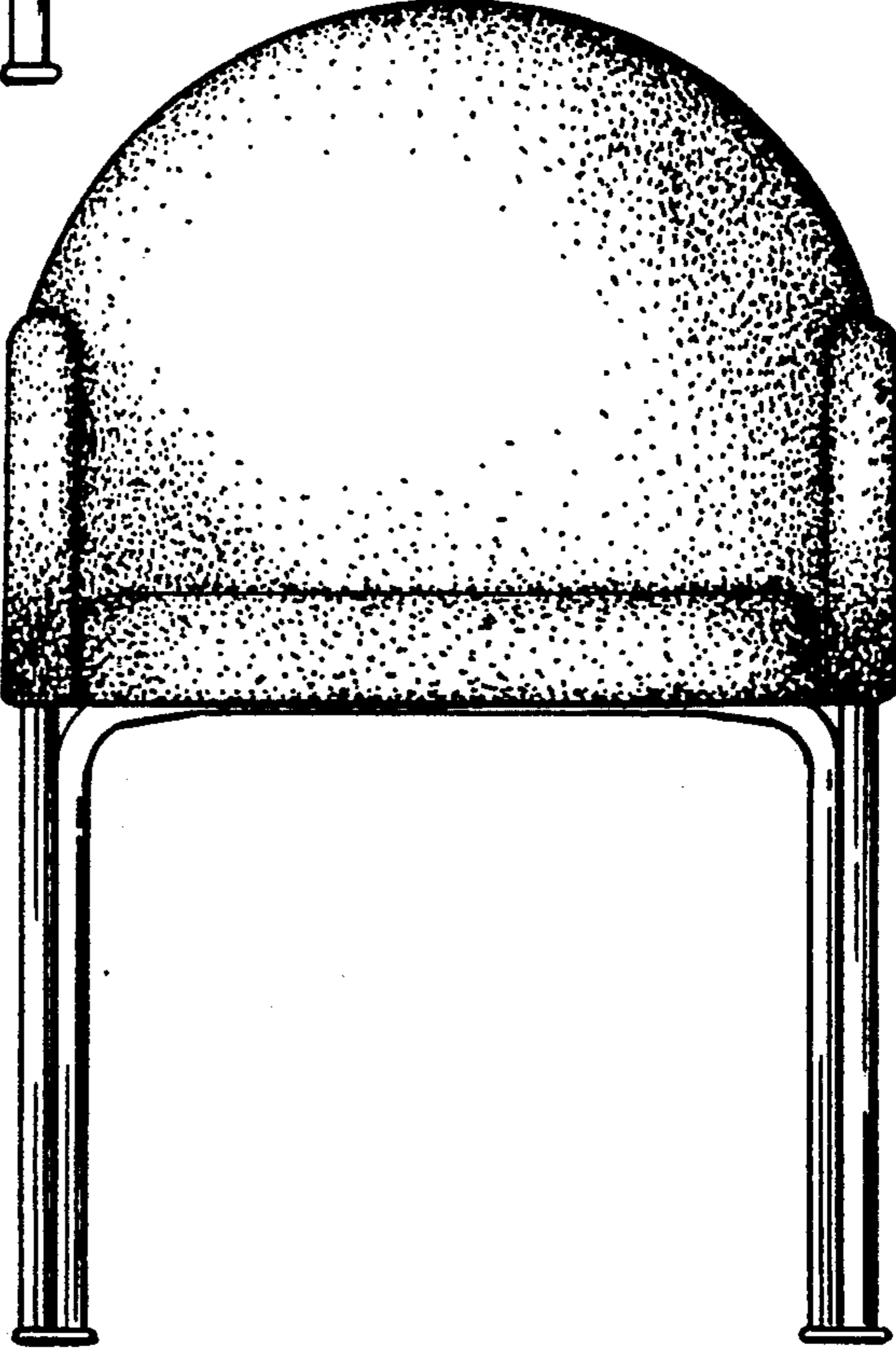

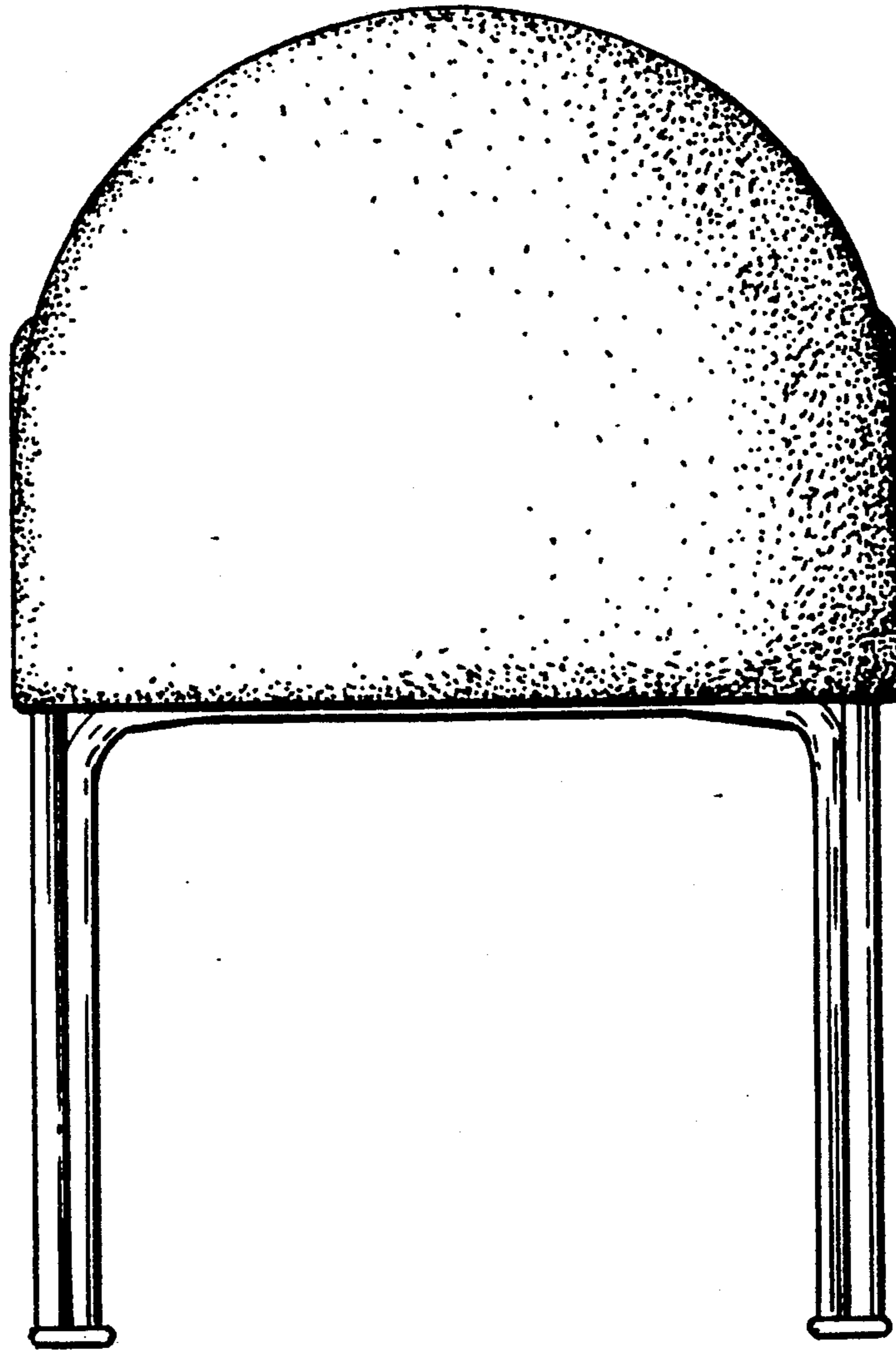

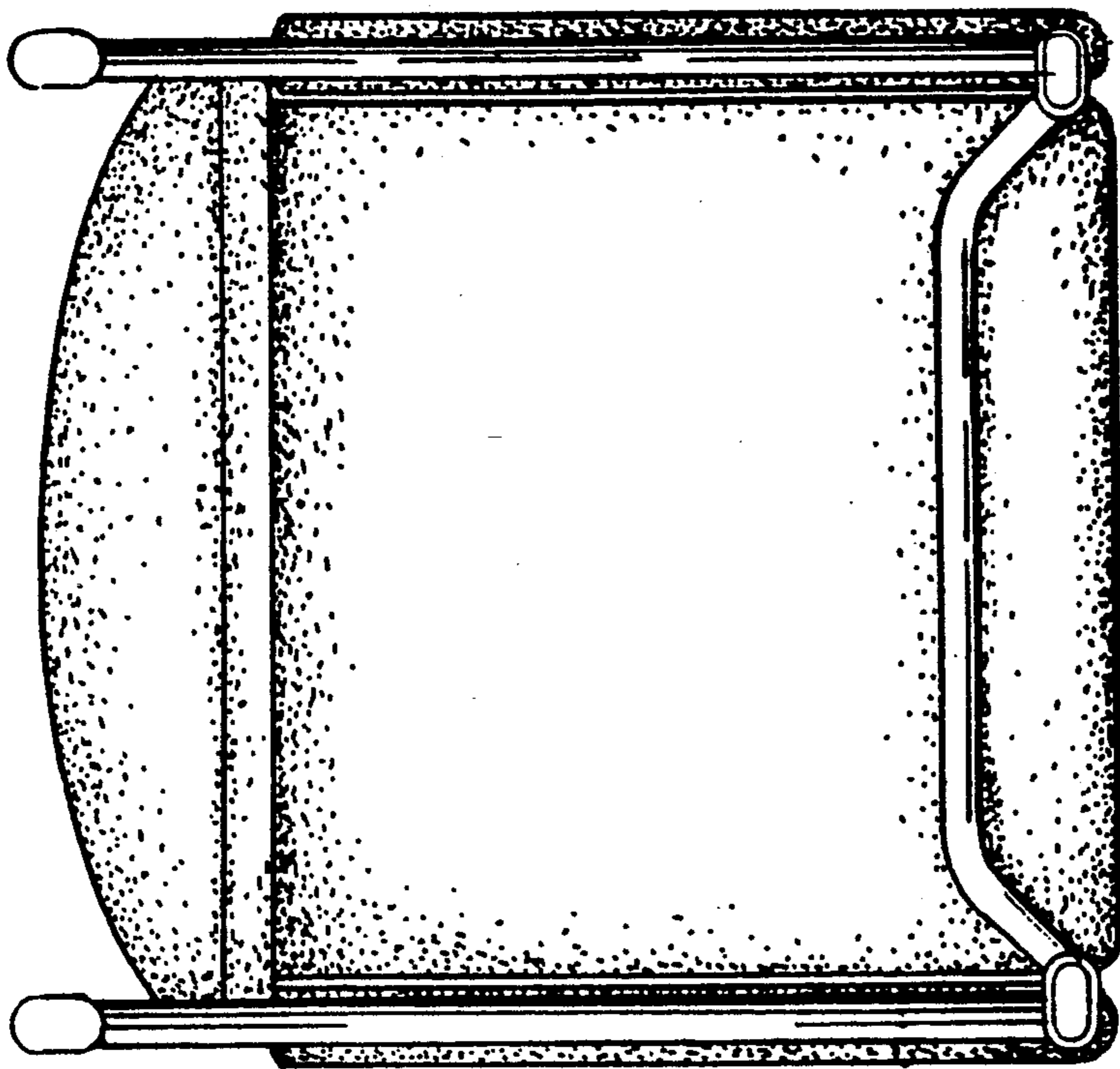

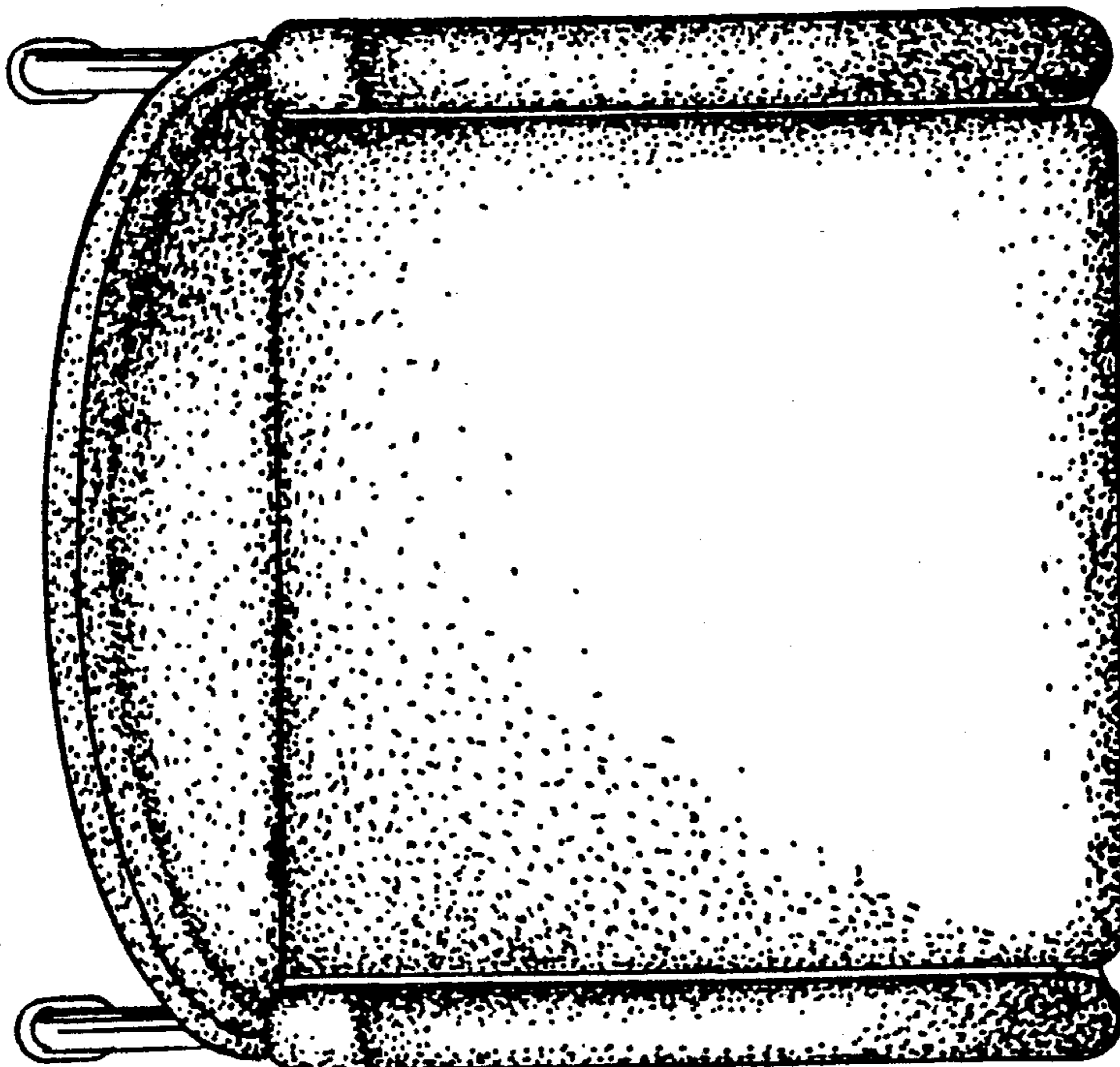
