The ornamental design for a accessory storage rack for attachment to a computer monitor, as shown and described.

**DESCRIPTION**

FIG. 3 is a top plan view thereof on an enlarged scale;

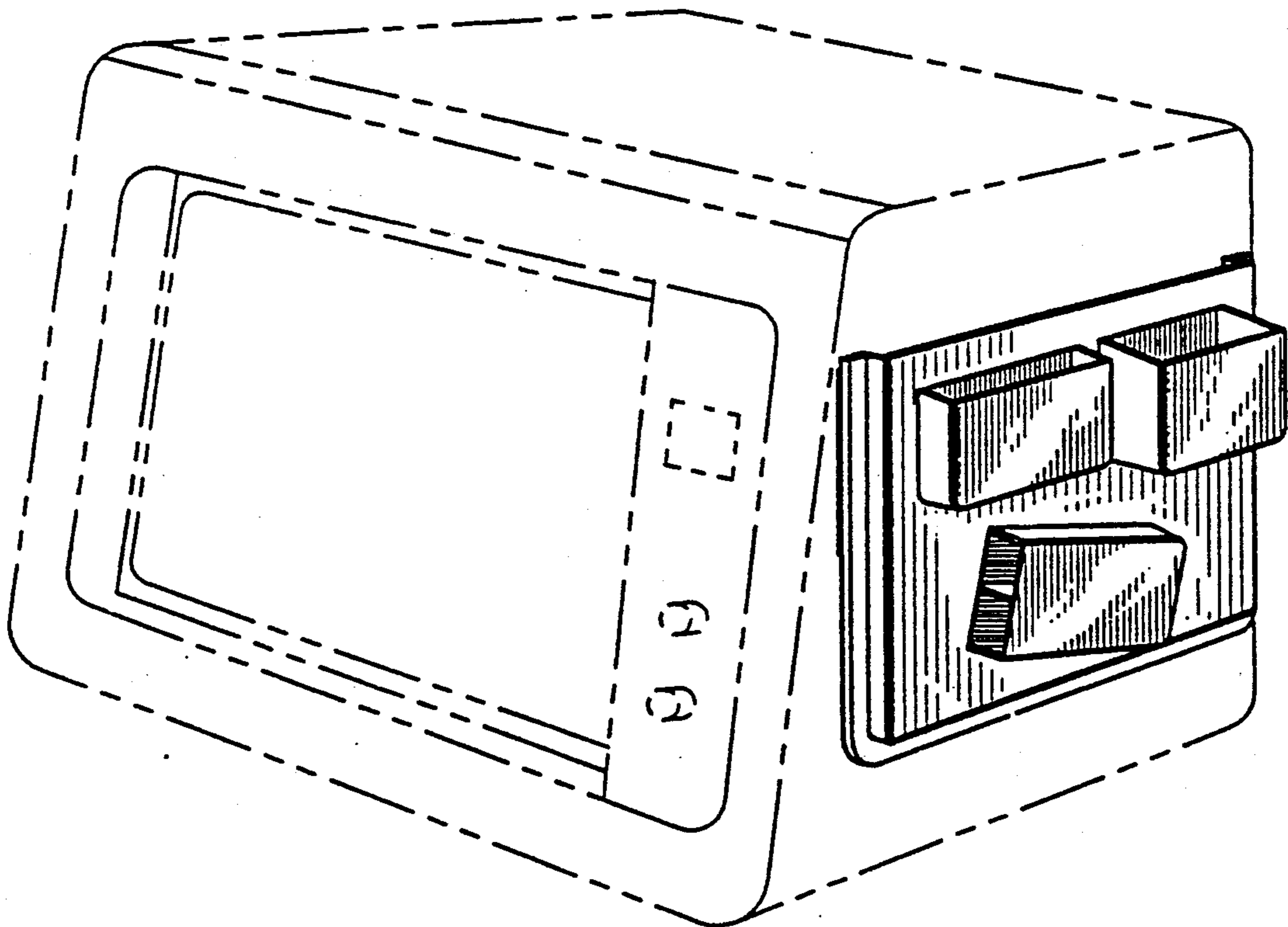
FIG. 4 is a side plan view of a side thereof on an enlarged scale;

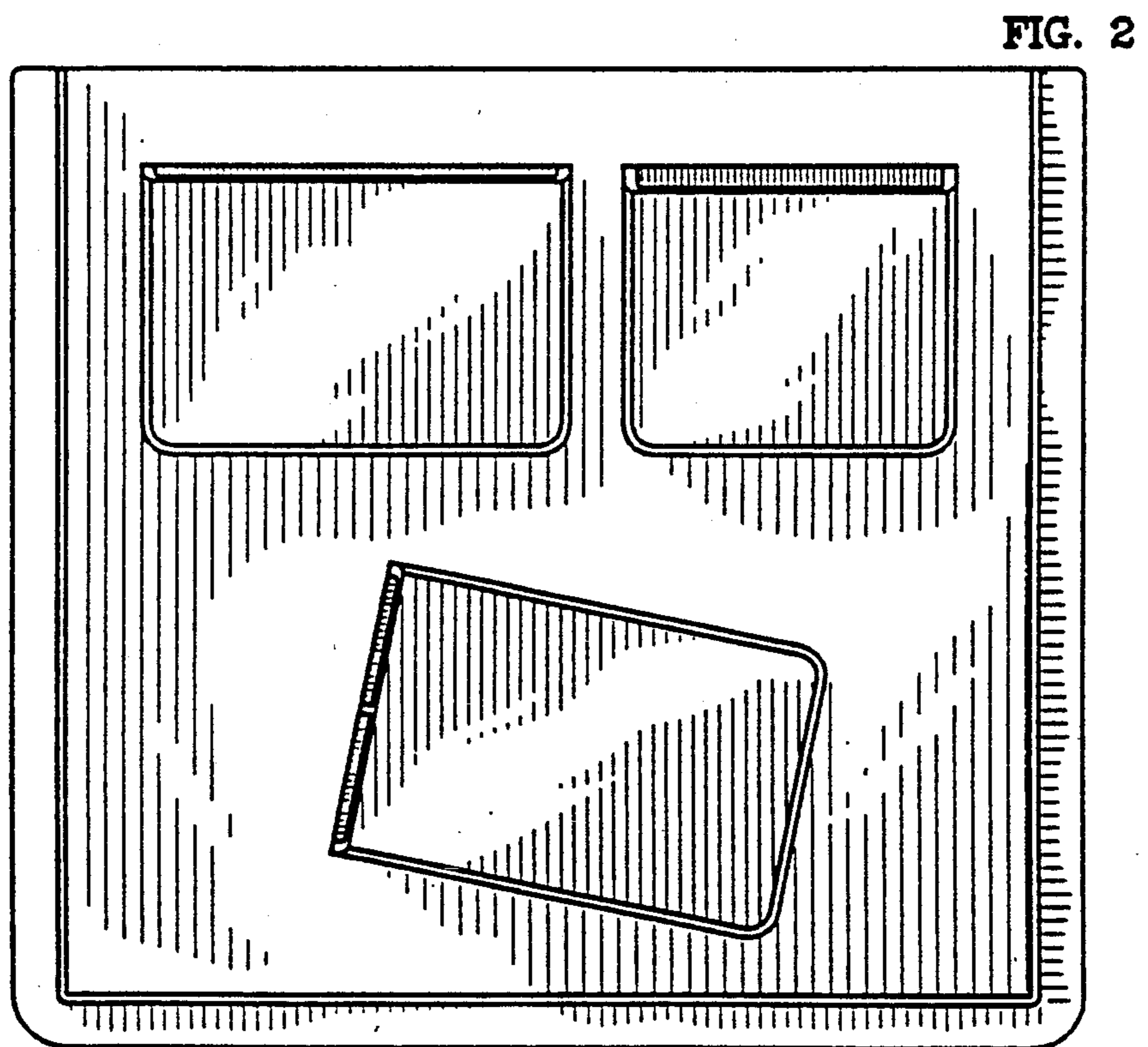
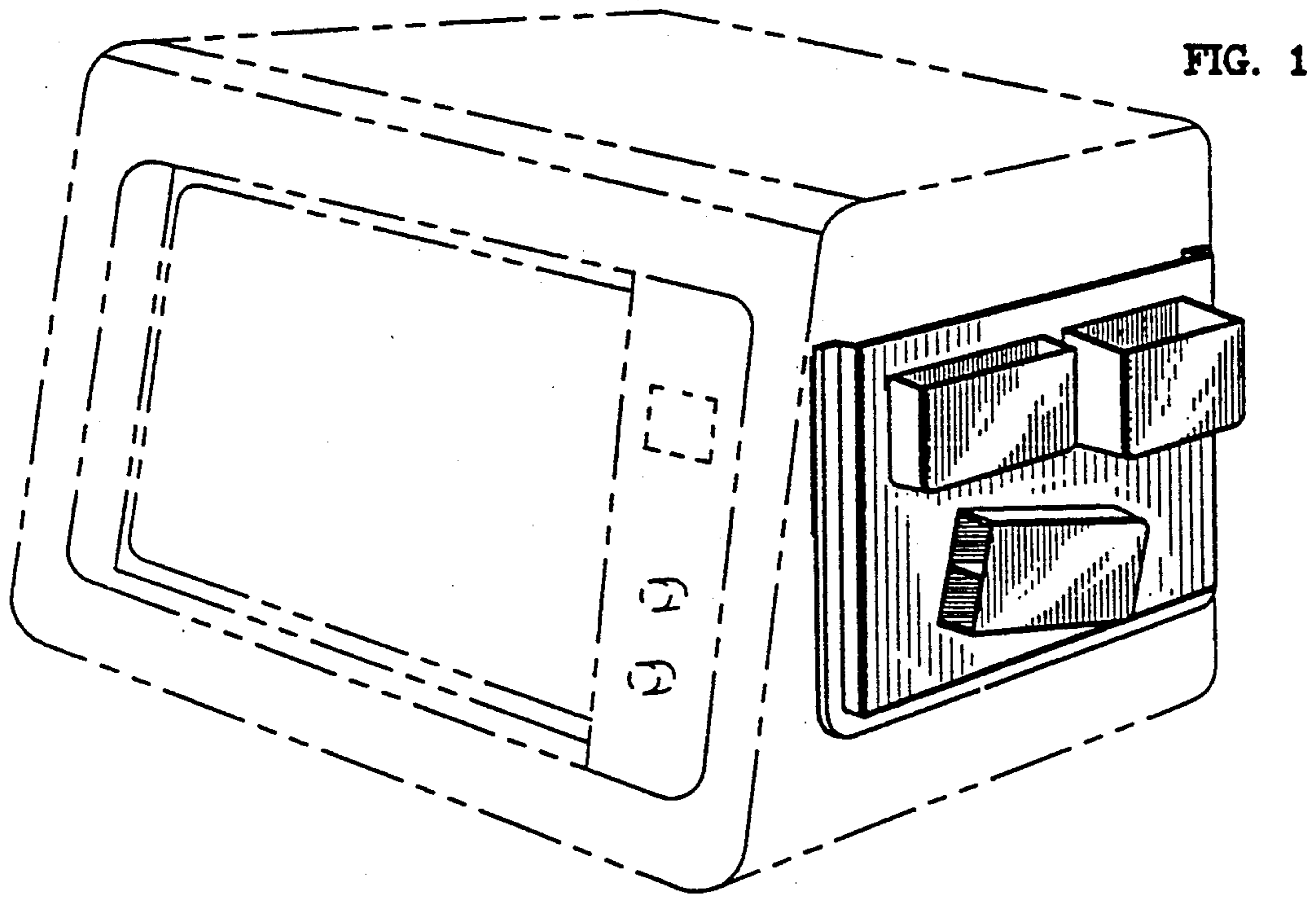
FIG. 5 is a side plan view of the opposite side thereof on an enlarged scale;

The broken line drawing of a computer monitor is for illustrative purposes only and forms no part of the claimed design.





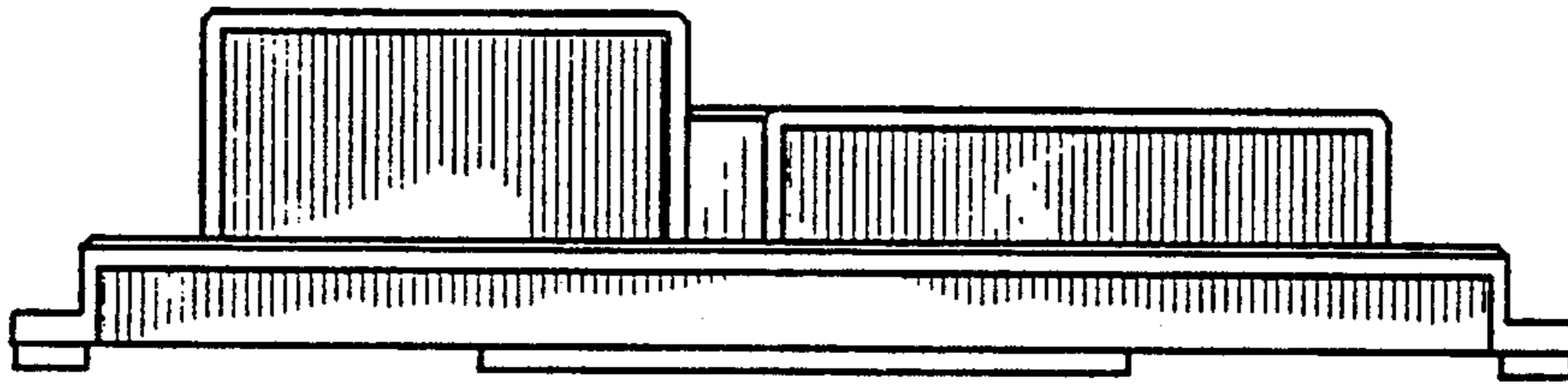

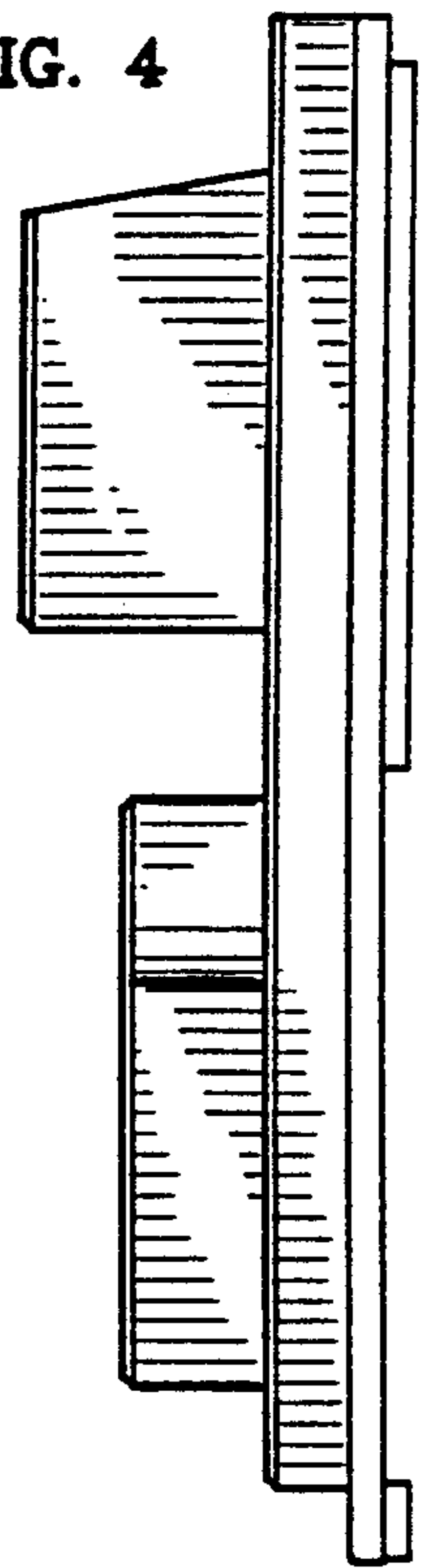

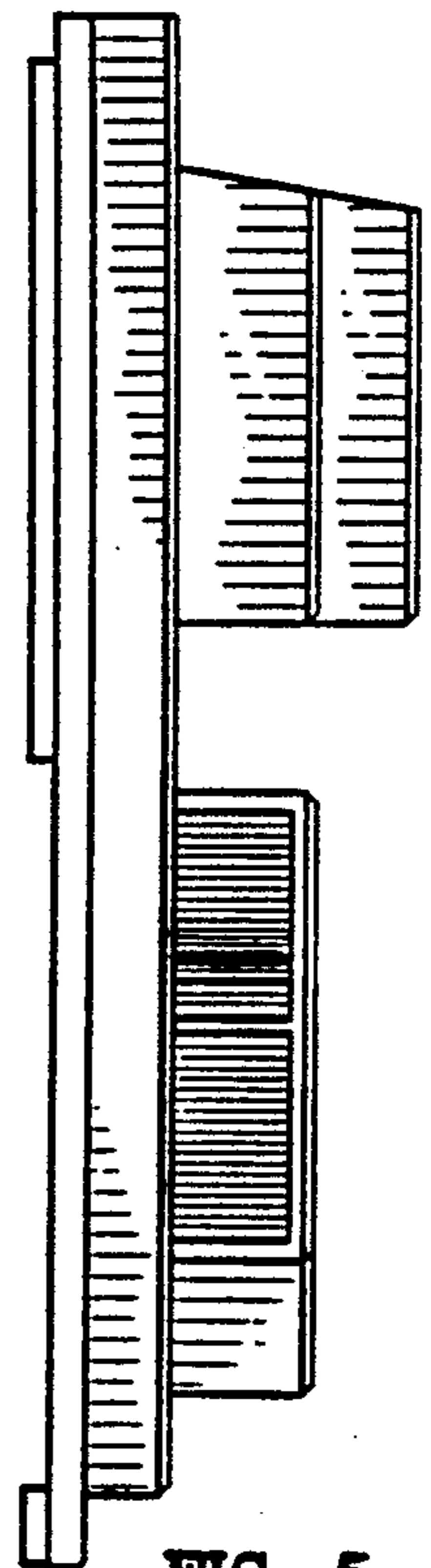
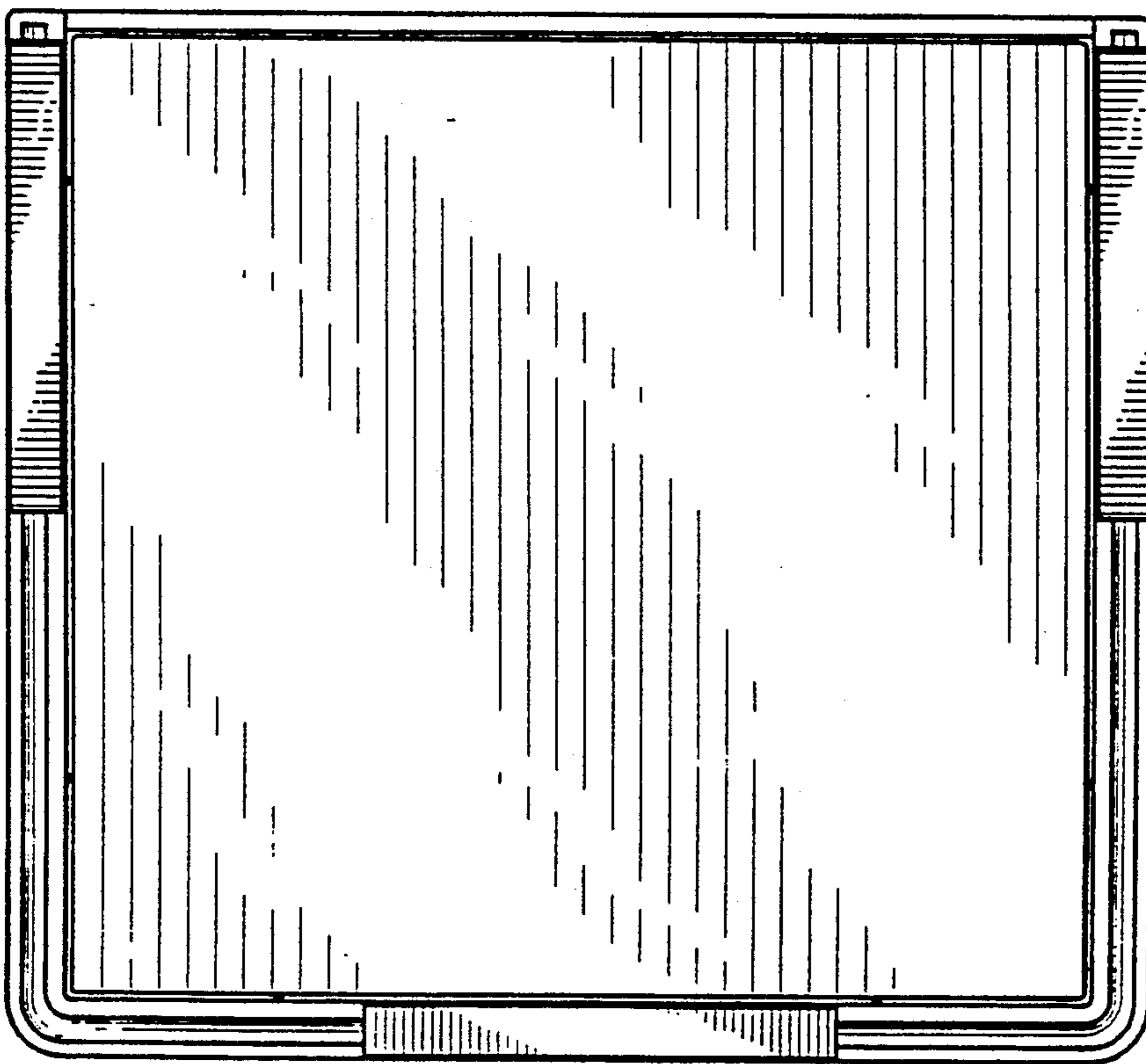

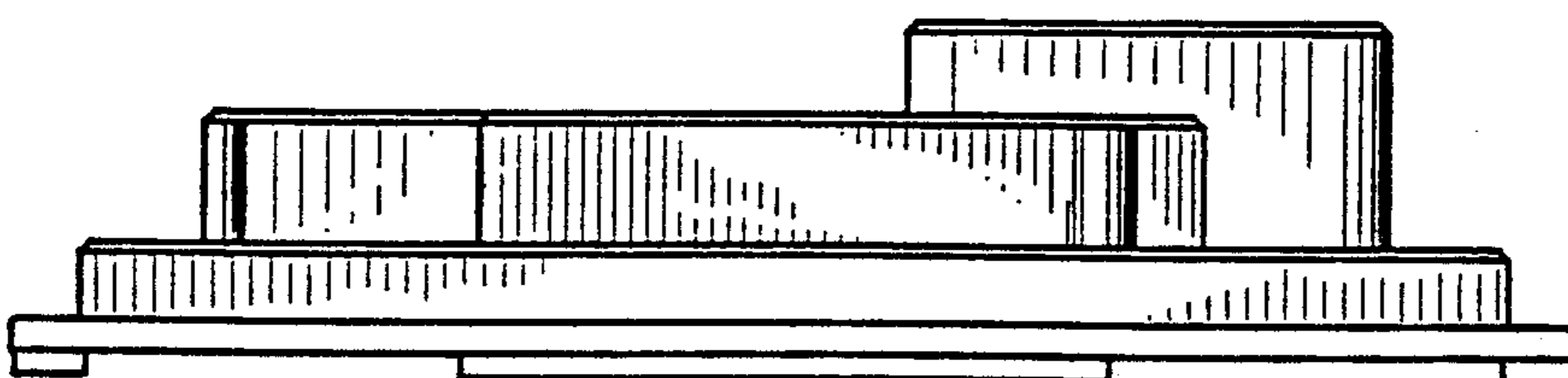
