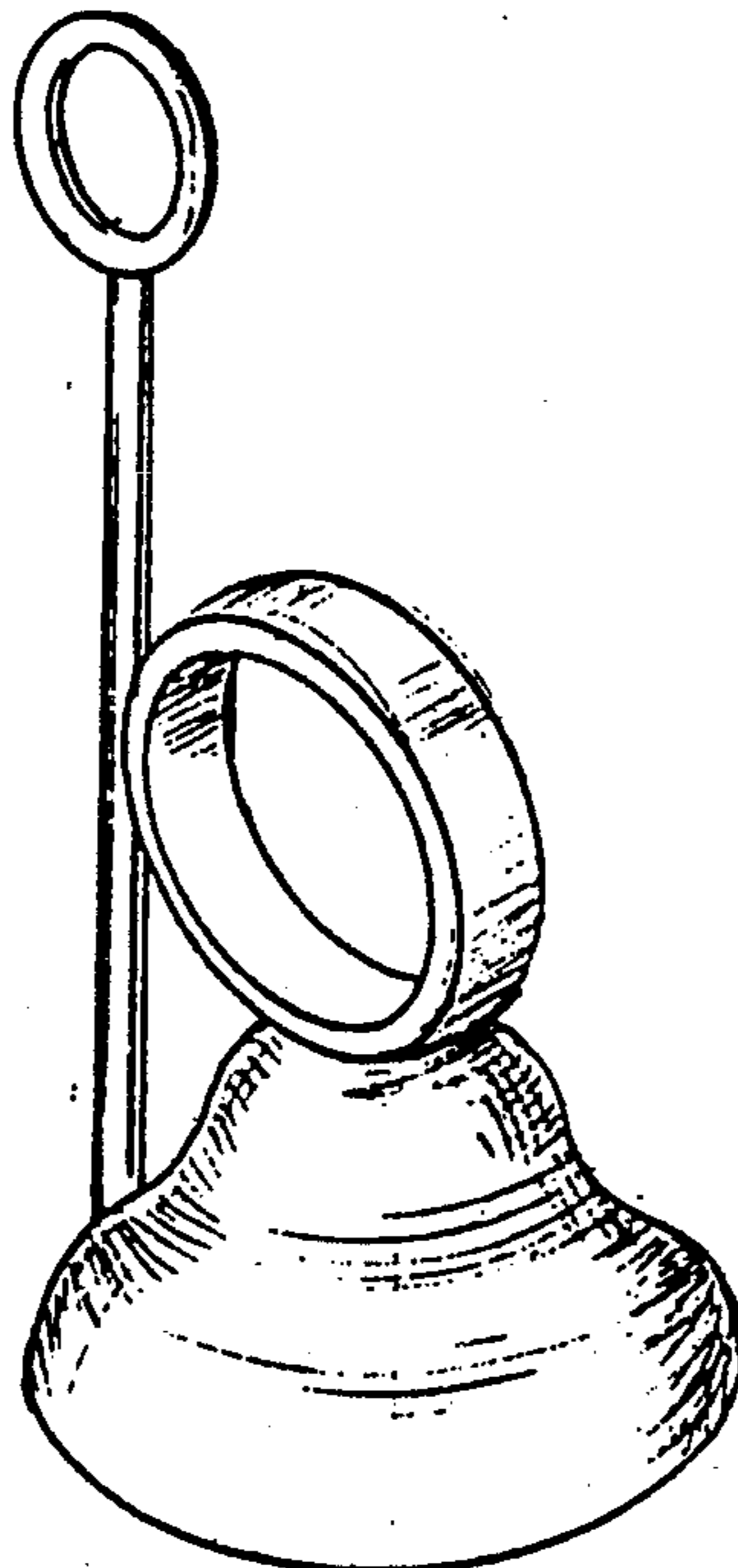

[57] **CLAIM**

The ornamental design for a protective cap for a beverage bottle, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a protective cap for a beverage bottle showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof, the left side being a mirror image of the right side as shown; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.



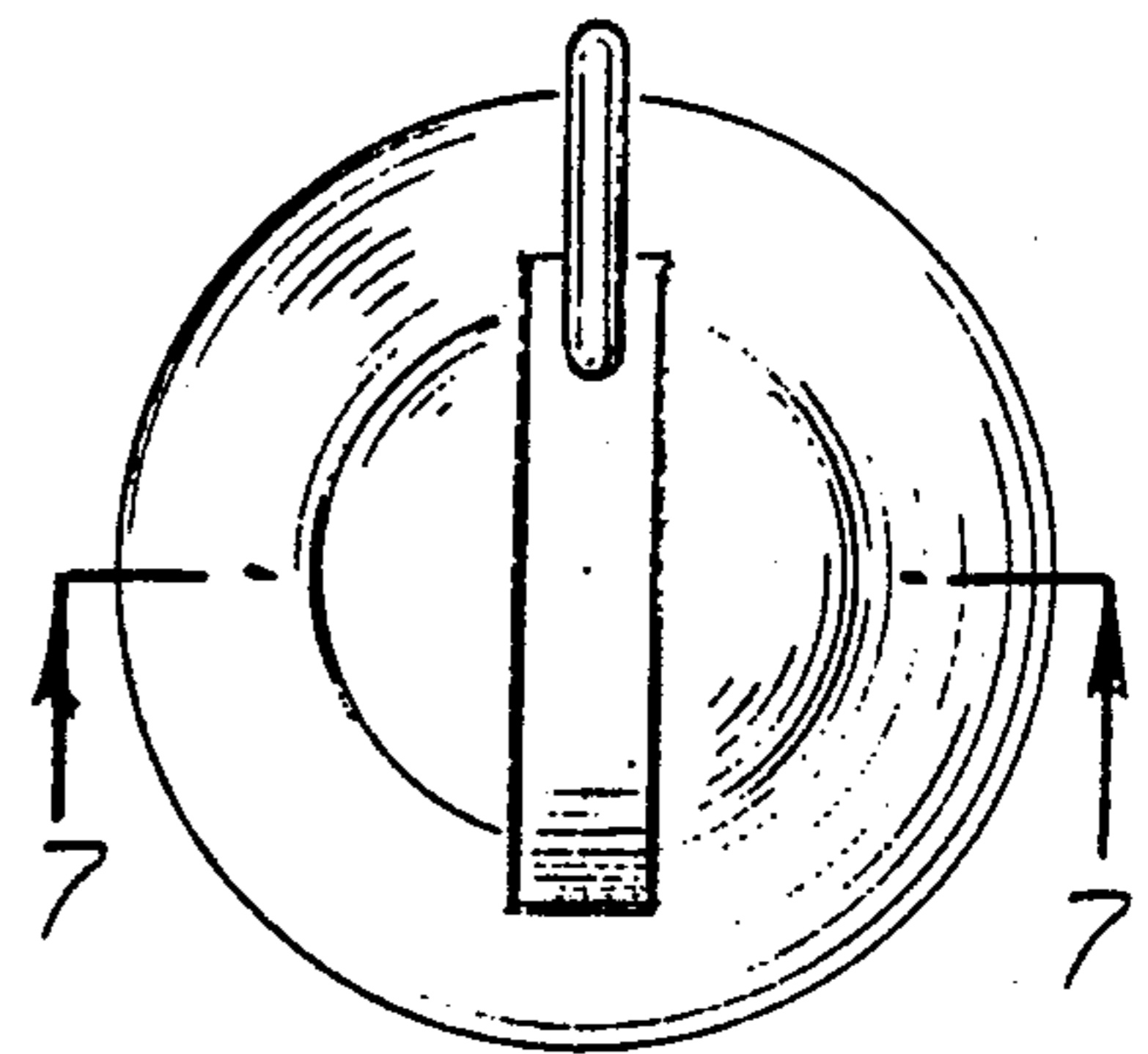
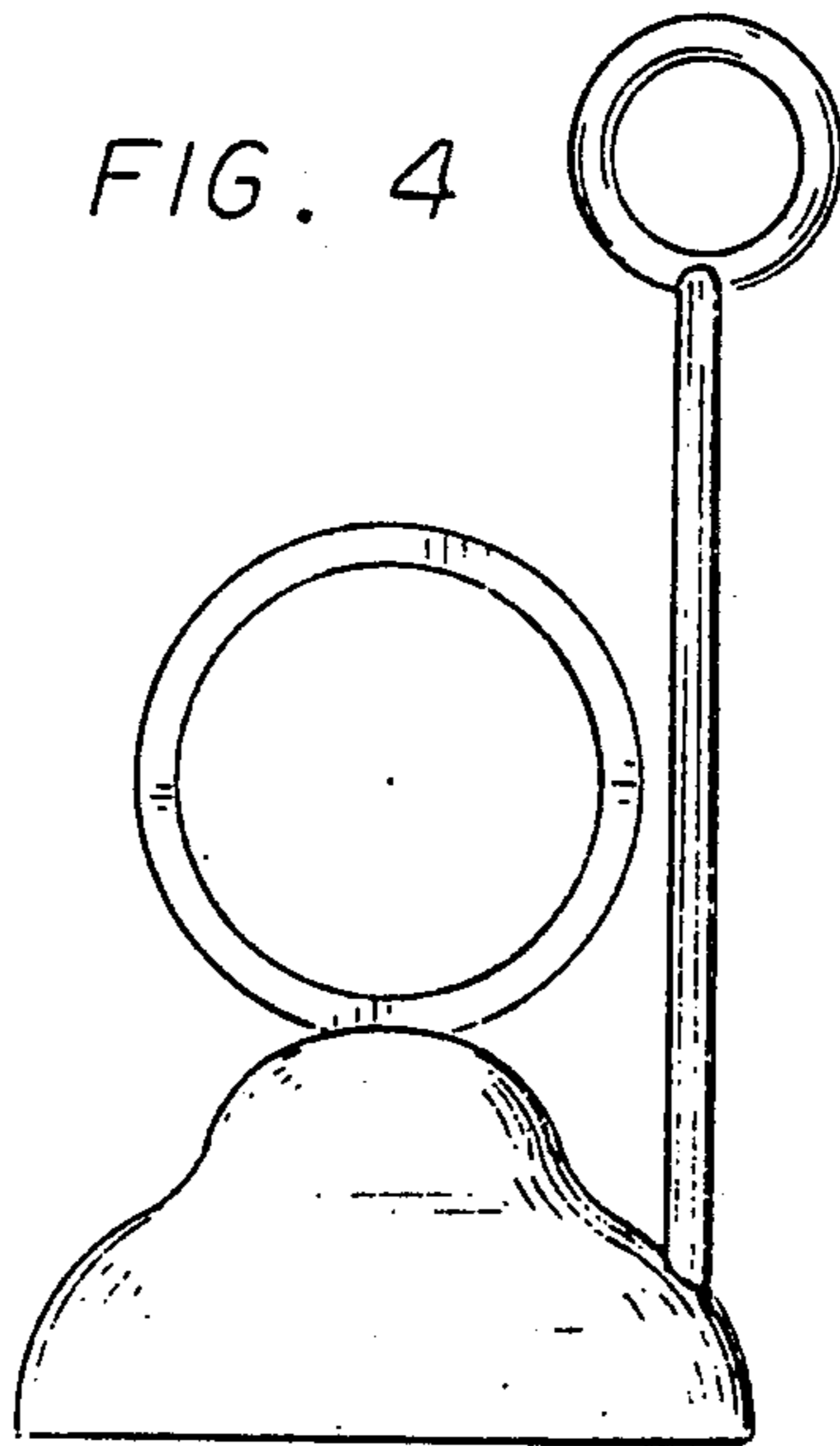
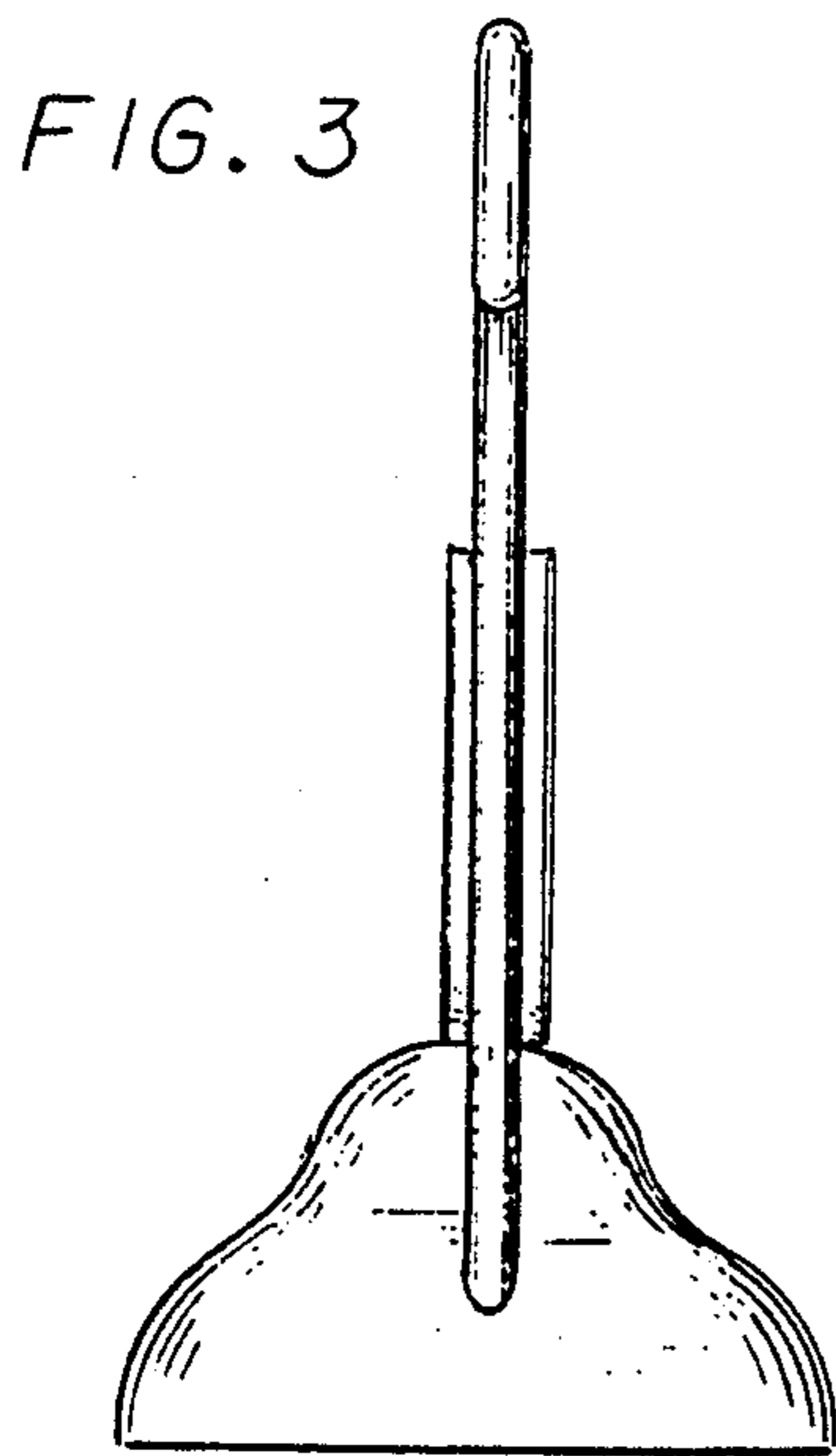
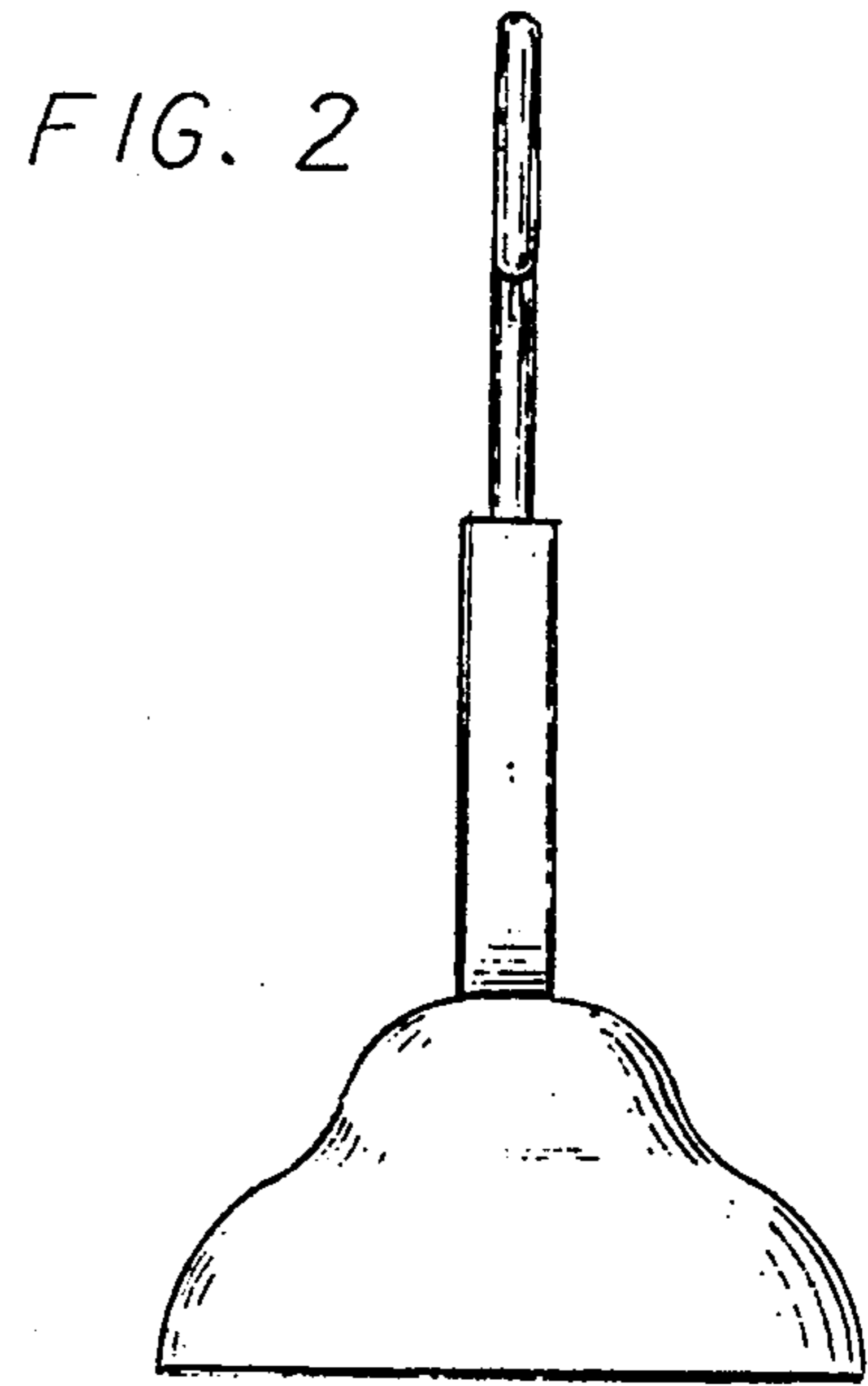
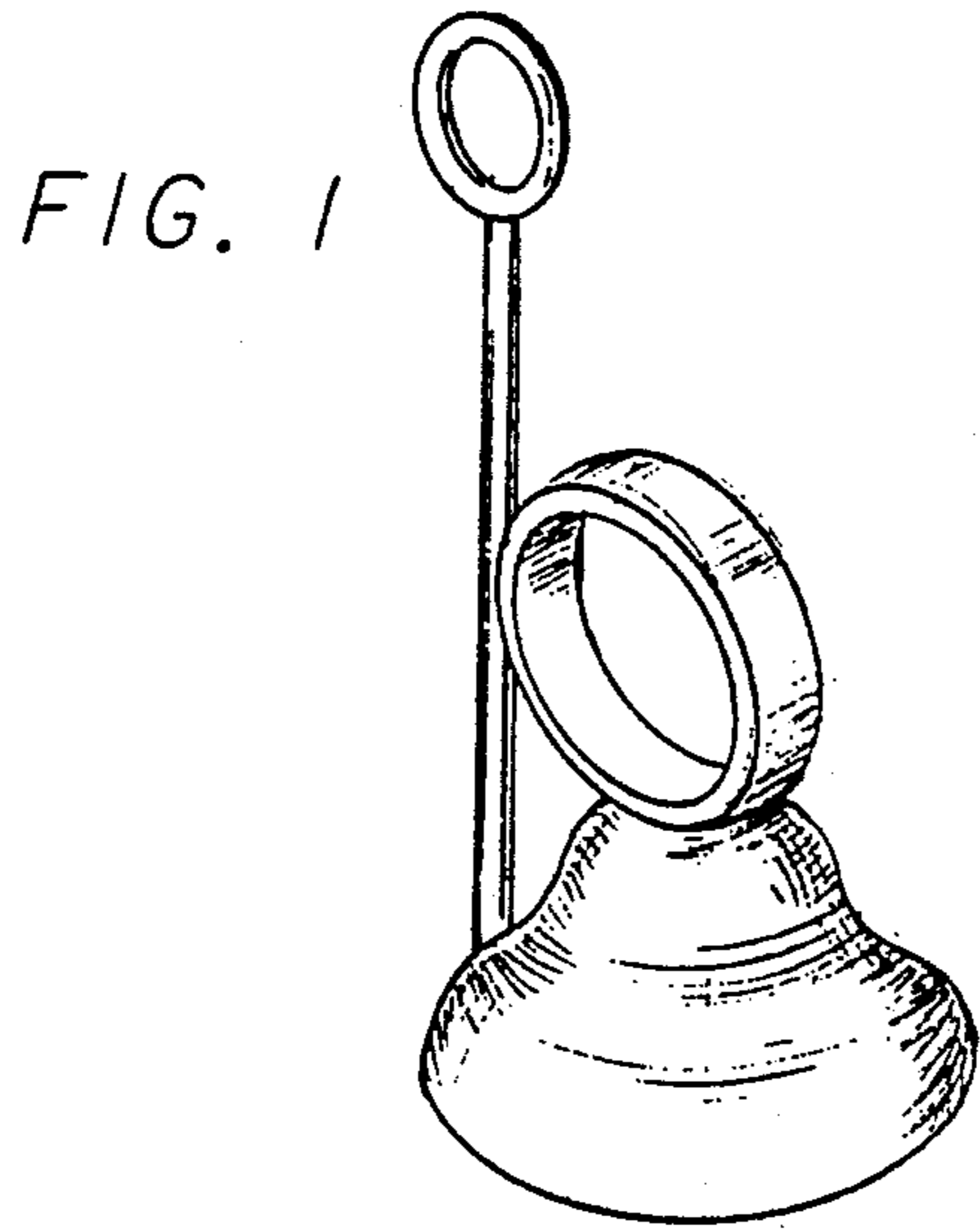
