The ornamental design for an adapter unit for providing a cordless connection between the handset and base of a telephone, as shown and described.

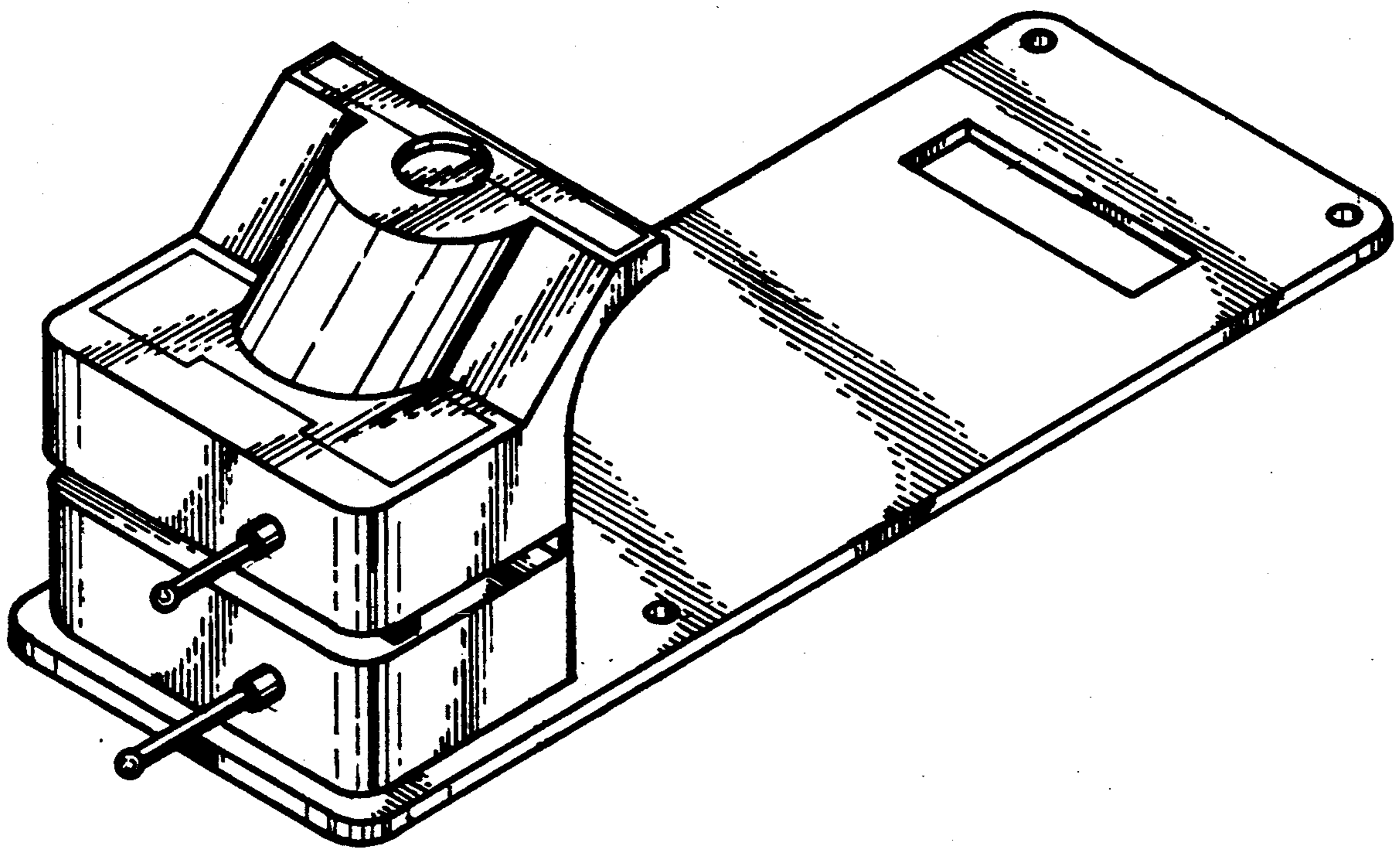
DESCRIPTION

FIG. 1 is a perspective view of the adapter unit for providing a cordless connection between the handset and base of a telephone embodying the design of the present invention;
FIG. 2 is a front elevational view thereof, the rear being a mirror image of the front shown in FIG. 2;
FIG. 3 is an end elevational view thereof;
FIG. 4 is an opposite end elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom view thereof.

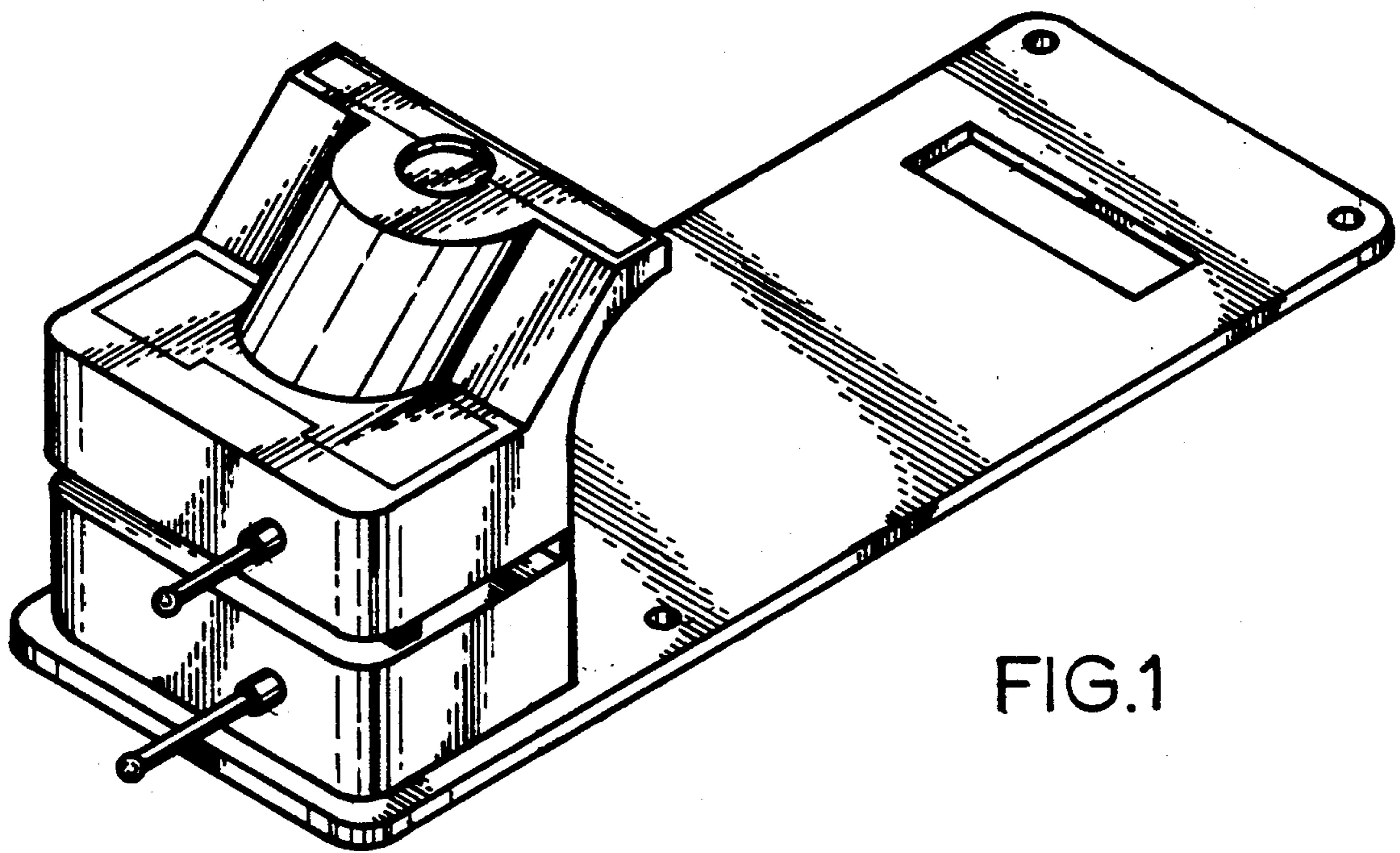

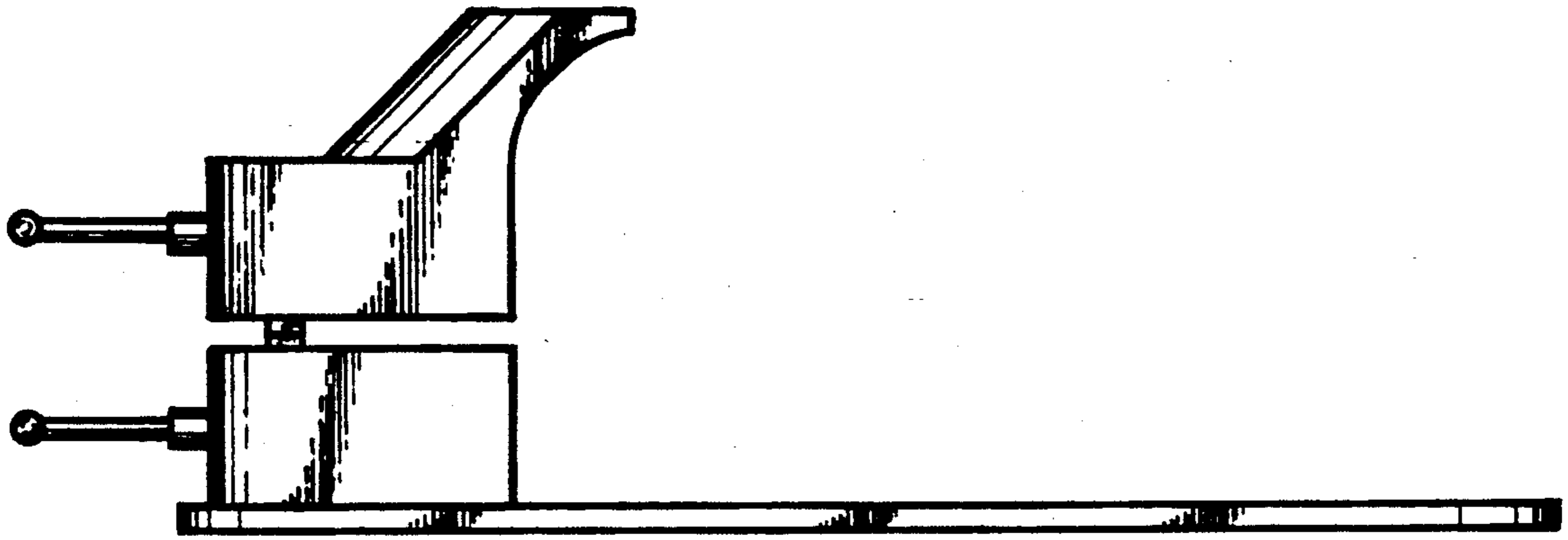

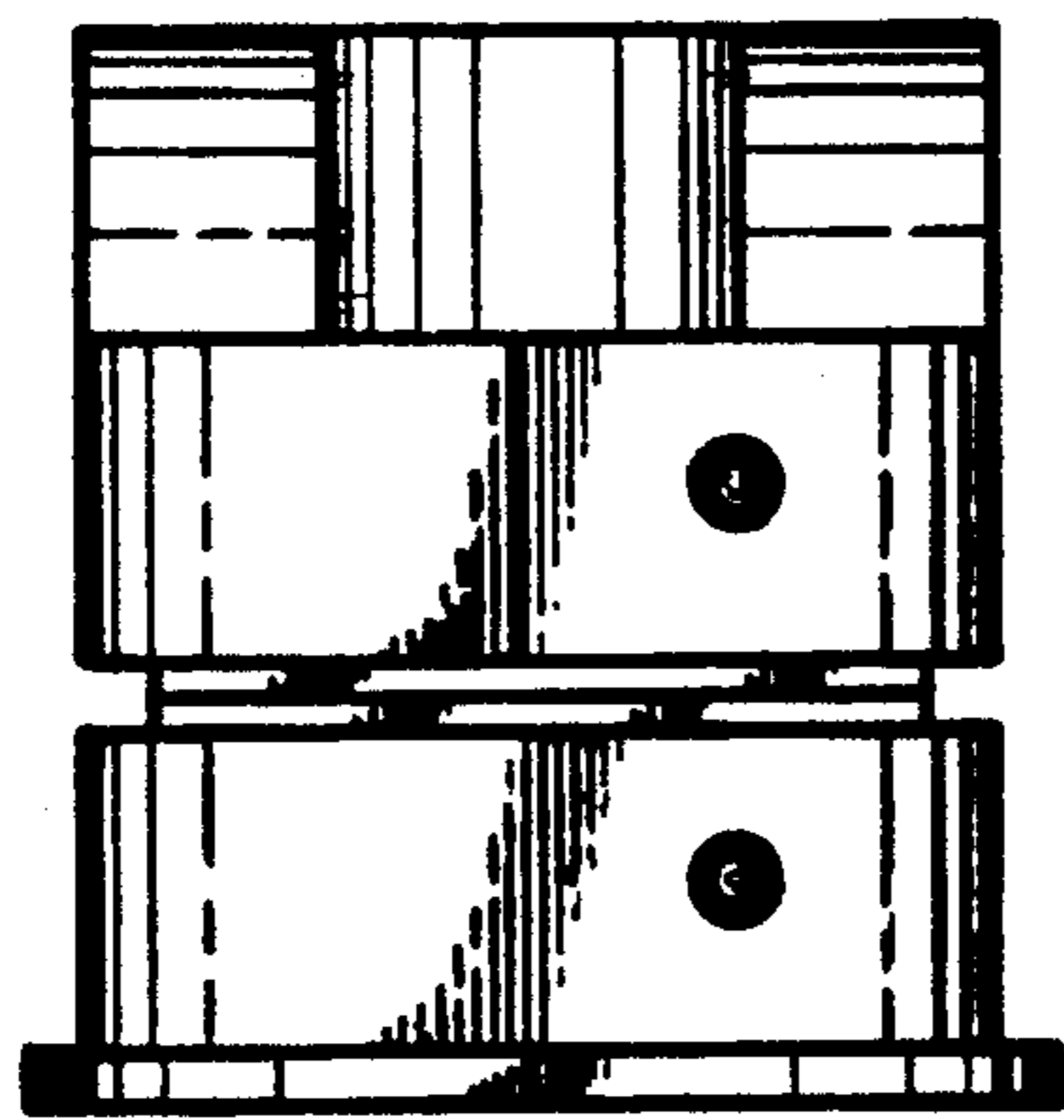

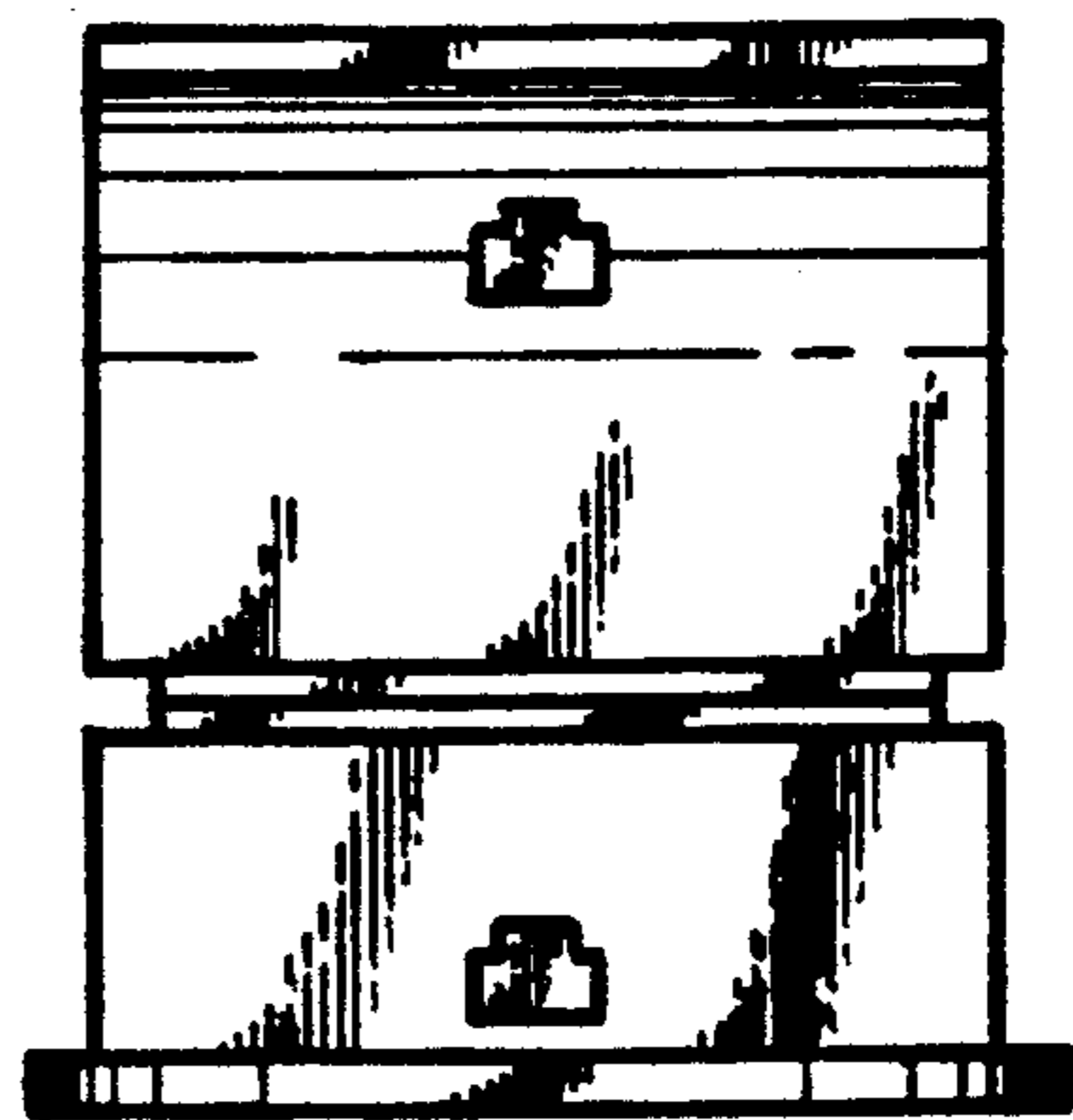

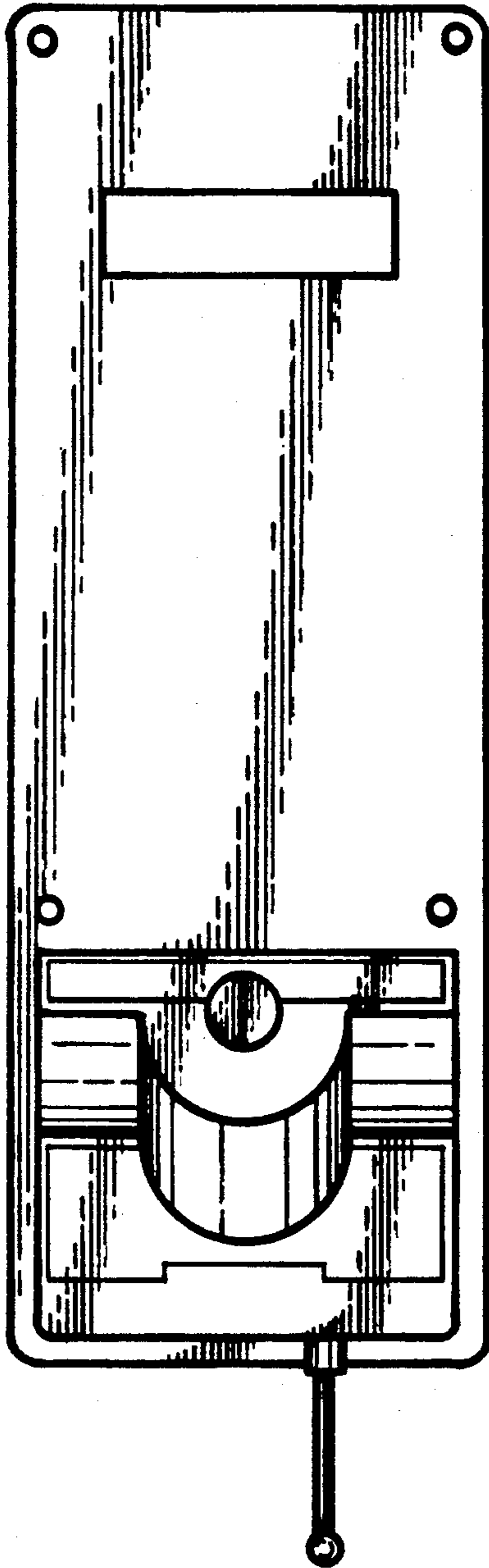

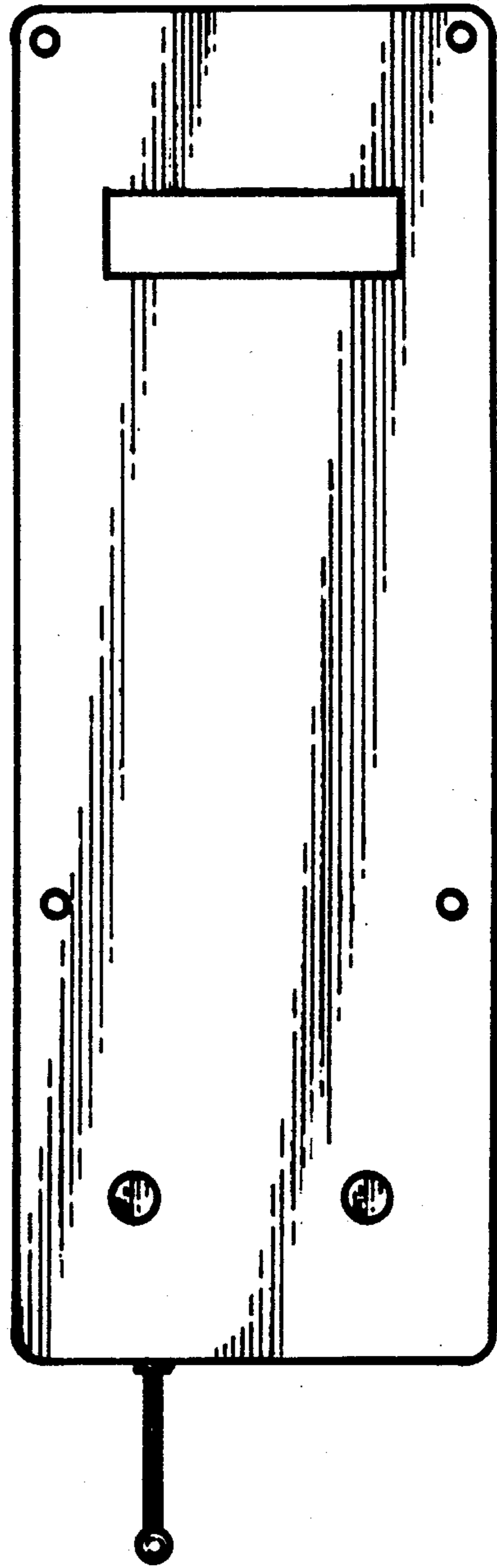
