[57] **CLAIM**

The ornamental design for a belt or belt buckle display rack, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a belt or belt buckle display rack showing my new design the rear being a mirror image thereof;
FIG. 2 is a top plan view, the bottom being a mirror image thereof; and,
FIG. 3 is a right side elevational view, the left side being a mirror image thereof.

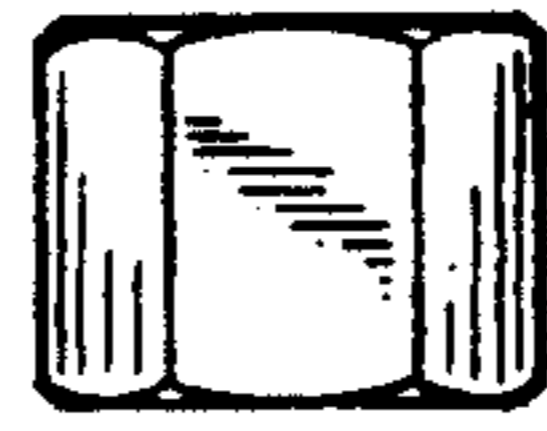
