The ornamental design for a combined bottle and cap, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a combined bottle and cap showing my new design;

FIG. 2 is a view from the left side thereof;

FIG. 8 is an exploded perspective view thereof.

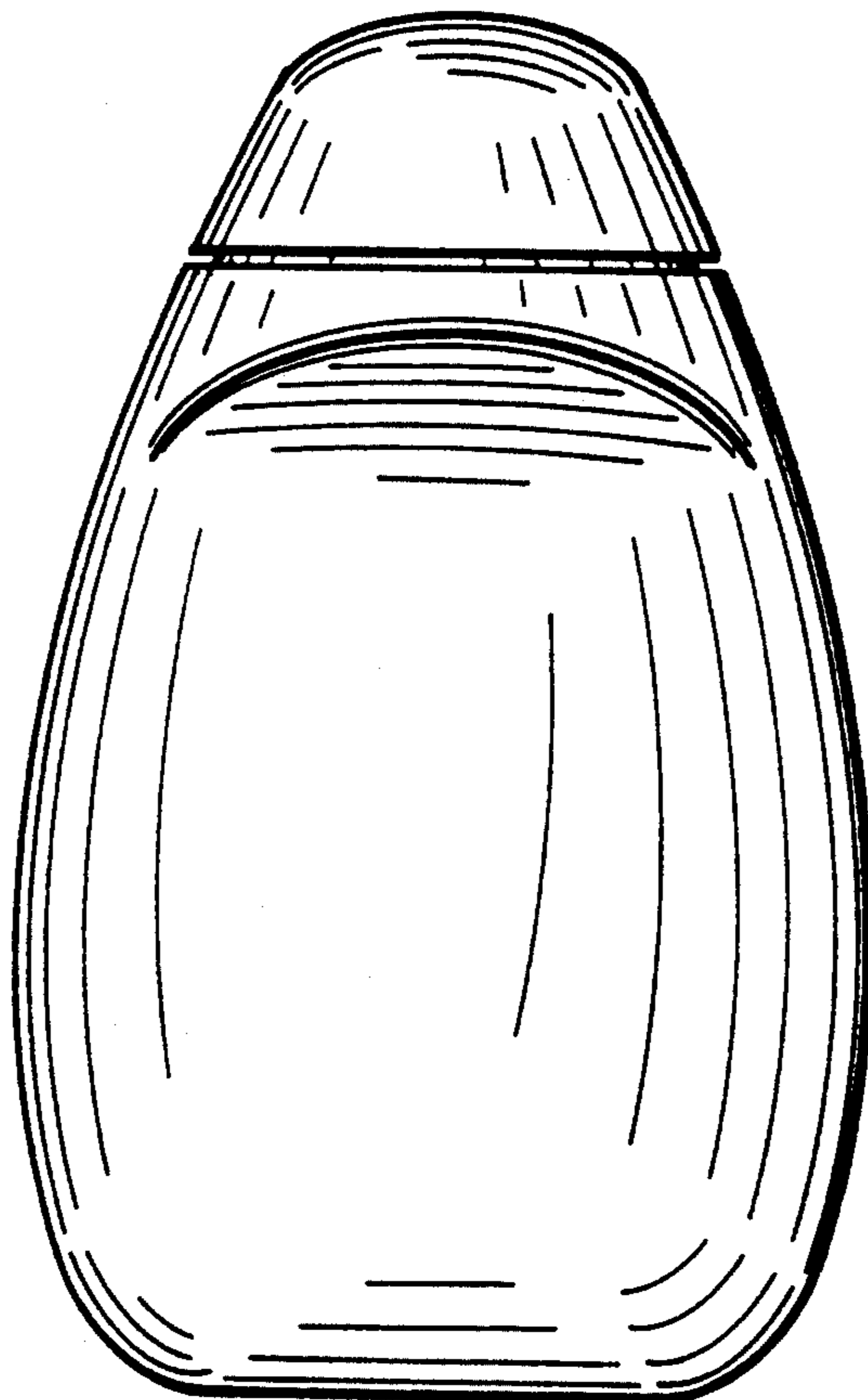

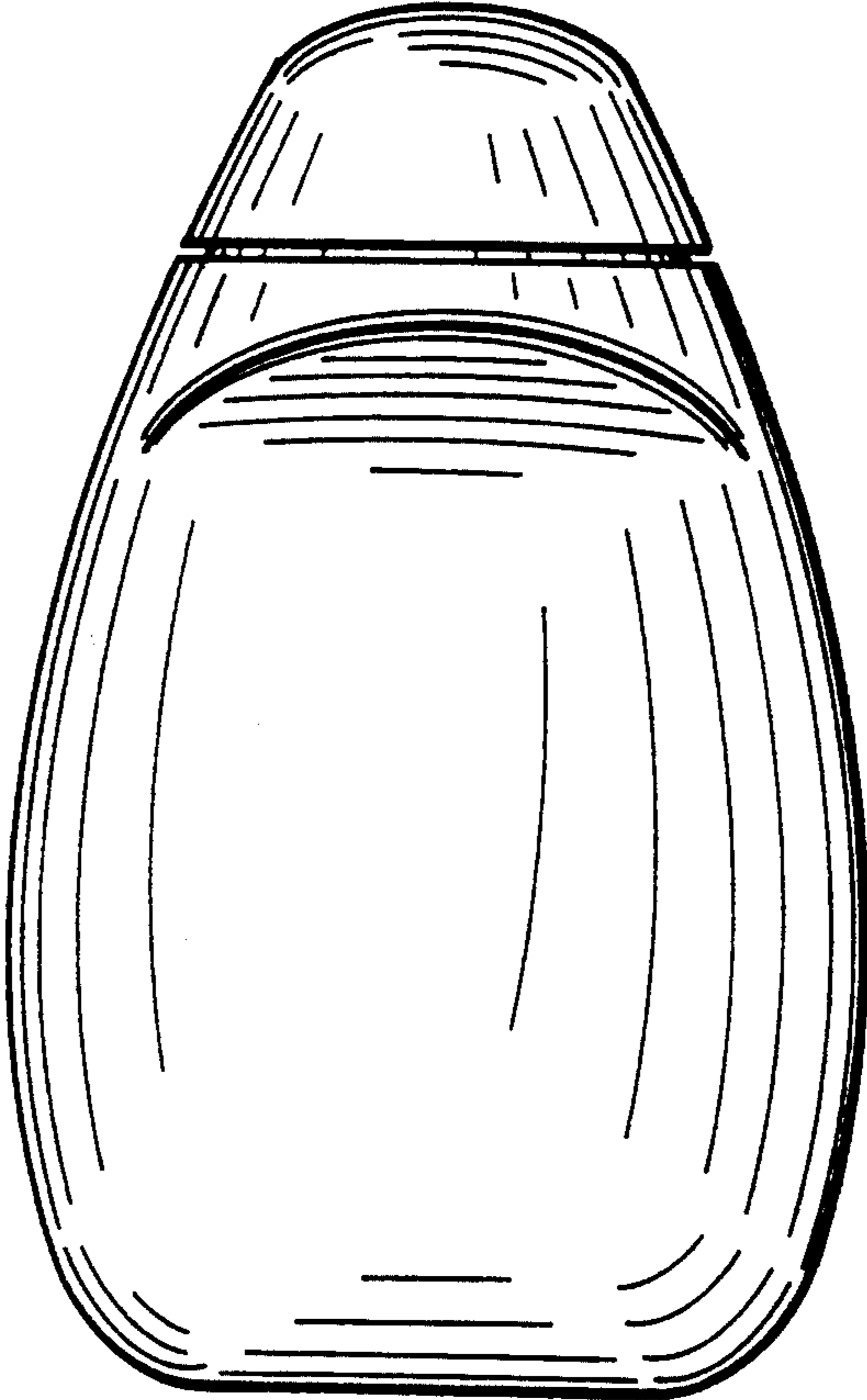

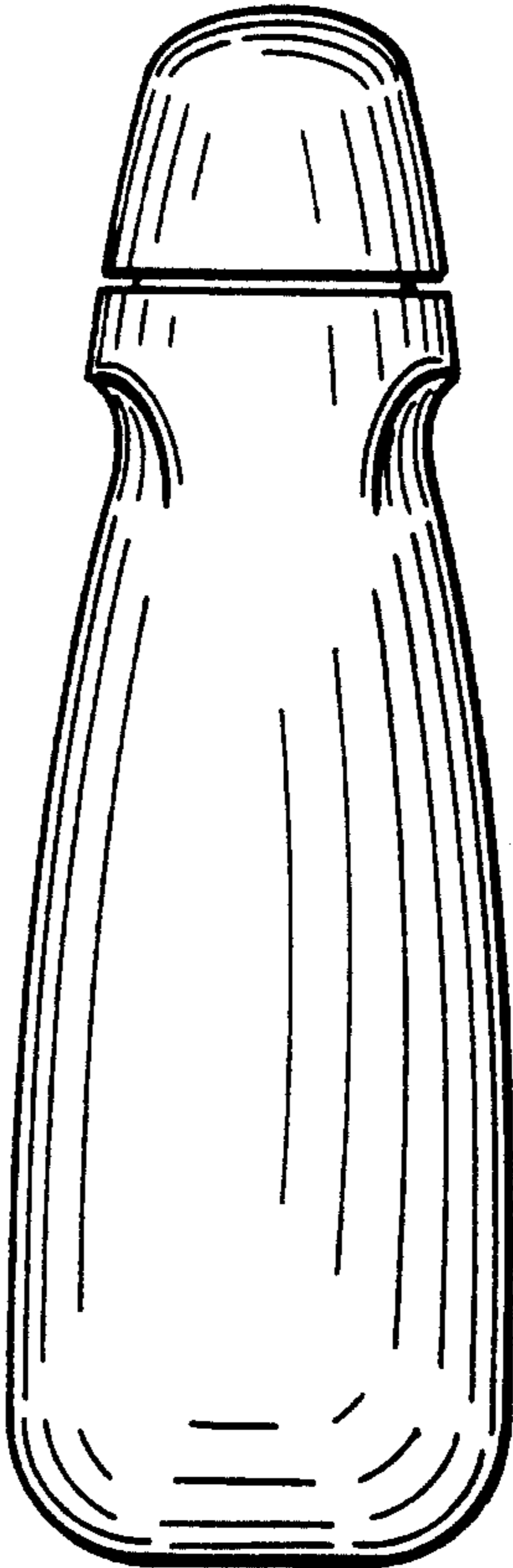

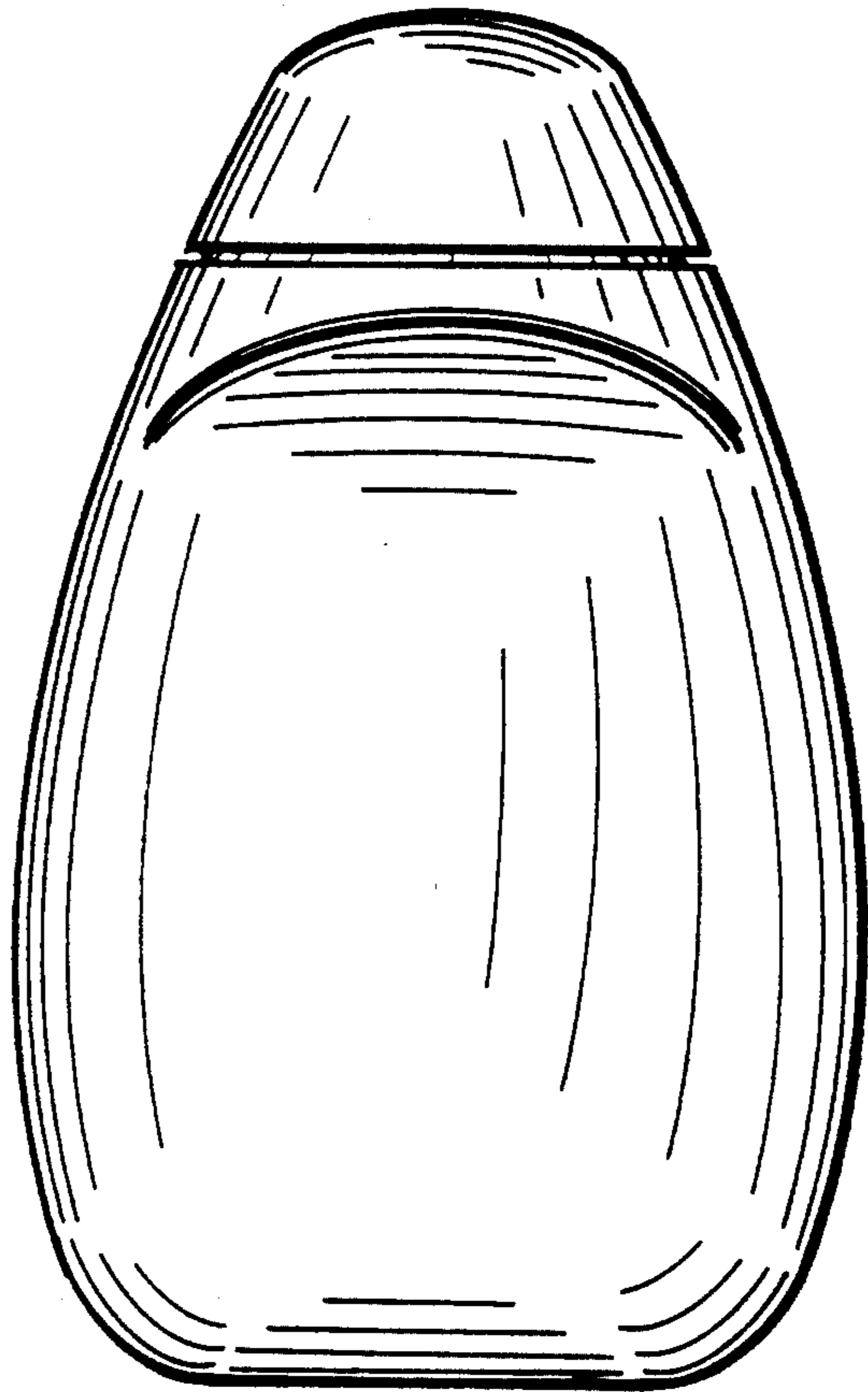

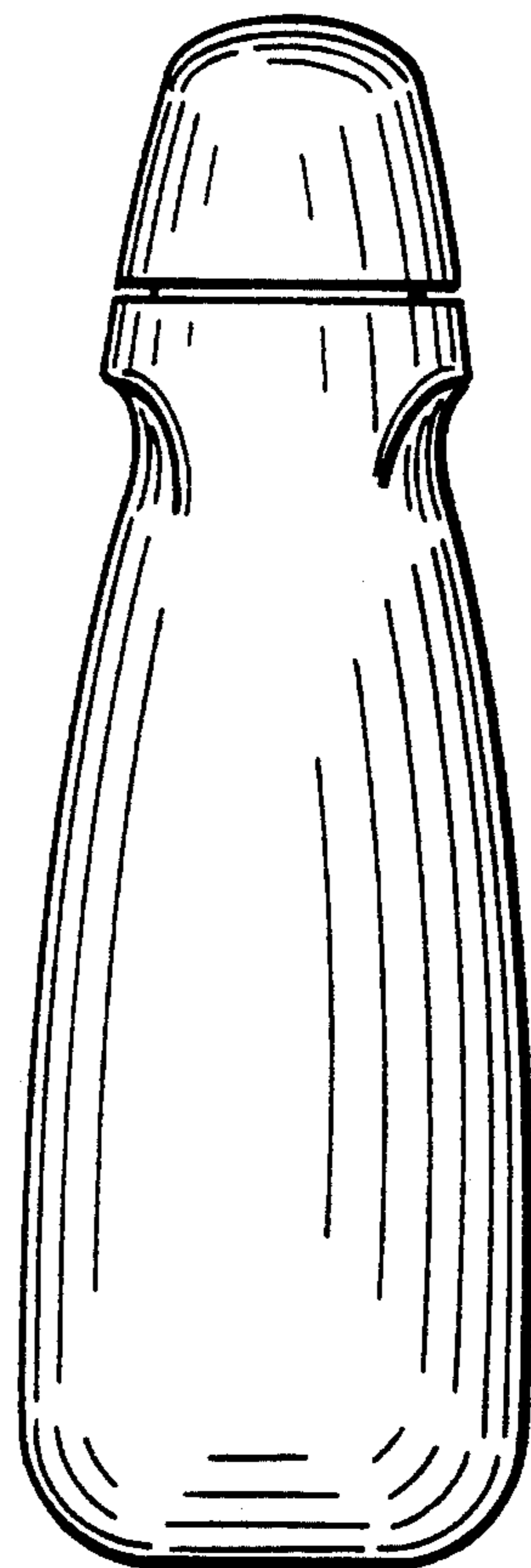

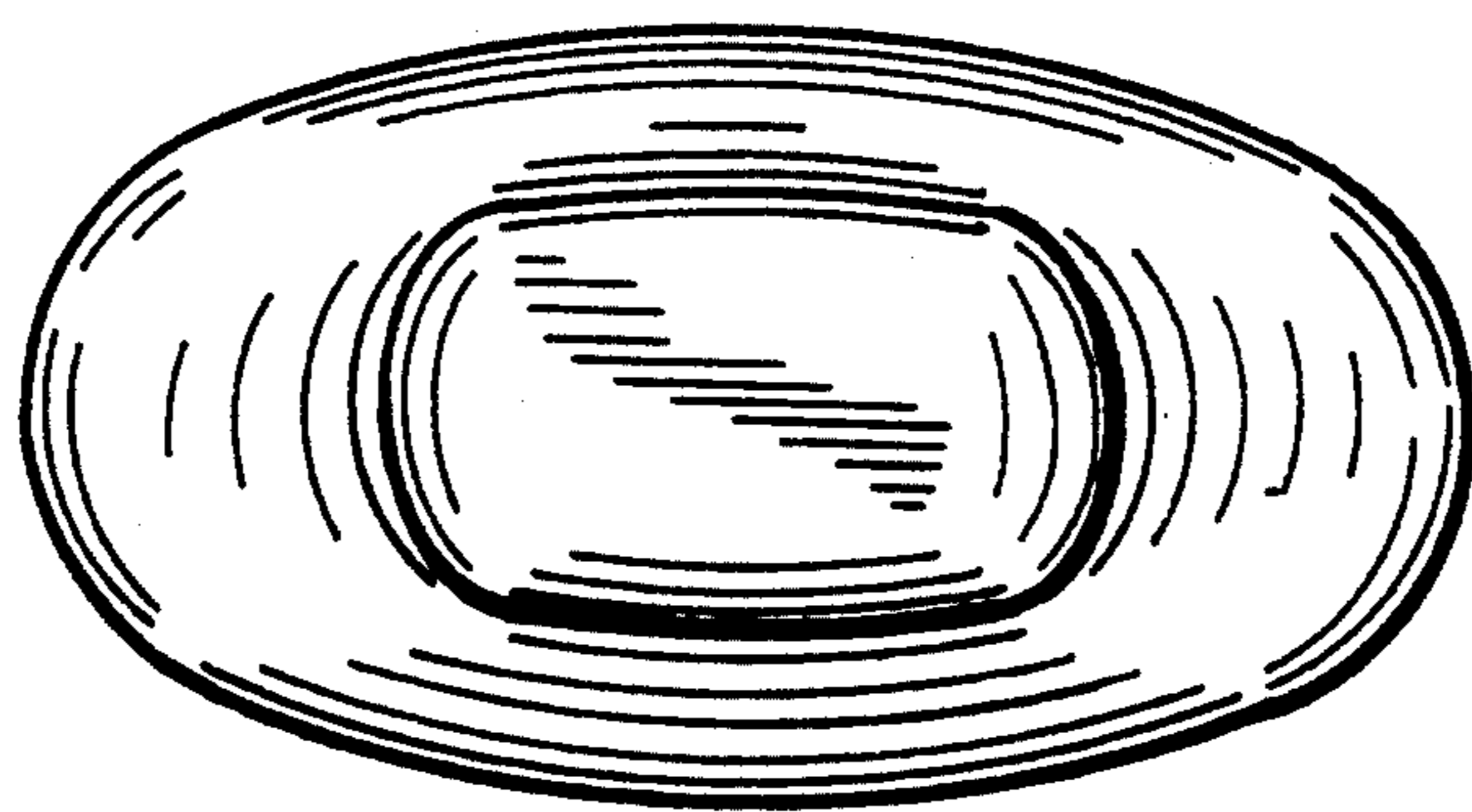
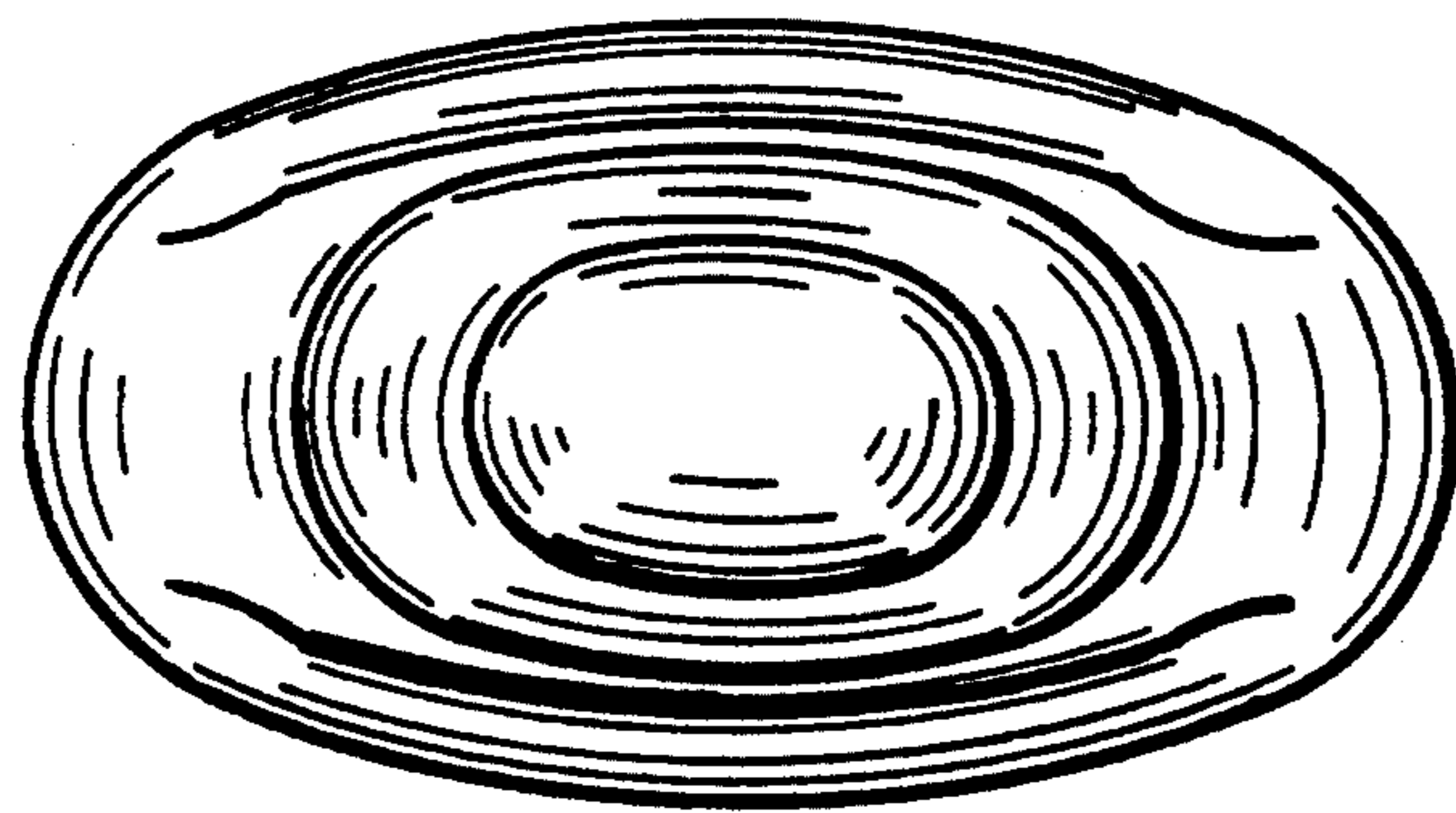

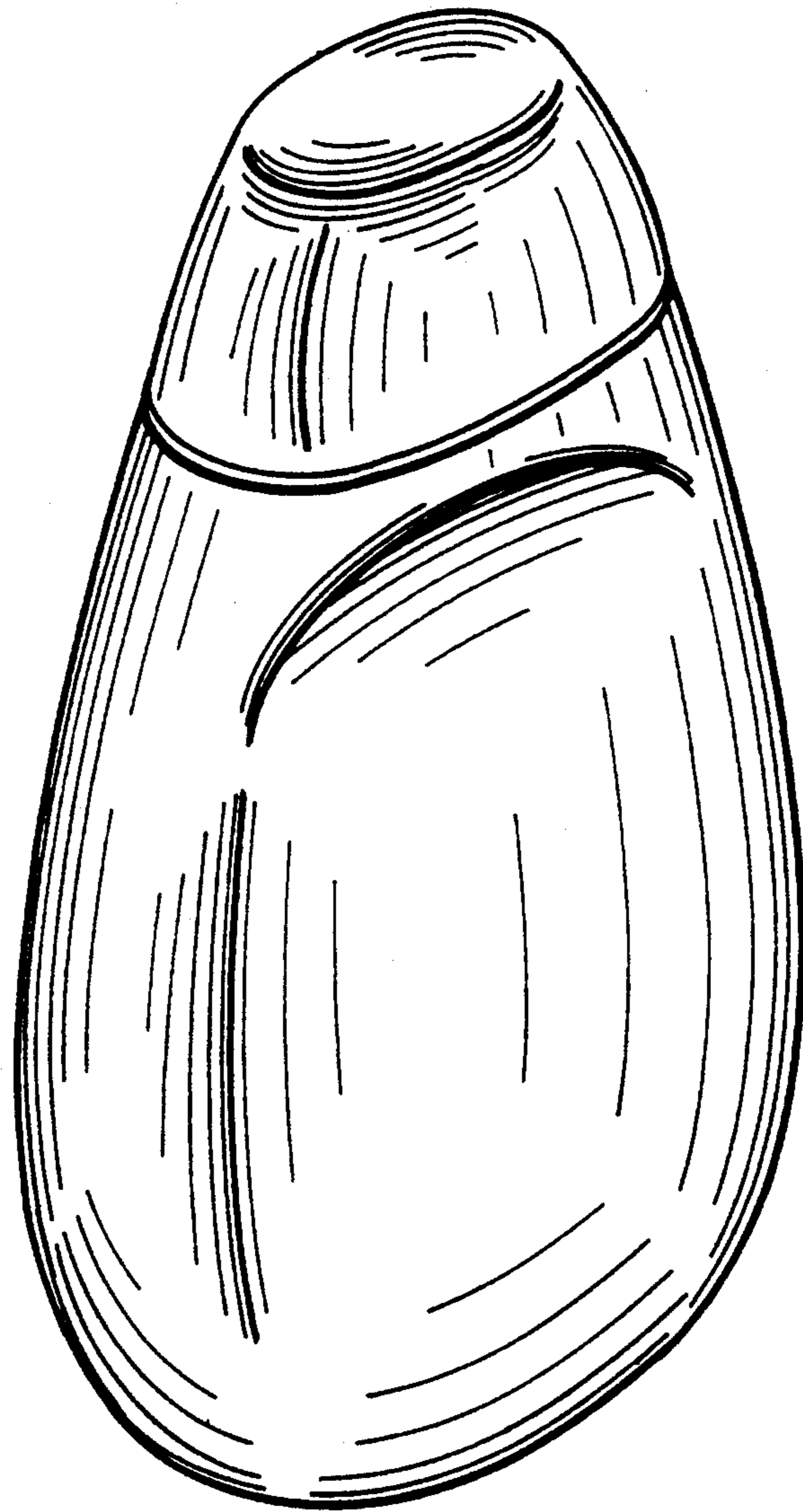
