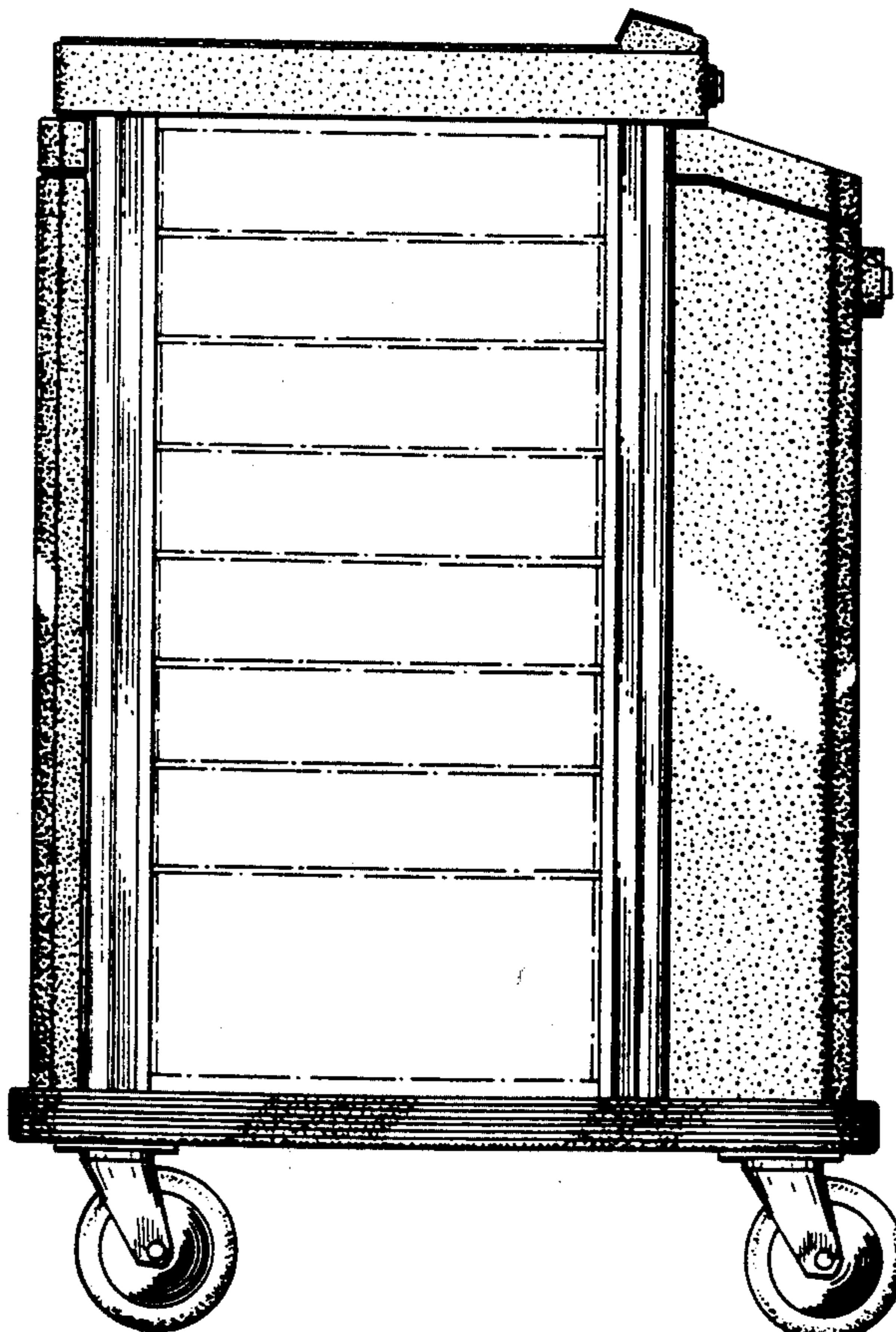

The ornamental design for a medication cart, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one embodiment of a medication cart;
 FIG. 2 is a side elevational view of a second embodiment of the medication cart;
 FIG. 3 is a side elevational view of a third embodiment of the medication cart;
 FIG. 4 is a top elevational view taken from FIG. 1;
 FIG. 5 is a top elevational view taken from FIG. 2;
 FIG. 6 is a top elevational view taken from FIG. 3;

 FIG. 13 is a bottom view taken from FIG. 3.



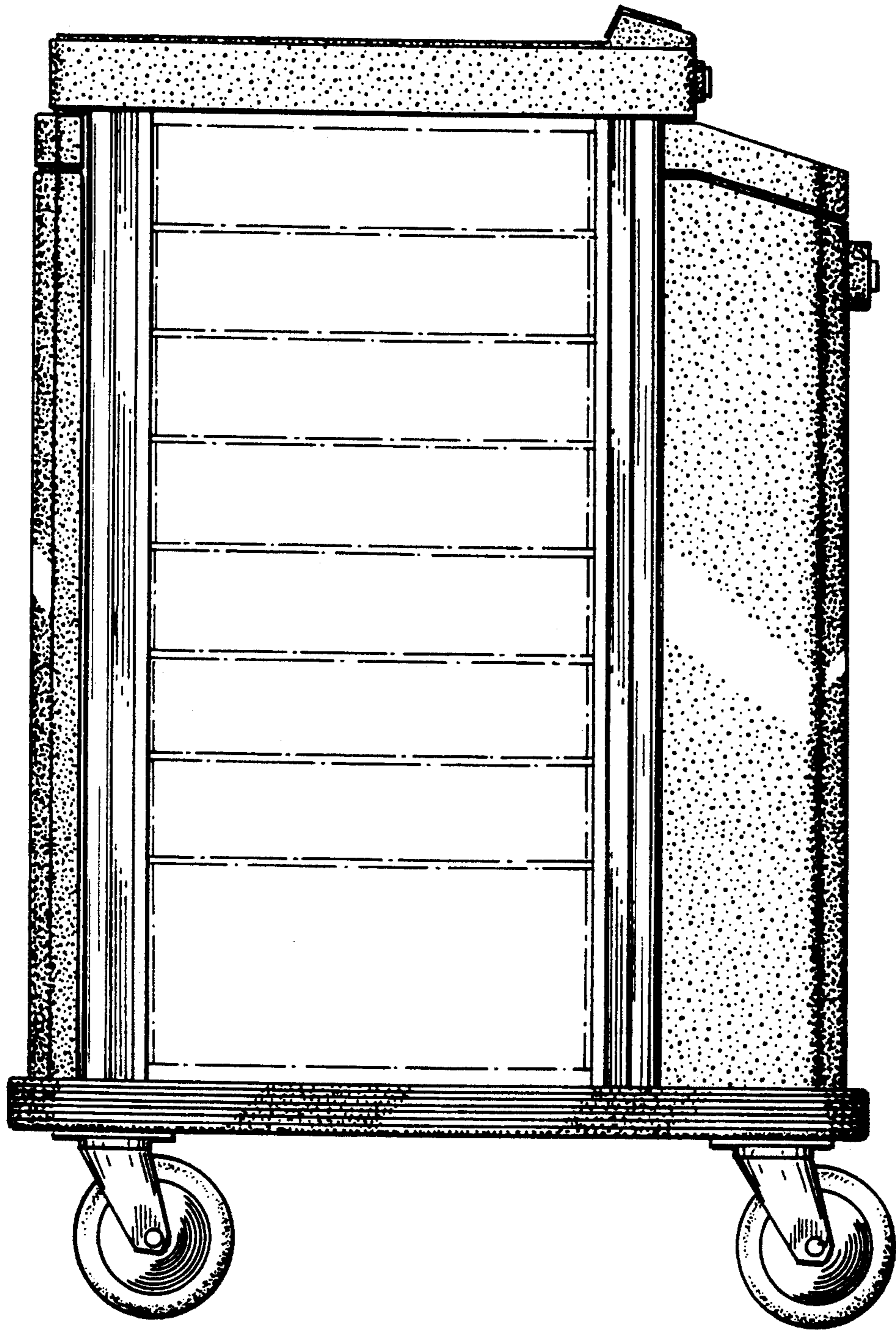

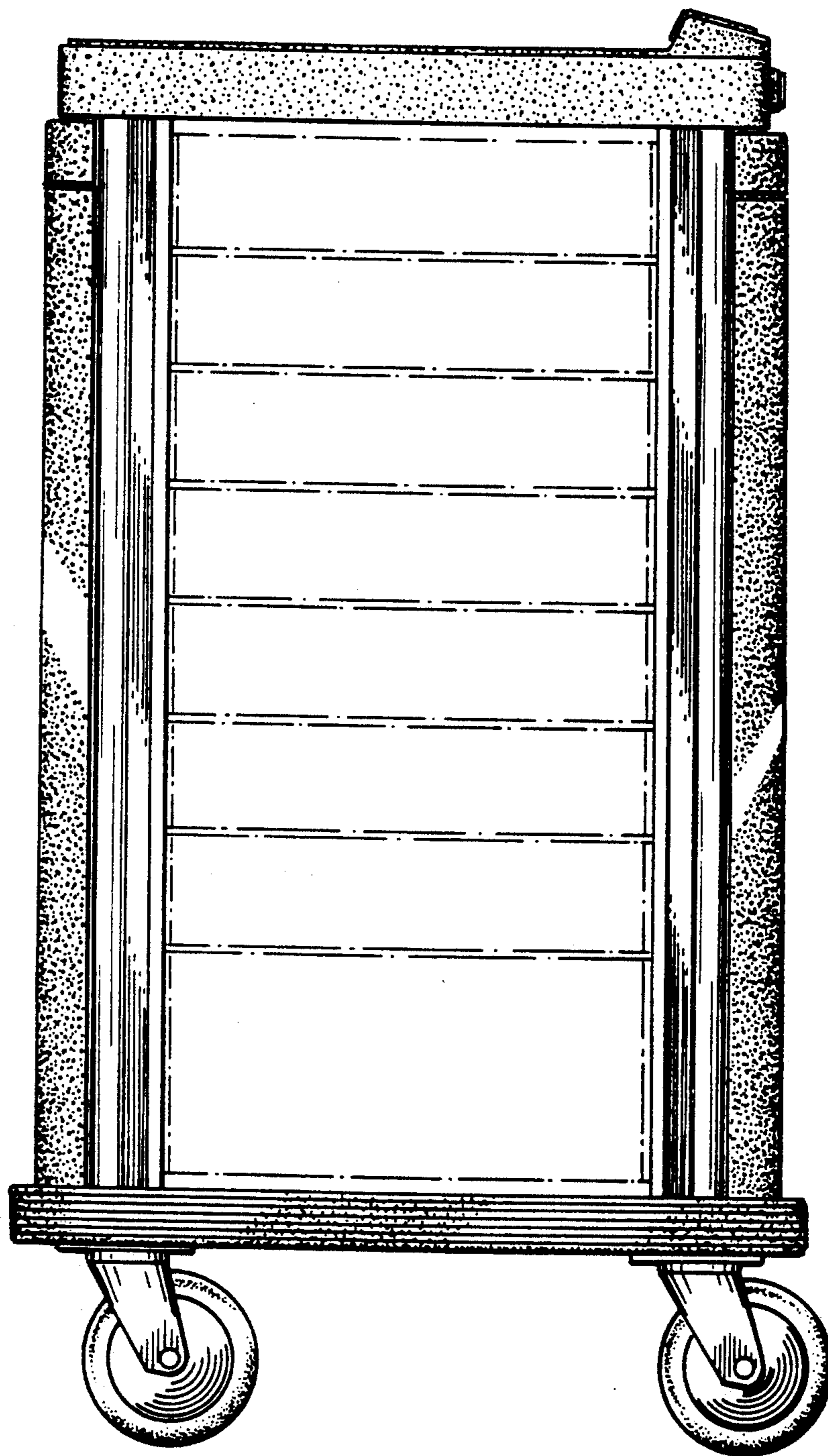

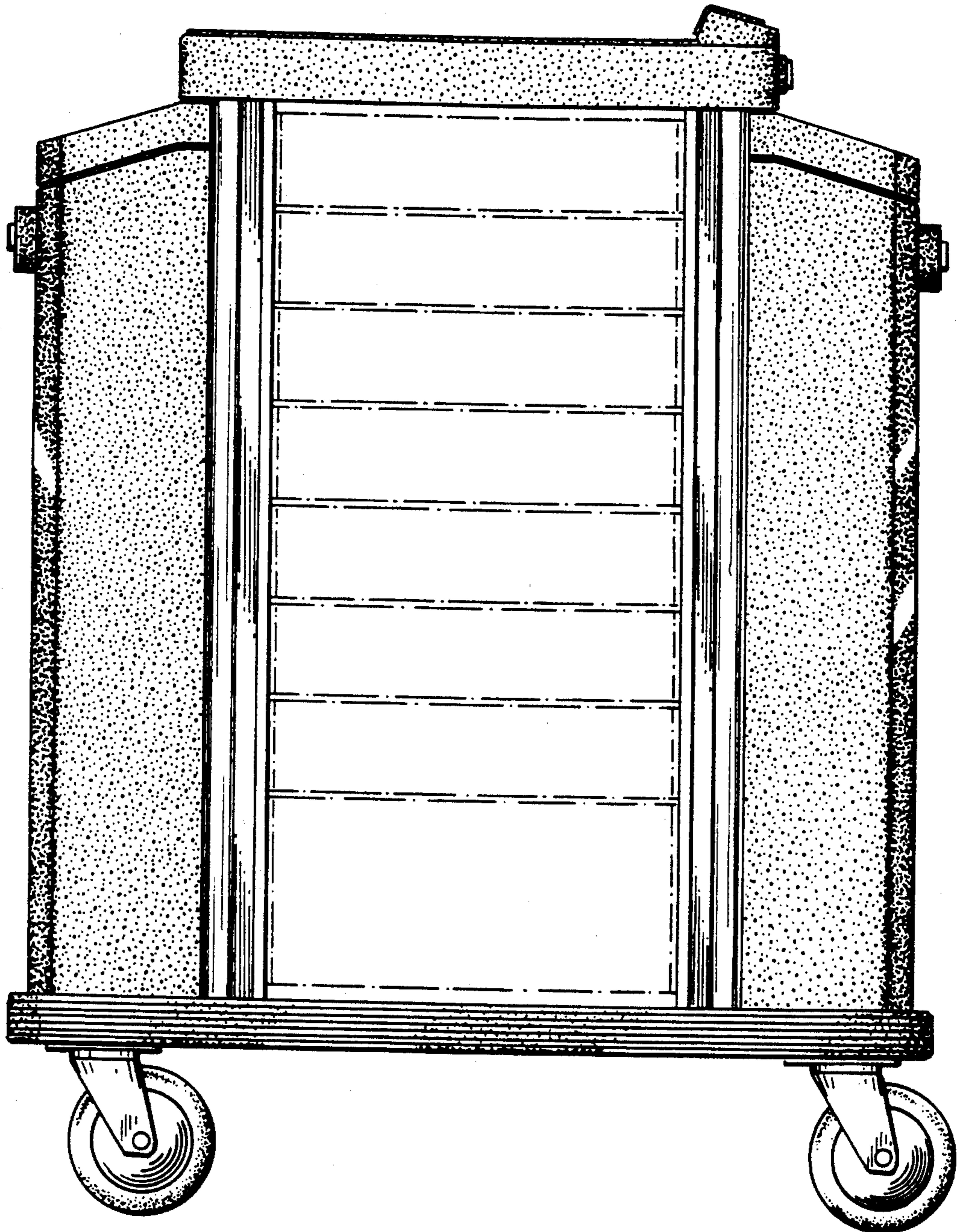

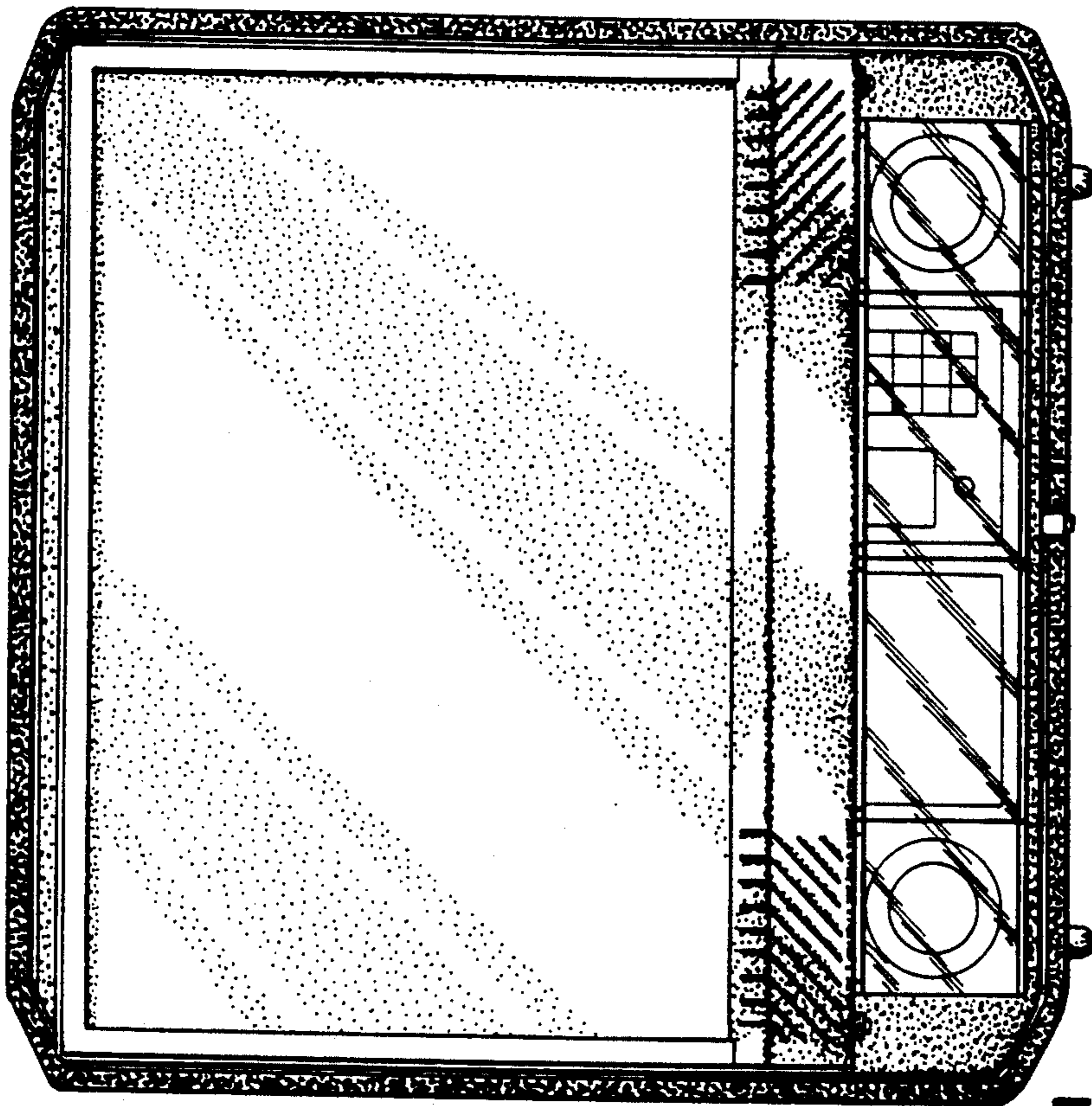

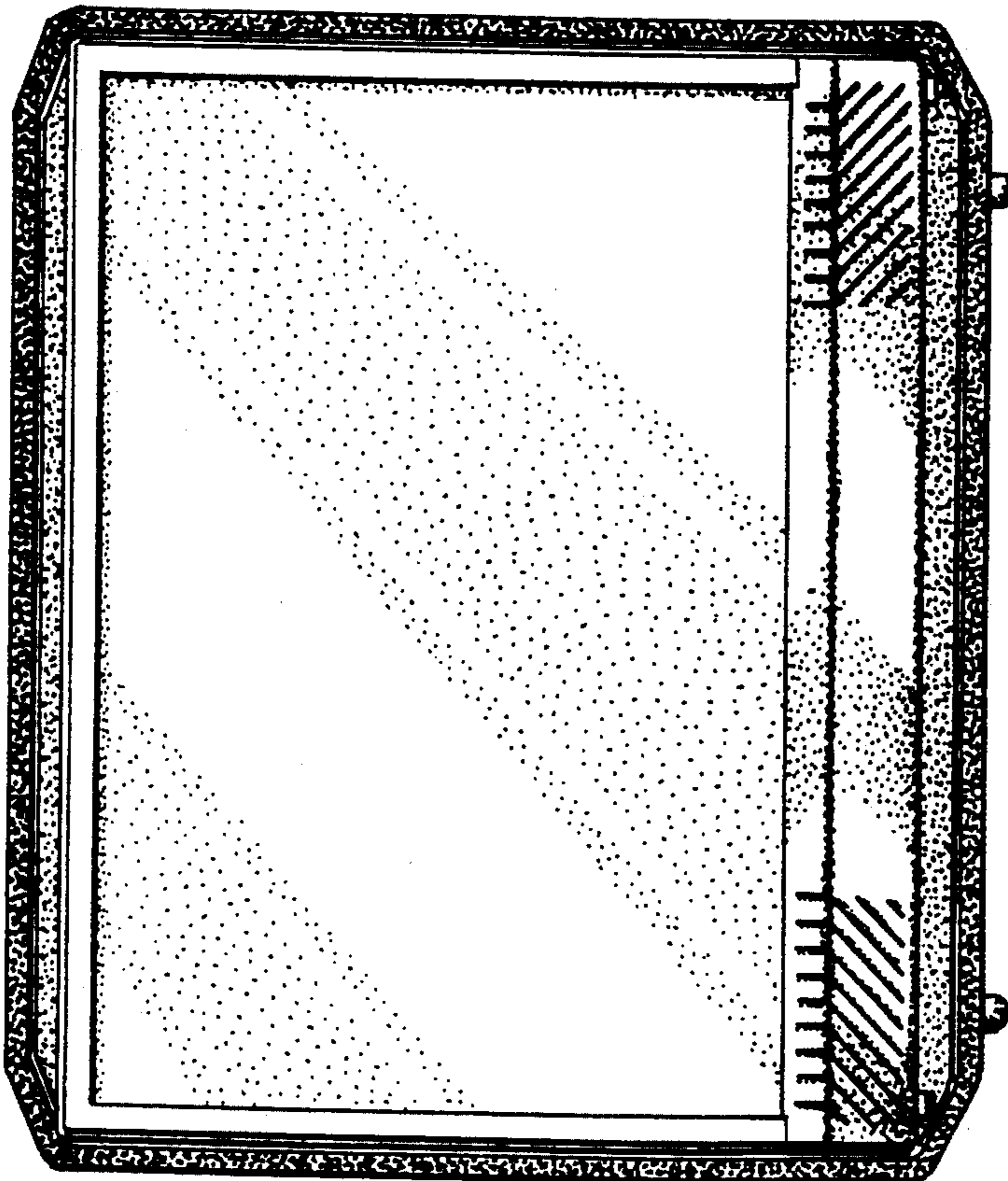

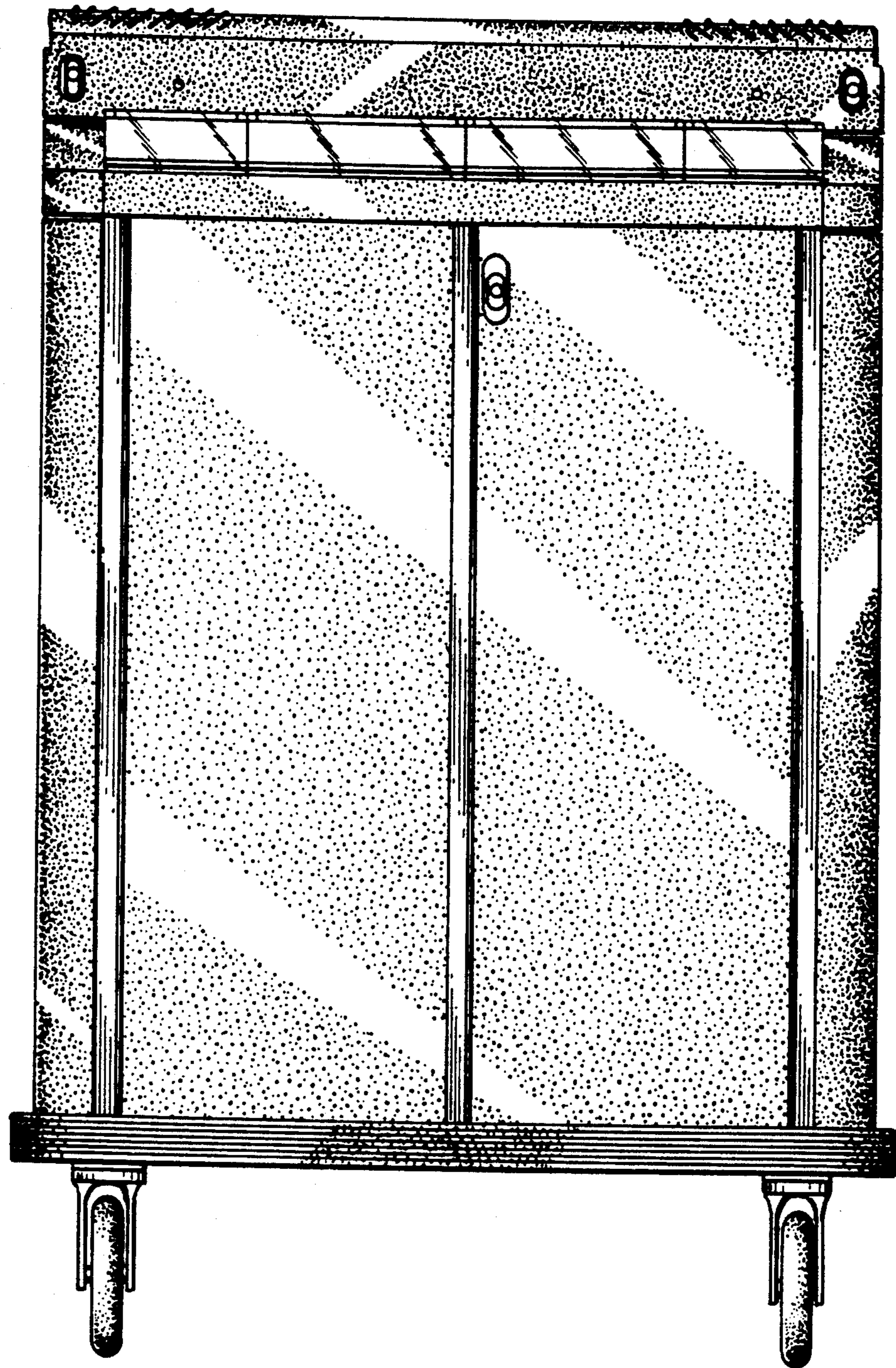

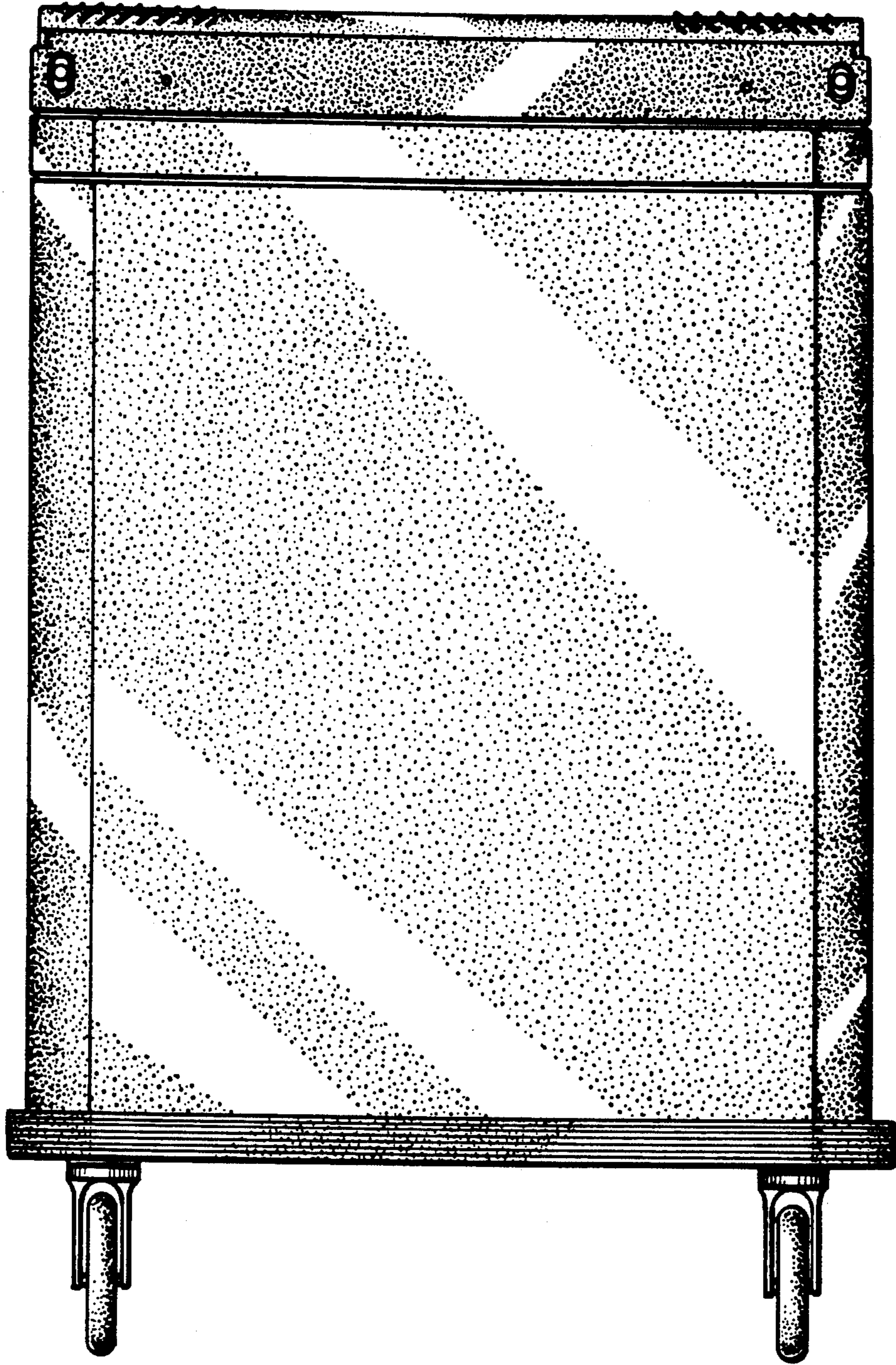

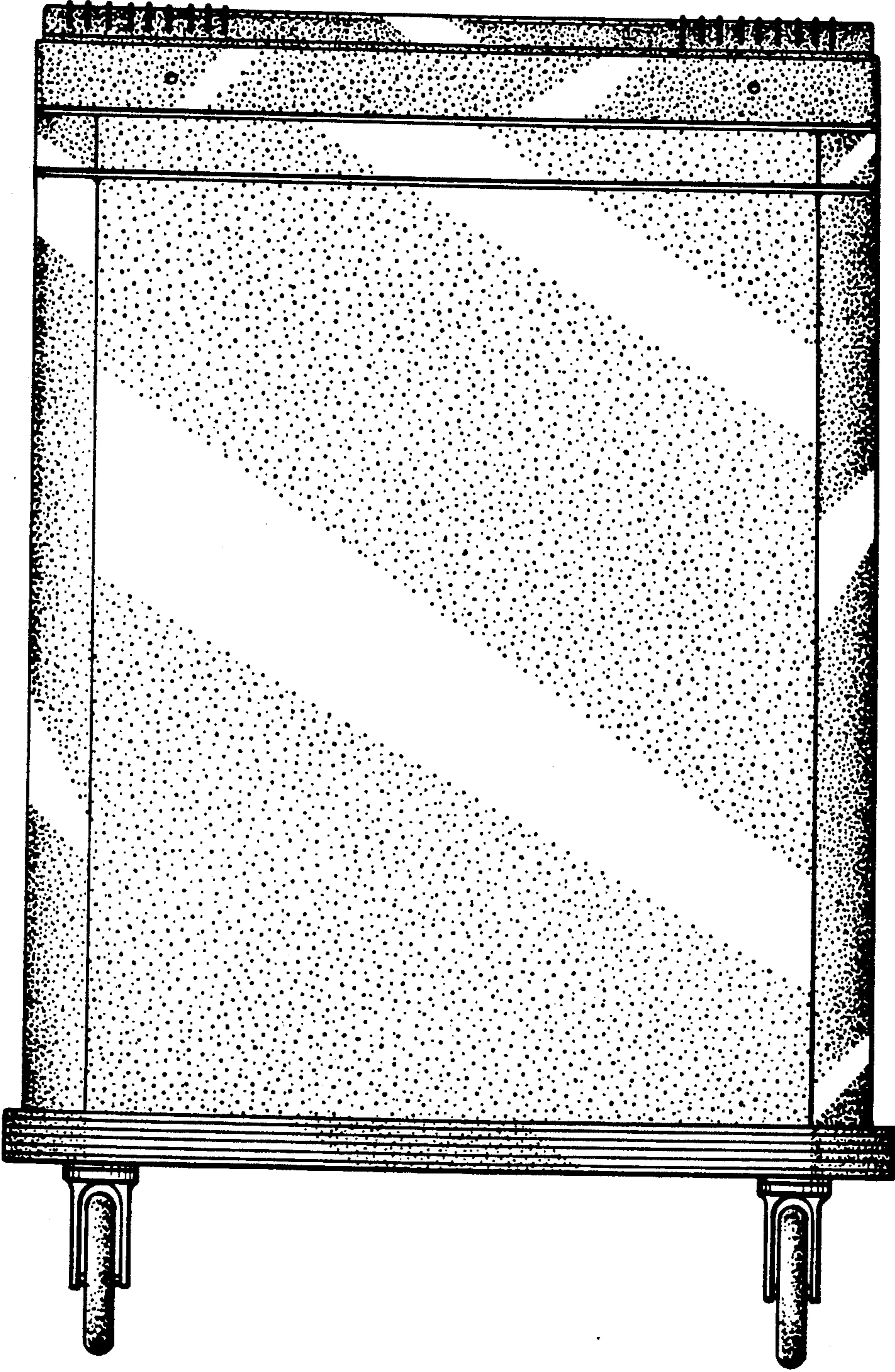

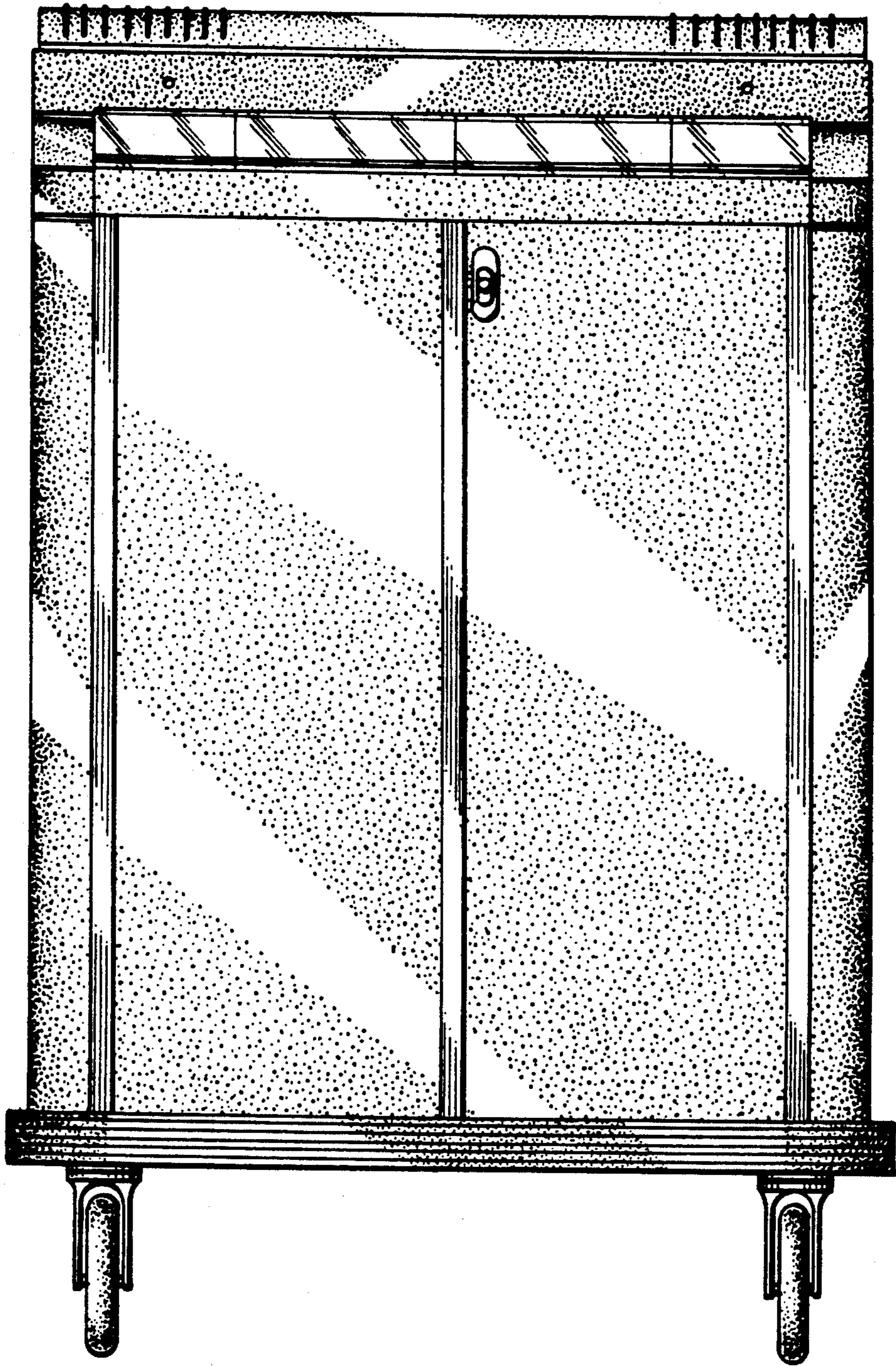

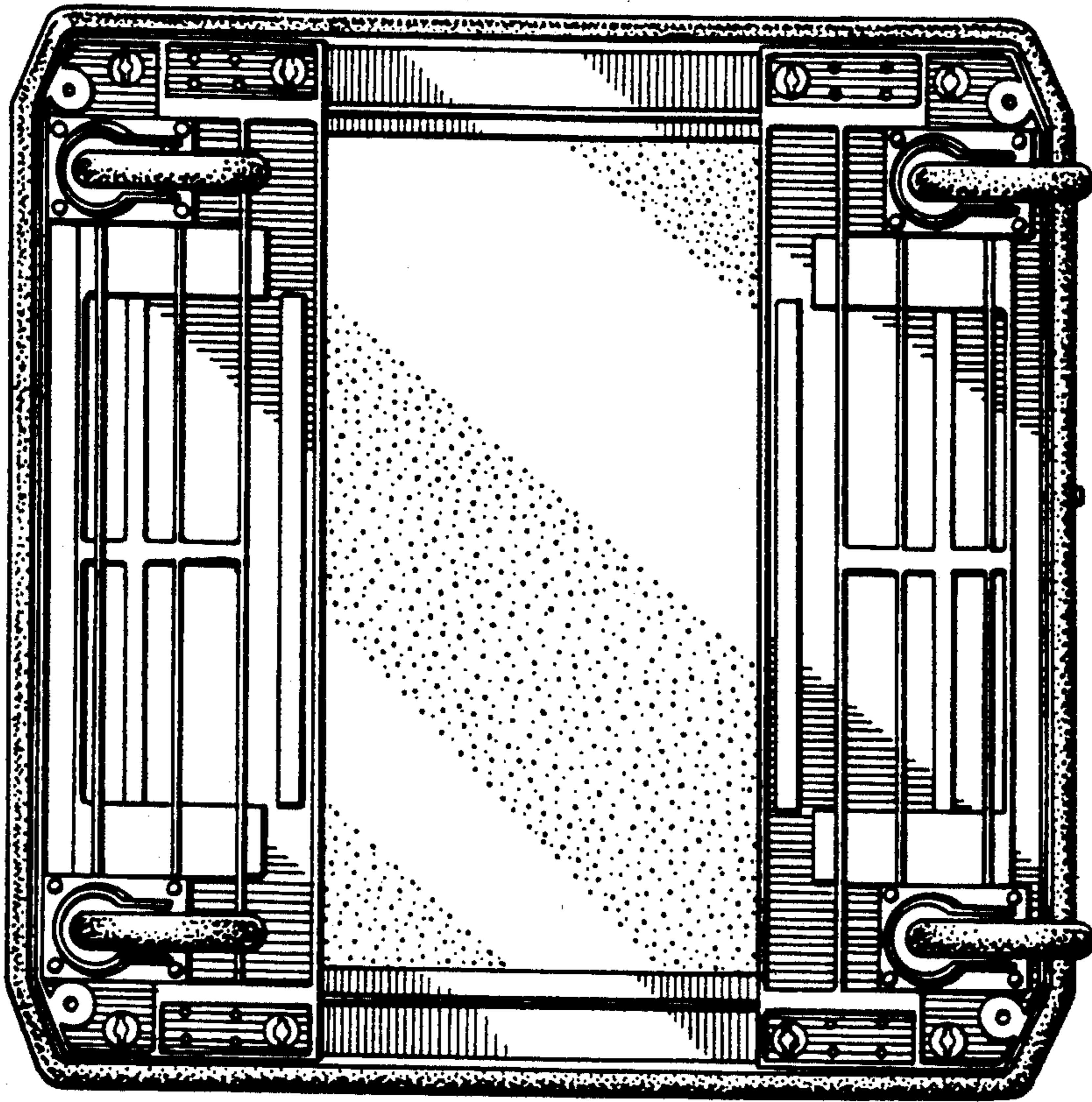

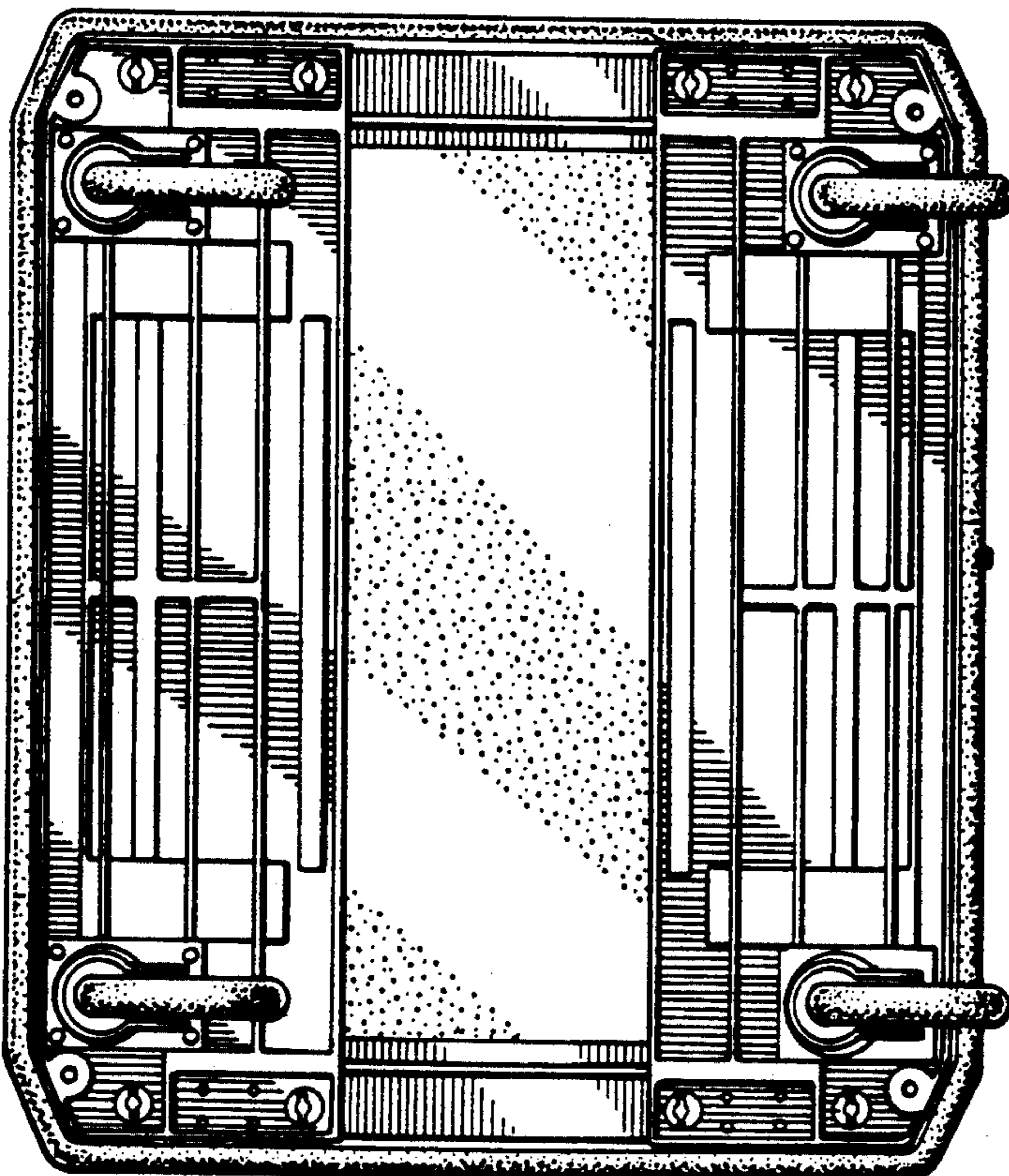

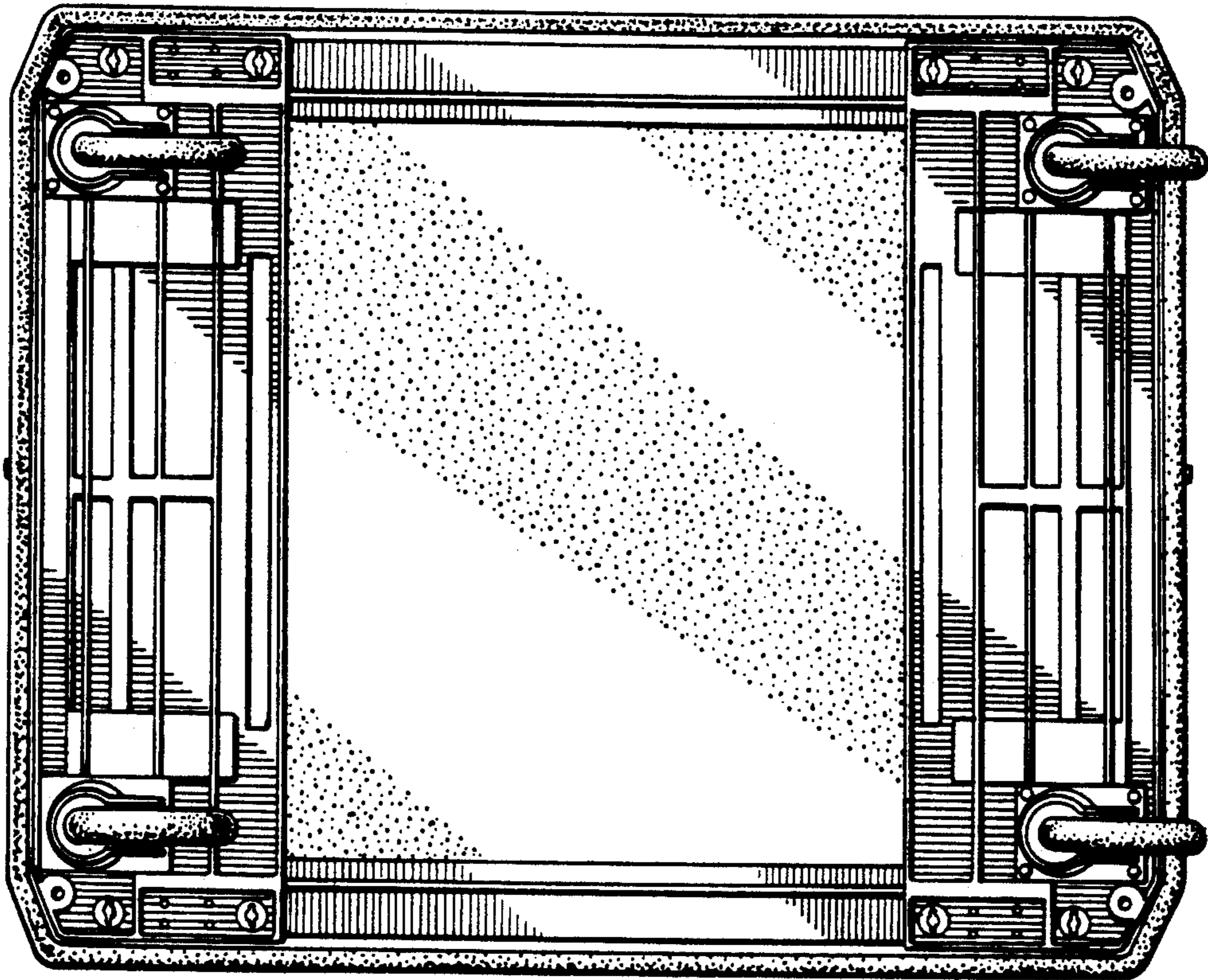

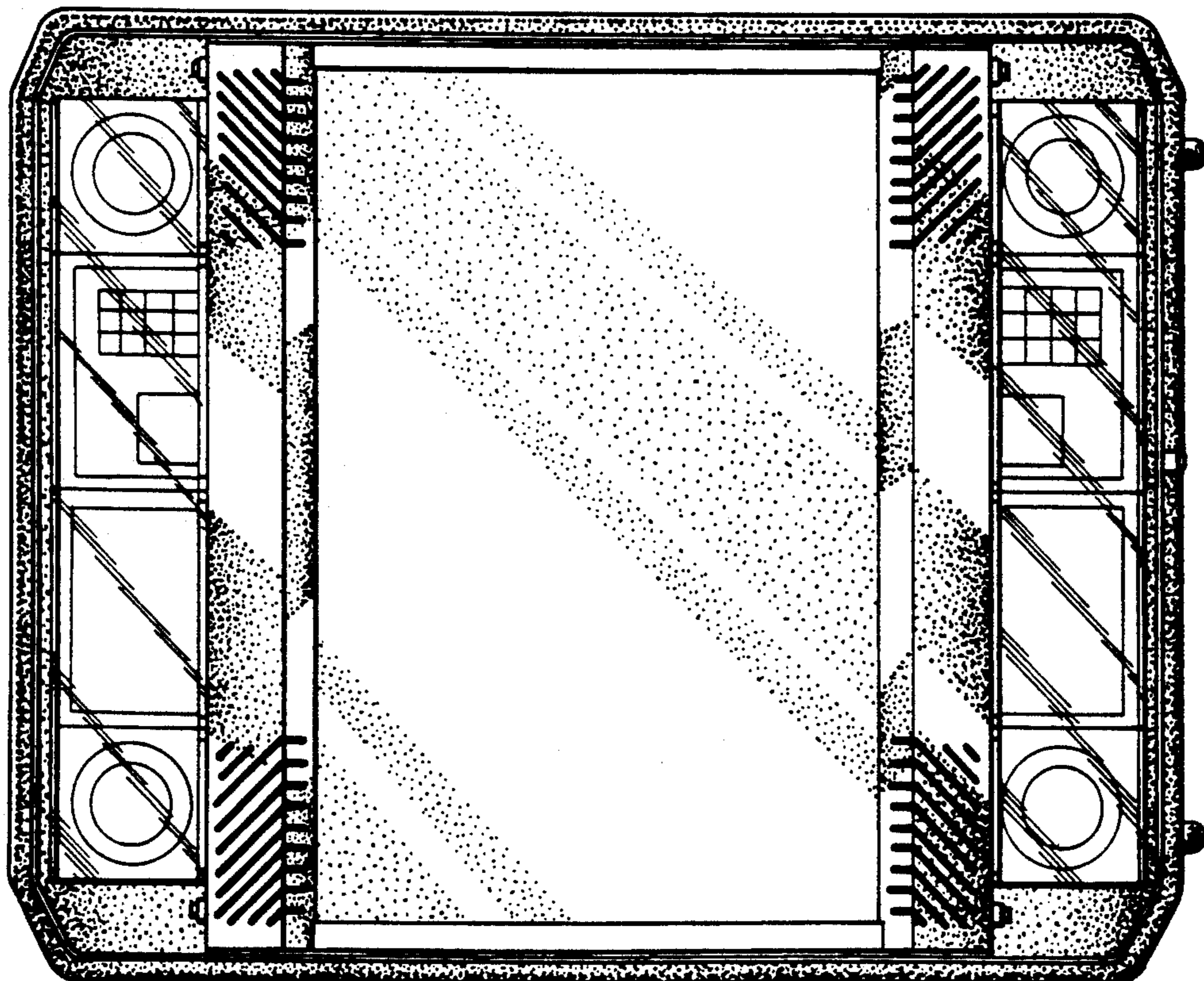
