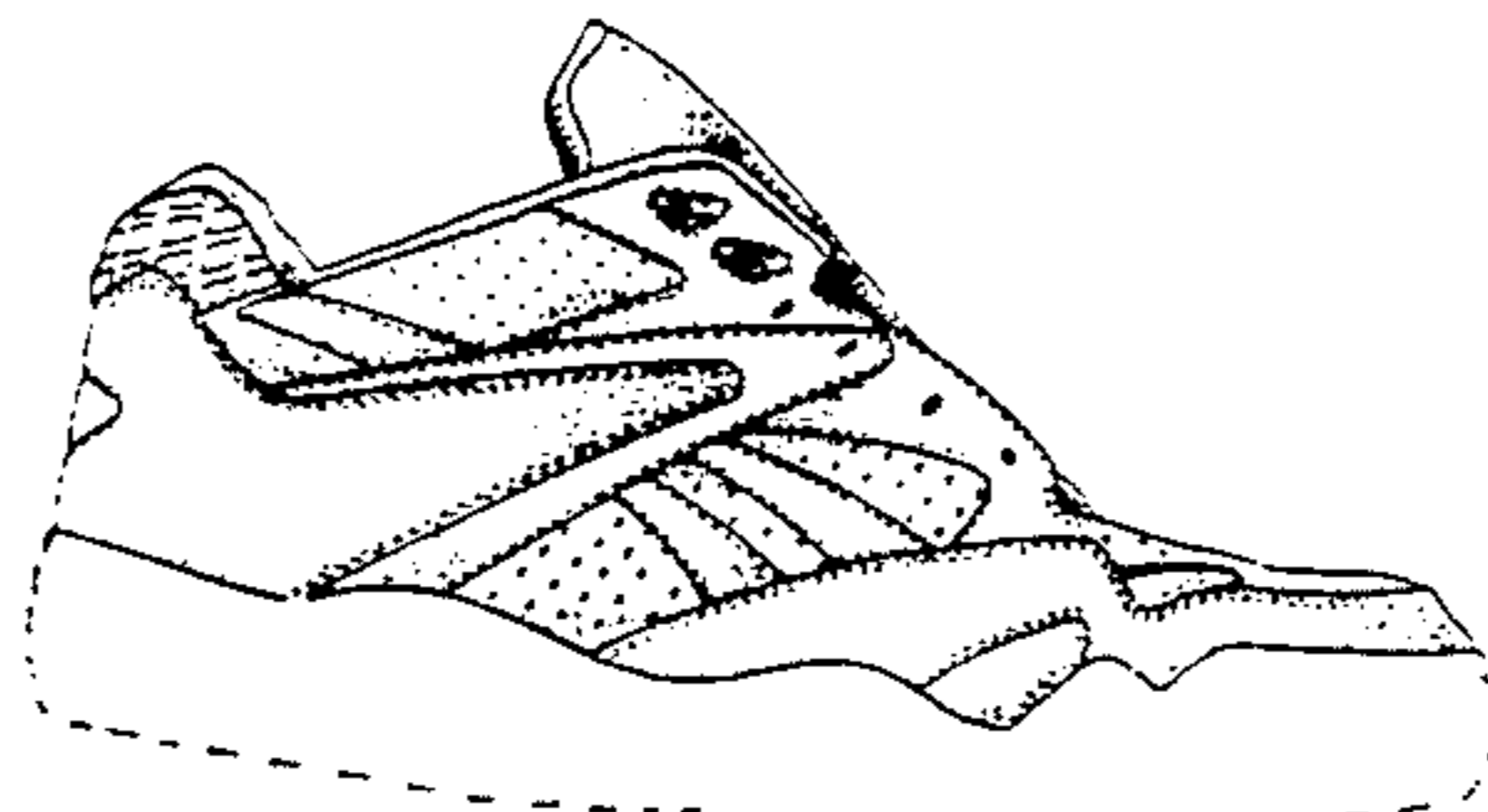
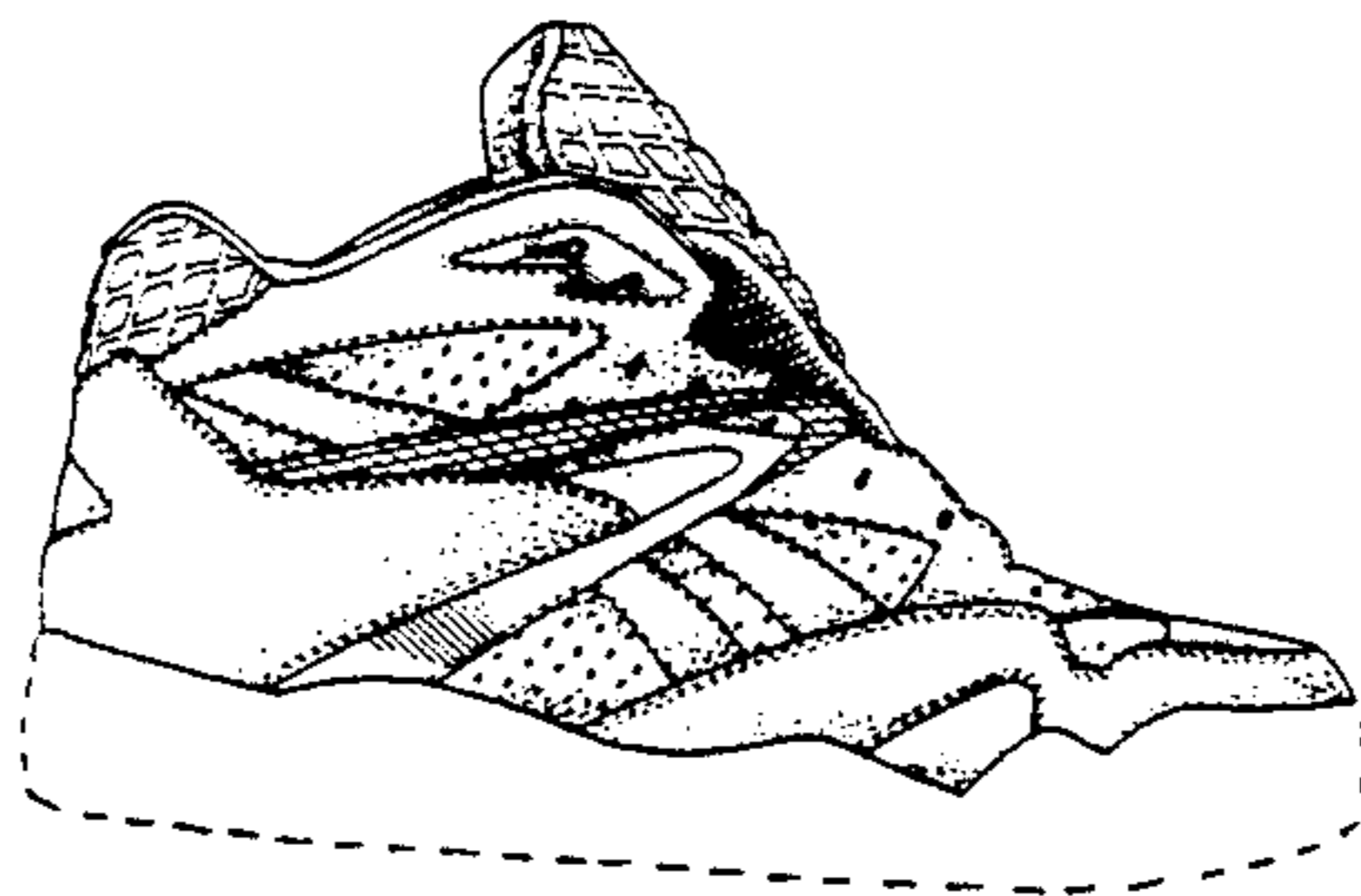
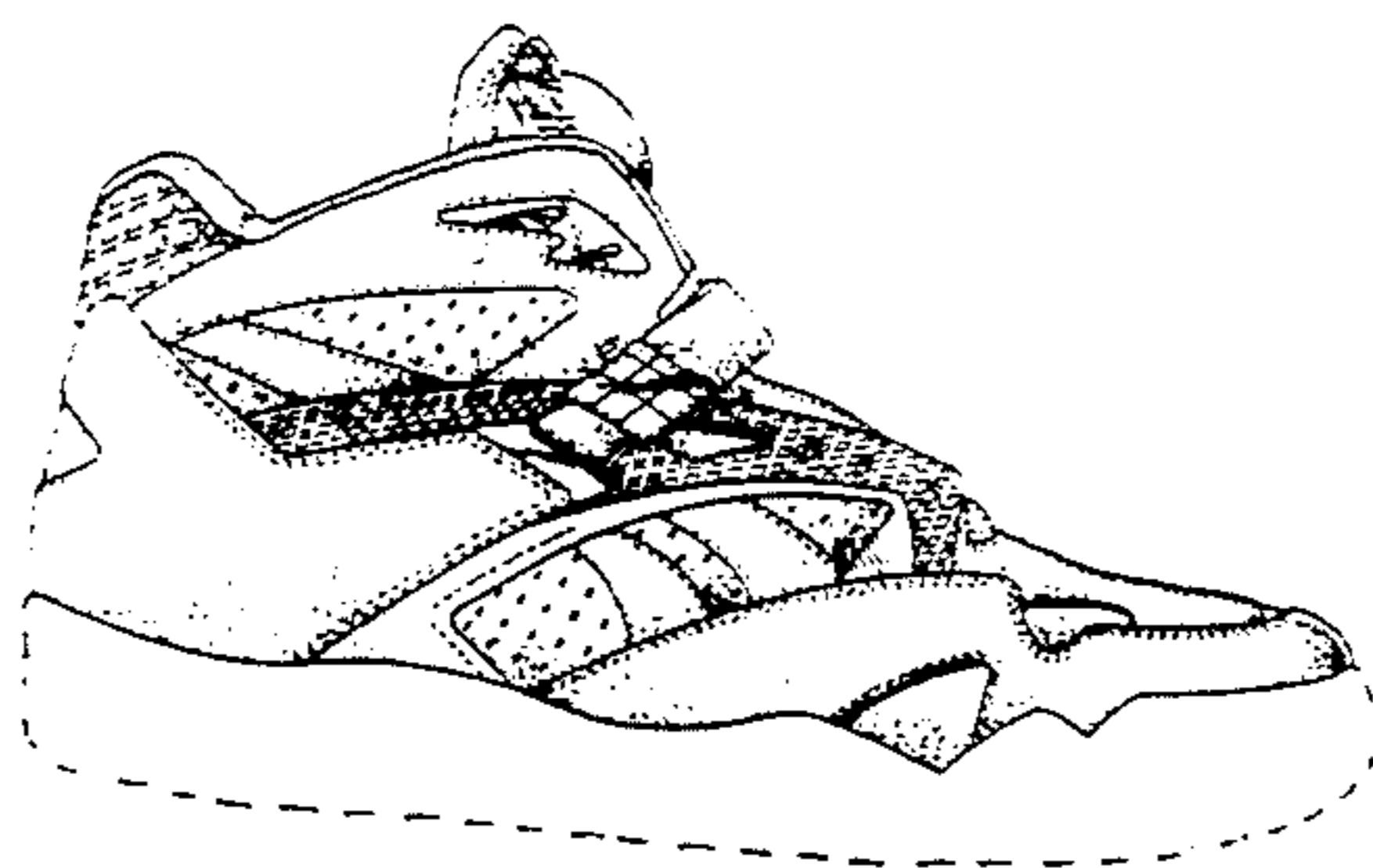
FIG. 1 is a left side elevational view of a shoe upper showing our new design;

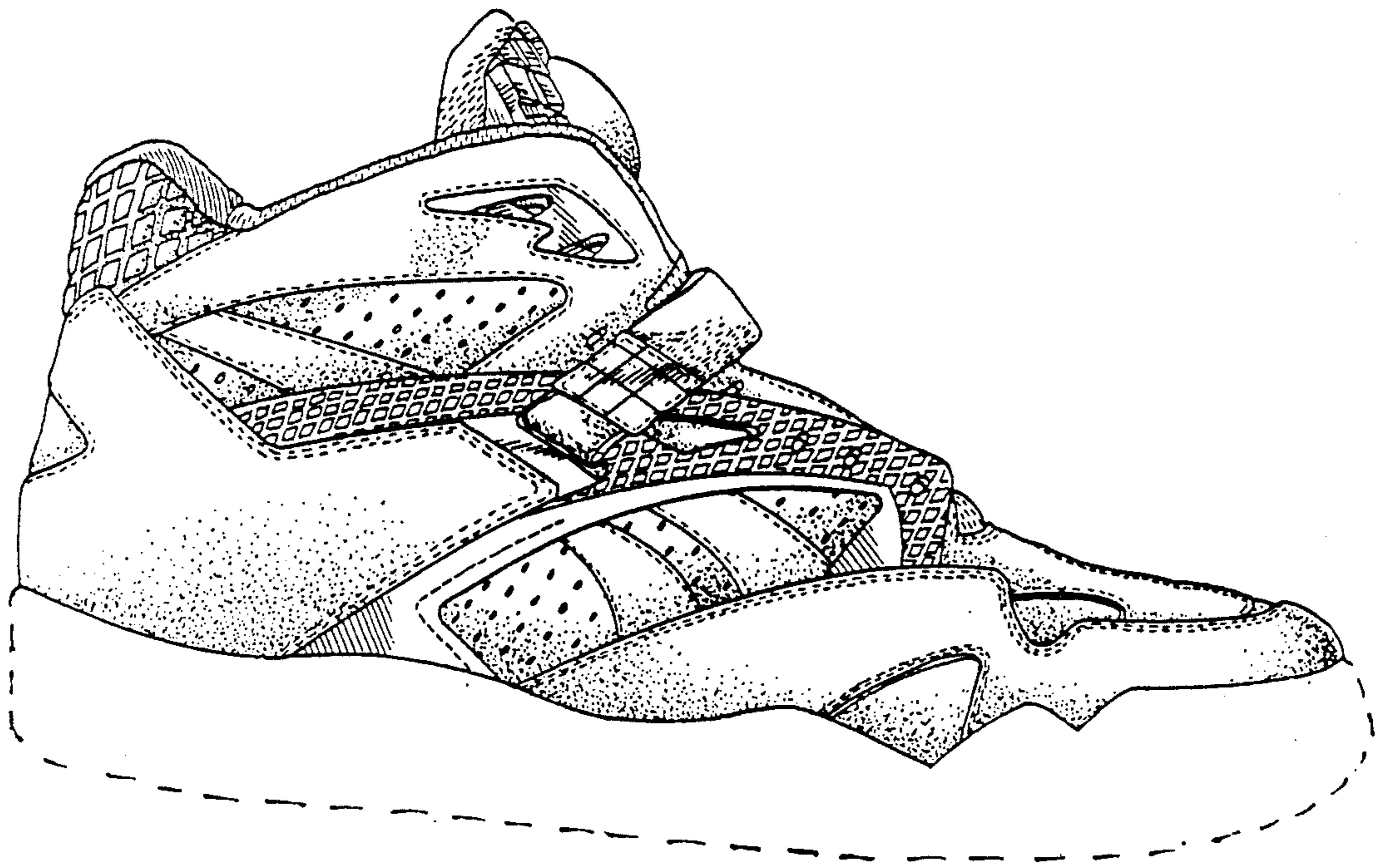

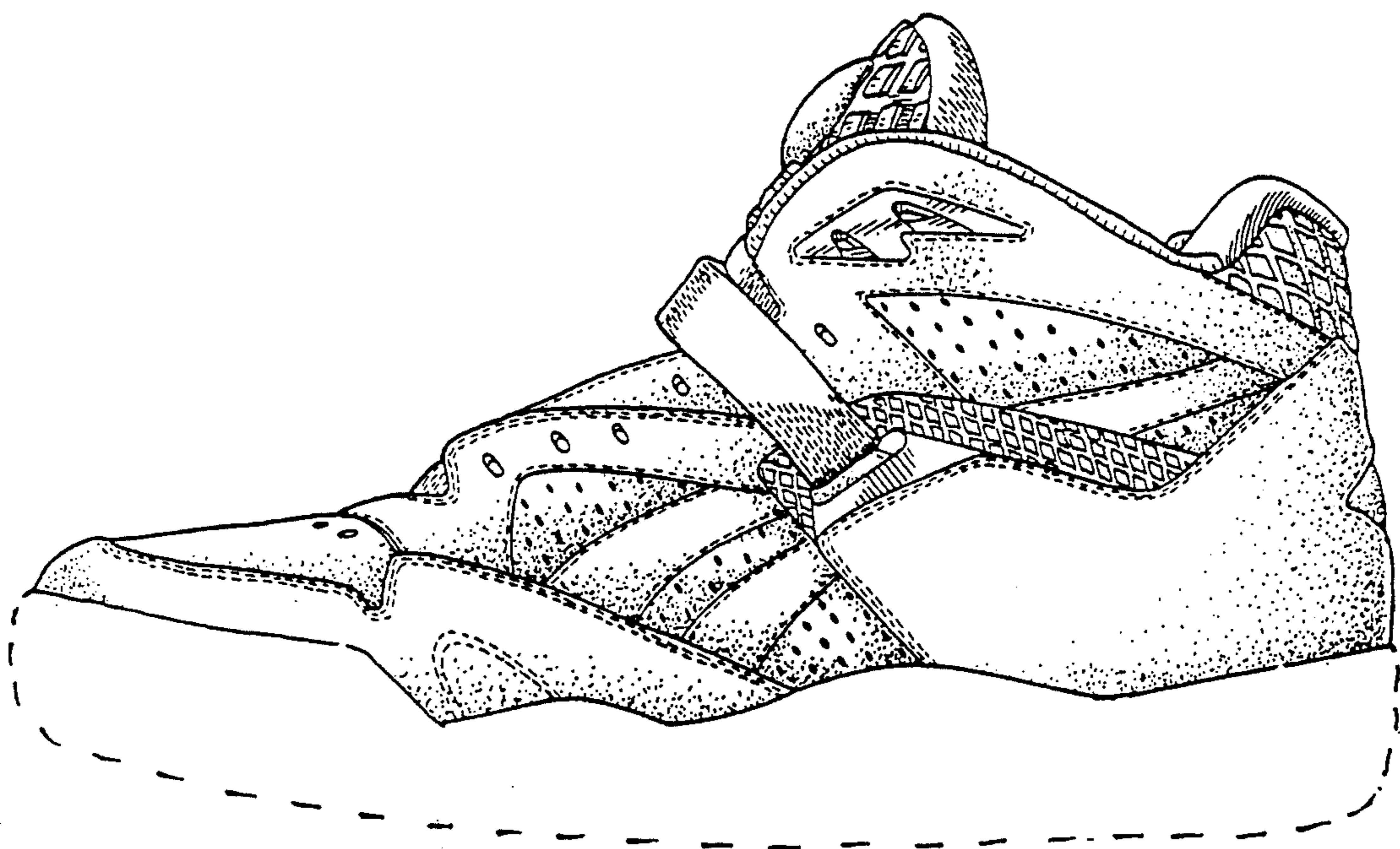

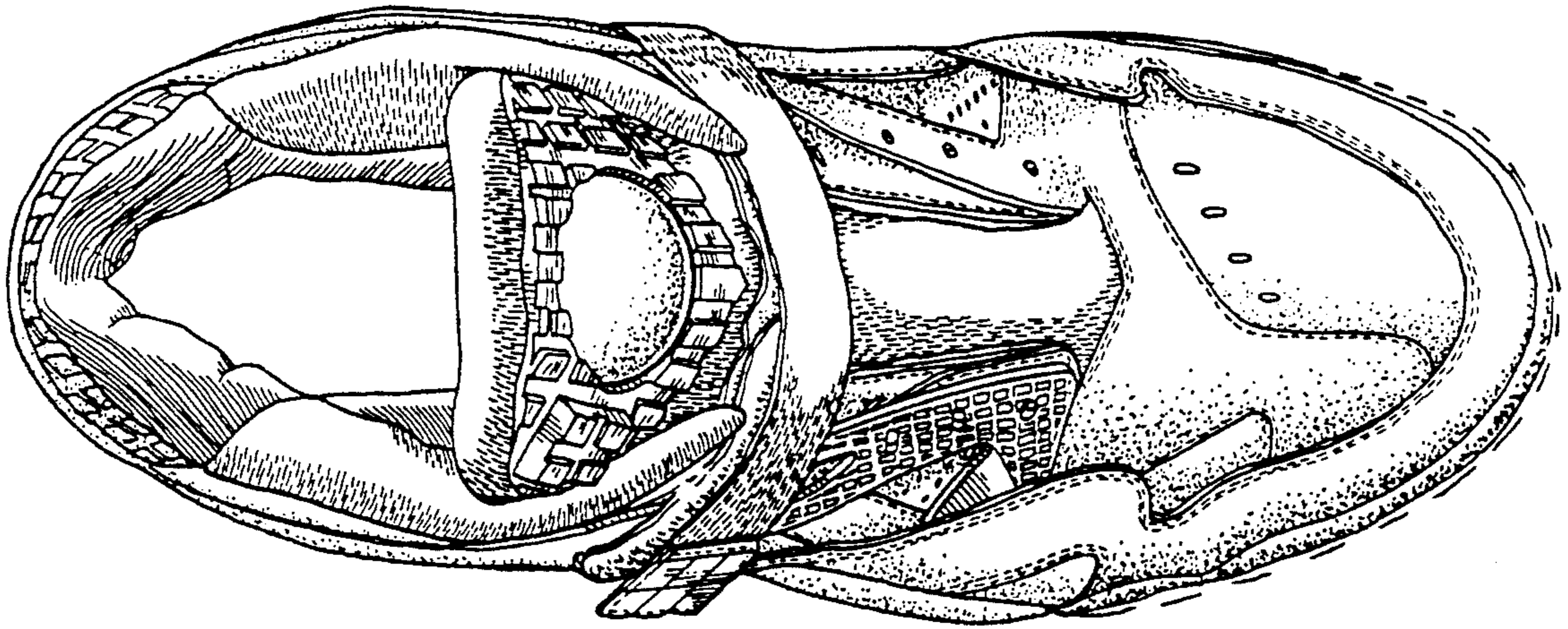

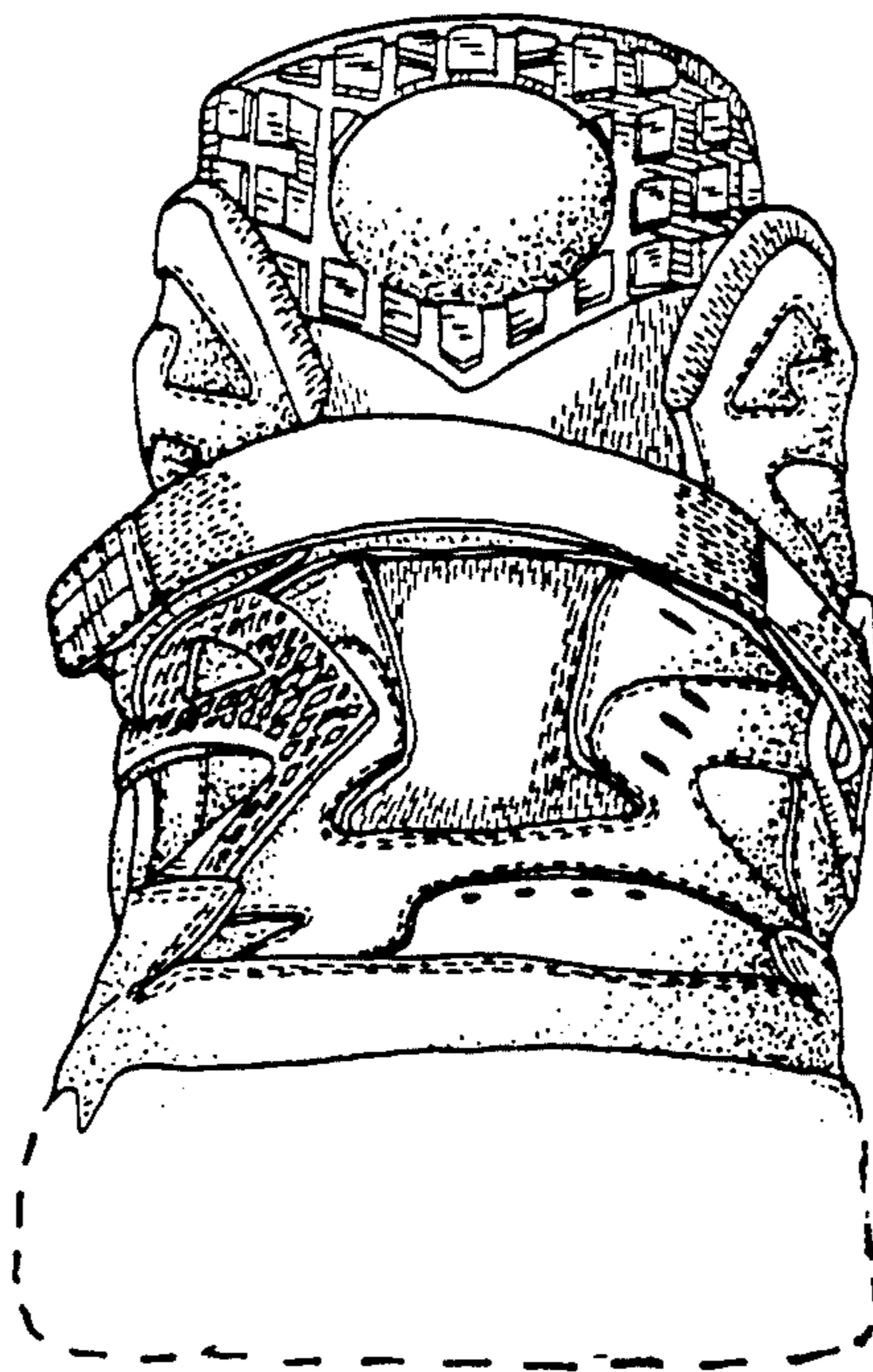

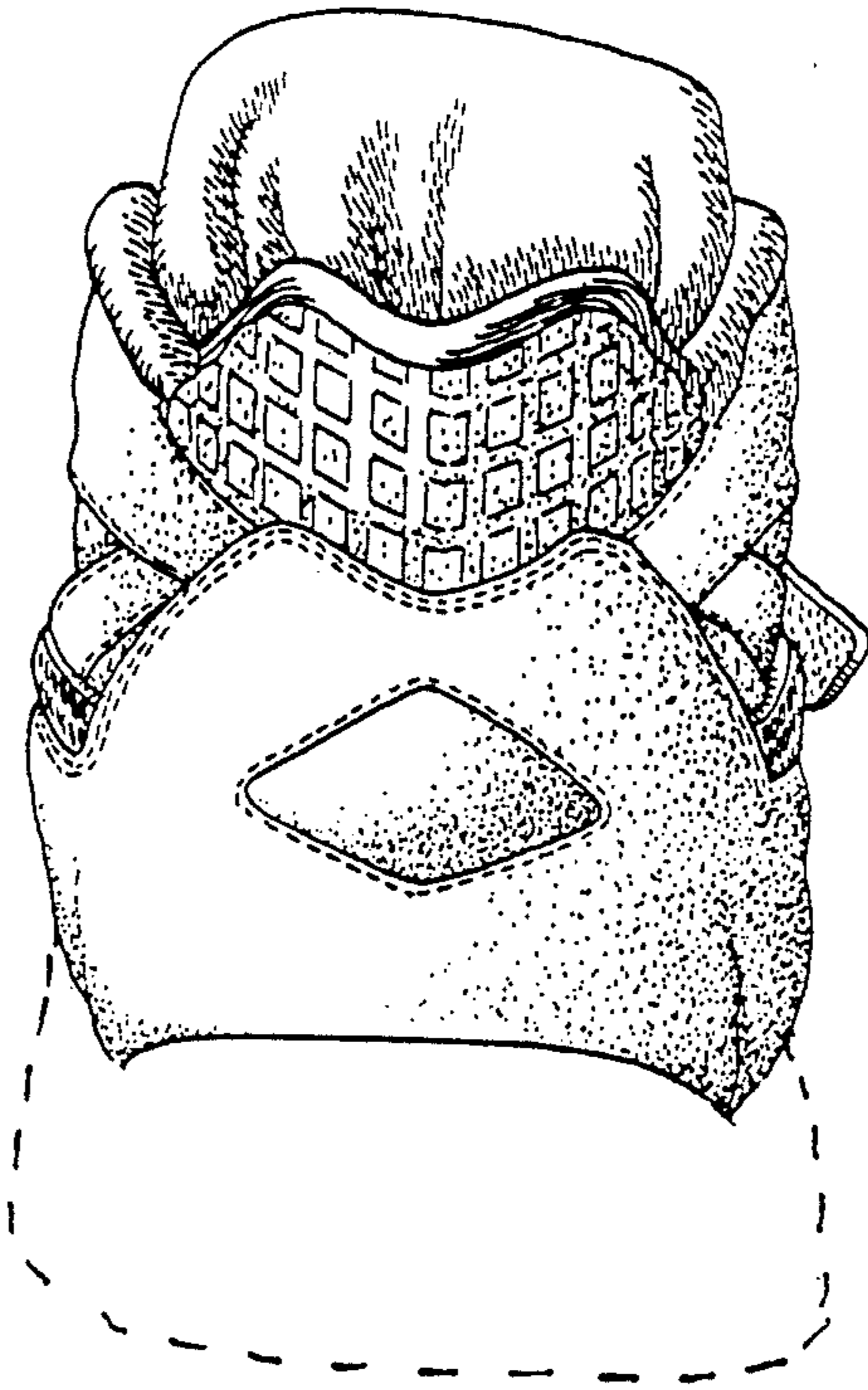

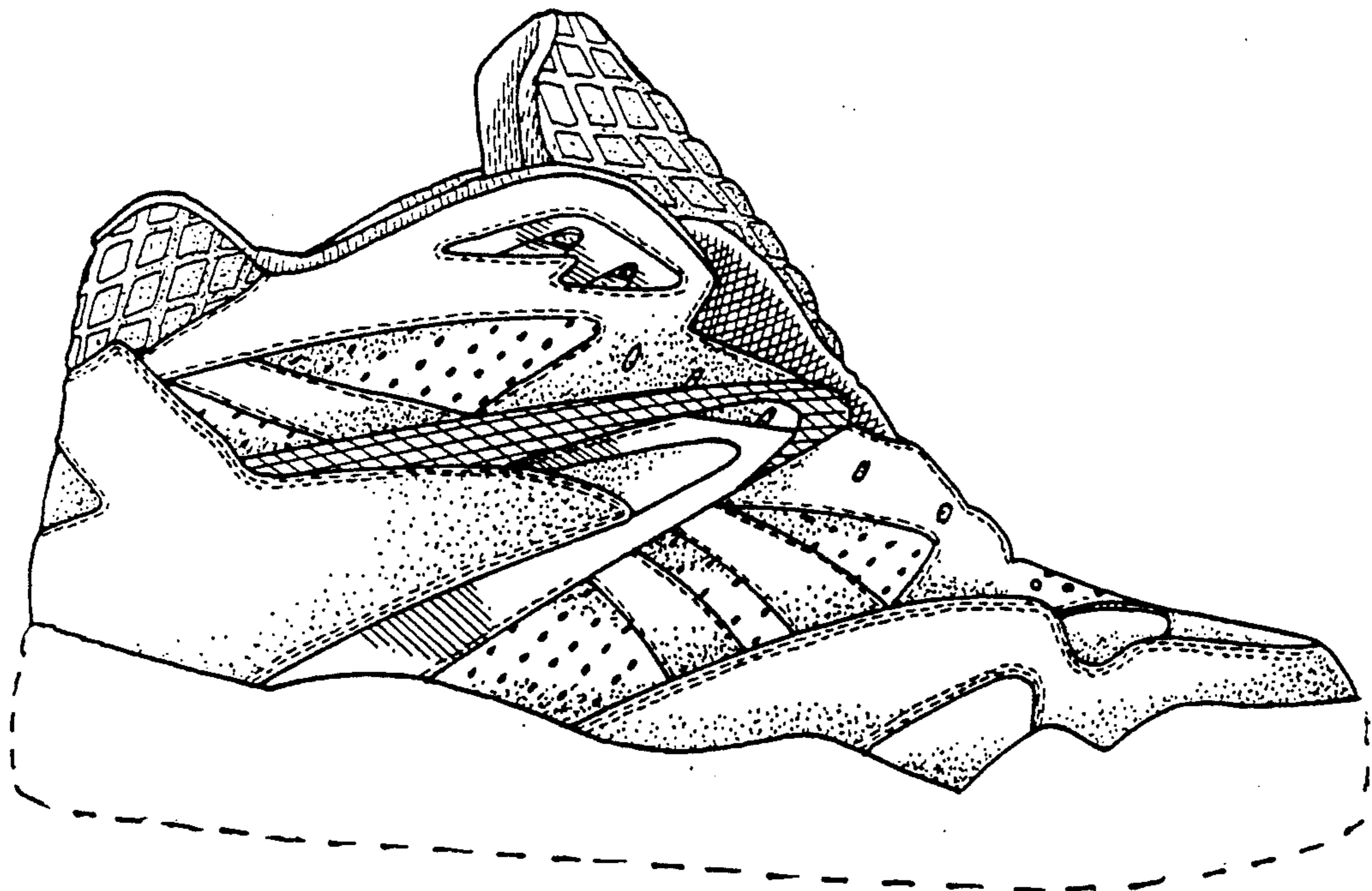

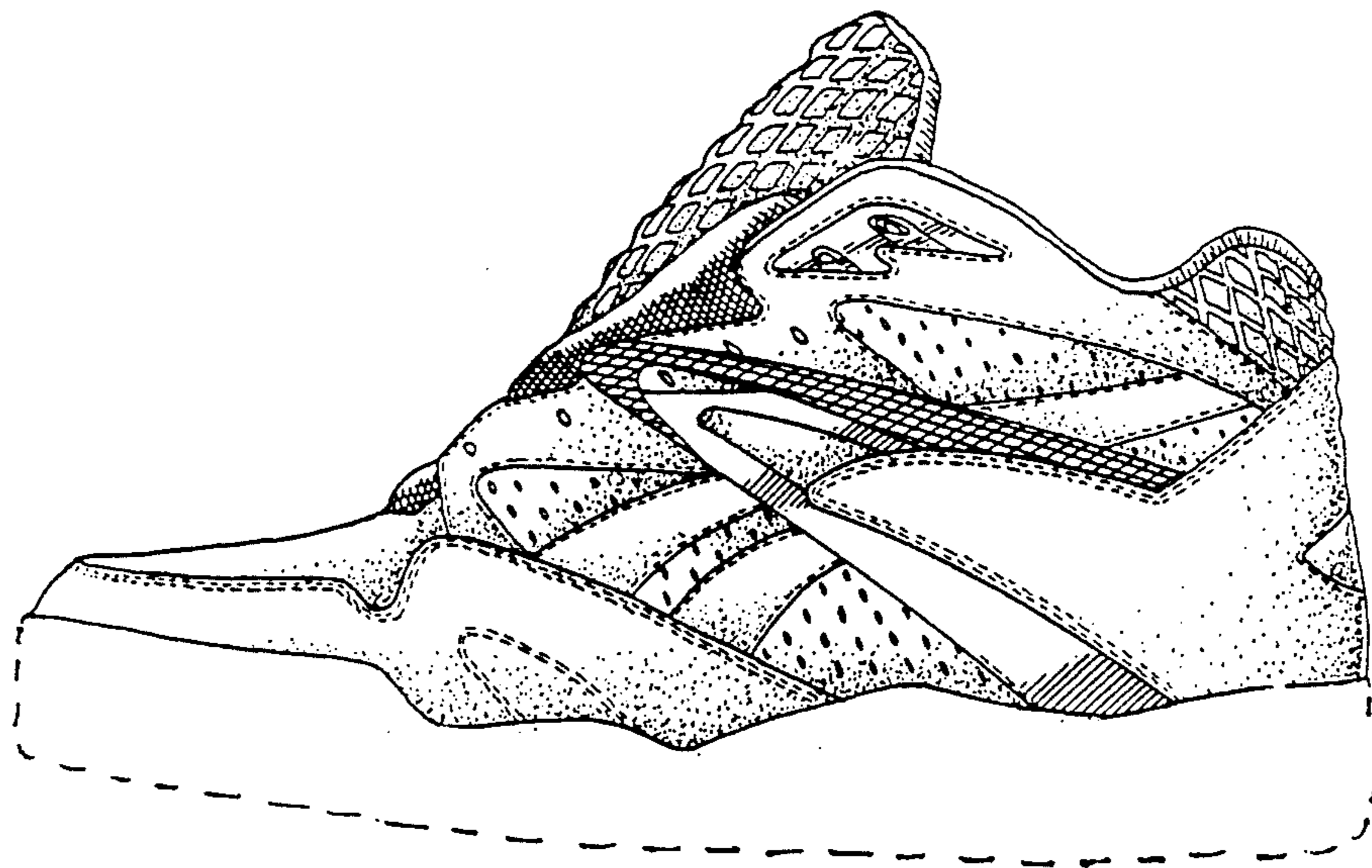

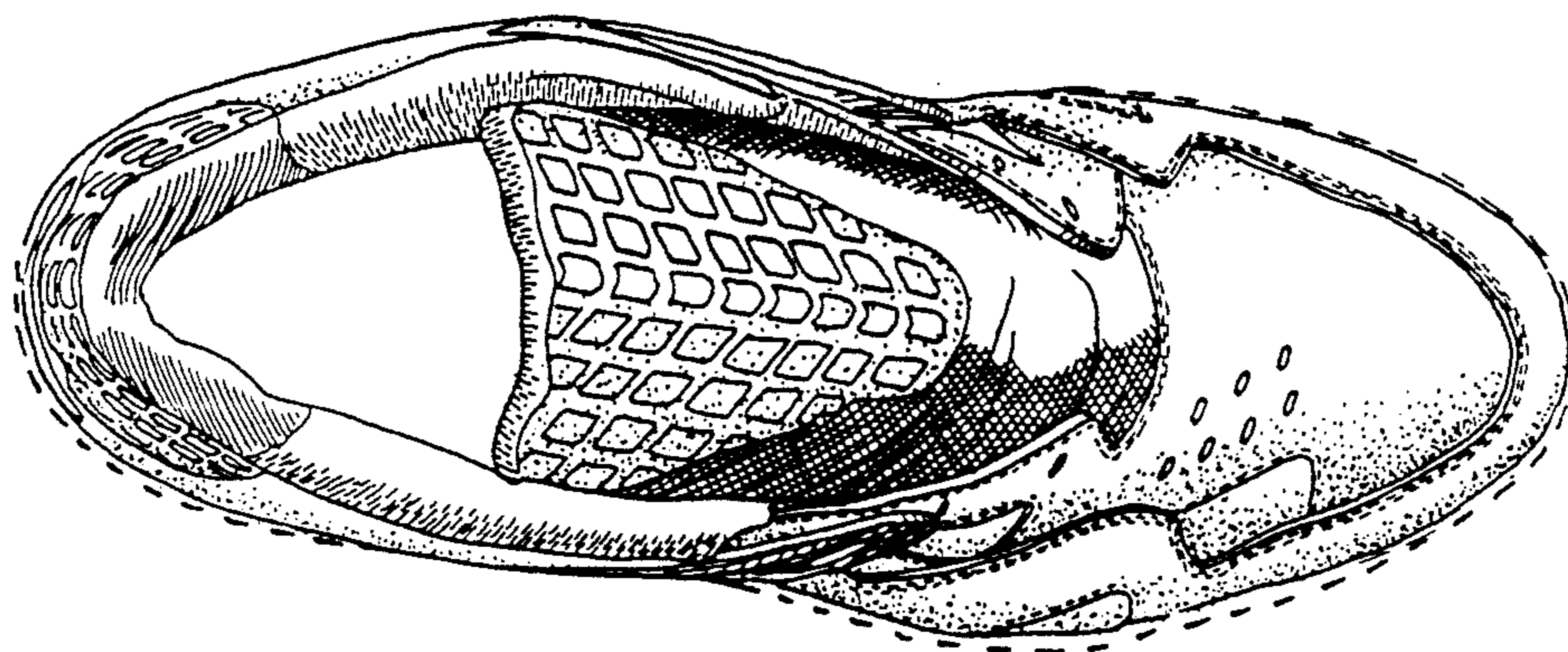

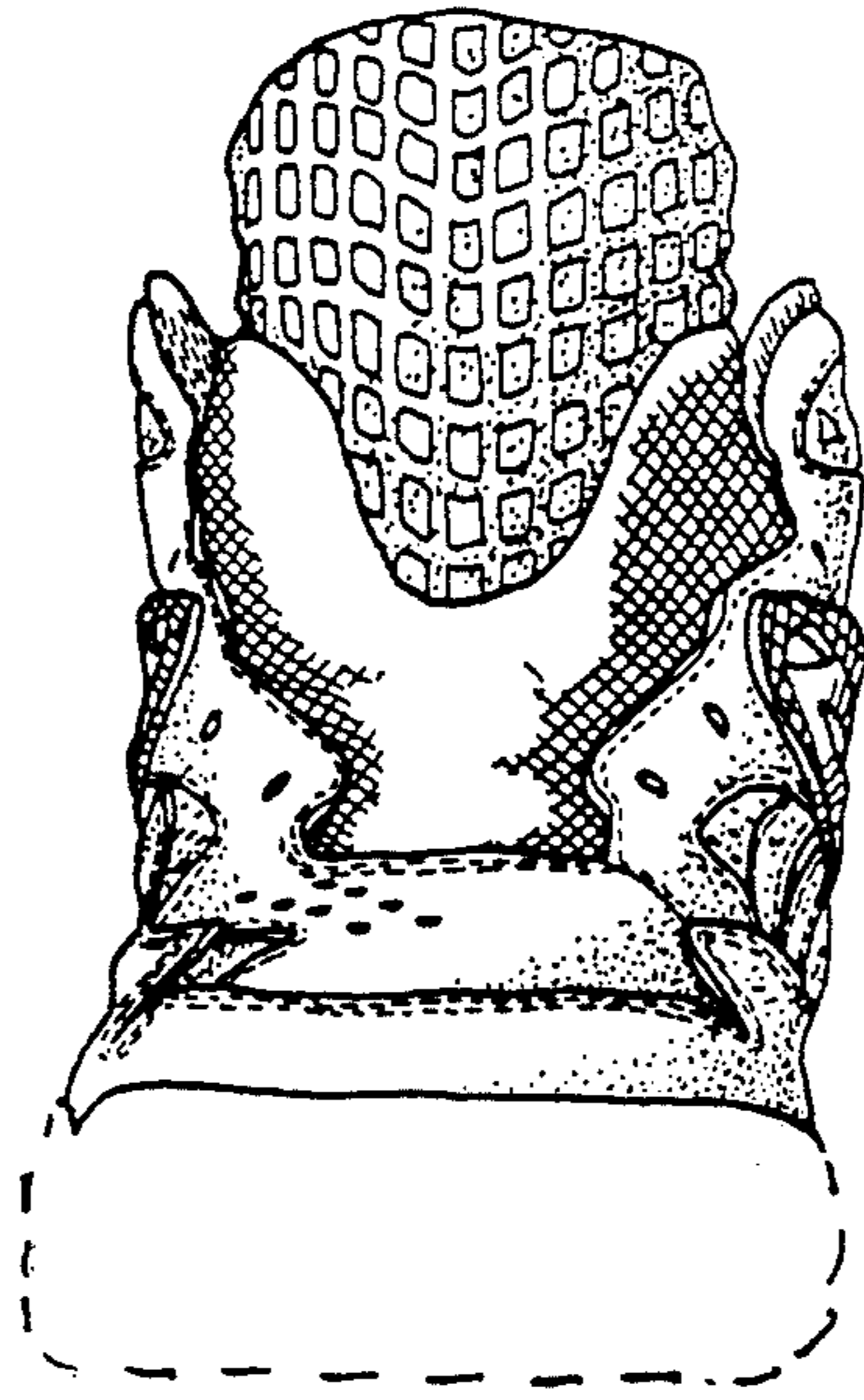

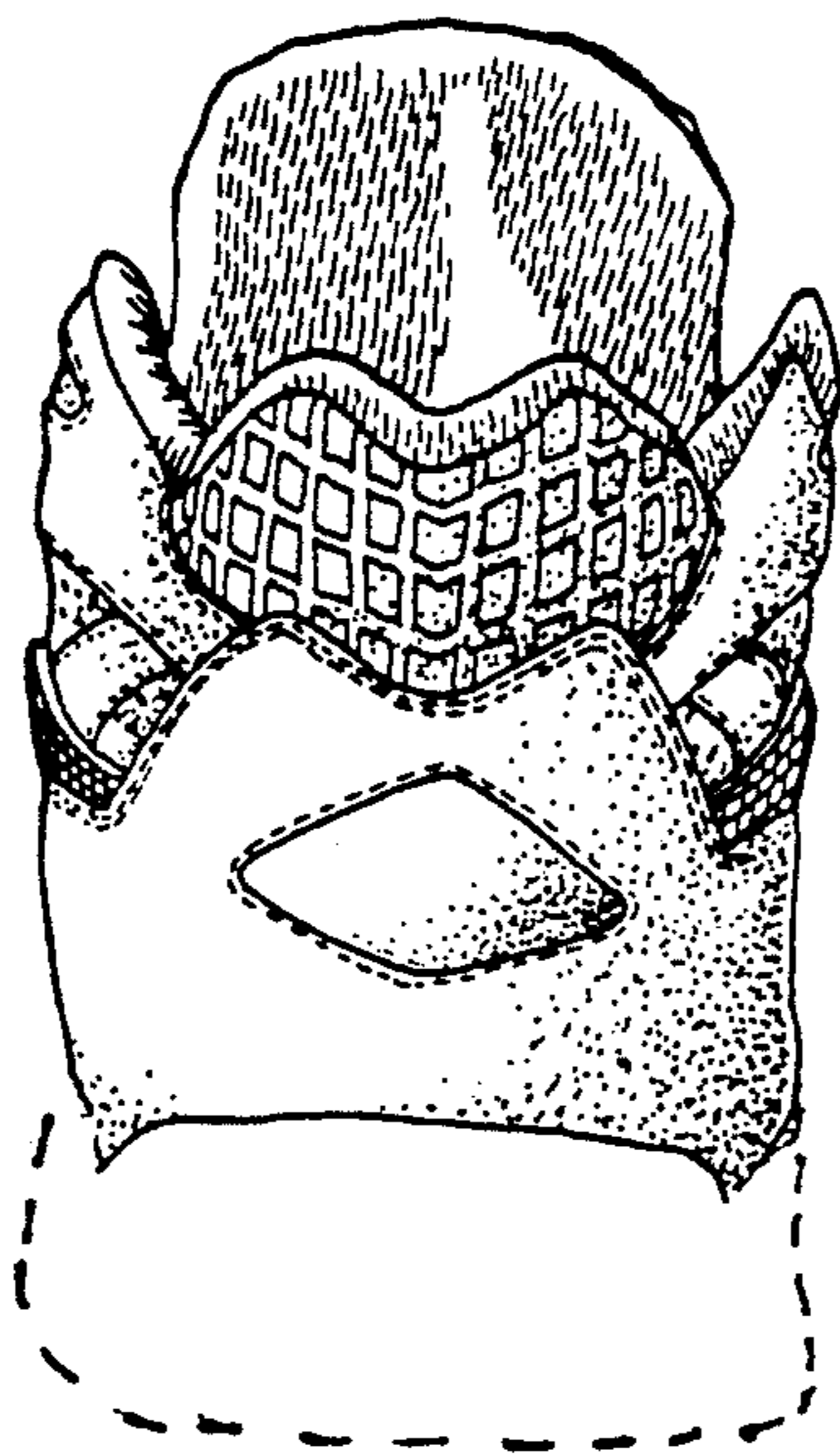

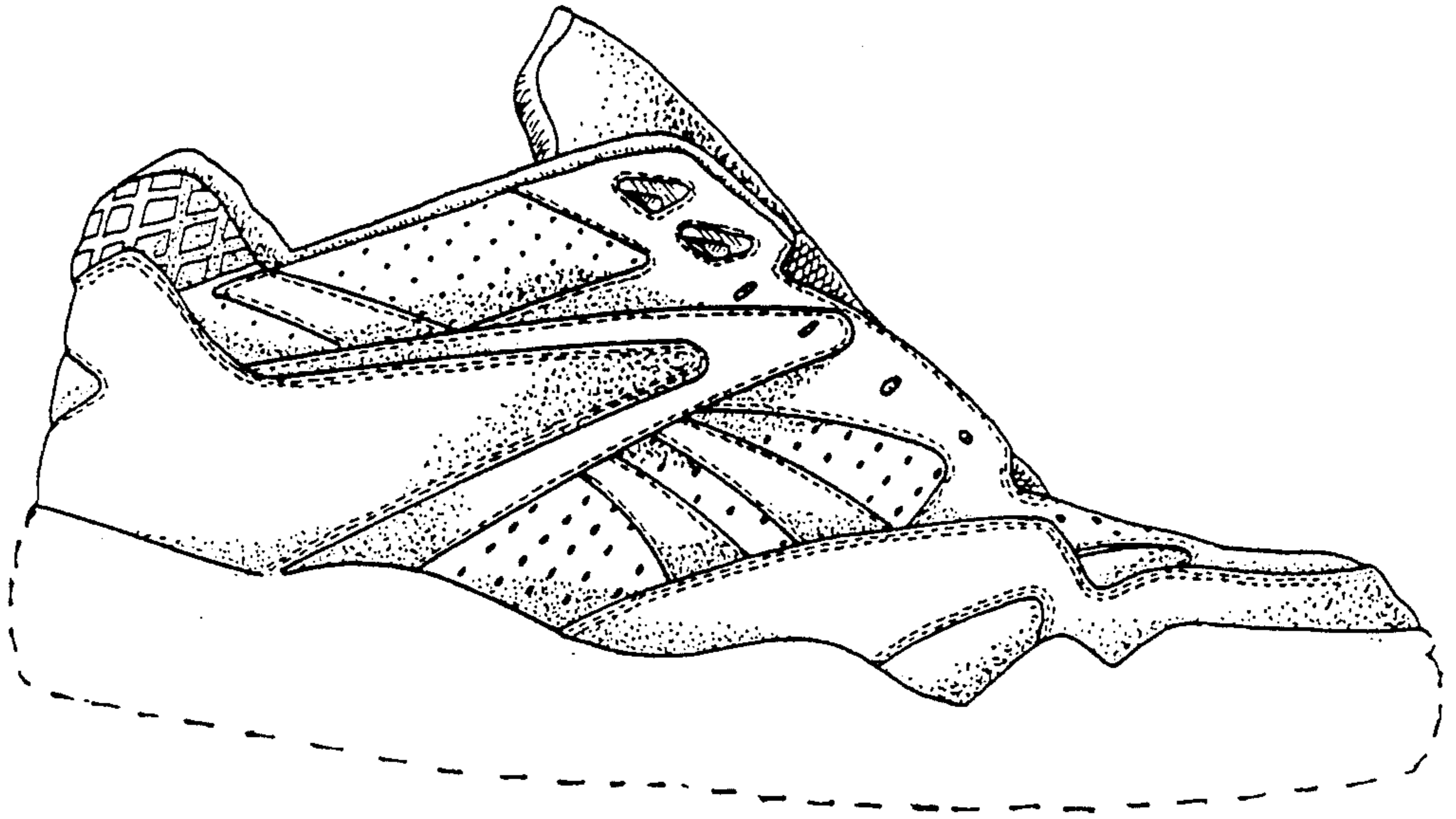

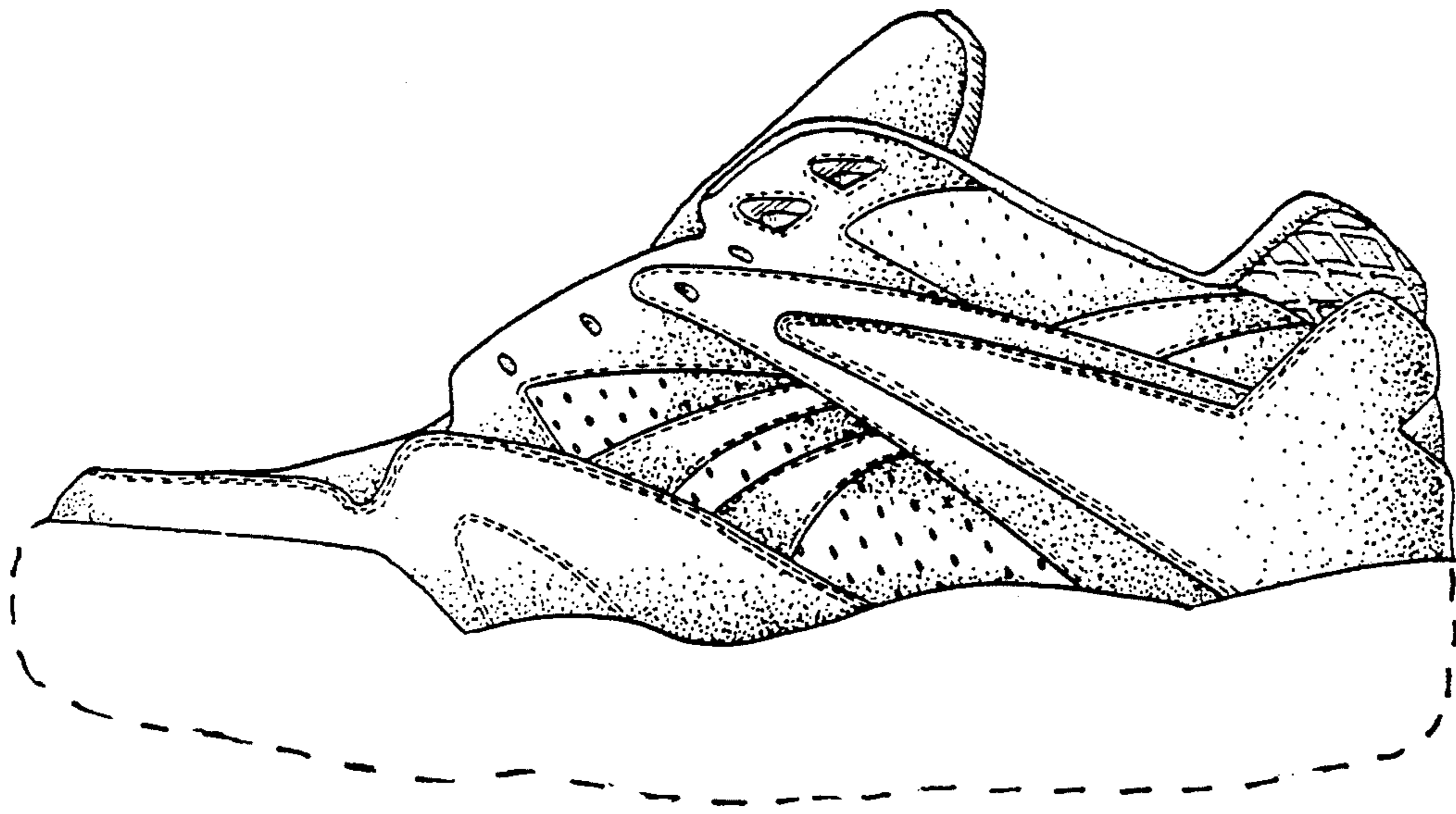

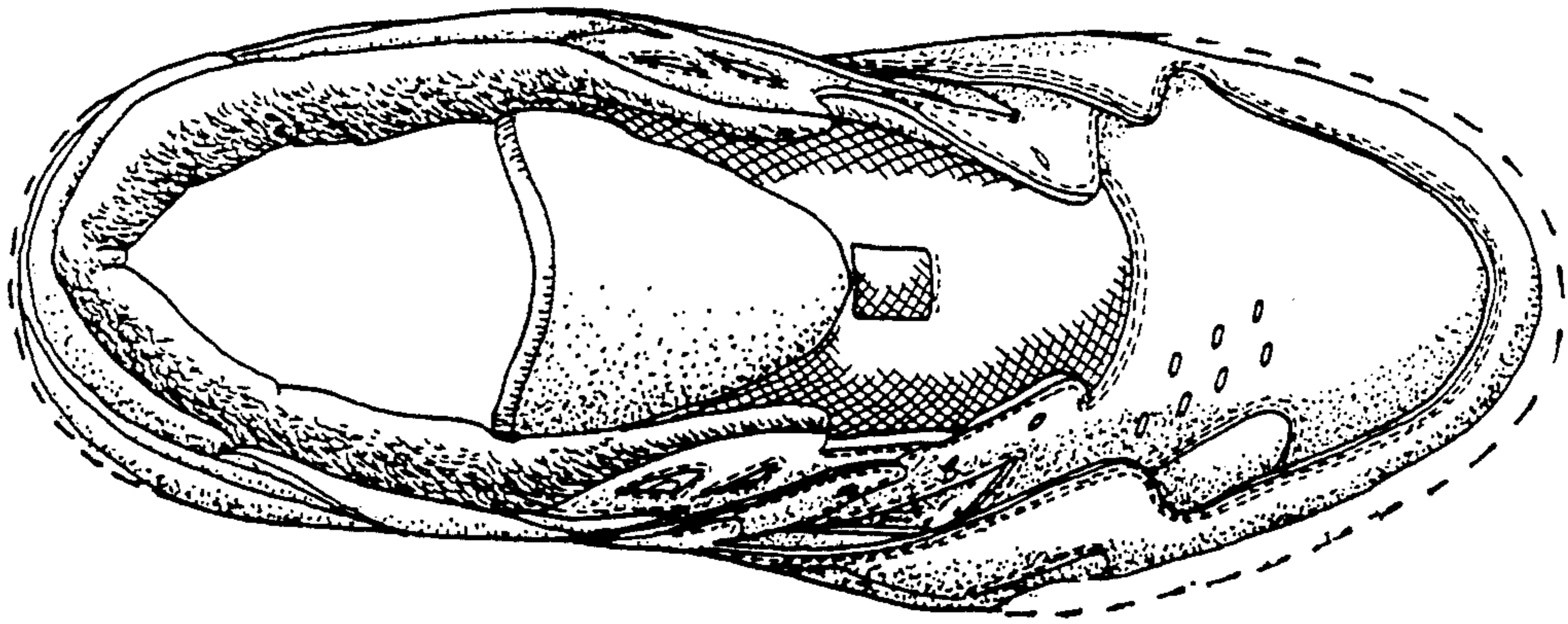

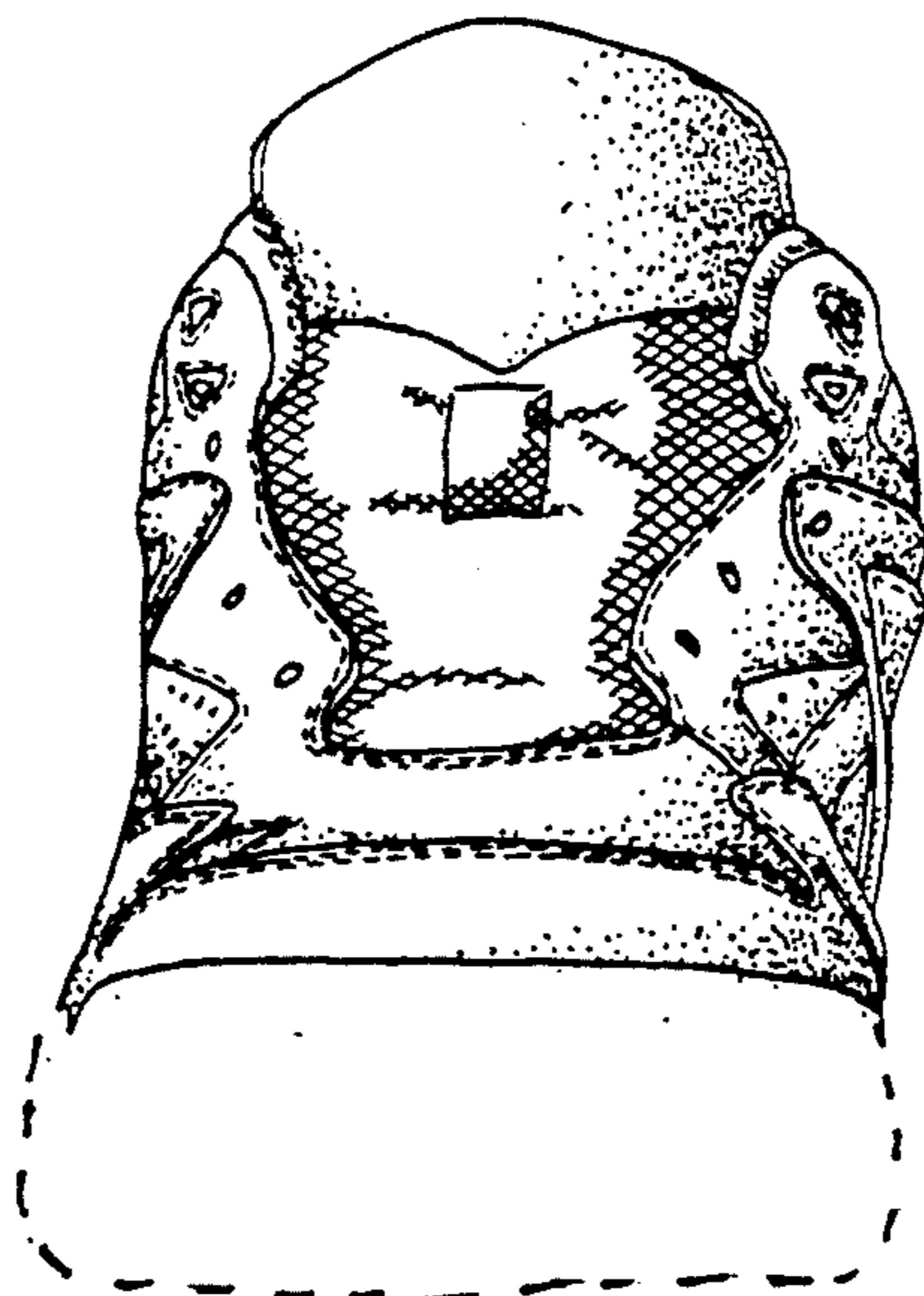

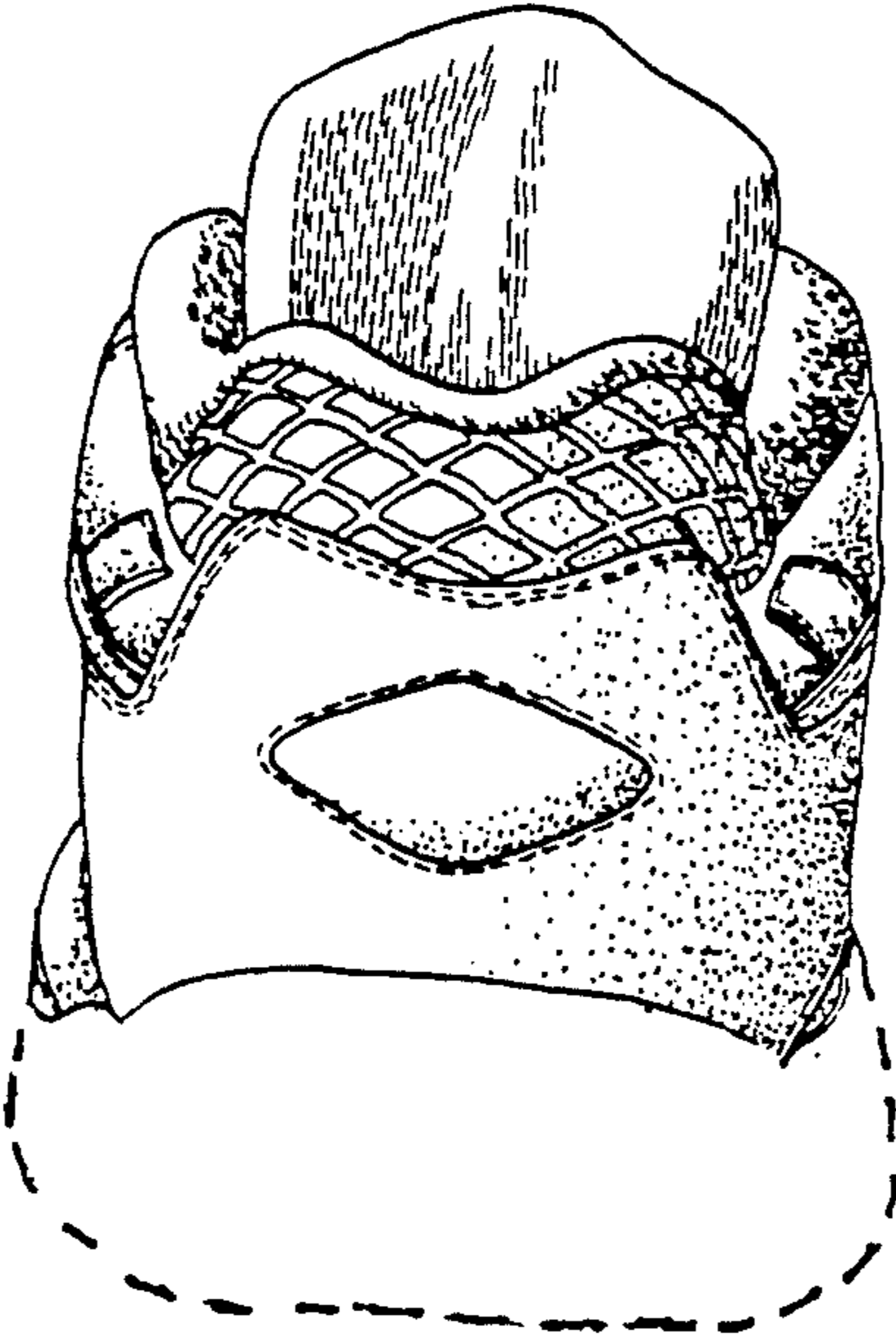
