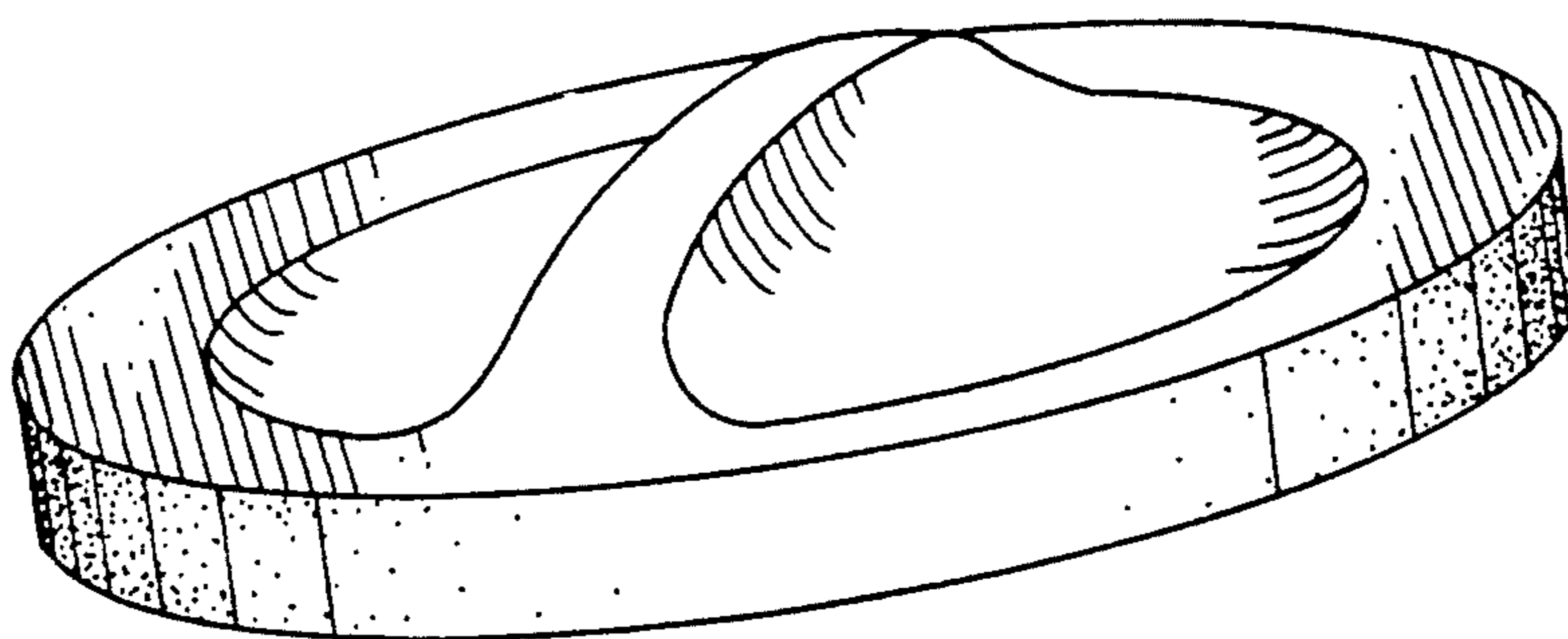

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a canister plug showing my design;

FIG. 5 is a top plan view thereof.



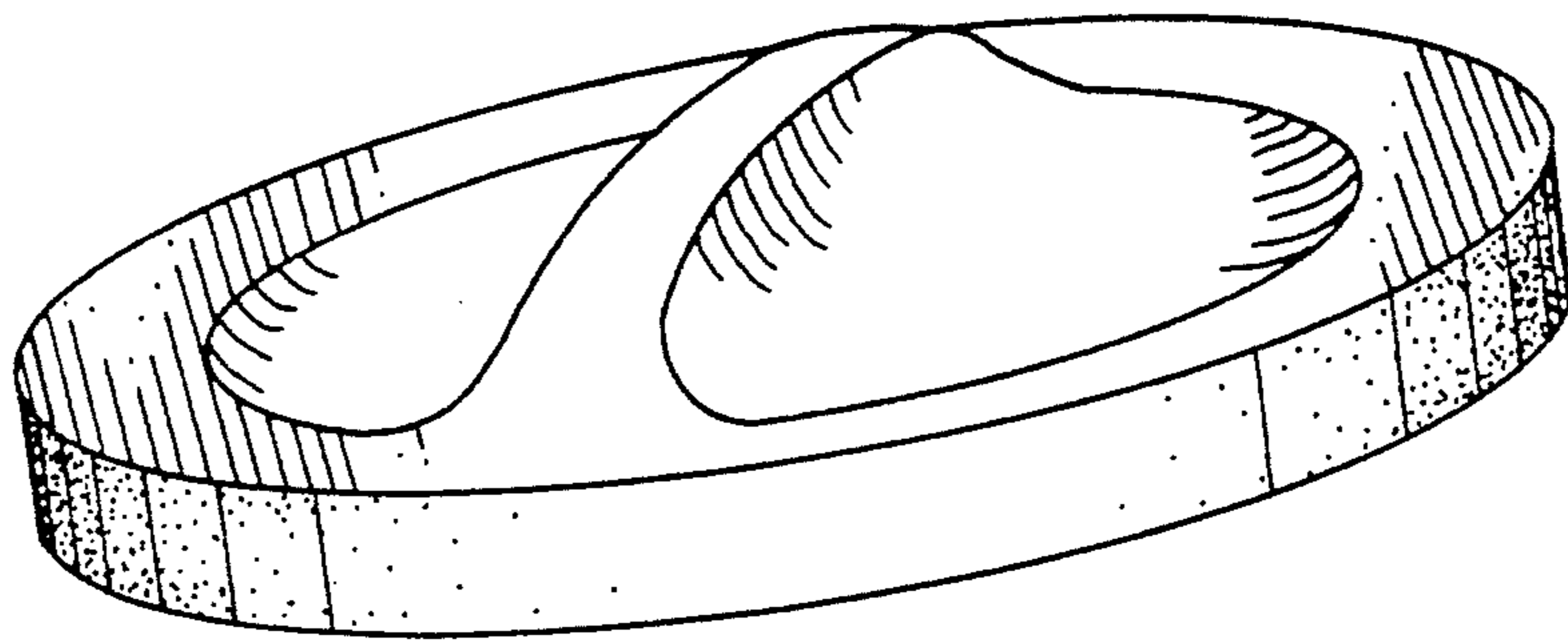

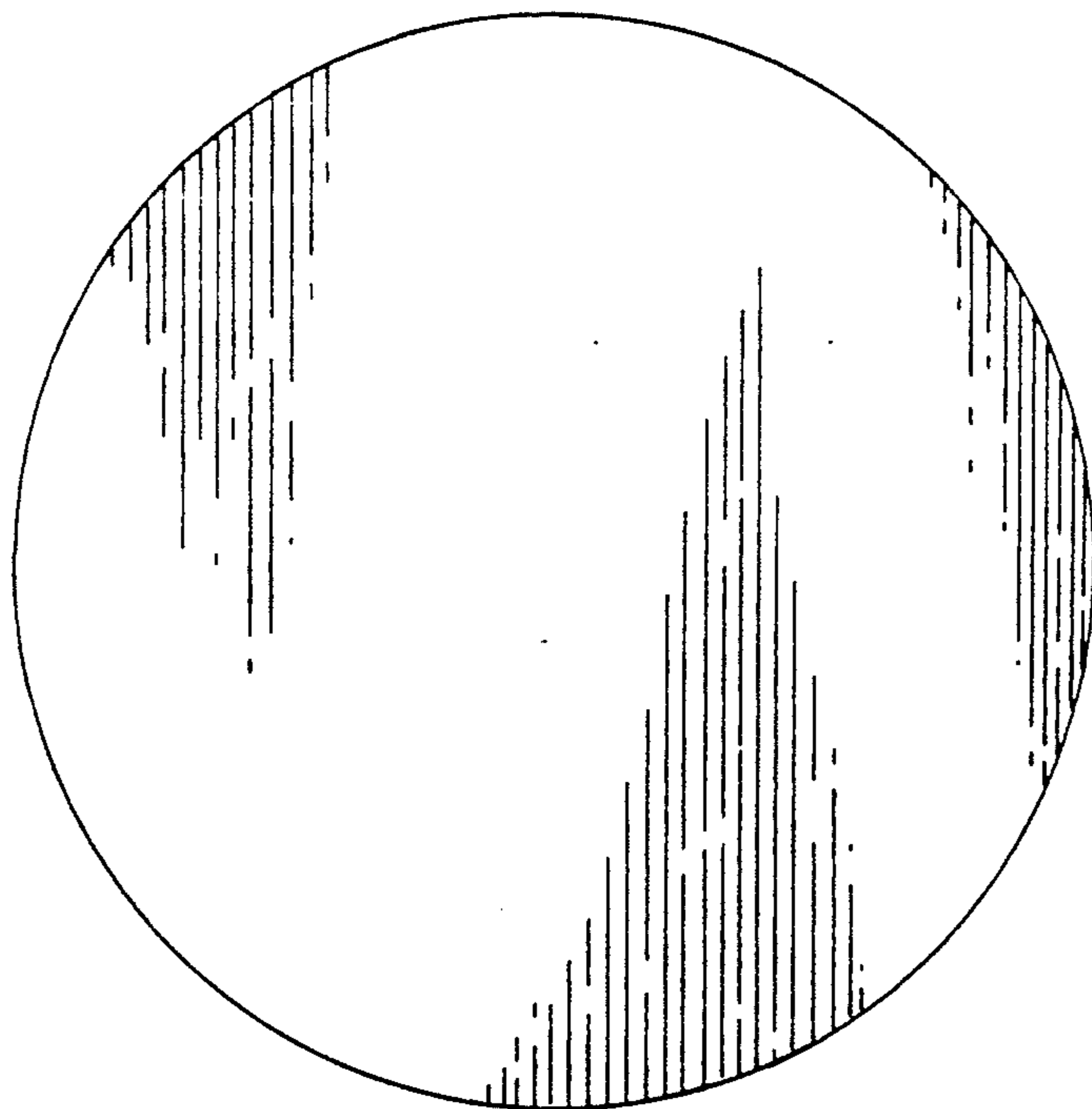

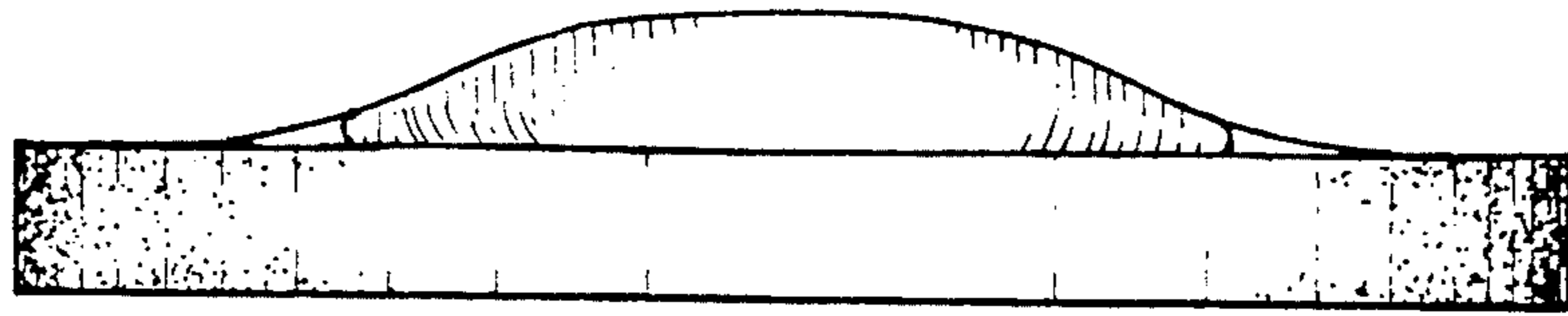

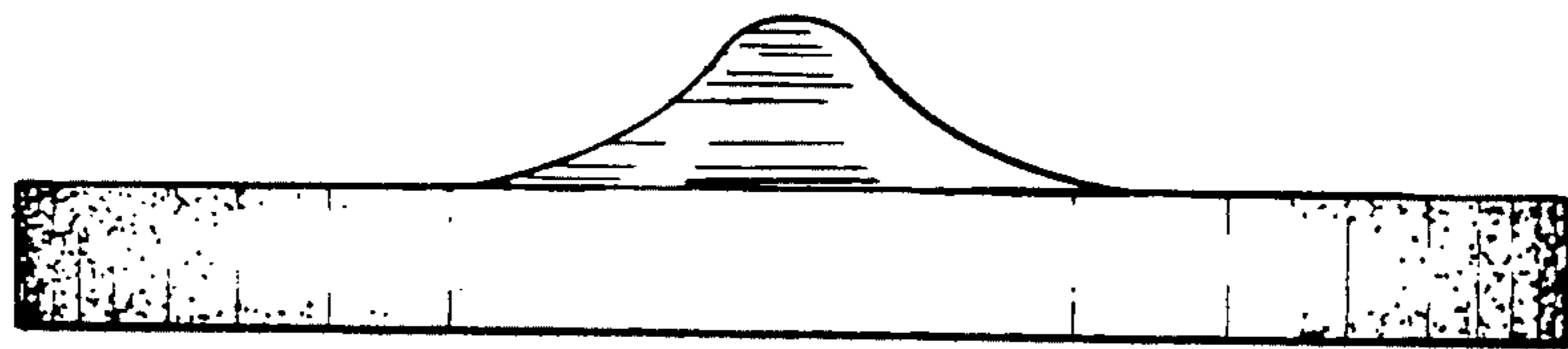

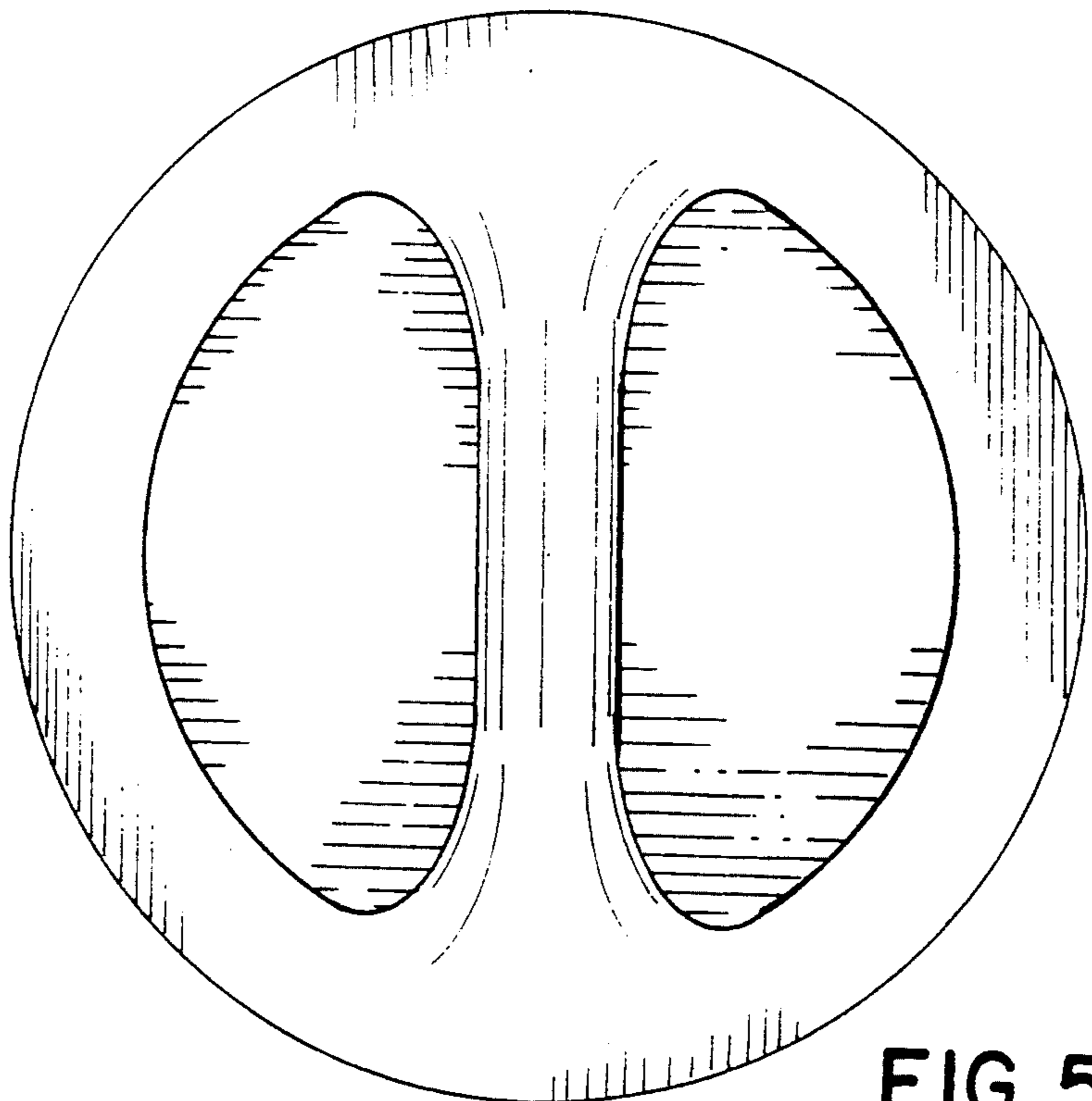
