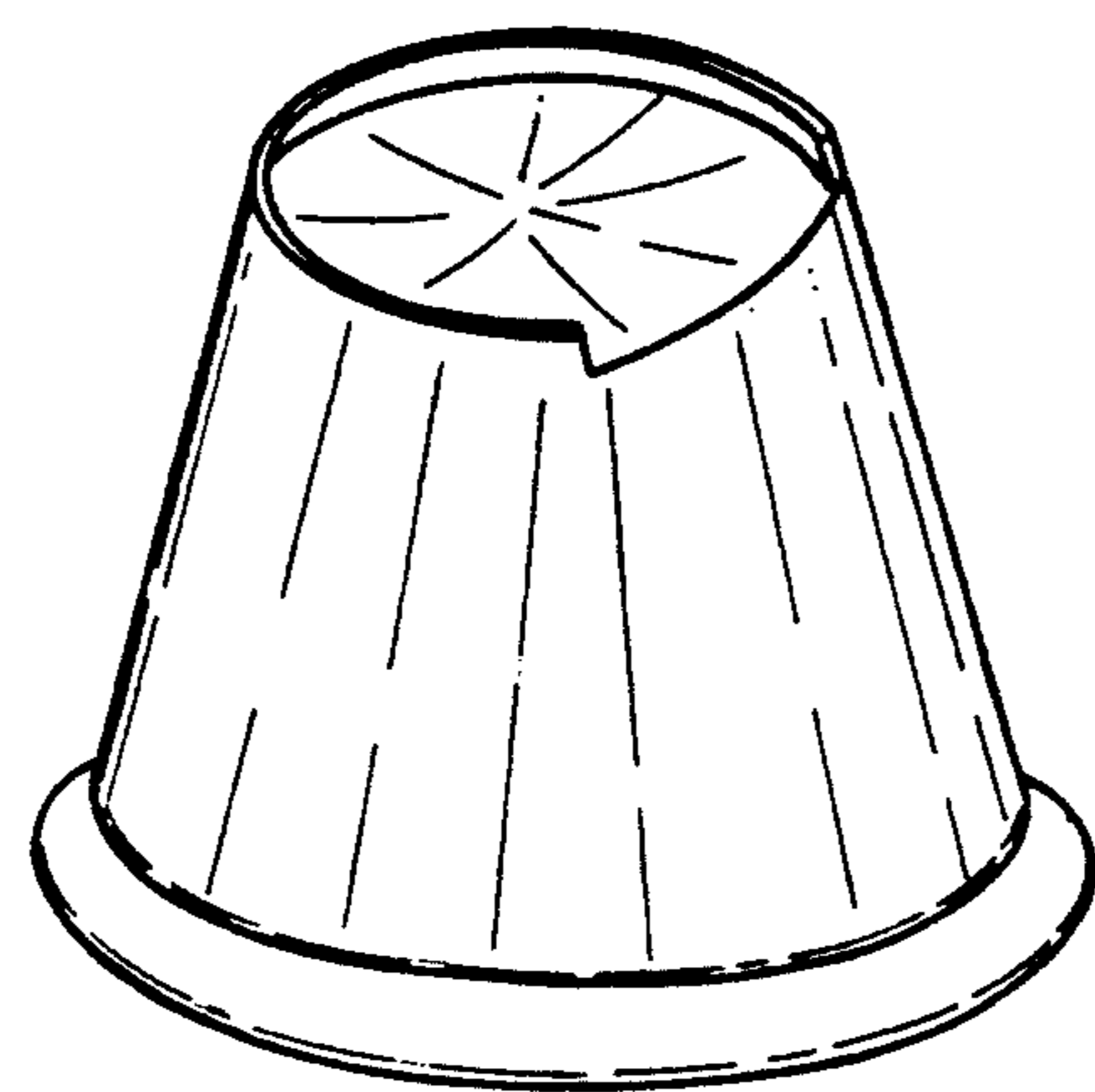
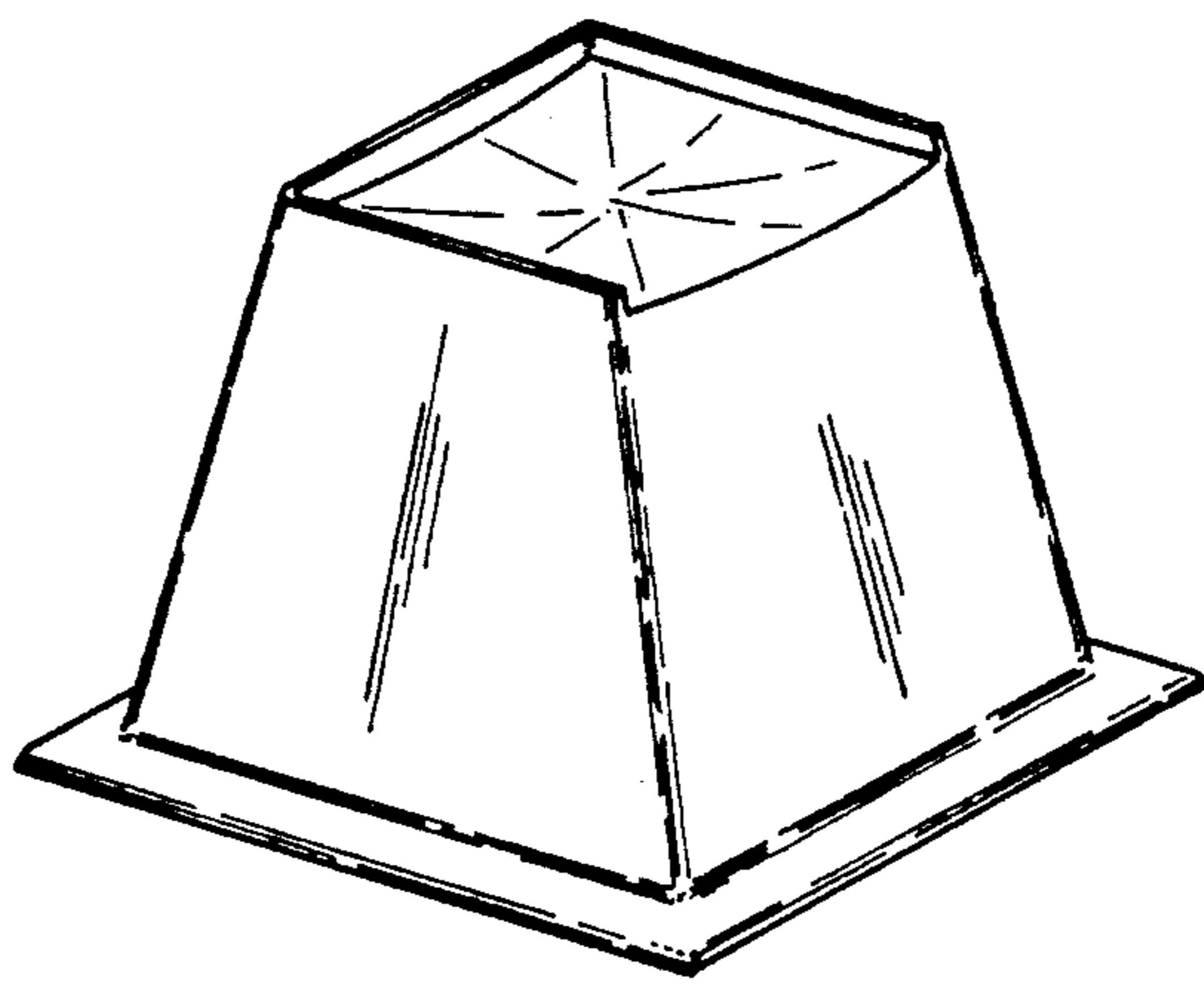

[57] **CLAIM**

The design for a bed elevator for supporting a leg of a bed in elevated condition, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a bed elevator for supporting a leg of a bed in elevated condition, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof, the left side being a mirror image of that shown;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top, front and left side perspective view of another embodiment of a bed elevator for supporting a leg of a bed in elevated condition;
FIG. 7 is a top plan view of FIG. 6;
FIG. 8 is a front elevational view of FIG. 6;
FIG. 9 is a right side elevational view of FIG. 6, the left side being a mirror image of that shown; and,
FIG. 10 is a rear elevational view of FIG. 6.
The bottom of the design is flat and unornamented.



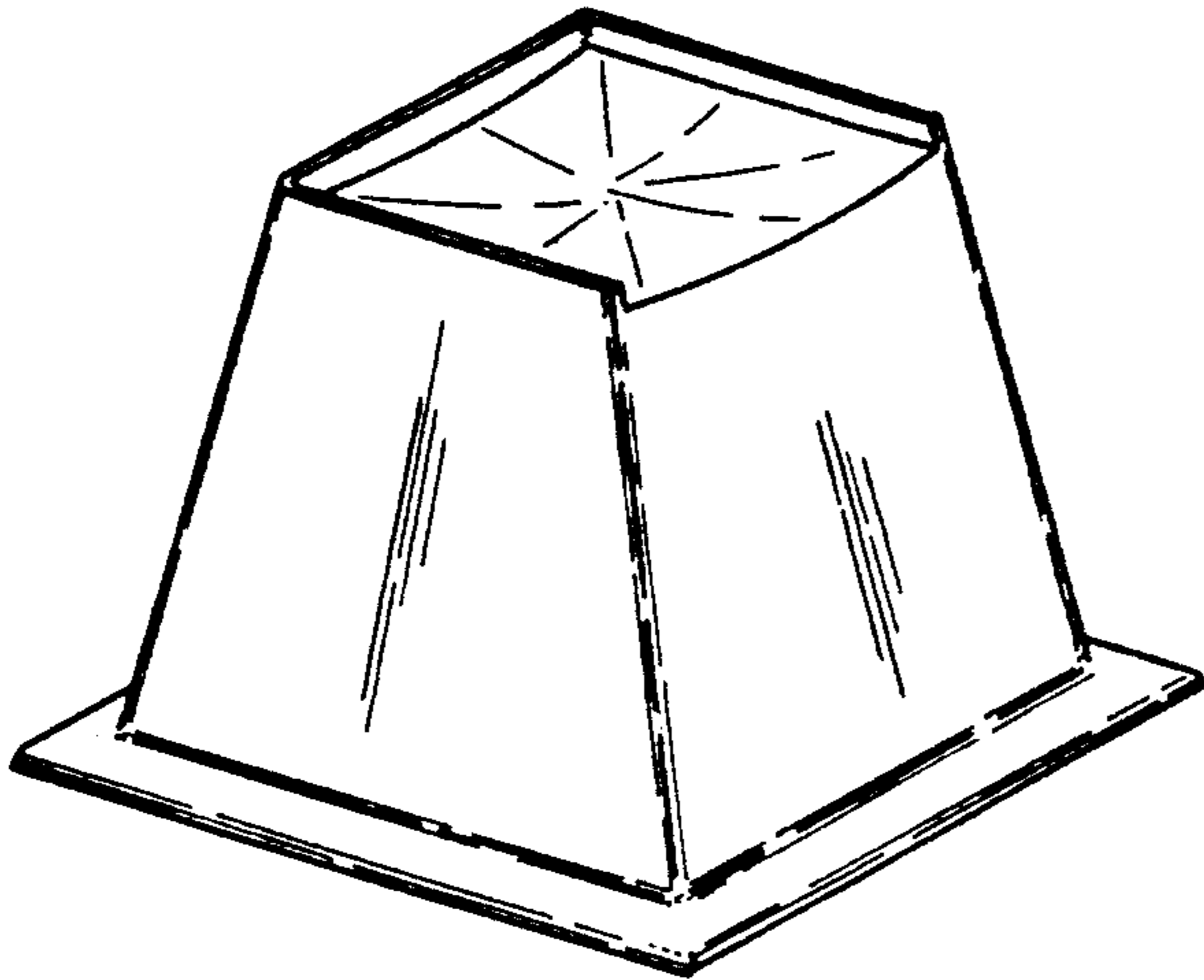

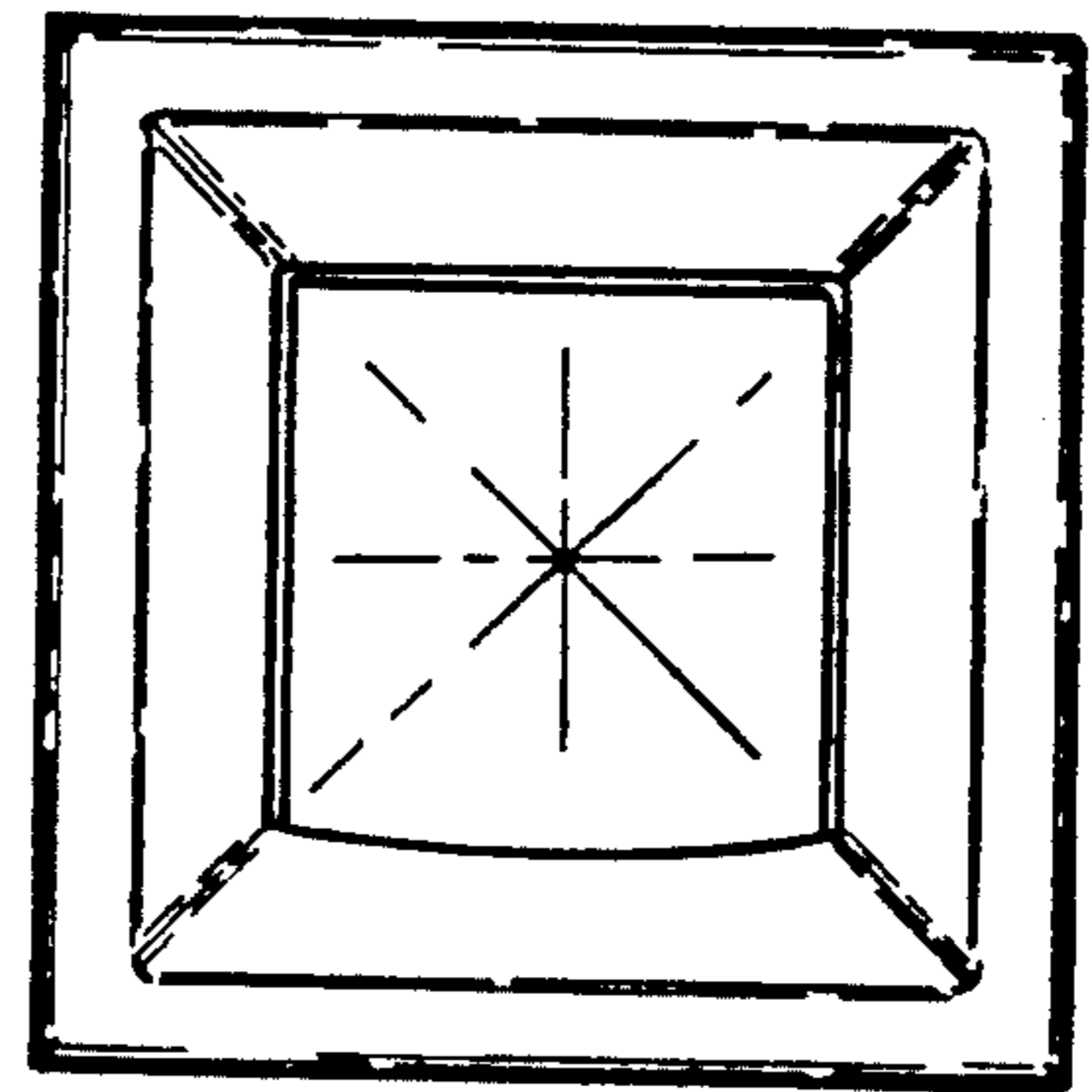

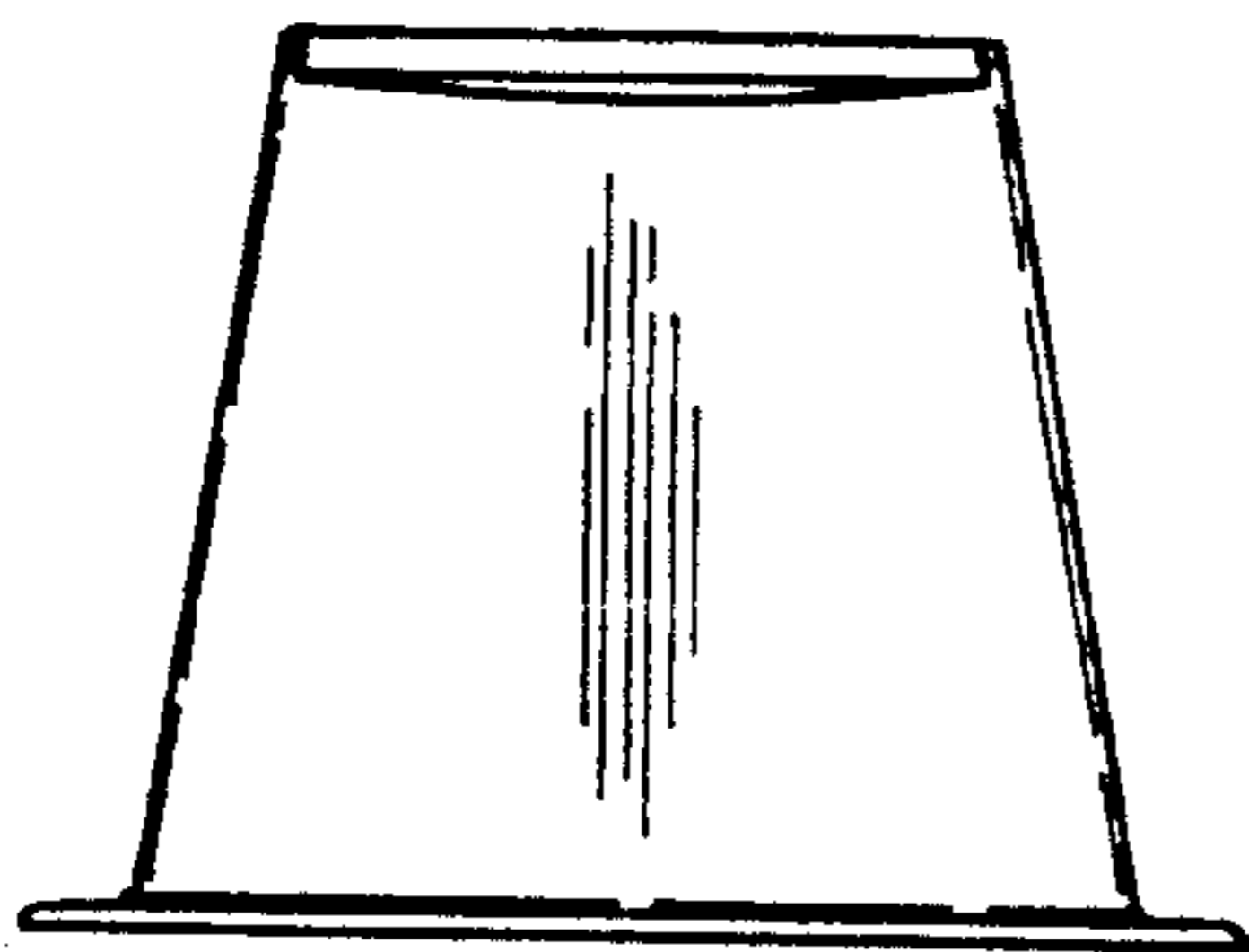

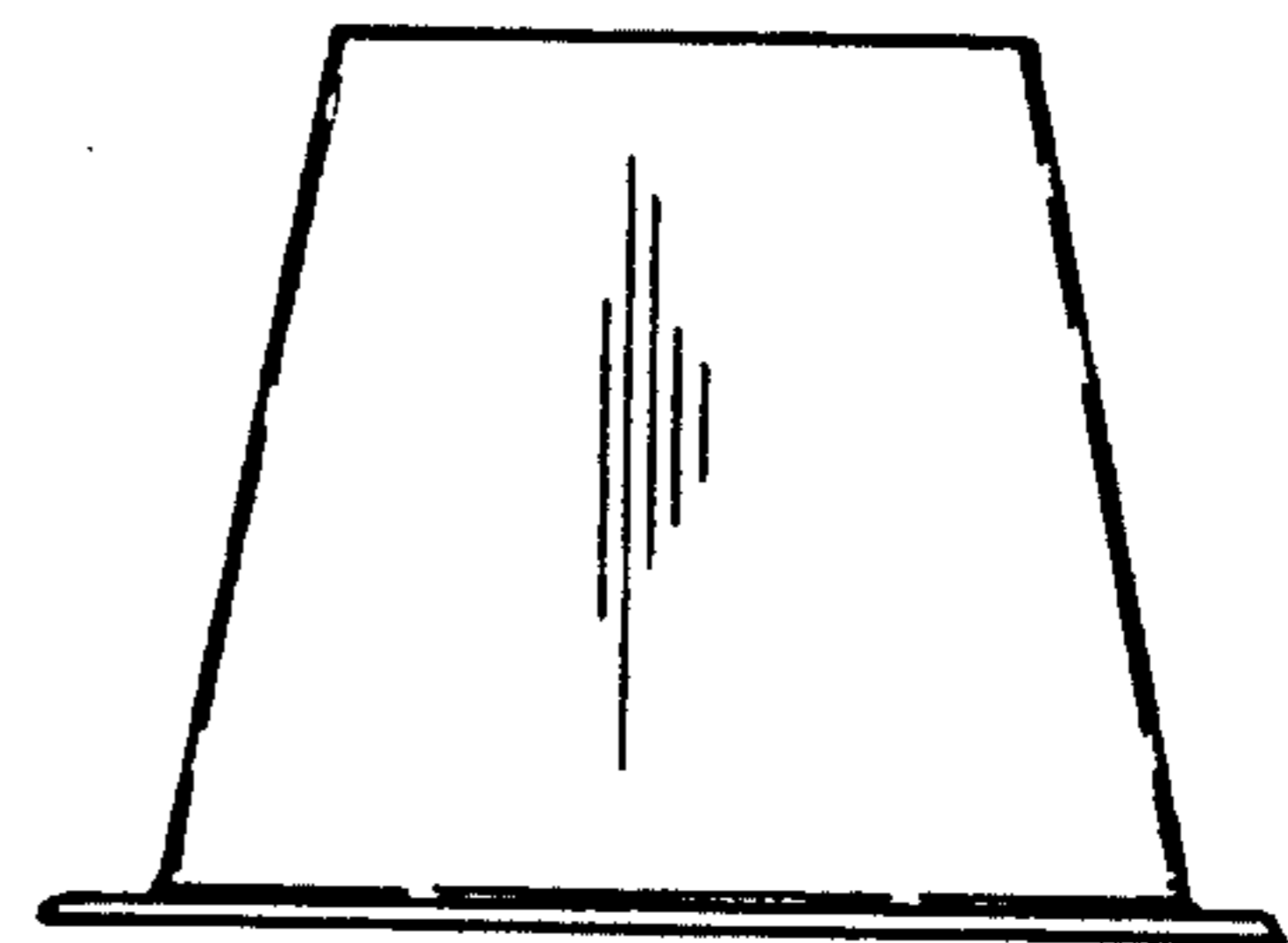

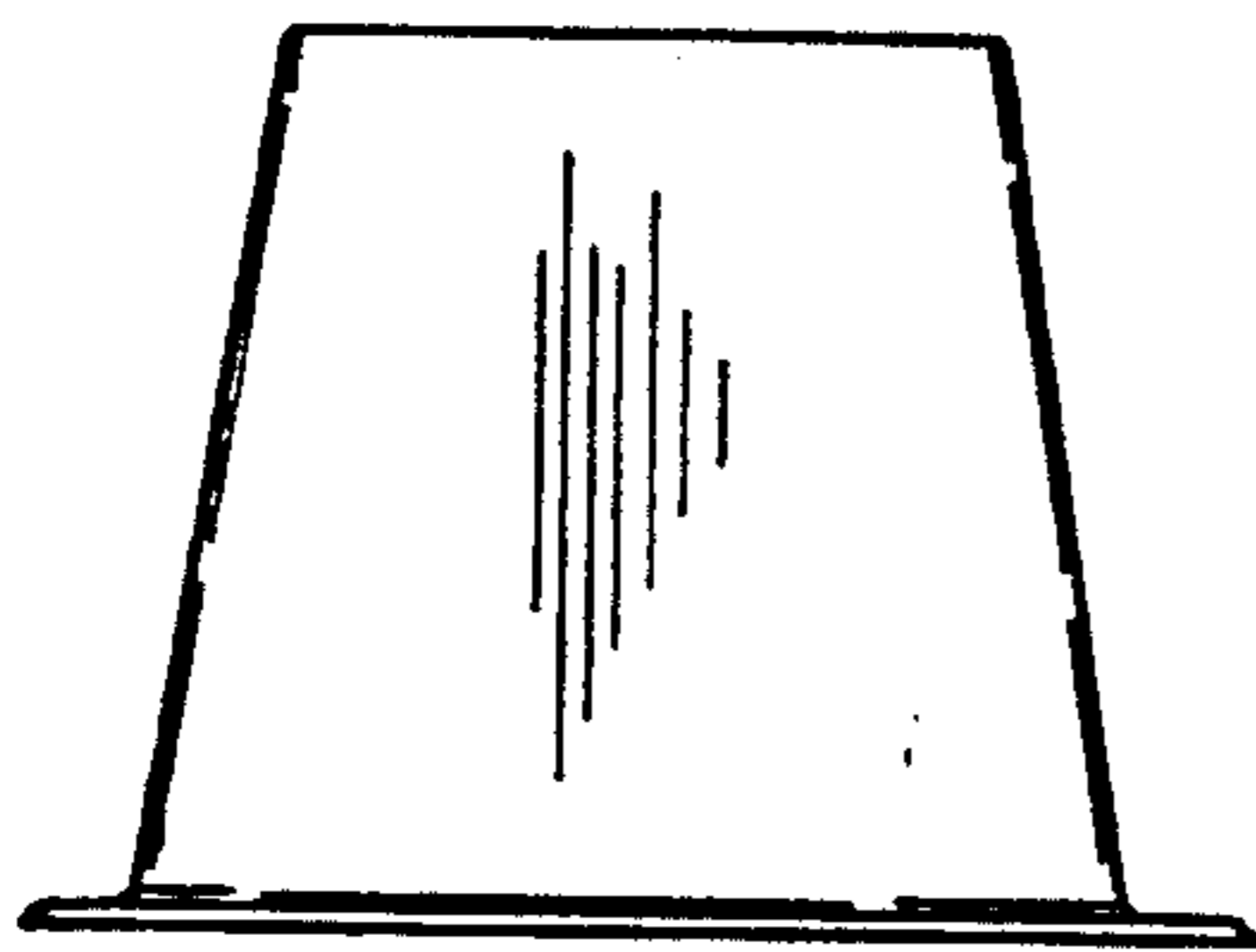

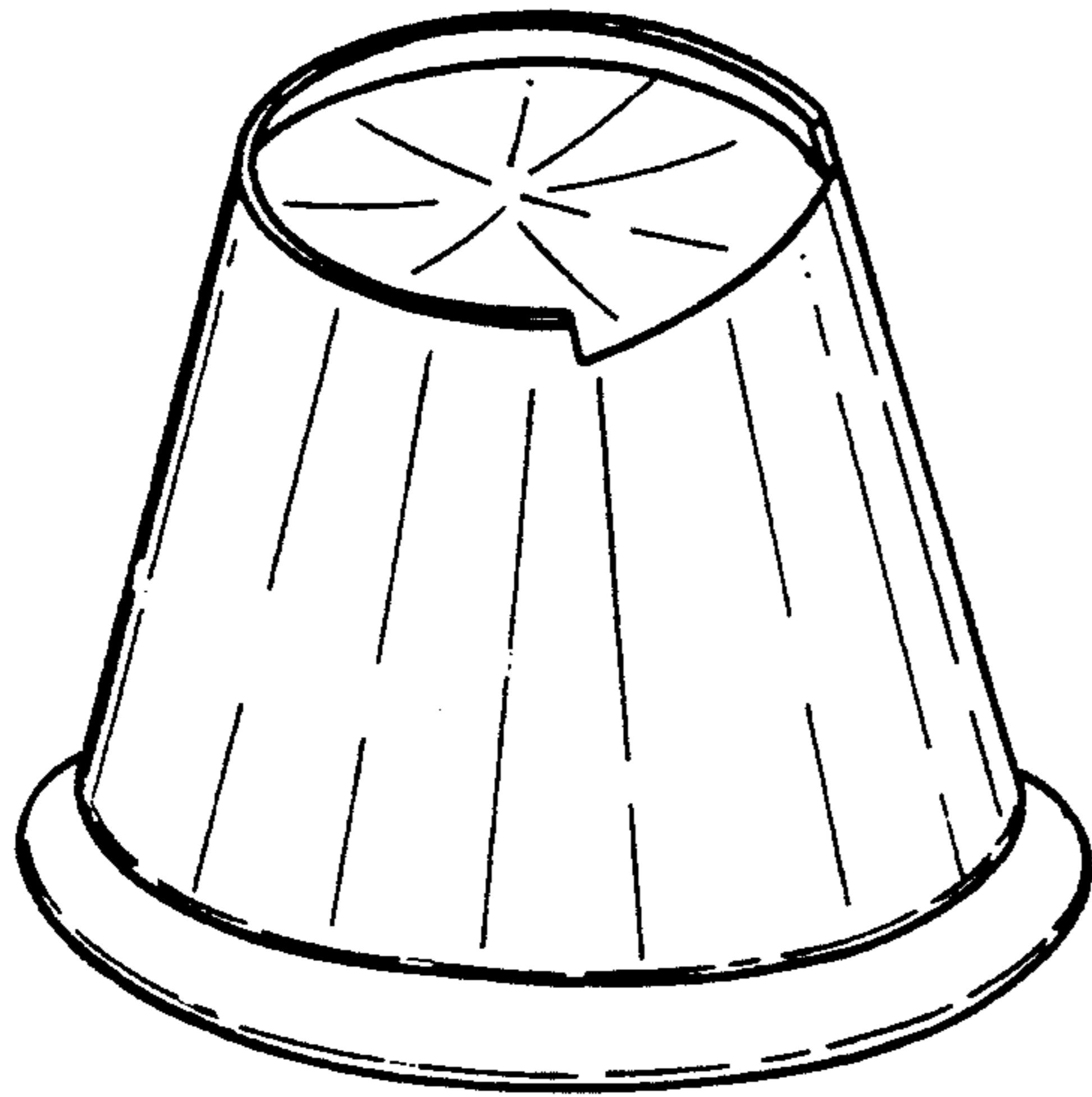

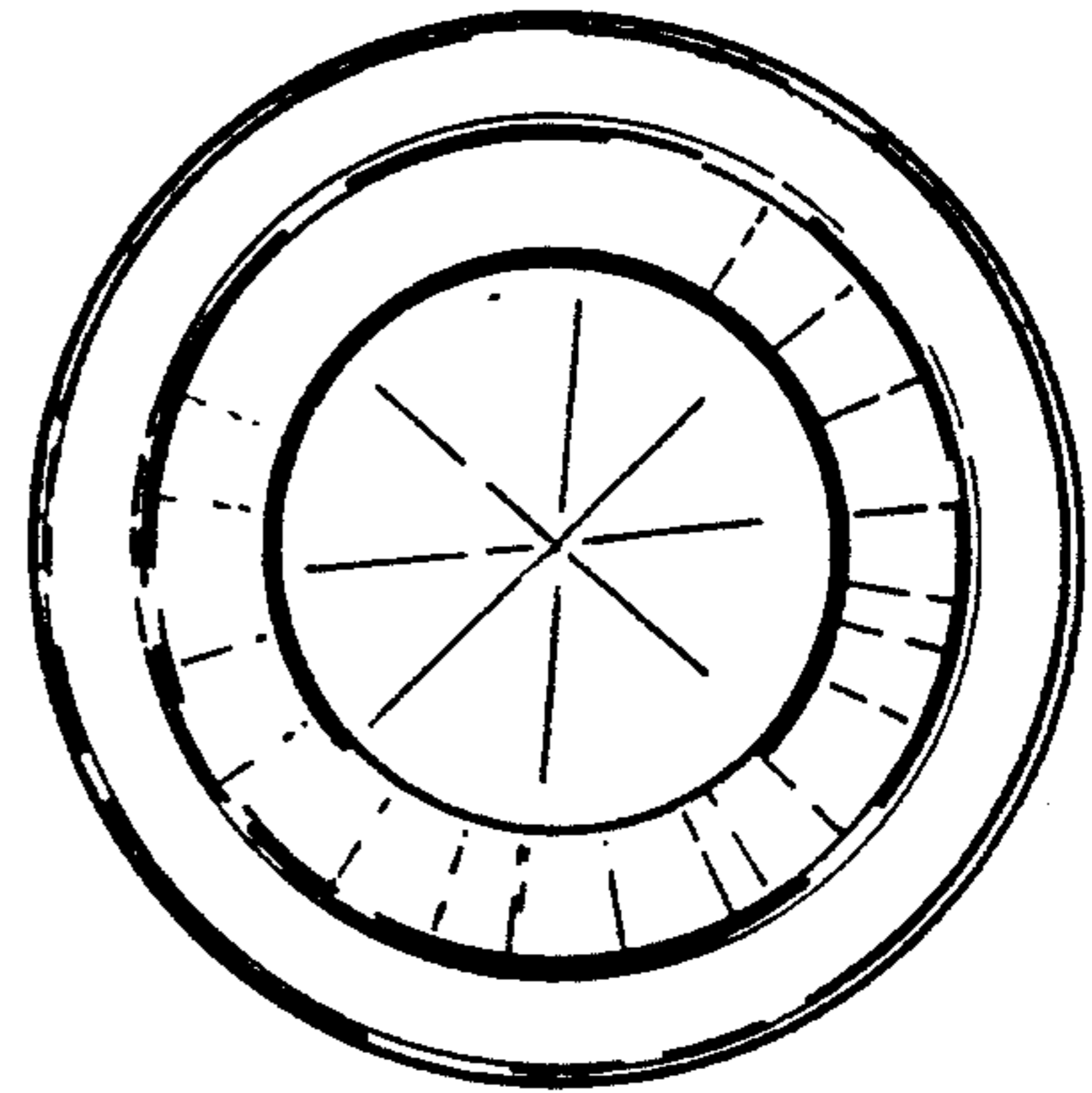

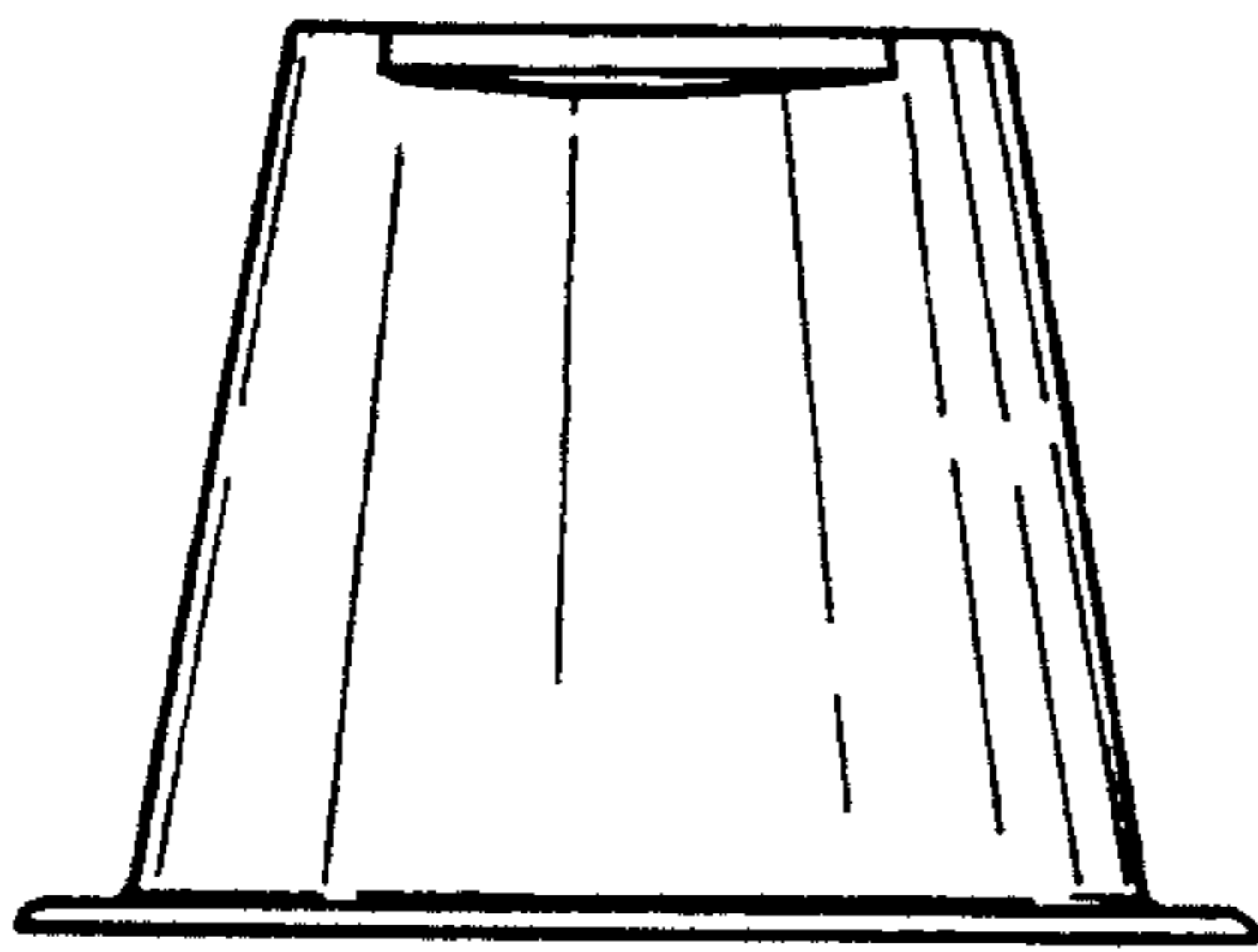

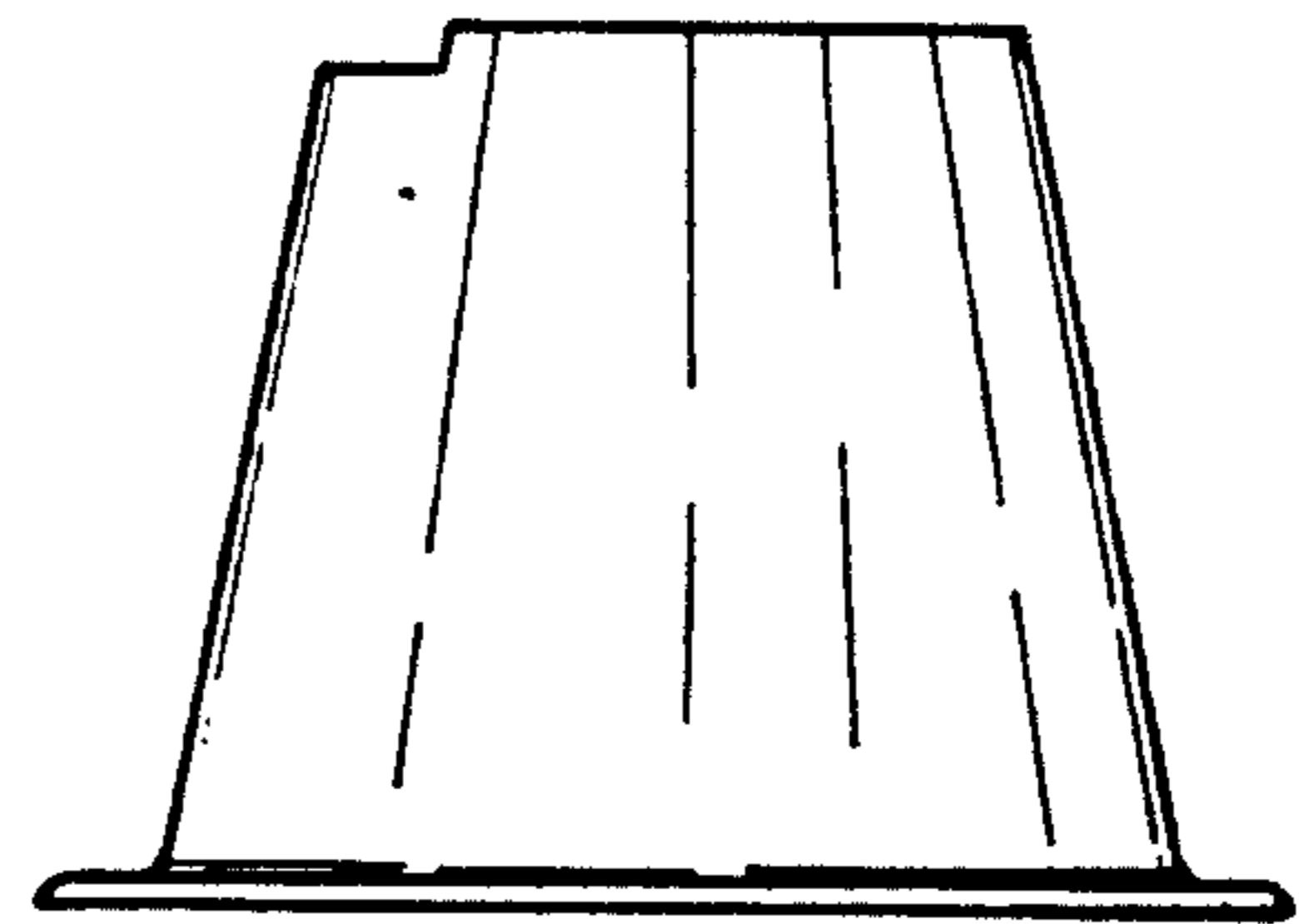

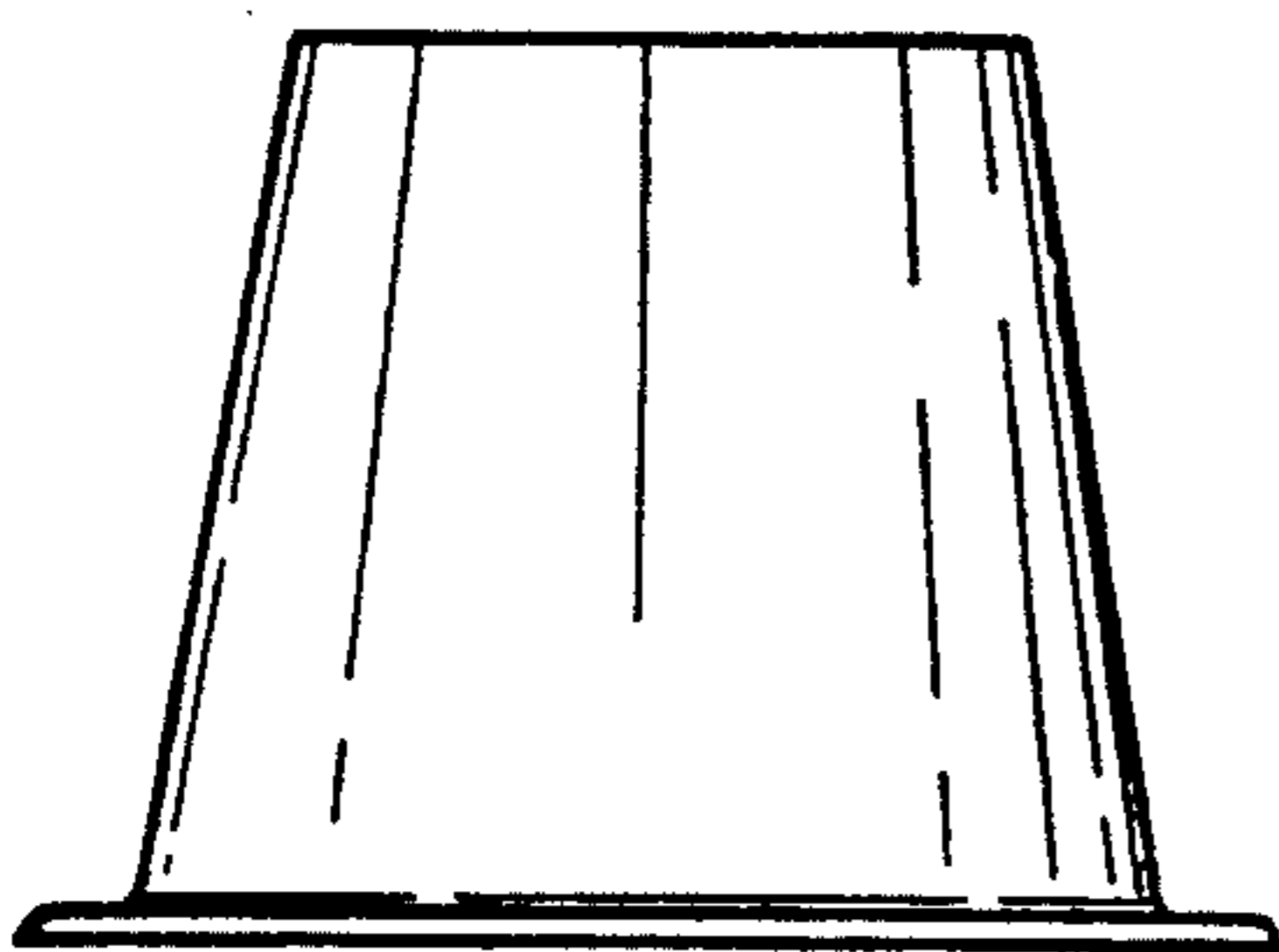
