FIG. 3 is a left front perspective view thereof with the front panel opened and stored in the frontal pouch;

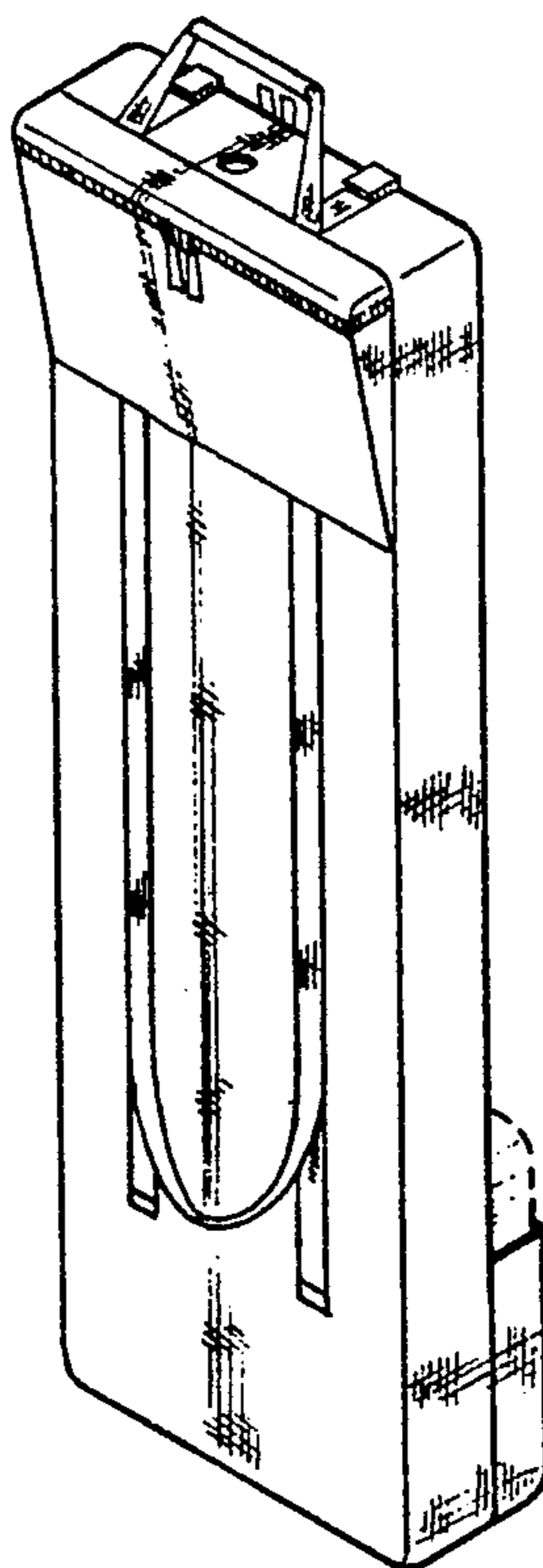
FIG. 4 is a left rear perspective view thereof;

FIG. 8 is a bottom plan view thereof.



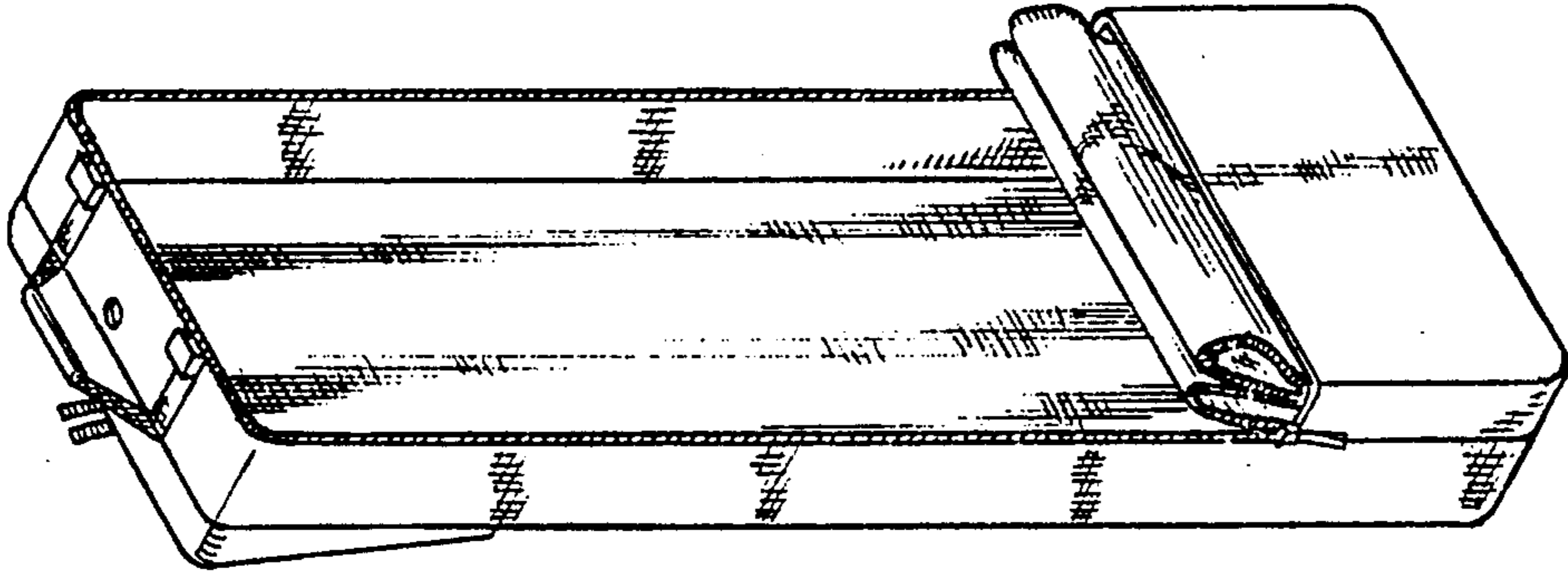

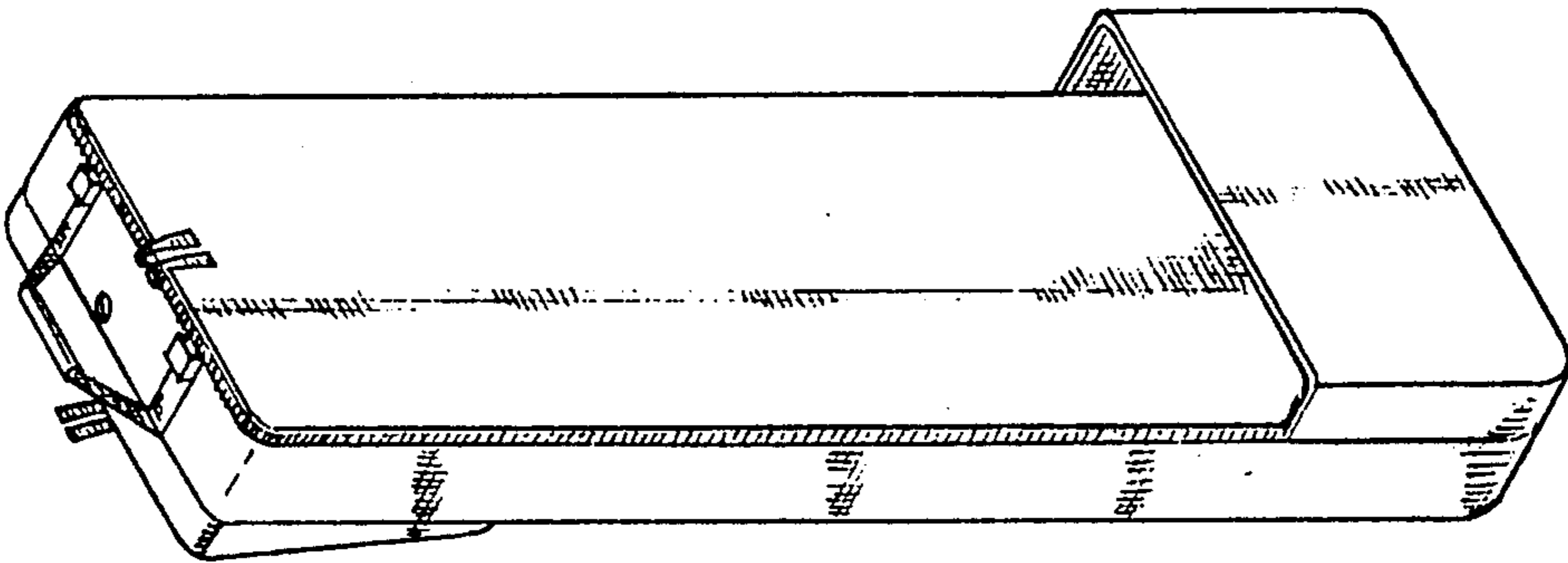

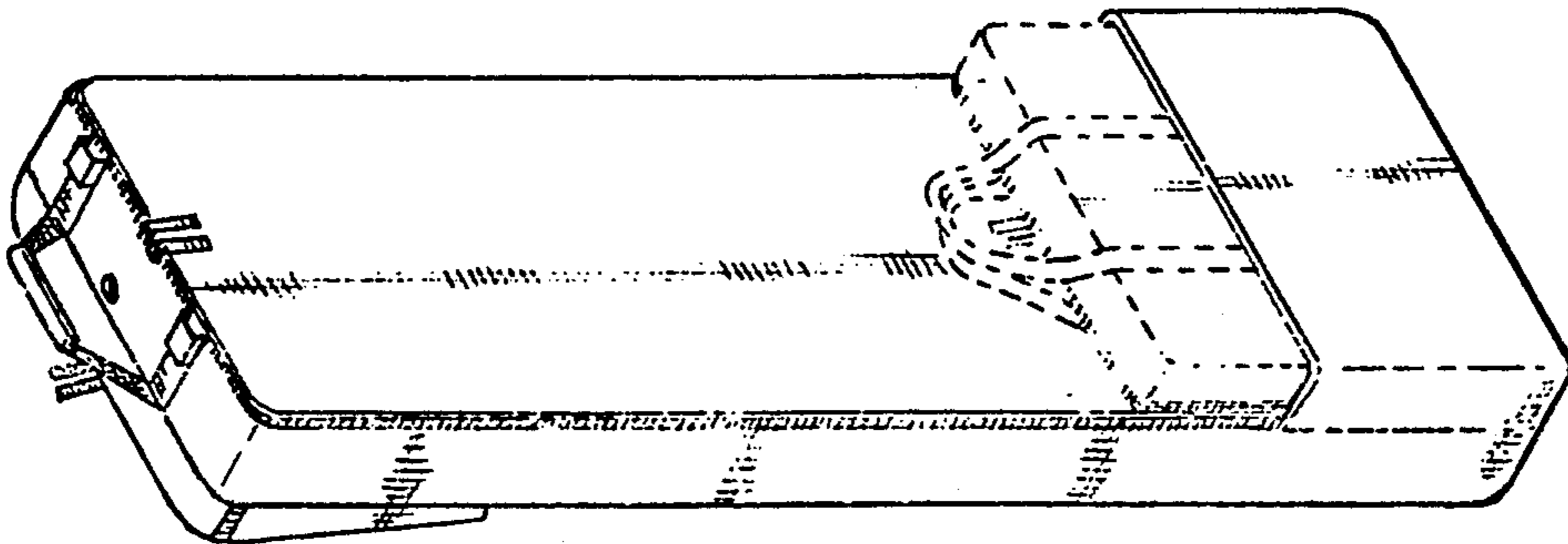

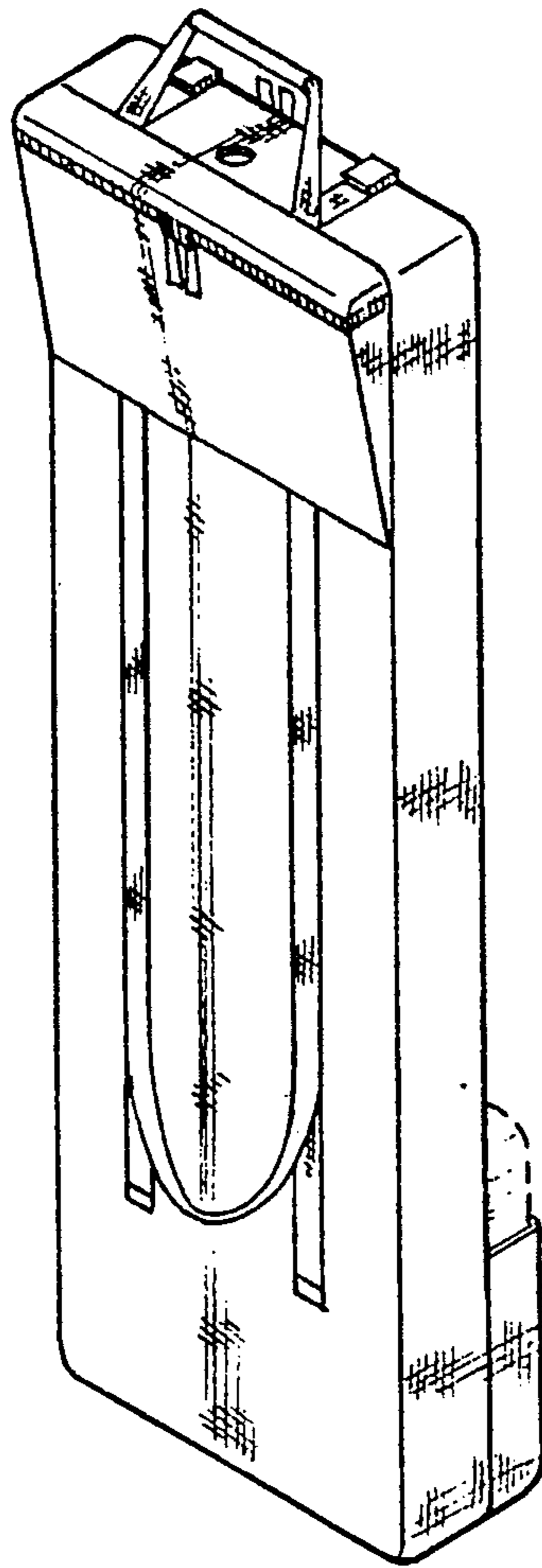

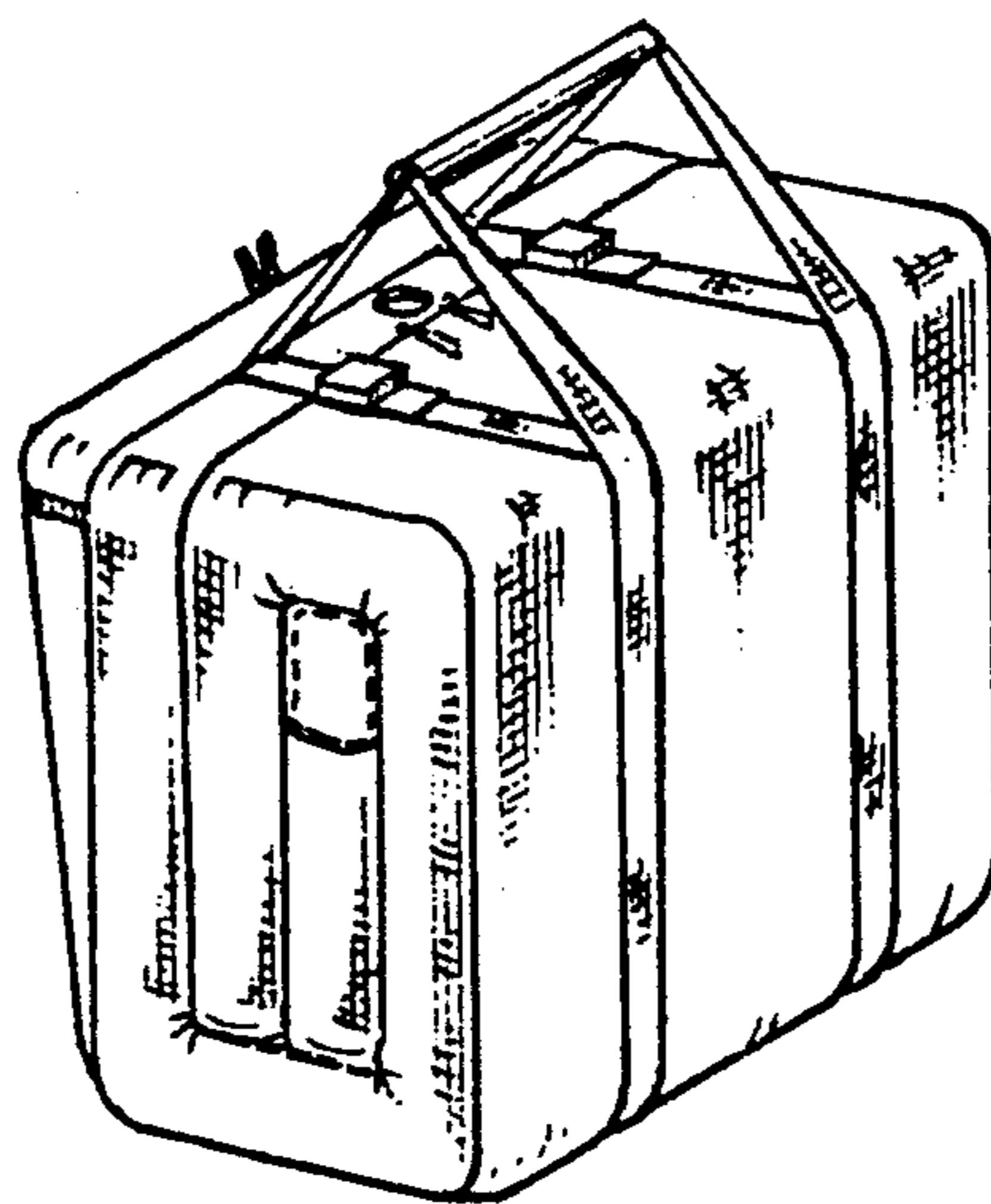

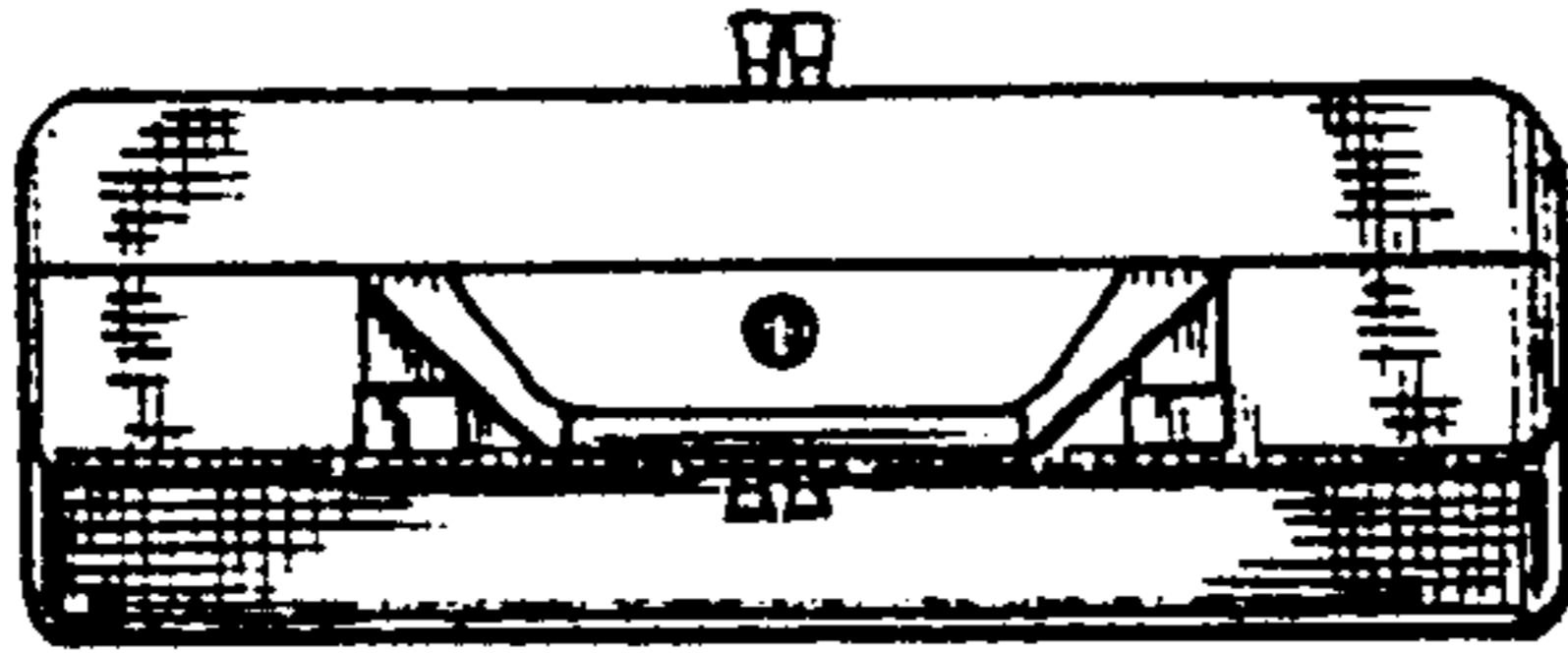

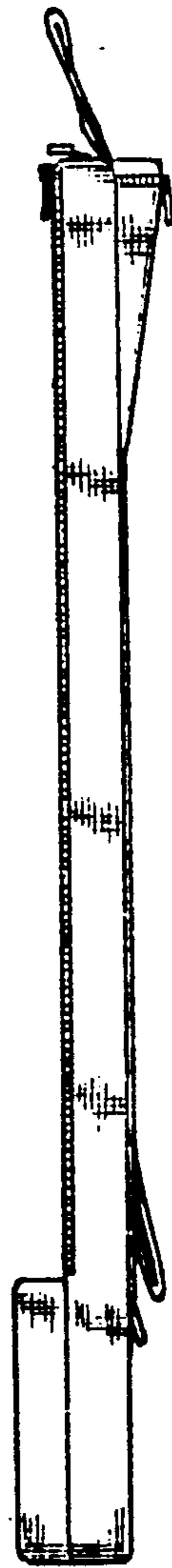

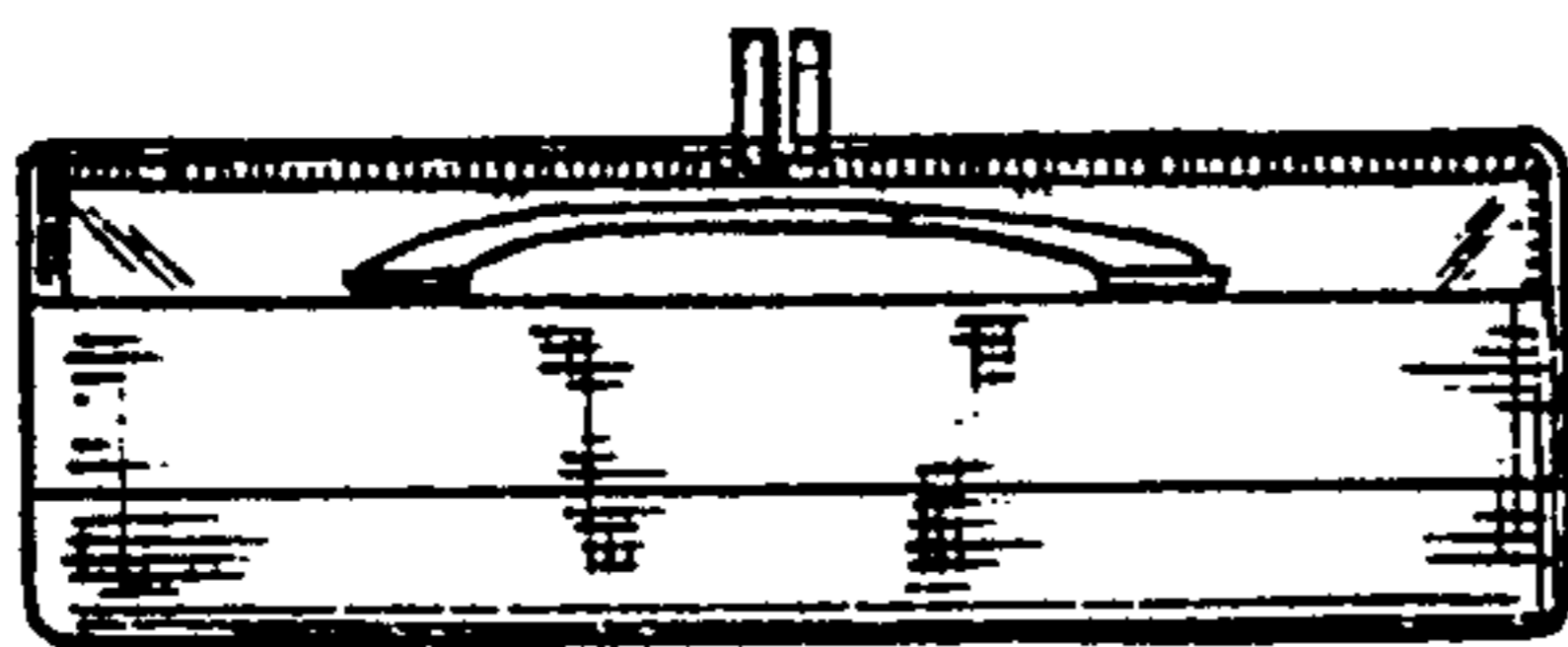
