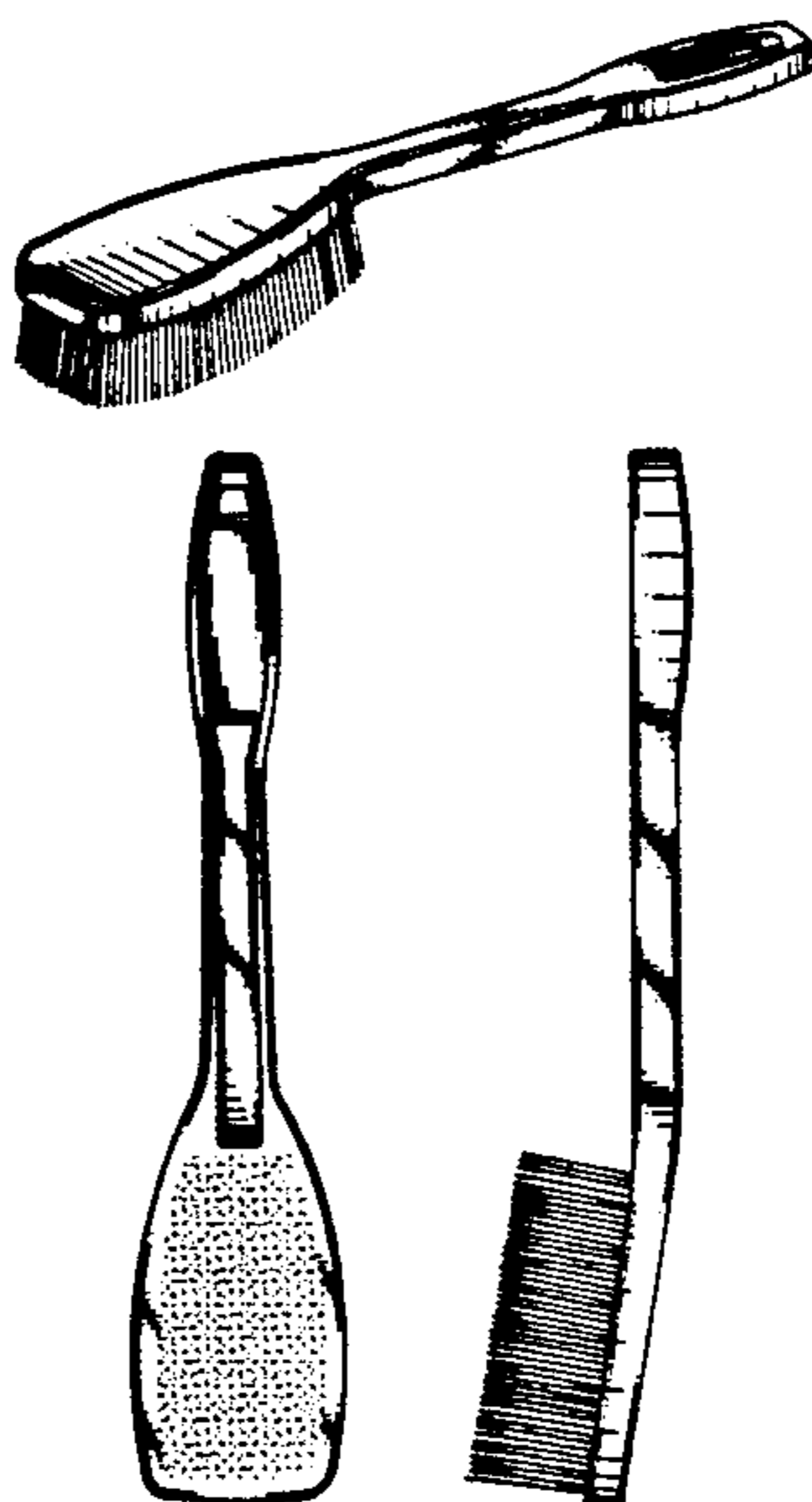

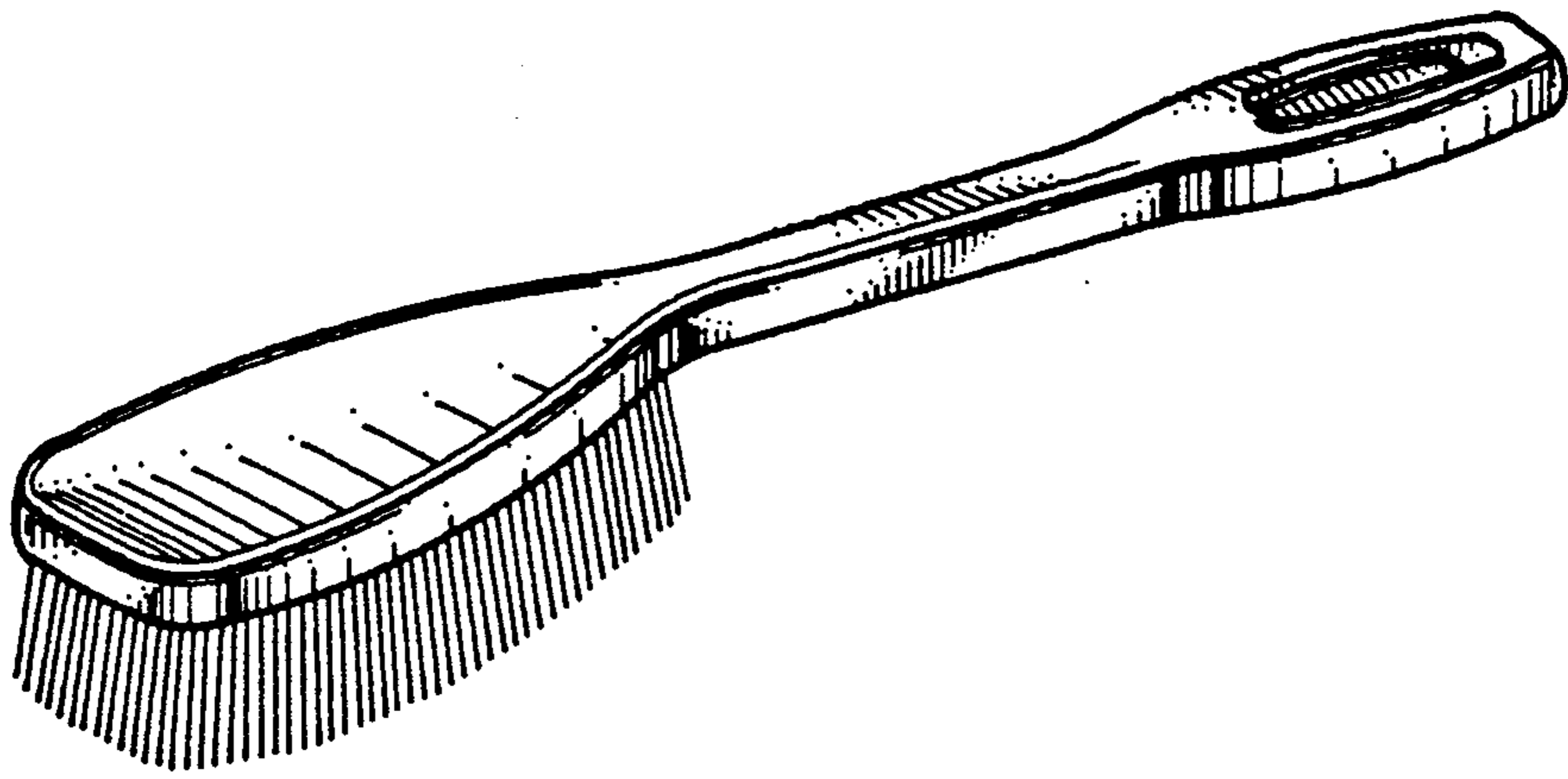
### [57] CLAIM

The ornamental design for a brush and handle unit, as shown and described.

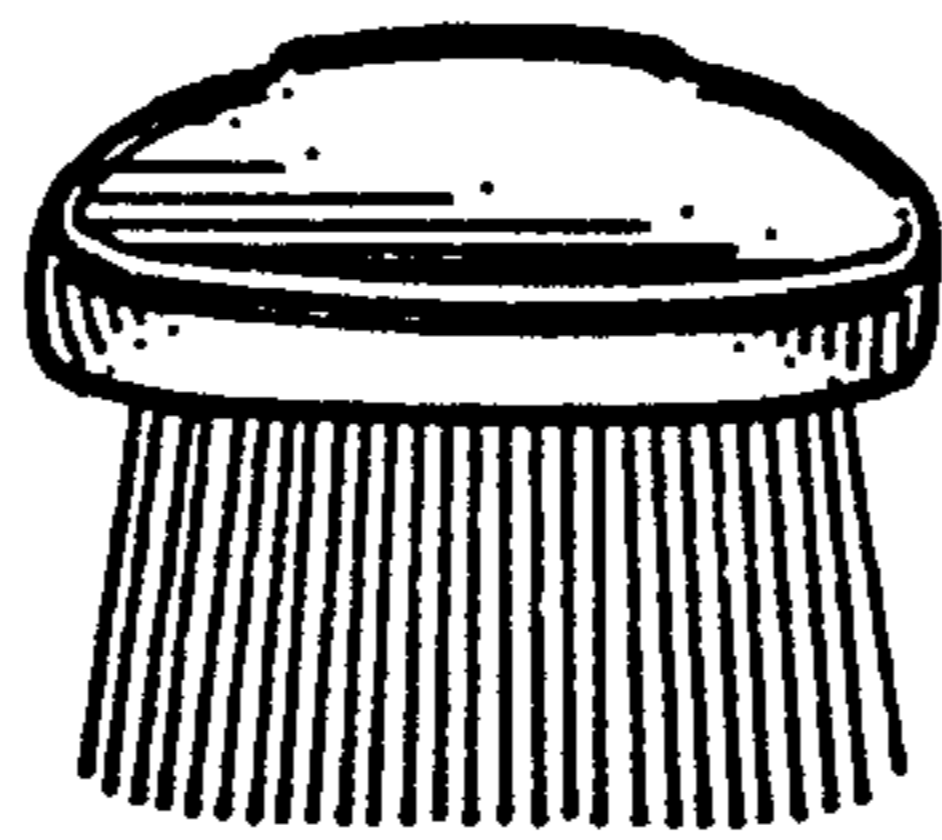
### DESCRIPTION

FIG. 1 is a left front perspective view of a brush and handle unit embodying our new design;  
 FIG. 2 is a left side elevational view thereof;

 FIG. 6 is a right side elevational view thereof.

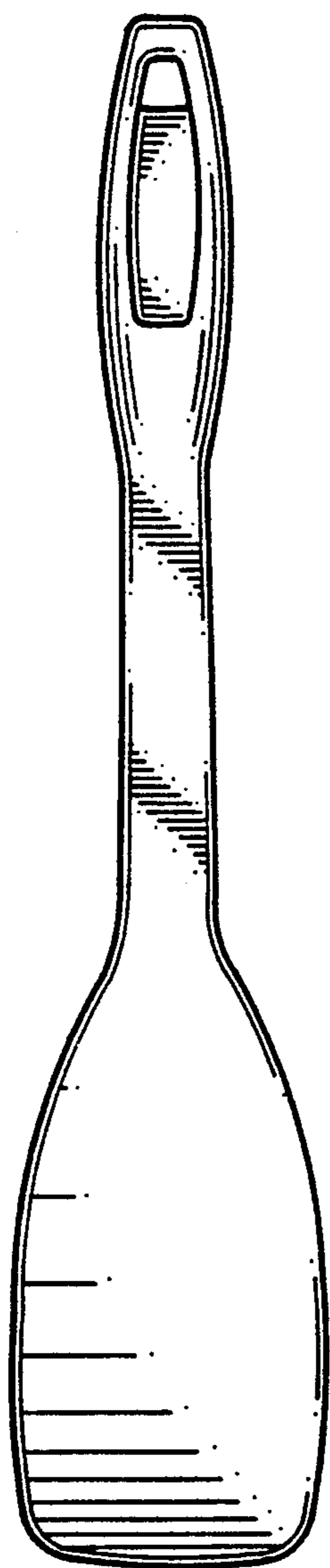




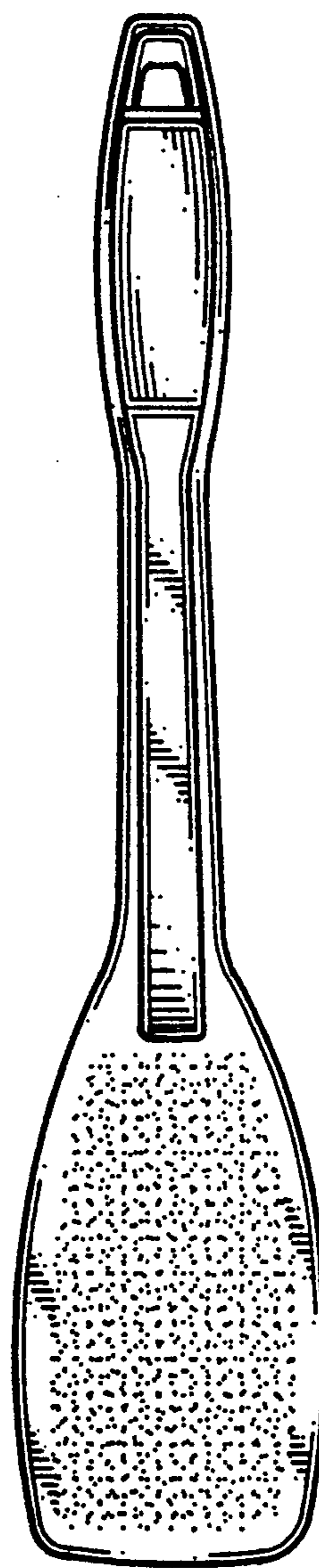

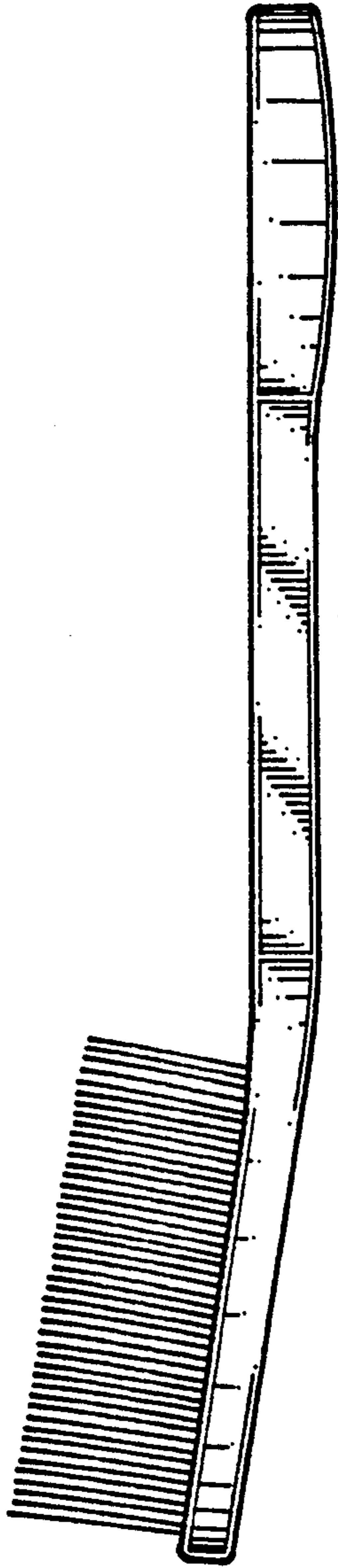

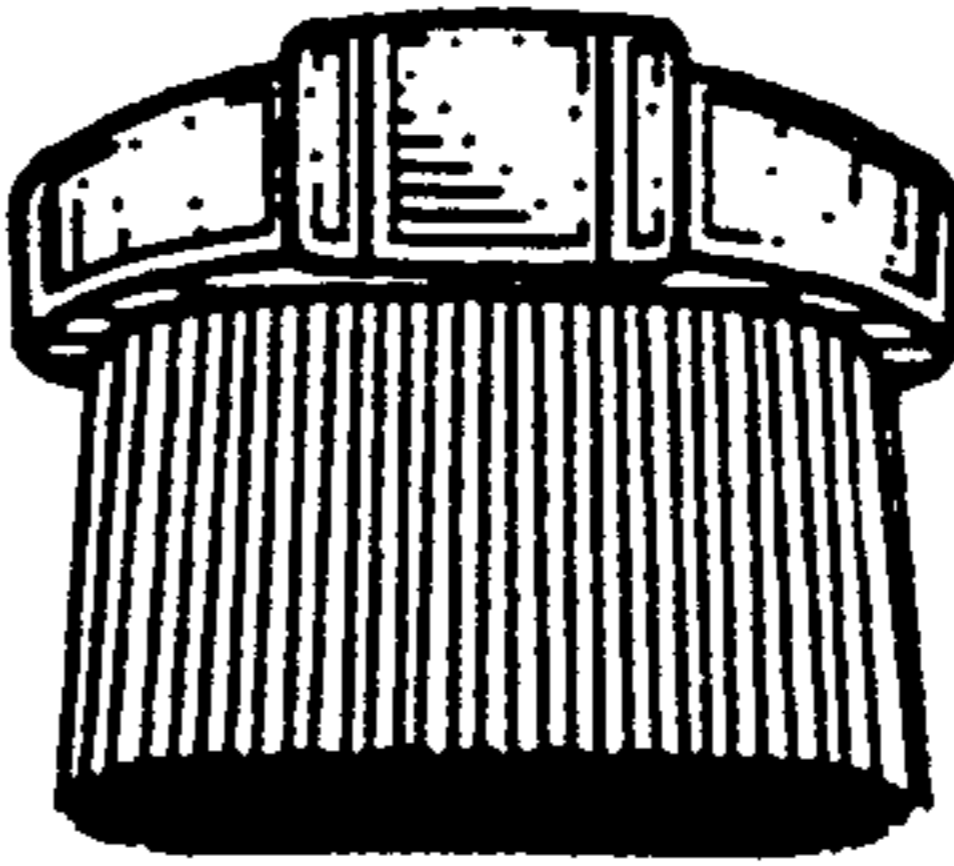
