FIG. 1 is a top plan view of a headphone, showing our new design;

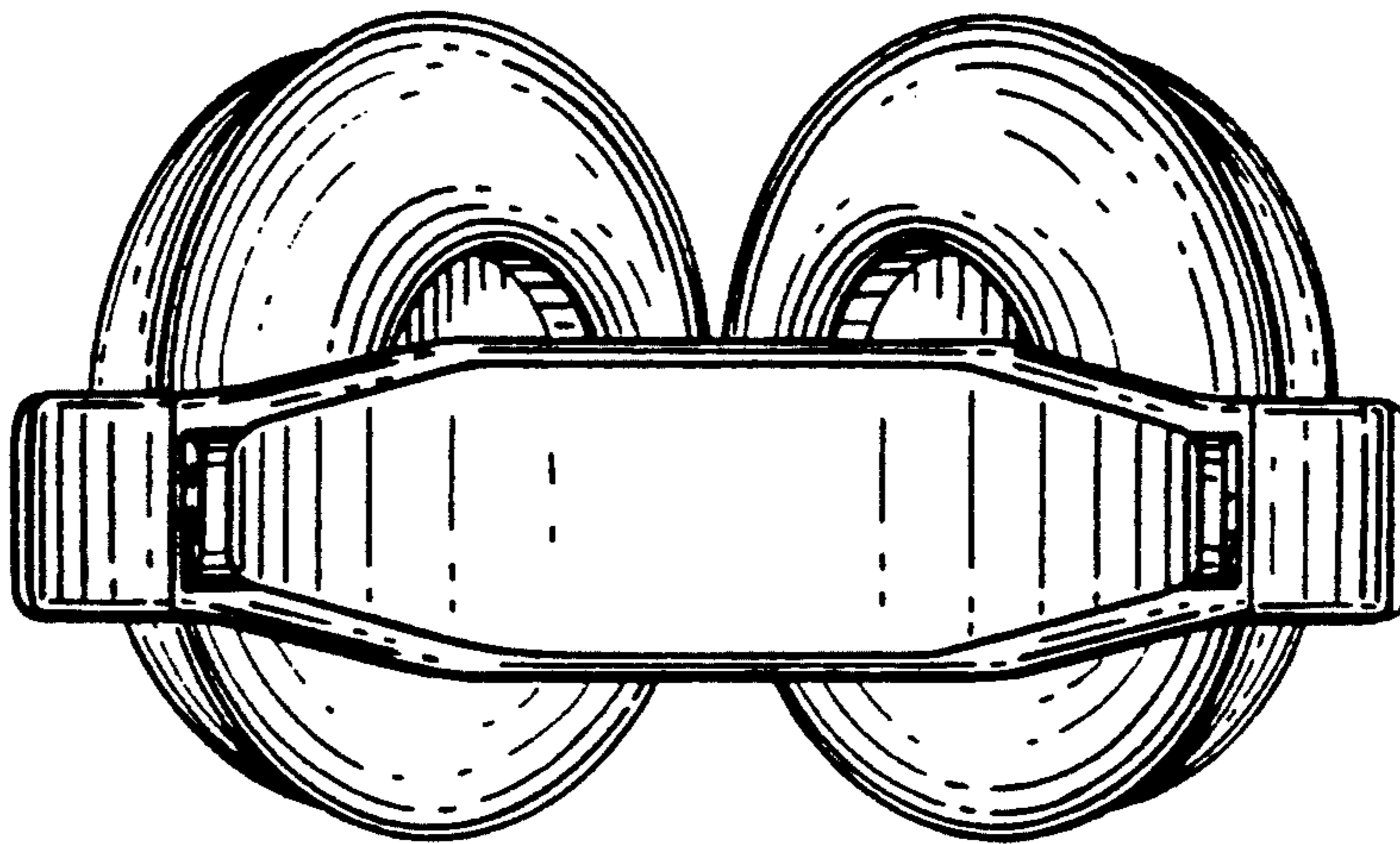

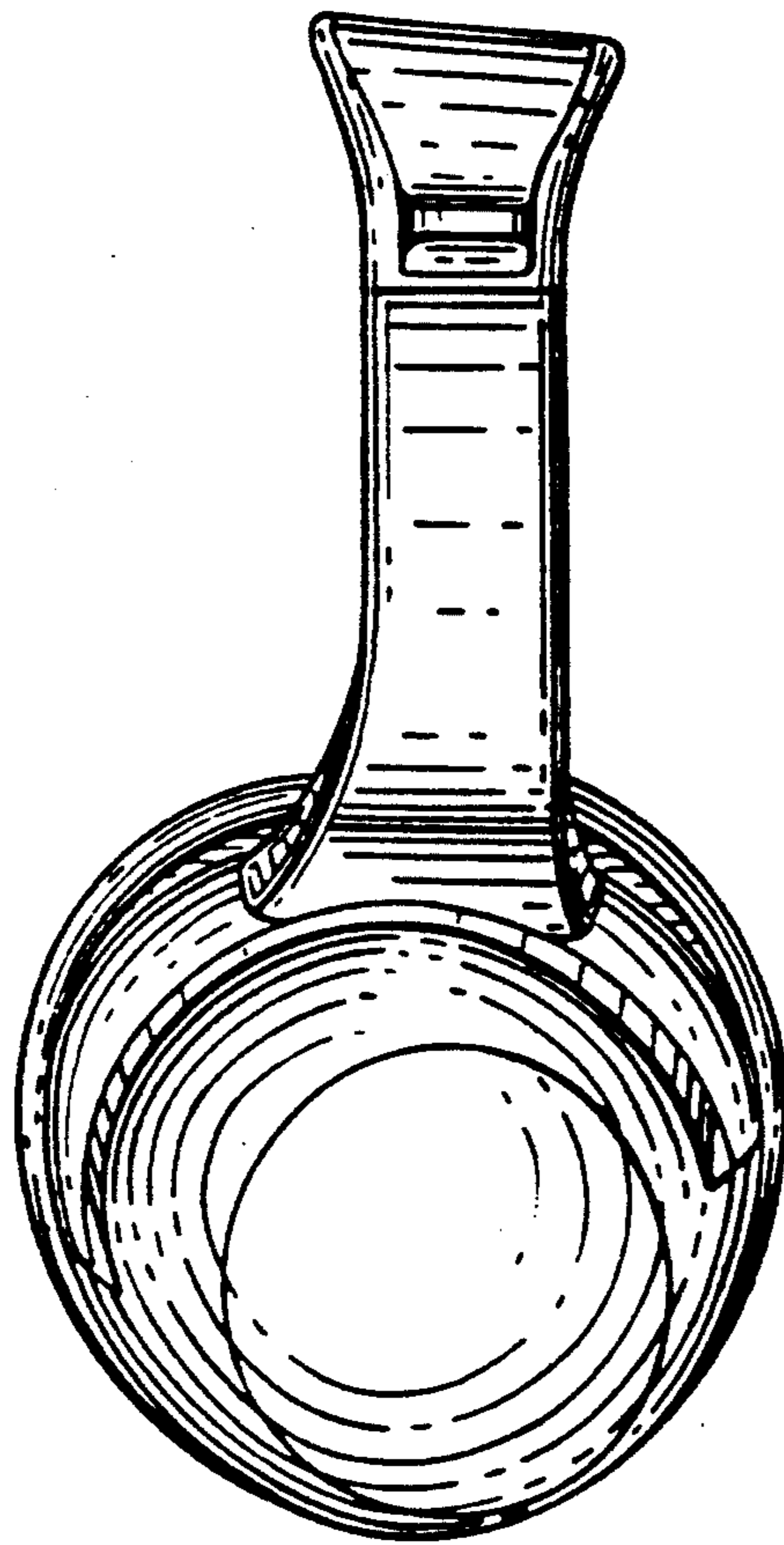

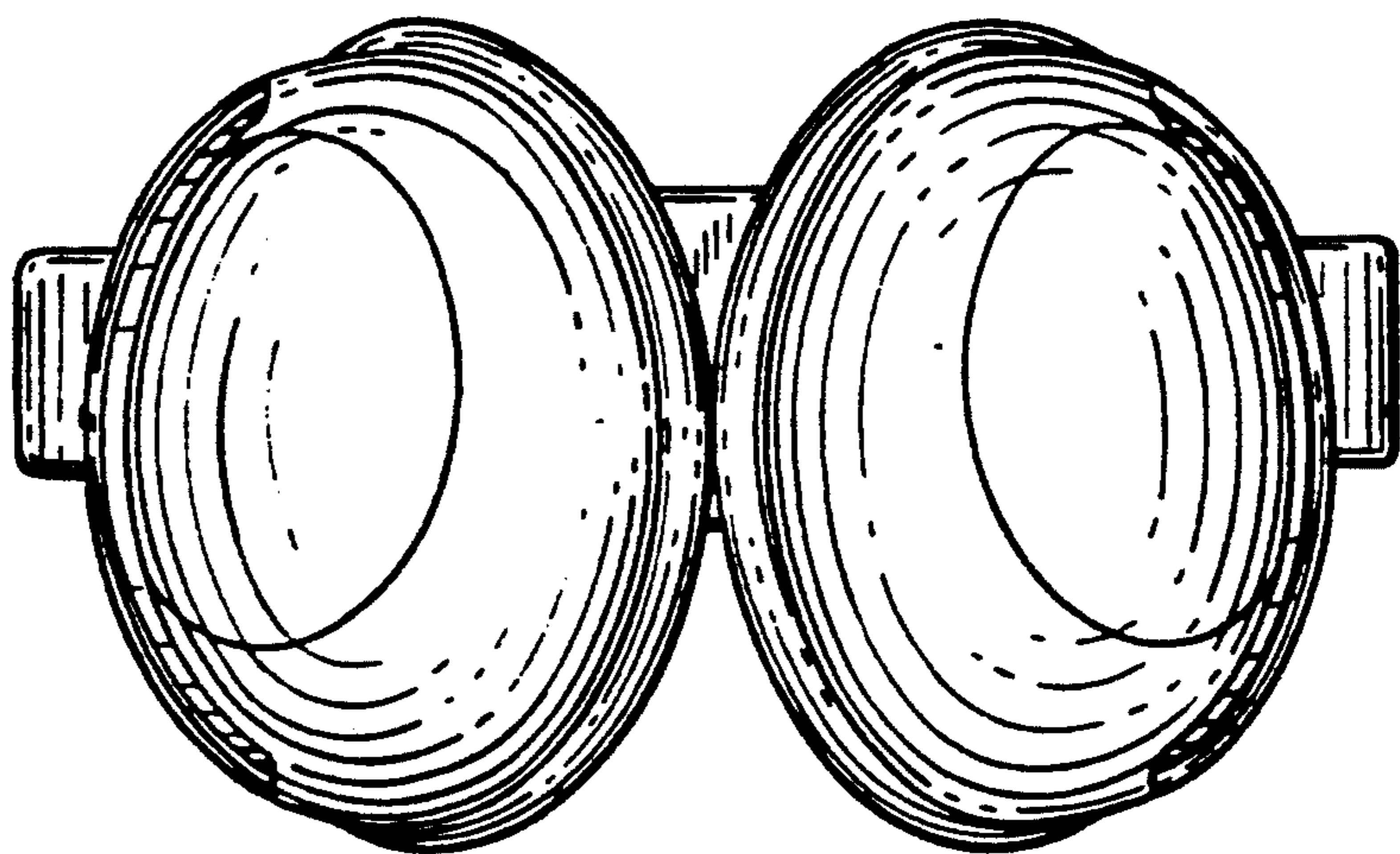

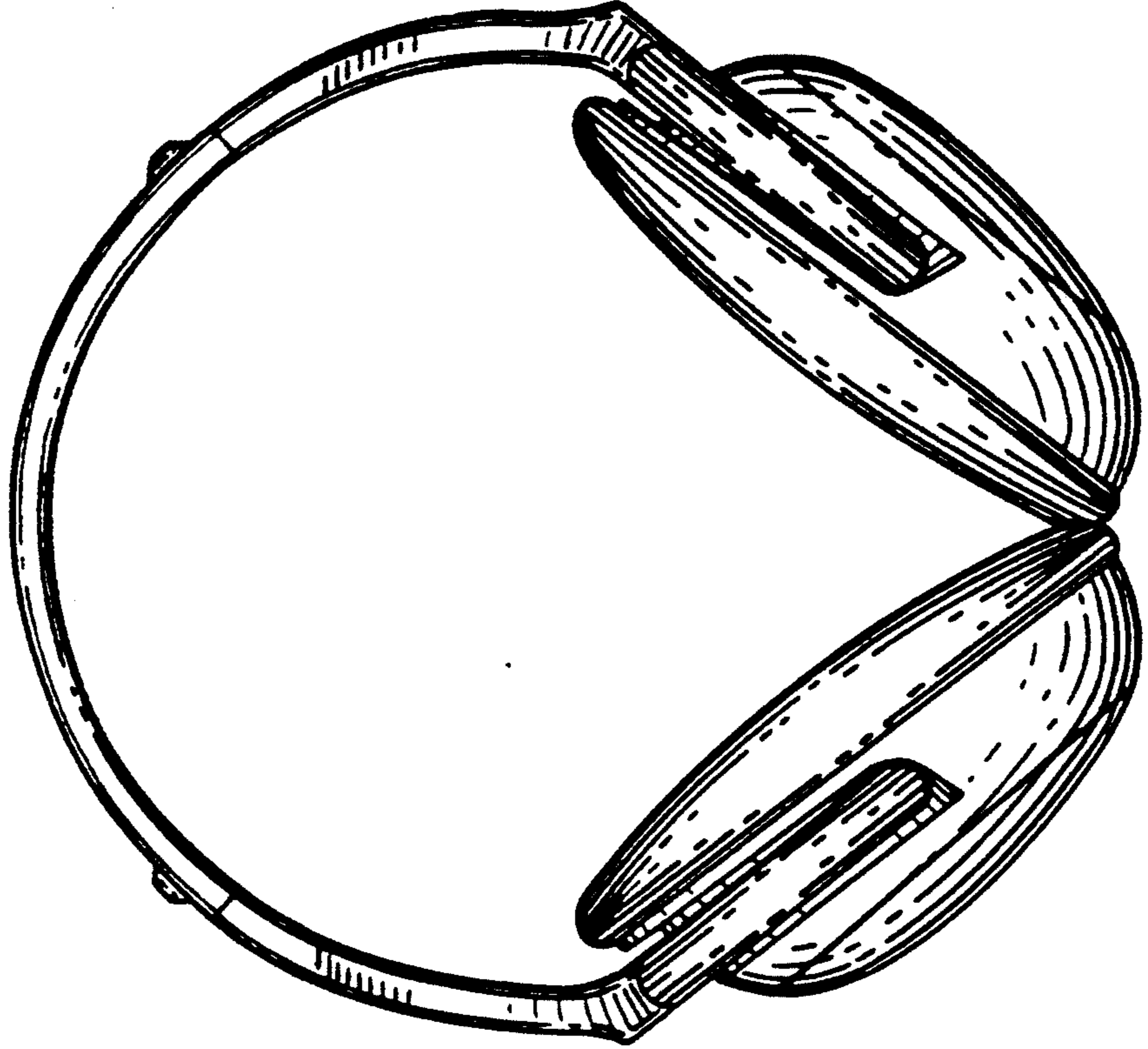
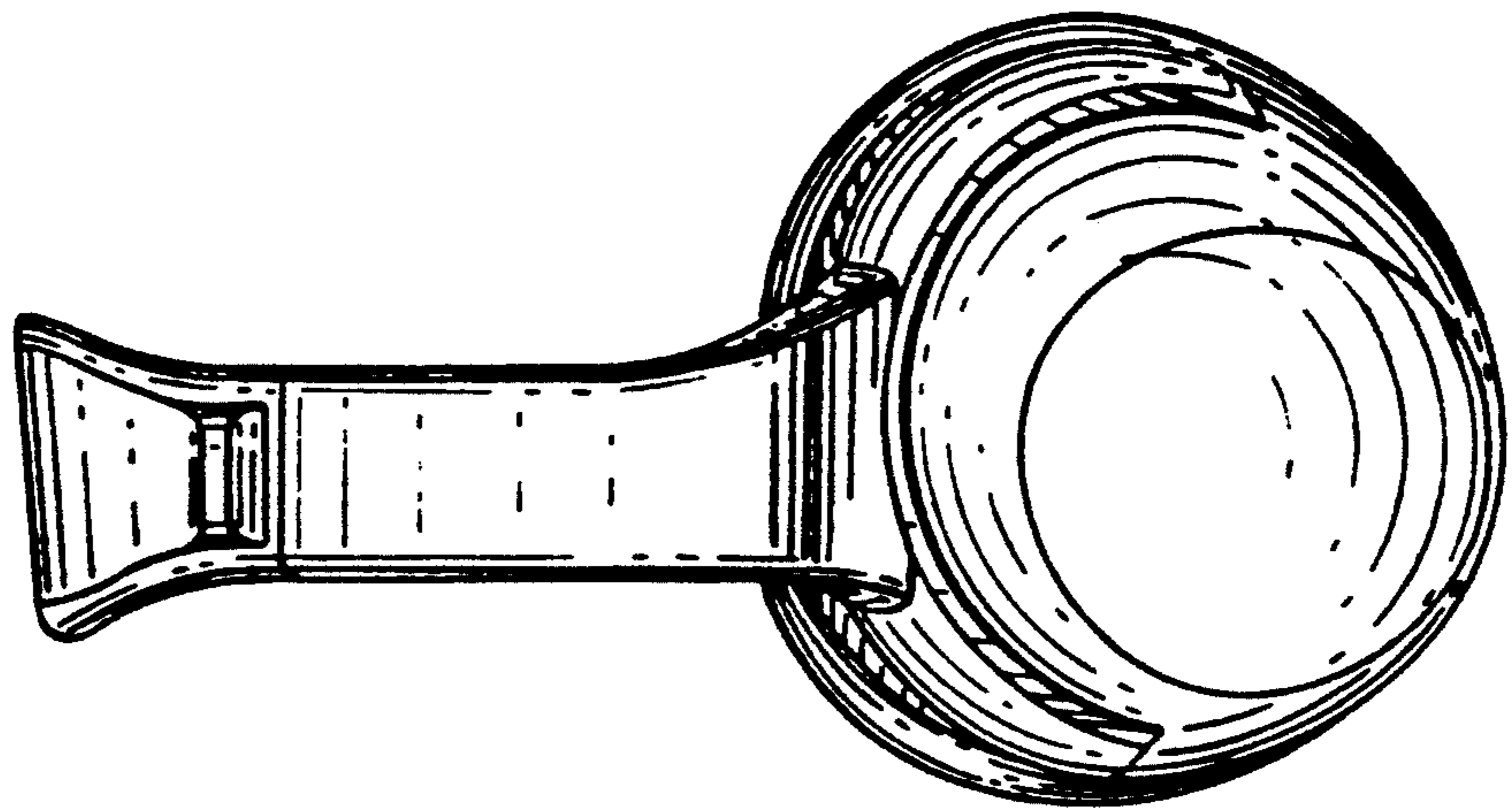

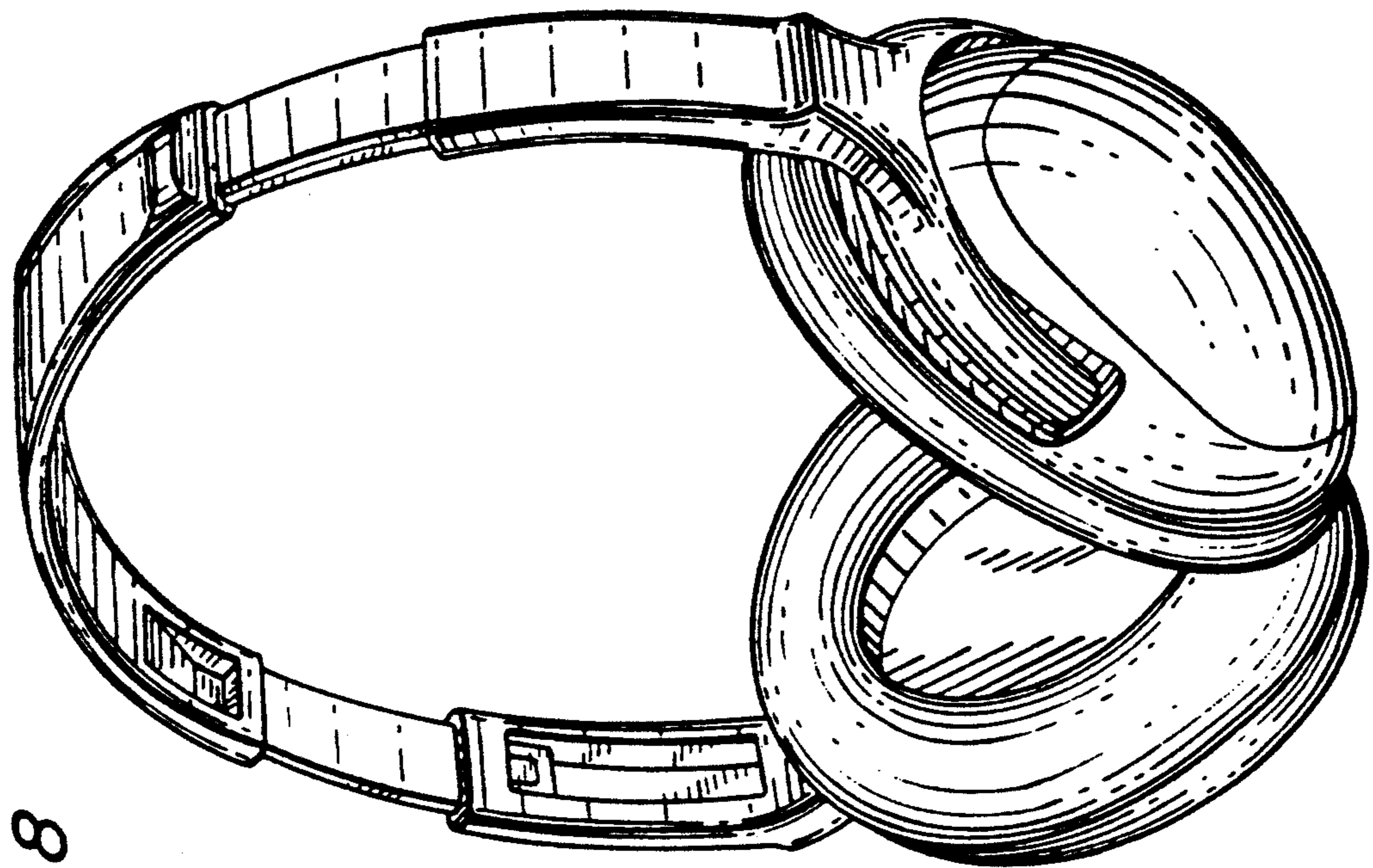

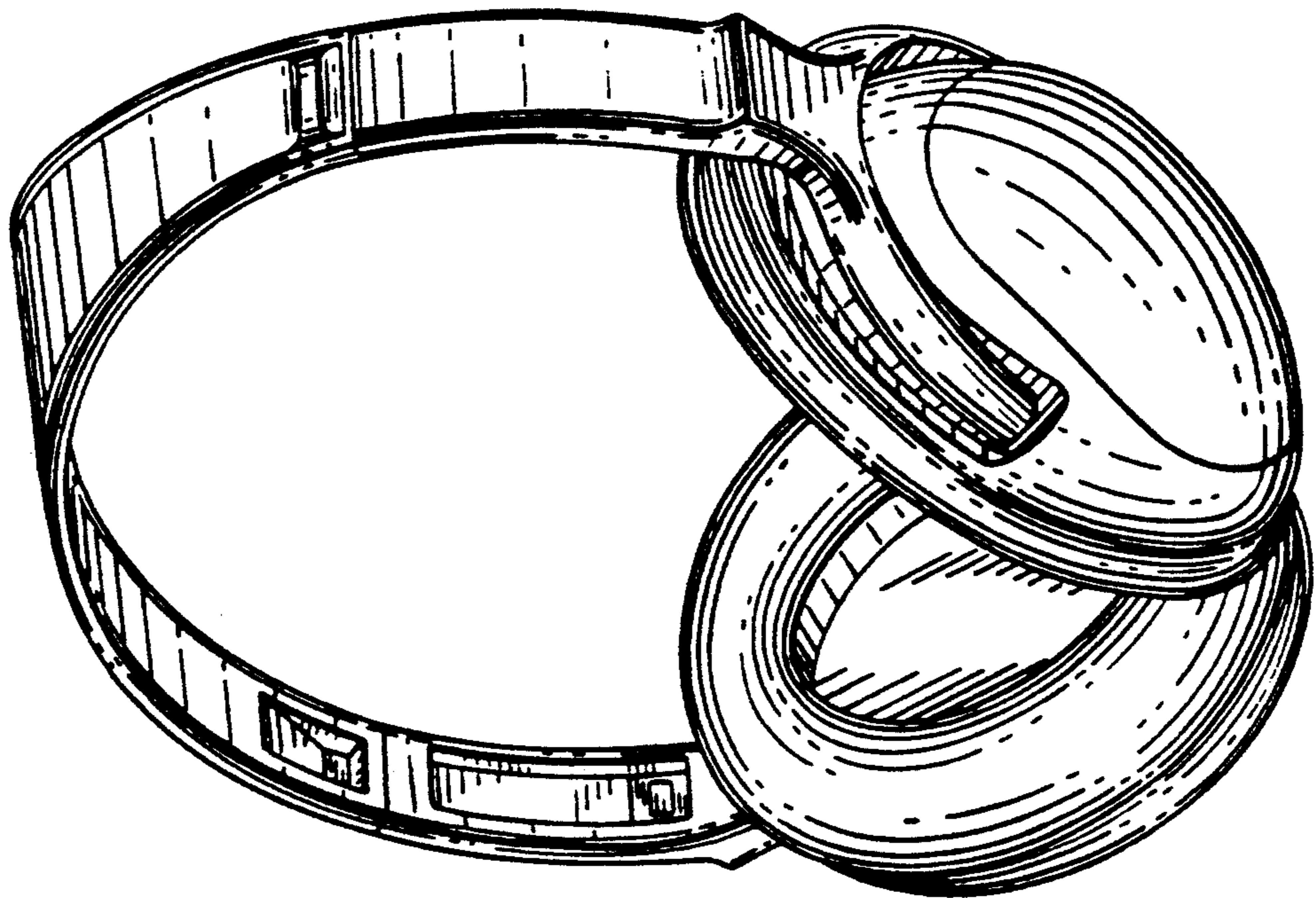
