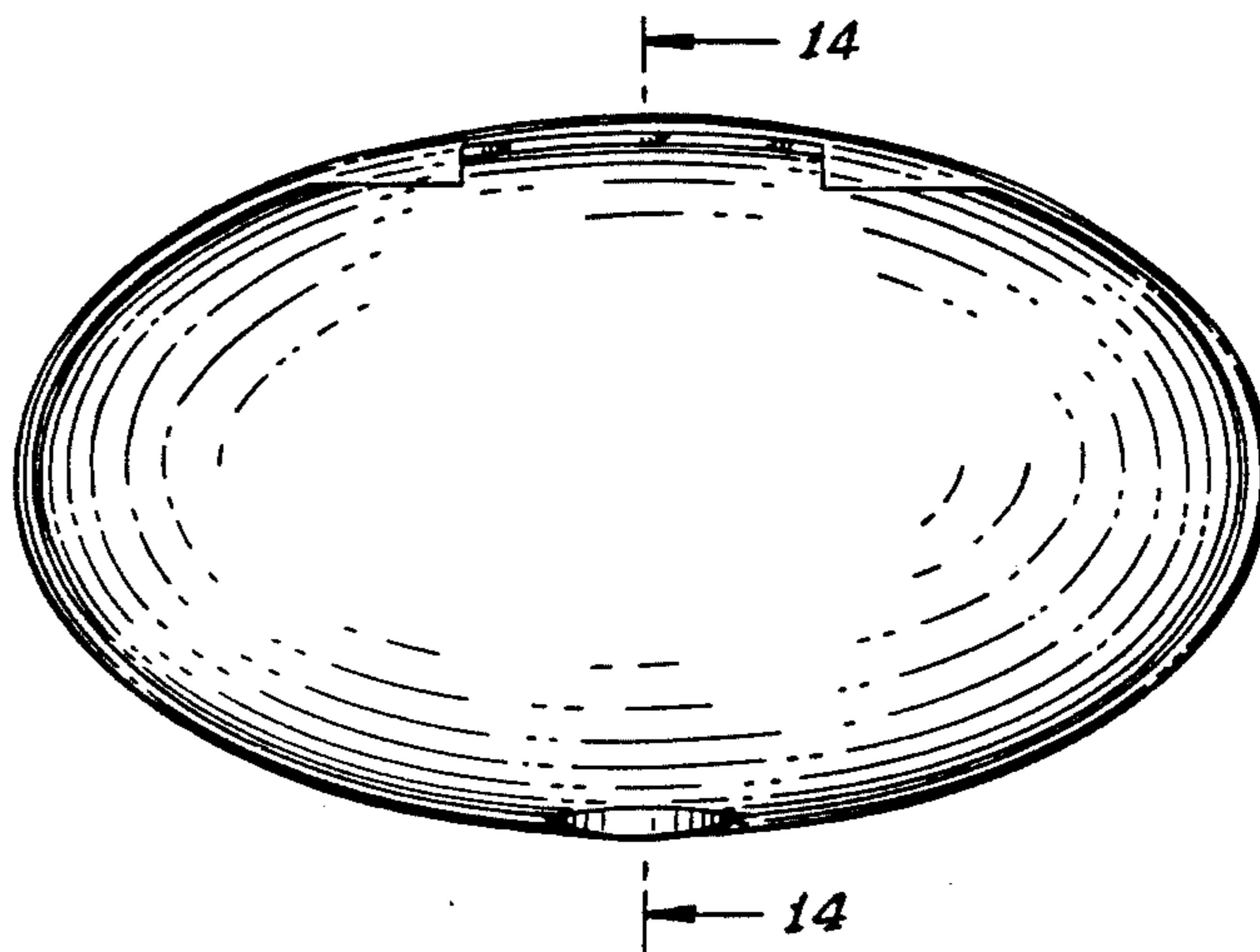
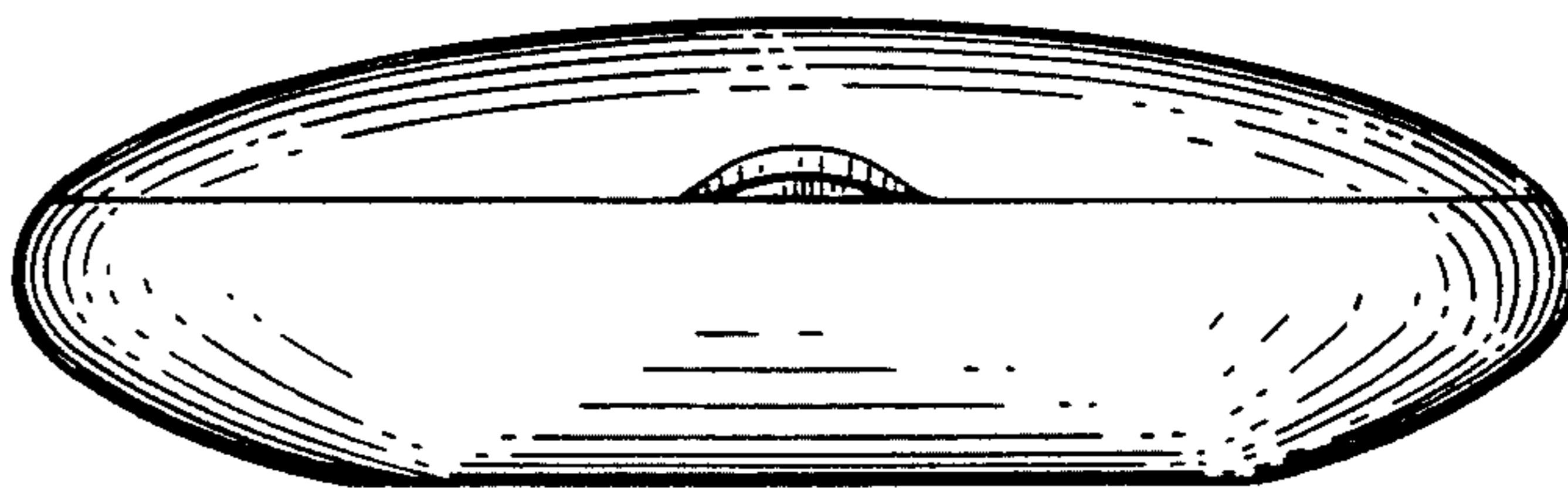
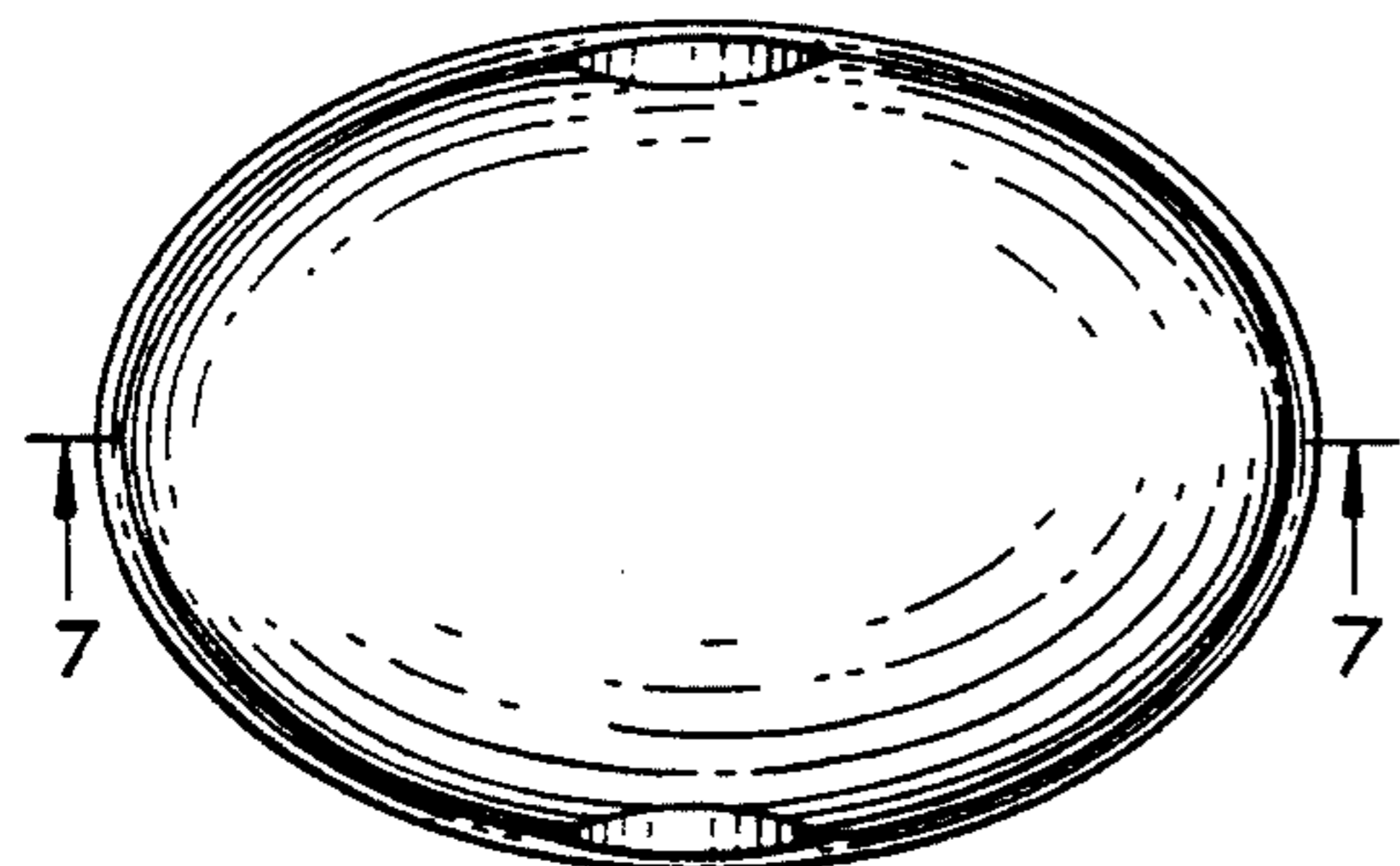

[57] CLAIM

The ornamental design for a cosmetic receptacle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a cosmetic receptacle showing our new design as embodied in a soap receptacle; FIG. 2 is a bottom plan view thereof; FIG. 3 is a front elevational view thereof, the side opposite being identical to the side shown; FIG. 4 is a right side elevational view thereof, the side opposite being identical to the side shown; FIG. 5 is a bottom plan view of the lid element, shown separately for clarity of illustration; FIG. 6 is a top plan view of the base portion of the container, shown separately for clarity of illustration; FIG. 7 is an exploded cross sectional view taken along line 7—7 of FIG. 7; FIG. 8 is a front elevational view showing my new design embodied in a cosmetic receptacle; FIG. 9 is a rear elevational view thereof; FIG. 10 is a top plan view of the lid element, shown separately for clarity of illustration; FIG. 11 is a front elevational view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a top plan view of FIG. 8; FIG. 14 is a cross sectional view taken along line 14—14 of FIG. 14; FIG. 15 is a bottom plan view of the assembled article; FIG. 16 is a right side elevational view thereof, the side opposite being a mirror image of the side shown; and, FIG. 17 is an exploded rear elevational view thereof.



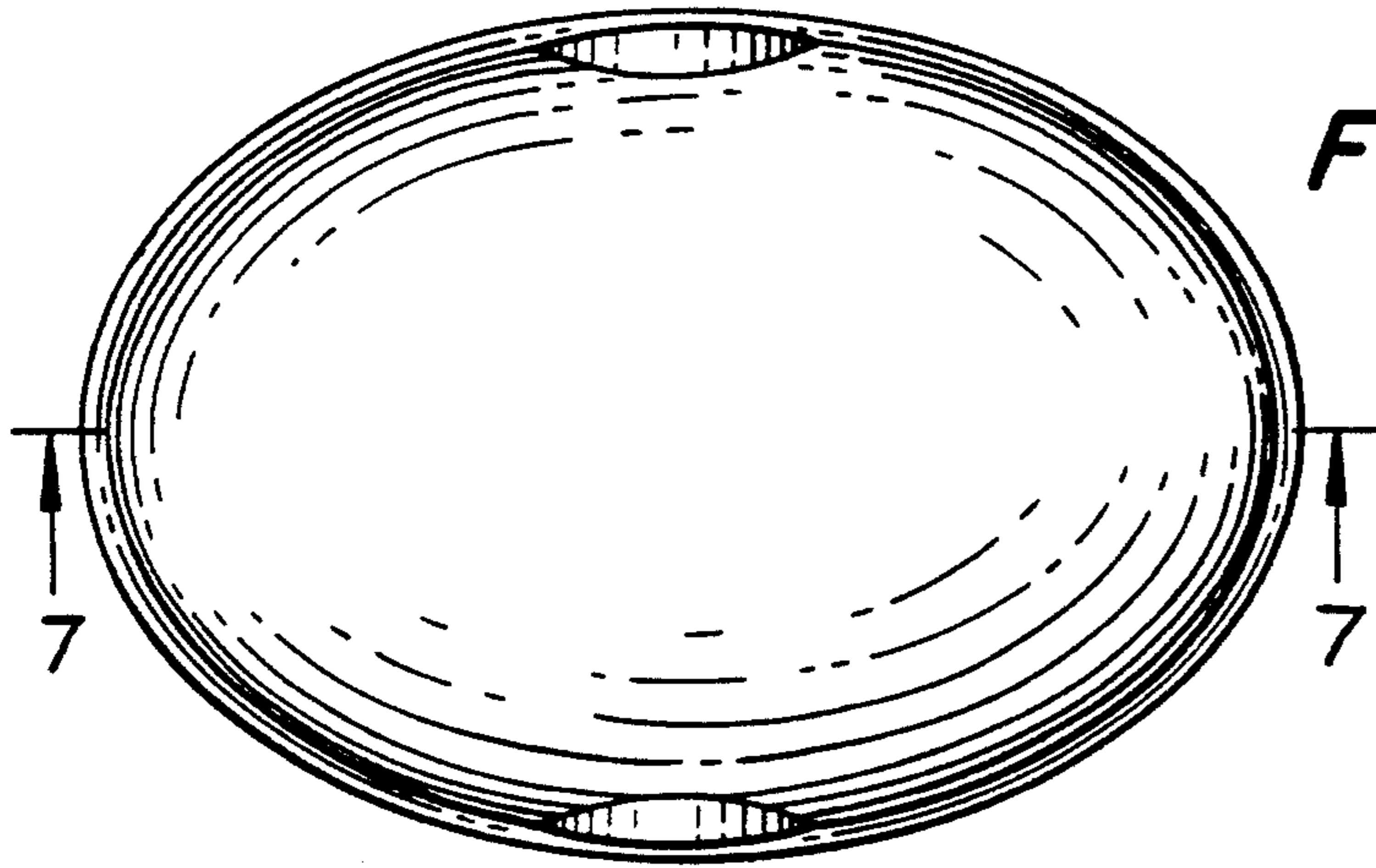

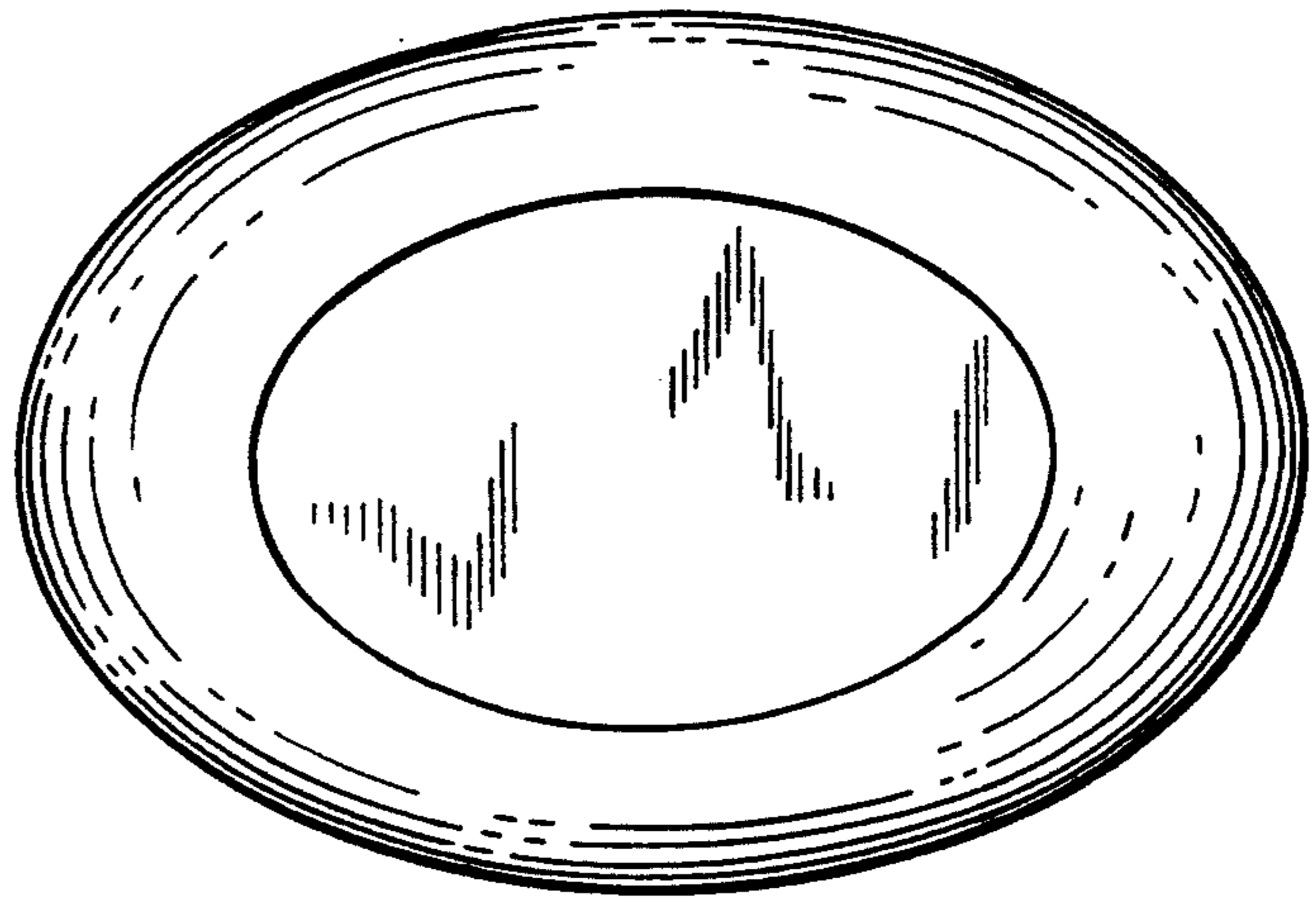

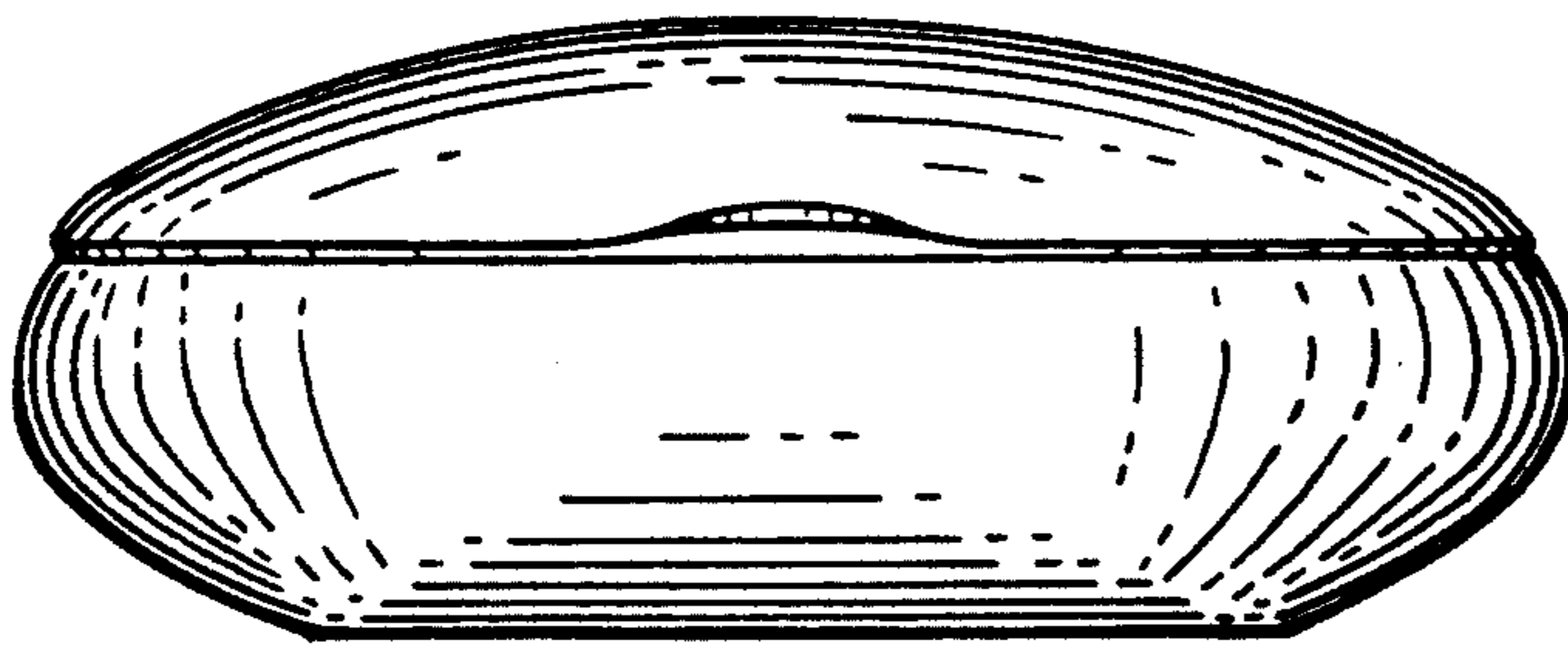

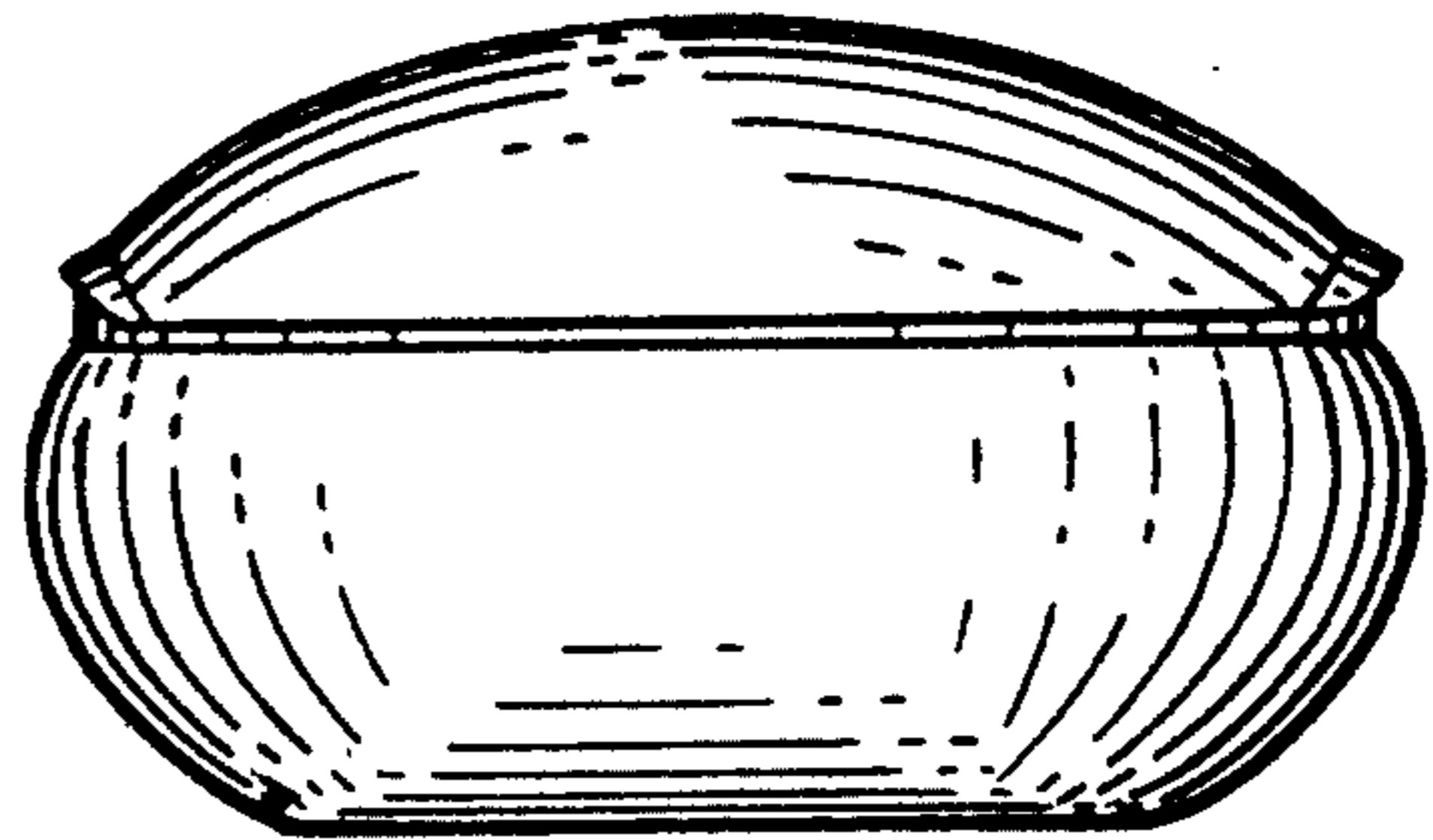

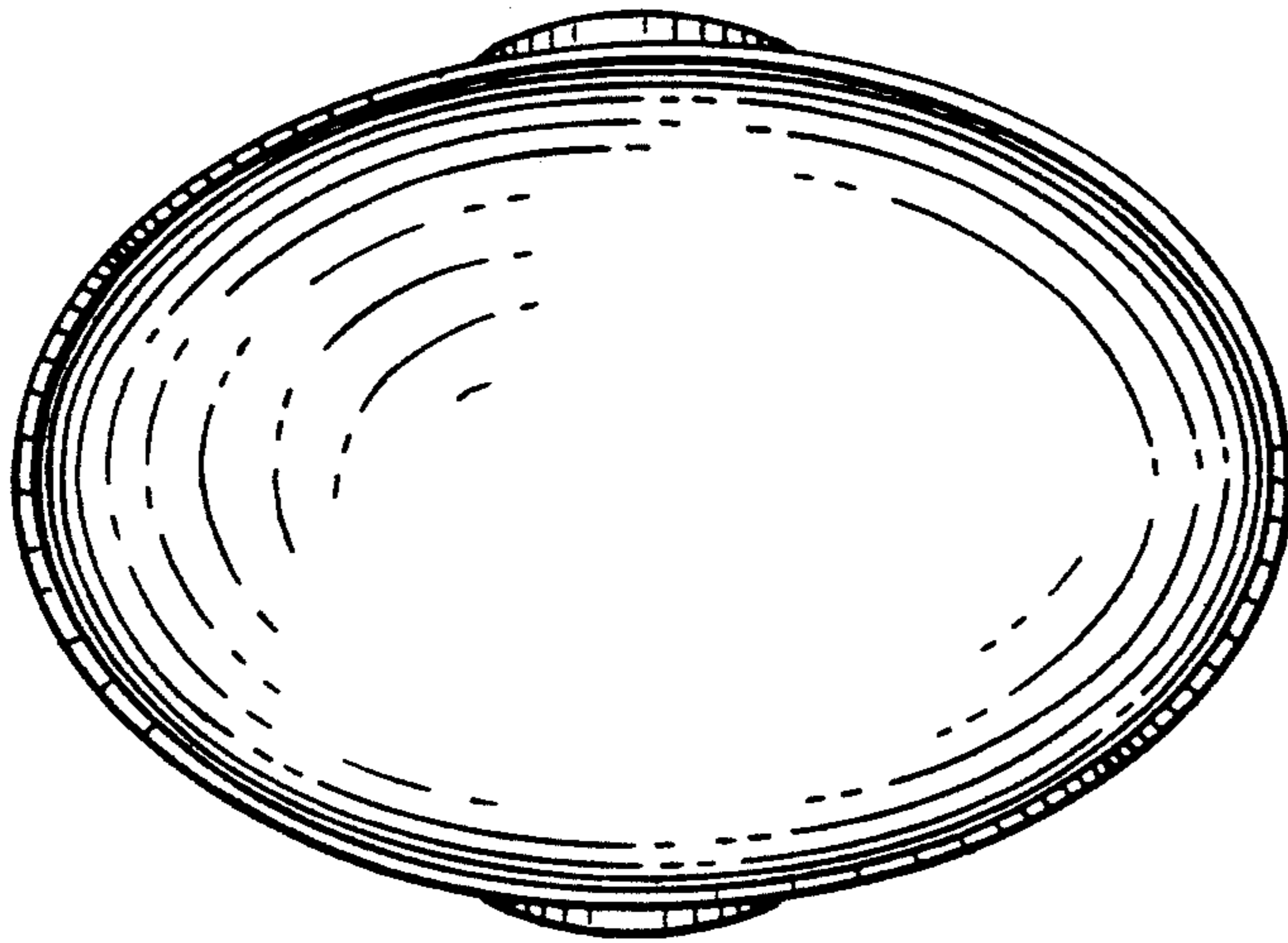

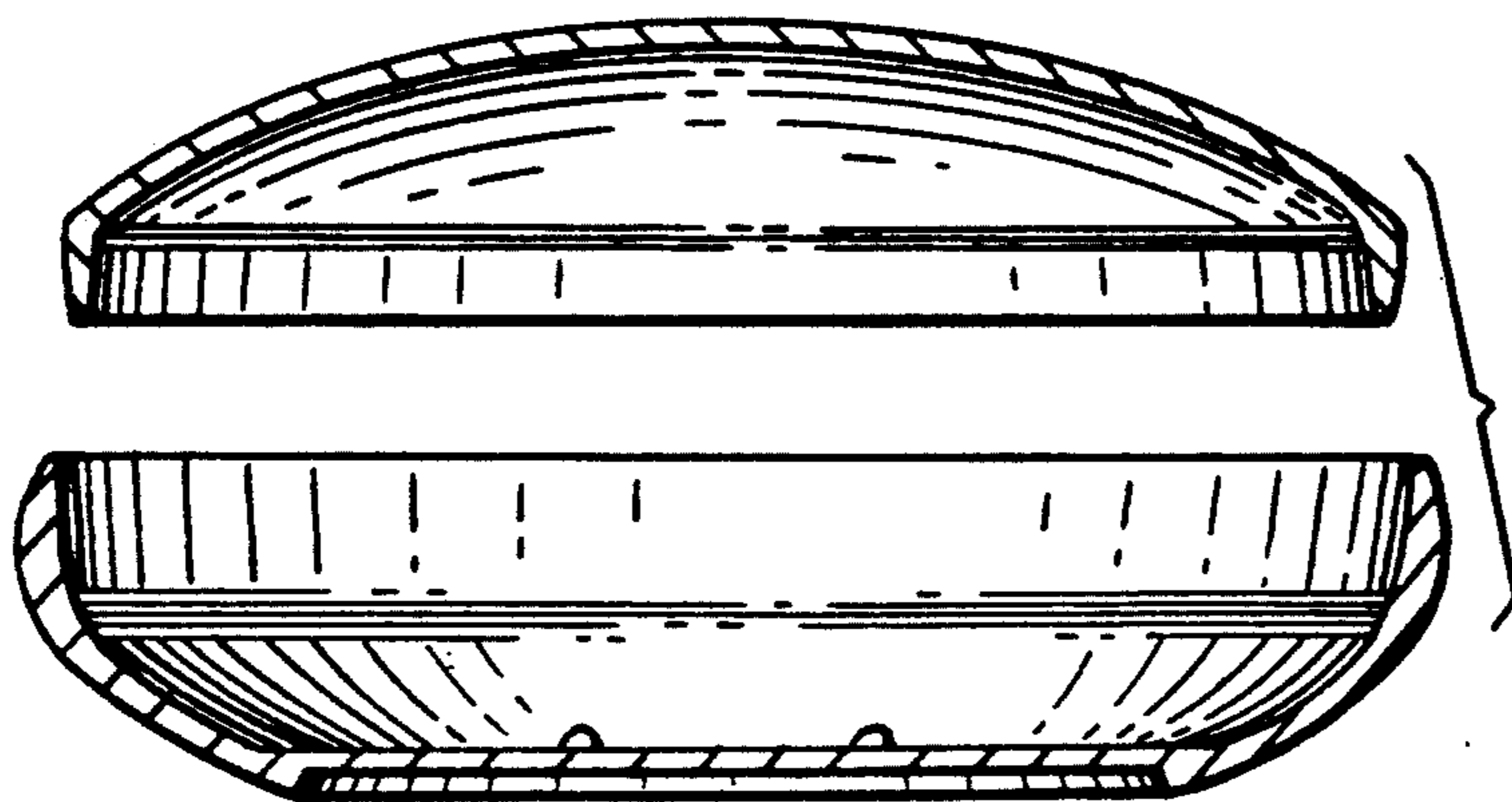
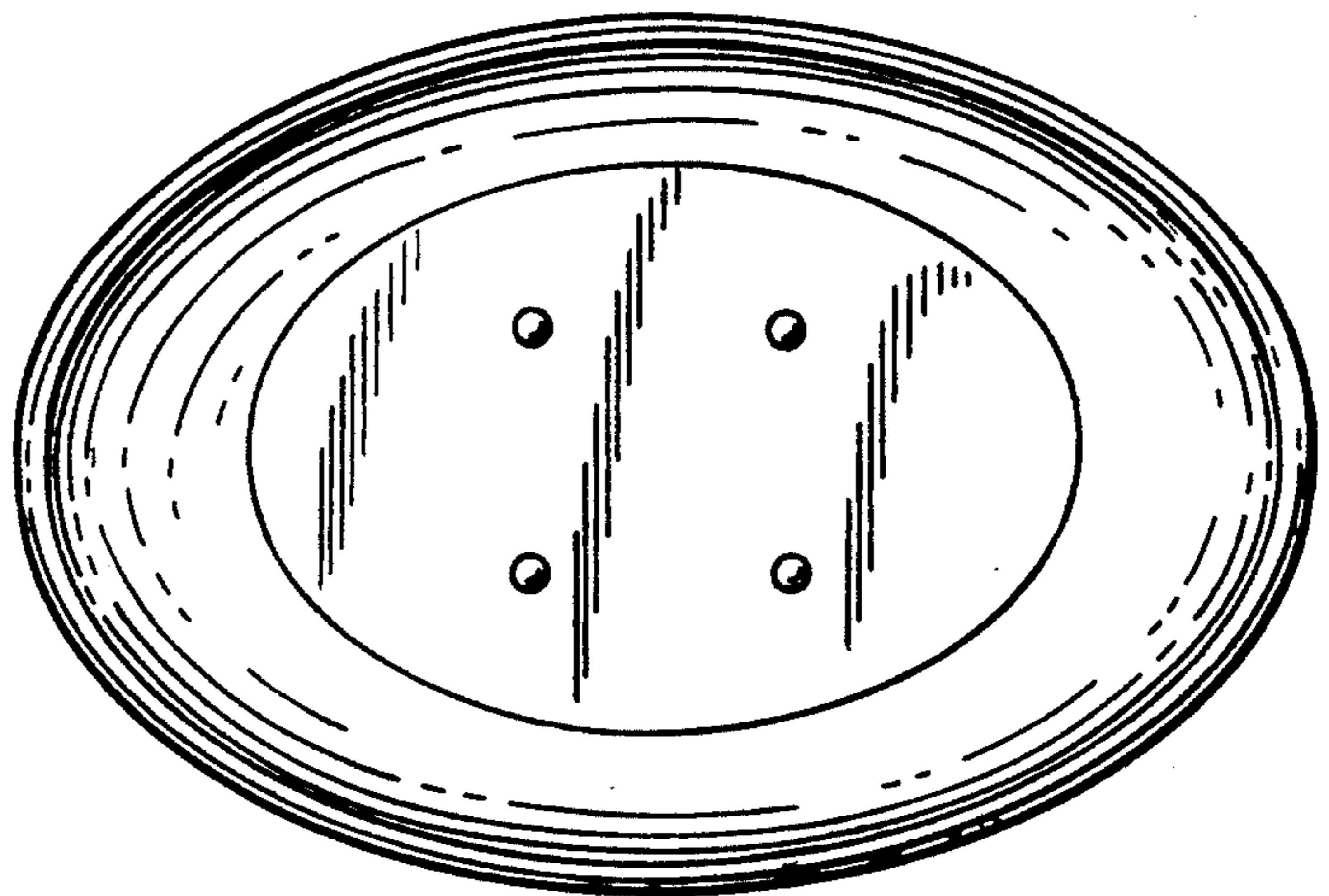

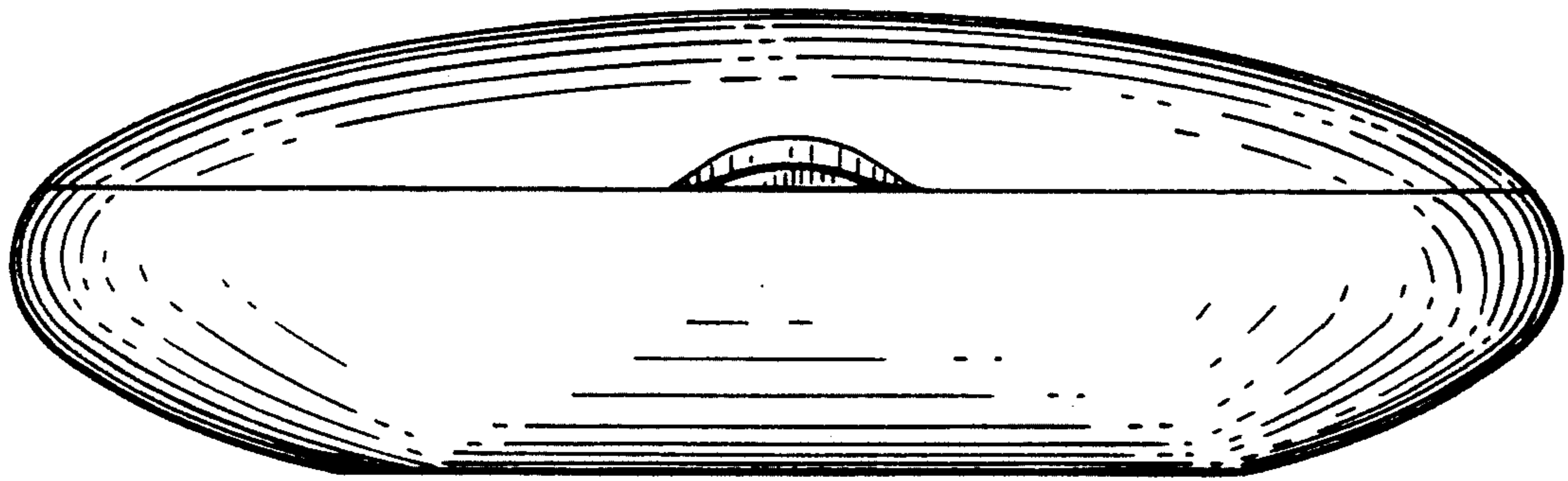

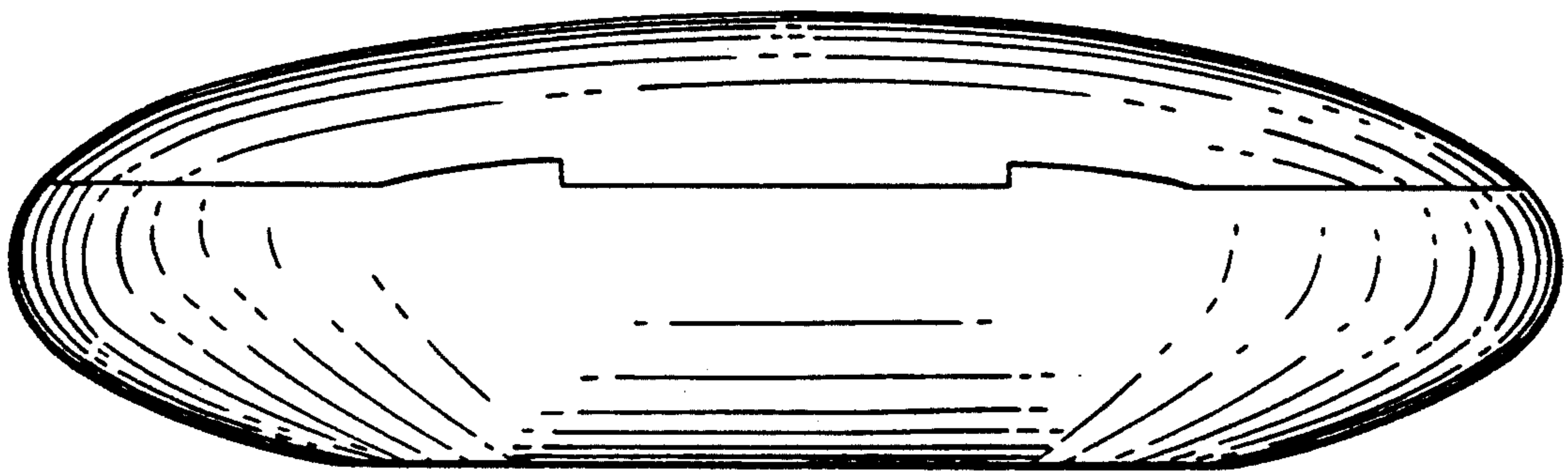

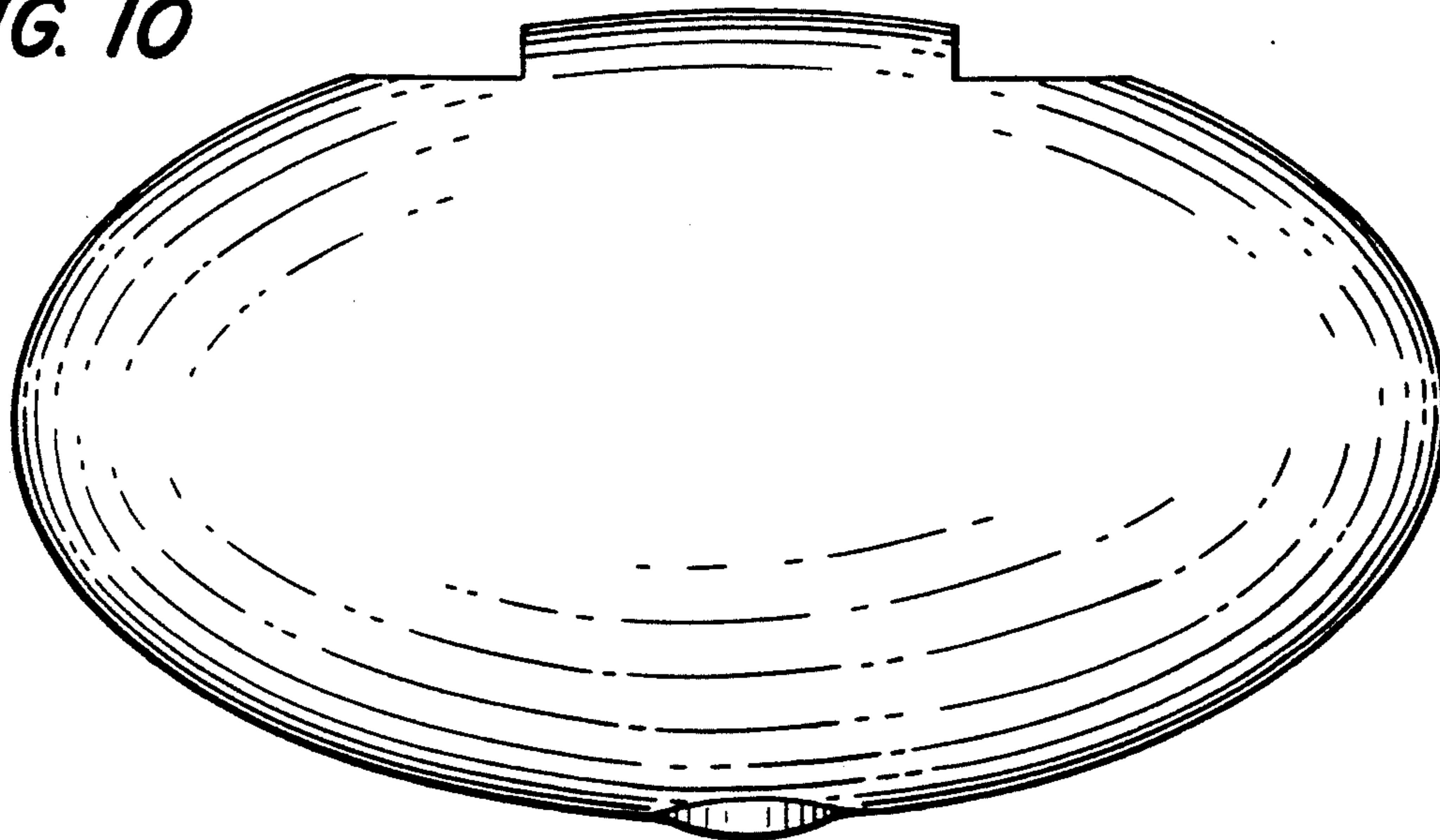

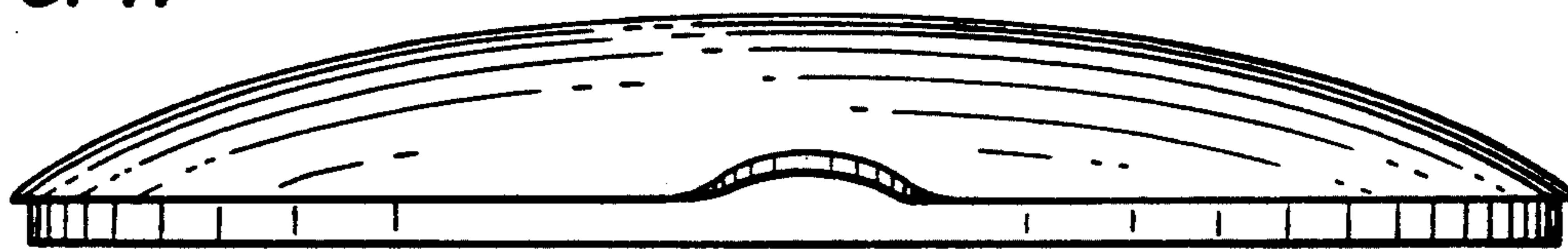
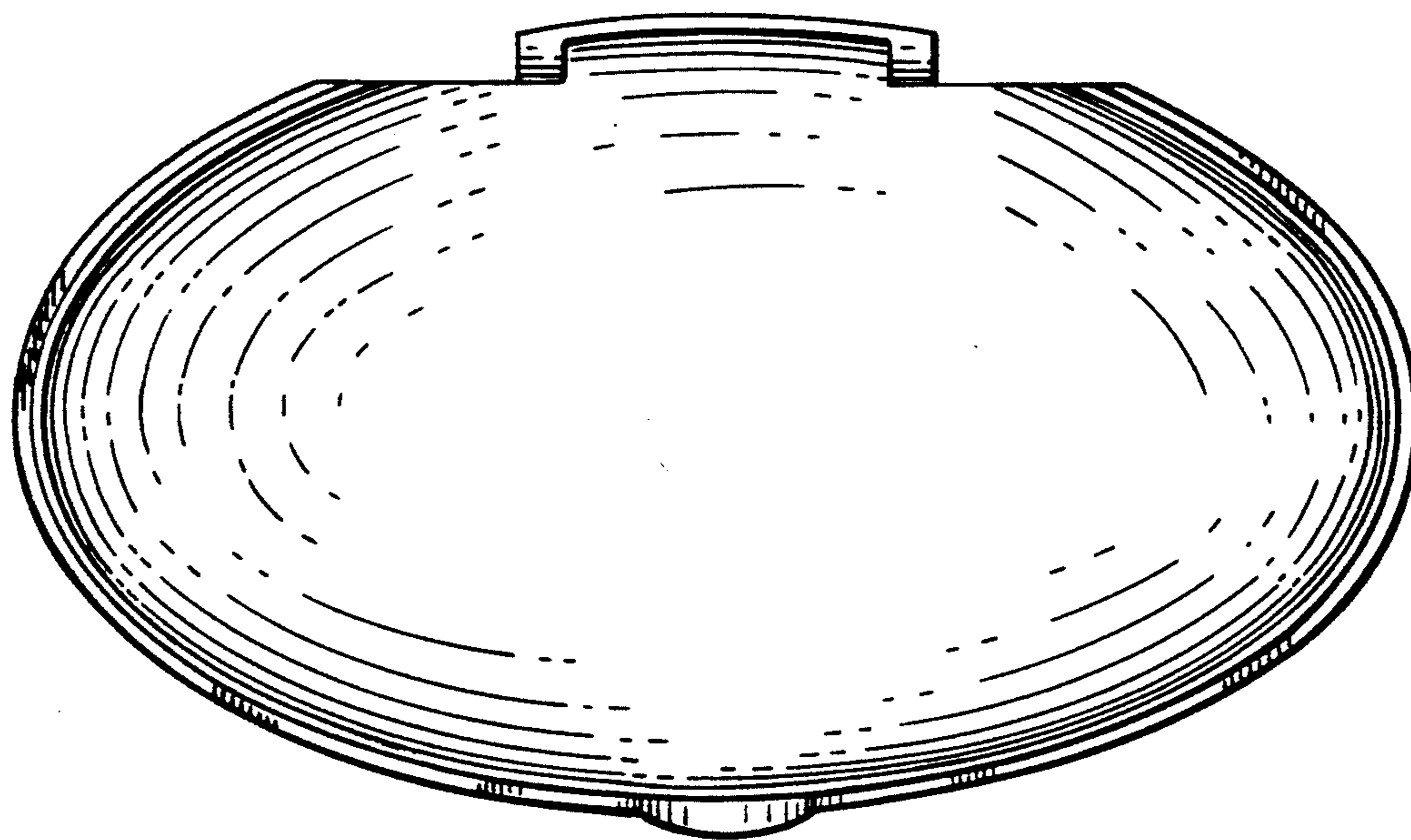

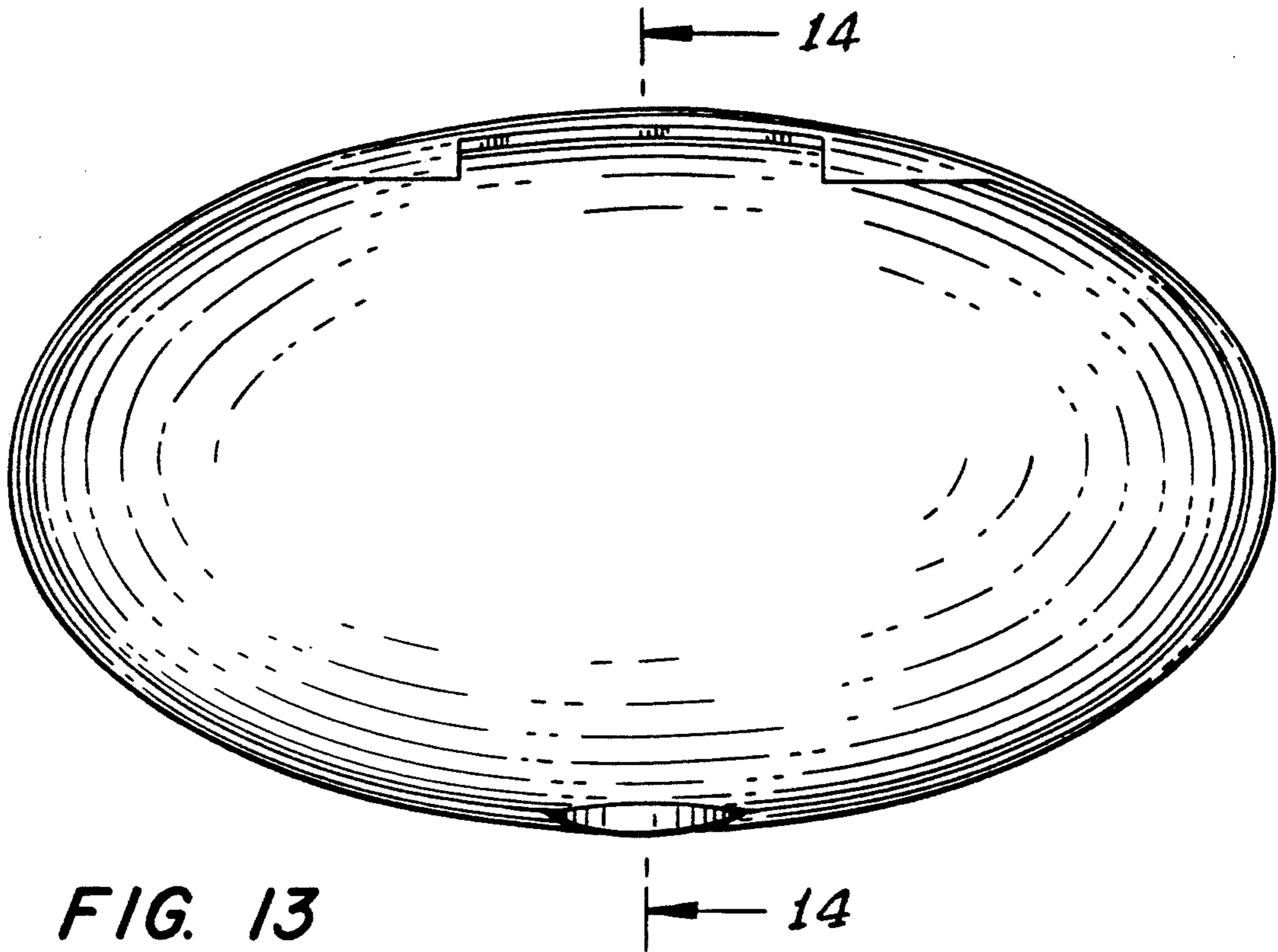
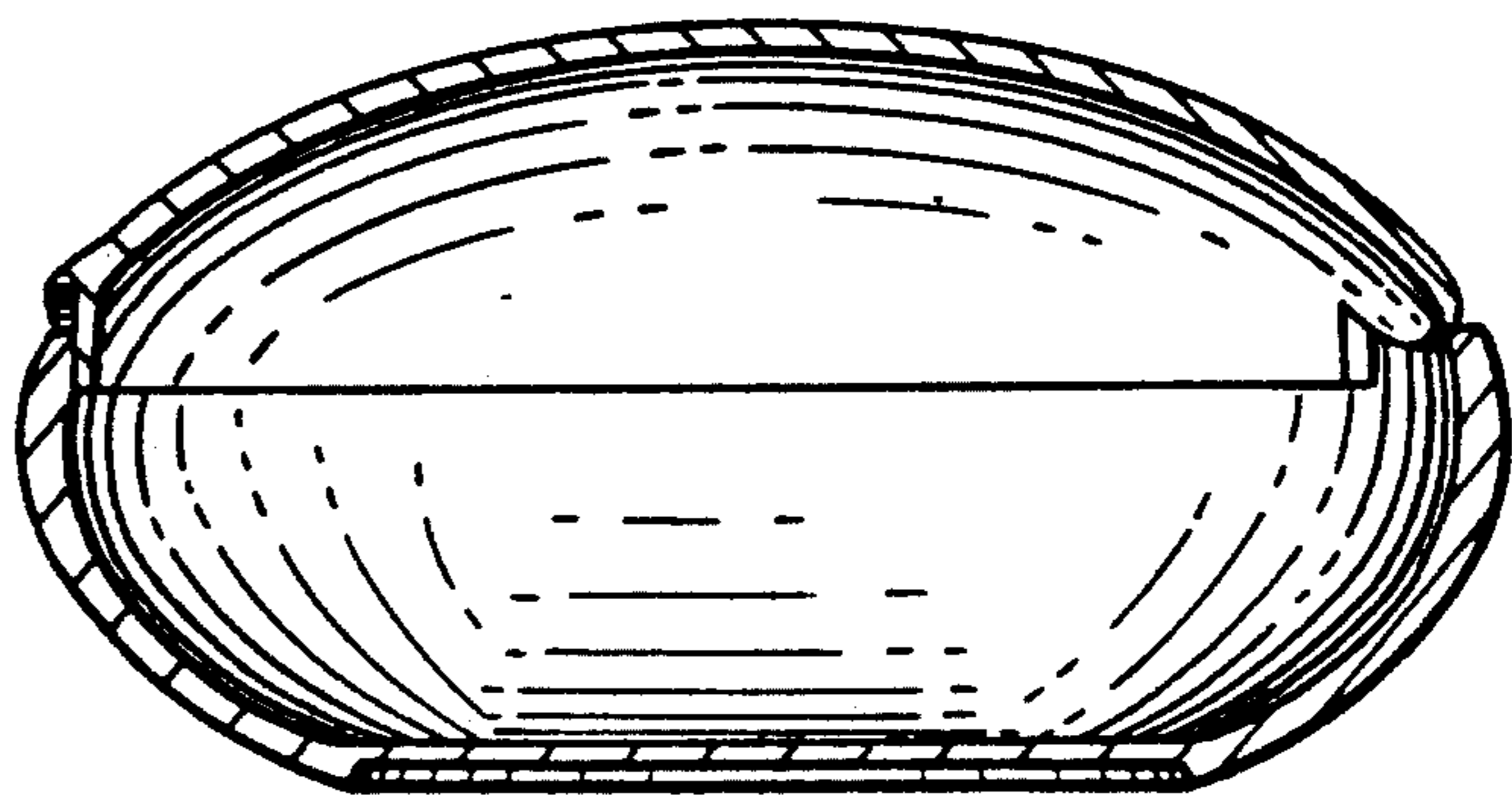

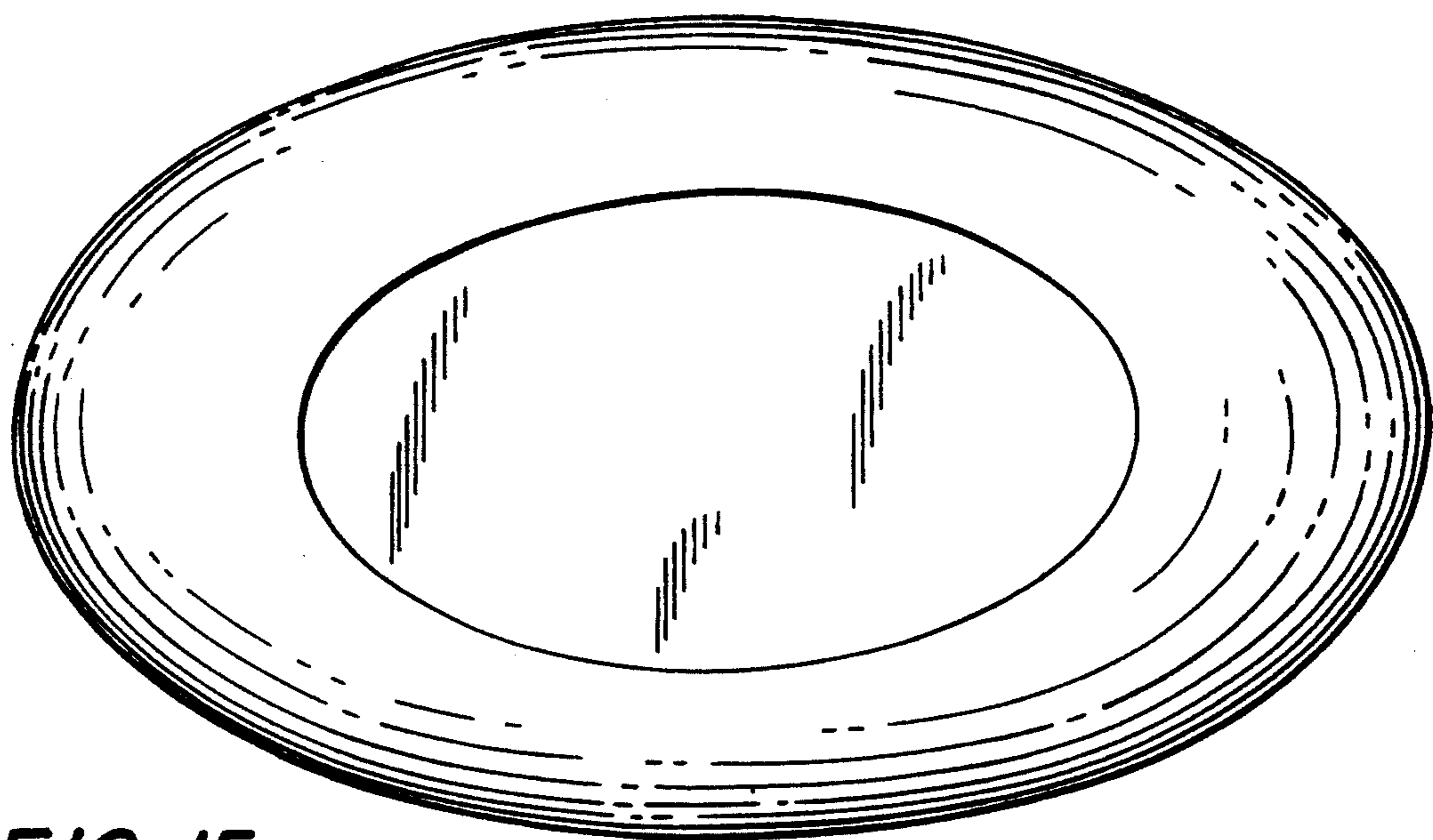

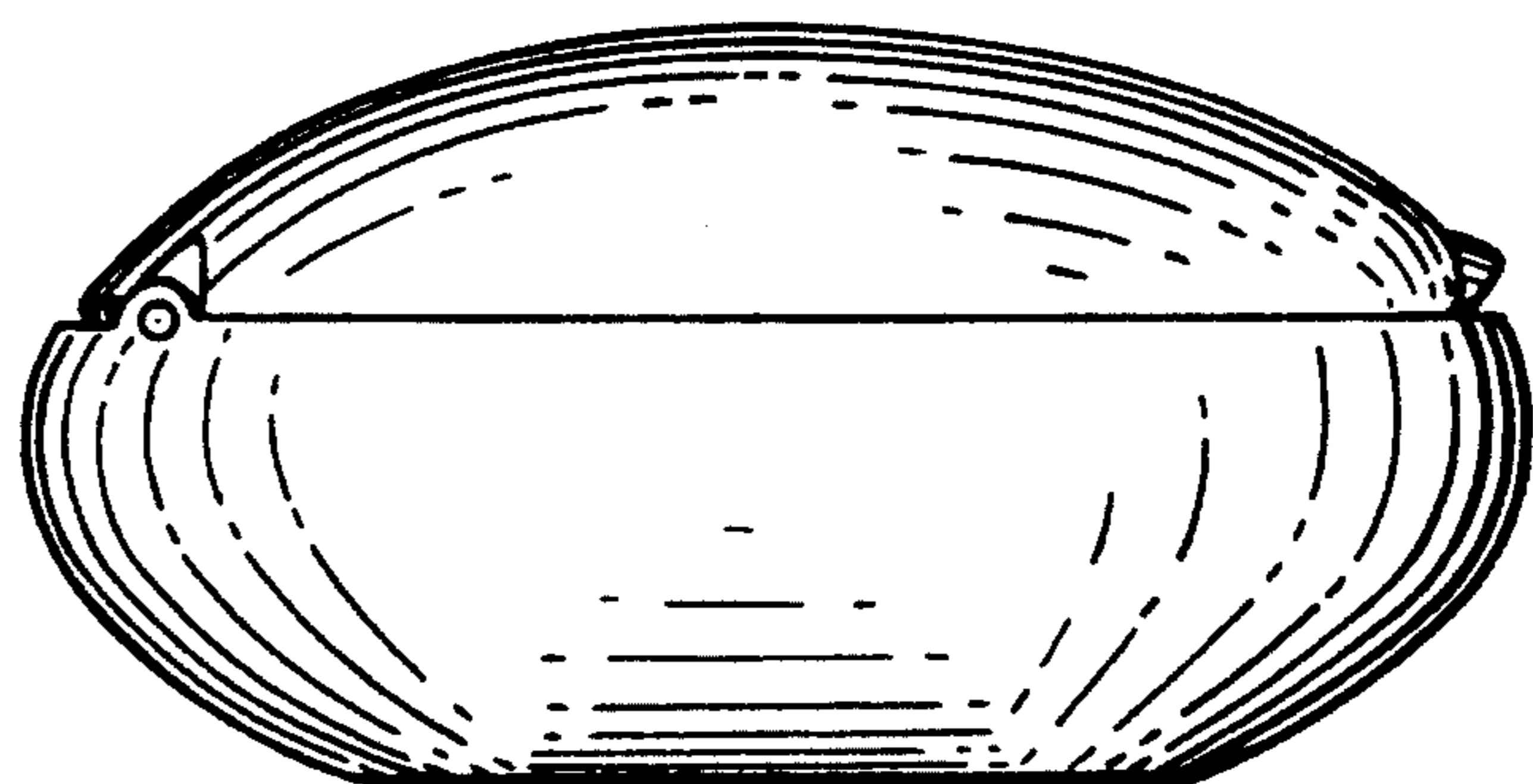

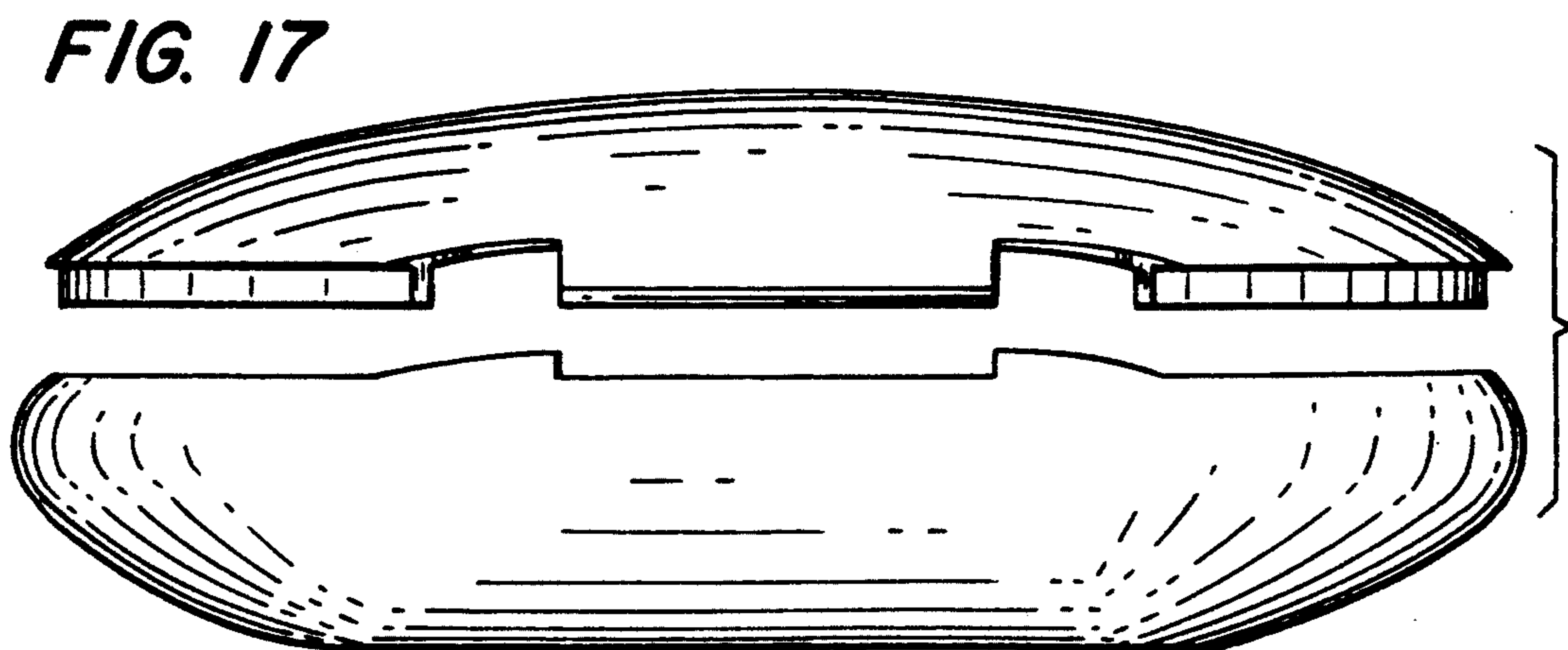
