embodiment of my design for a chair.

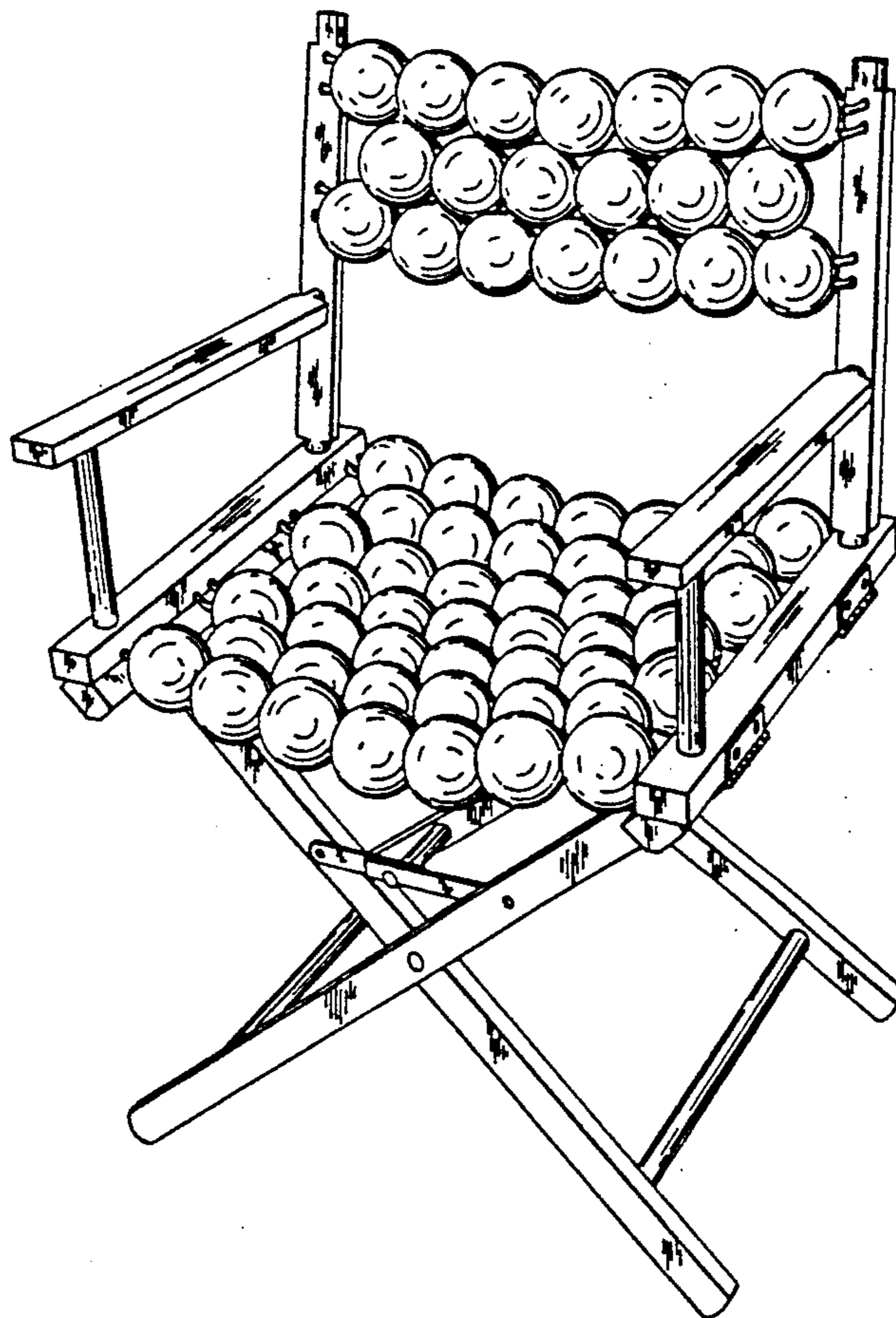

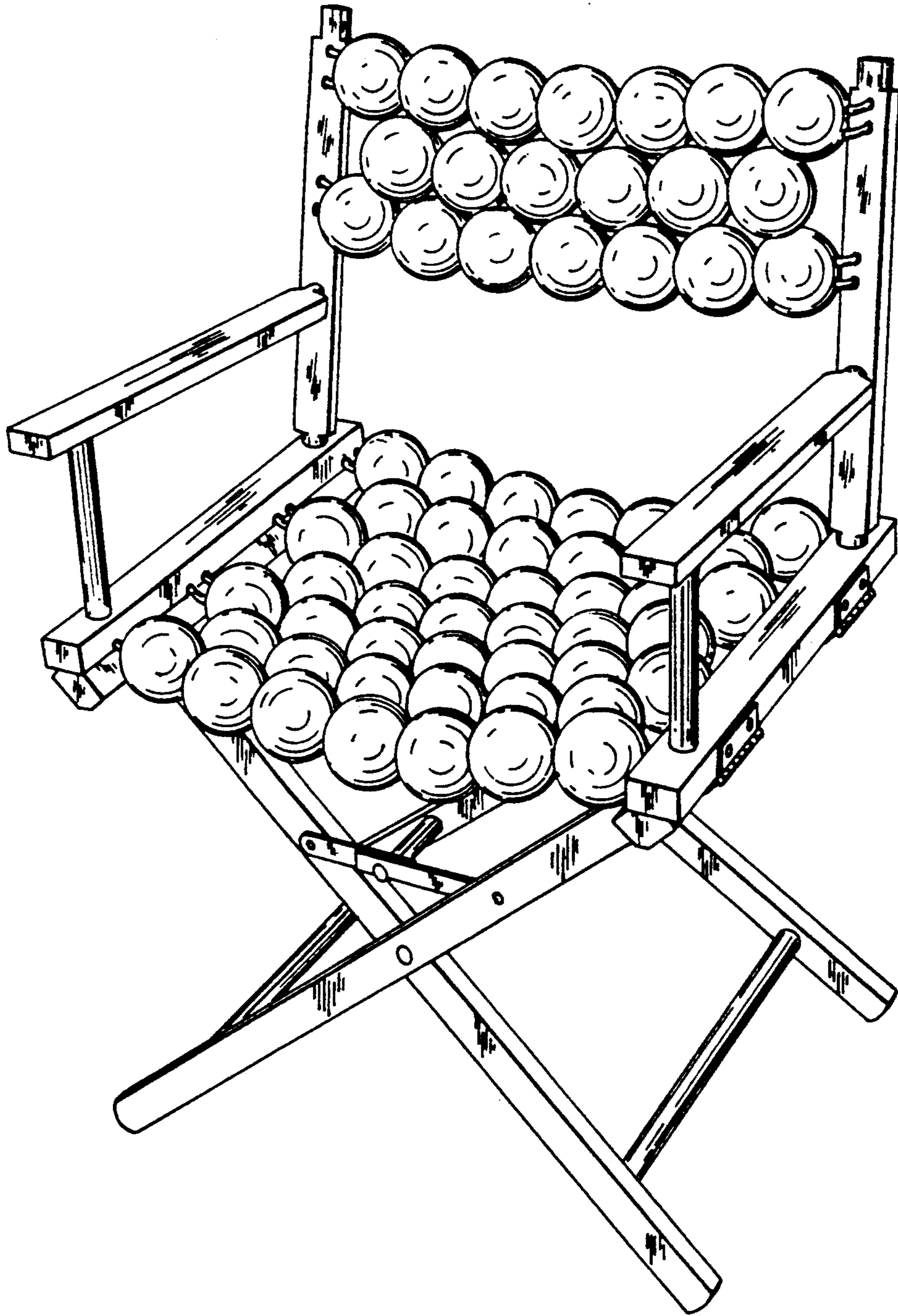

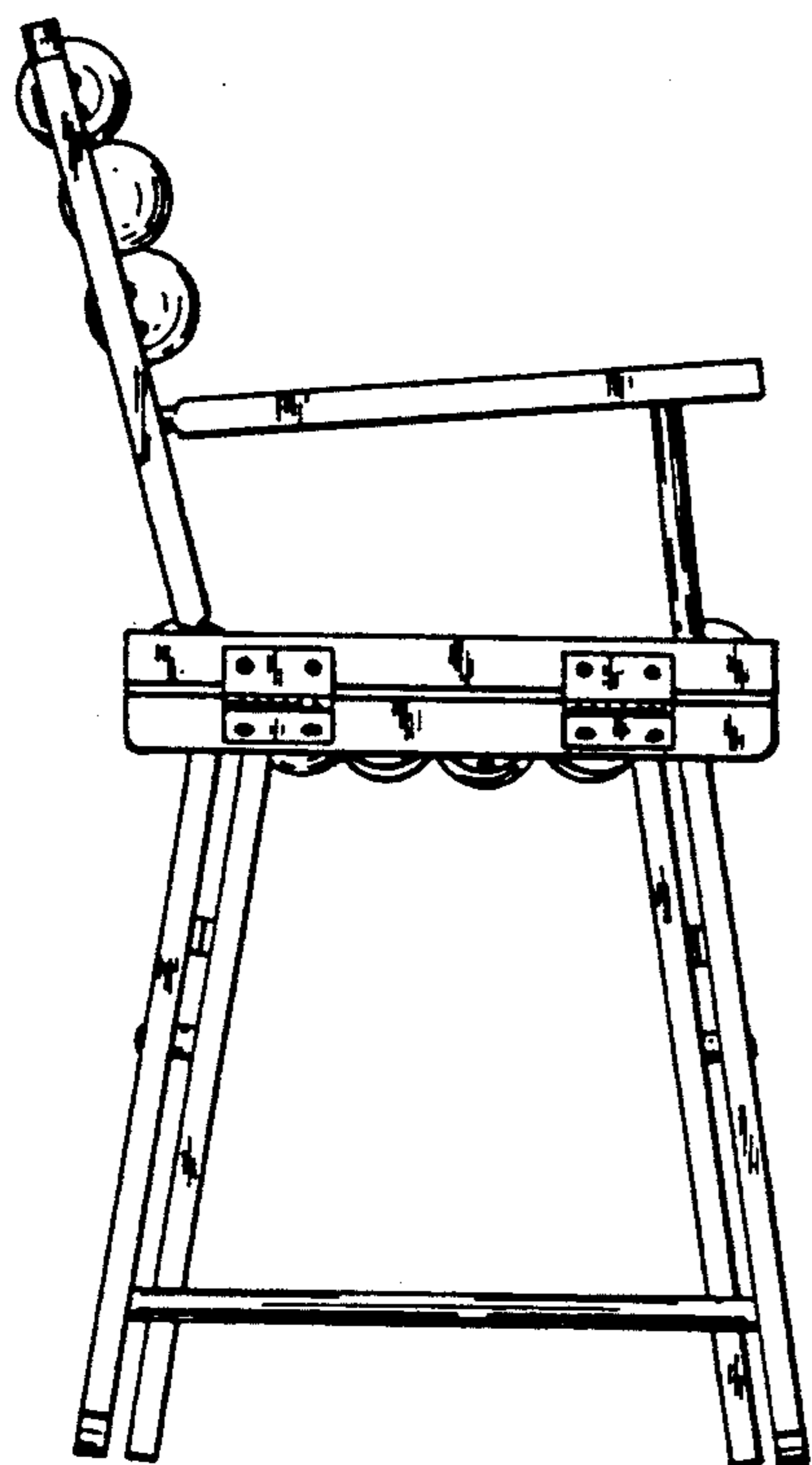

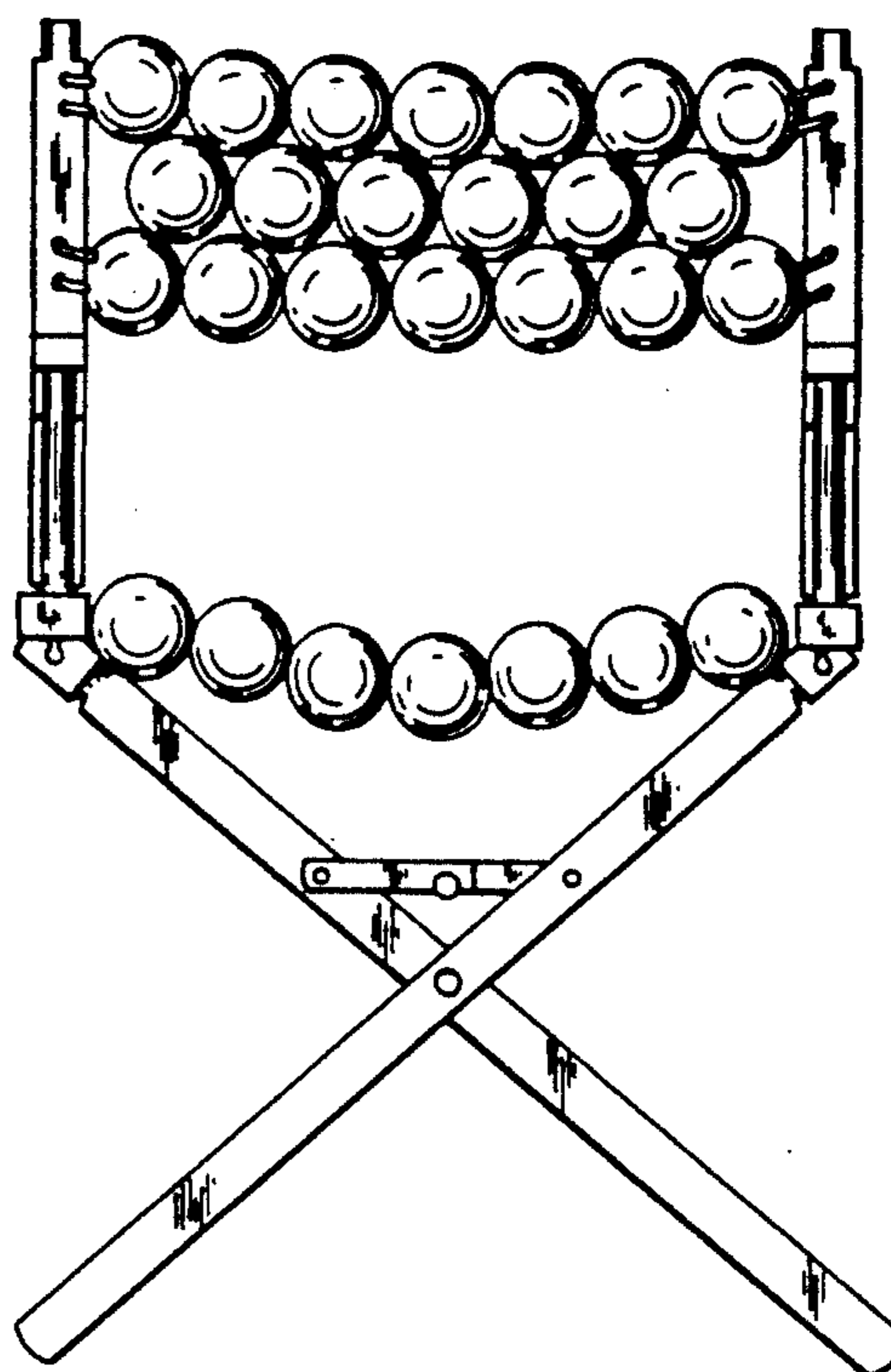

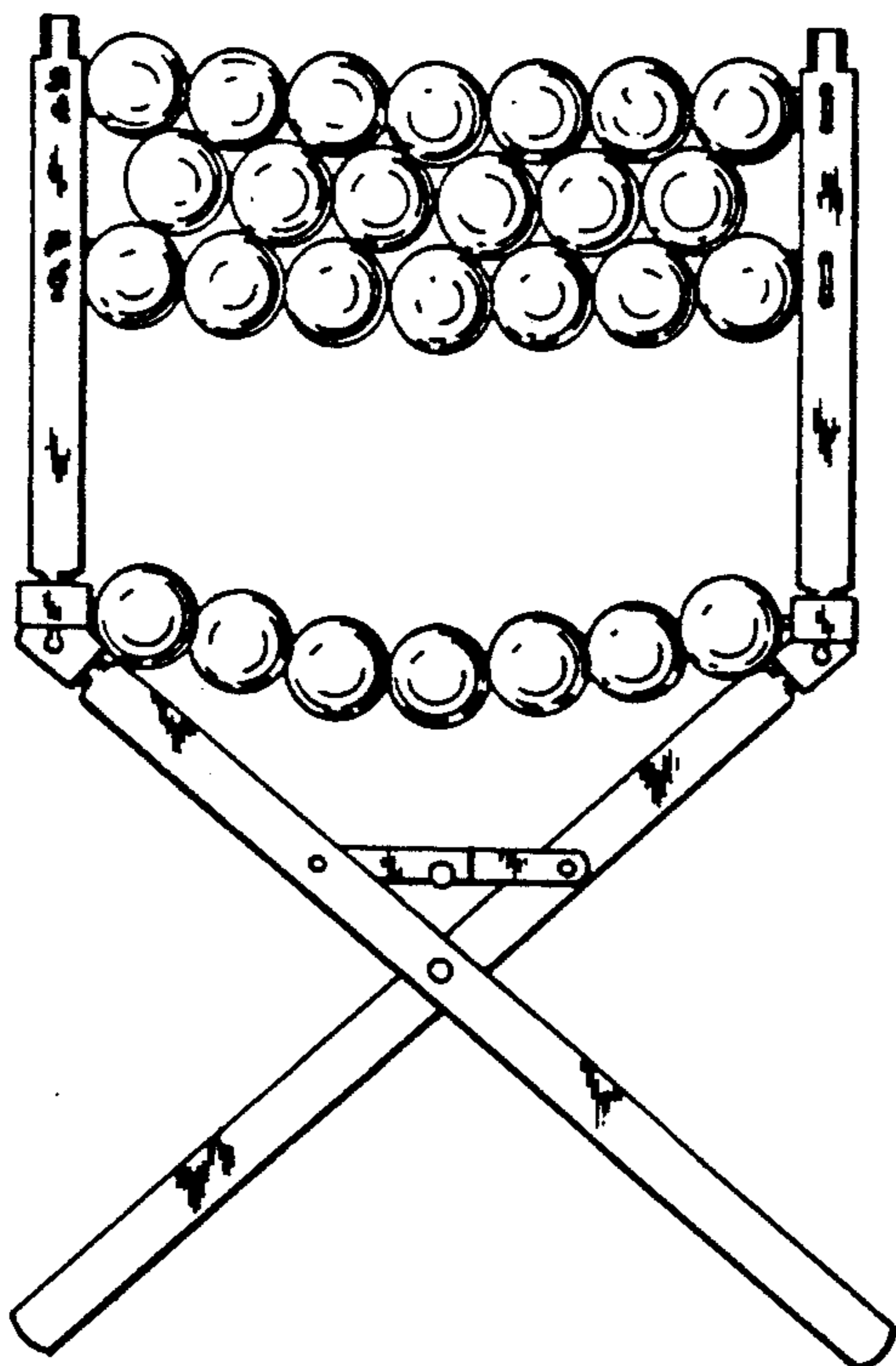

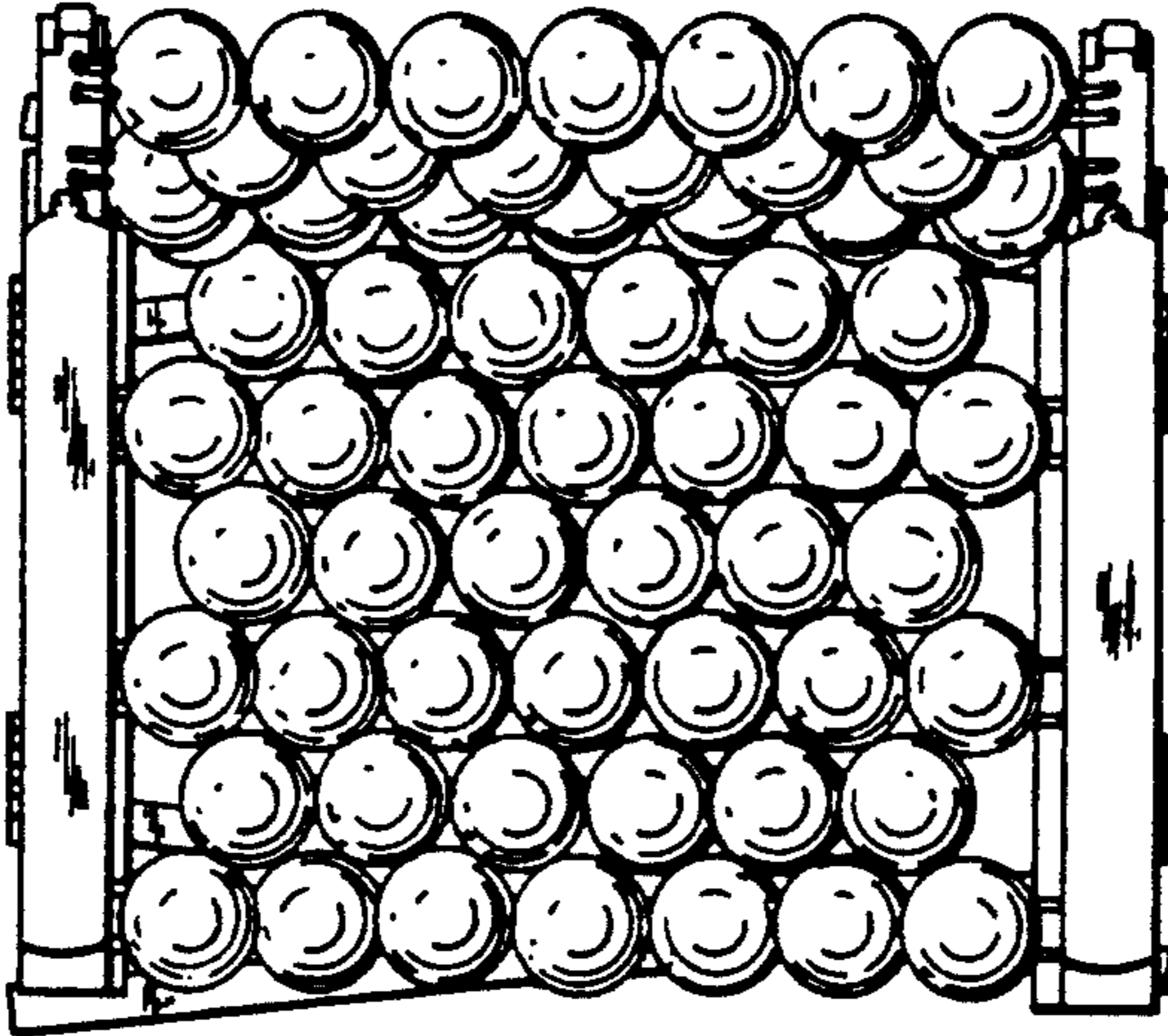

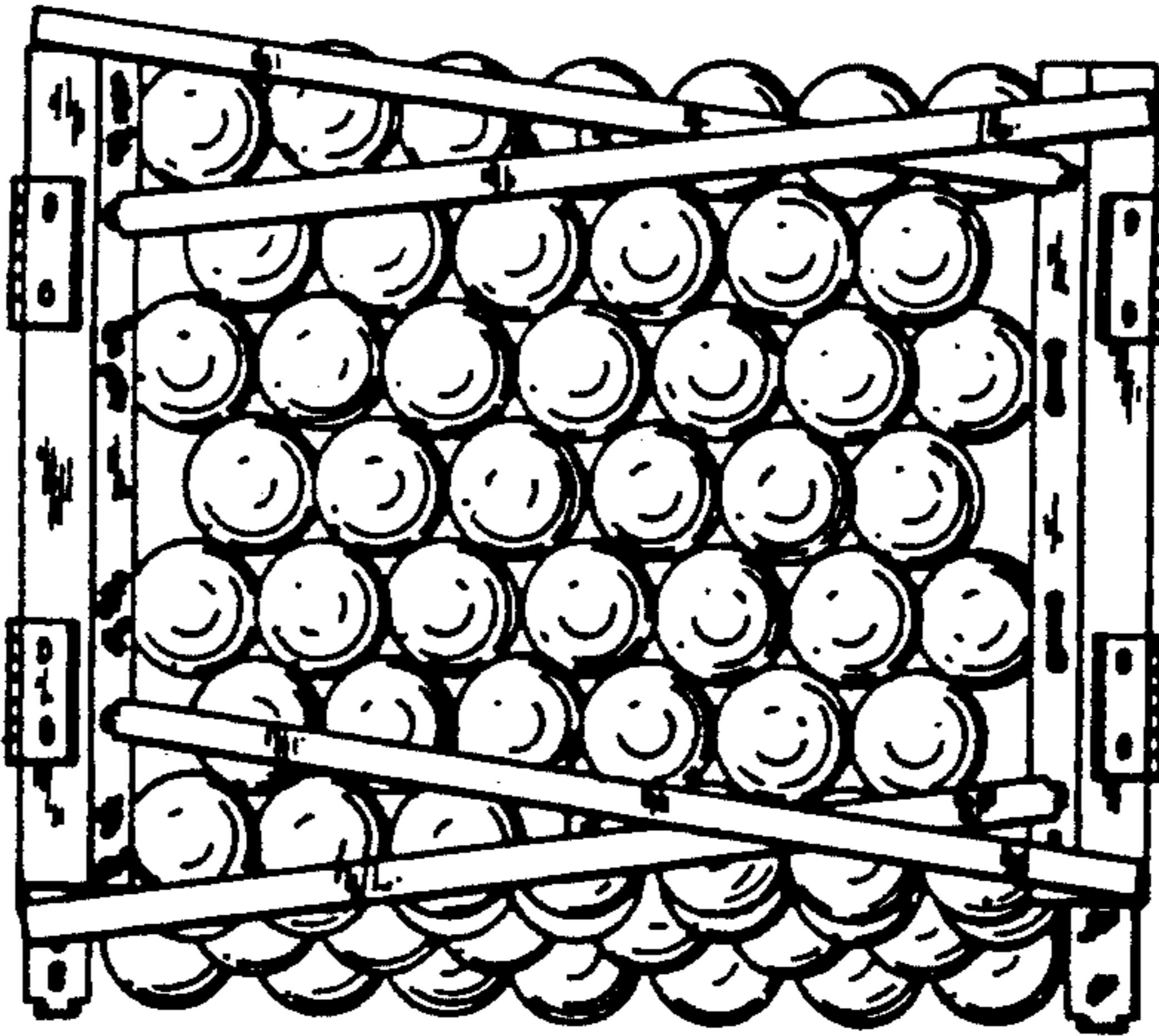
