[57] **CLAIM**

The ornamental design for a lavatory, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and left side of a lavatory showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side being a mirror image of the left side;

FIG. 5 is a cross-sectional view taken on line 5—5 of FIG. 2; and,

FIG. 6 is a cross-sectional view taken on line 6—6 of FIG. 2.

The broken line representations of fitting mounting holes in FIGS. 1, 2 and 5 are for the purpose of illustration only and form no part of the claimed design.

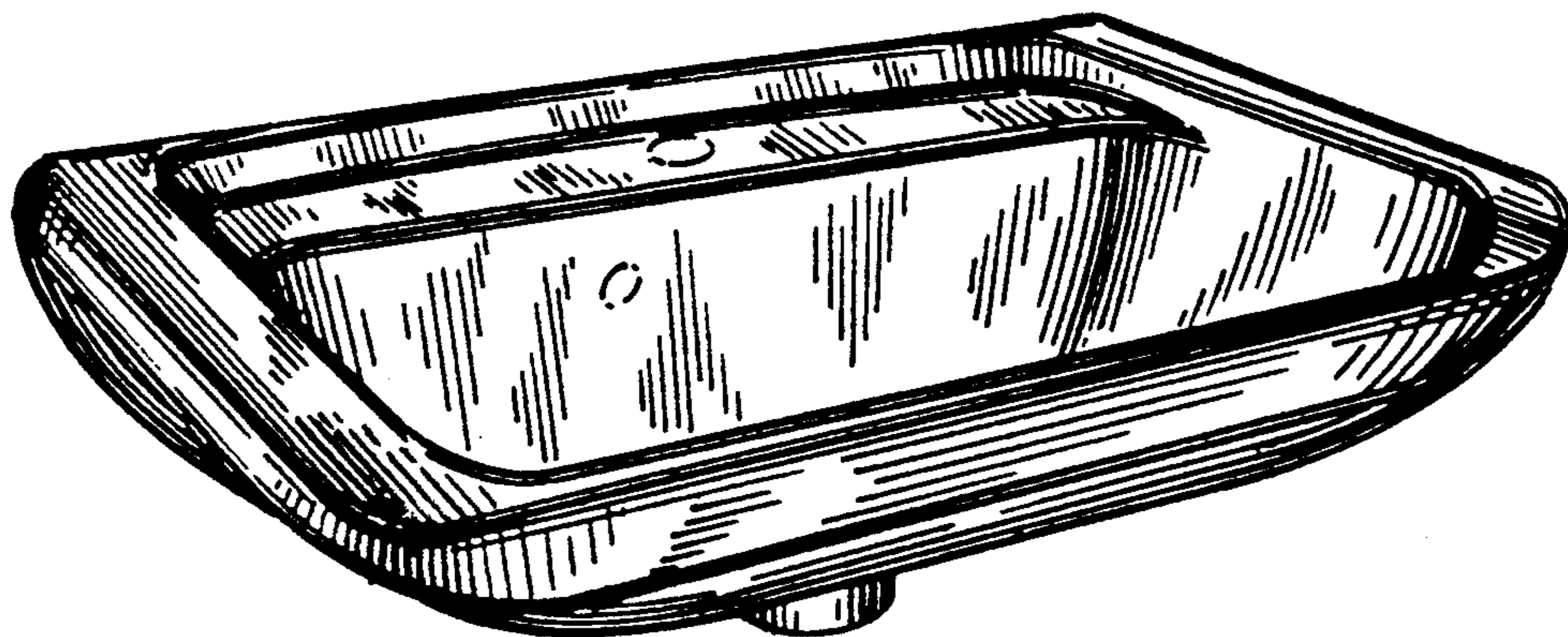

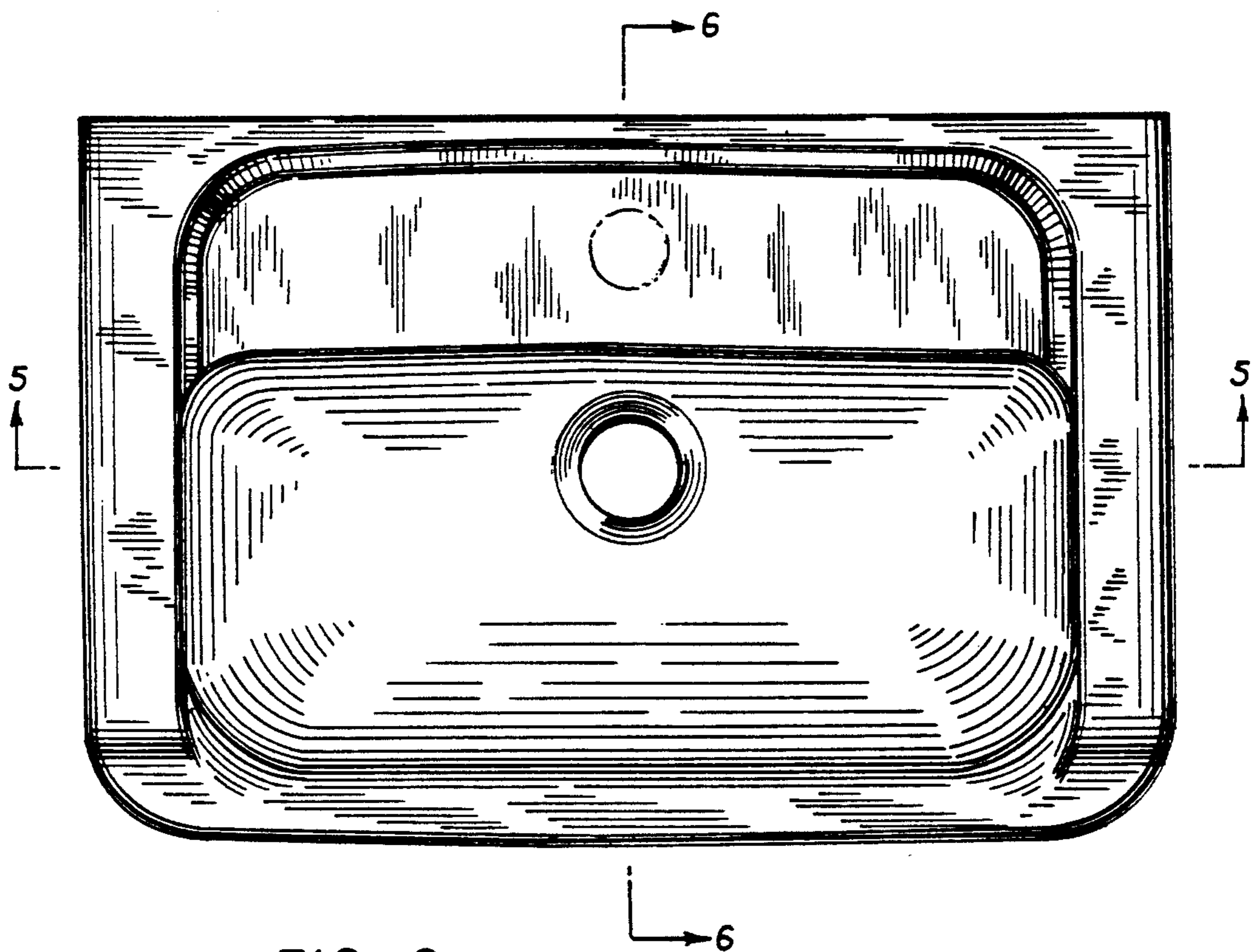
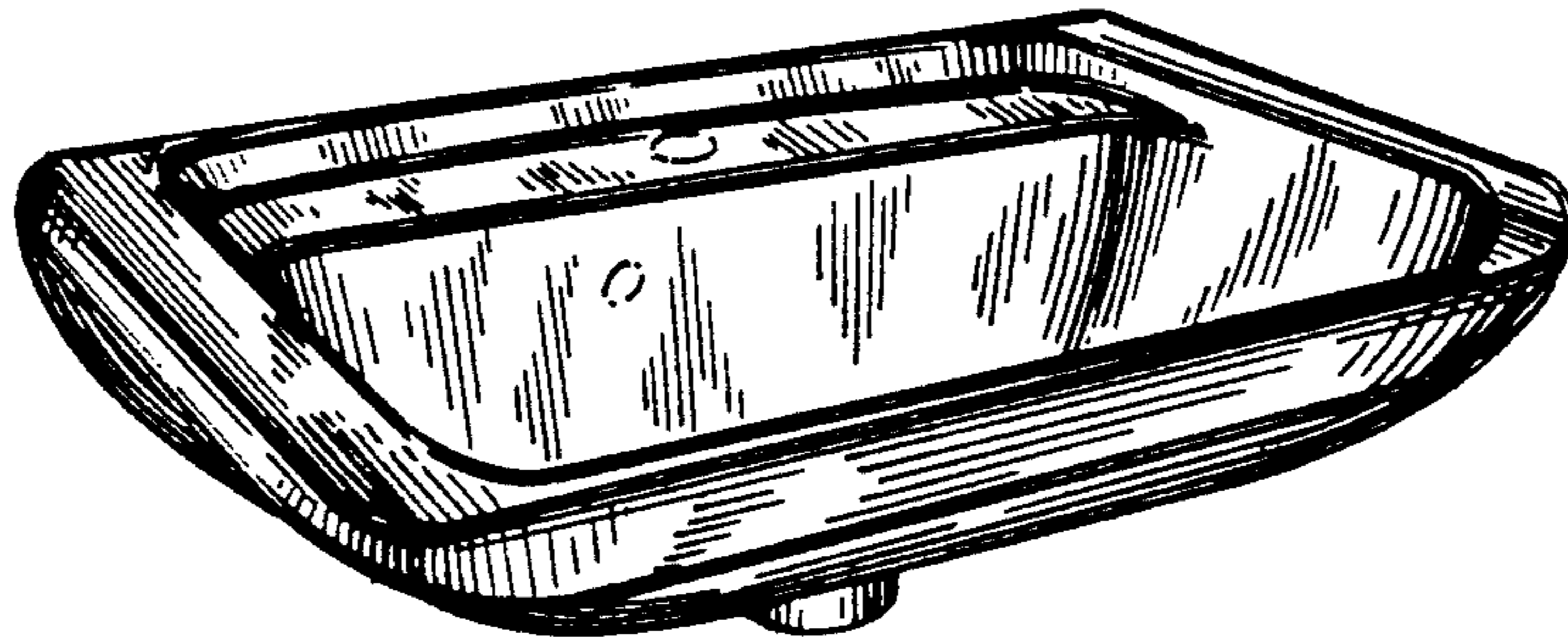

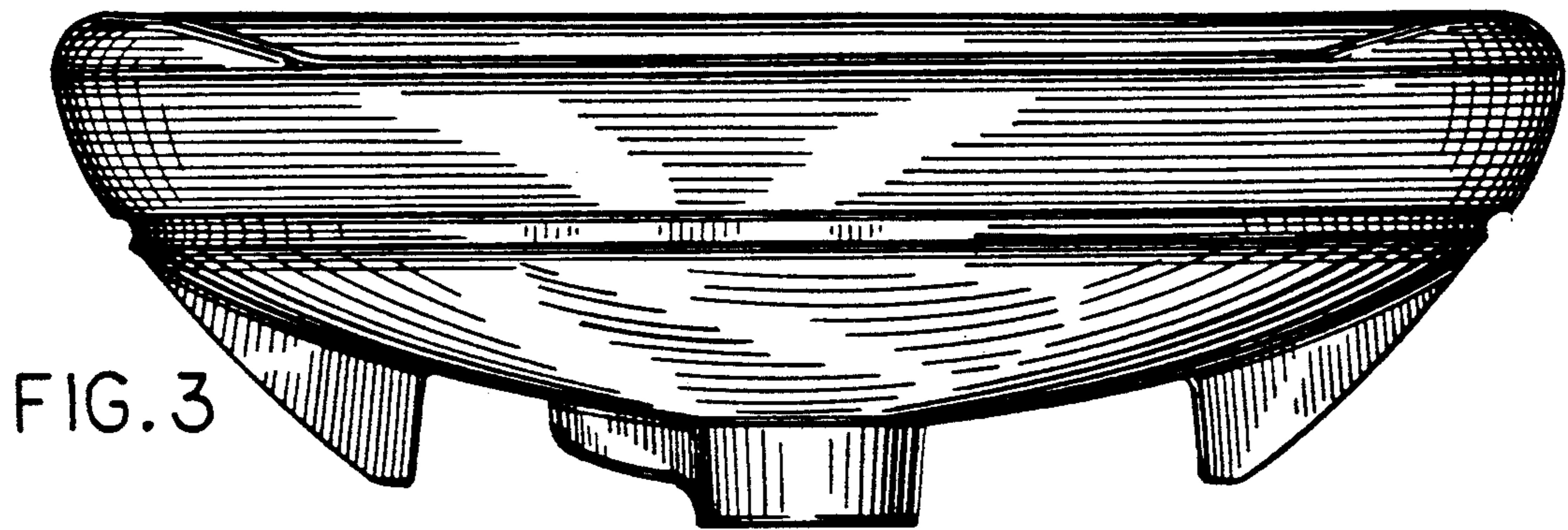

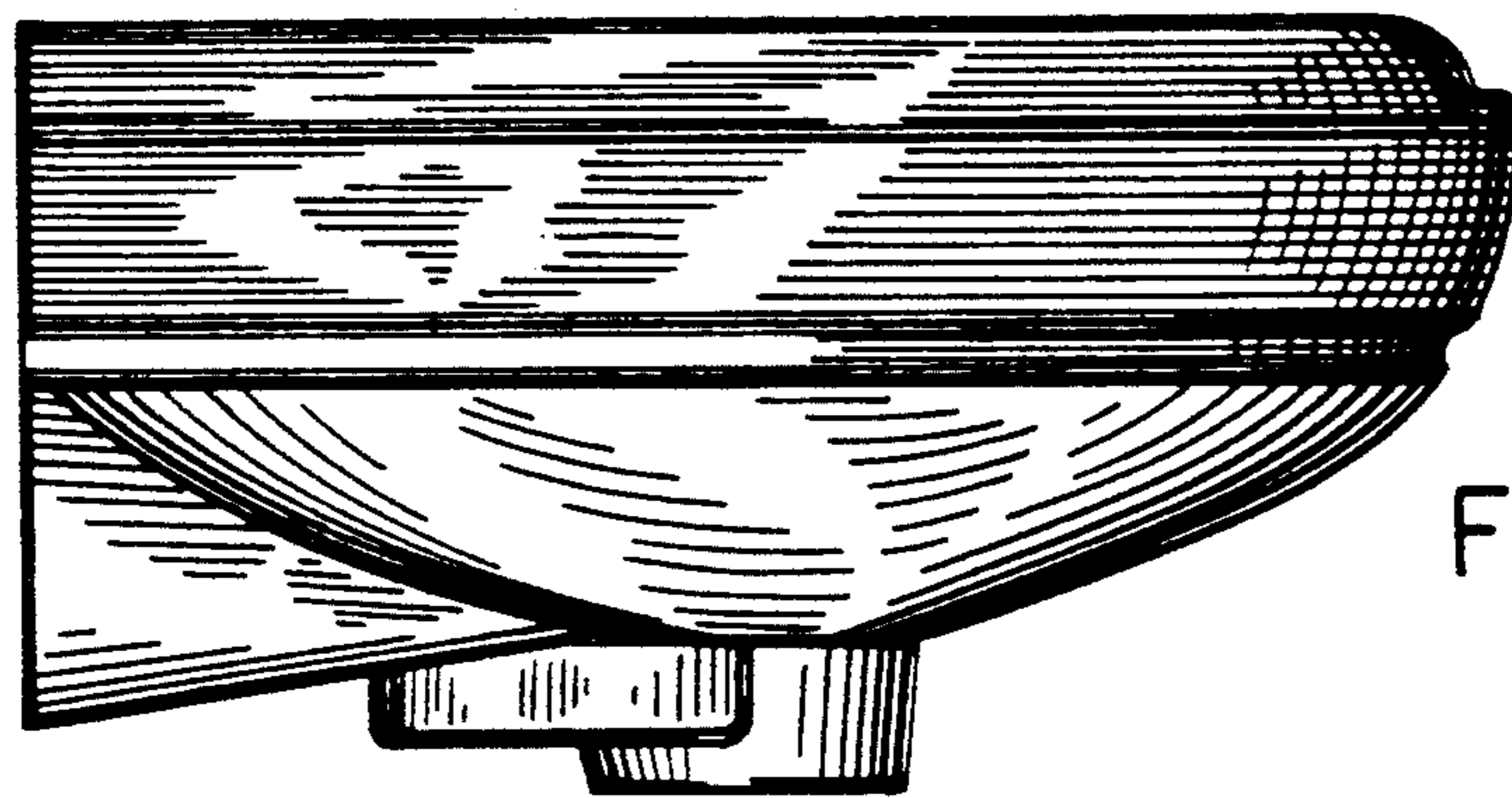

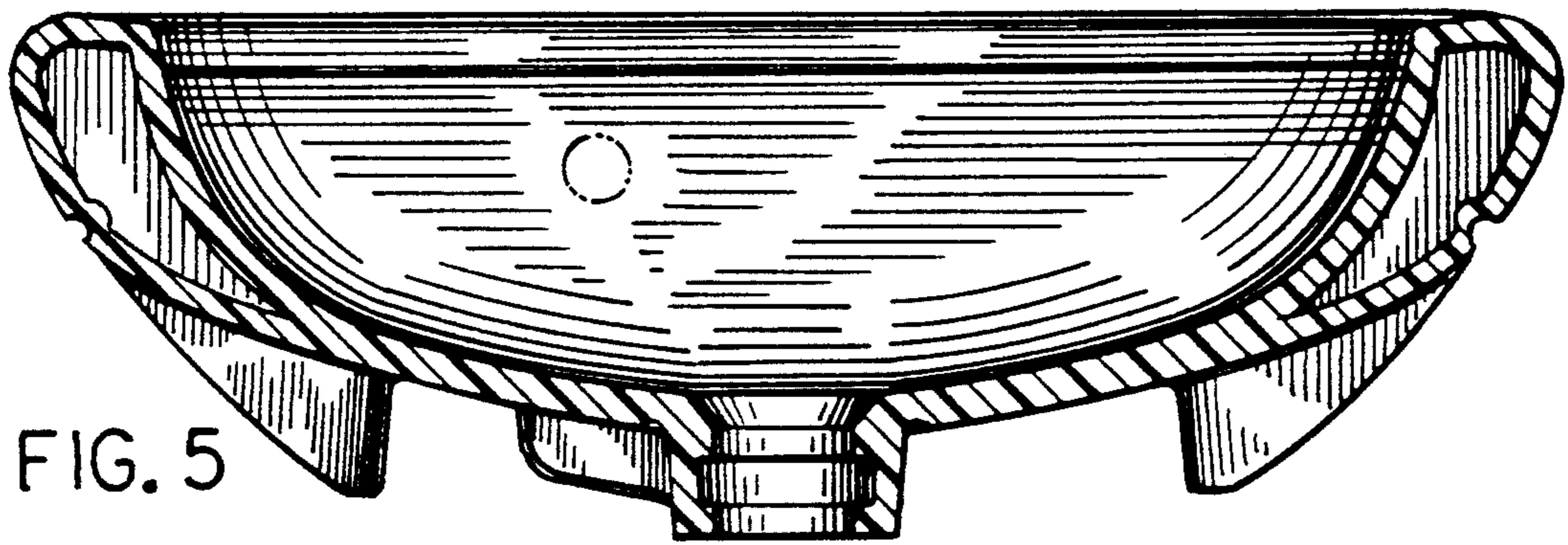

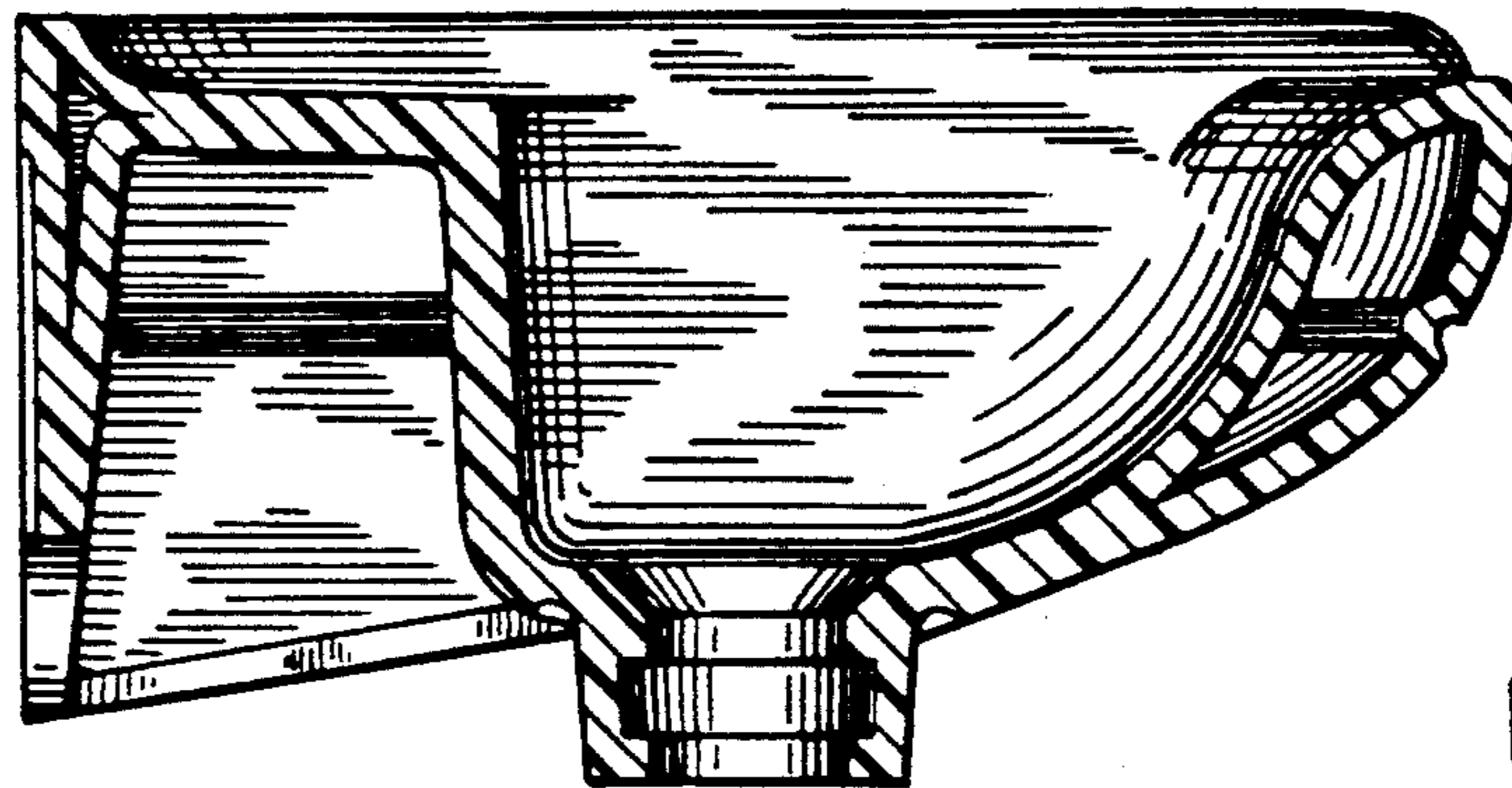
