DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right of a lavatory showing our new design;

FIG. 2 is a top plan view thereof;

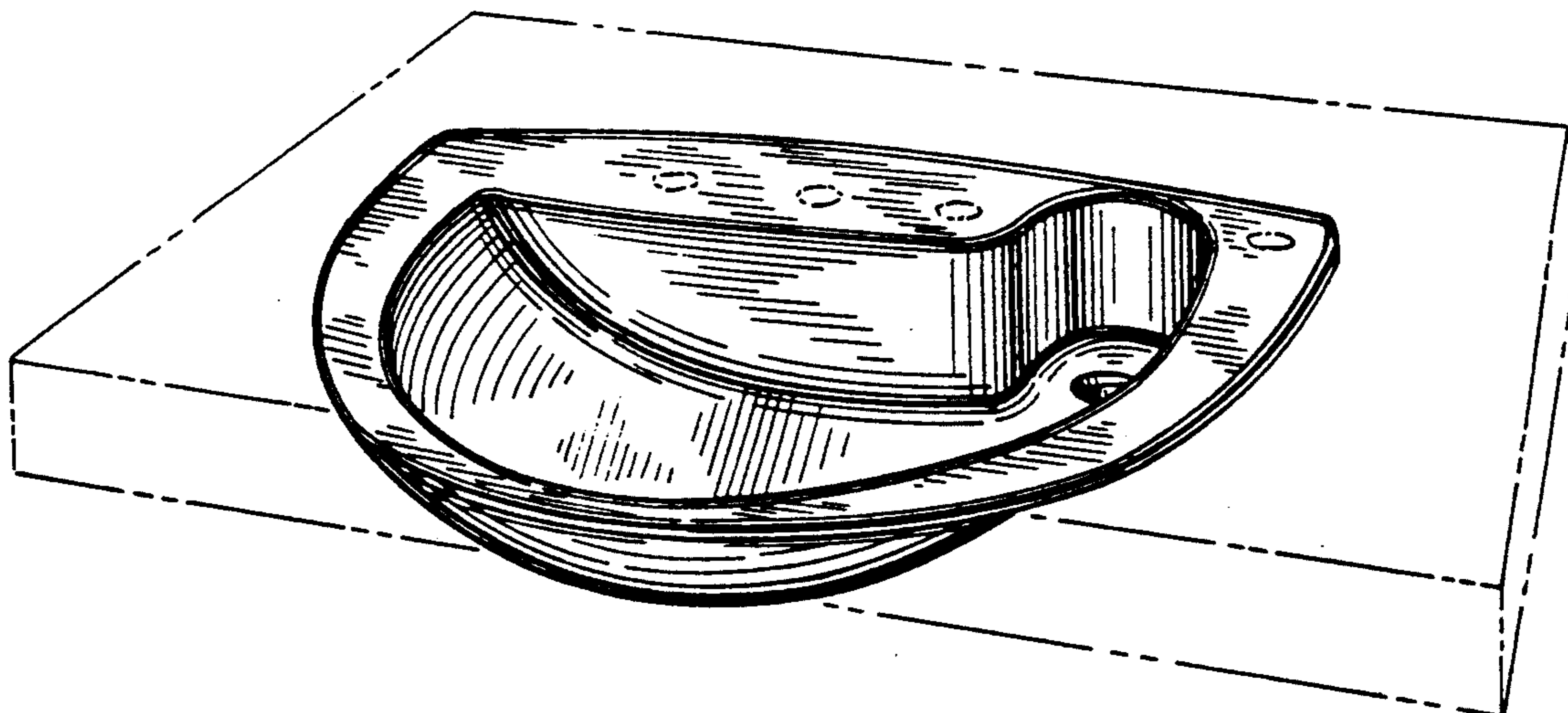
FIG. 3 is a cross-sectional view thereof taken on line 3-3 of FIG. 2;

FIG. 4 is a cross-sectional view thereof taken on line 4-4 of FIG. 2;

FIG. 5 is a partial cross-sectional view thereof taken on line 5-5 of FIG. 2; and,

FIG. 6 is a top plan view of a second embodiment thereof.

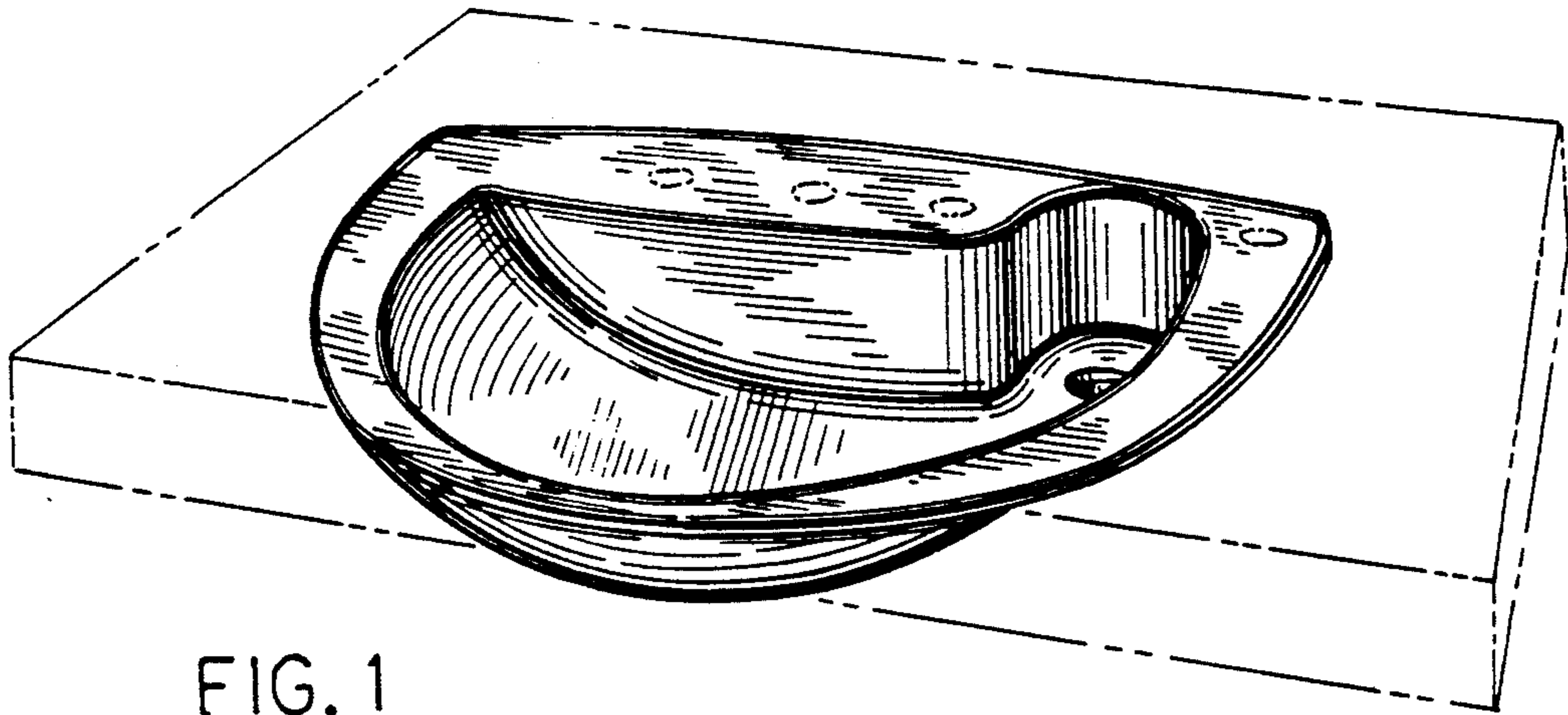

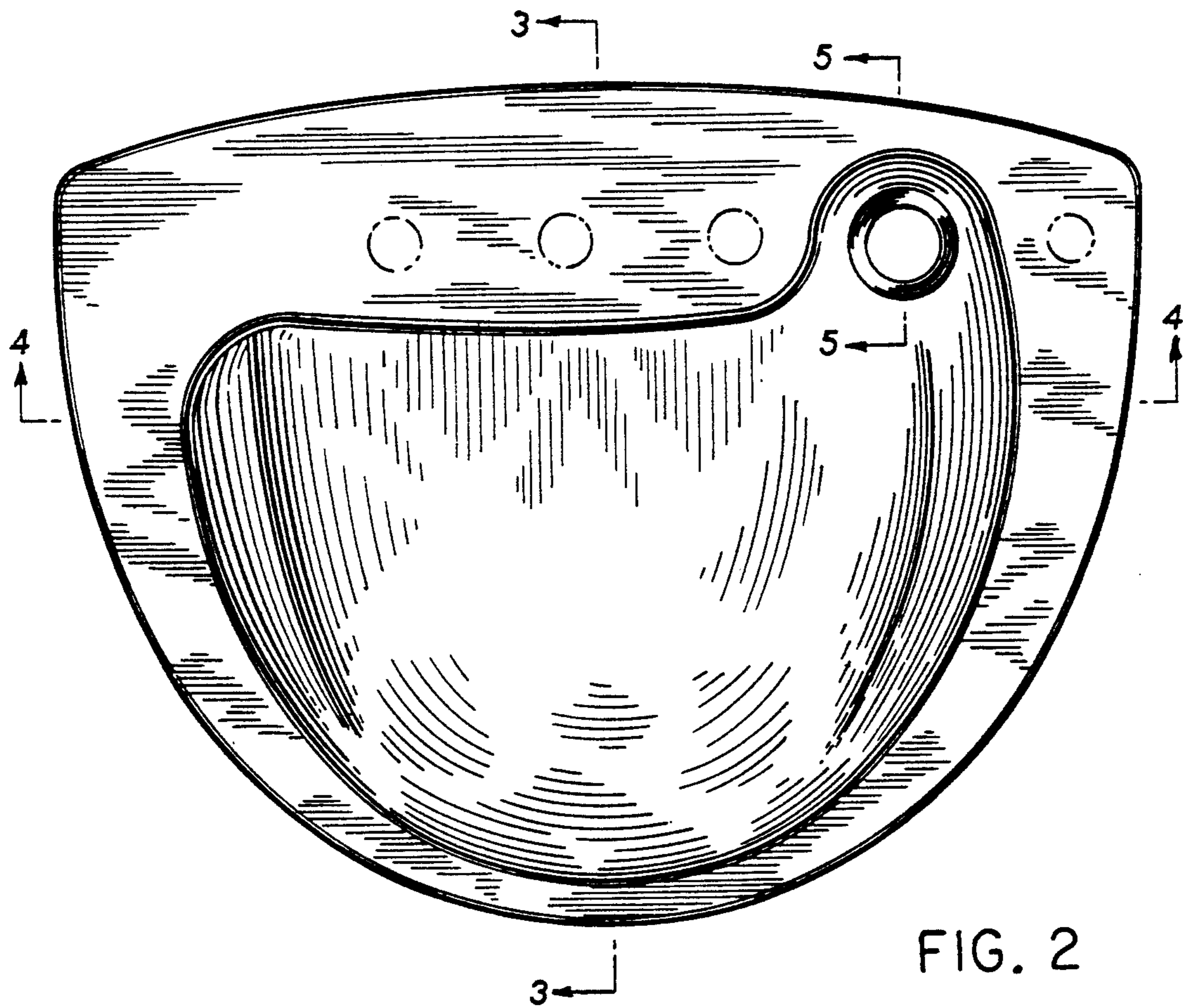

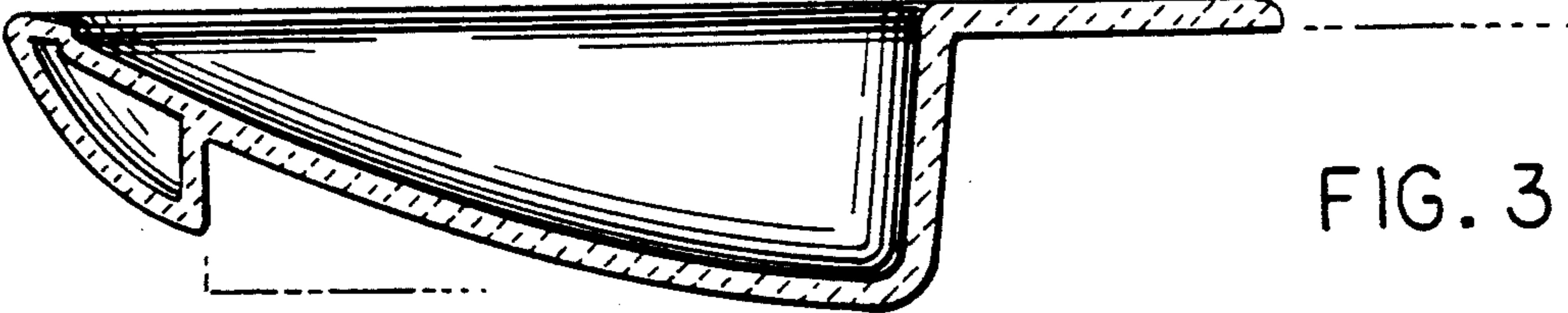

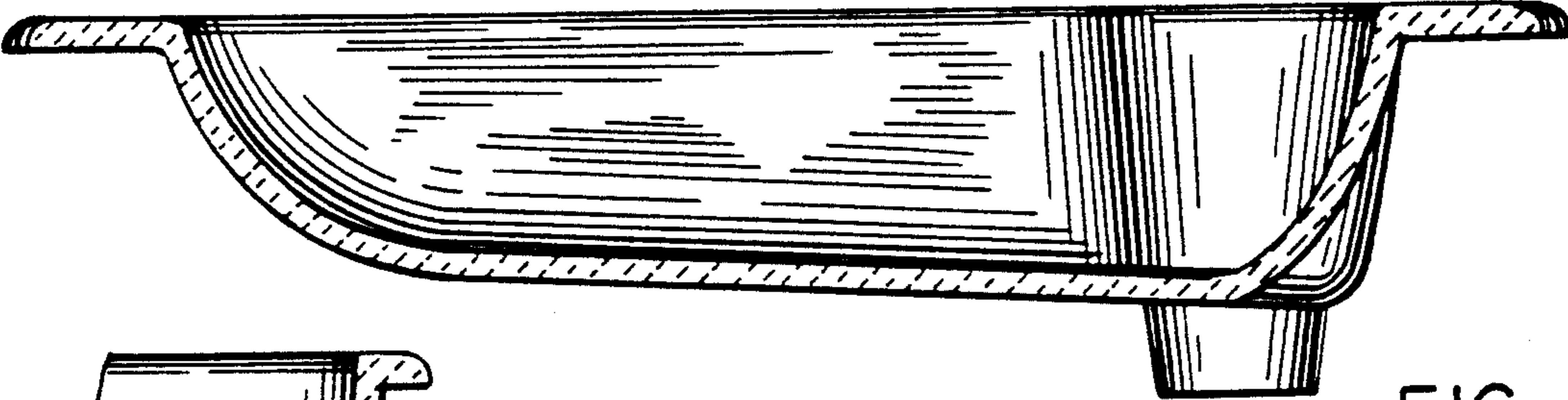

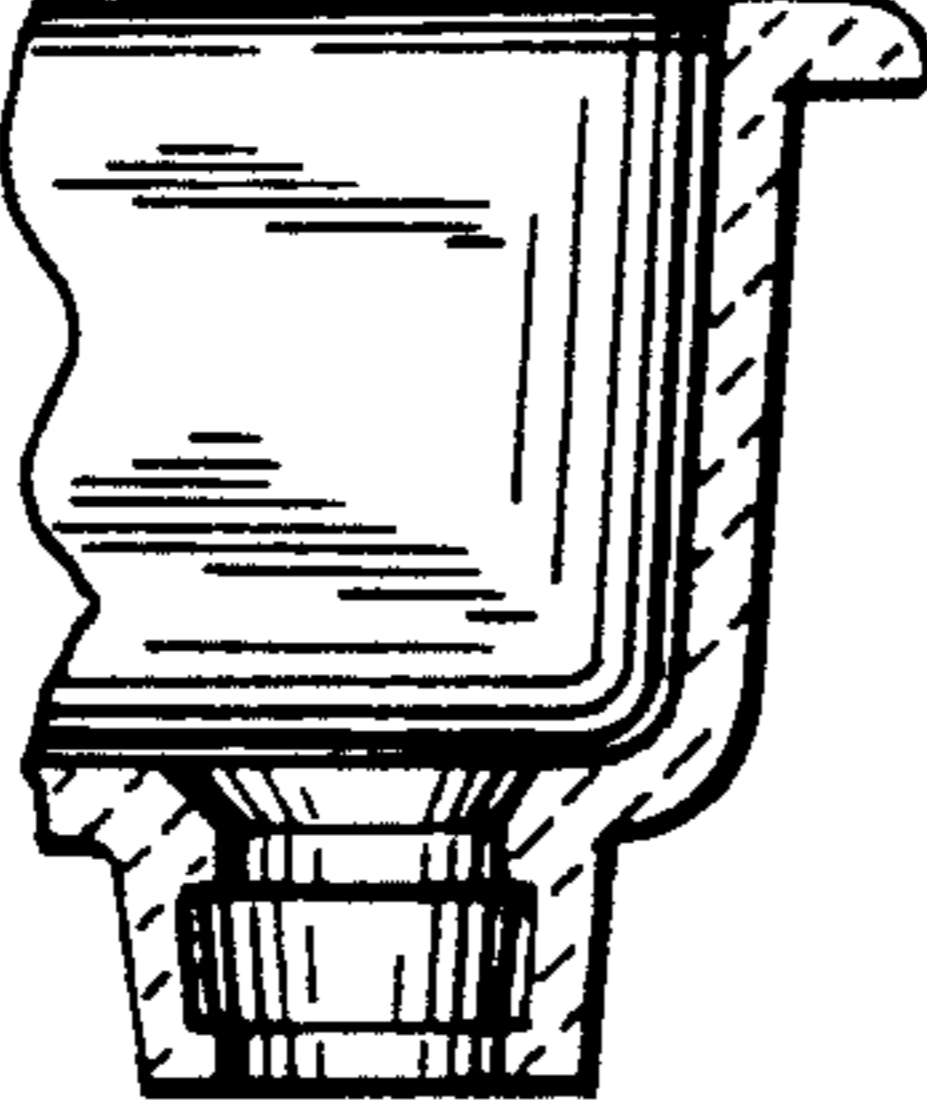

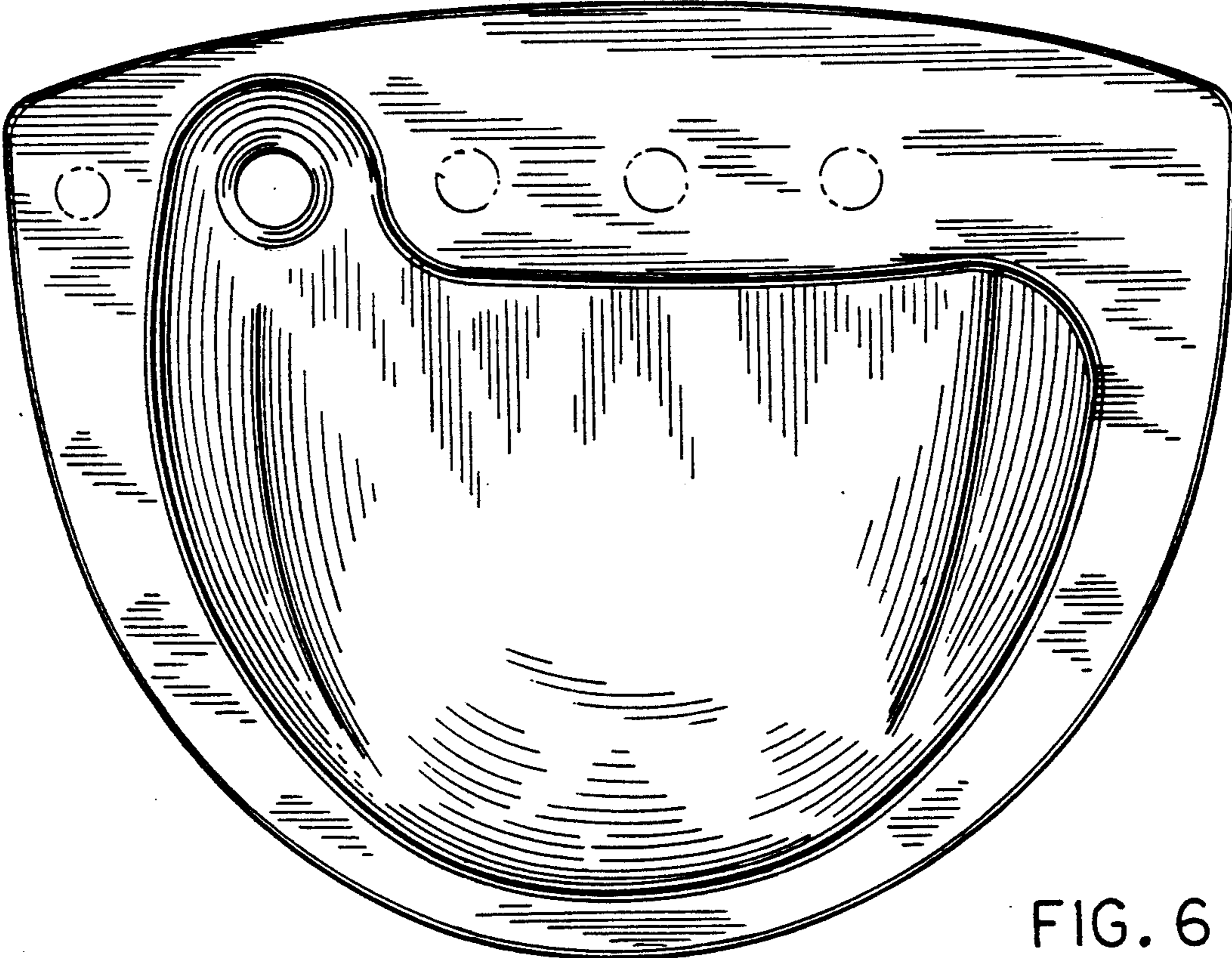
