DESCRIPTION

FIG. 1 is a perspective view looking from above of a chair showing one embodiment of my new design;

FIG. 5 is a left side elevational view thereof;

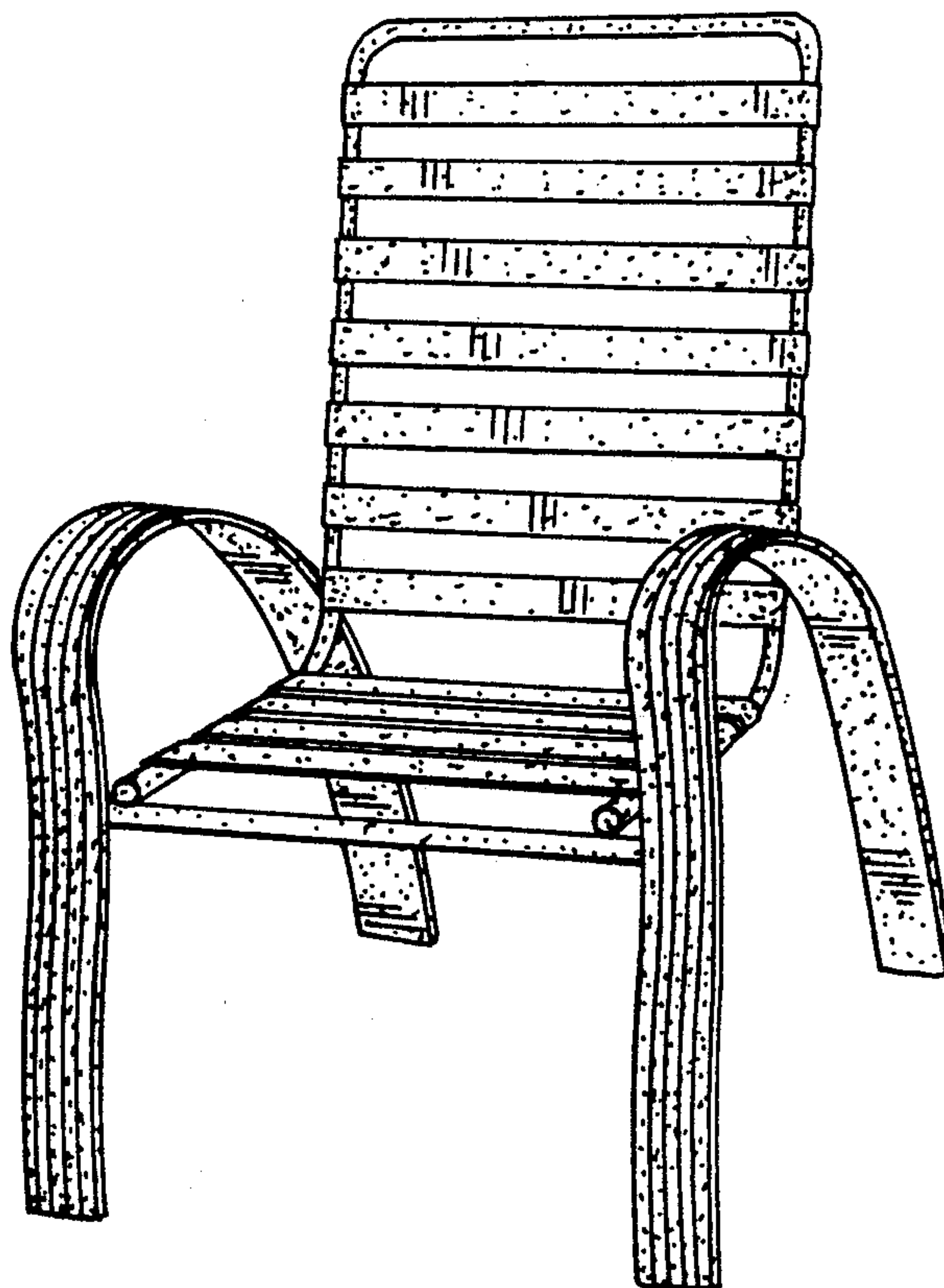
FIG. 6 is a top plan view thereof;

FIG. 10 is a left side elevational view thereof.



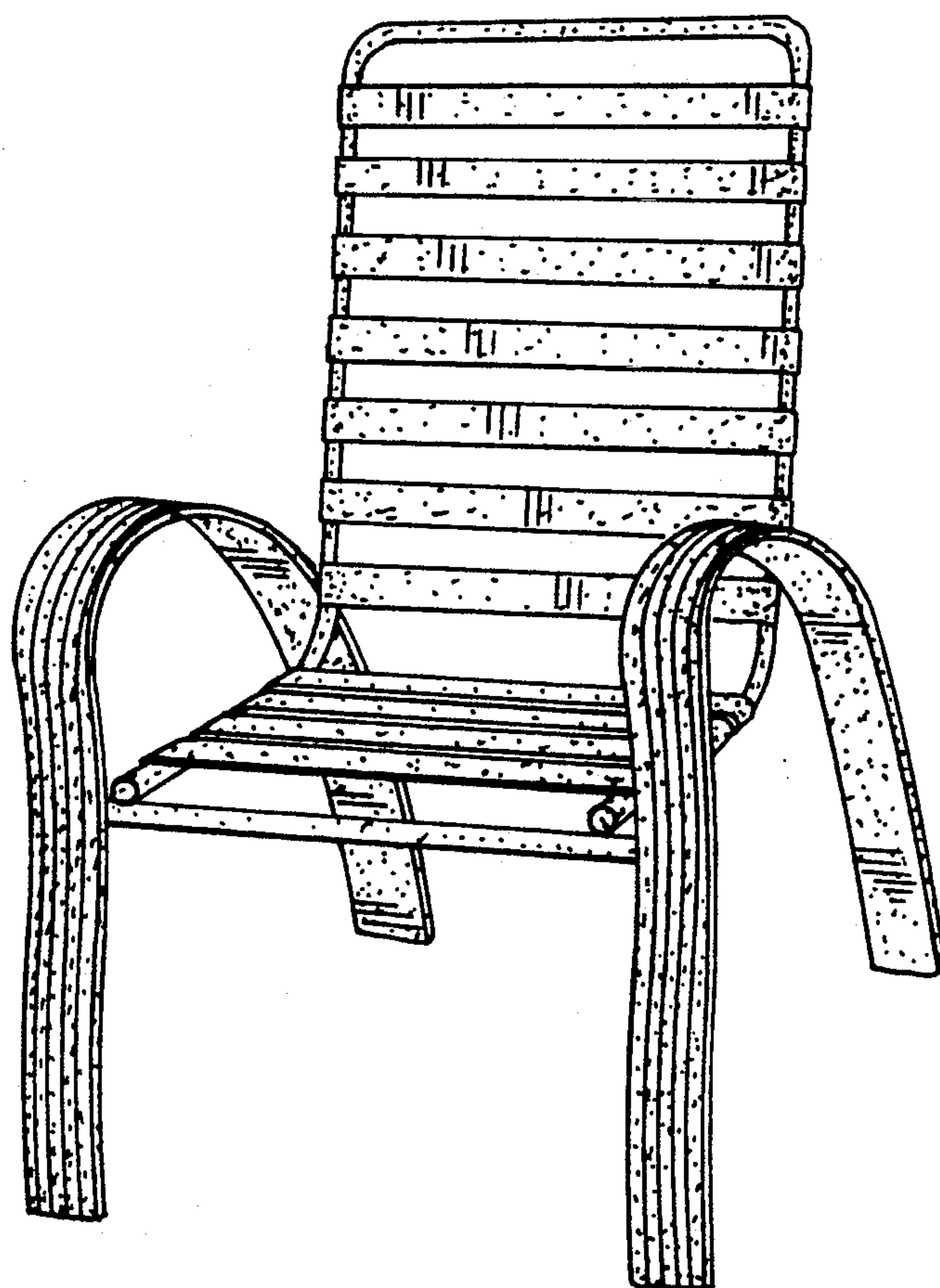

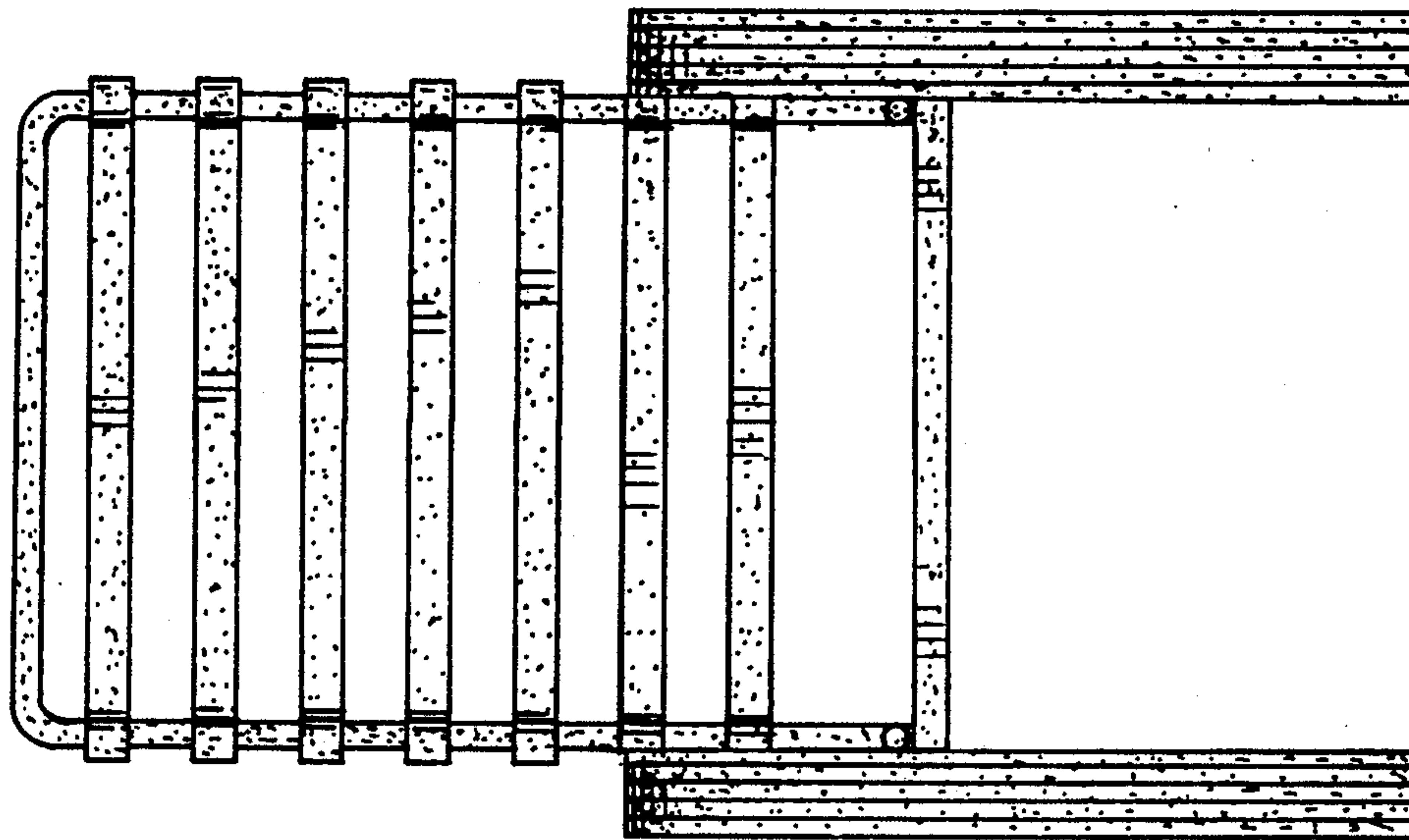

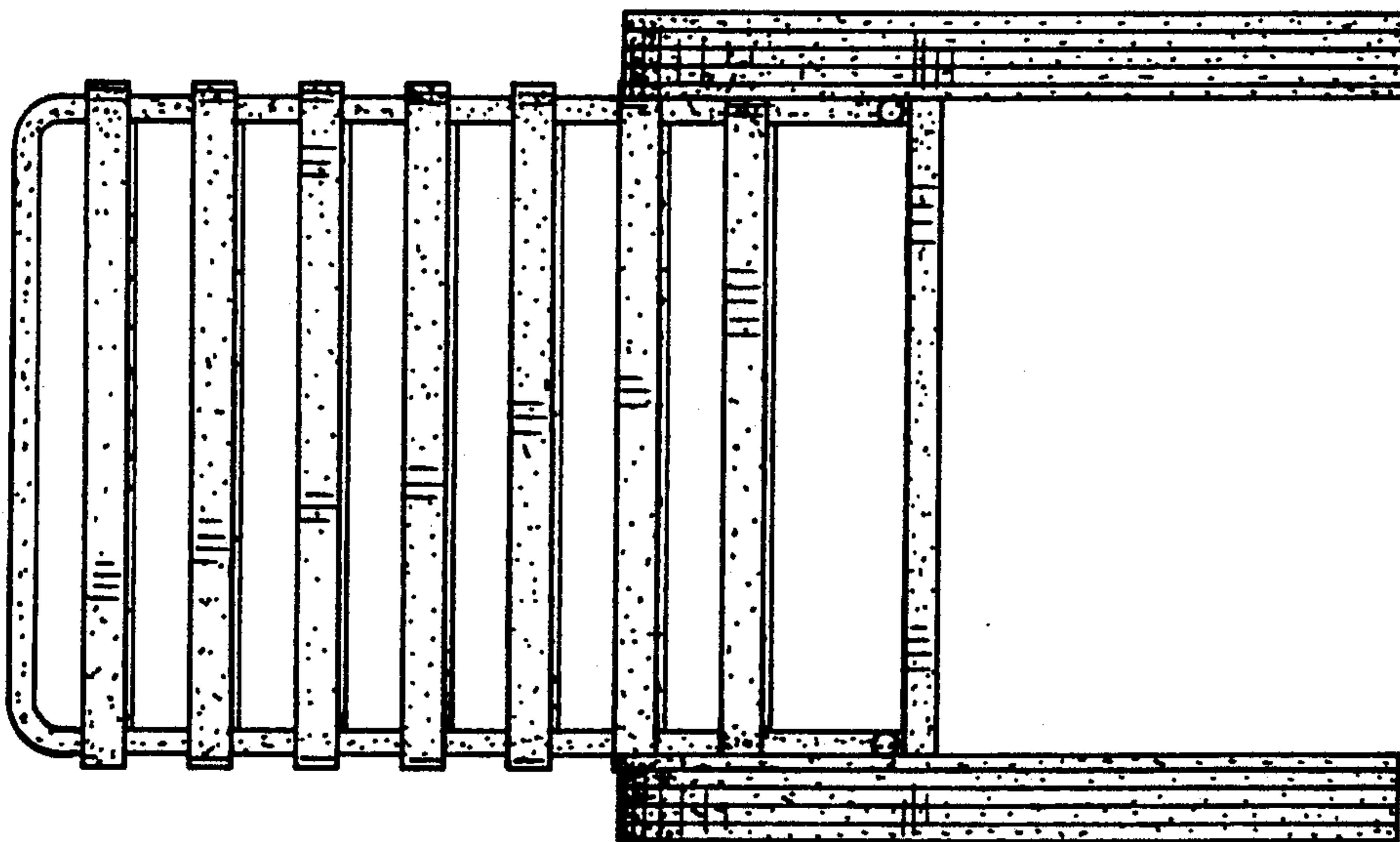

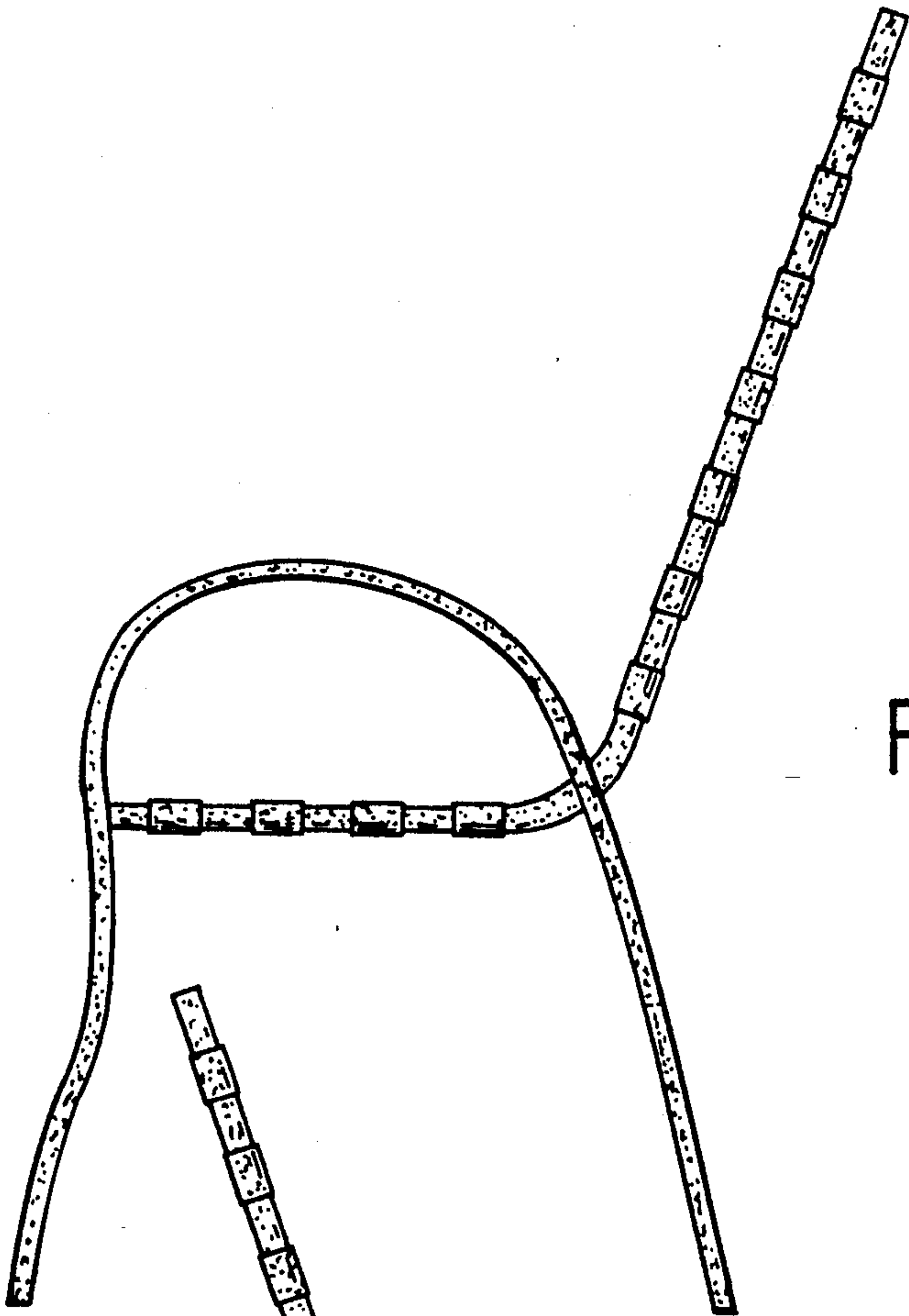
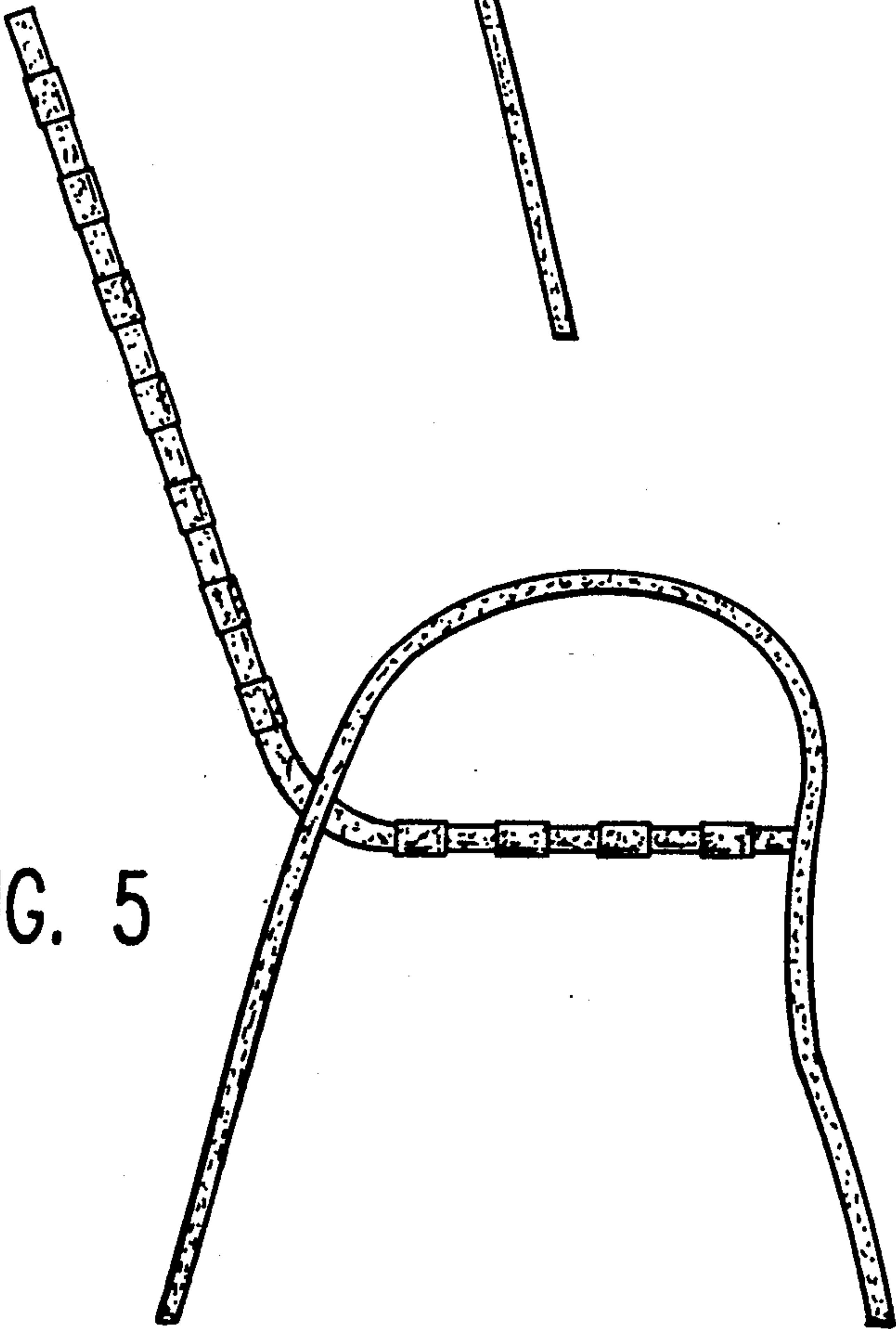

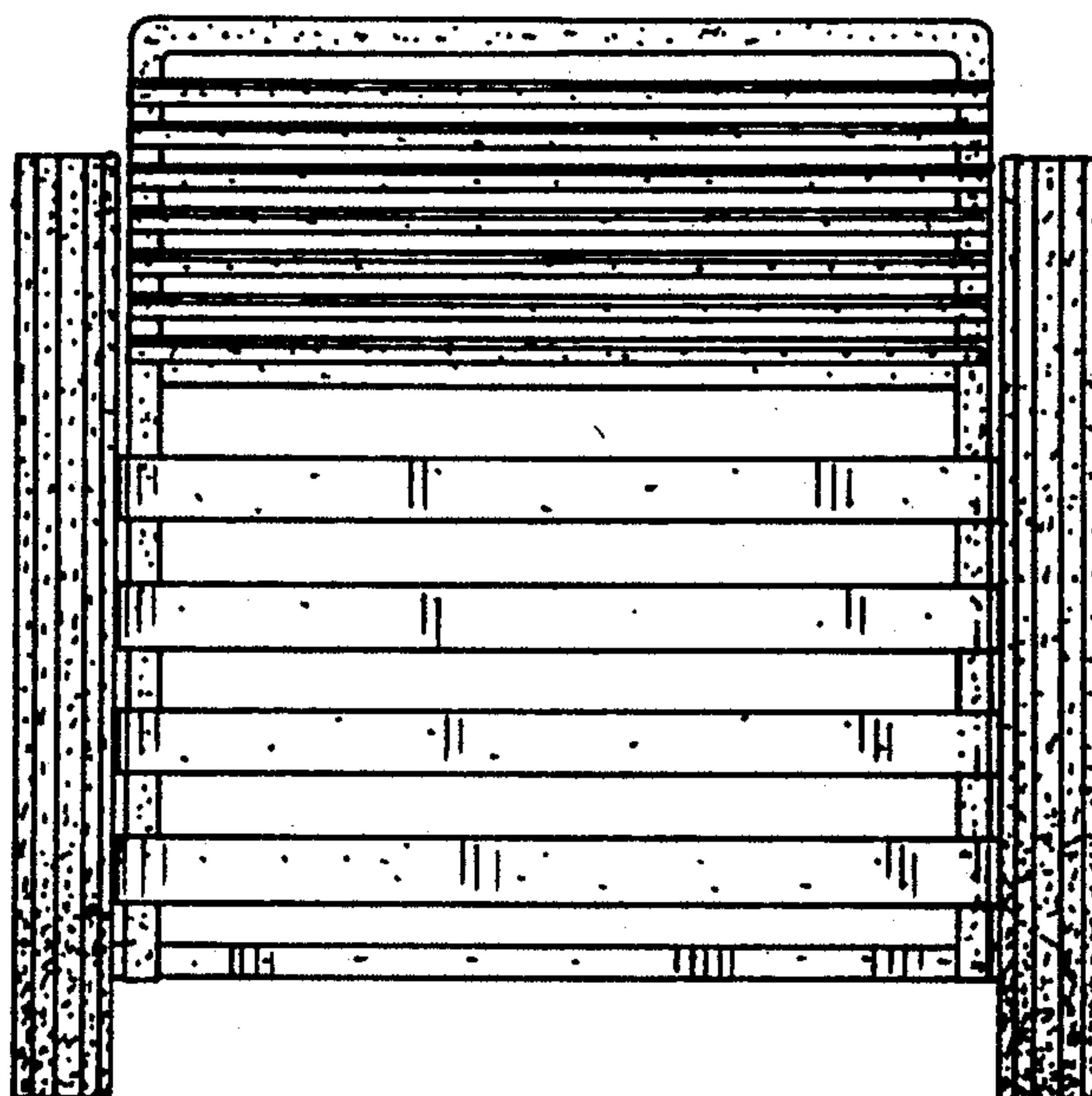

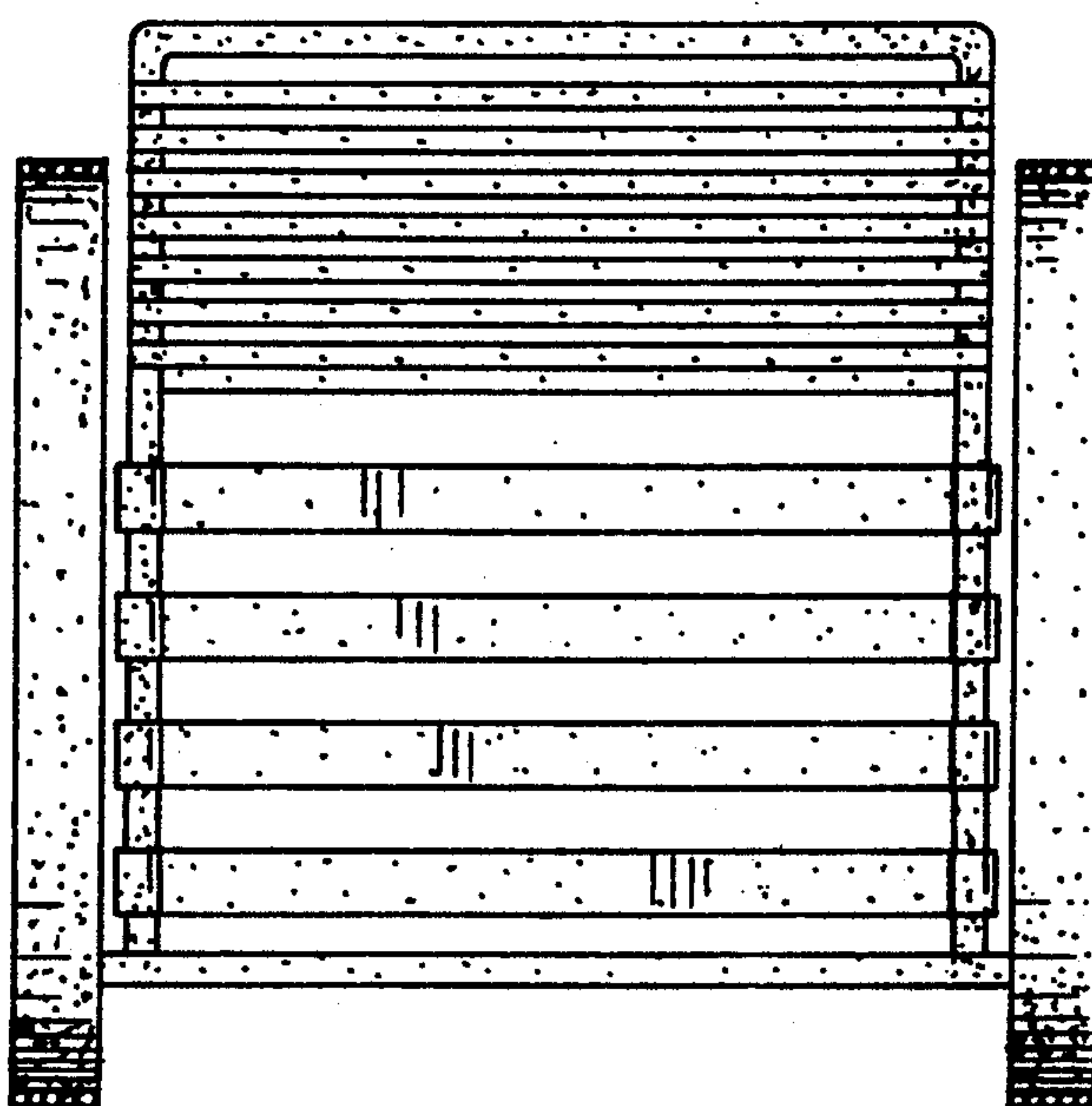

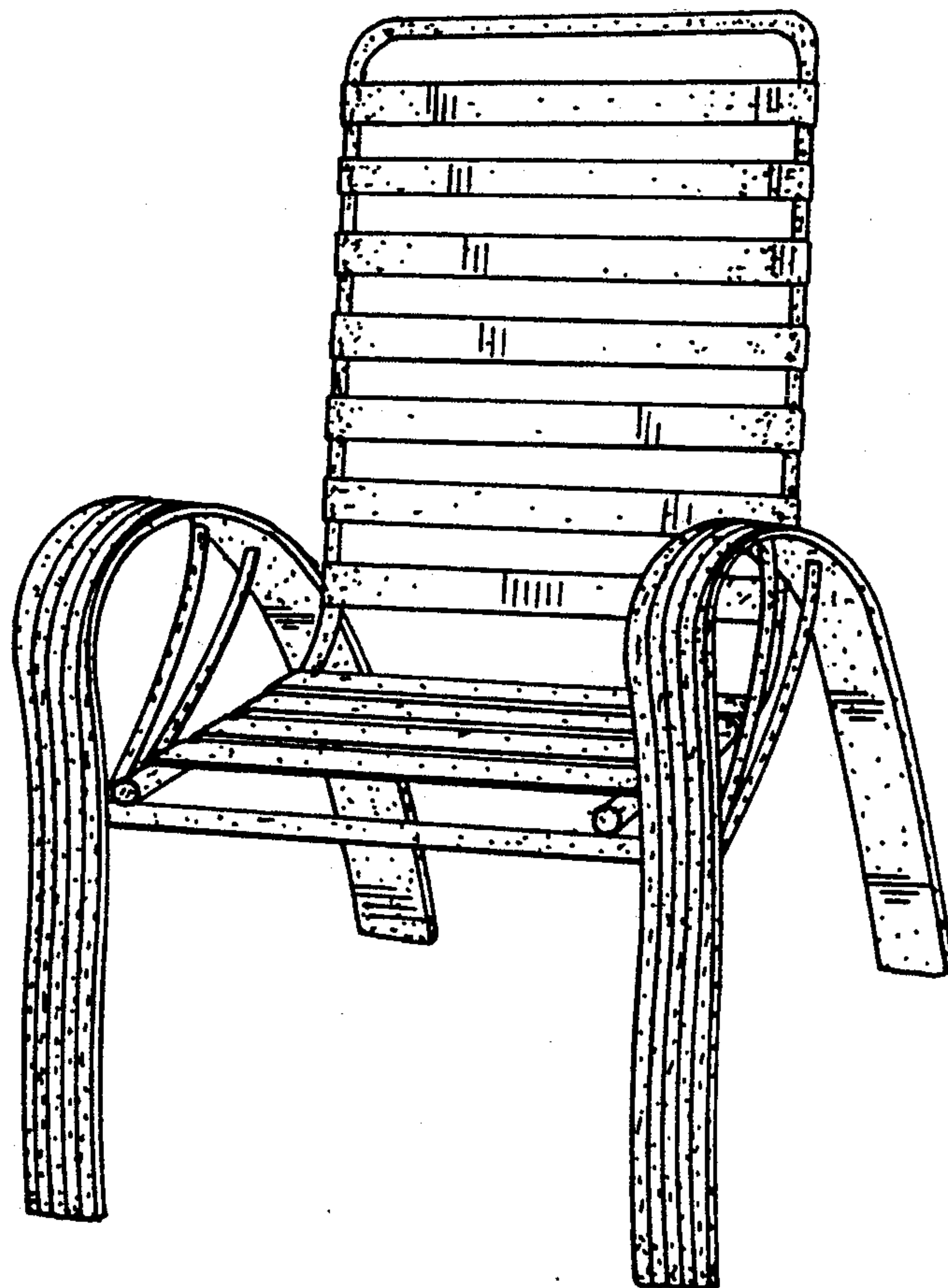

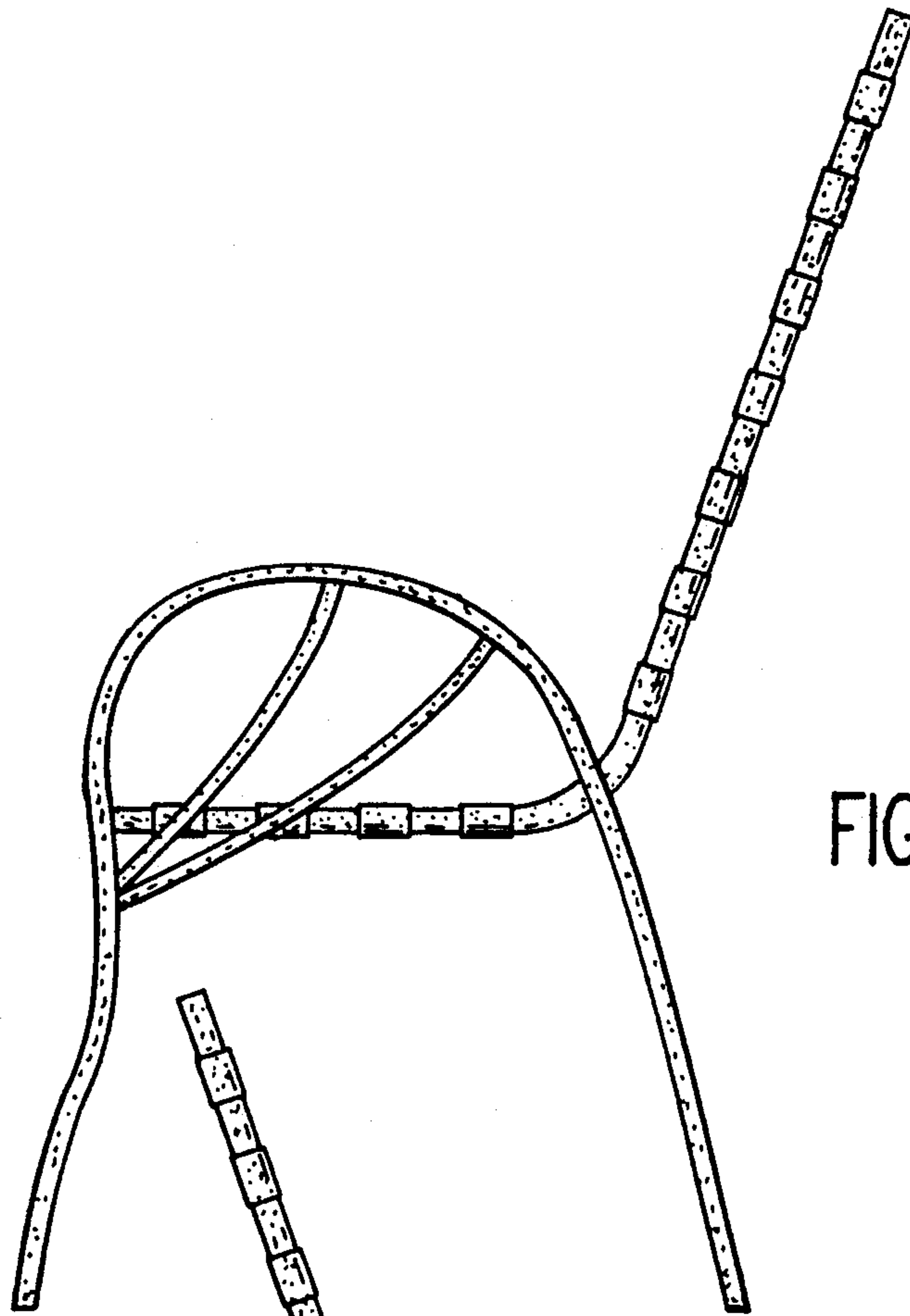
