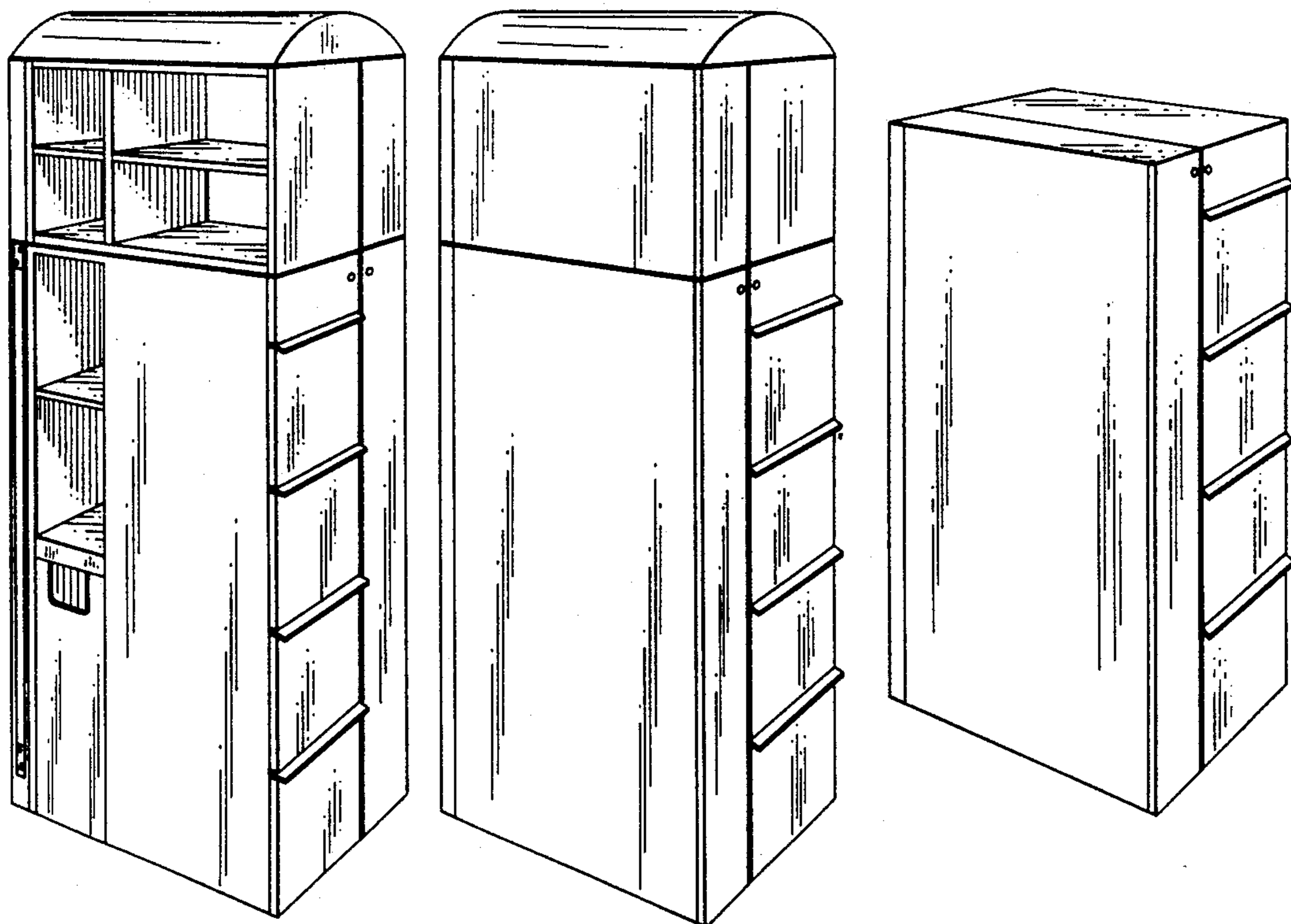
[57] **CLAIM**

The ornamental design for a storage cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a storage cabinet showing our new design;

FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side elevational view as seen when in use;  
 FIG. 4 is a left side elevational view as seen when in use;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a perspective view of a second embodiment of the storage cabinet shown in FIG. 1;  
 FIG. 9 is a front elevational view thereof;  
 FIG. 10 is a right side elevational view as seen when in use;  
 FIG. 11 is a left side elevational view as seen when in use;  
 FIG. 12 is a rear elevational view thereof;  
 FIG. 13 is a top plan view thereof;  
 FIG. 14 is a bottom plan view thereof;  
 FIG. 15 is a perspective view of a third embodiment of the storage cabinet shown in FIG. 1; the front, sides, rear and bottom views being identical to FIGS. 9-12 and 14 respectively with the cupola removed;  
 FIG. 16 is a top plan view thereof;  
 FIG. 17 is a perspective view of fourth embodiment of the storage cabinet shown in FIG. 1; the front, sides, rear and bottom views being identical to FIGS. 9-12 and 14 respectively with the cupola and top section removed; the top plan view being identical to FIG. 16; and,  
 FIG. 18 is a perspective view of a fifth embodiment of the storage cabinet shown in FIG. 1; the front, sides, rear, top and bottom views being identical to FIGS. 9-14 respectively with the cupola lowered to replace the top section.



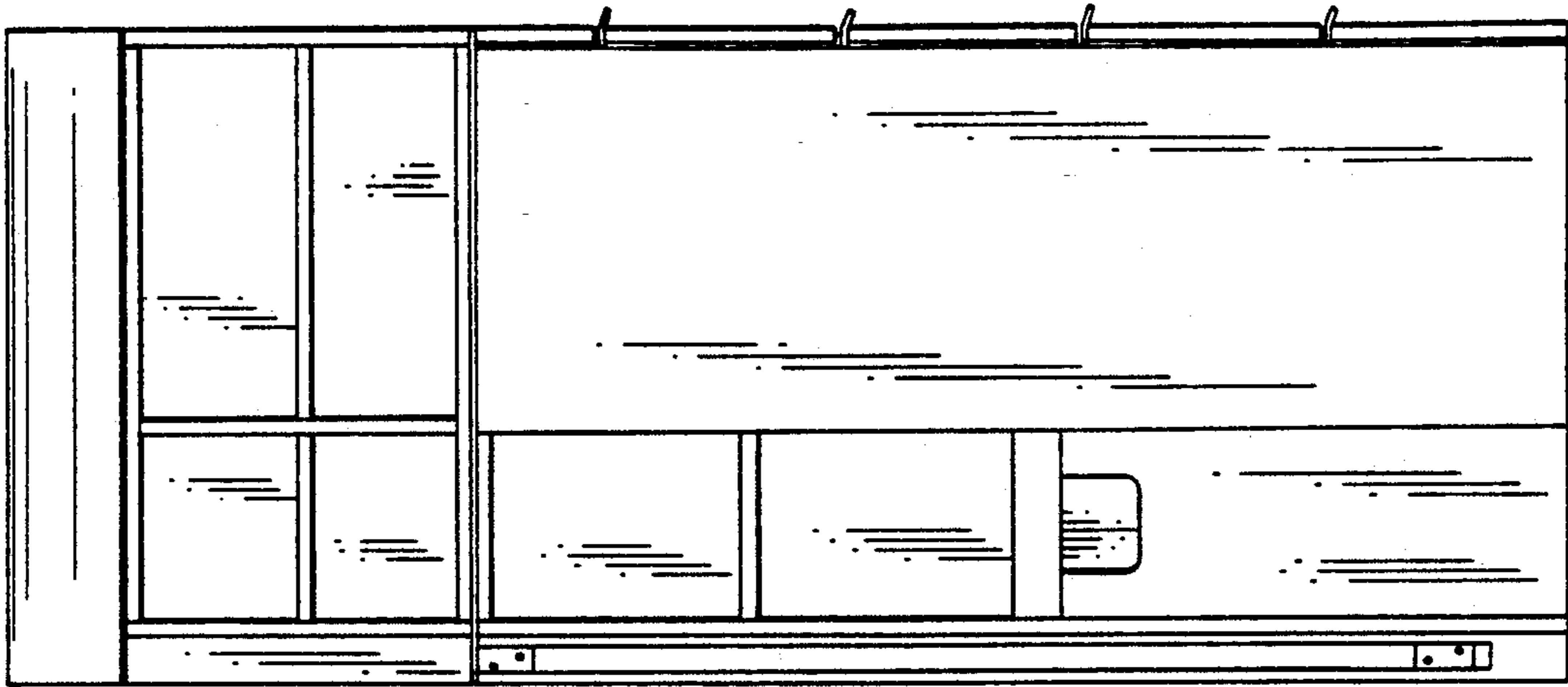

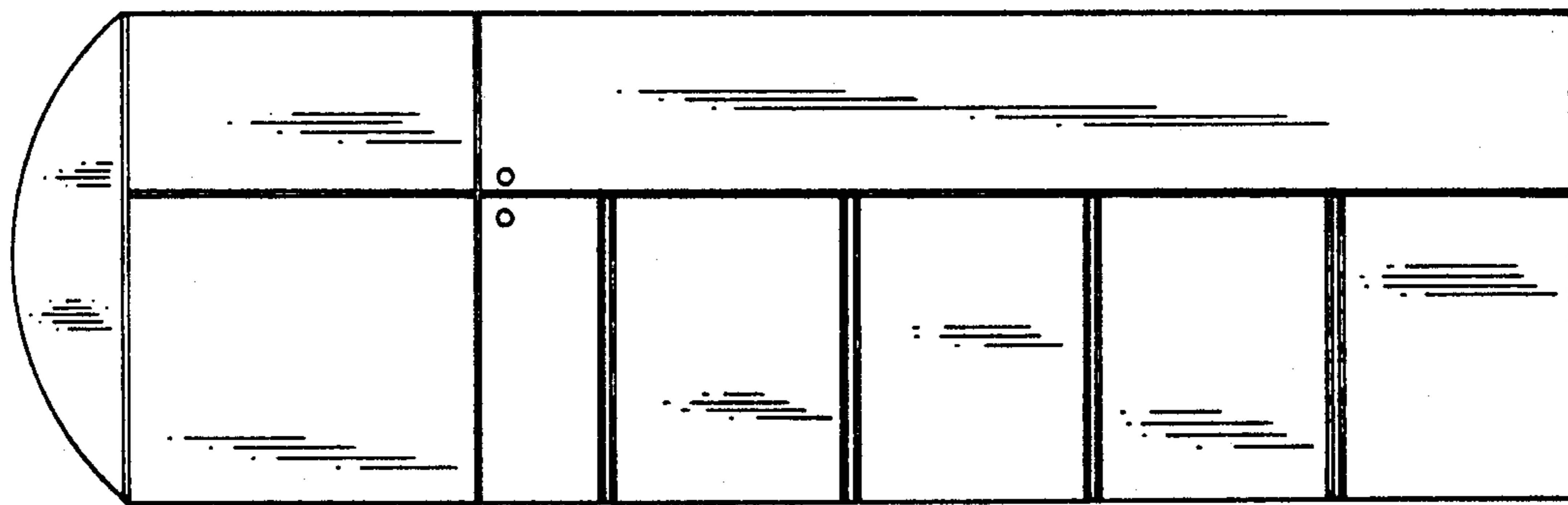

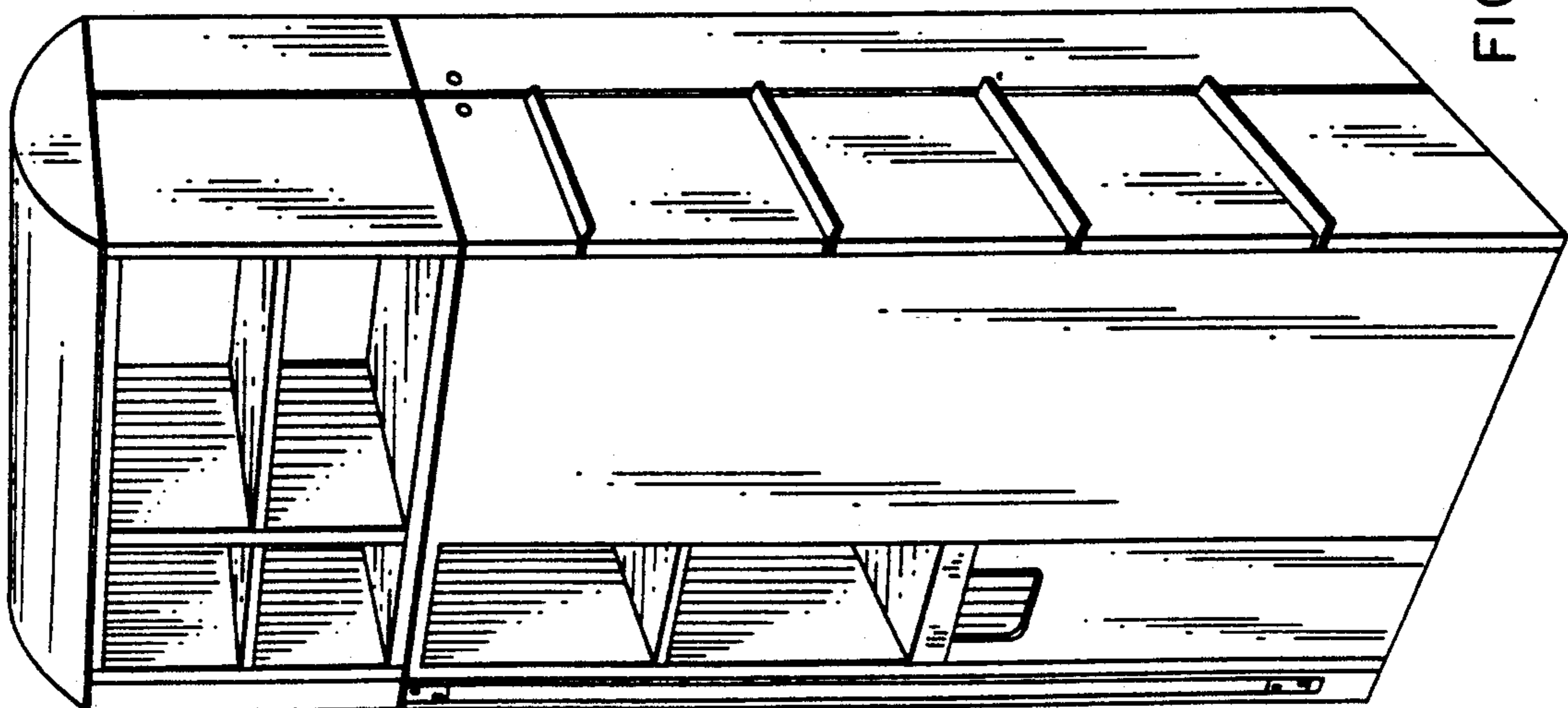

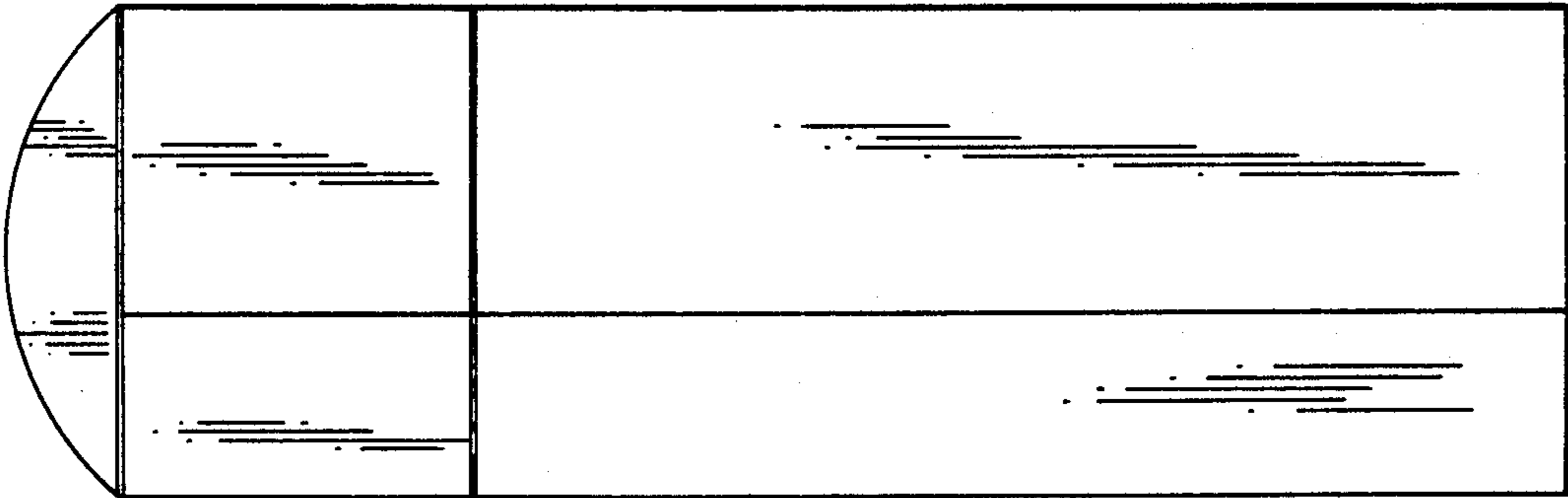

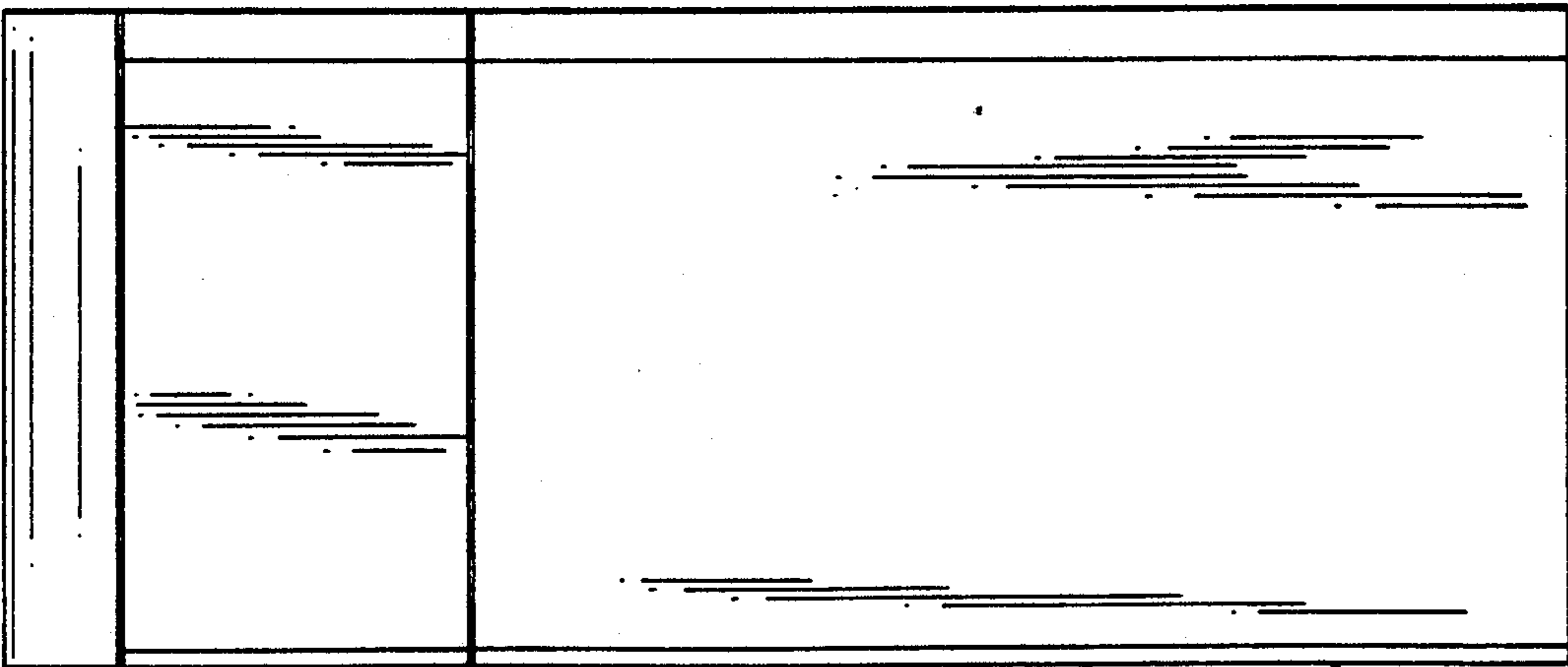

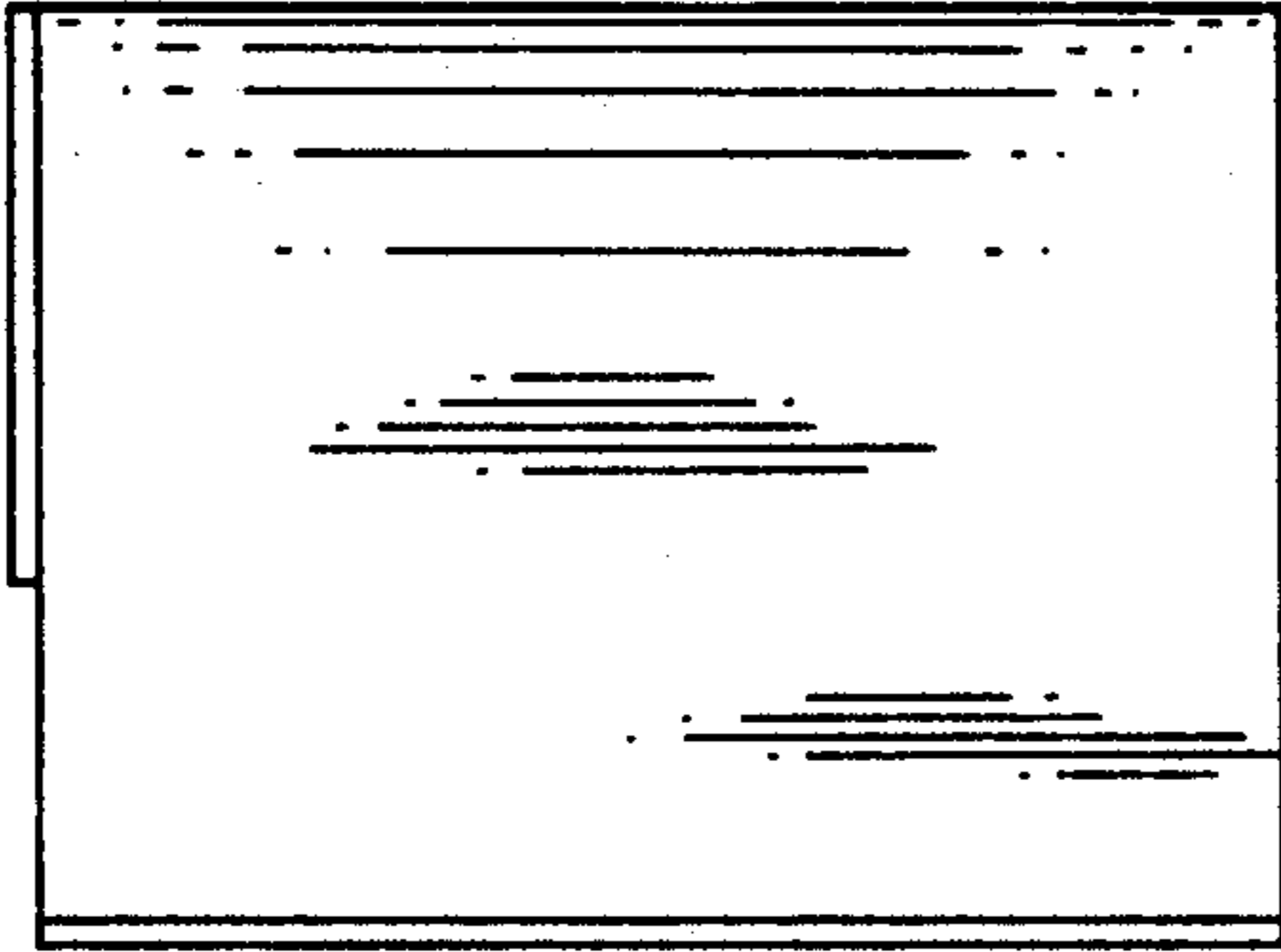
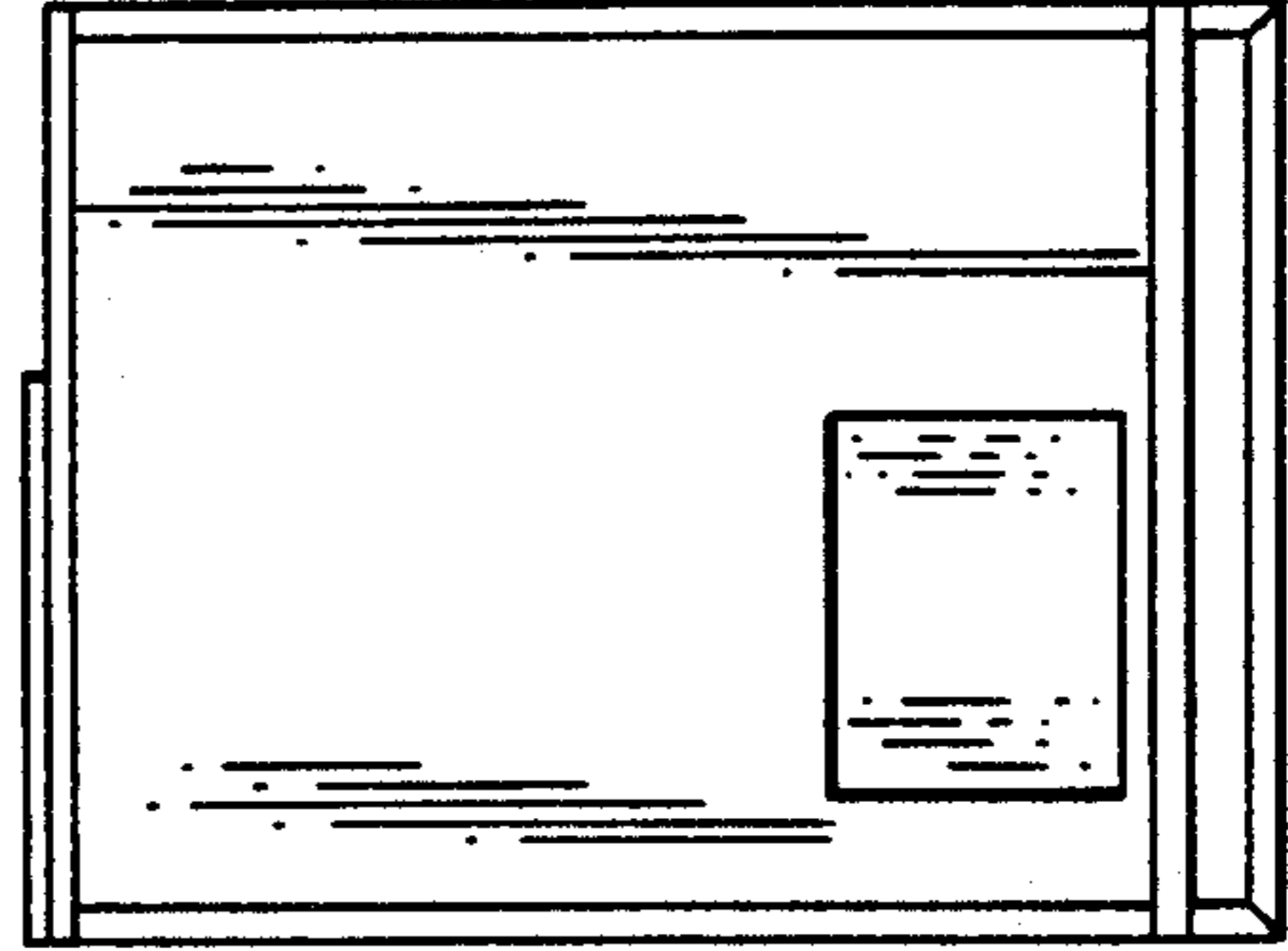

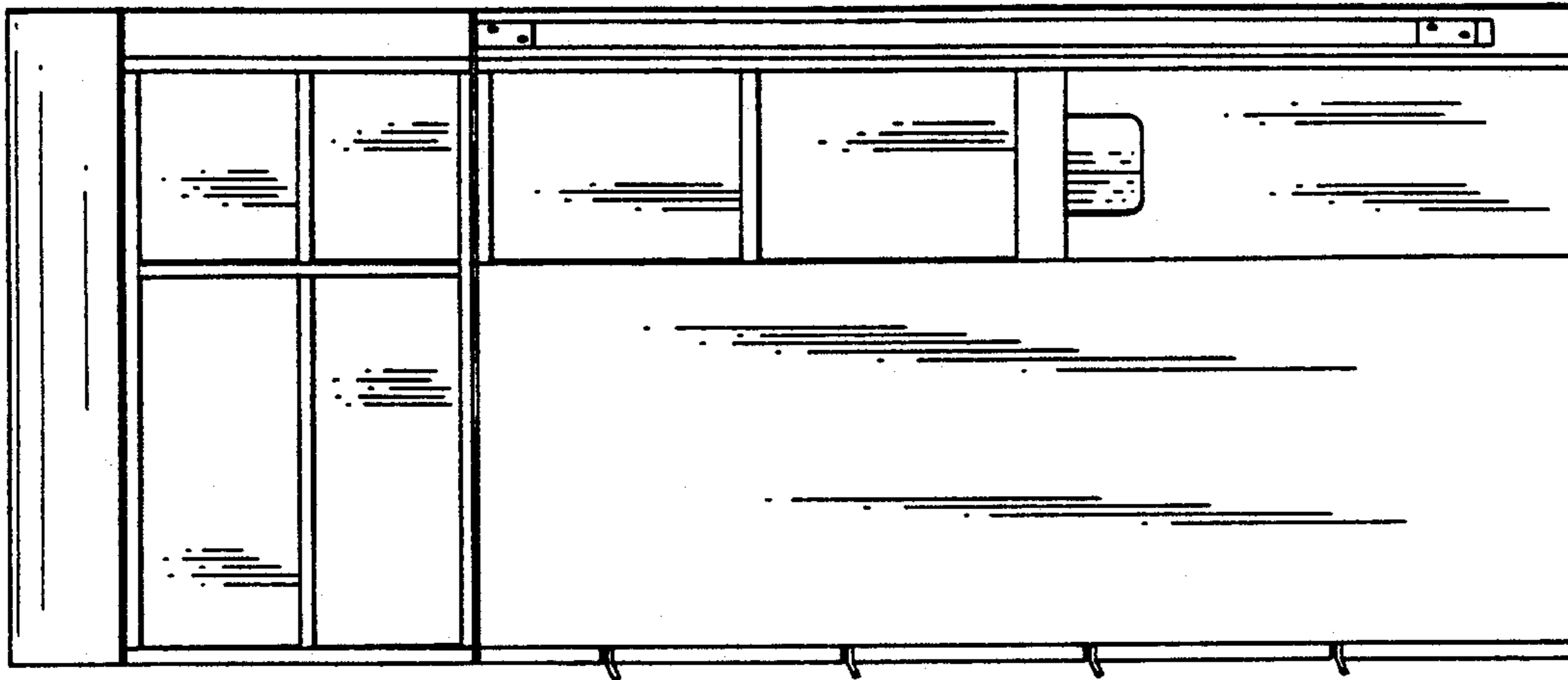

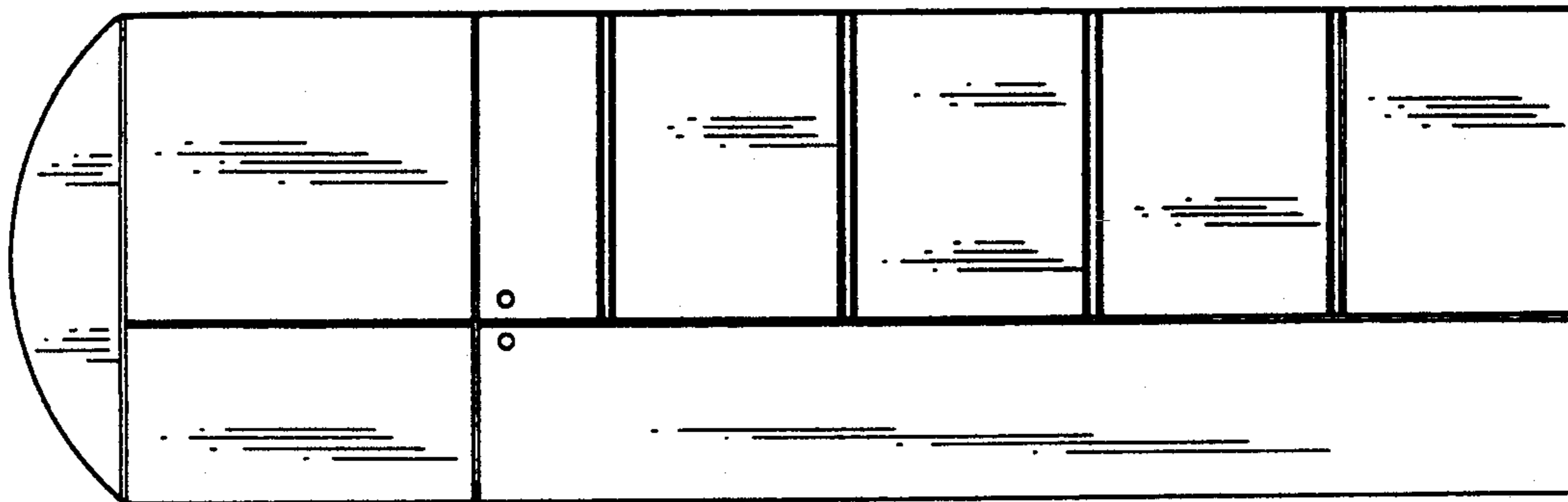

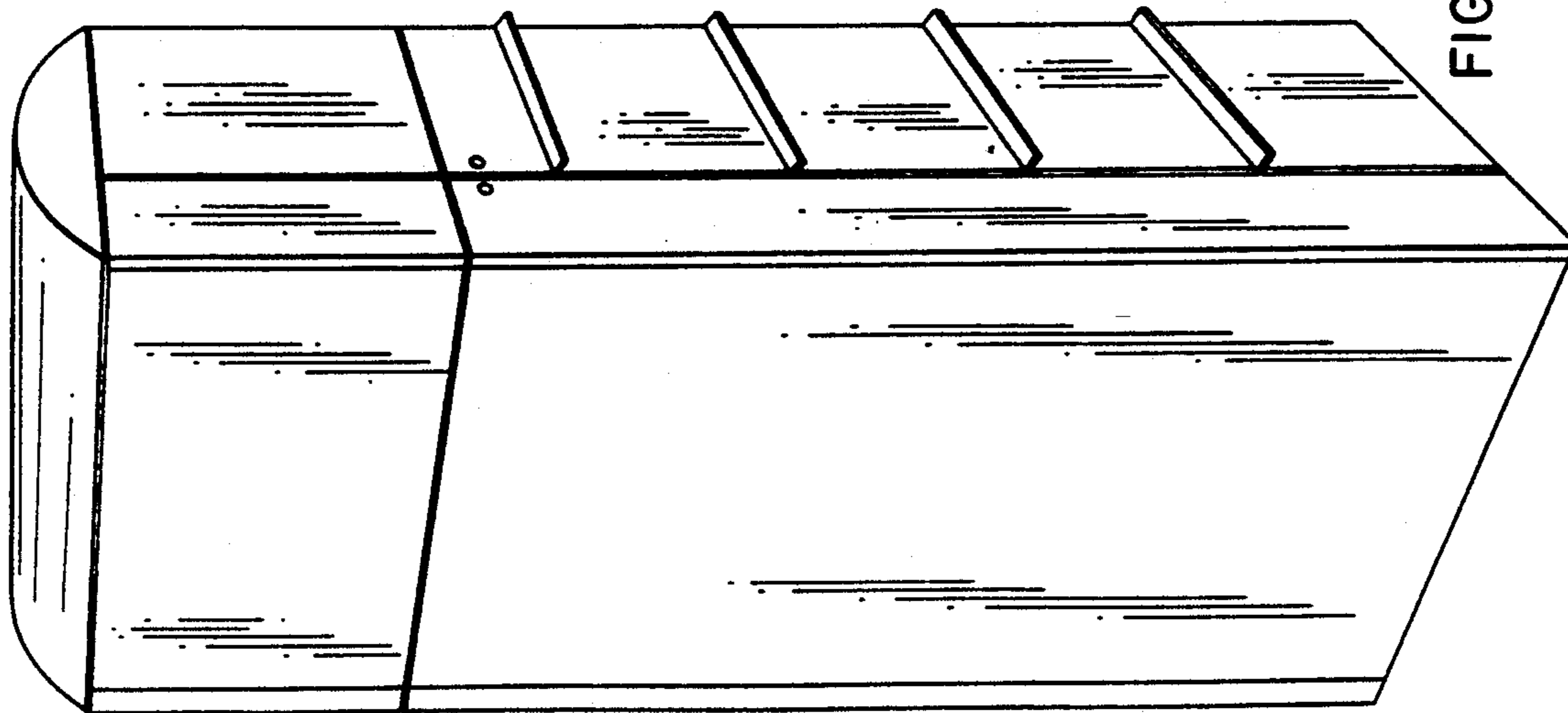

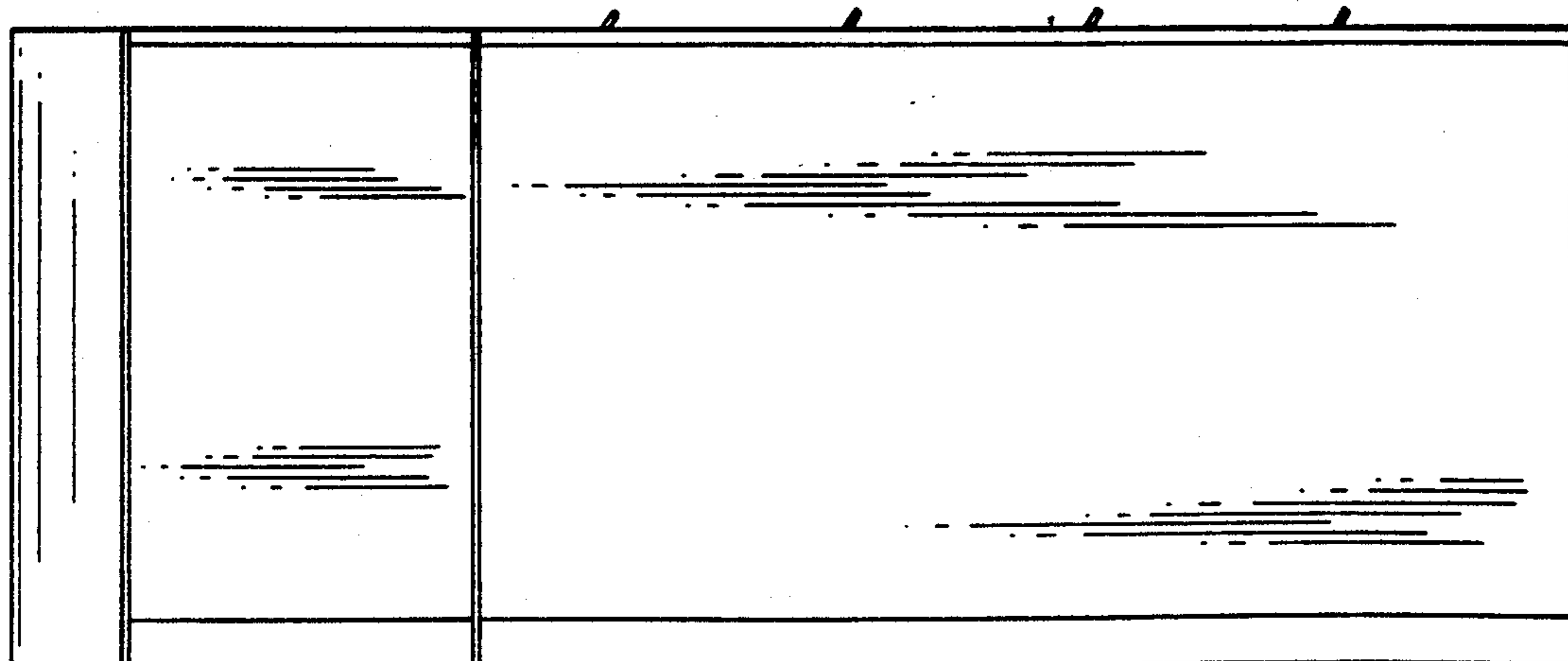

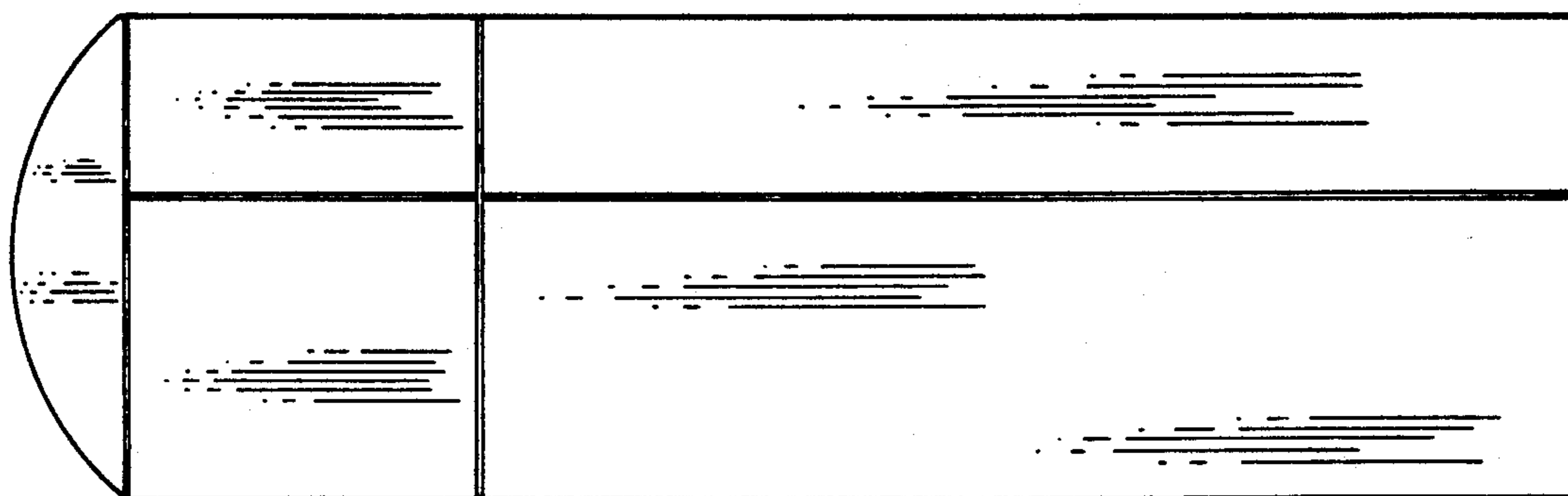

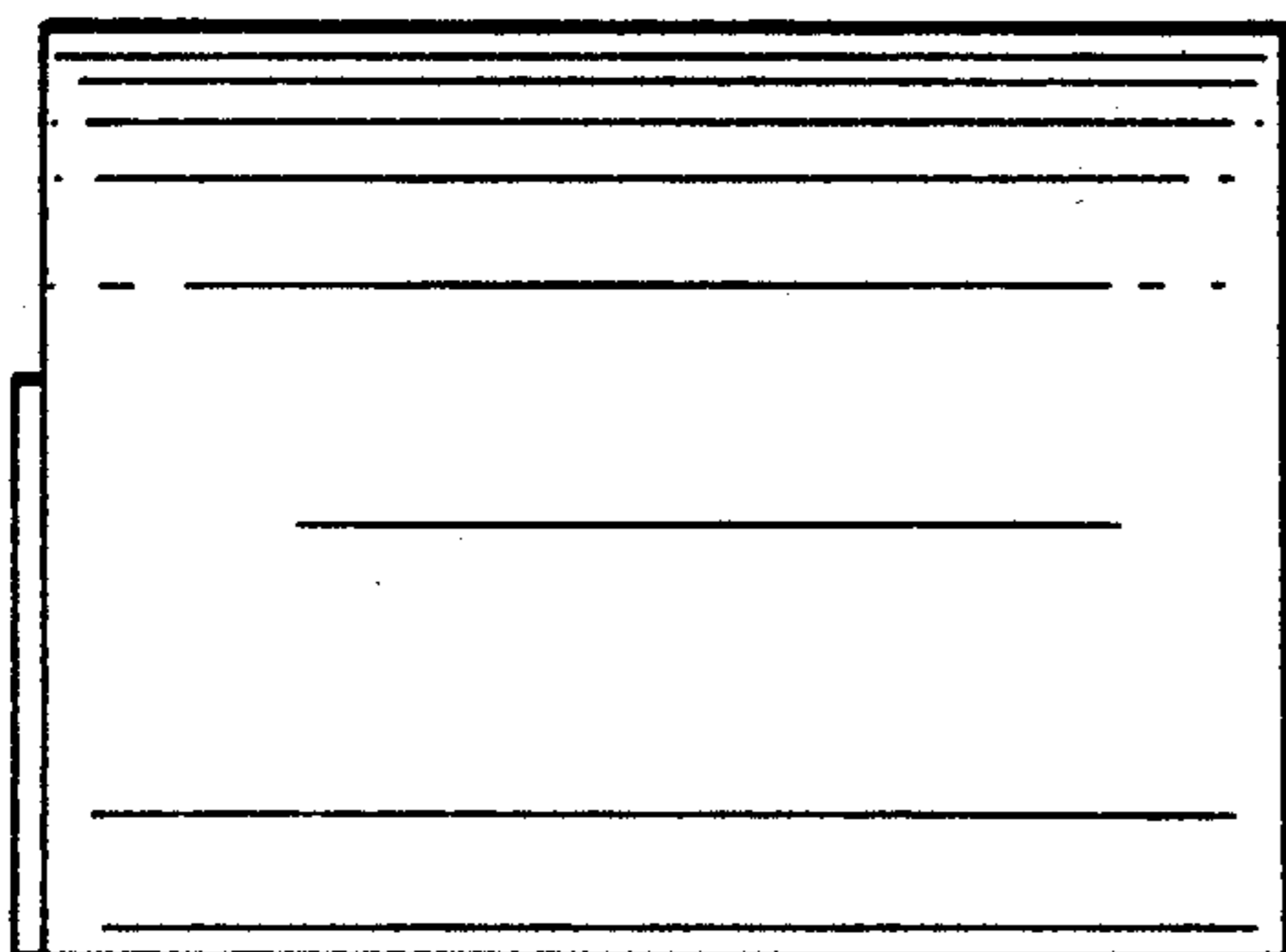

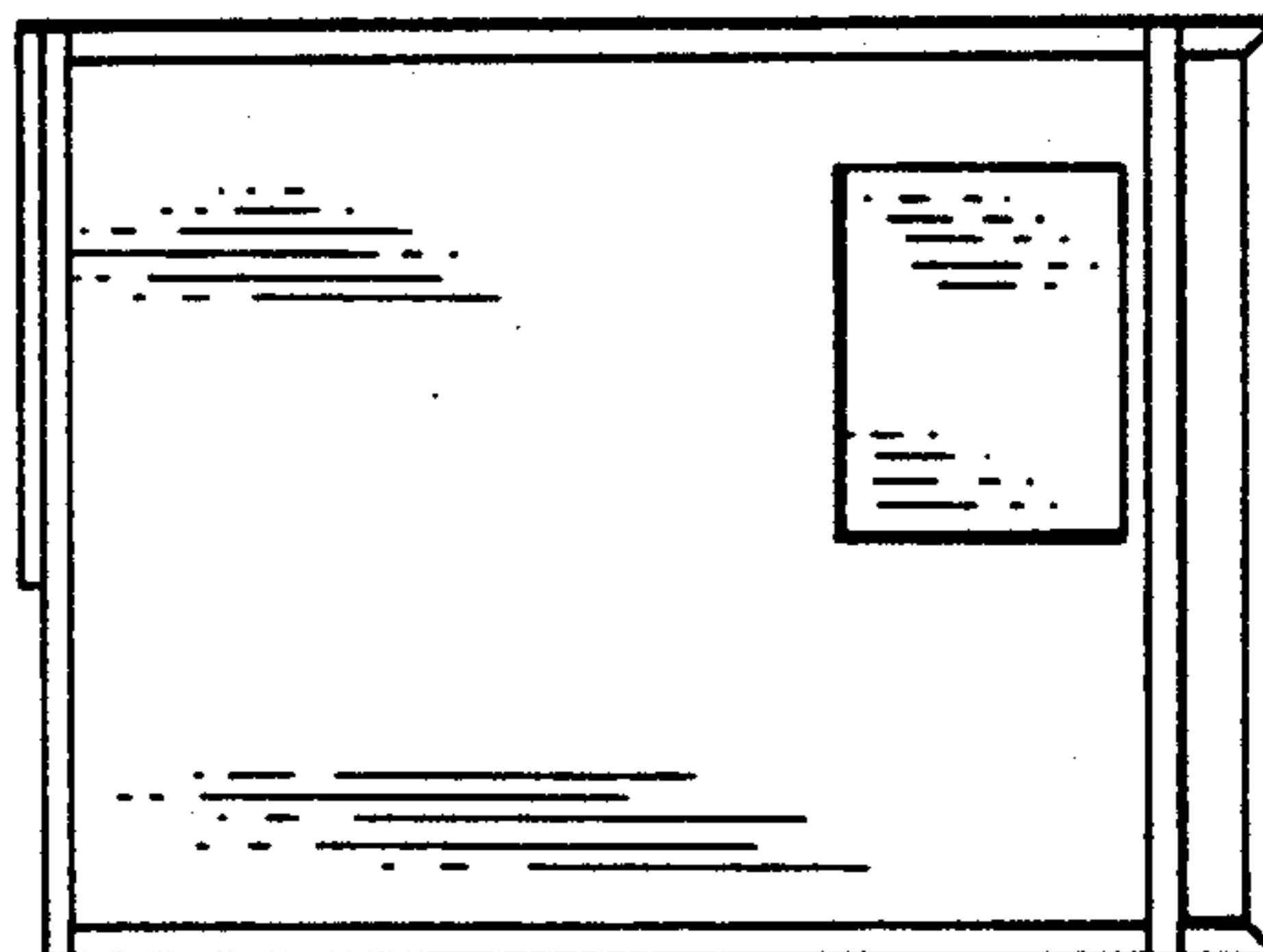

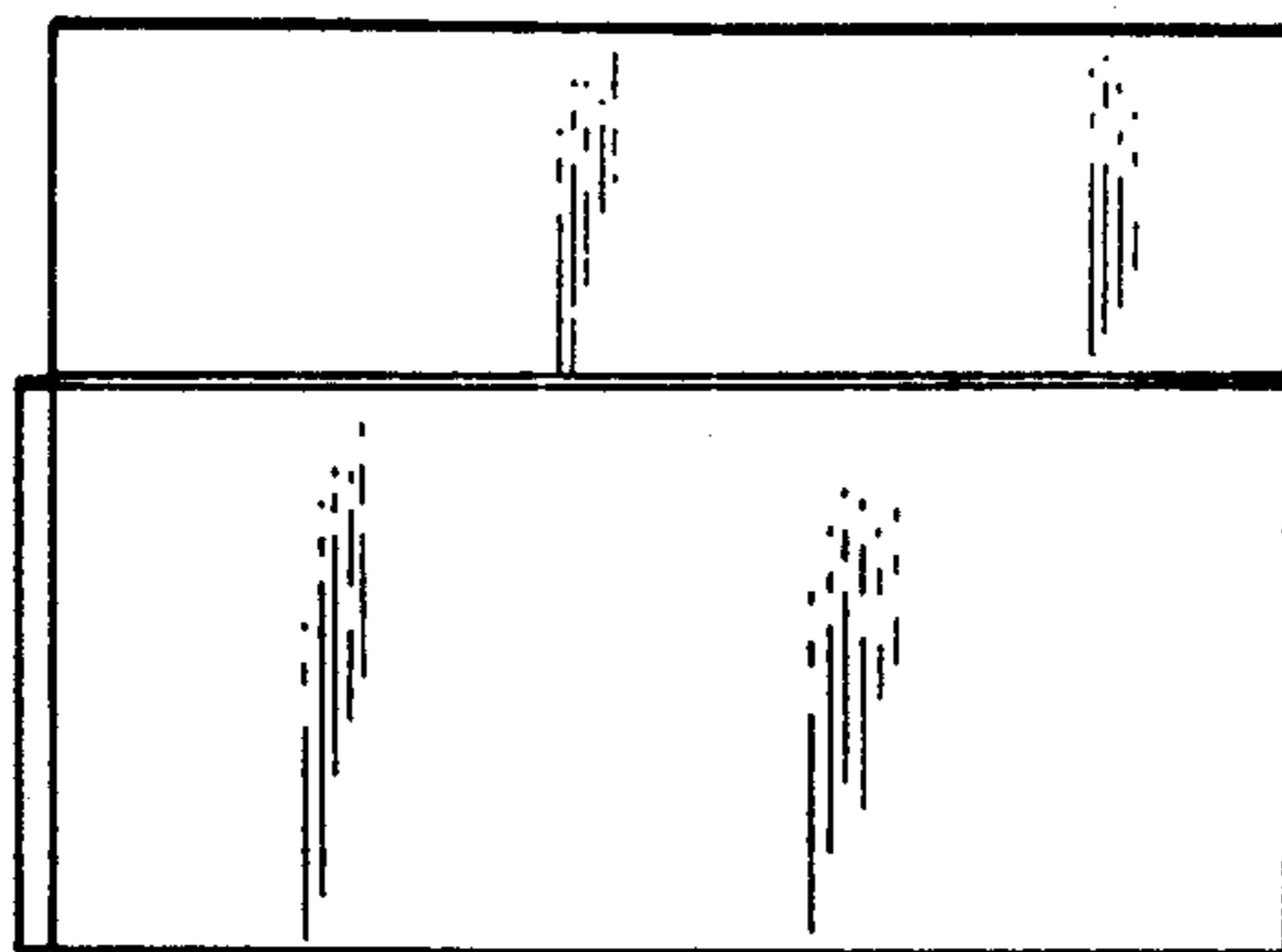

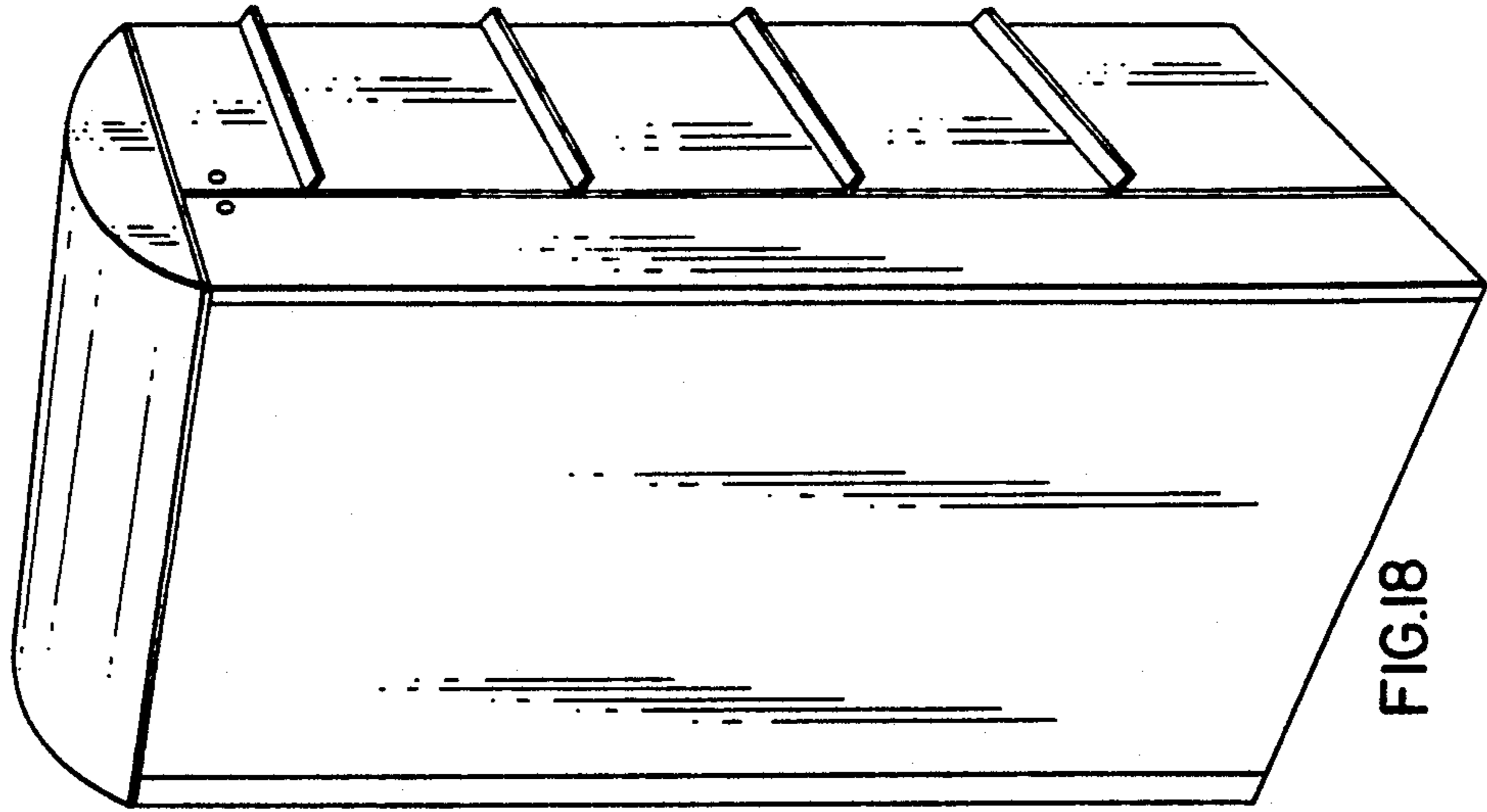

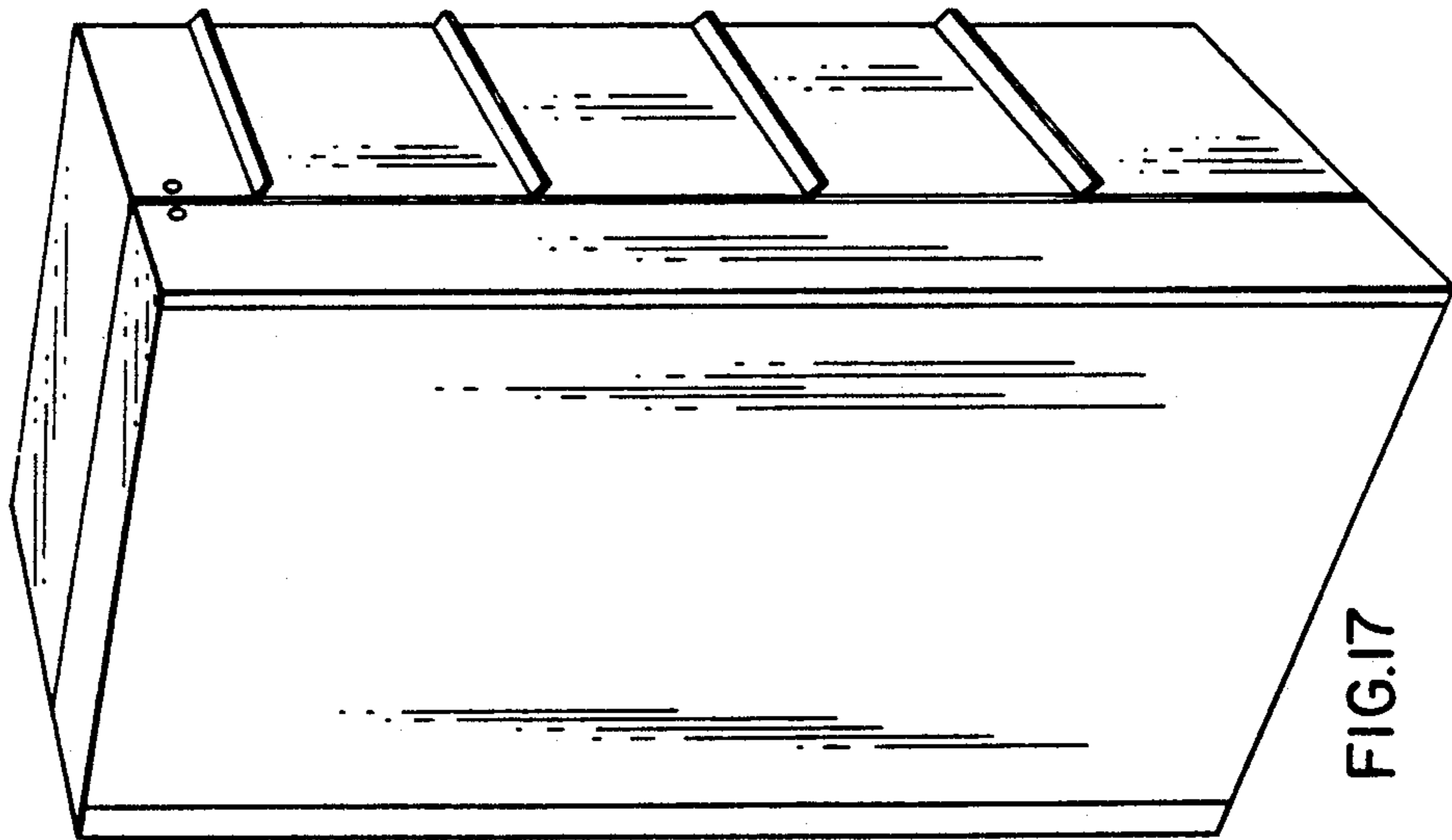

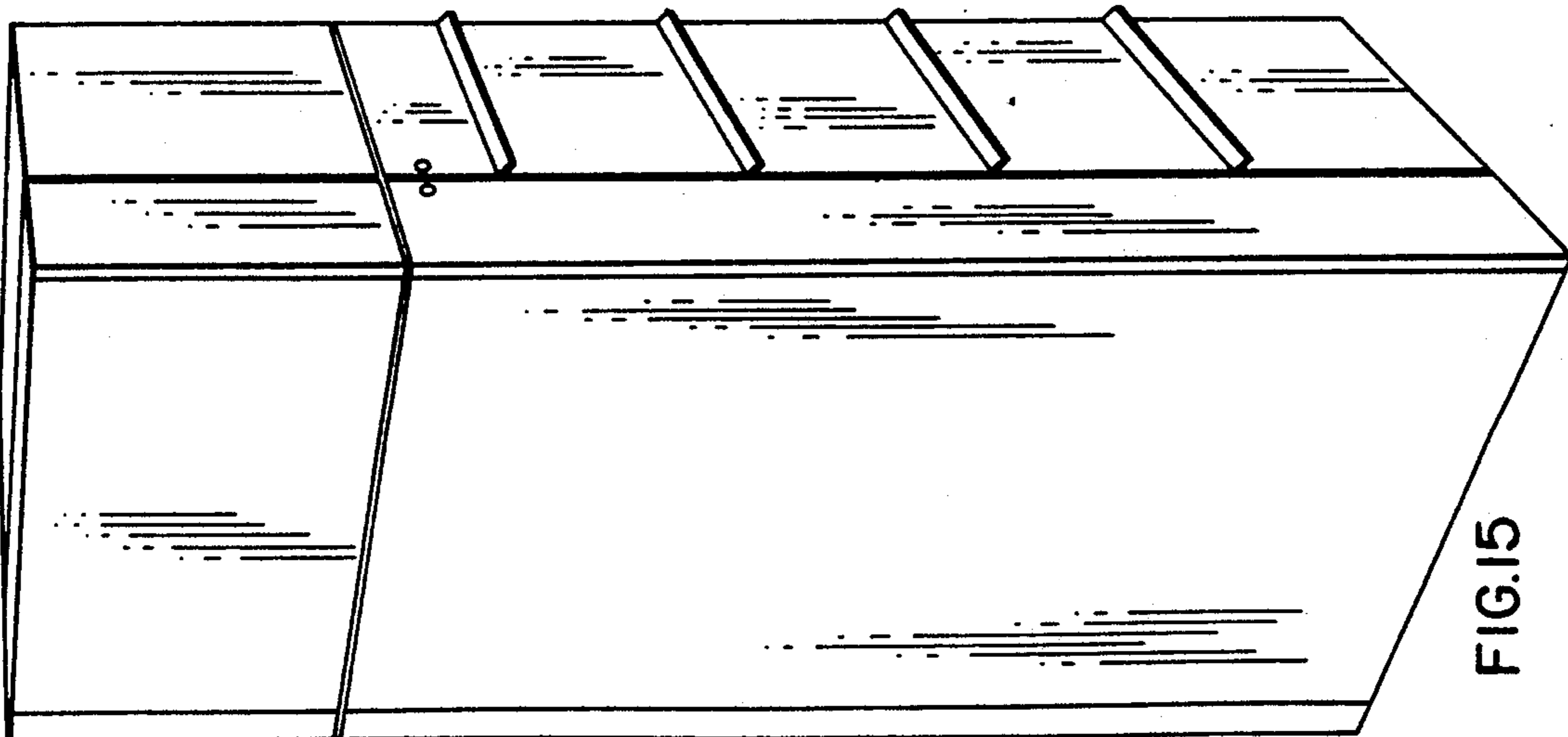
