FIG. 14 is a rear elevational view of FIG. 10;

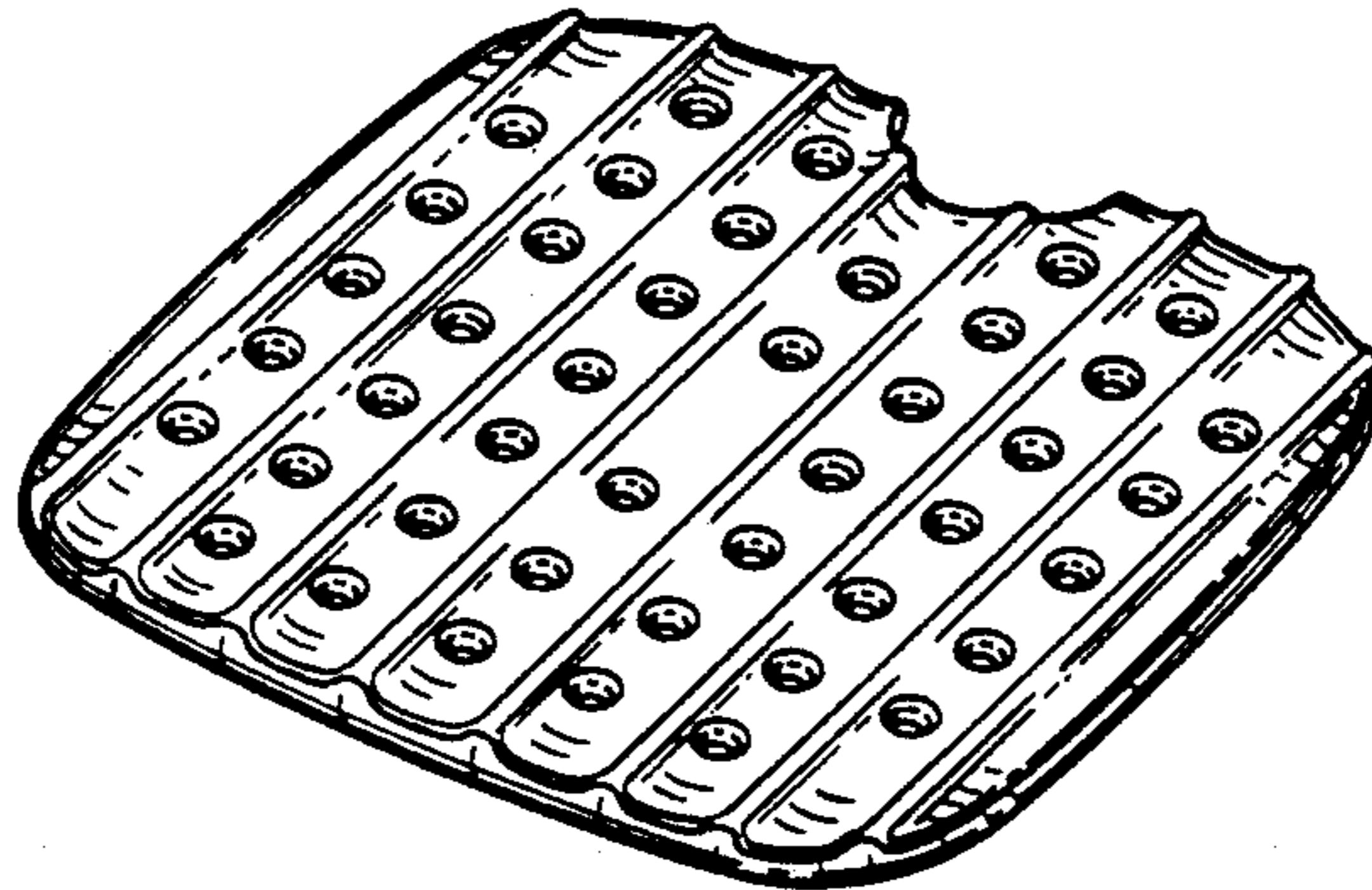
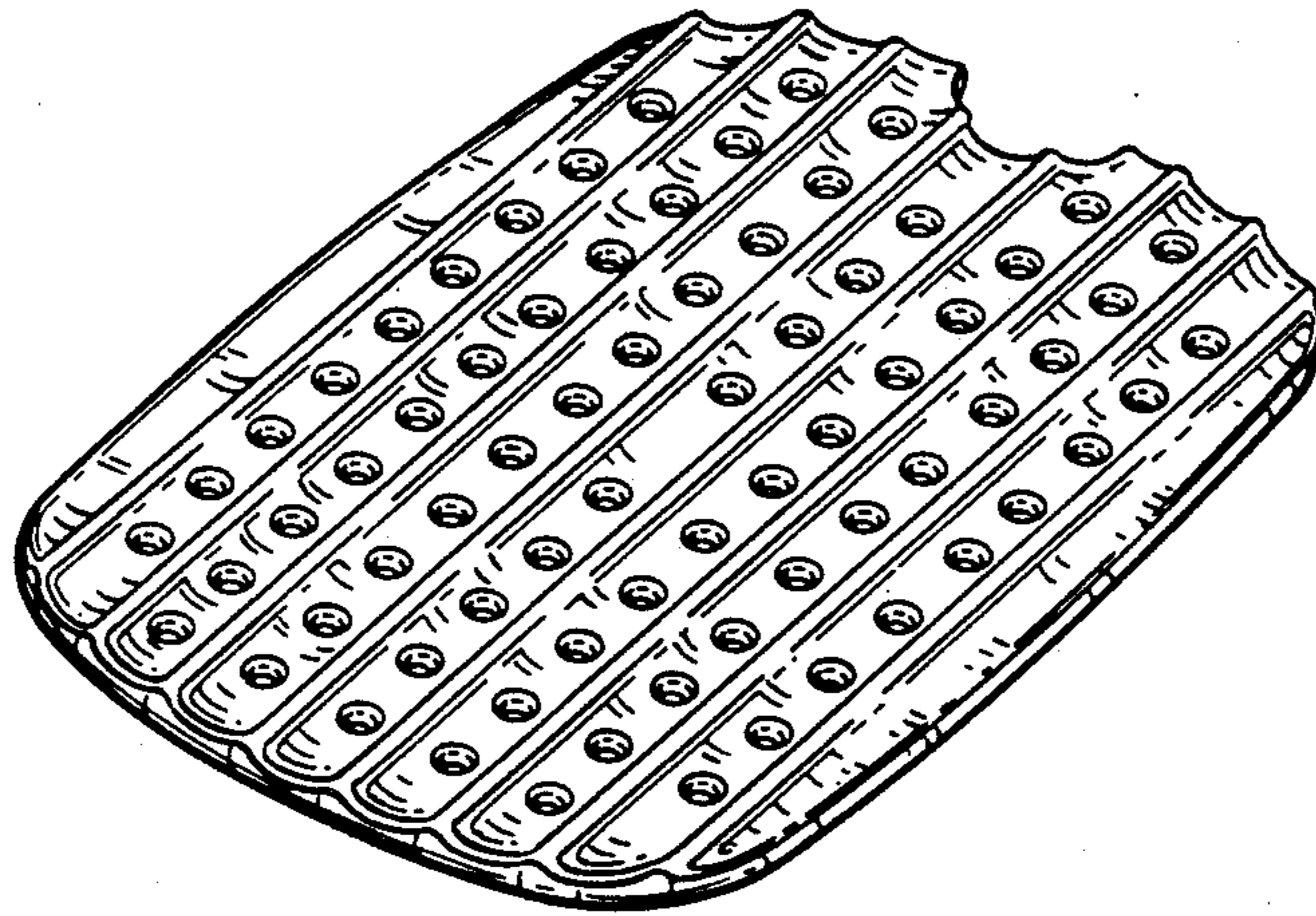
FIG. 15 is a right side elevational view of FIG. 10;

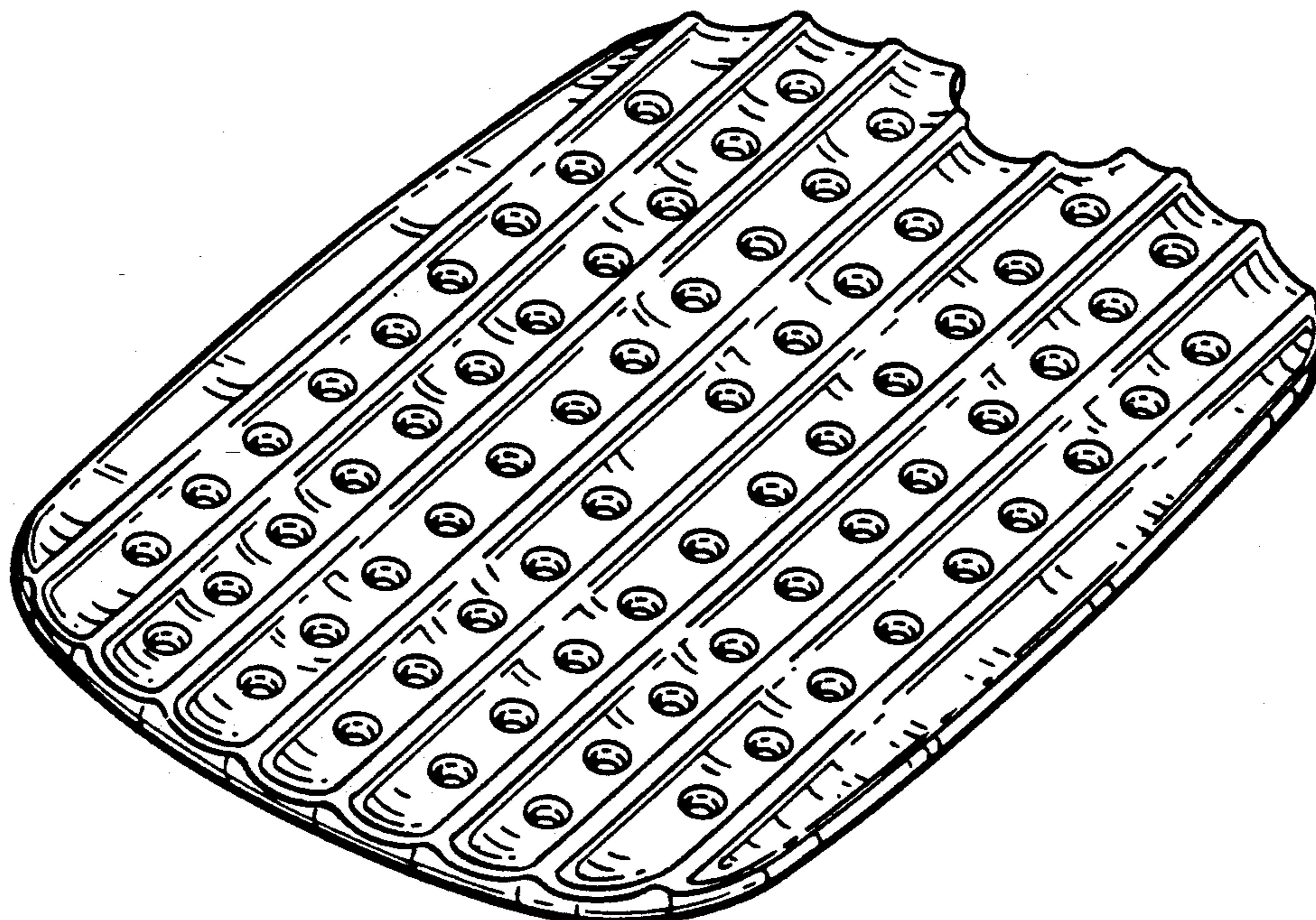

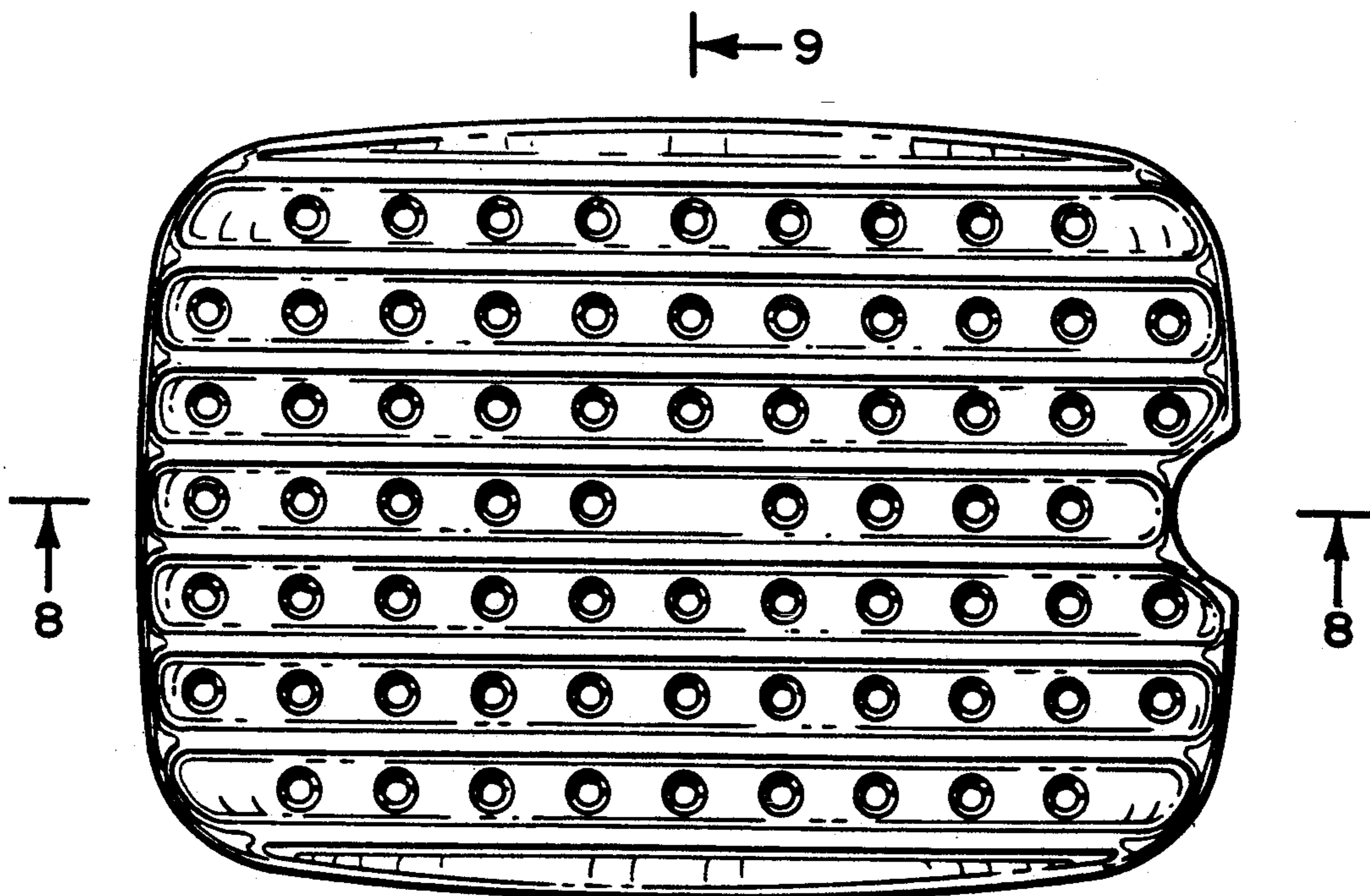

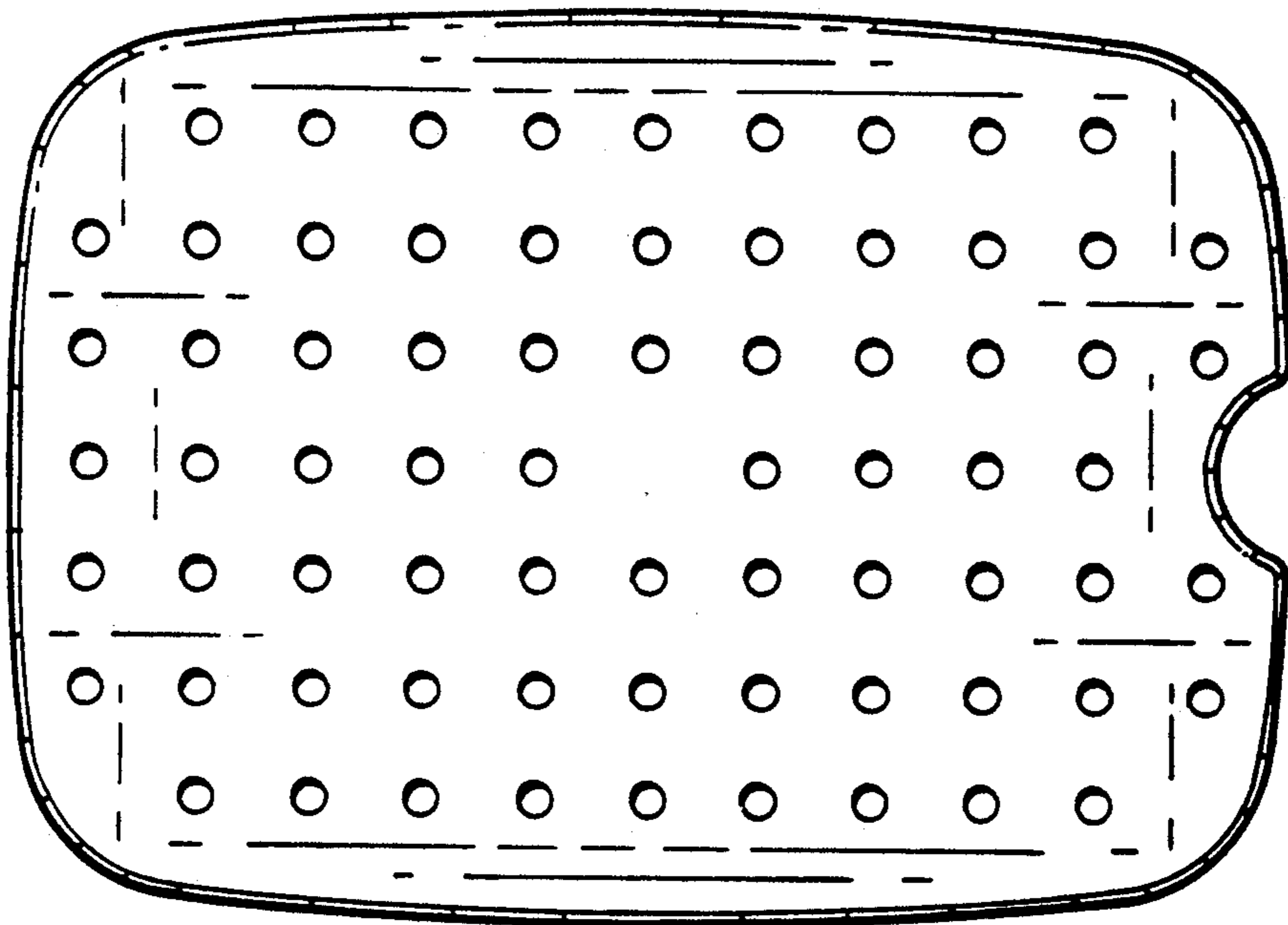

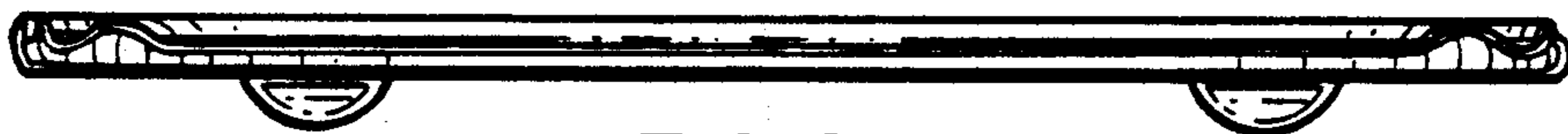

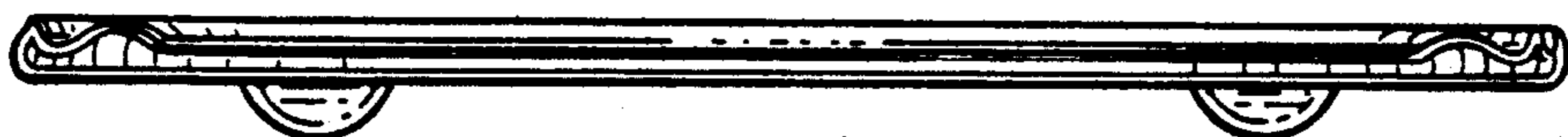

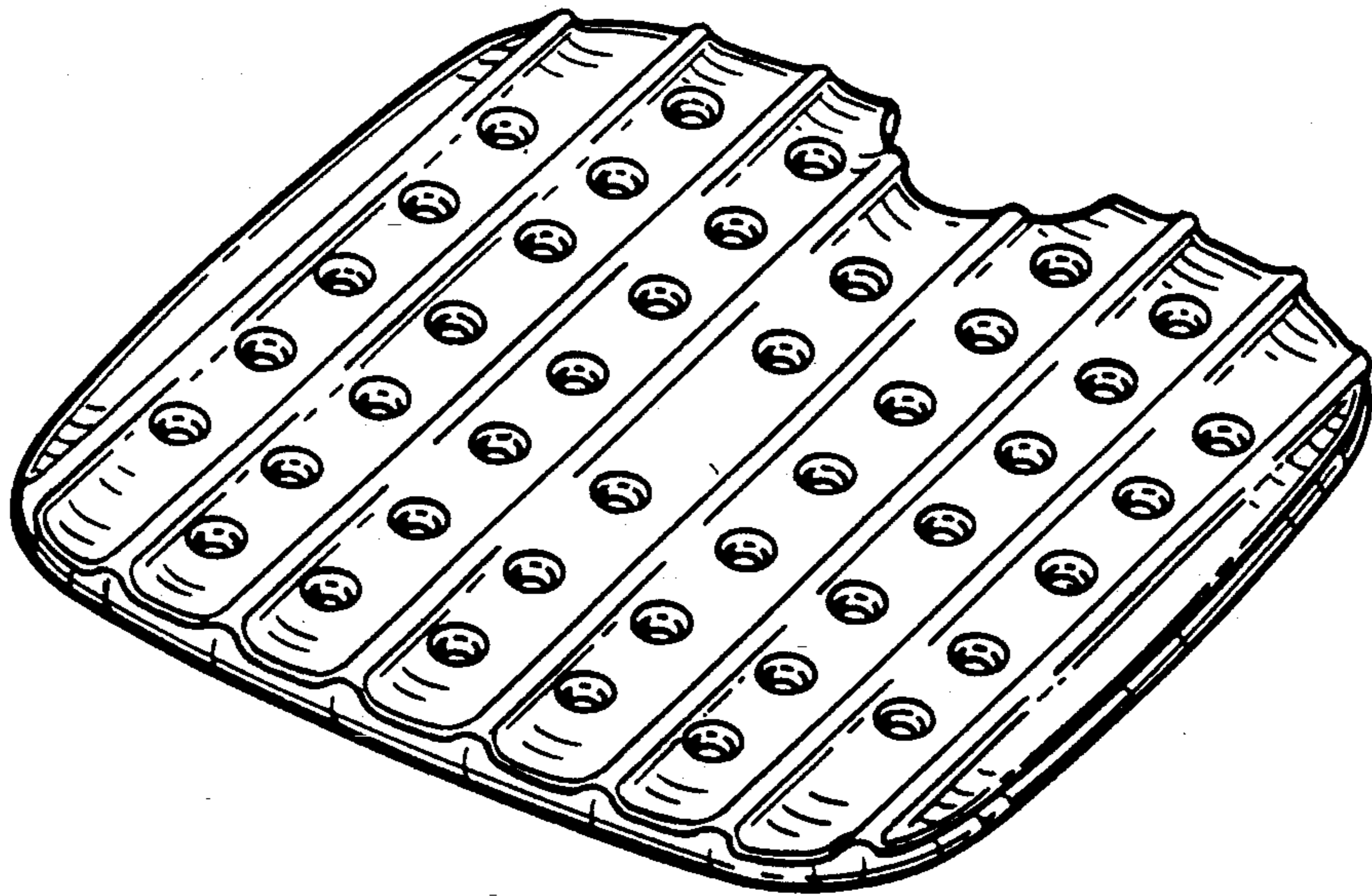

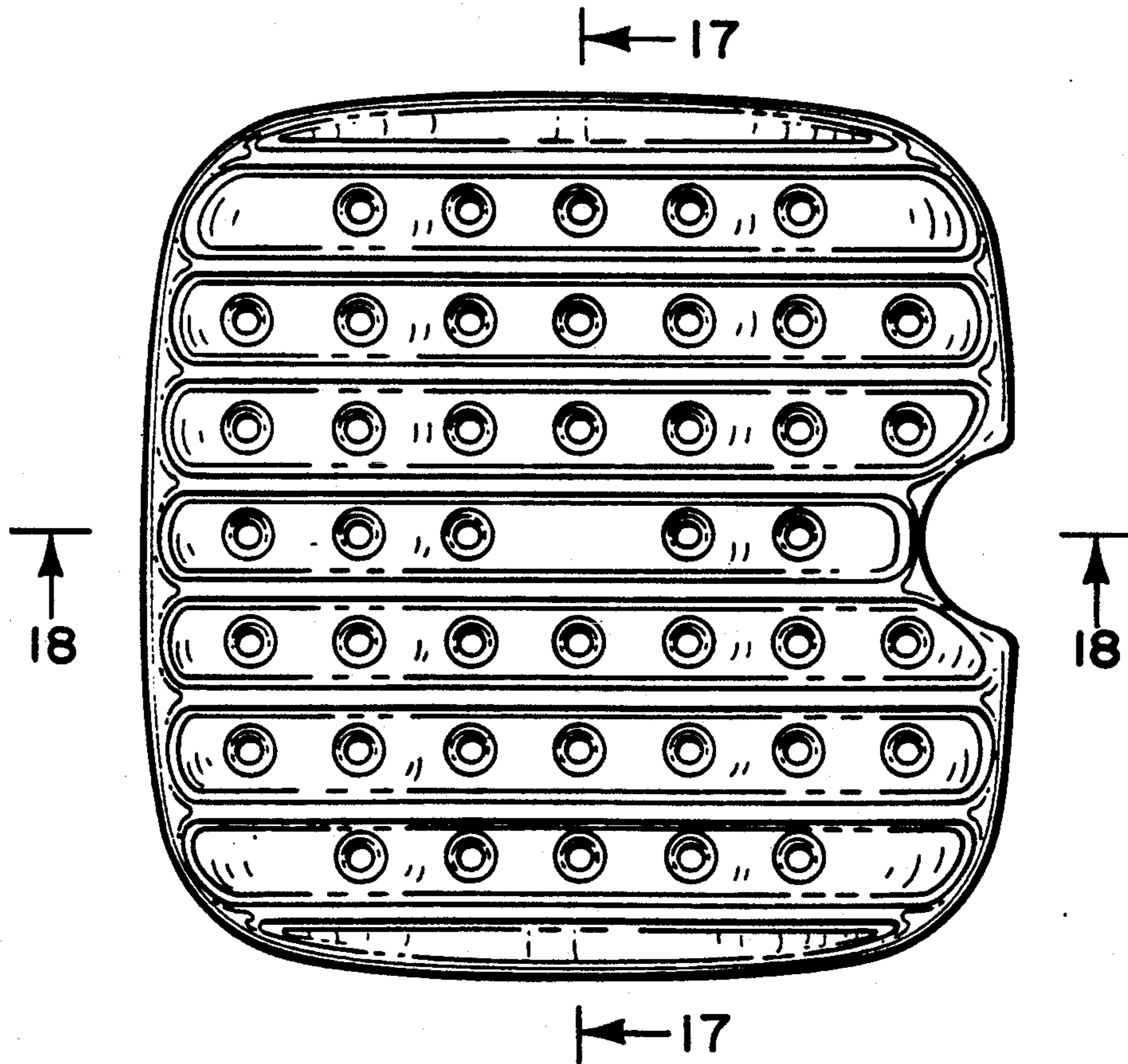

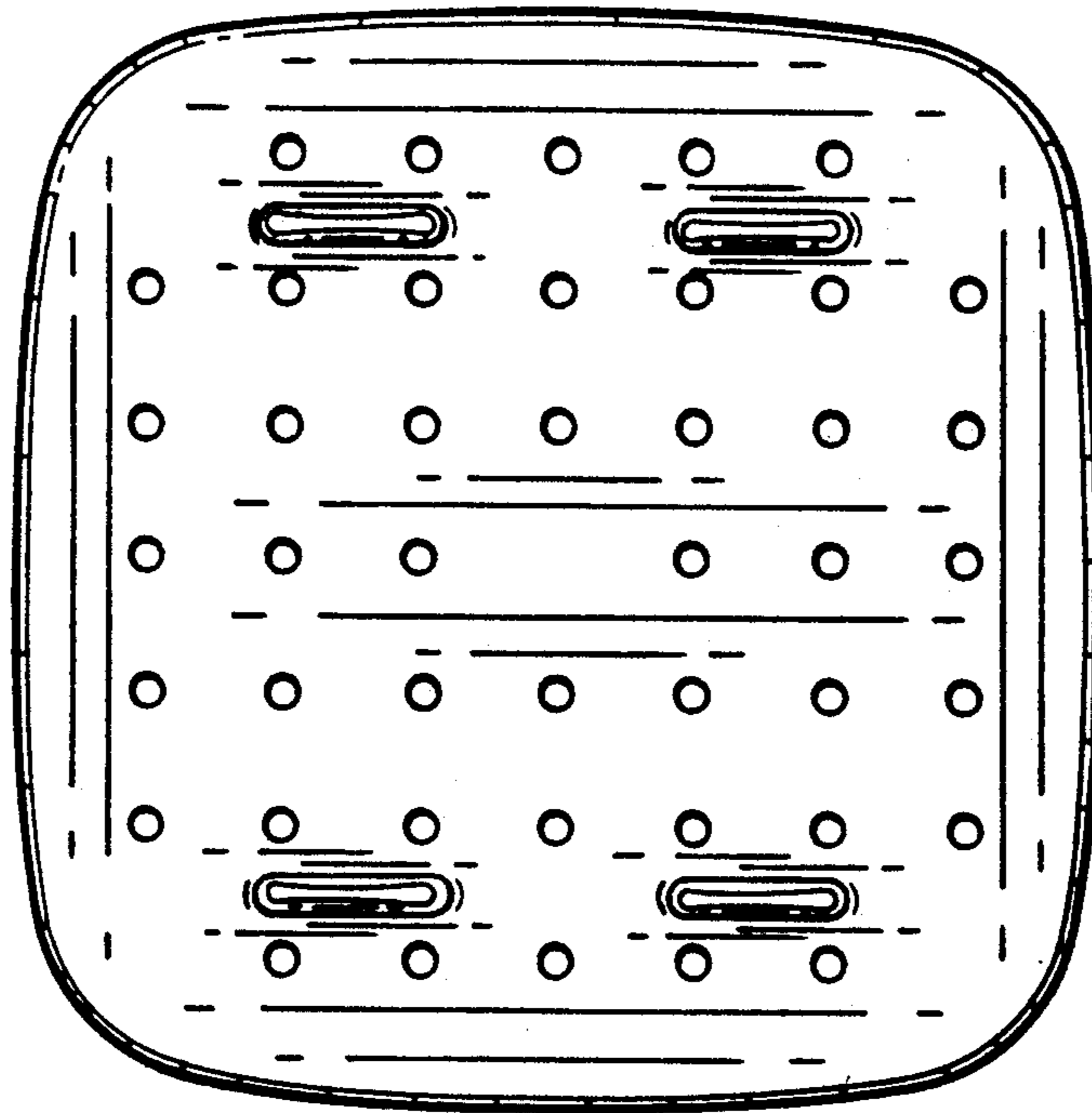

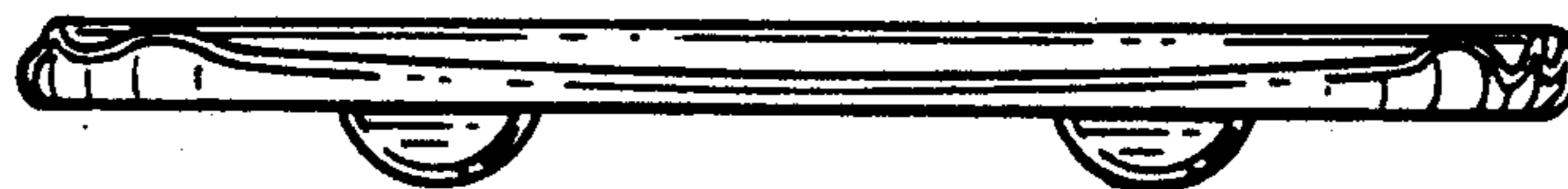

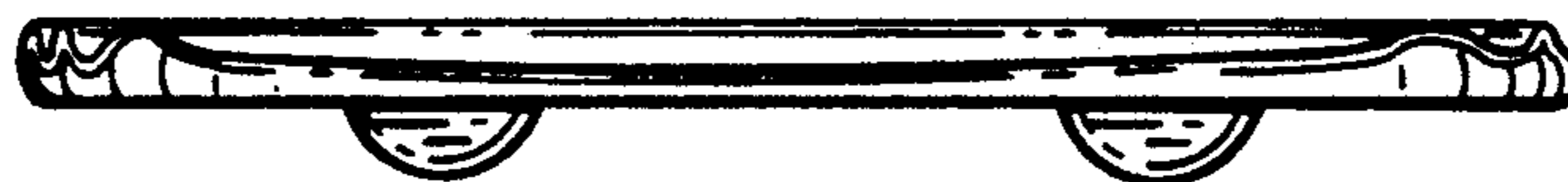
