The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a container showing my new design;
FIG. 2 is a rear elevation thereof;
FIG. 3 is a side elevation as seen from the left of FIG. 1, the right side being a mirror image thereof;
FIG. 4 is a bottom plan view thereof; and,
FIG. 5 is a top plan view thereof.

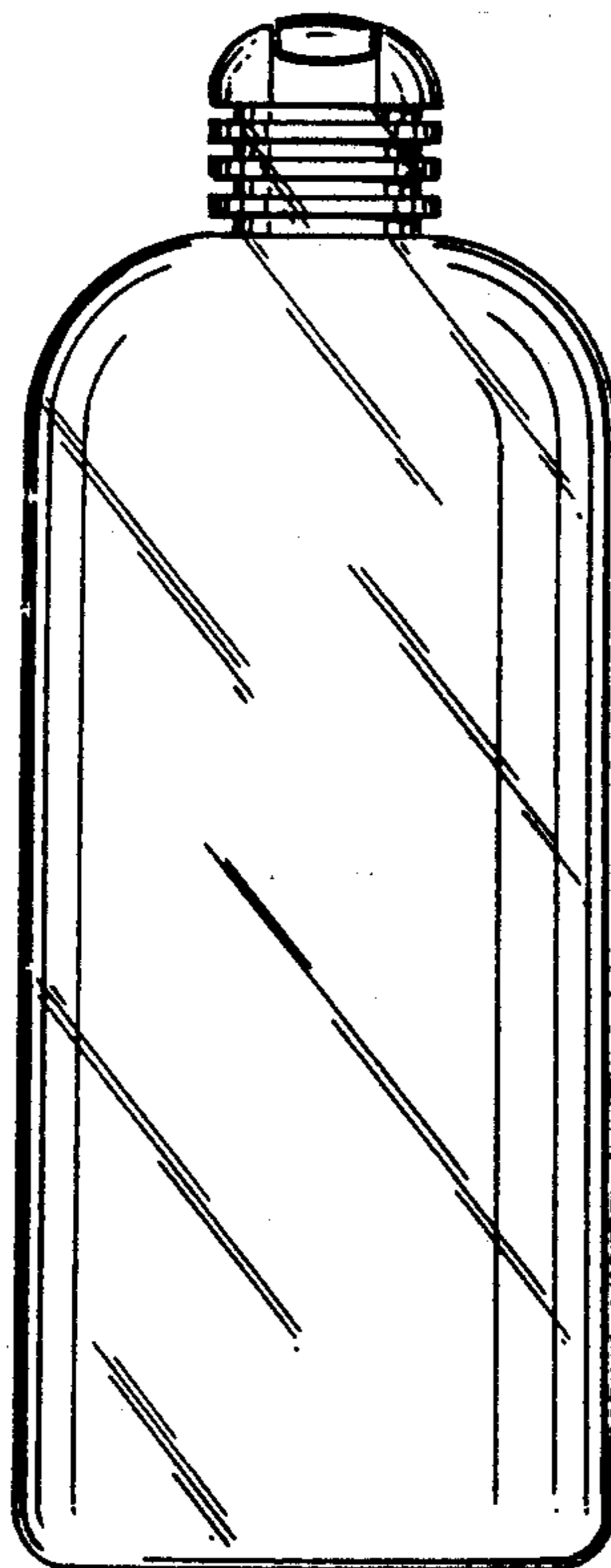

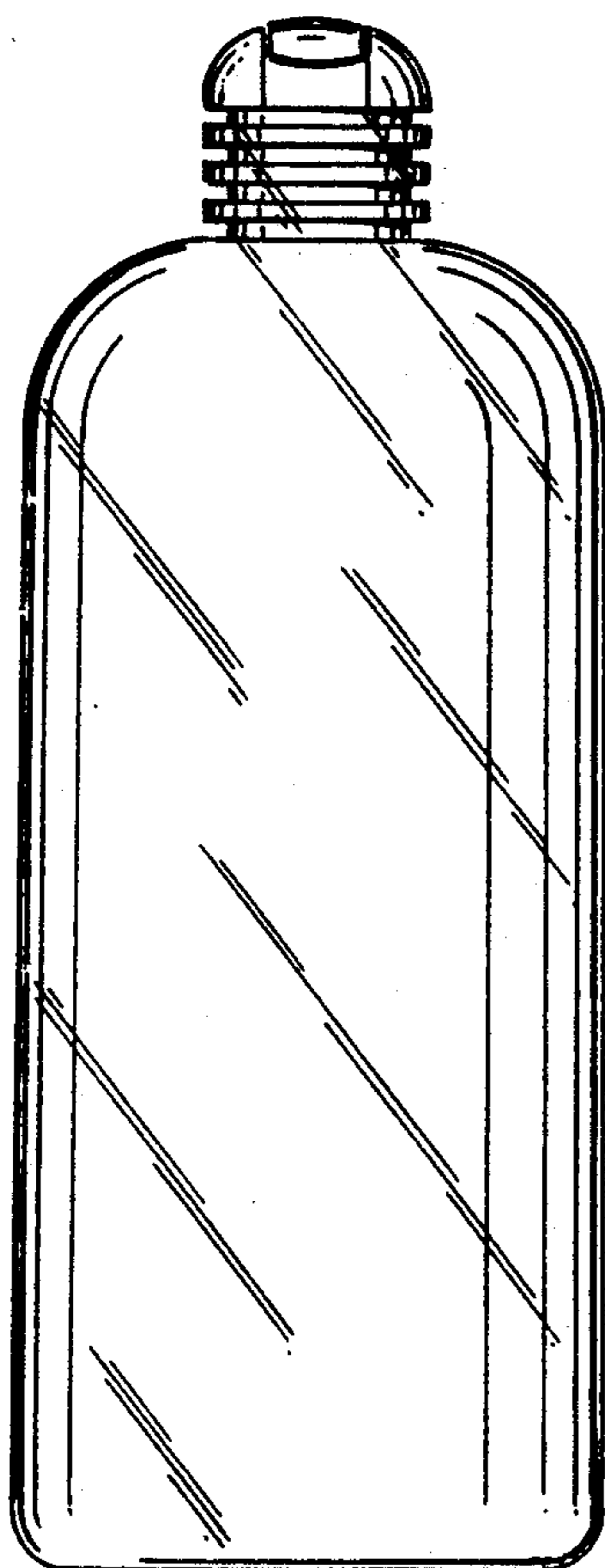

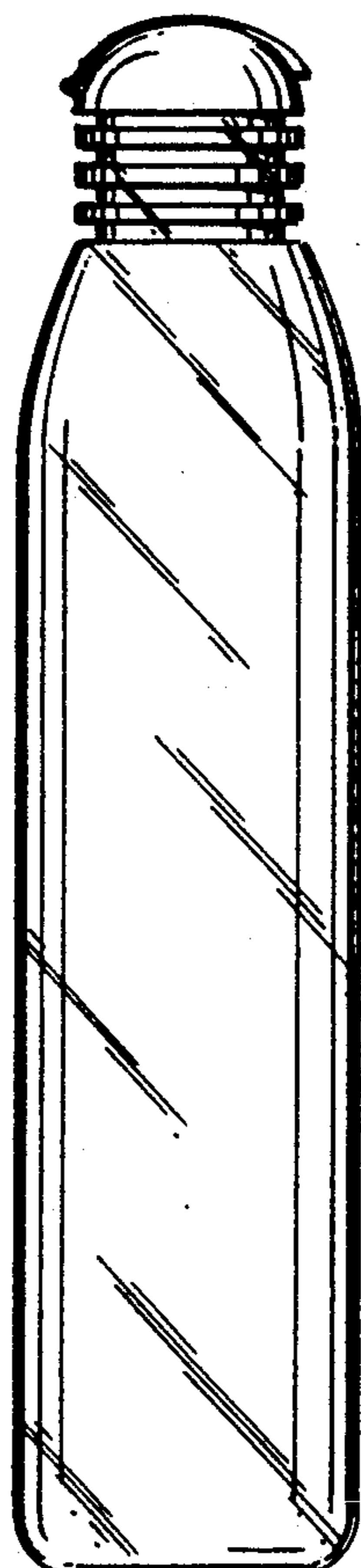

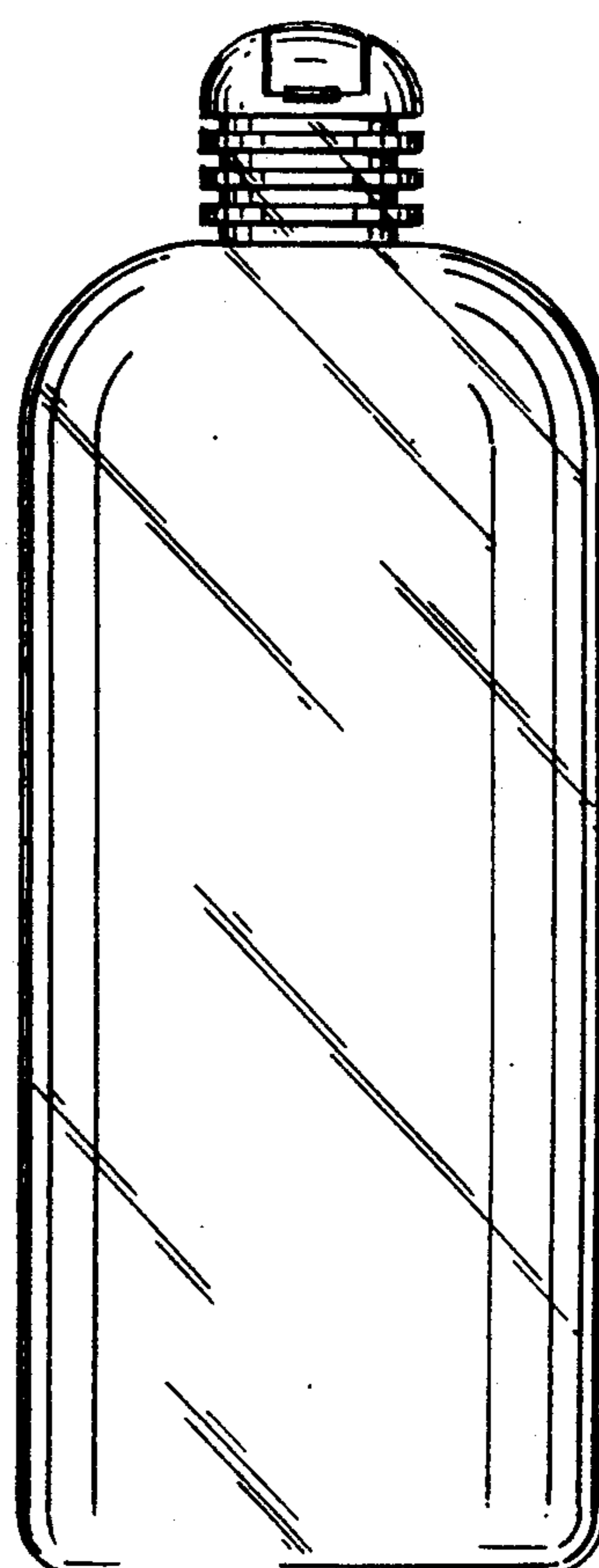

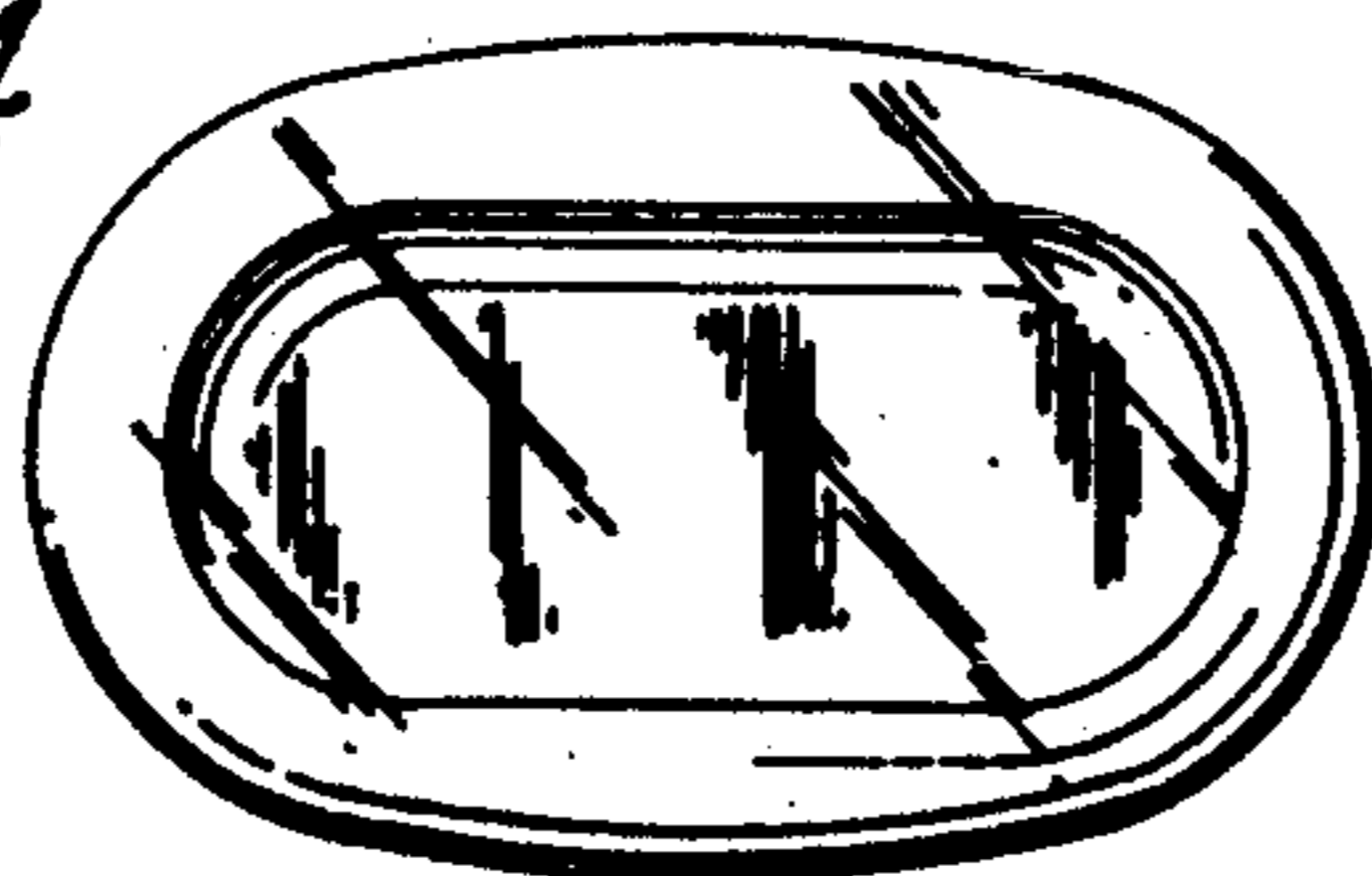
