[57] CLAIM

The ornamental design for a rotatable product display stand, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rotatable product display stand showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof, the right side view being a mirror image;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a top plan view thereof taken along line 7—7 of FIG. 3;

FIG. 8 is a front perspective view of a second embodiment of my design;

FIG. 9 is a top plan view thereof;

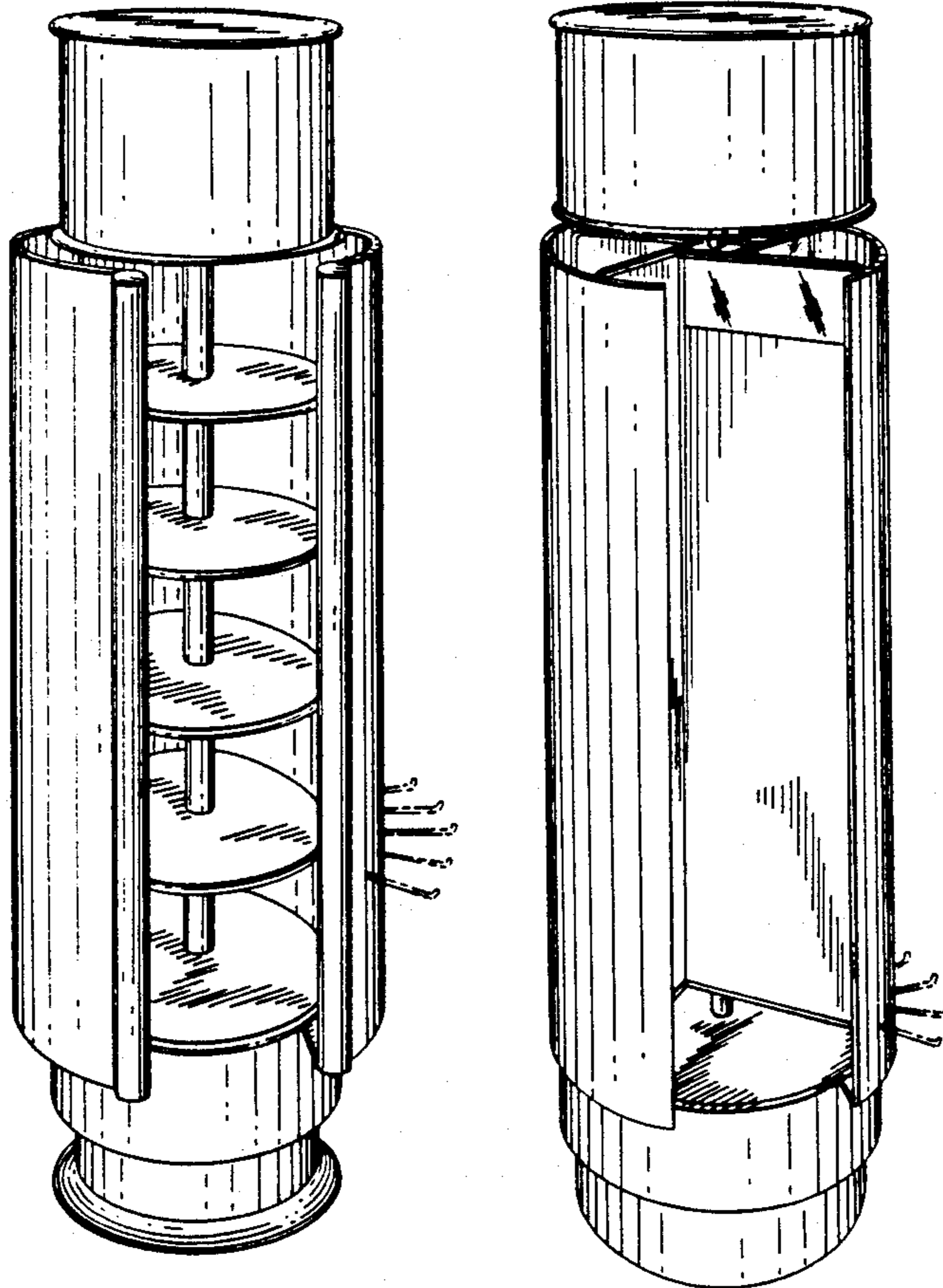
FIG. 10 is a front elevation view thereof;

FIG. 11 is a bottom plan view thereof;

FIG. 12 is a rear elevation view thereof; and,

FIG. 13 is a top plan view thereof taken along line 13—13 in FIG. 10; the left and right side elevation view being identical to those of the first embodiment as set forth in FIG. 4.

The broken line showings in FIGS 1 and 8 are for illustrative purposes only.



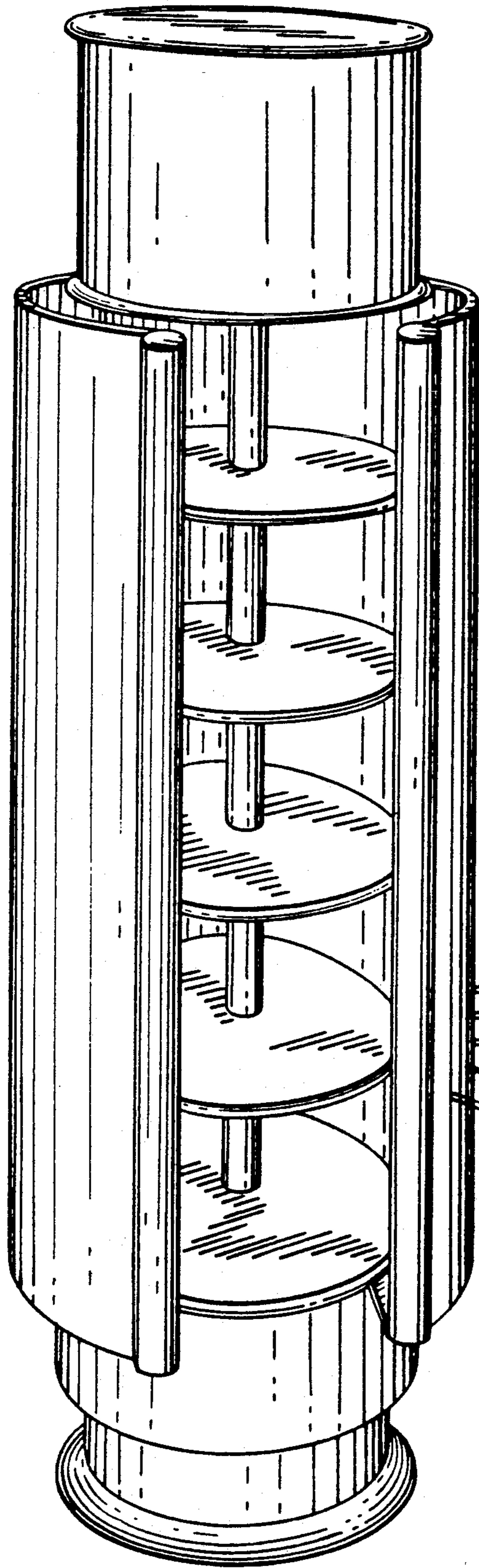
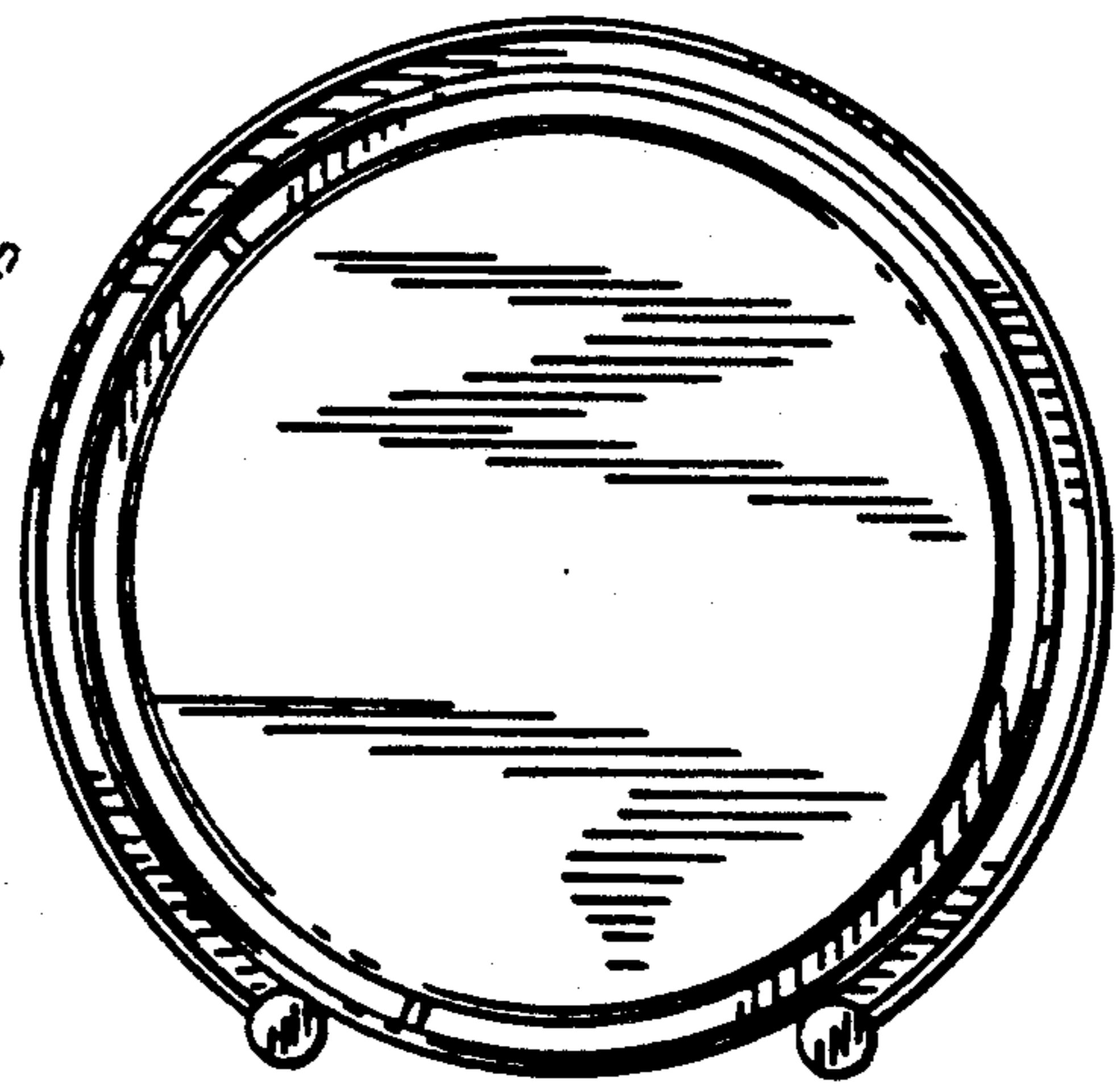
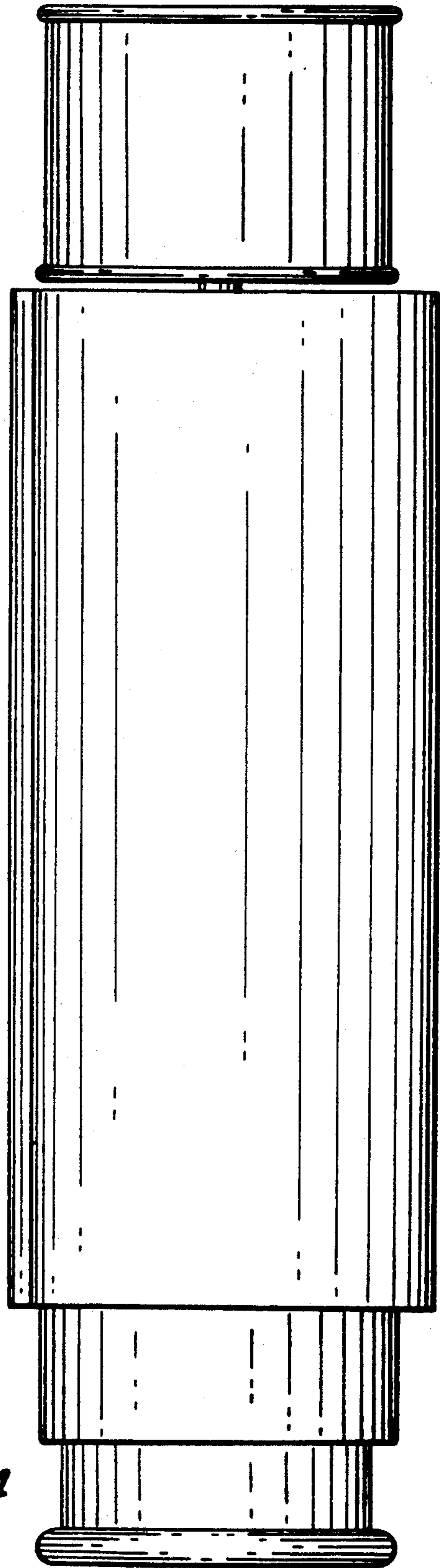
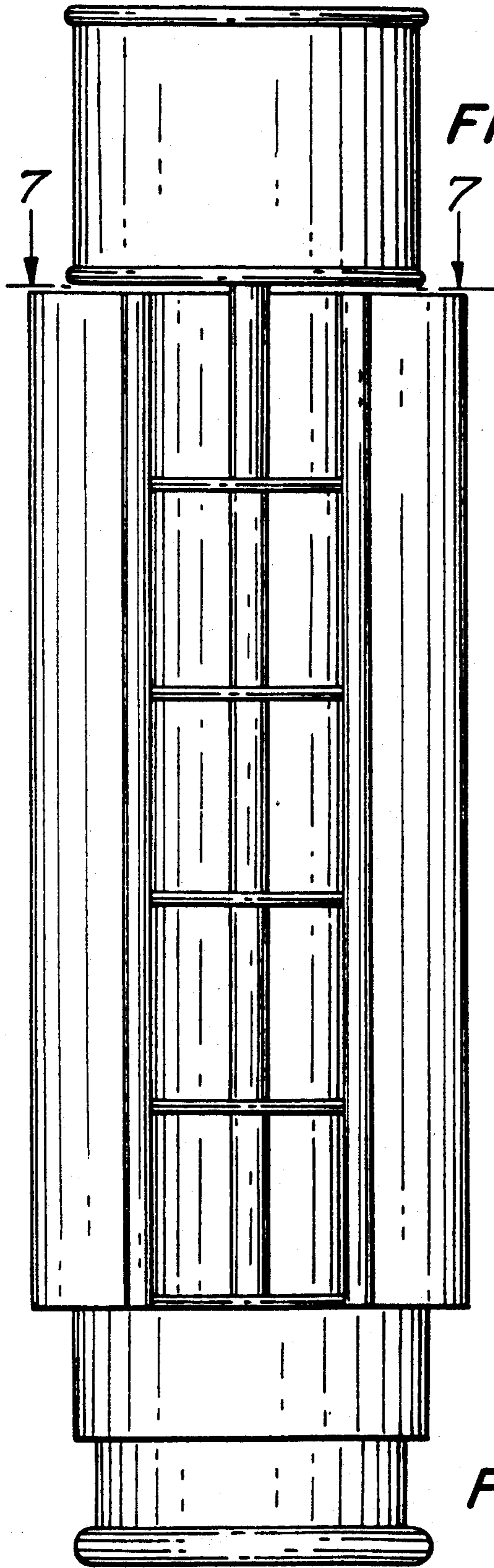

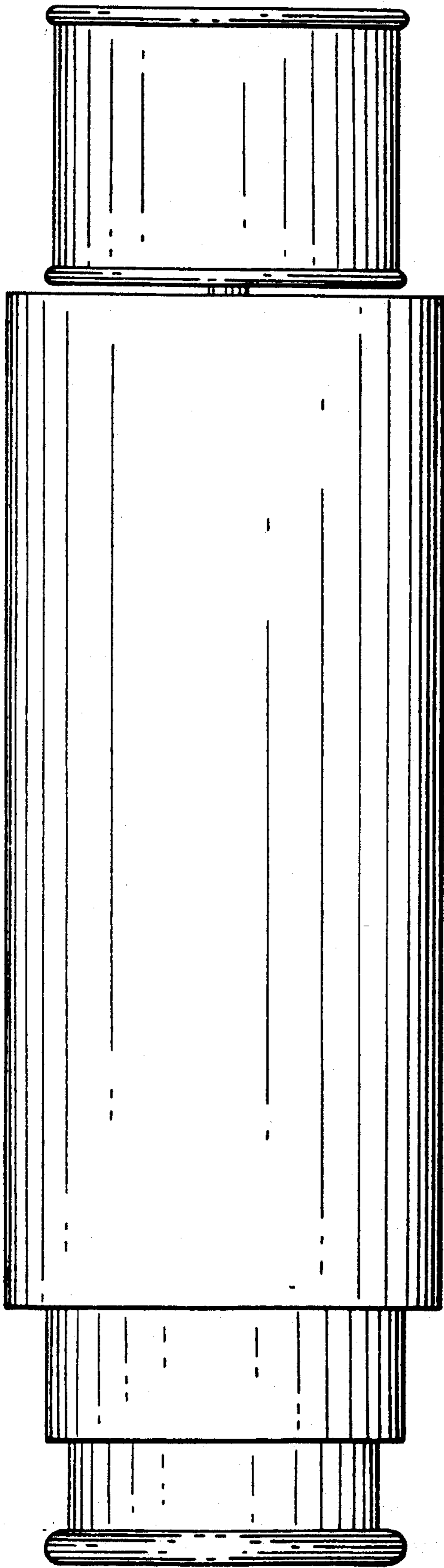

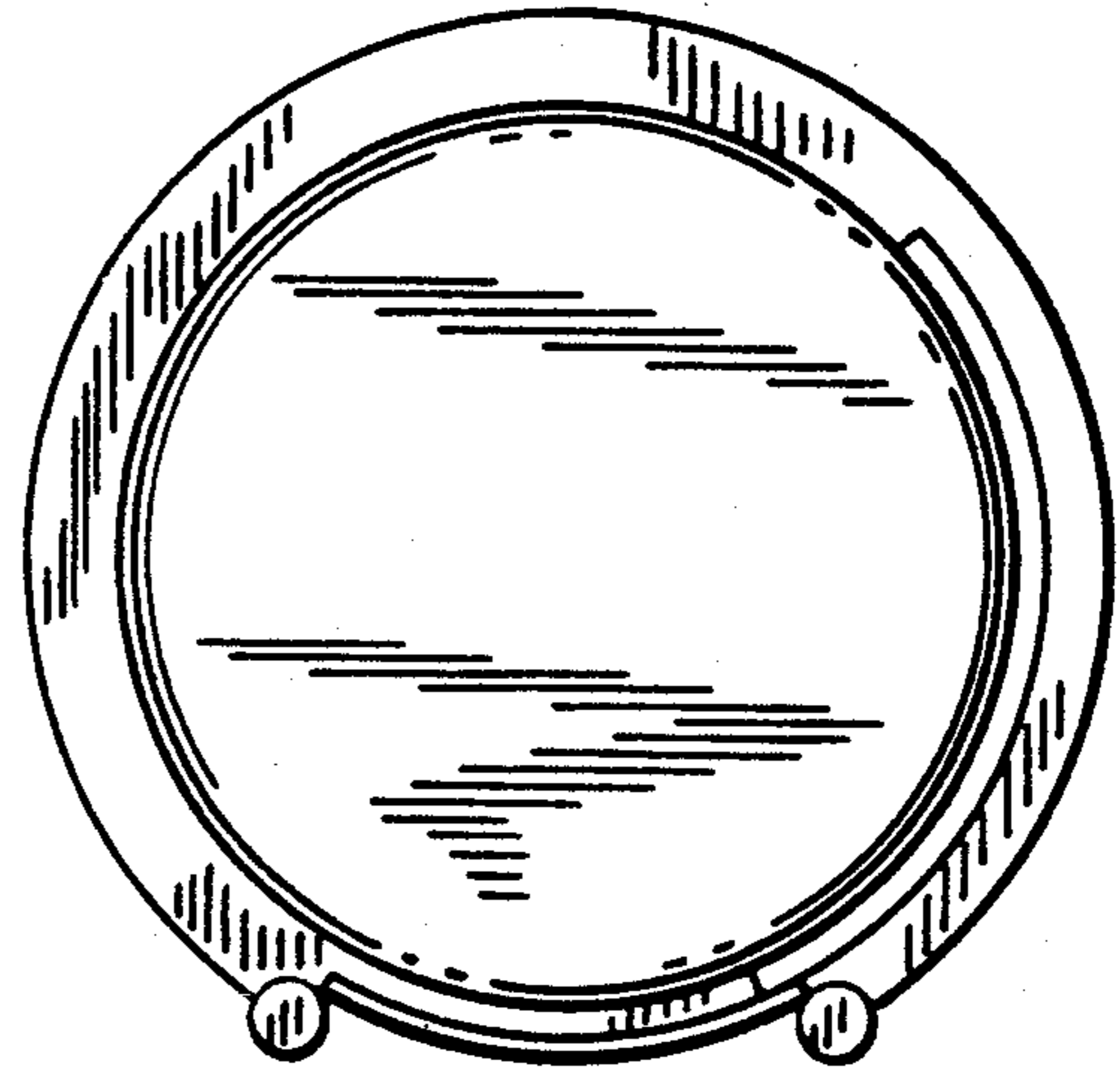

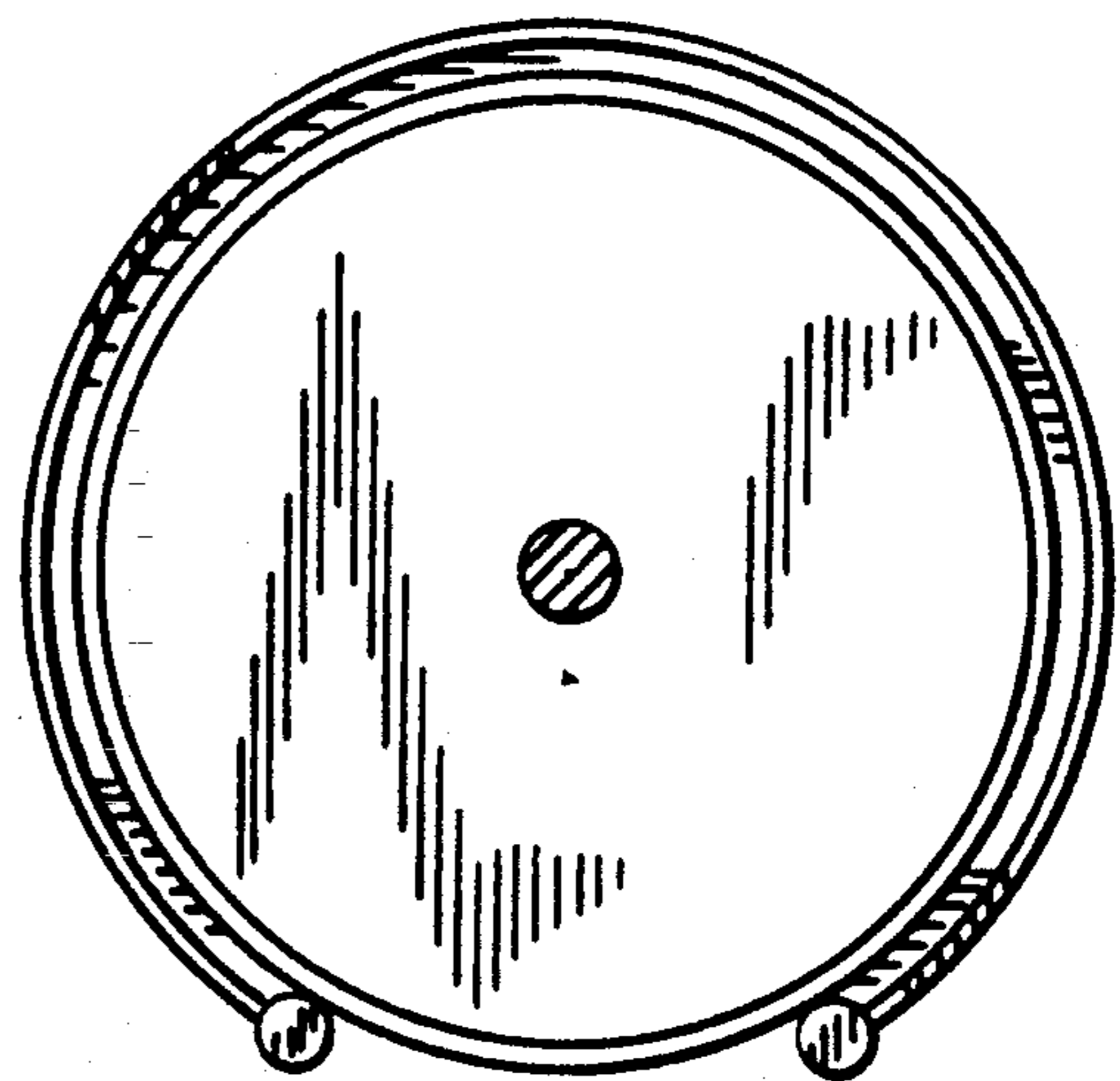

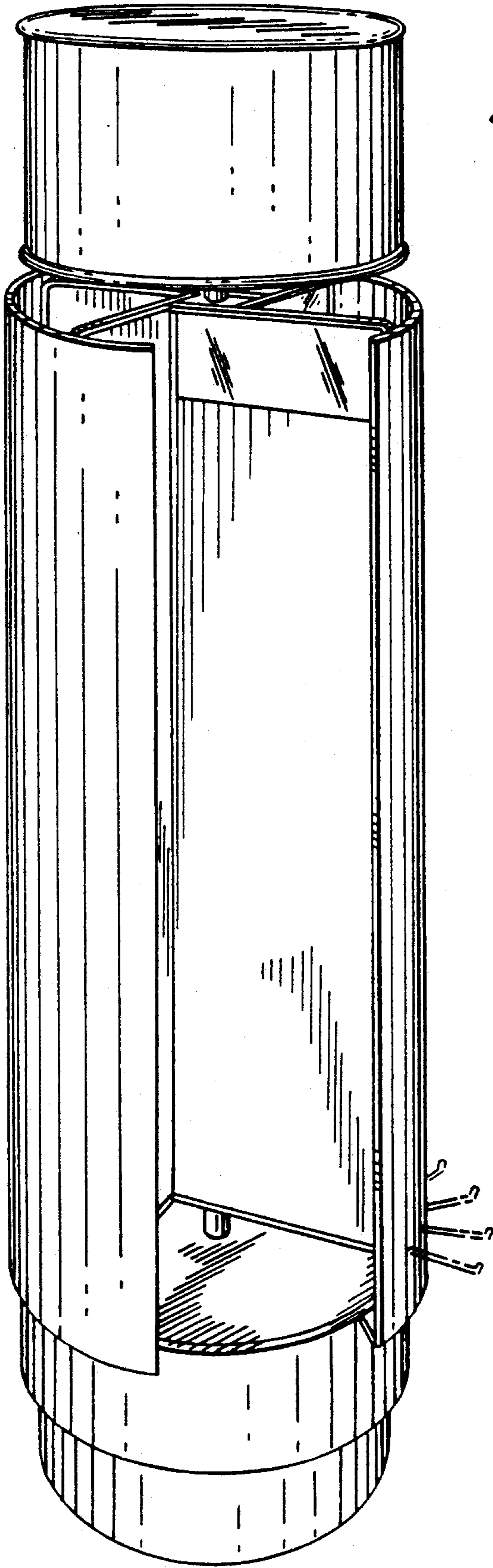

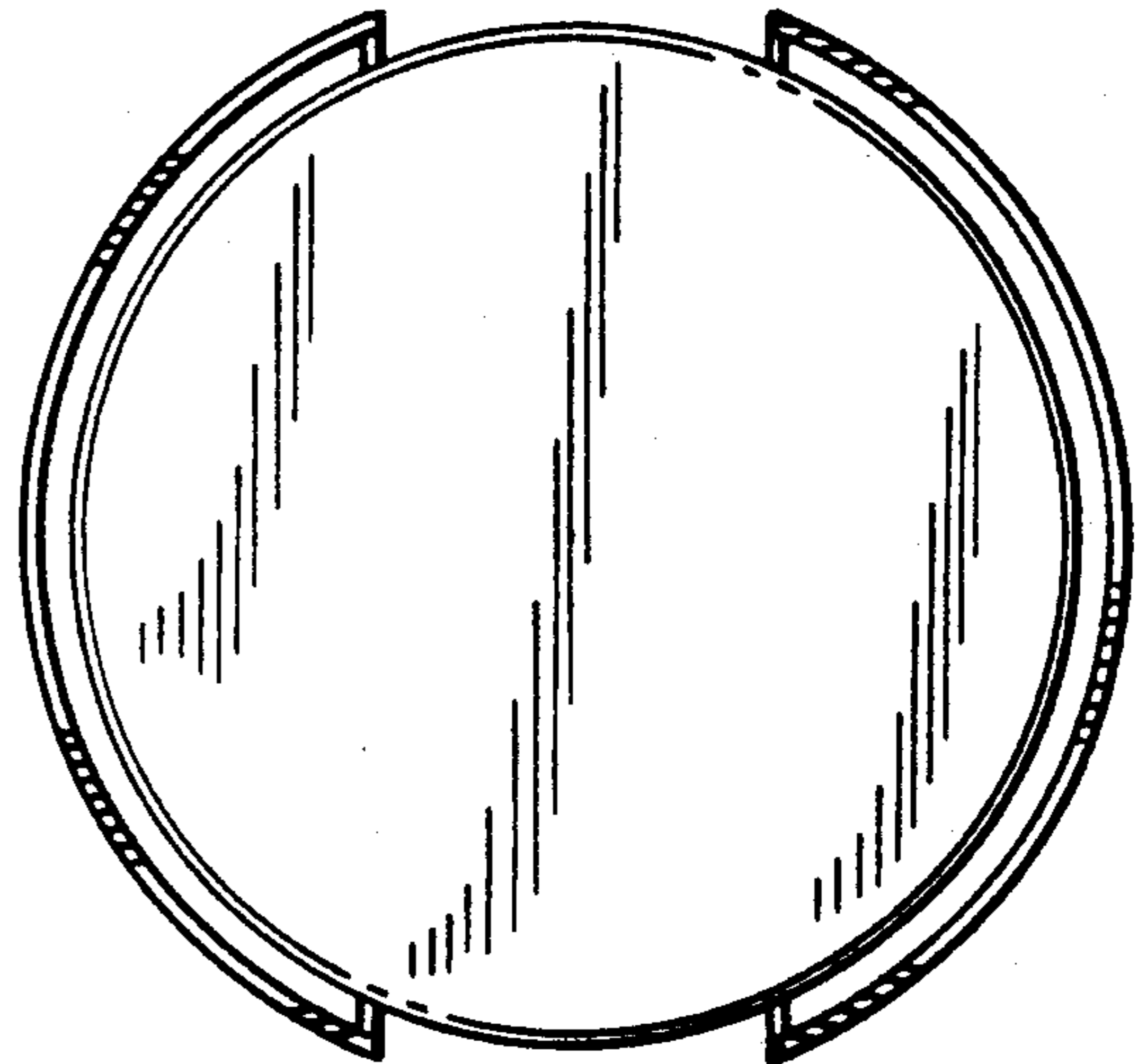

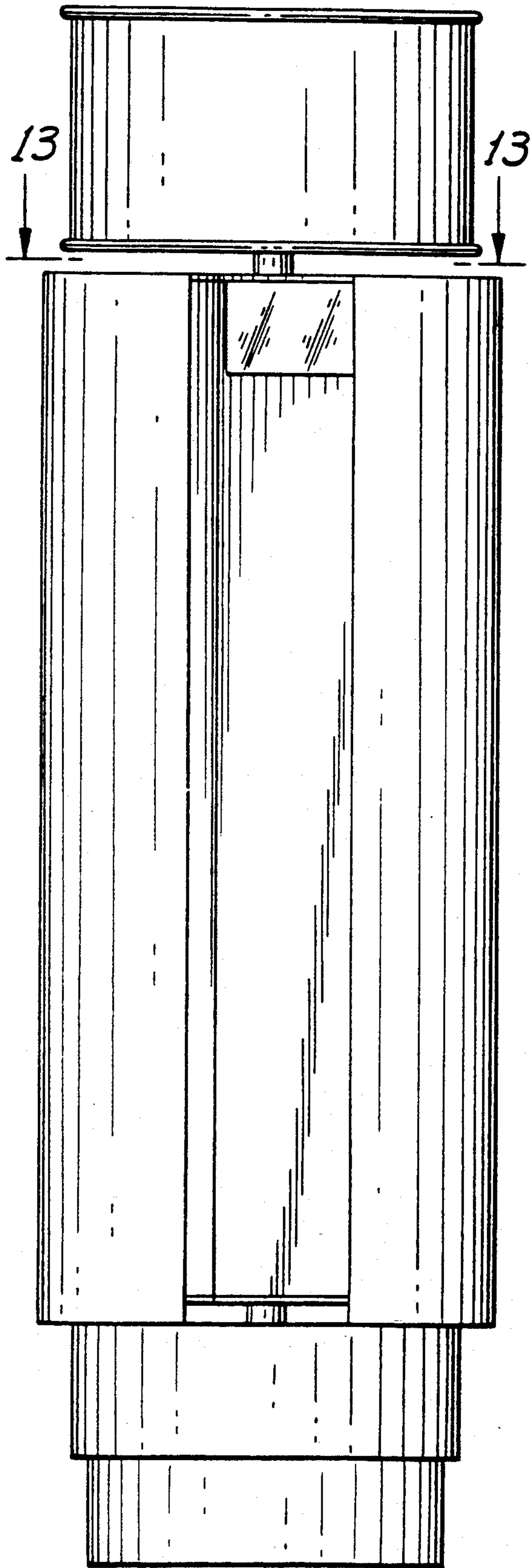
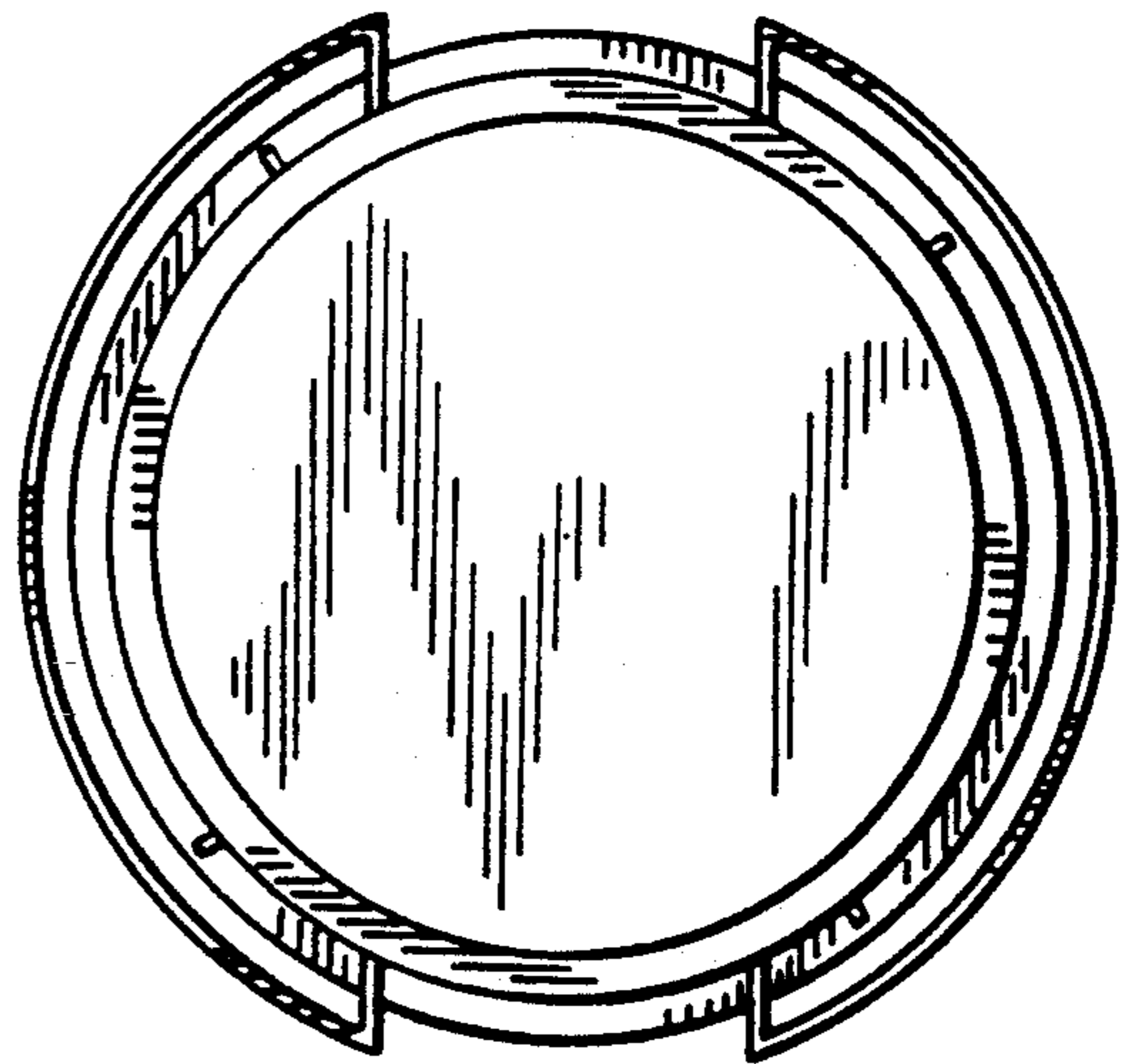

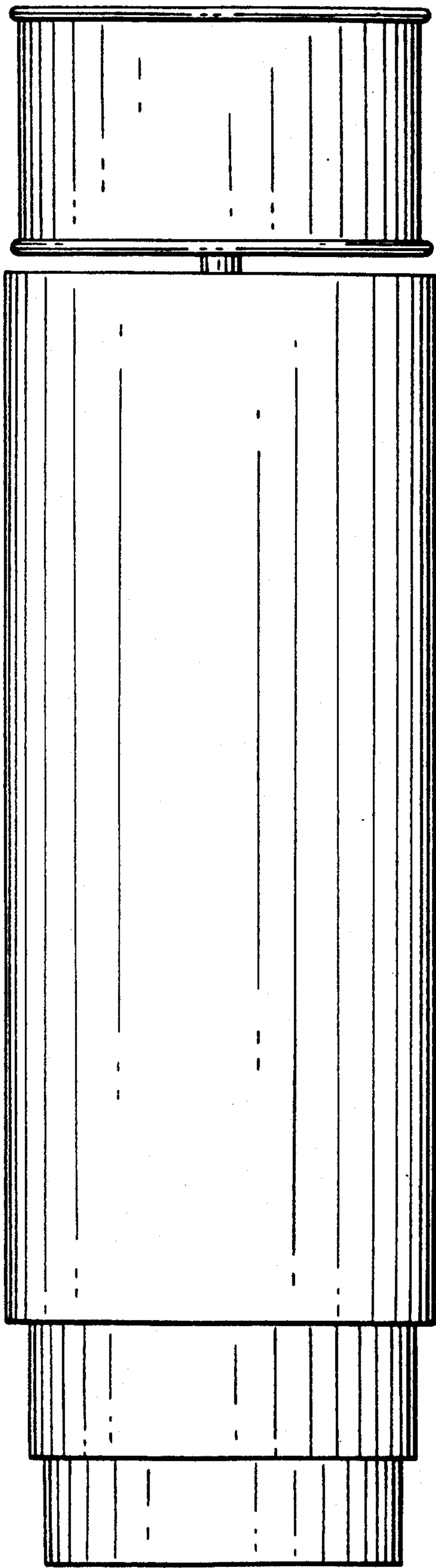
