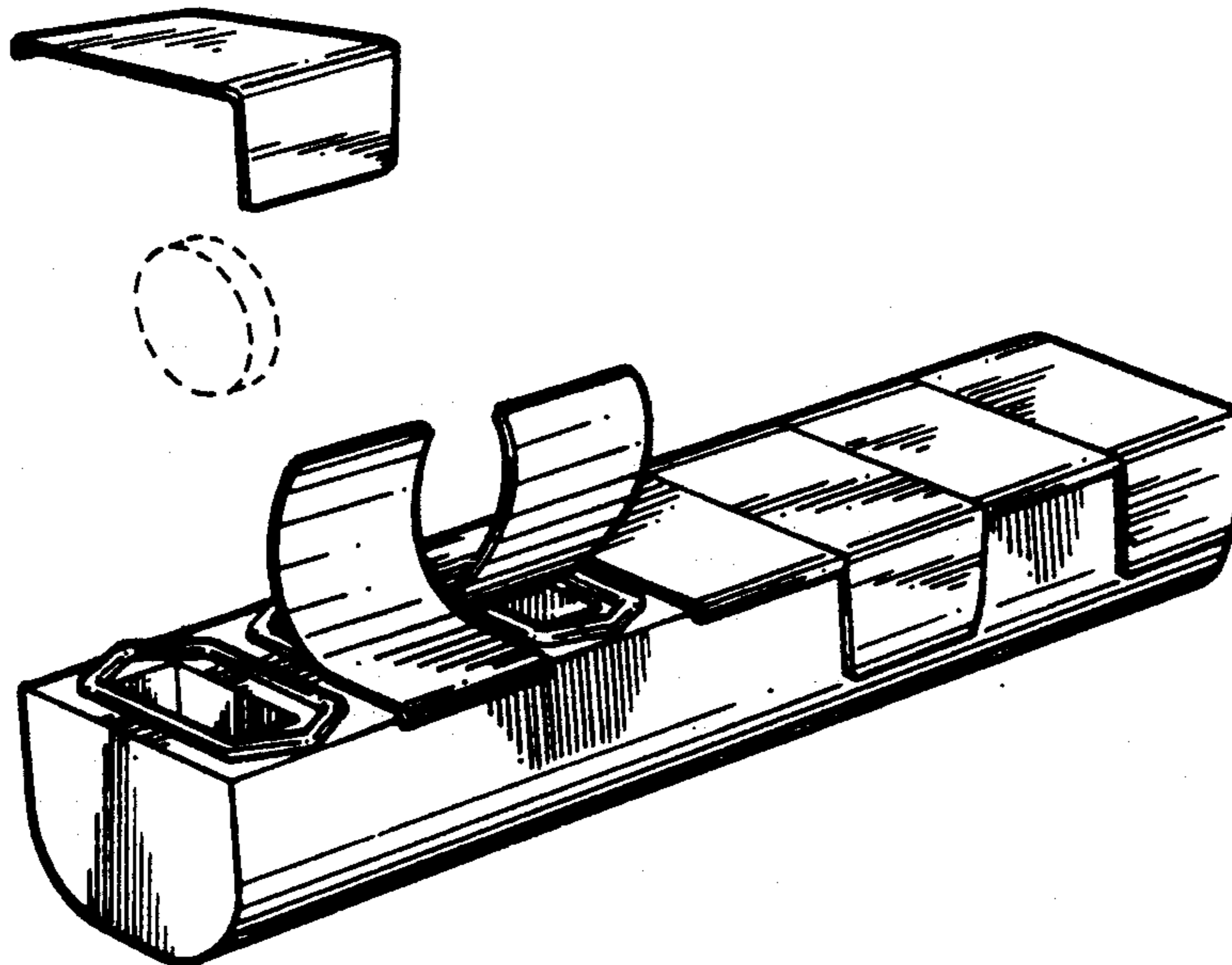

### [57] CLAIM

The ornamental design for a pill container, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a pill container and the like showing my new design;  
 FIG. 2 is a right side elevation thereof, the left side elevation being a mirror image thereof;  
 FIG. 3 is a sectional view taken on line 3—3 of FIG. 2;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a front elevation thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a rear elevation thereof; and,  
 FIG. 8 is an exploded perspective thereof, the broken lines showing a pill being for illustrative purposes only and forming no part of the claimed design.



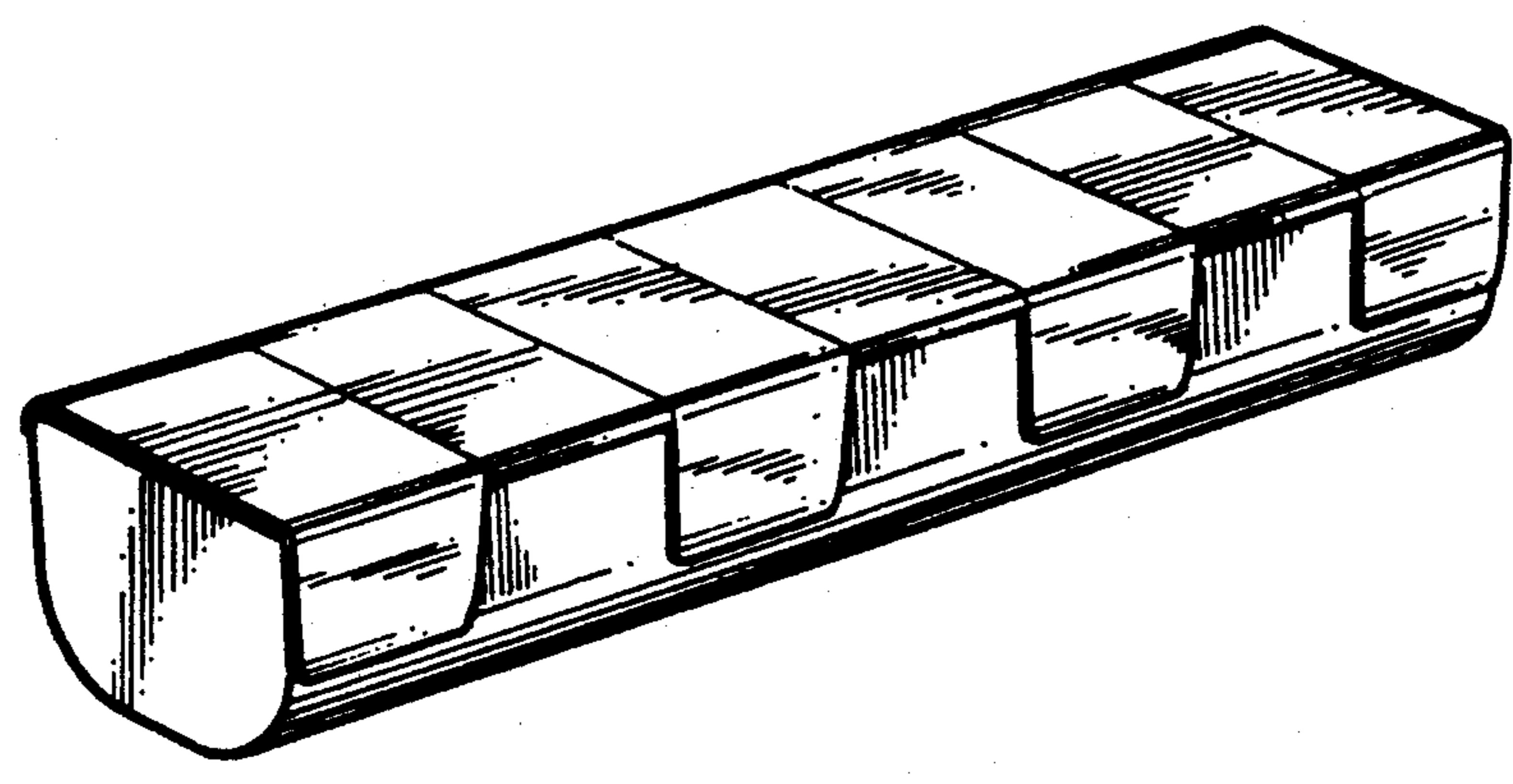

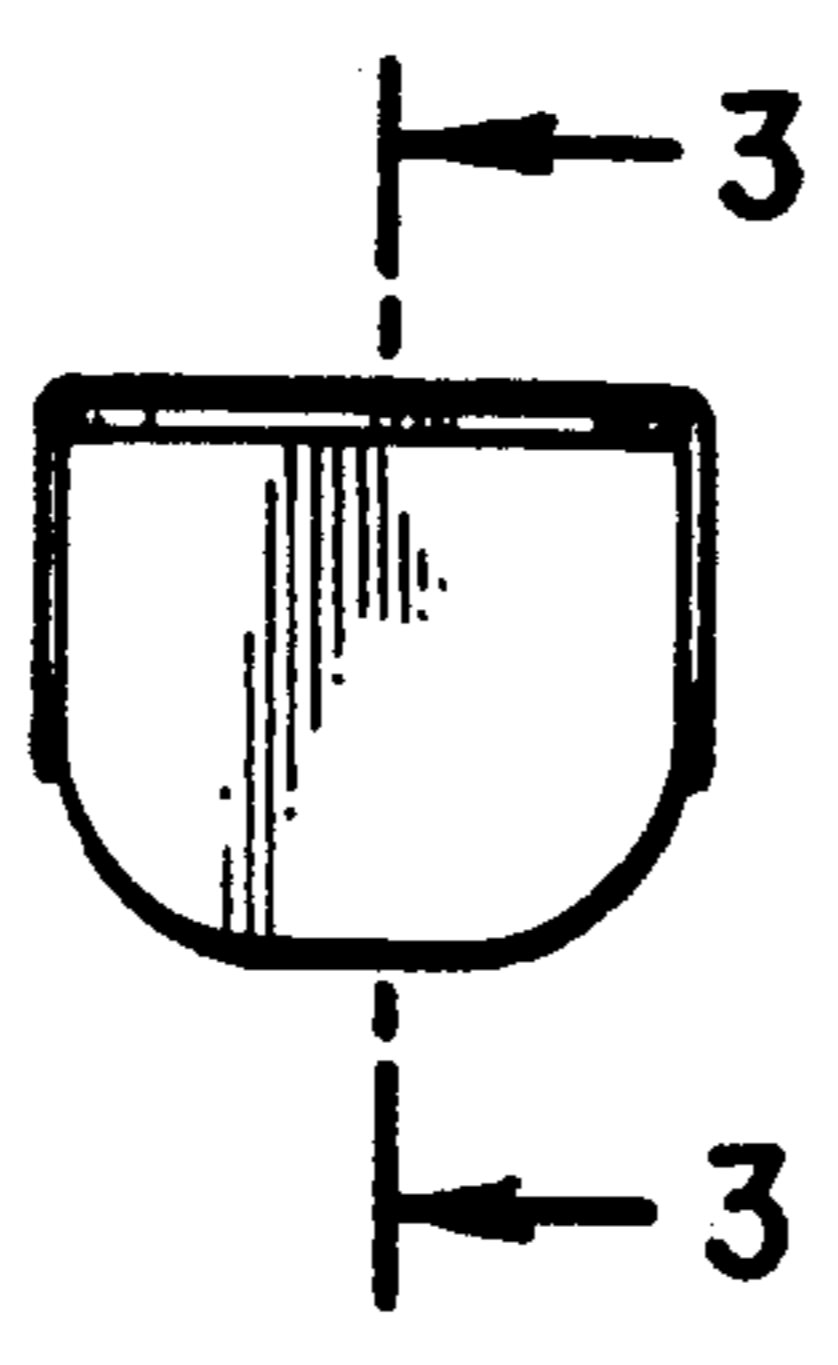

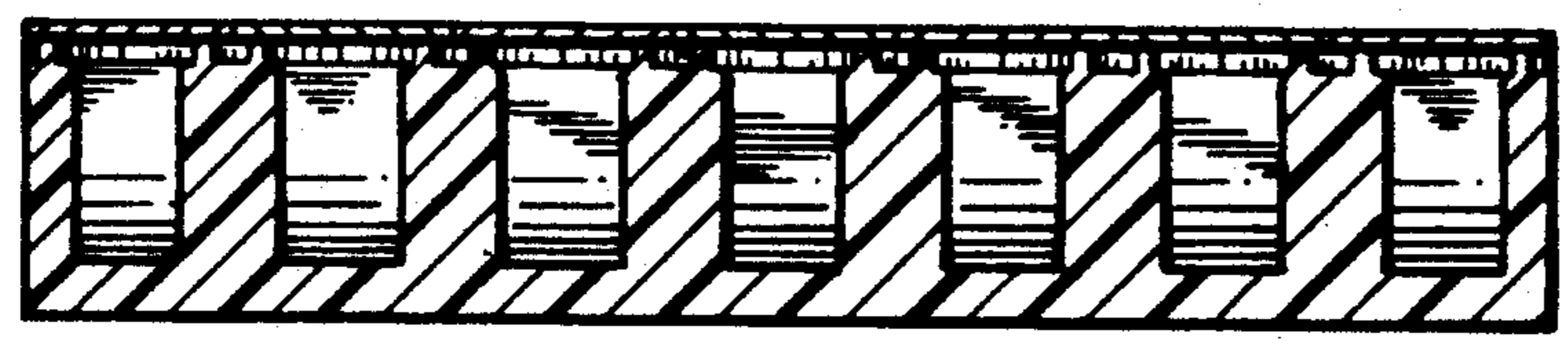

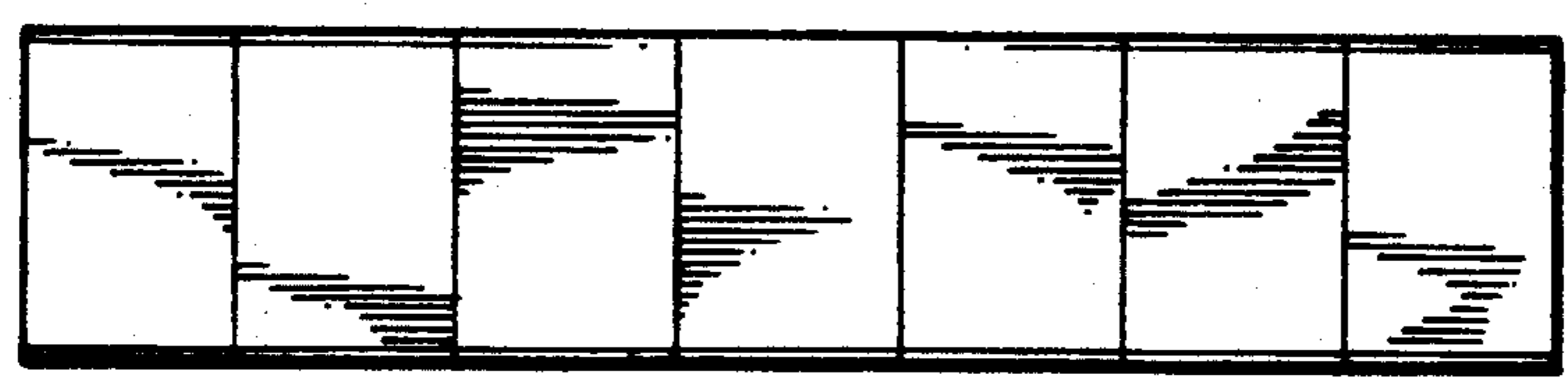

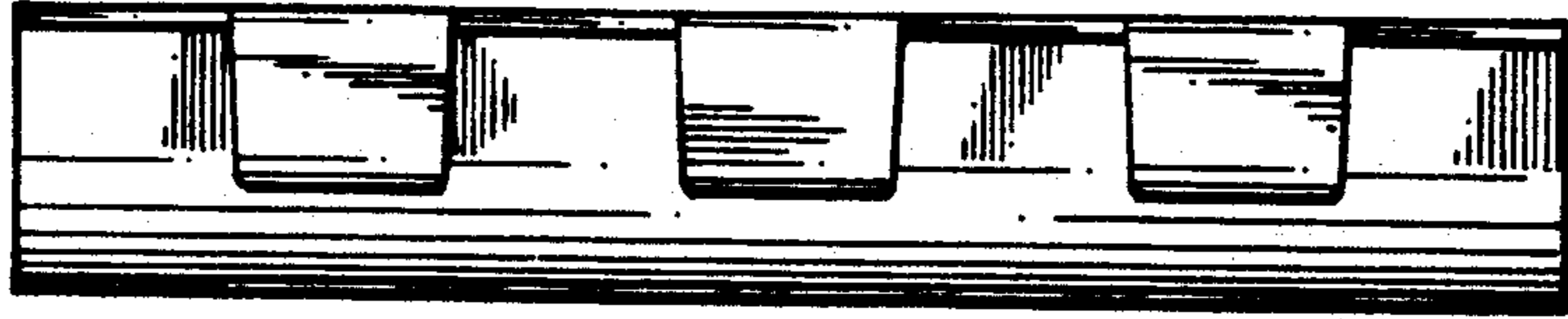

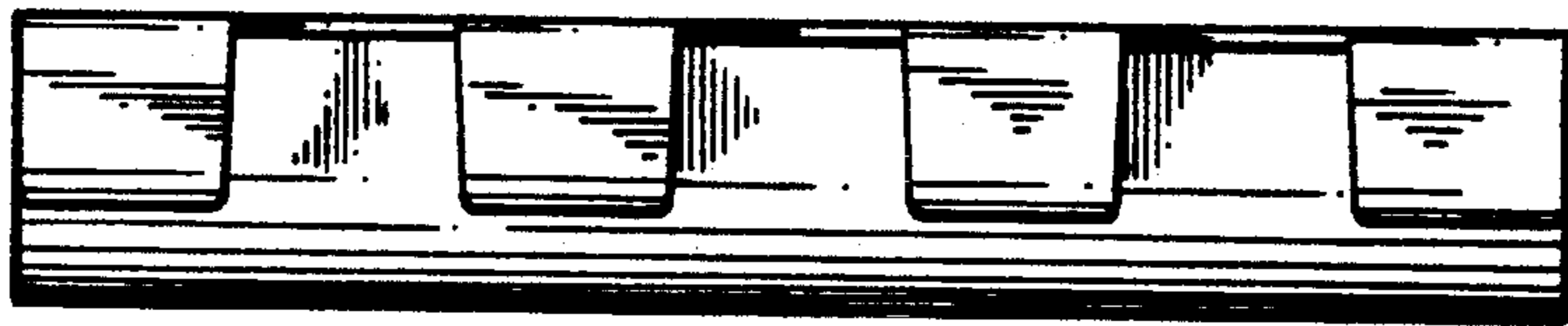

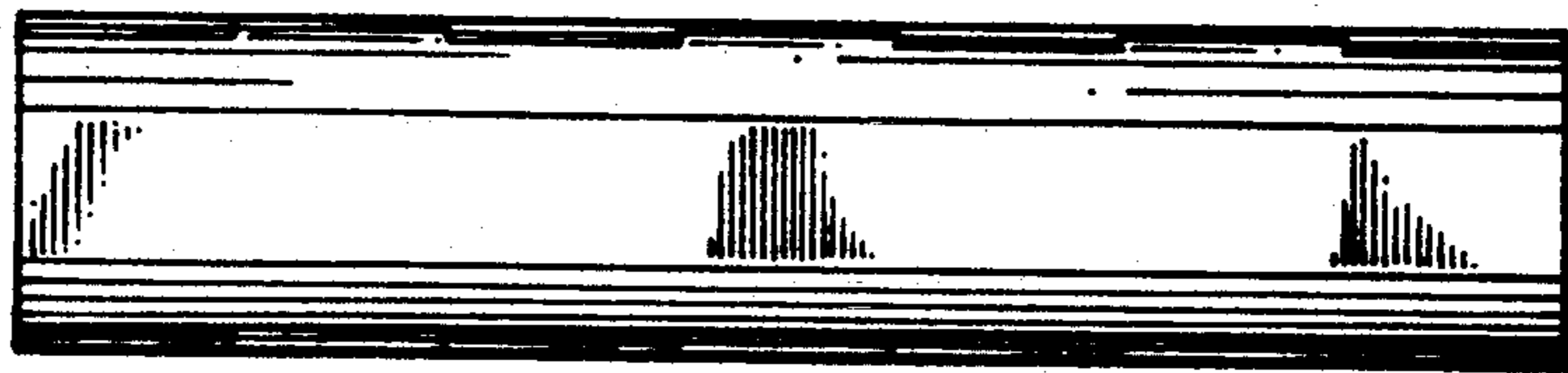
