[57] **CLAIM**

The ornamental design for an automotive telephone handset, as shown and described.

DESCRIPTION

FIG. 1 is a left side, top and front perspective view of an automotive telephone handset showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a sectional view taken along line VIII—VIII in FIG. 2; FIG. 9 is a front top and left side perspective view depicting a state of rotating a display cover and showing a display panel; and, FIG. 10 is a perspective view thereof, the broken line showing of displayed information being for illustrative purposes only.

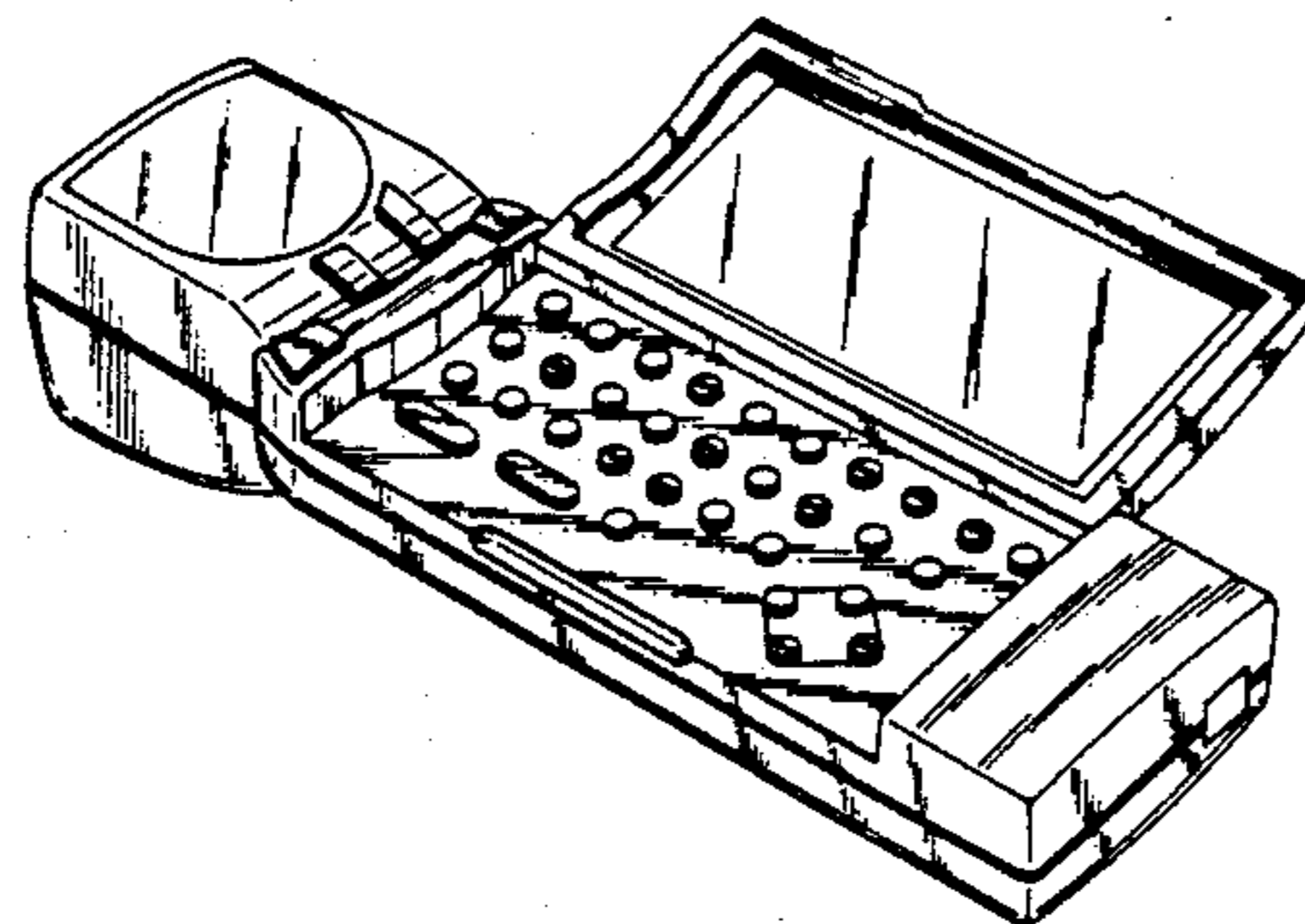
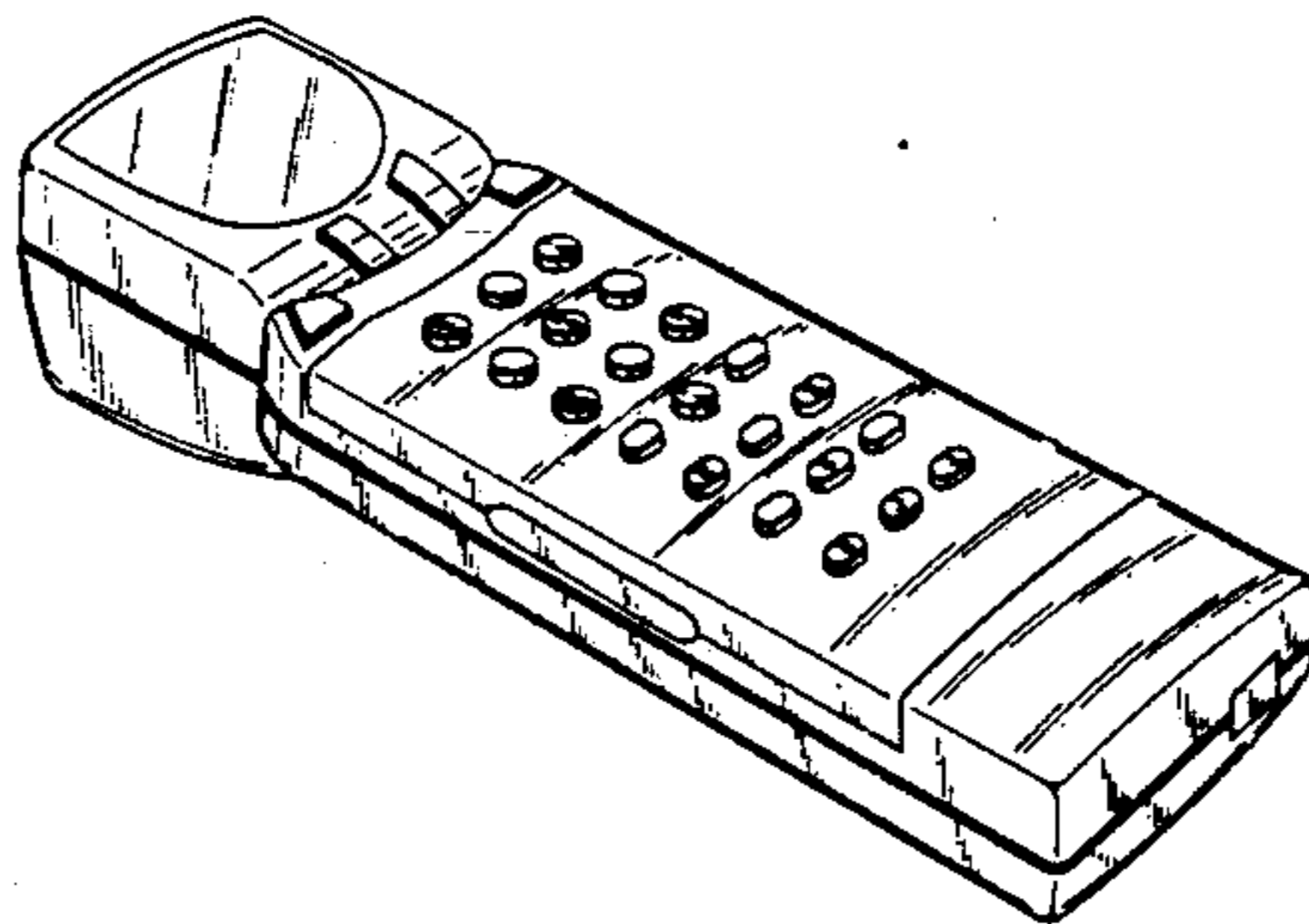

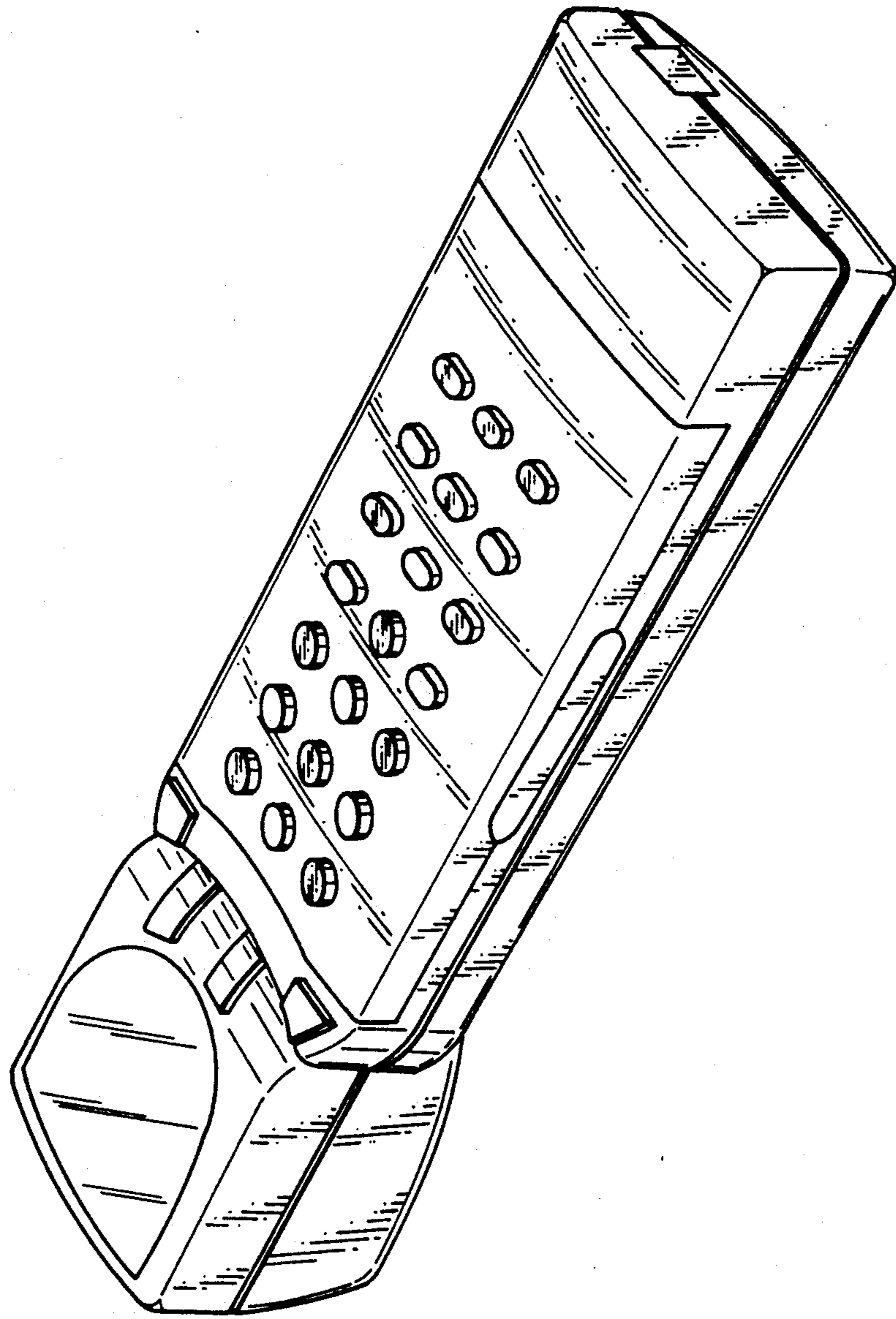

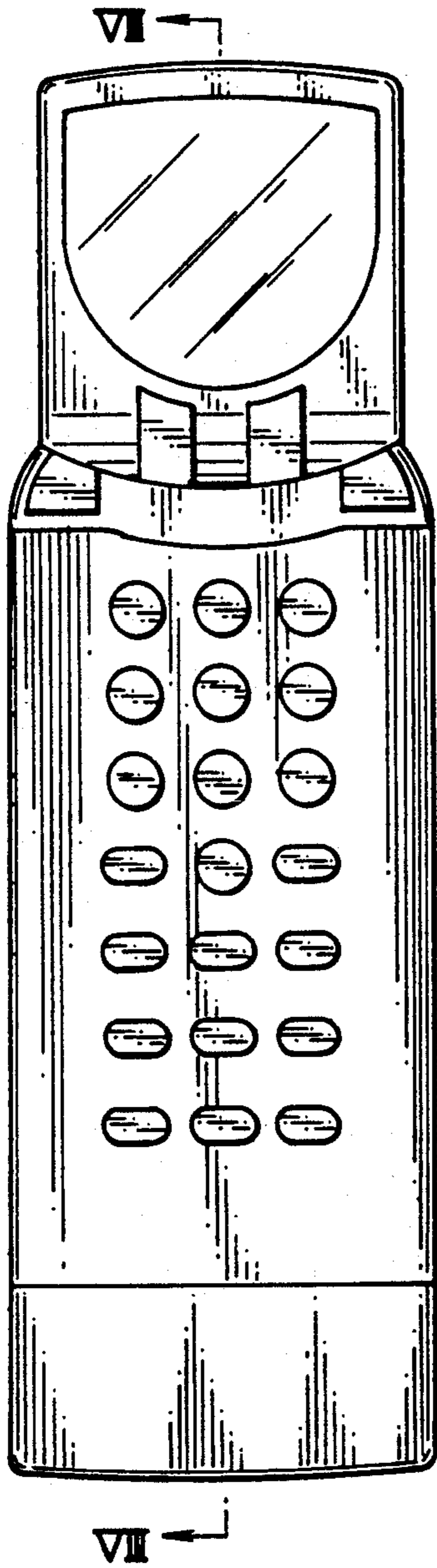

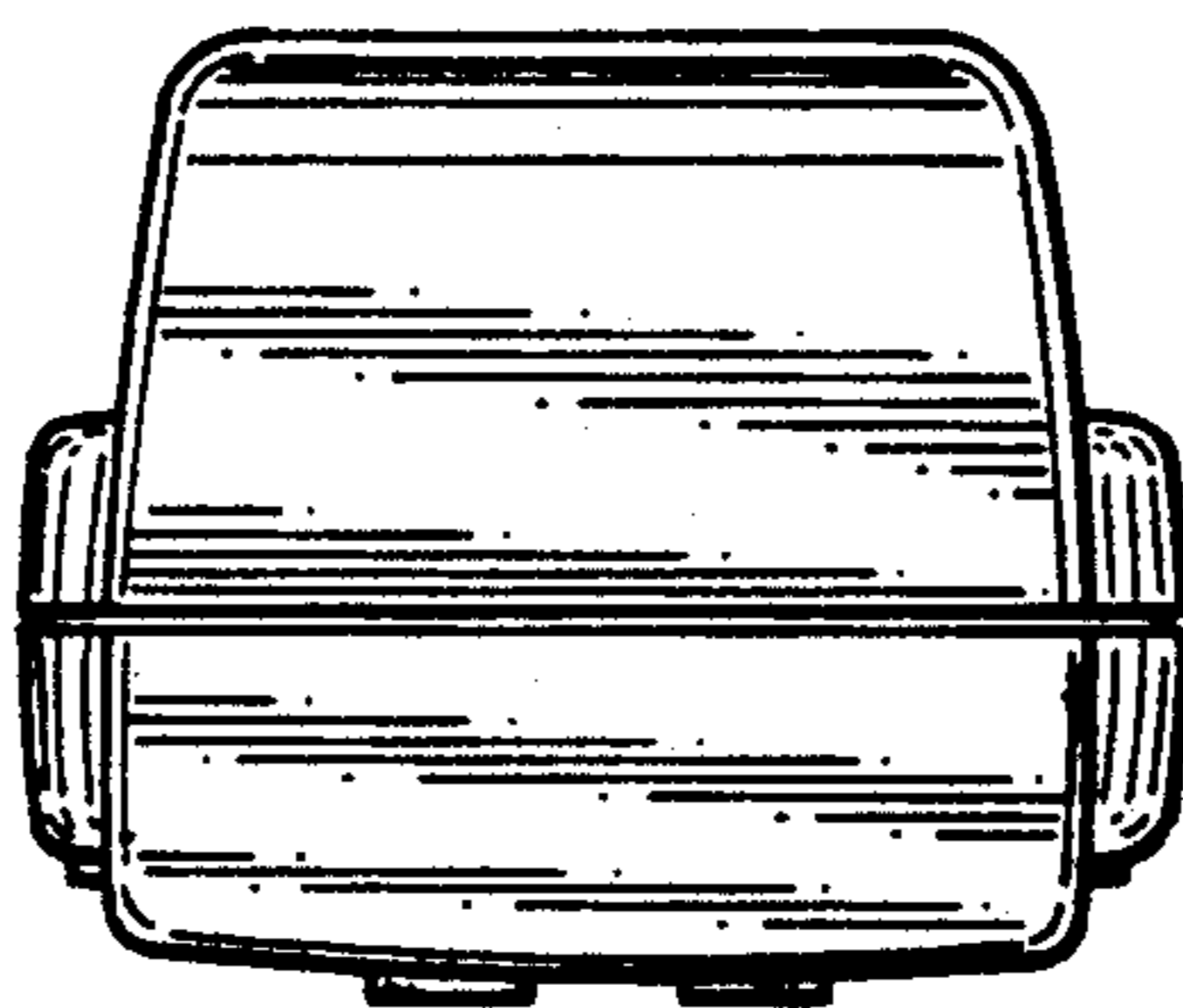

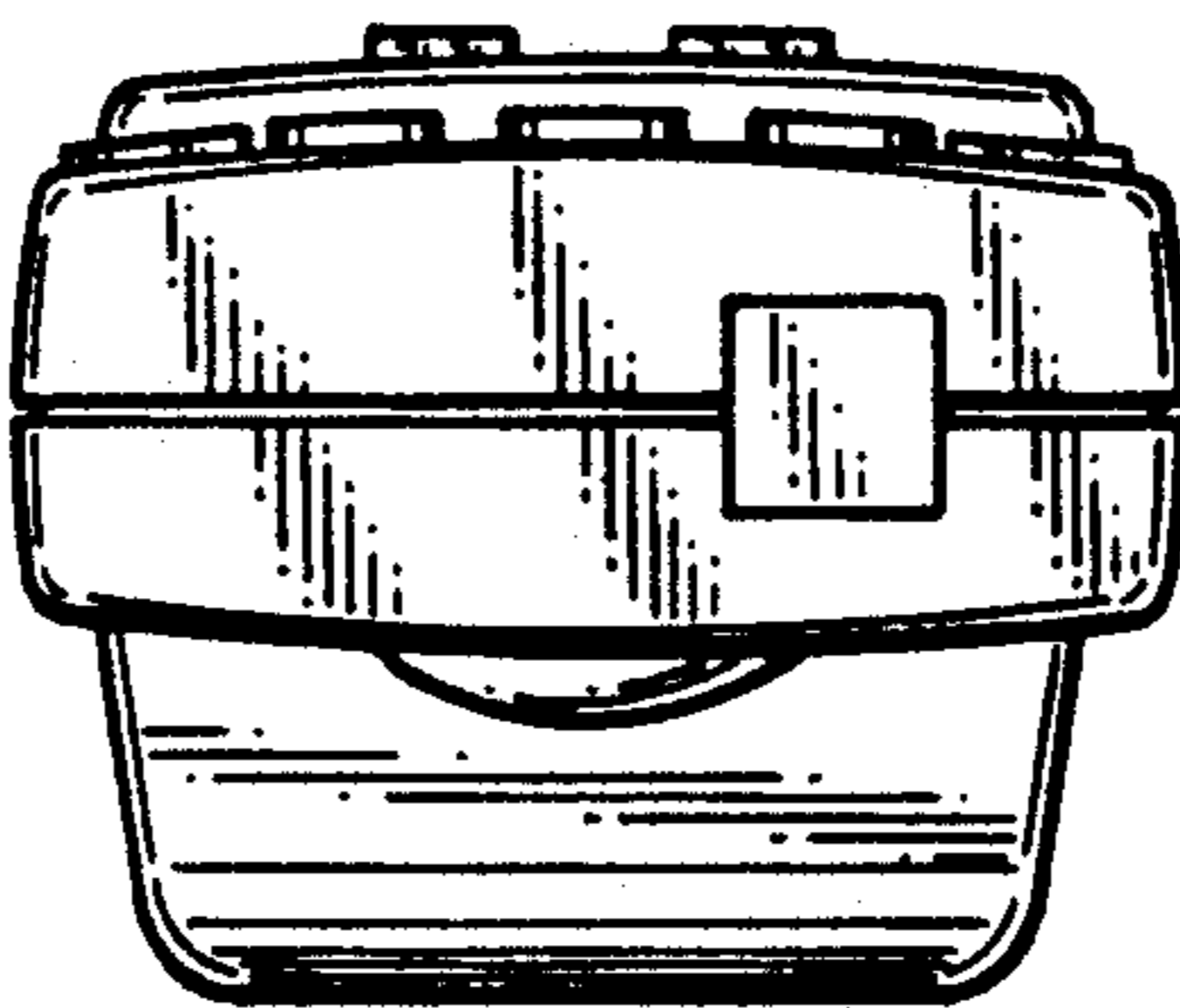

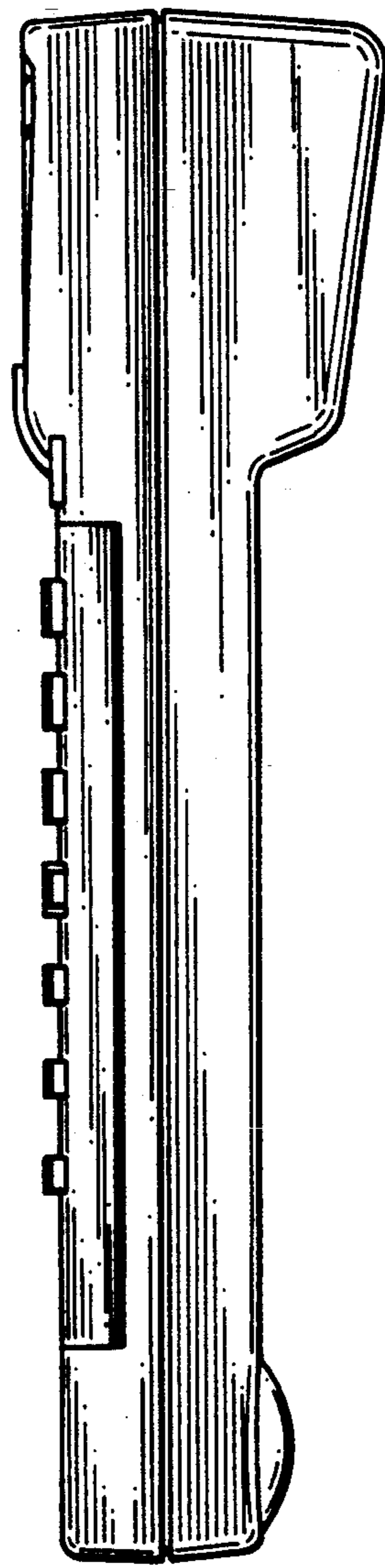
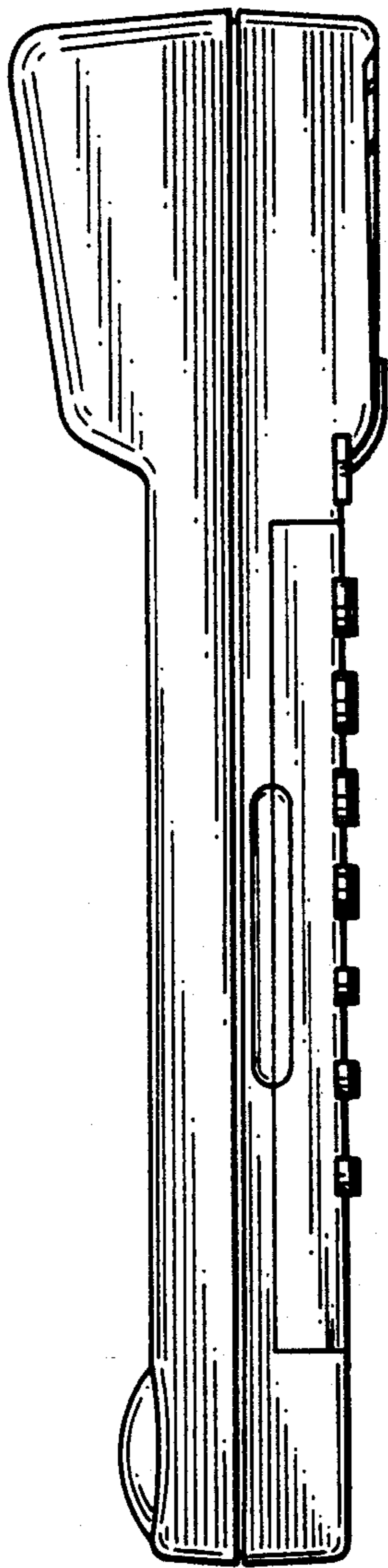

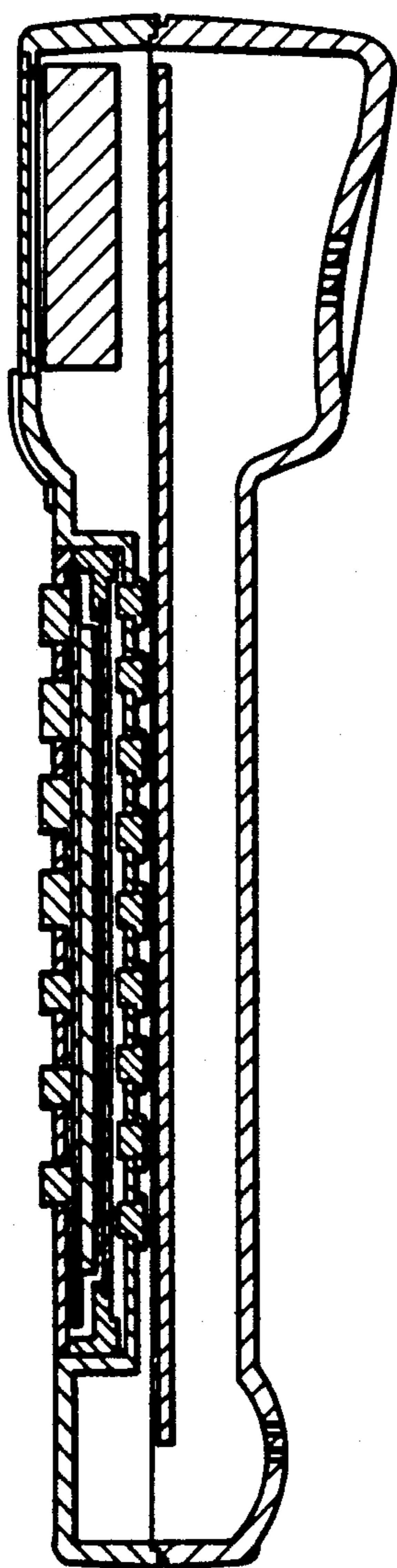

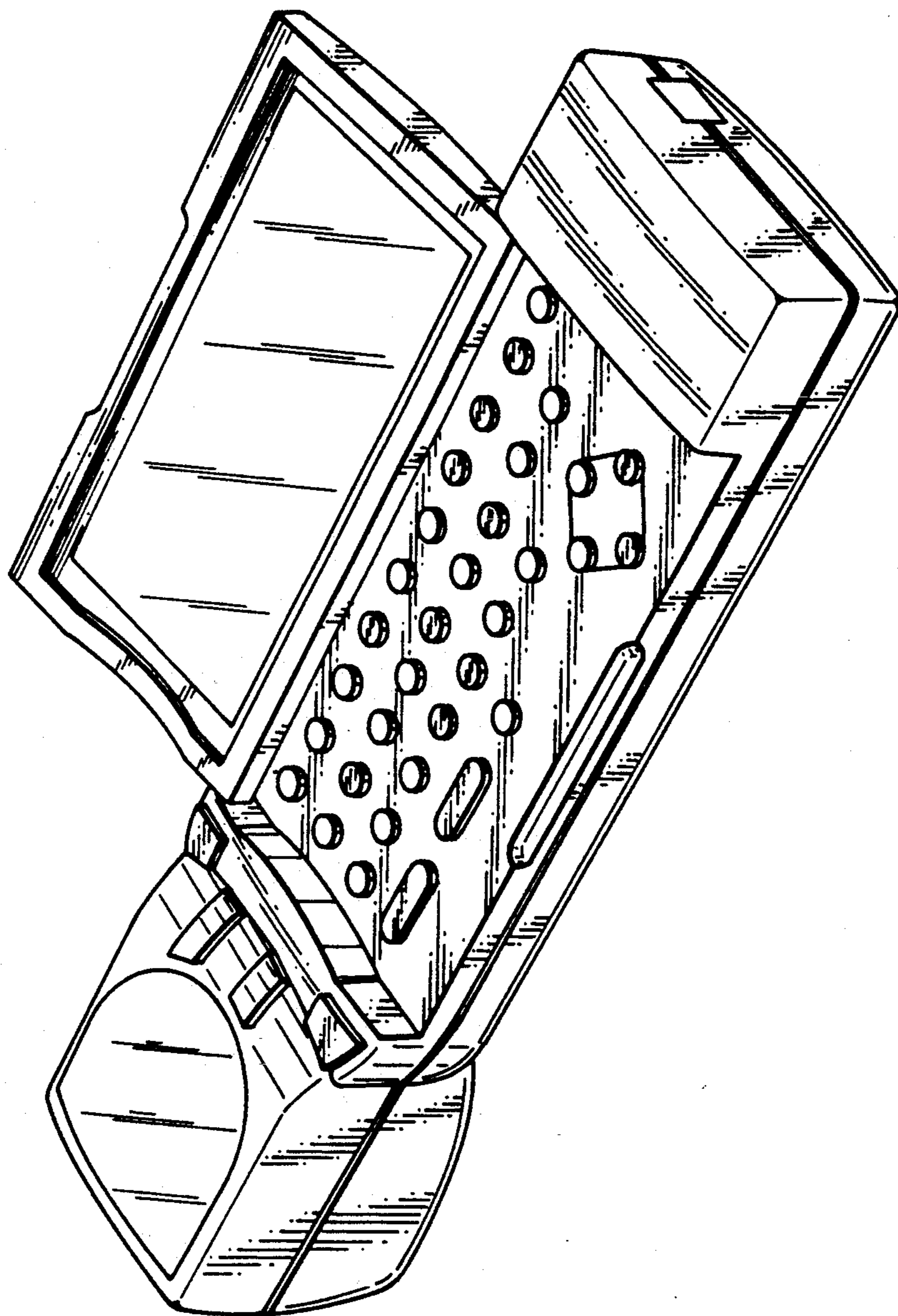
