## [57] CLAIM

The ornamental design for a laser beam printer, as shown and described.

## DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a laser beam printer showing our new design, with paper cassettes pulled out;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a top plan view thereof showing the paper cassettes pushed in;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a rear elevational view thereof; and,  
 FIG. 7 is a bottom plan view thereof.

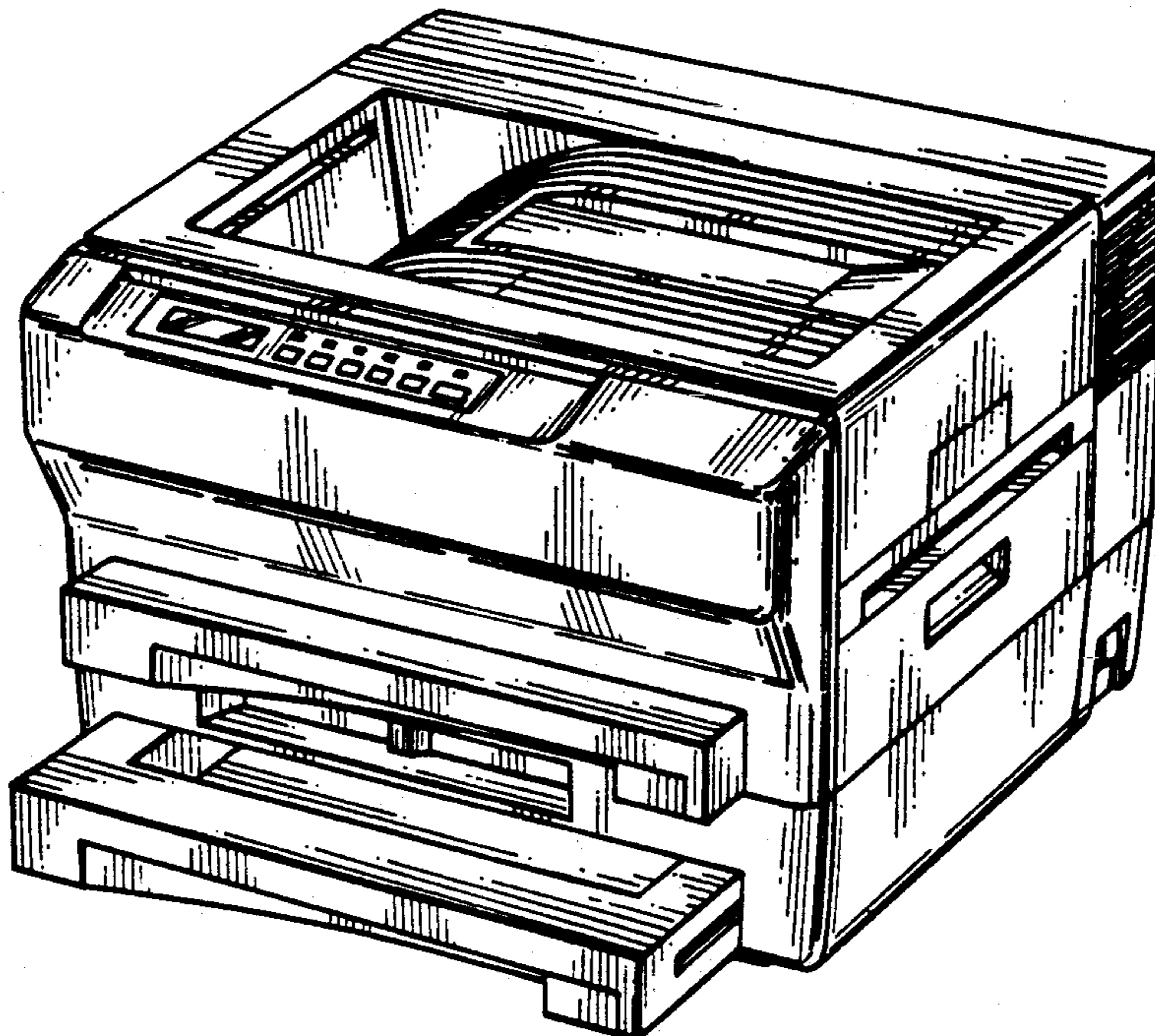

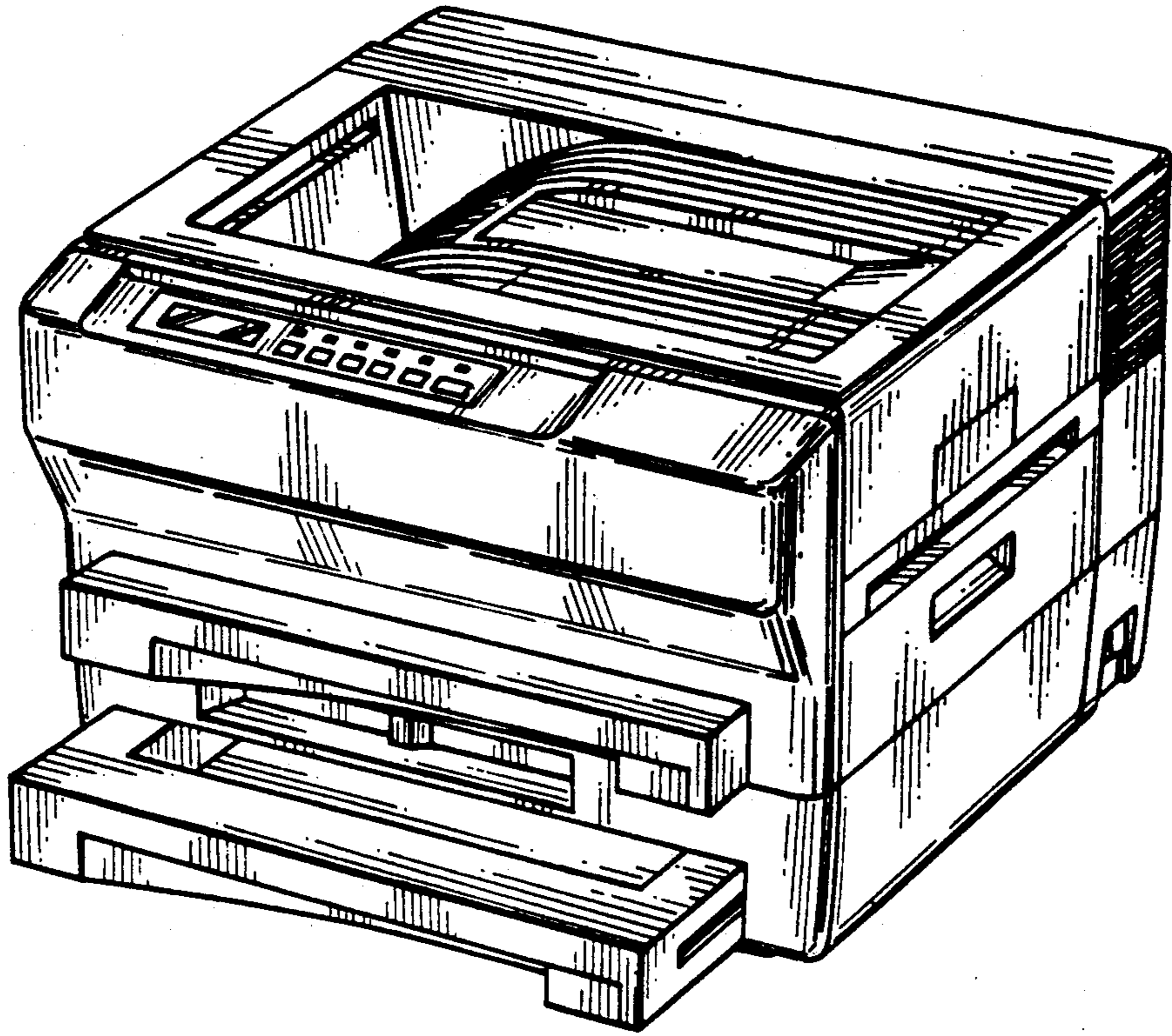

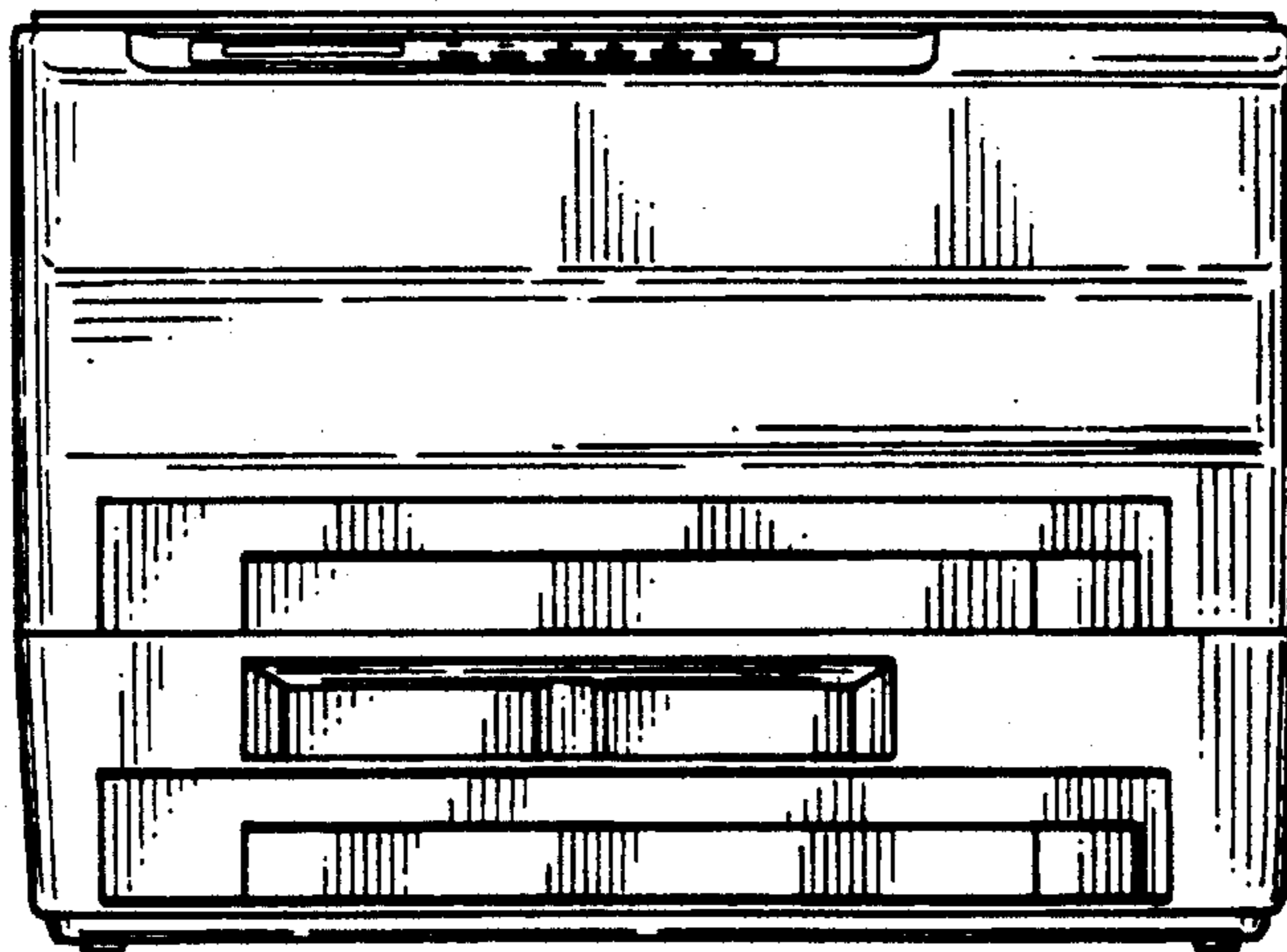

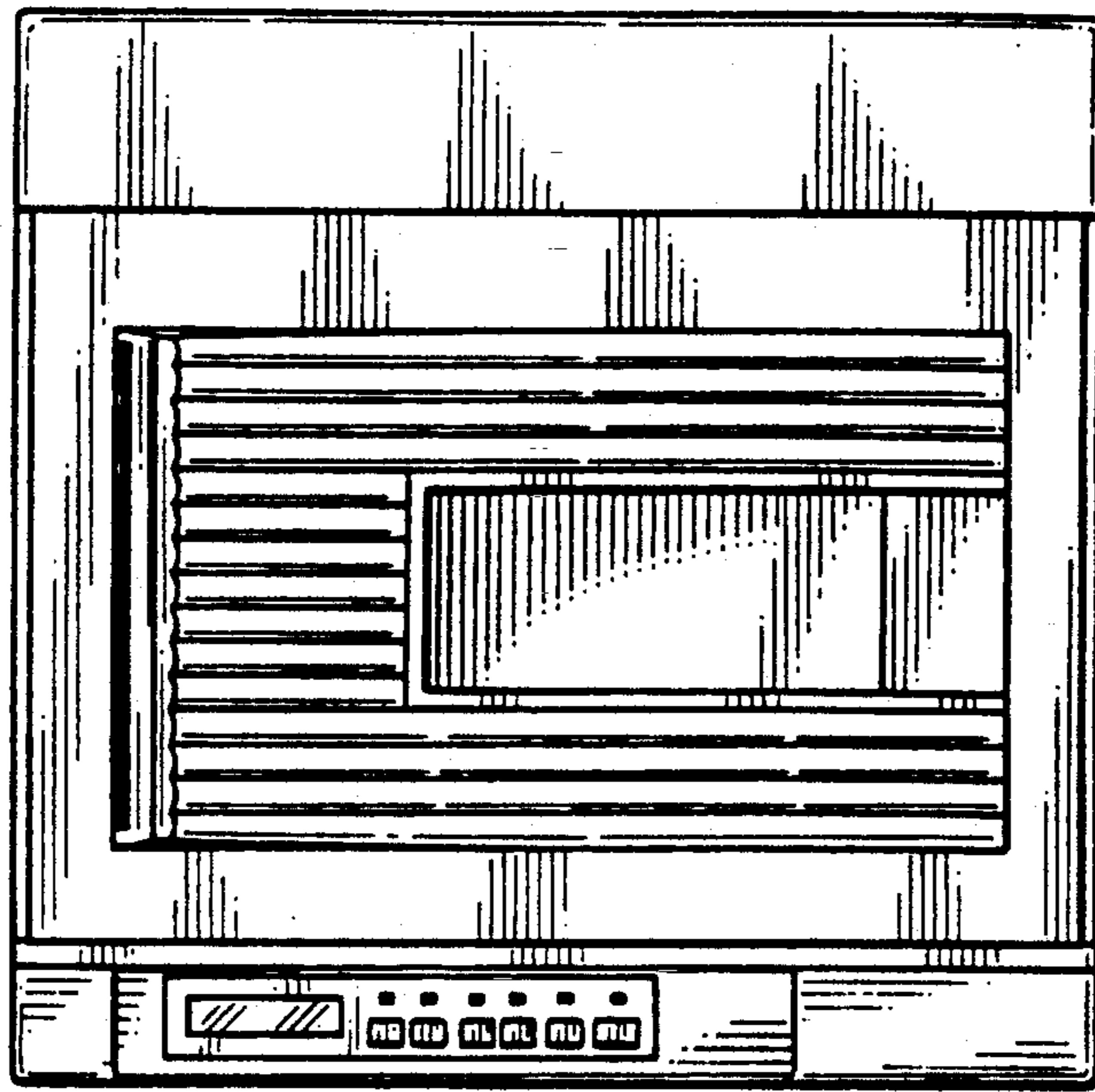

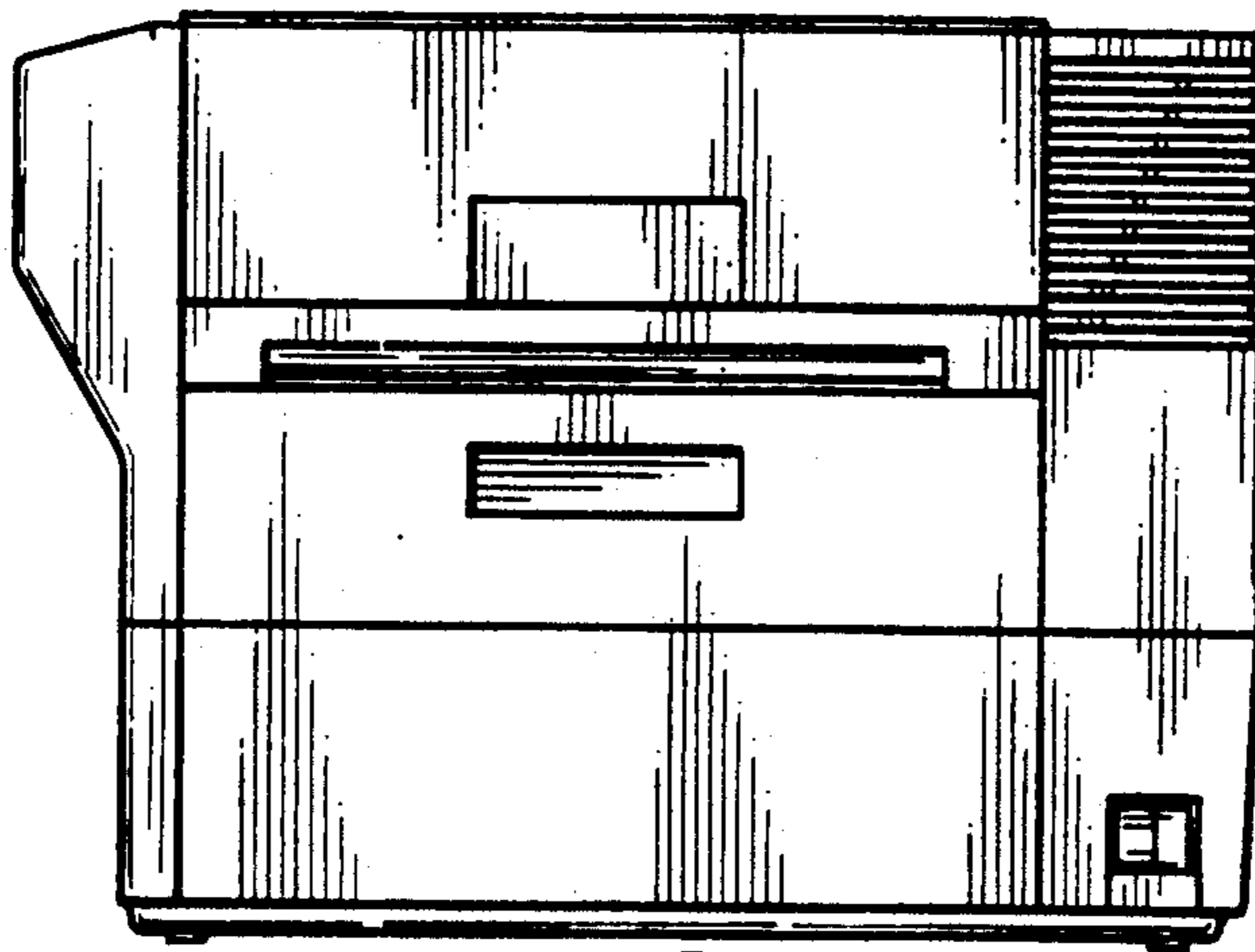

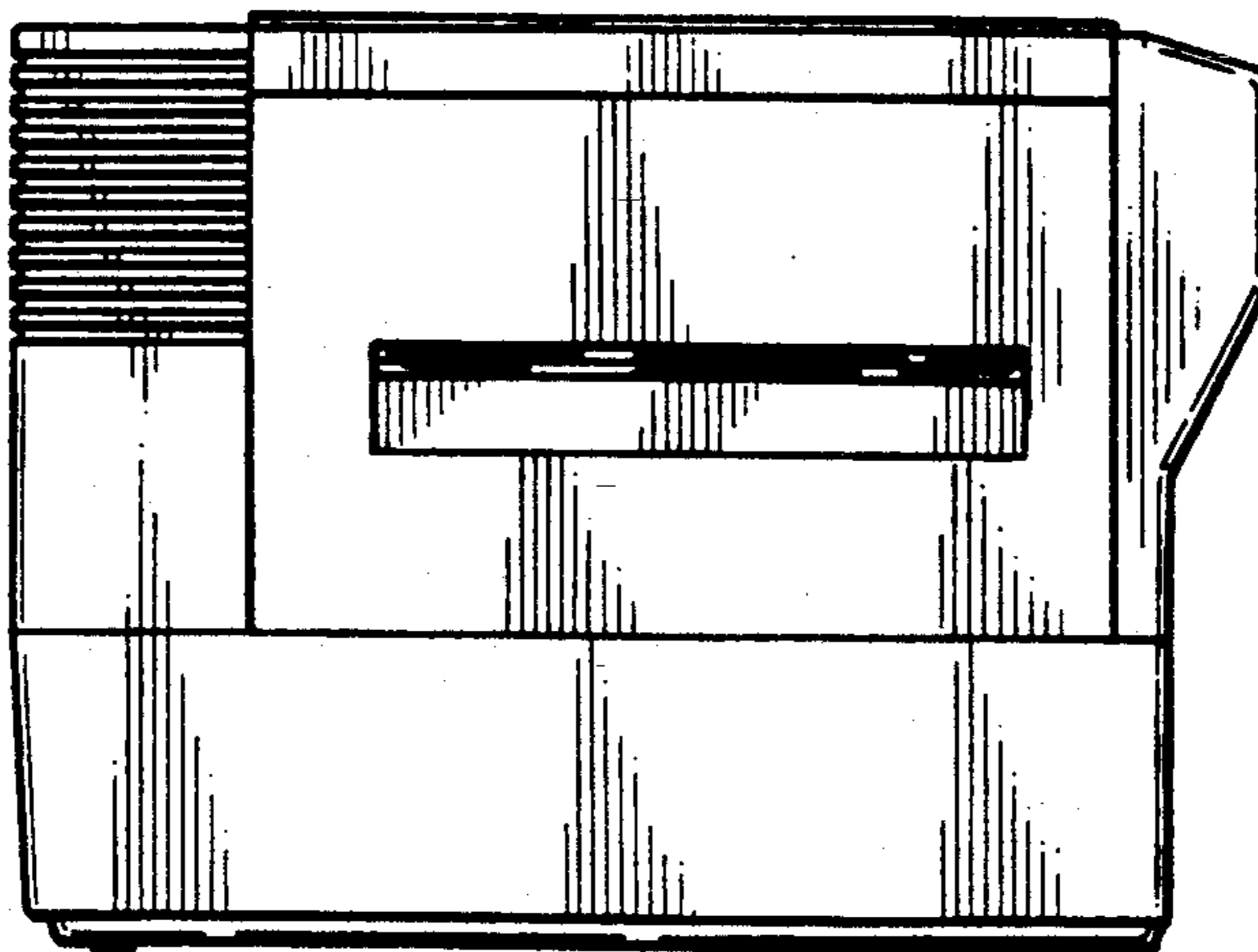

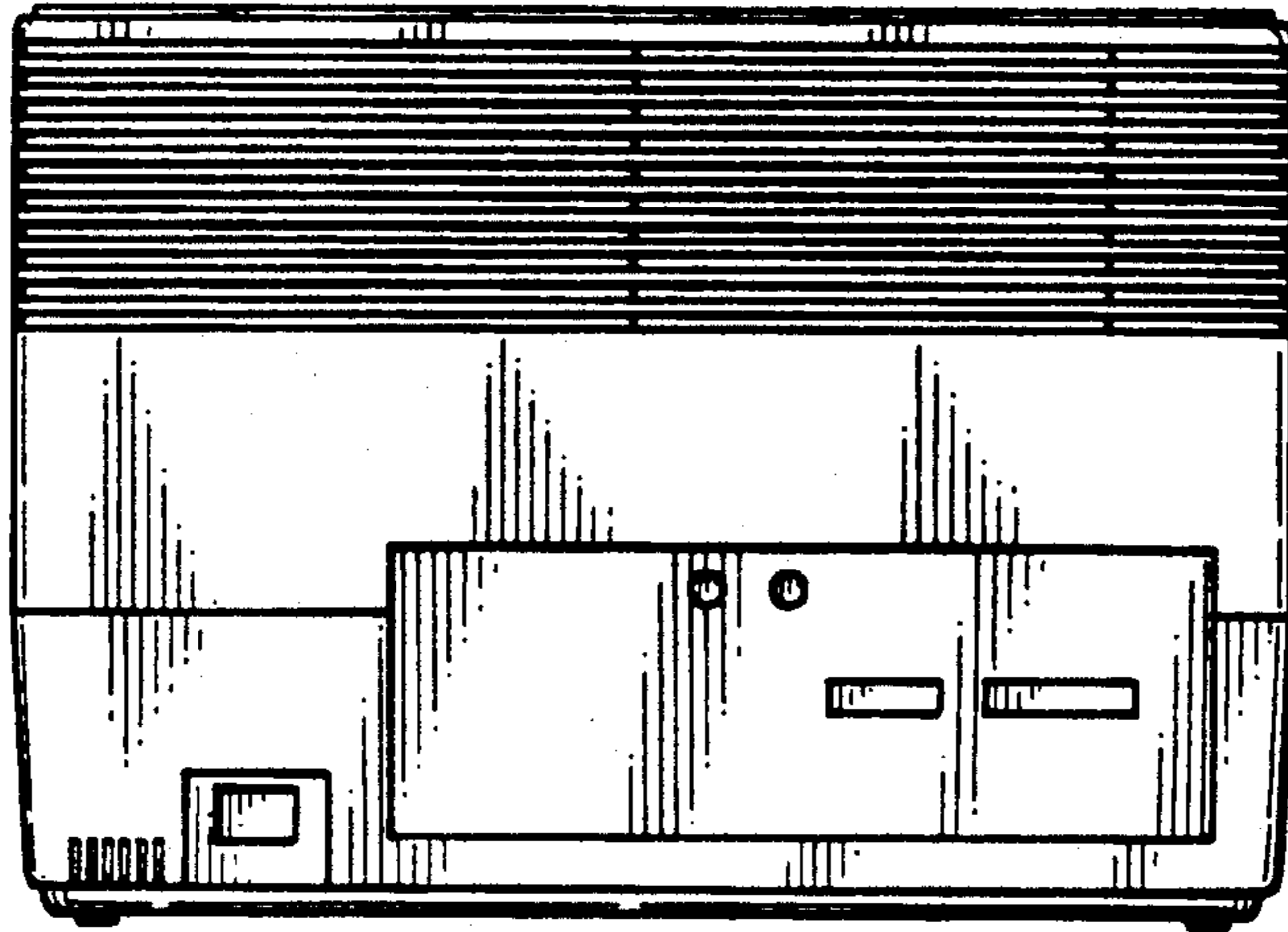
