The ornamental design for a combined holder and dispenser for correction tape, as shown and described.

DESCRIPTION

FIG. 22 is a bottom plan view of FIG. 17;

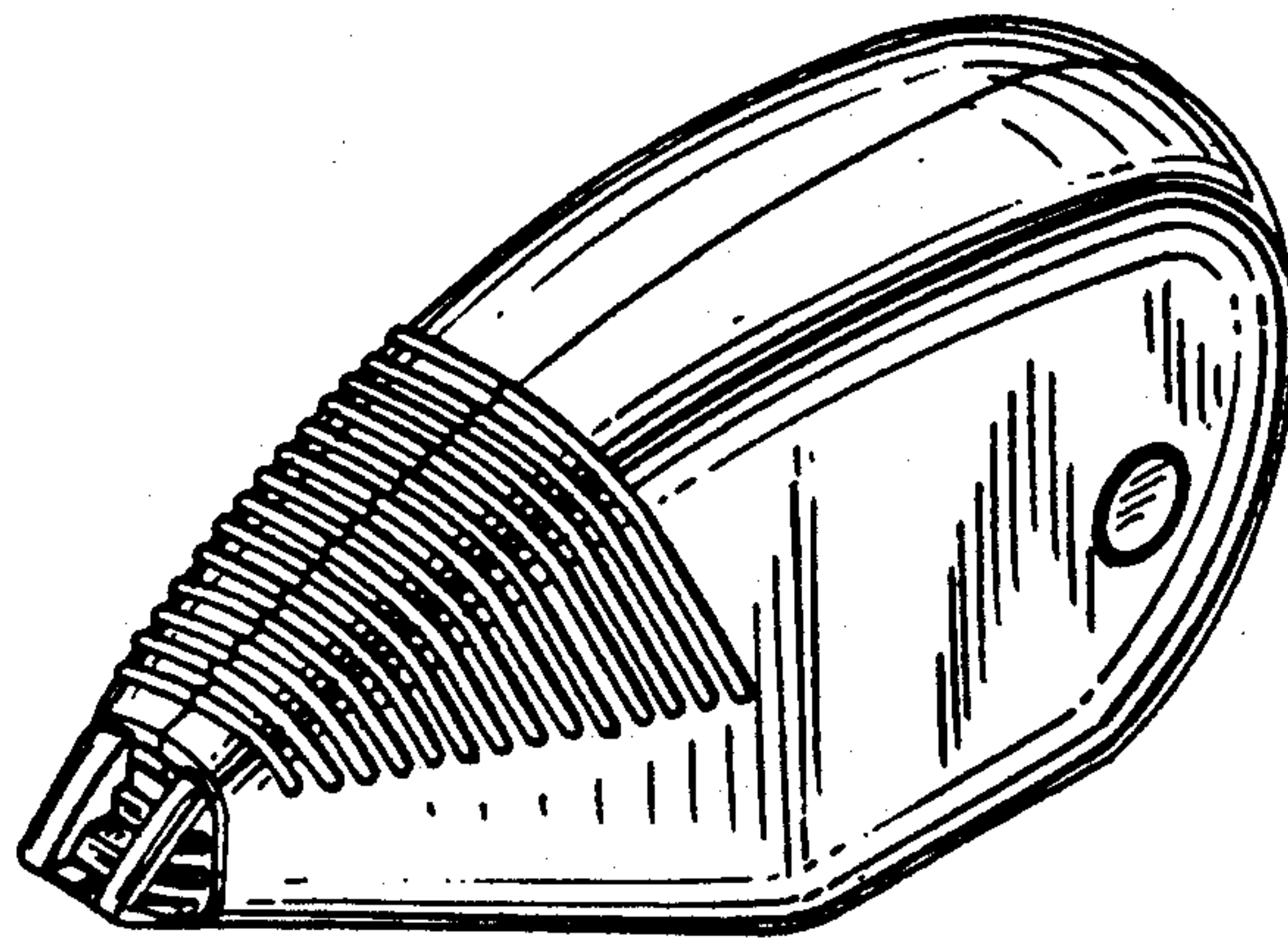
FIG. 23 is a bottom front perspective view of FIG. 17;

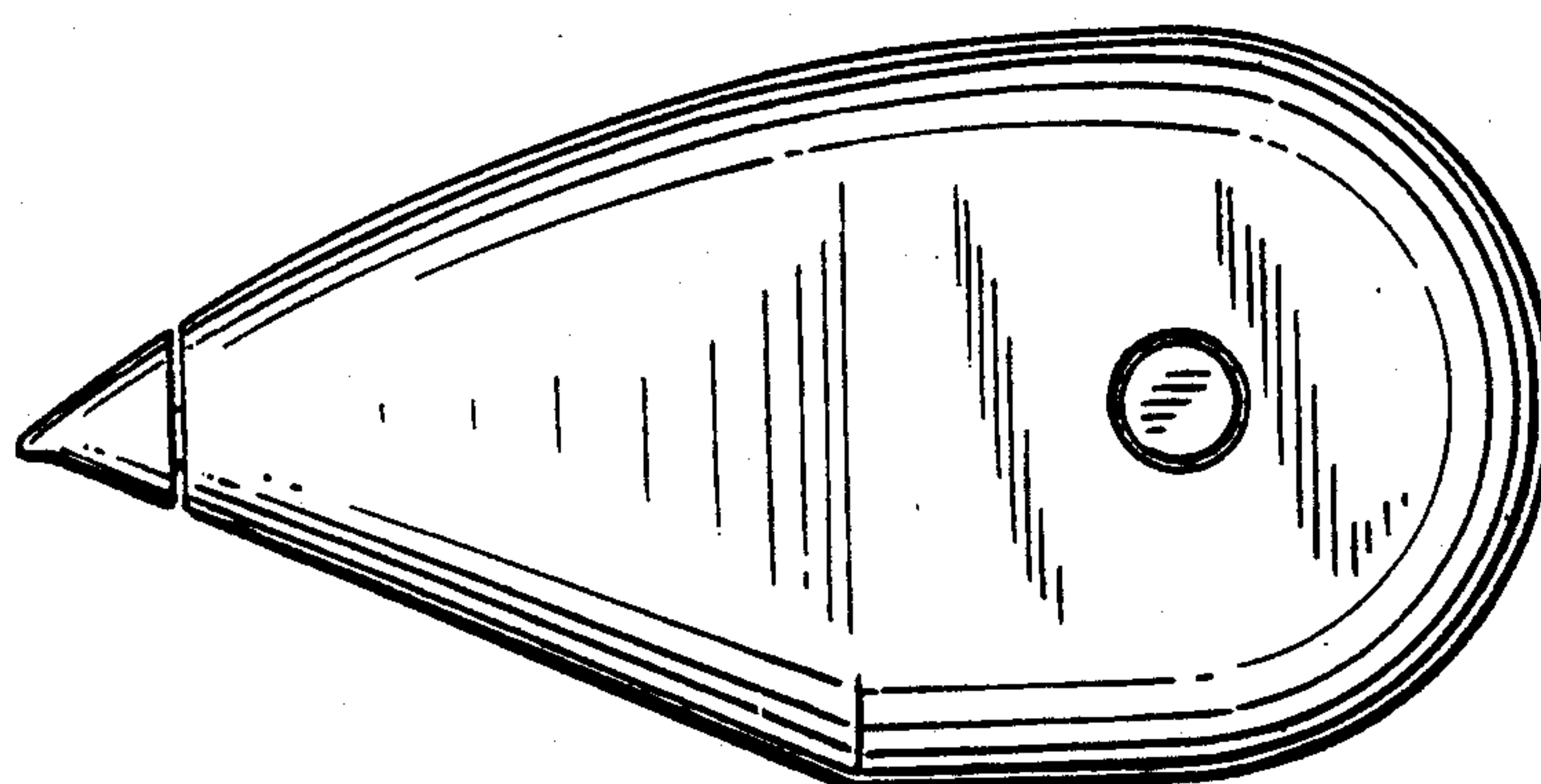

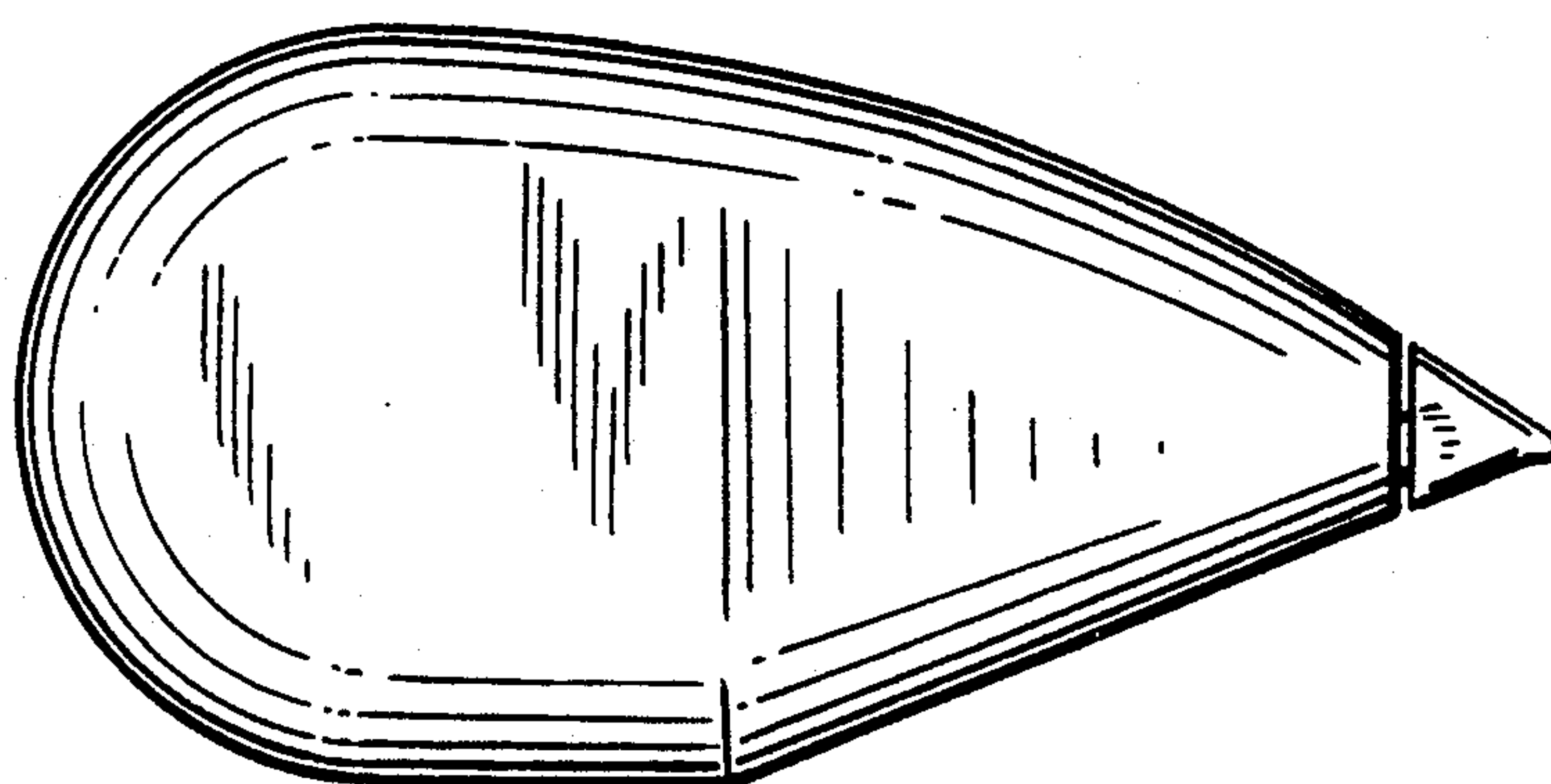

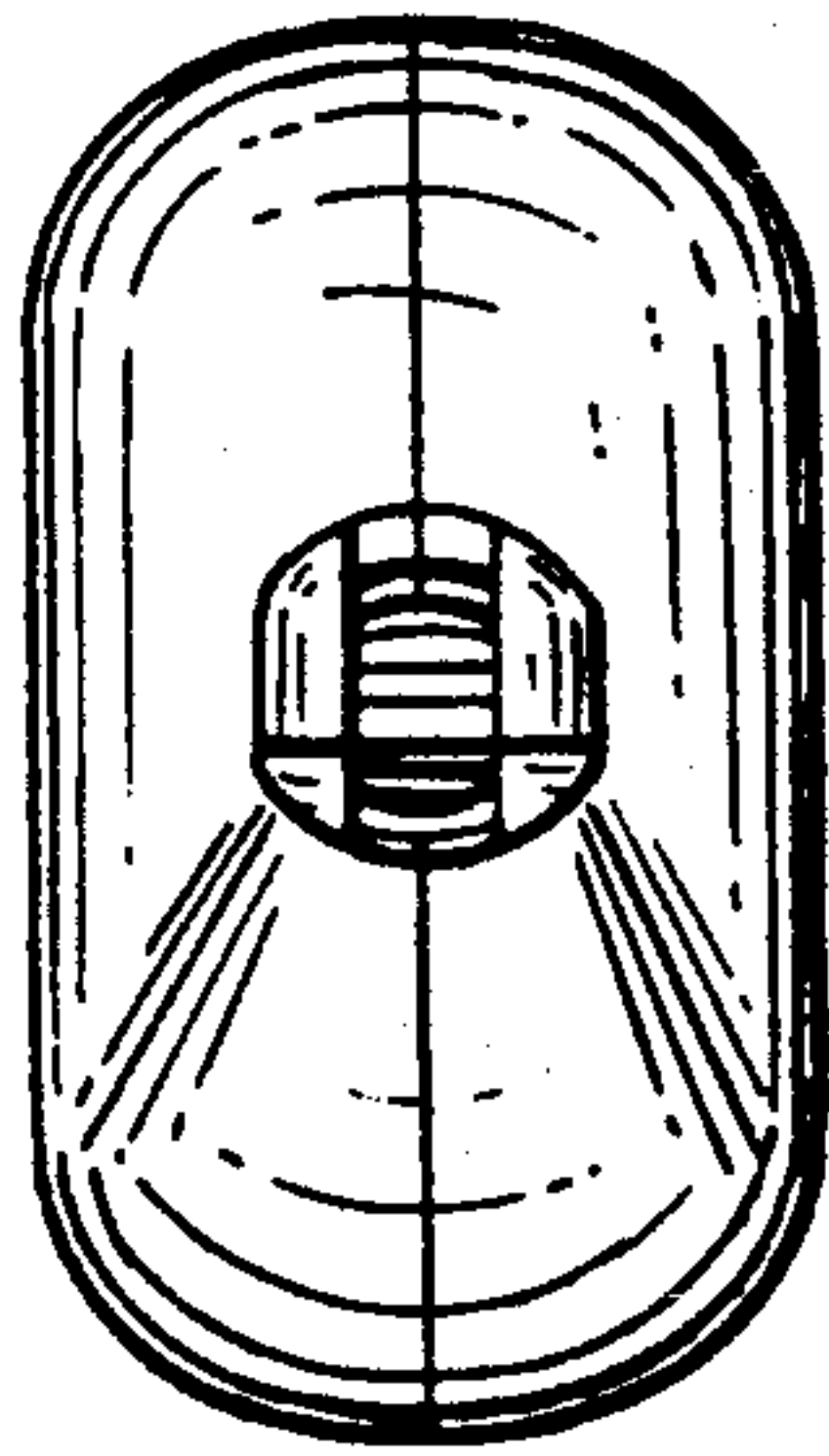

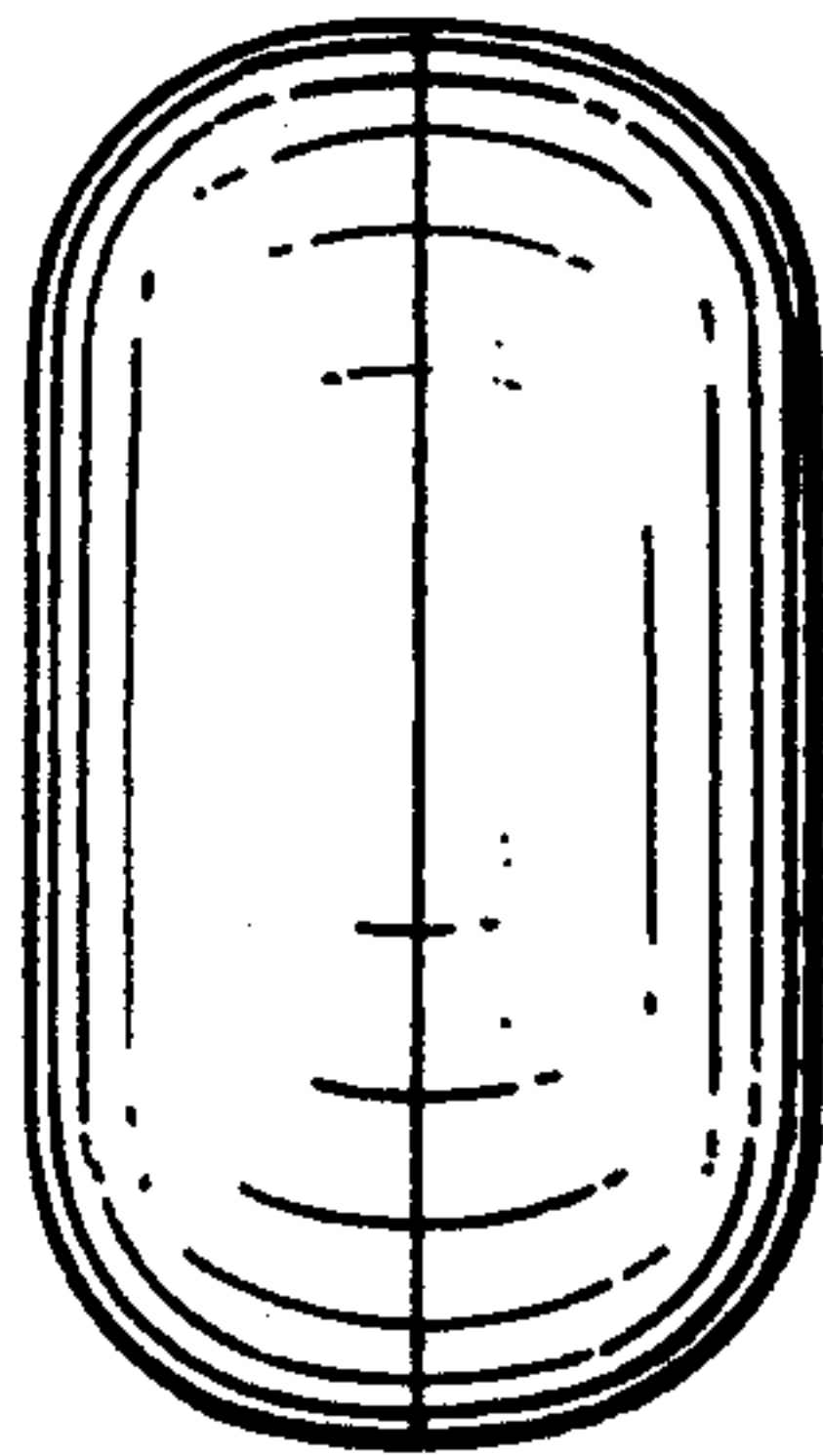

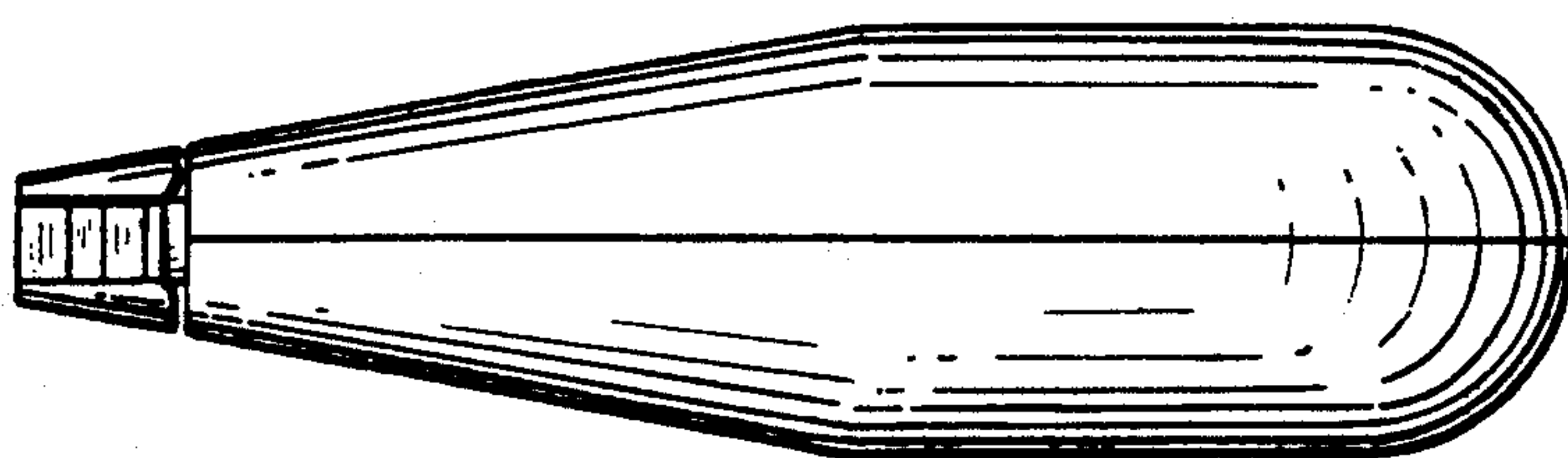

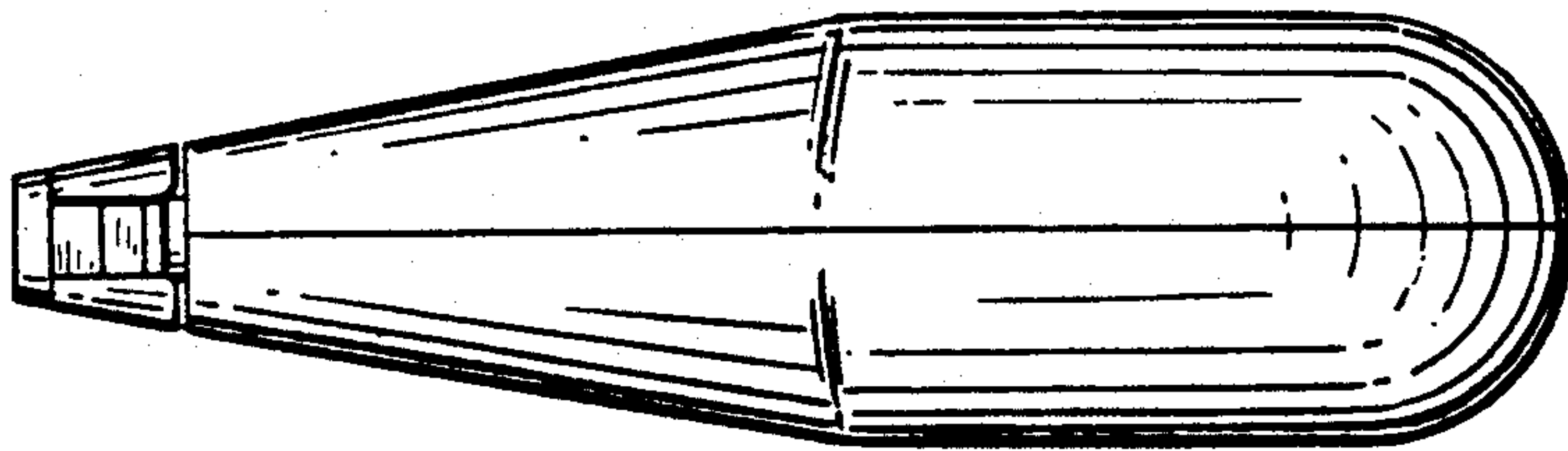

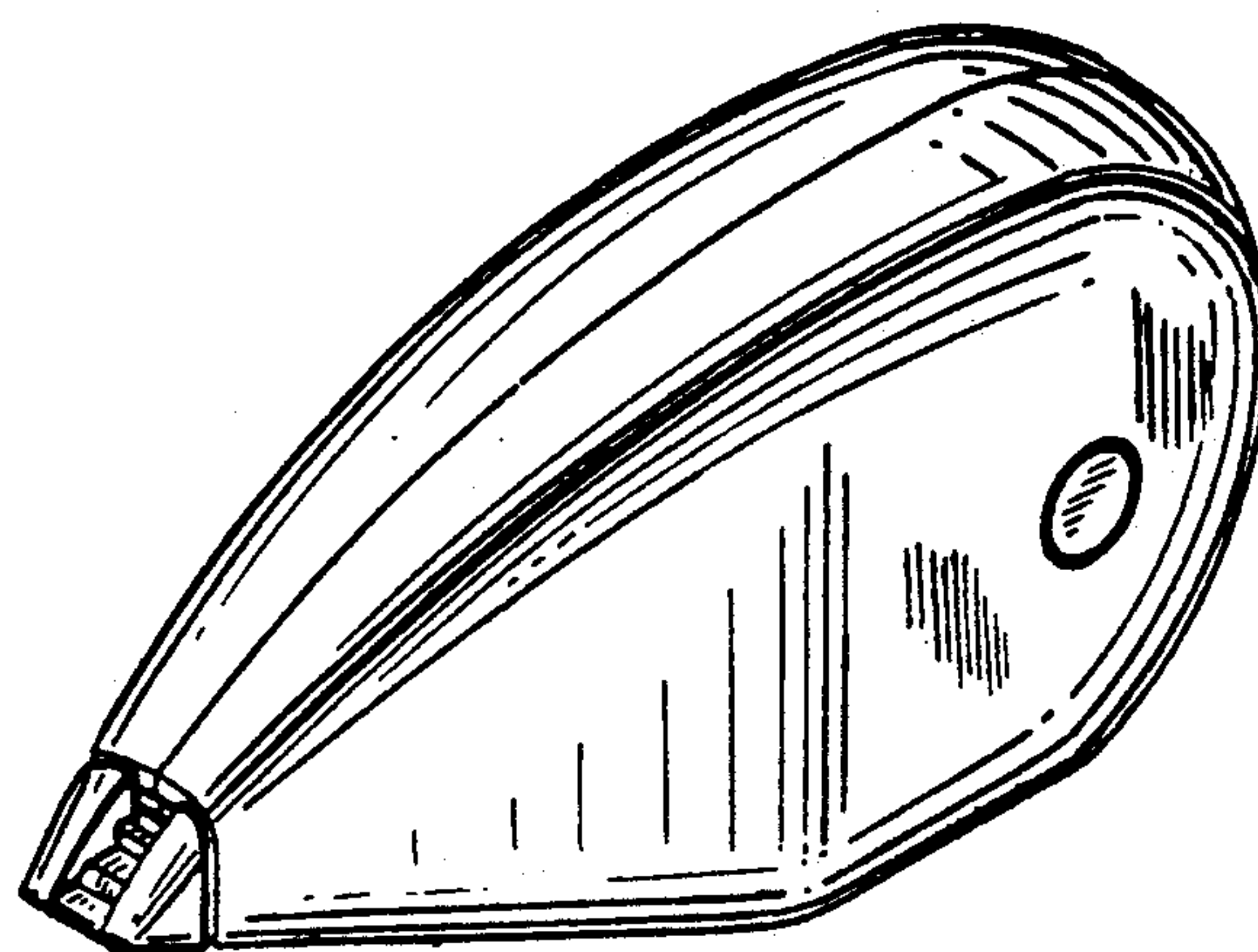

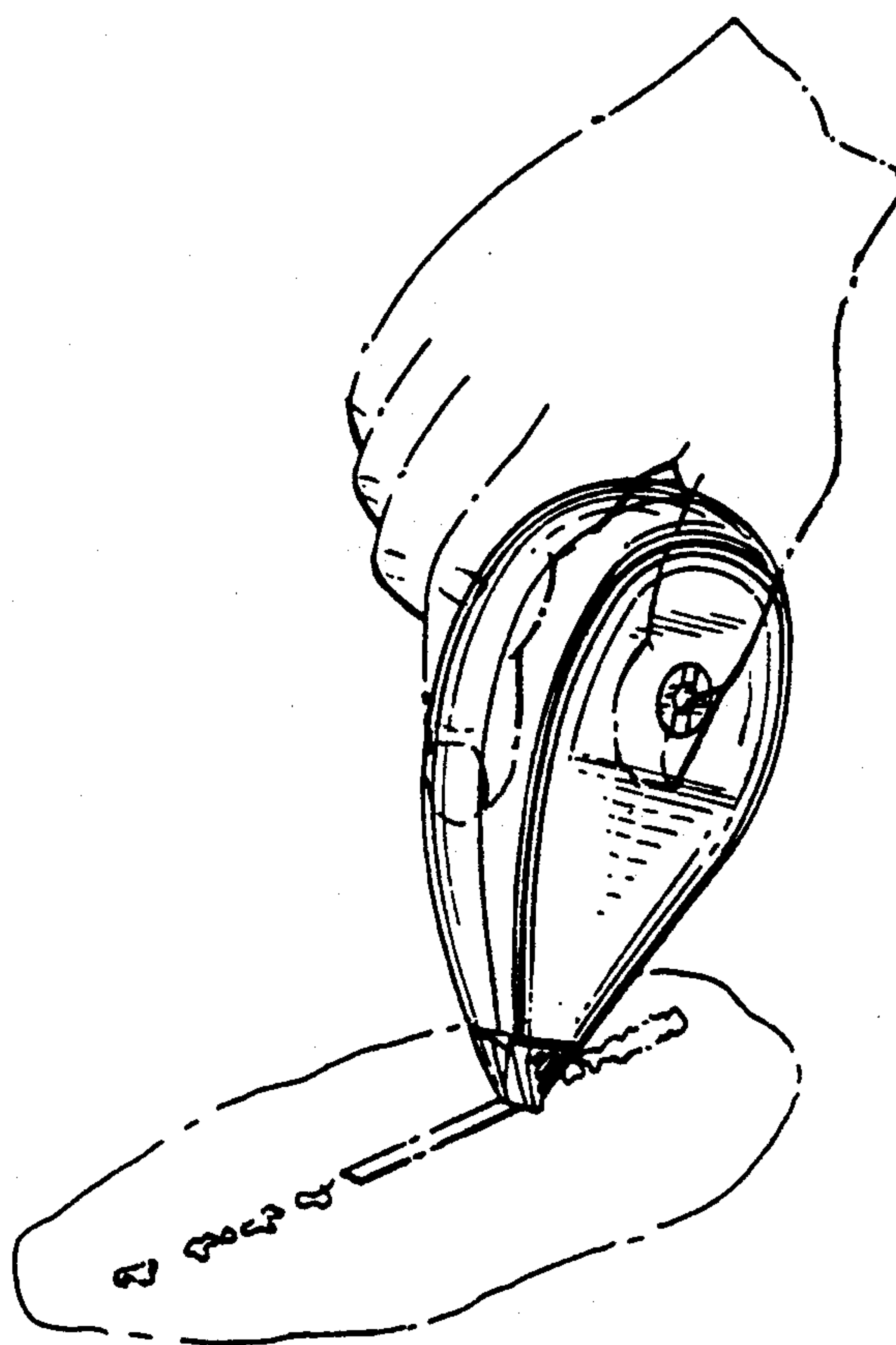

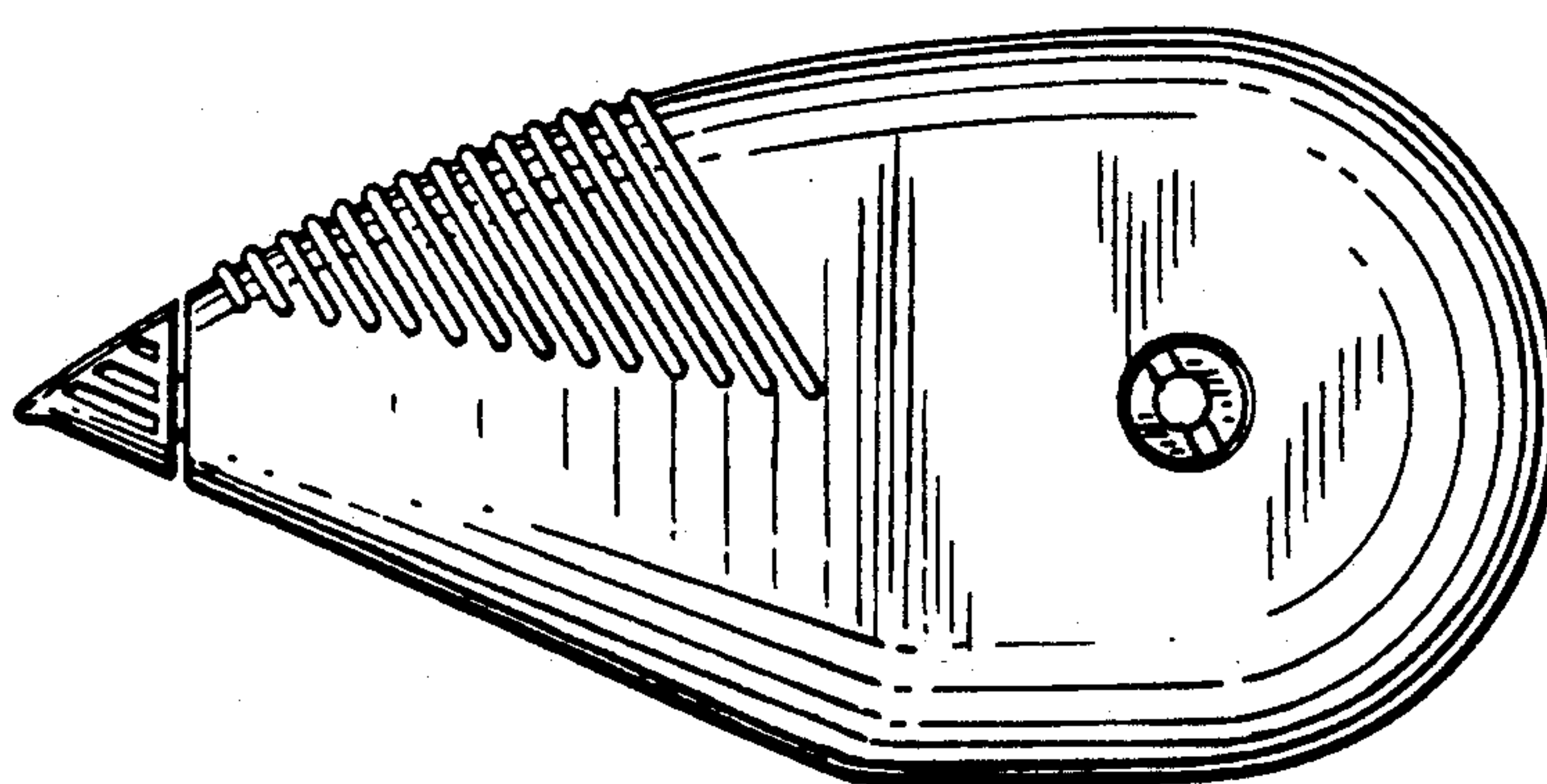

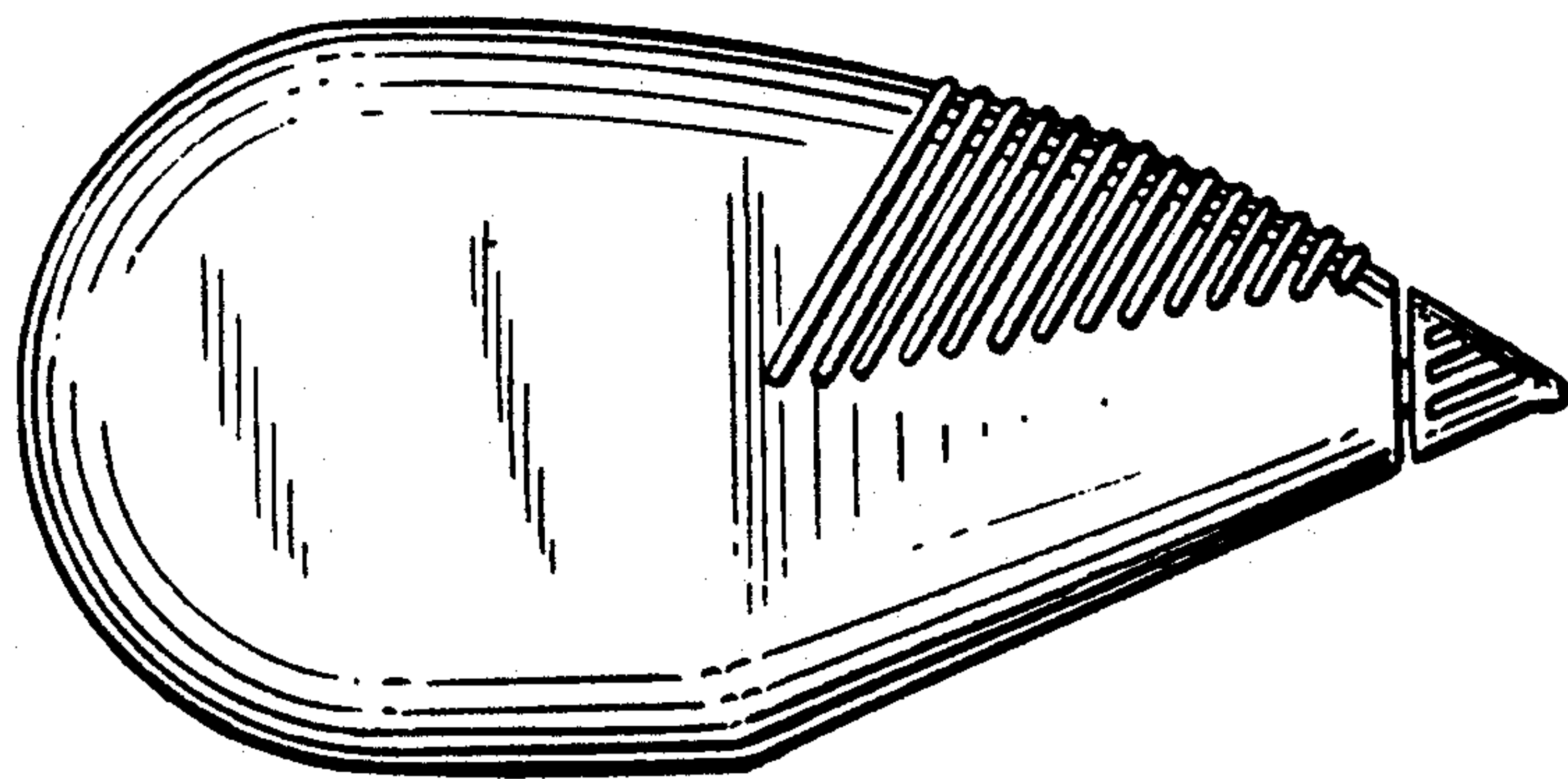

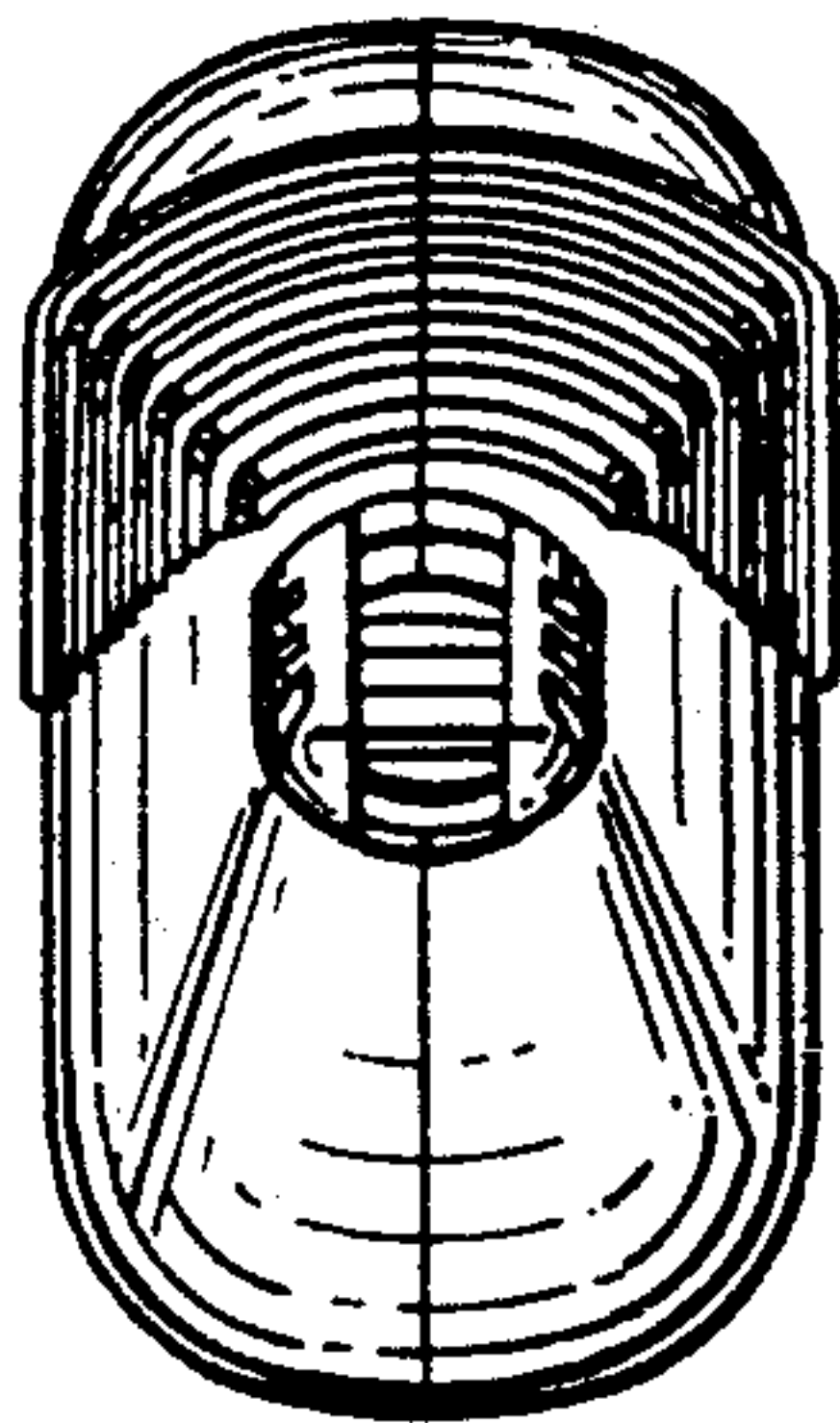

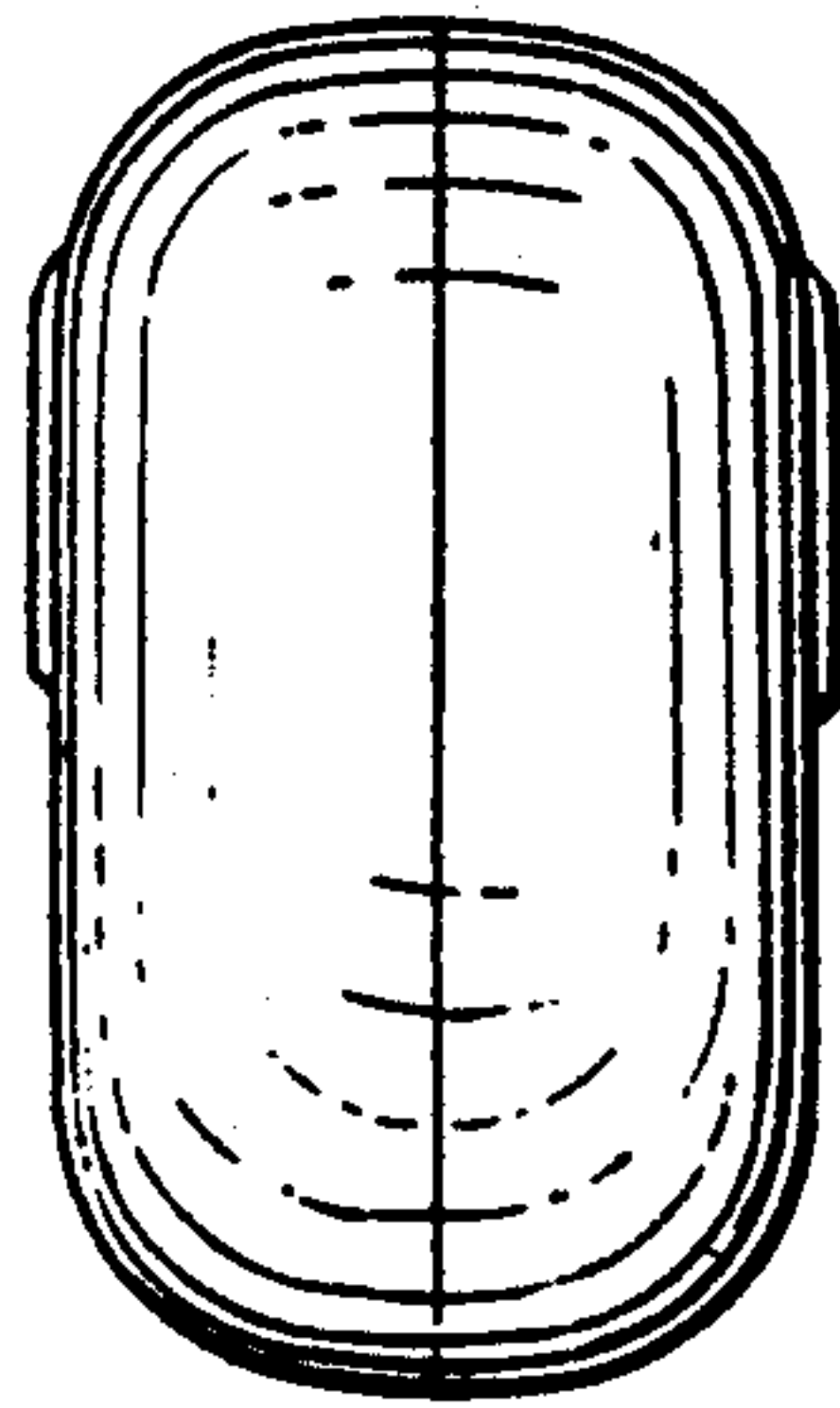

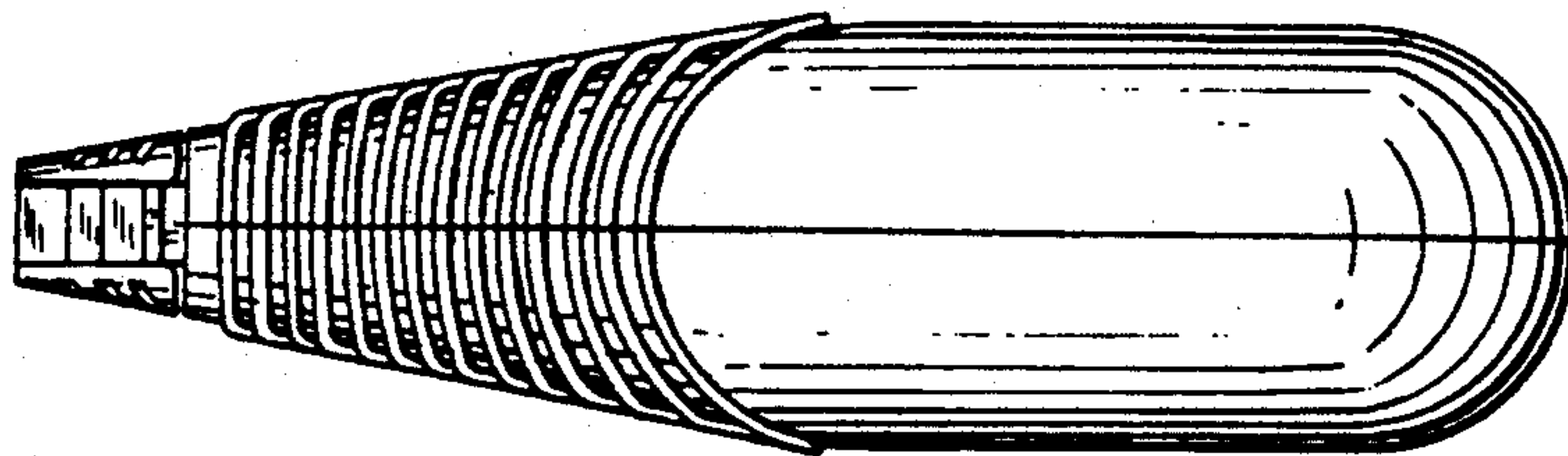

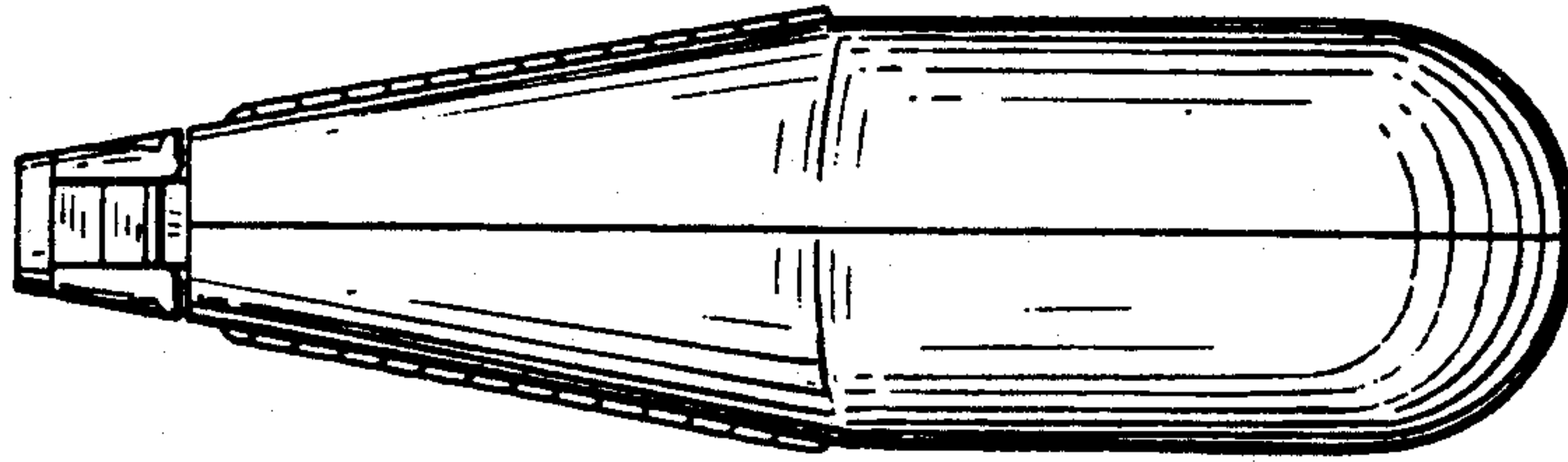

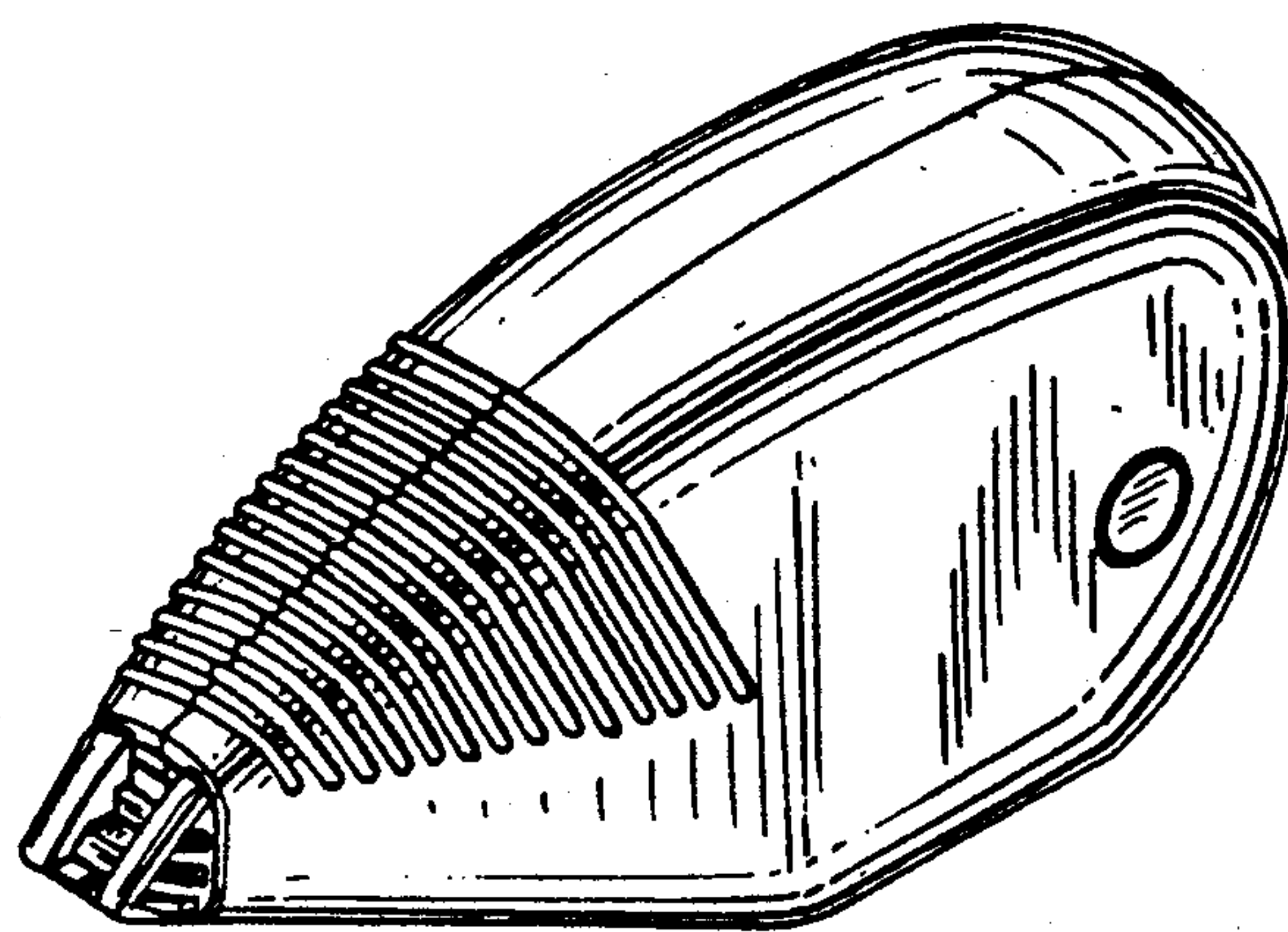

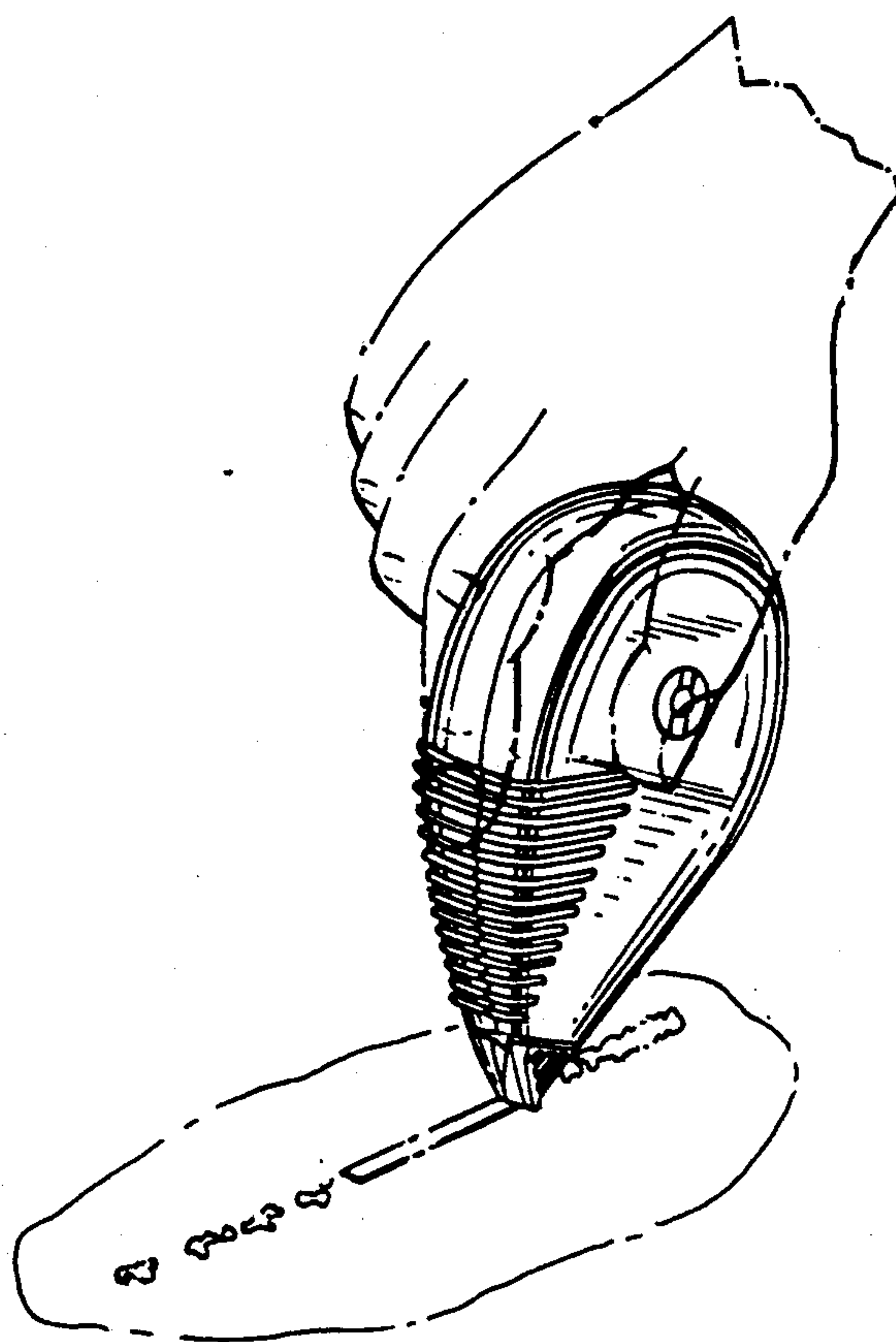

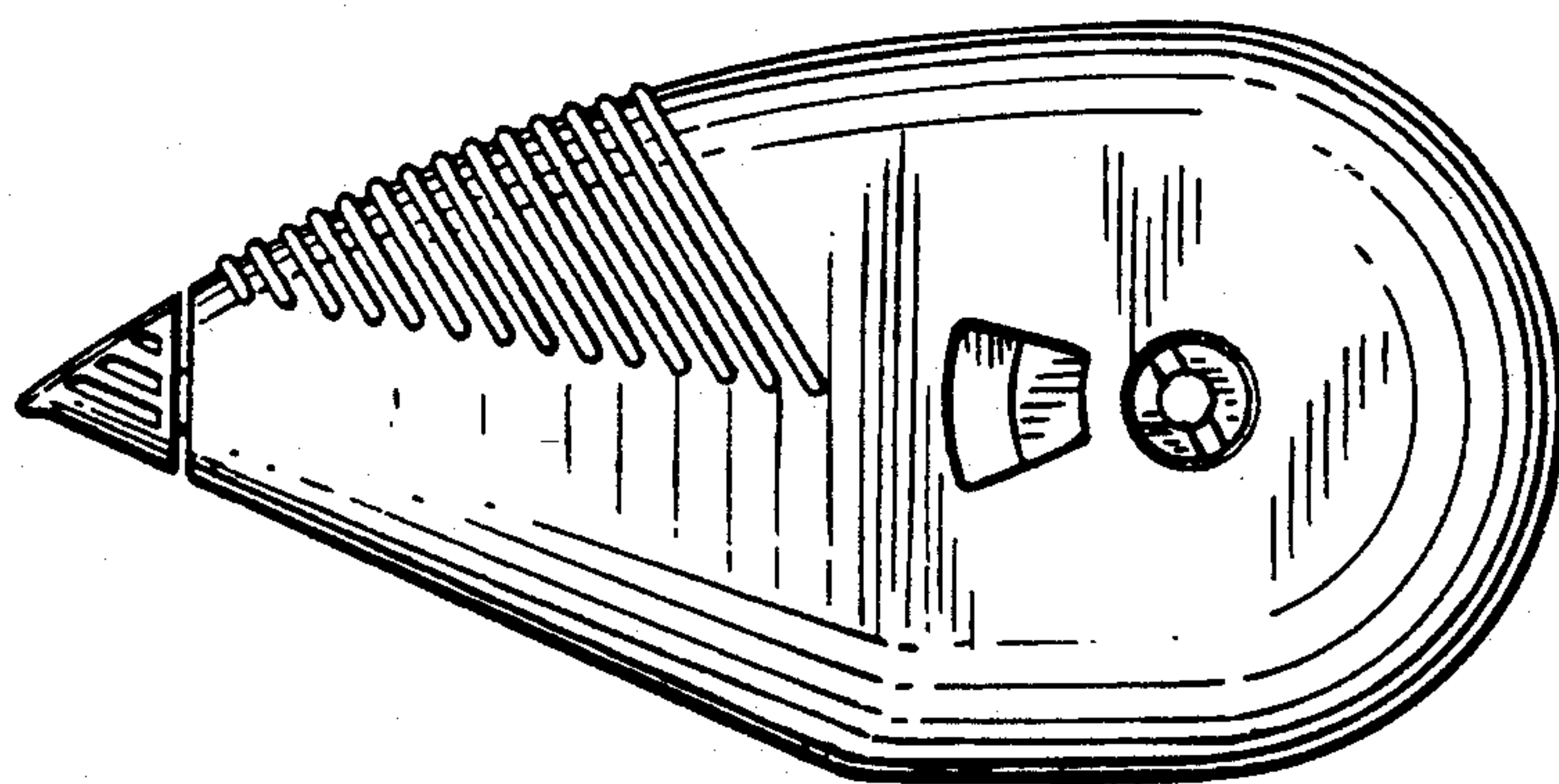

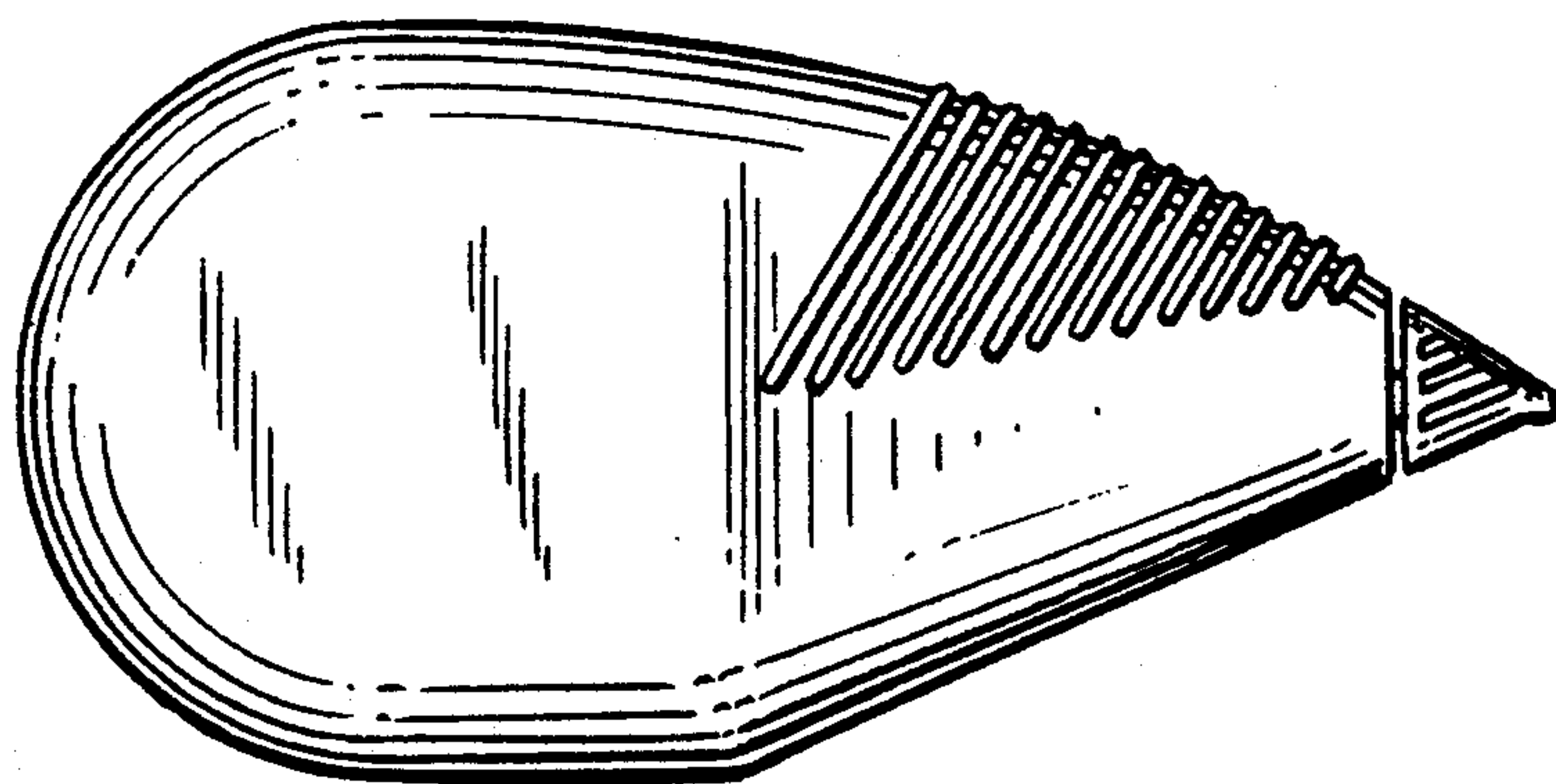

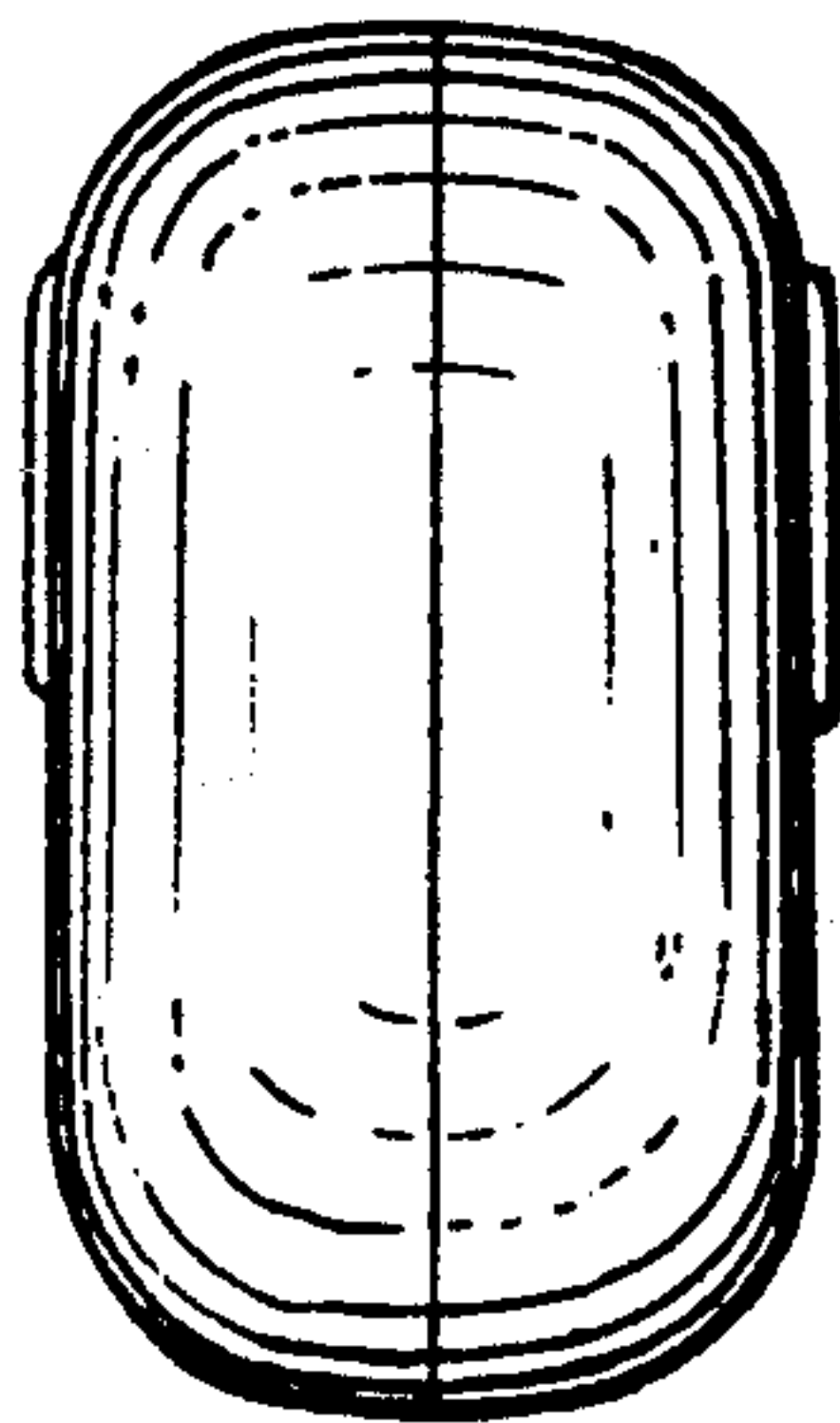

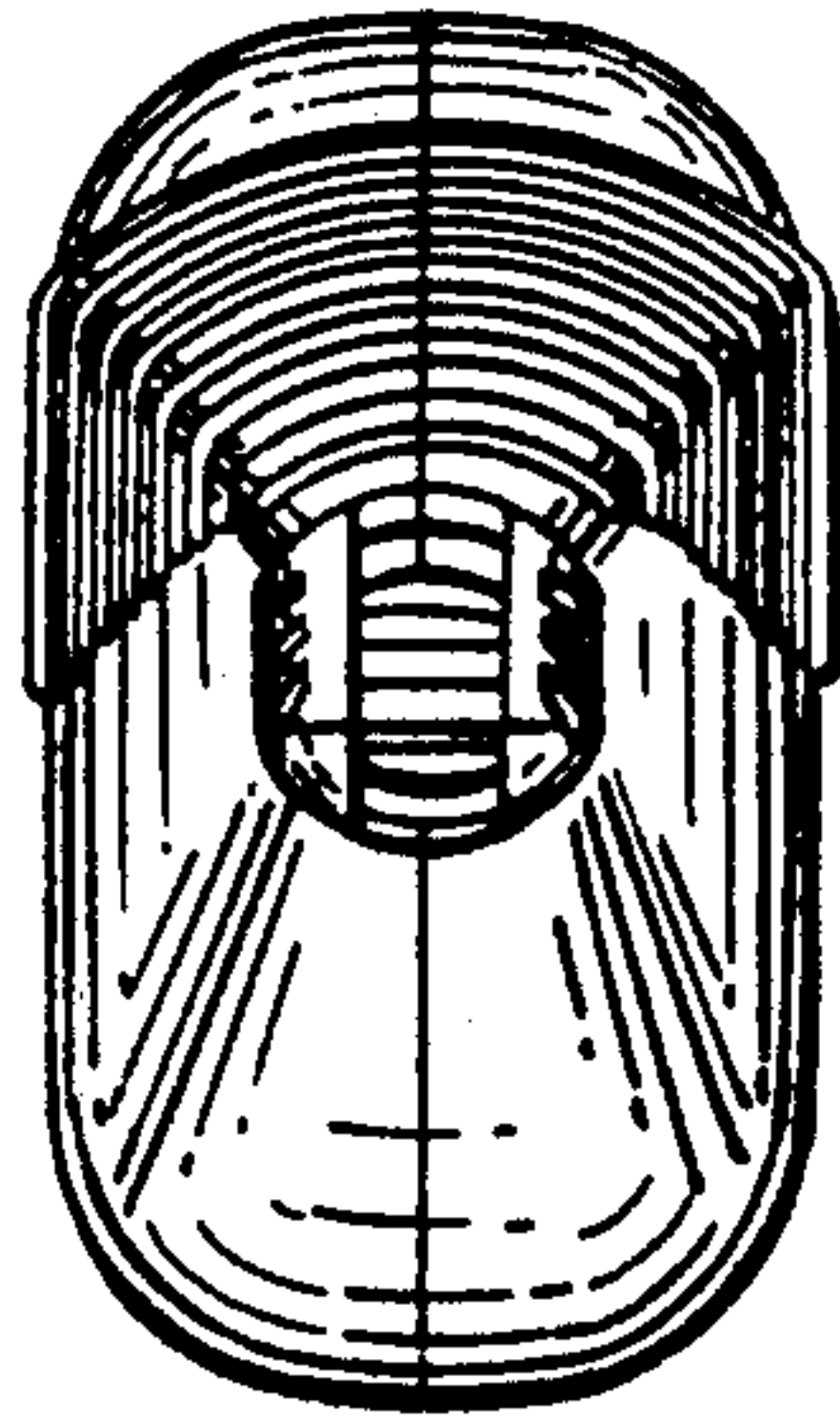

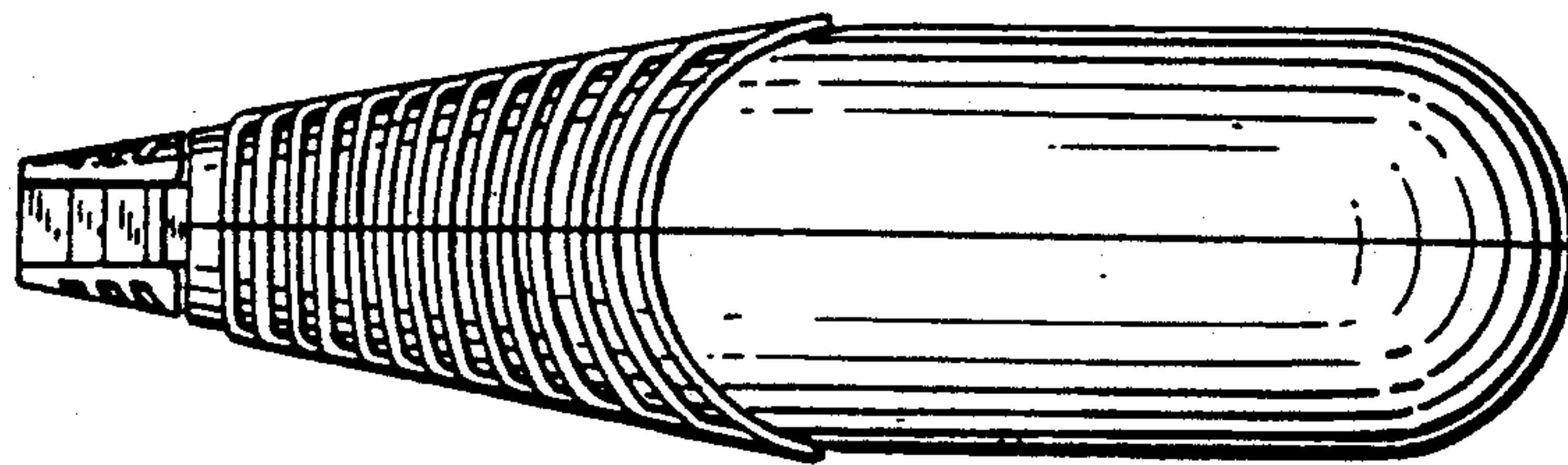

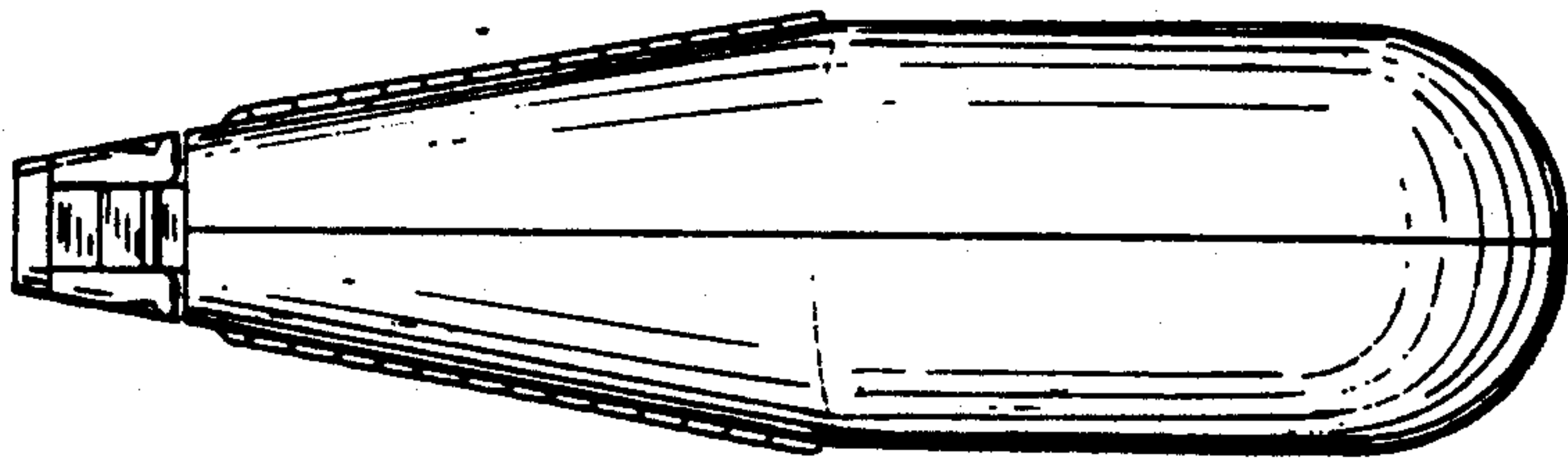
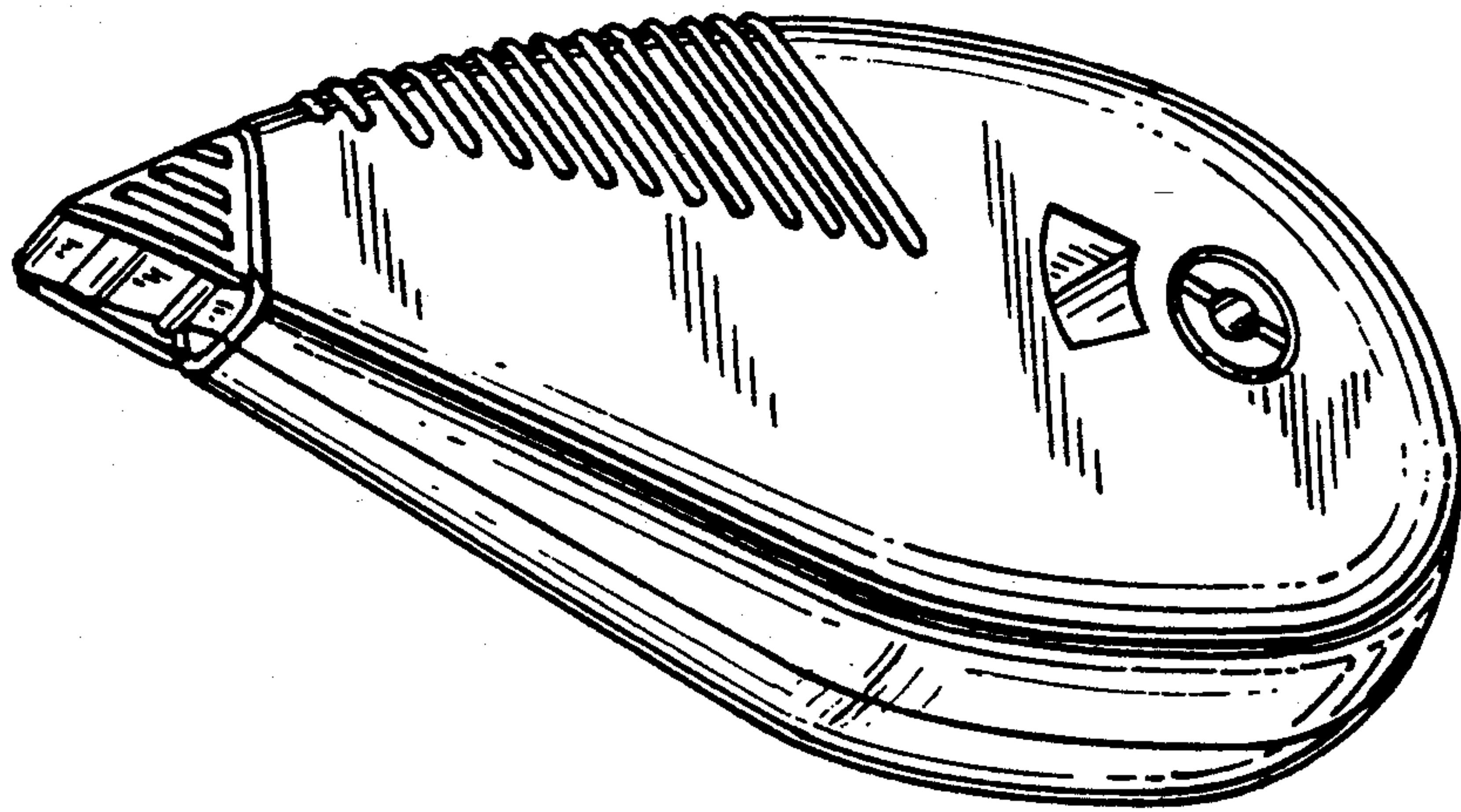

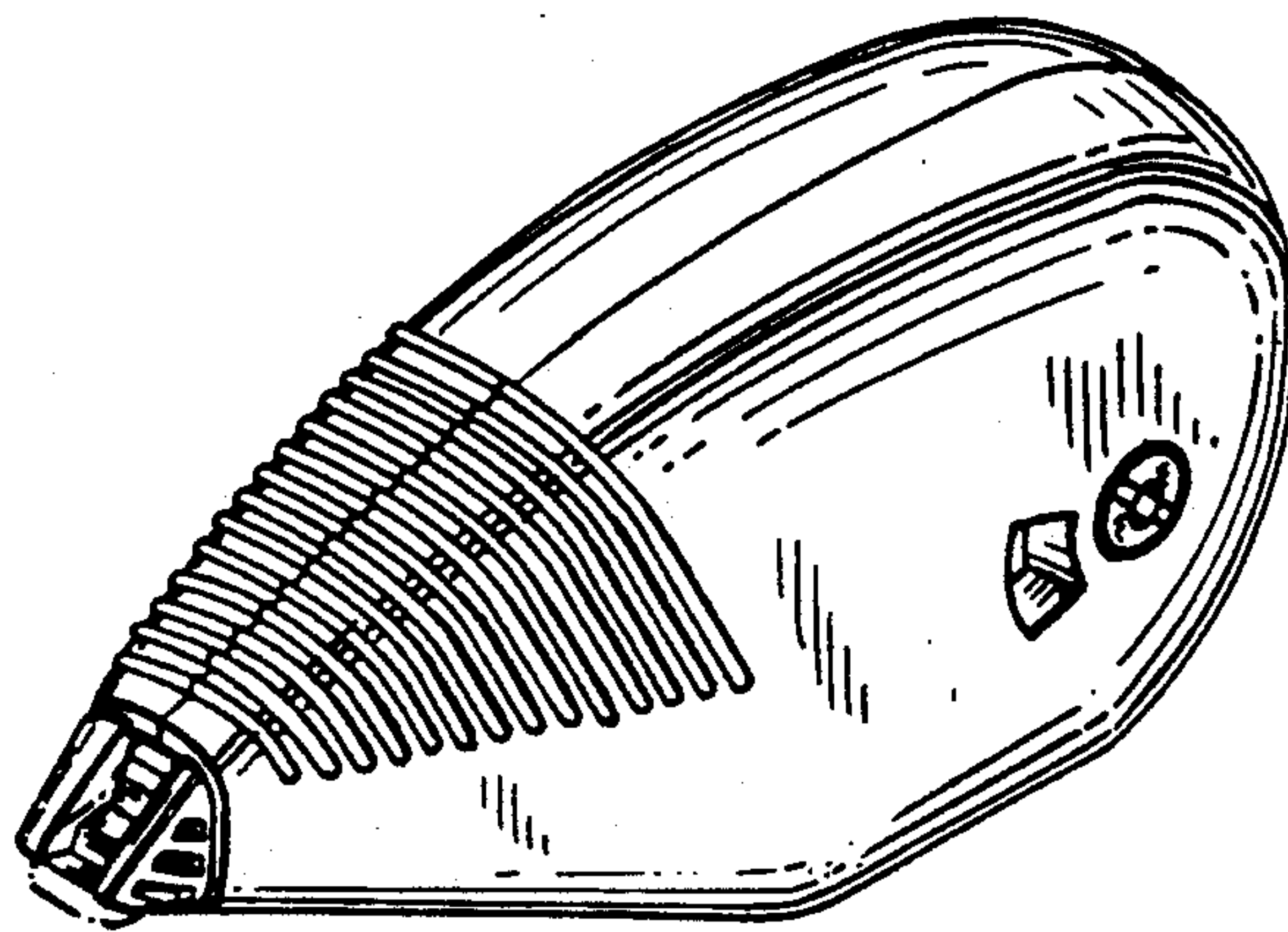
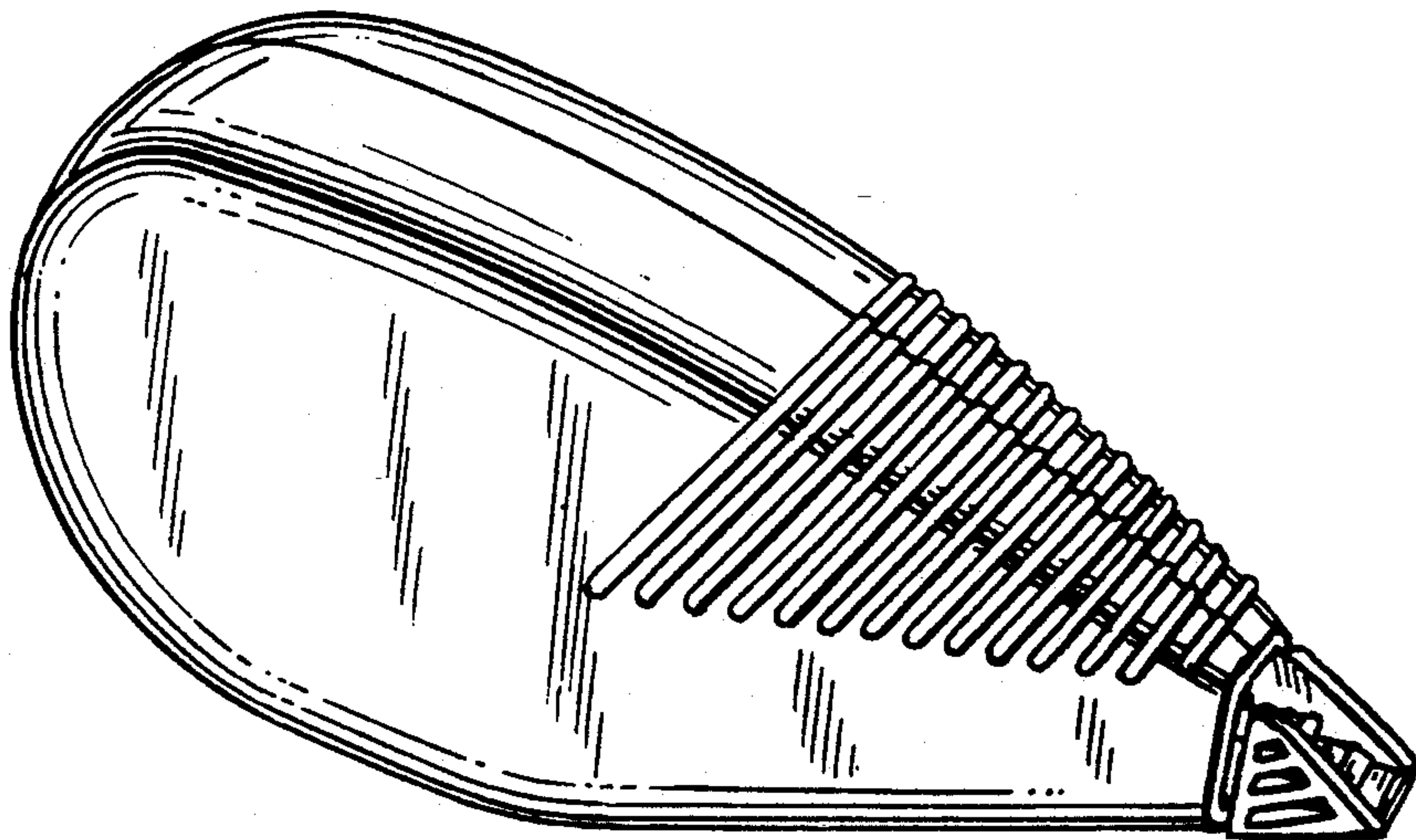

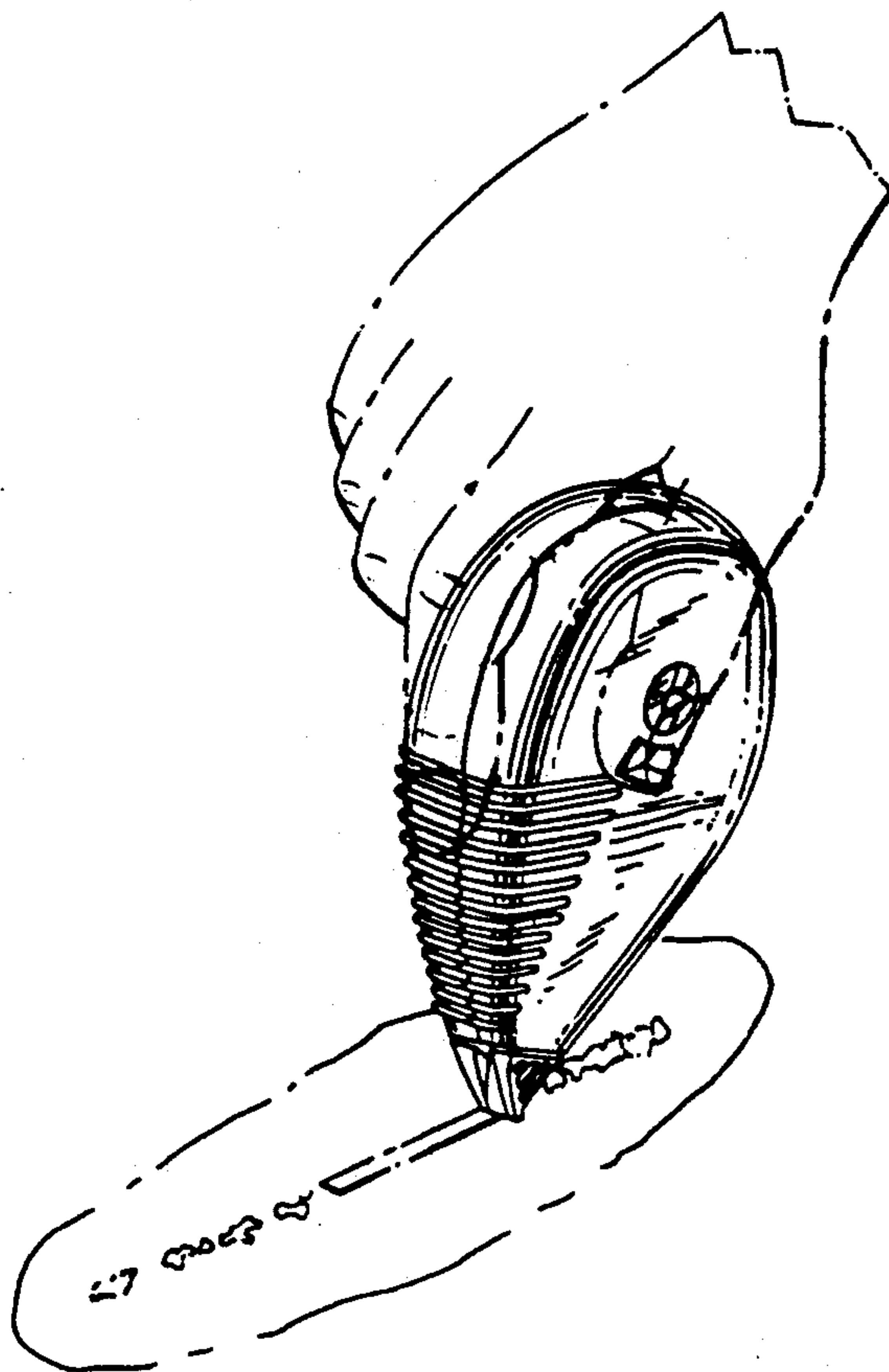
