### [57] CLAIM

The ornamental design for a portable shower, as shown and described.

### DESCRIPTION

FIG. 1 is a top and front right perspective view of a handy shower, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left-side elevational view thereof; FIG. 4 is a right-side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a bottom plan view thereof. Portions of the portable shower have been broken away in FIGS. 2, 3, 4 and 6 for ease in illustration.

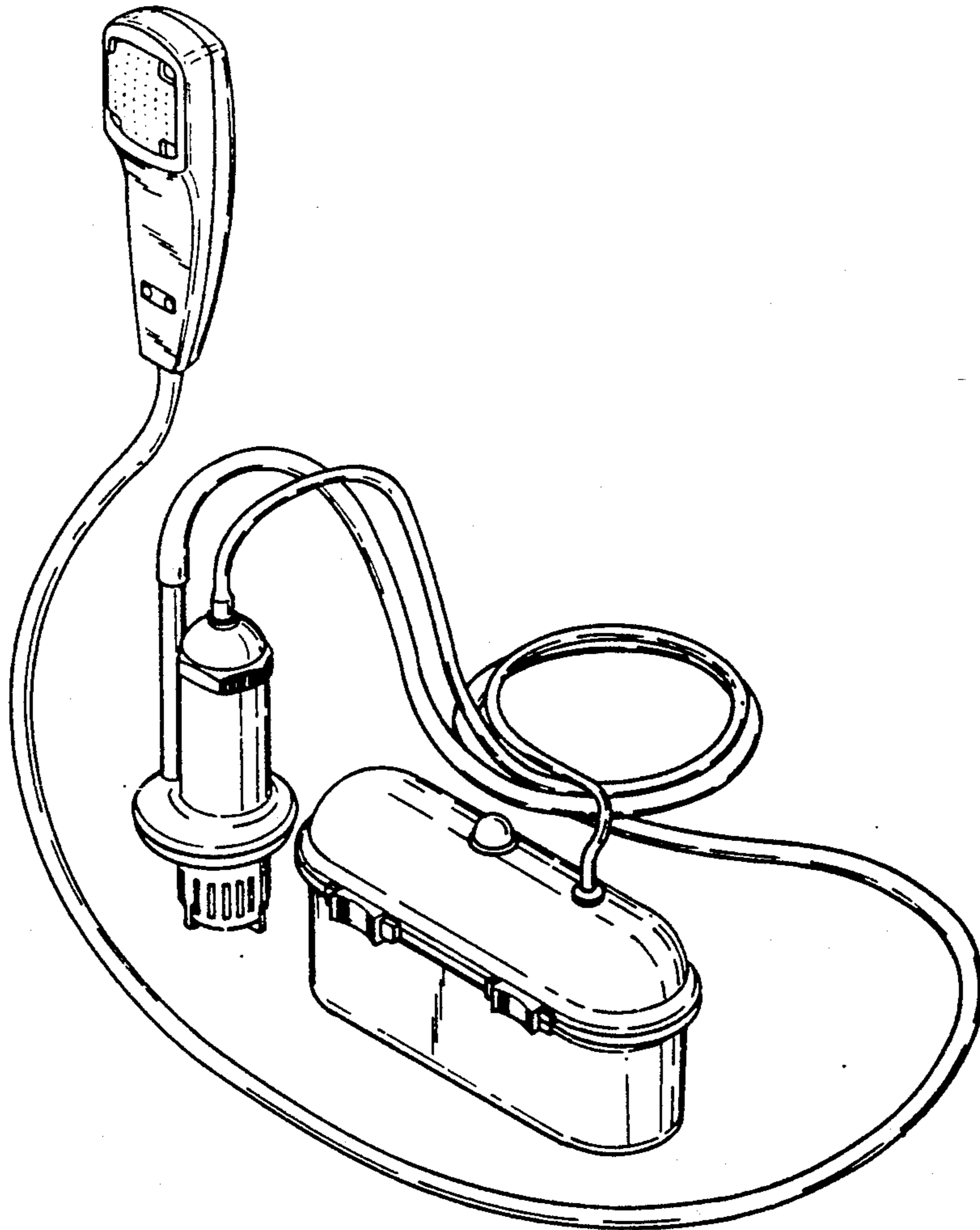

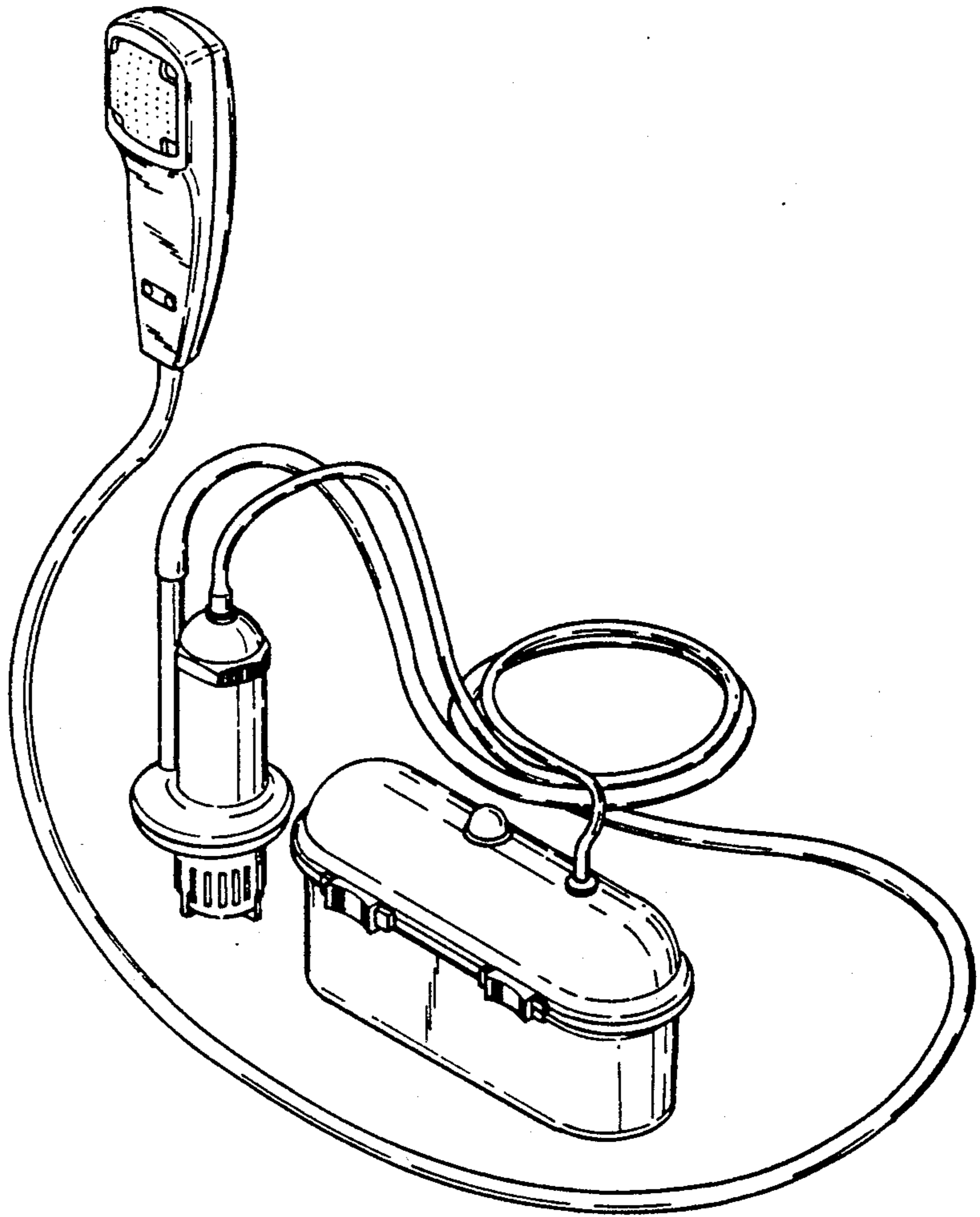

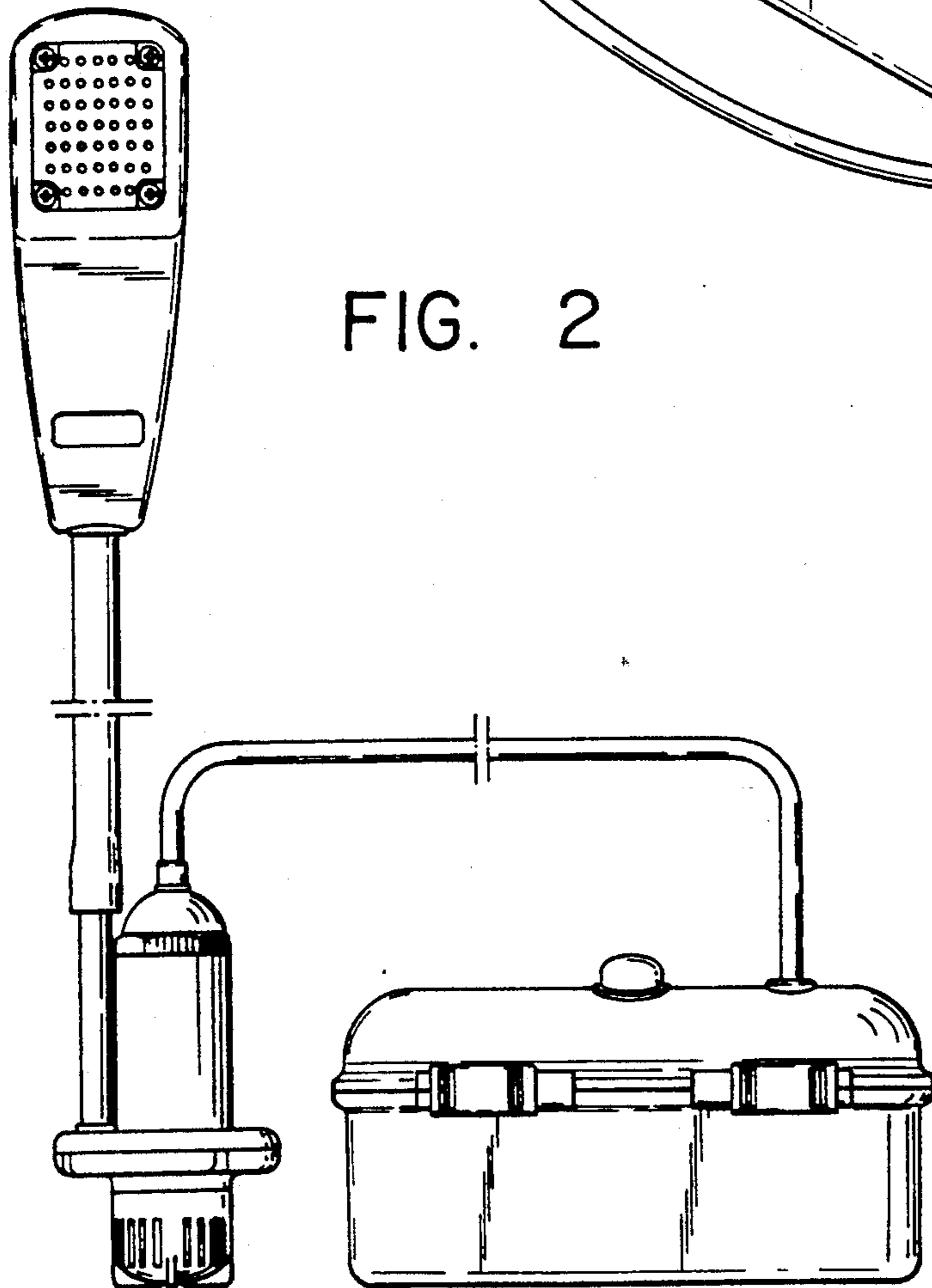

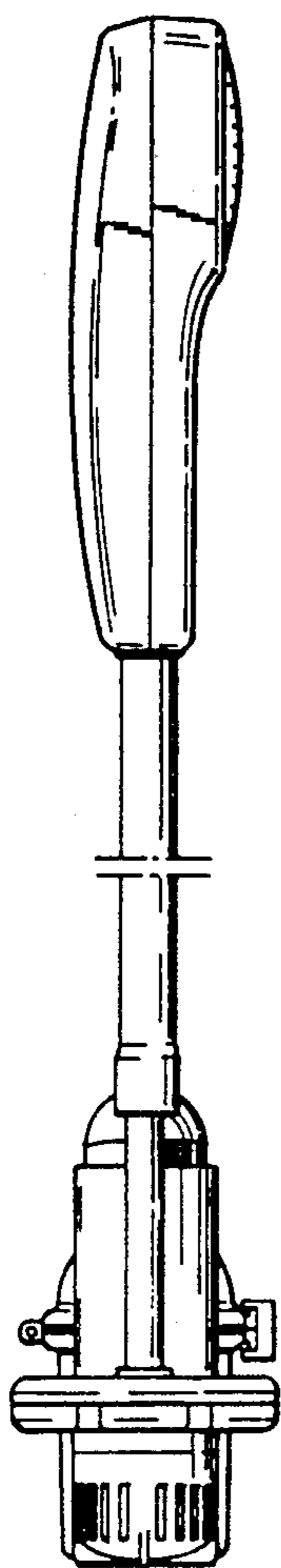

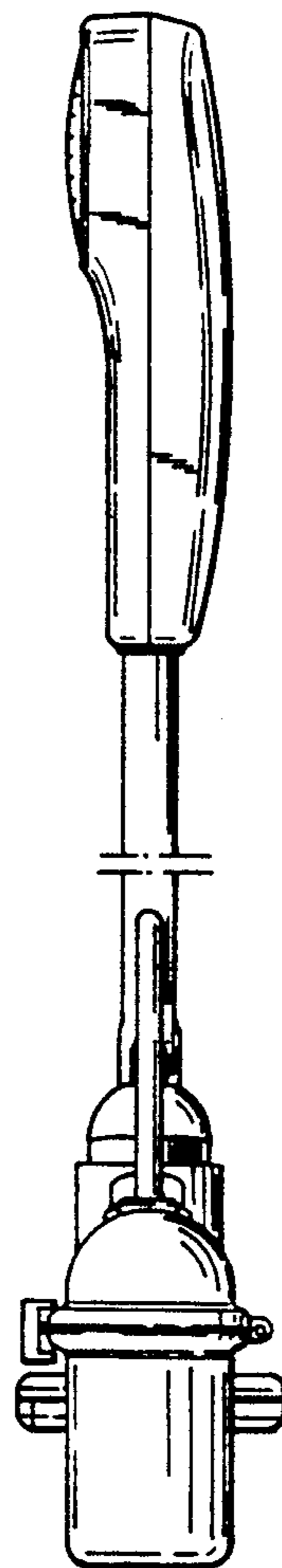

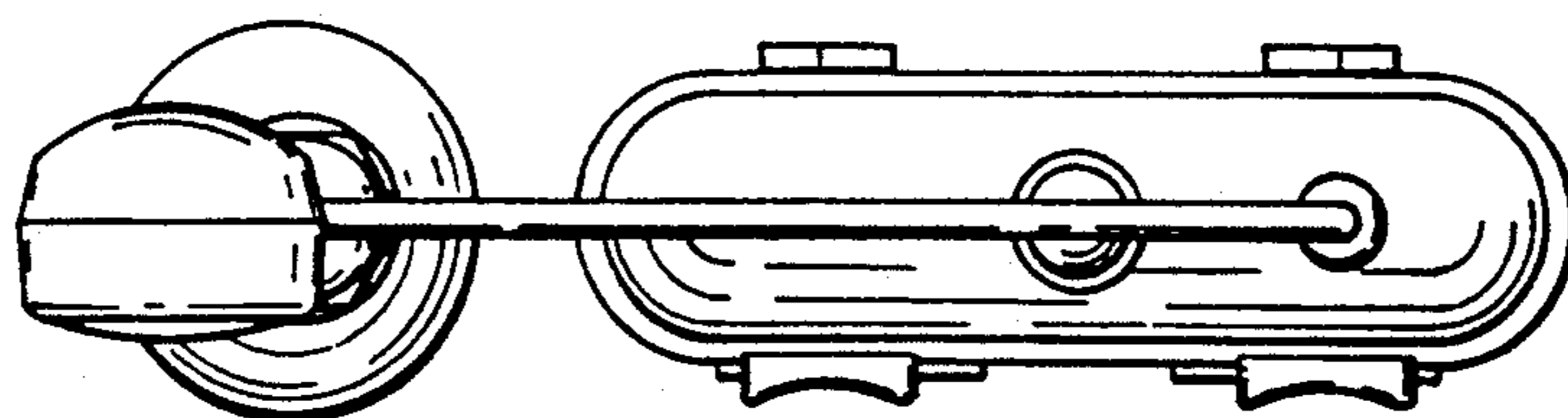

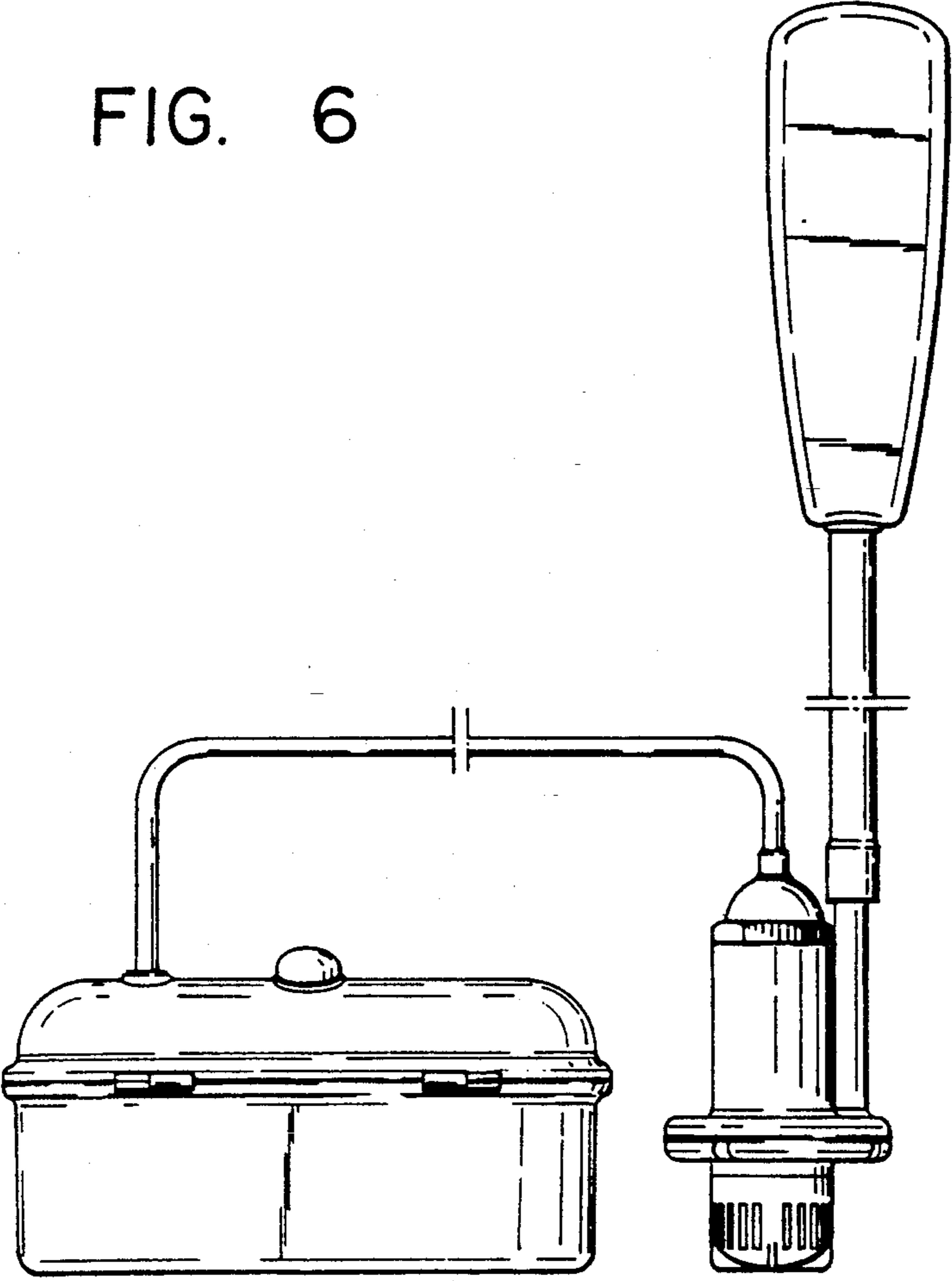
