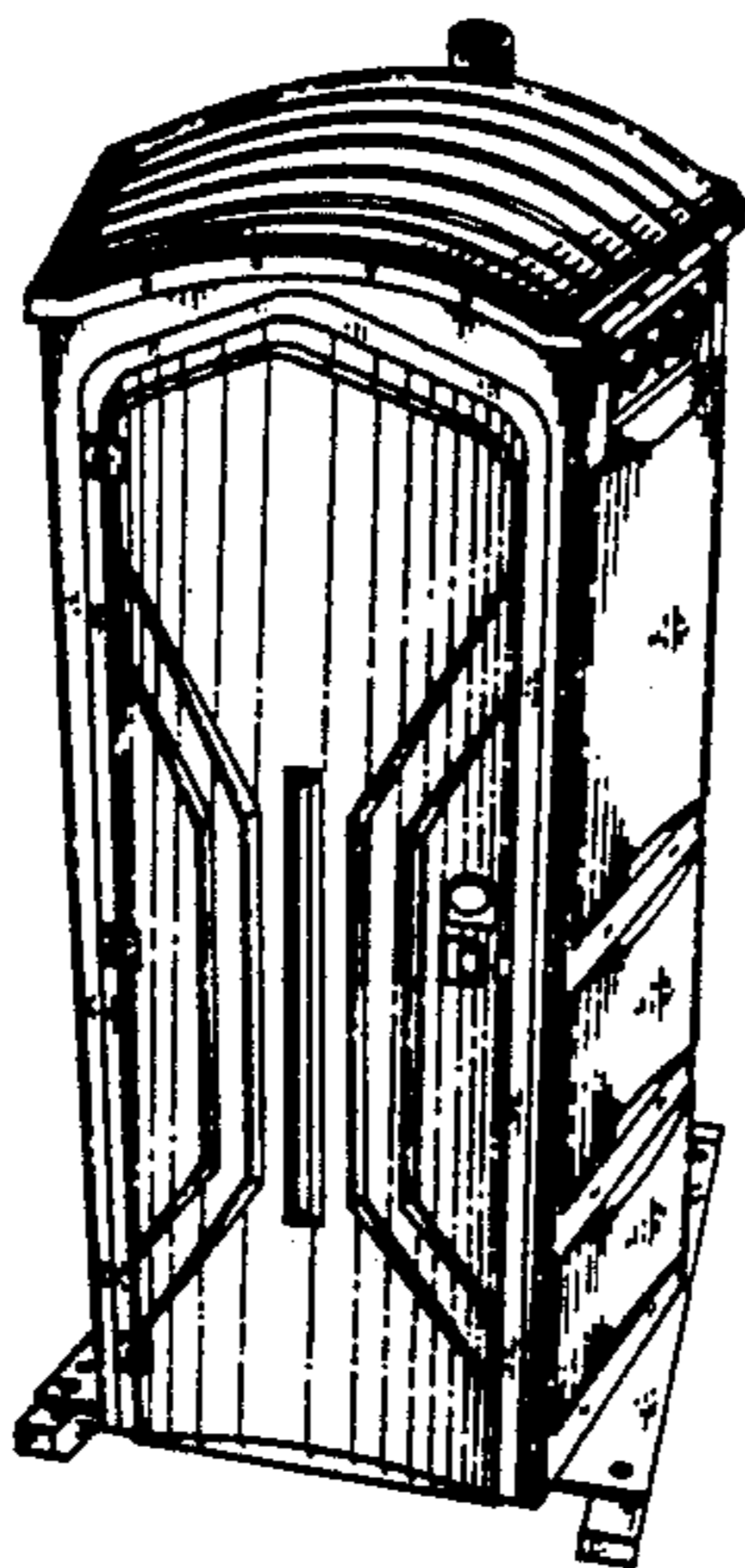

[57] **CLAIM**

The ornamental design for a portable restroom, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable restroom showing our new design;
 FIG. 2 is a top plan view thereof, the bottom plan being plain and unadorned;
 FIG. 3 is a front view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a rear view thereof;
 FIG. 7 is a perspective view of a portable restroom showing another embodiment of our new design;
 FIG. 8 is a top plan view of the embodiment of FIG. 7, the bottom plan being plain and unadorned;
 FIG. 9 is a front view of the embodiment of FIG. 7;
 FIG. 10 is a left side view of the embodiment of FIG. 7;
 FIG. 11 is a right side view of the embodiment of FIG. 7;
 FIG. 12 is a rear view of the embodiment of FIG. 7;
 FIG. 13 is a perspective view of another embodiment of our new design;
 FIG. 14 is a top plan view of the embodiment of FIG. 13, the bottom plan being plain and unadorned;
 FIG. 15 is a front view of the embodiment of FIG. 13;
 FIG. 16 is a right side view of the embodiment of FIG. 13;
 FIG. 17 is a left side view of the embodiment of FIG. 13;
 FIG. 18 is a rear view of the embodiment of FIG. 13;
 FIG. 19 is a perspective view of the embodiment of FIG. 13 with a portion cut away to reveal interior design;
 FIG. 20 is a perspective view of the embodiment of FIG. 13 with open door revealing interior design;
 FIG. 21 is a perspective view of the embodiment of FIG. 13 with open door and a portion cut away to reveal interior design; and,
 FIG. 22 is a sectional view at 22—22 of FIG. 15.



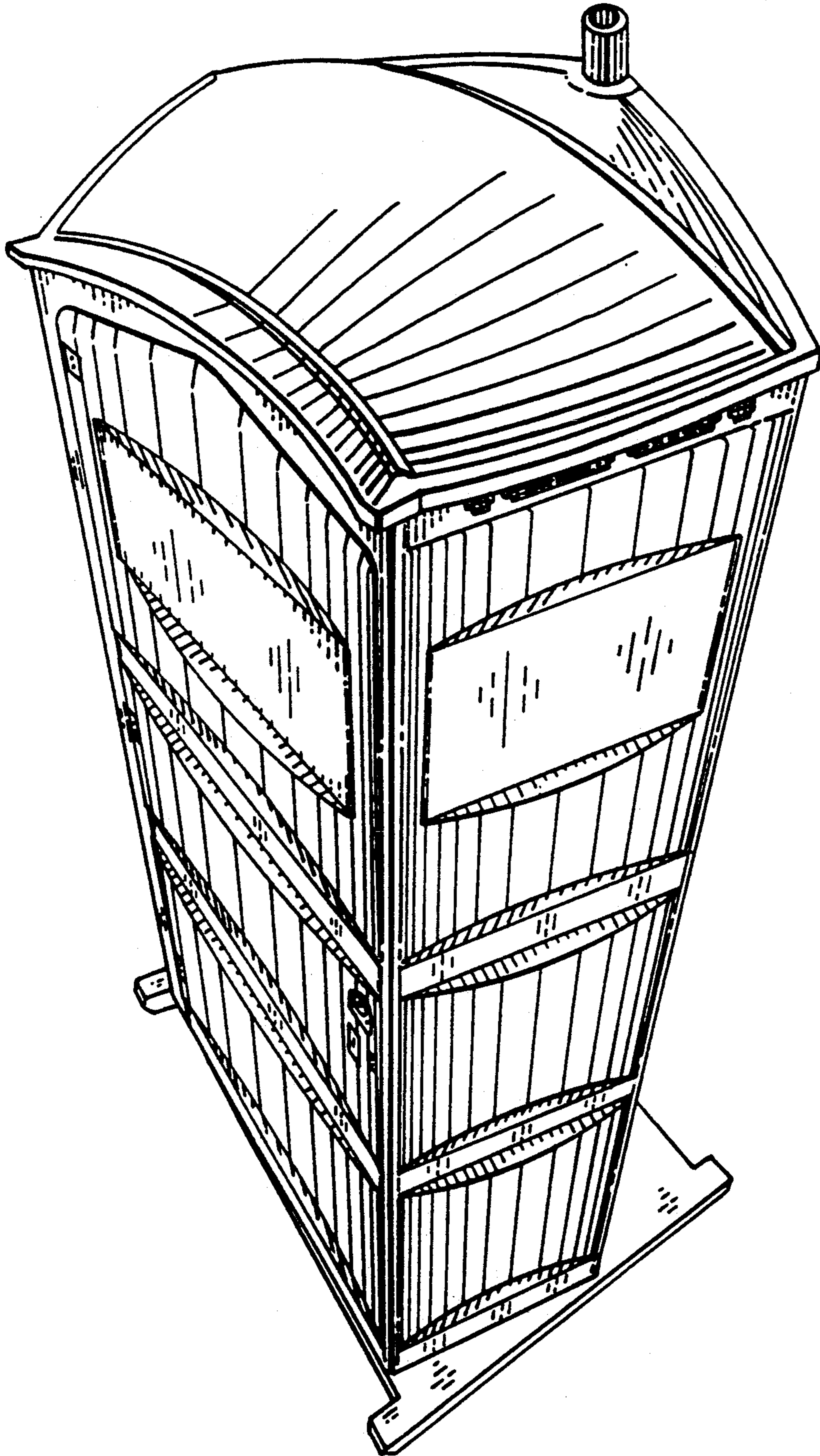

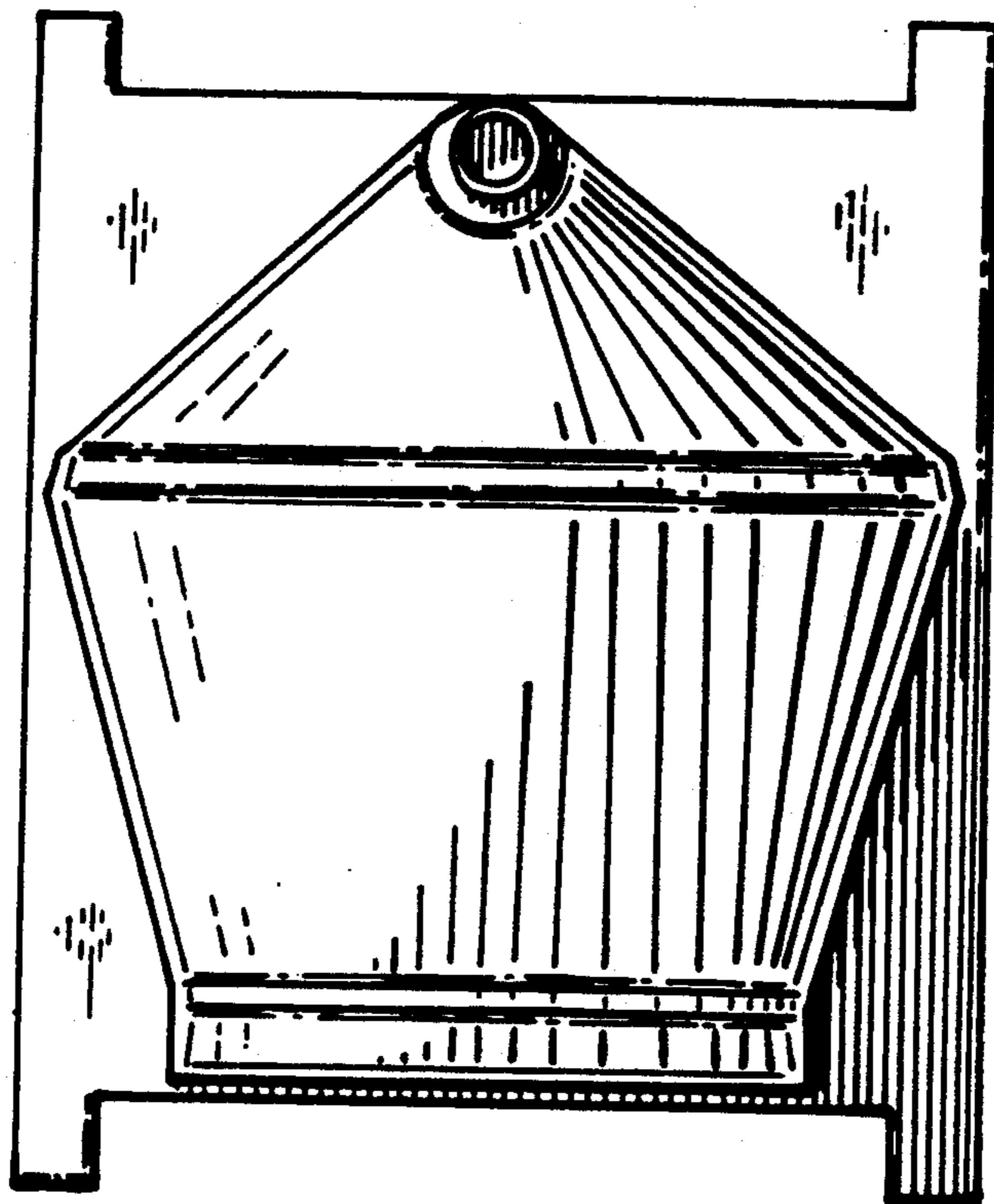

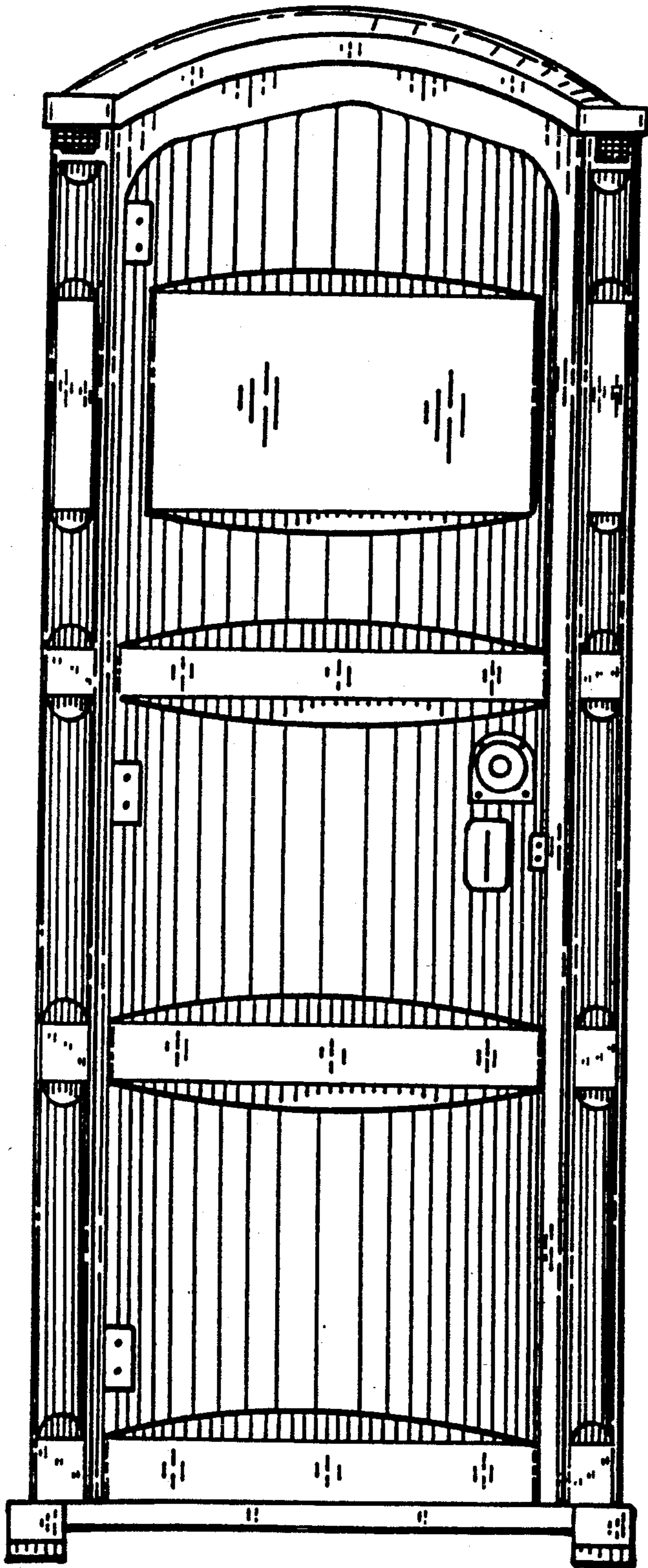

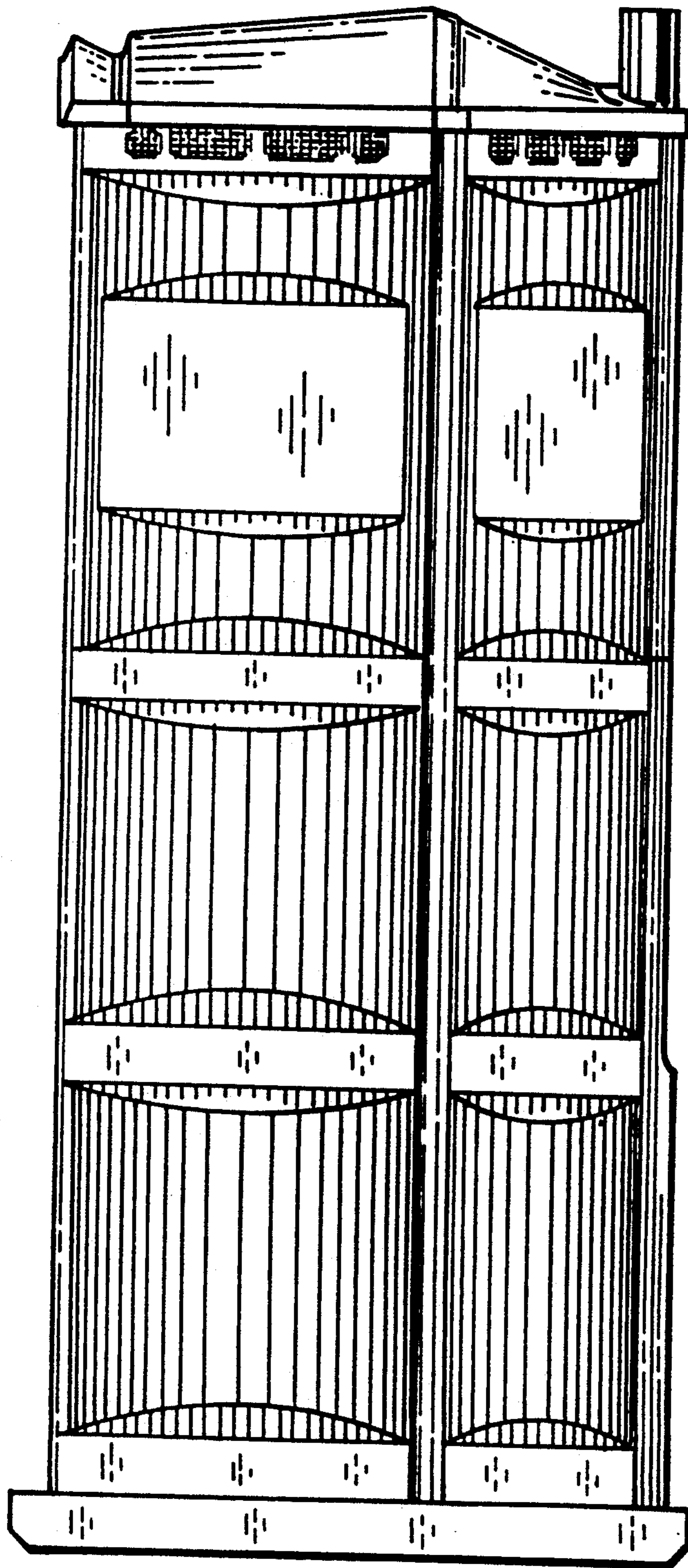

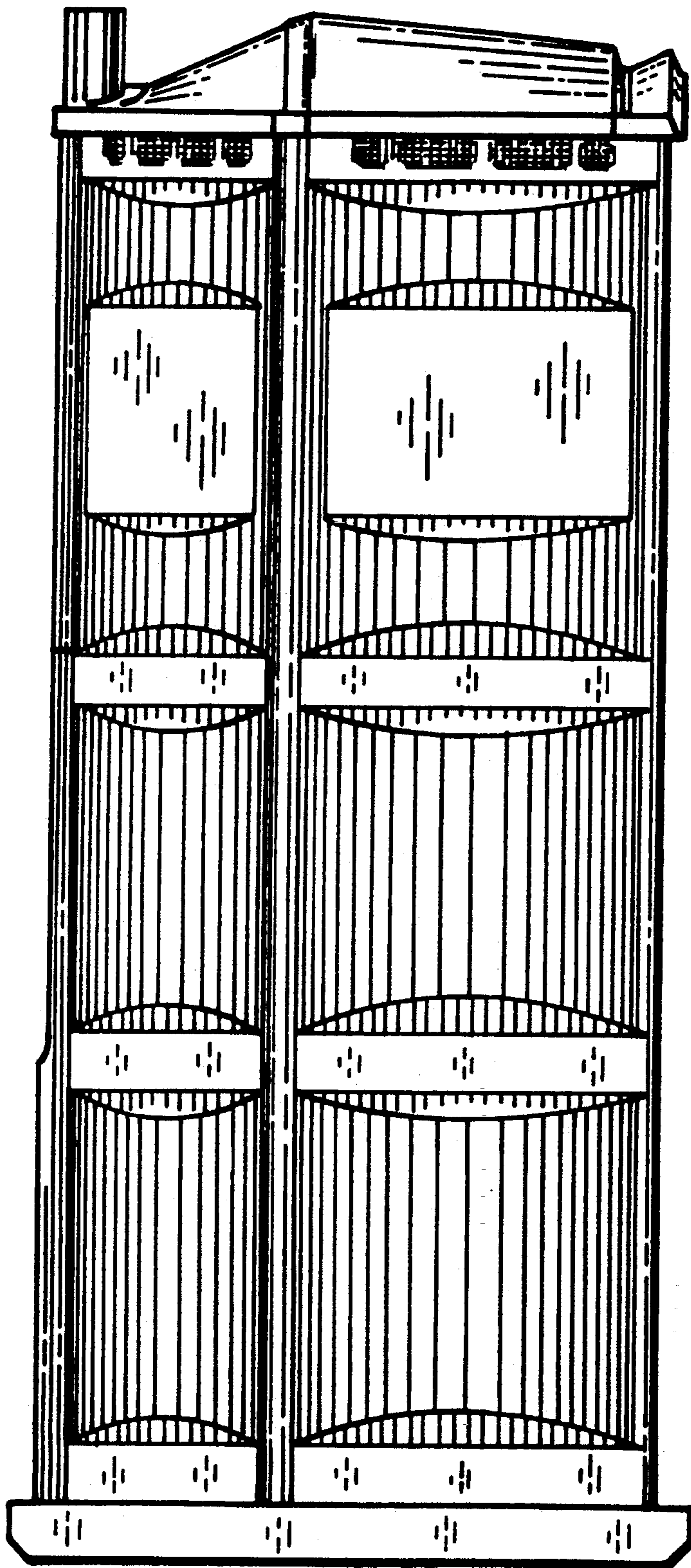

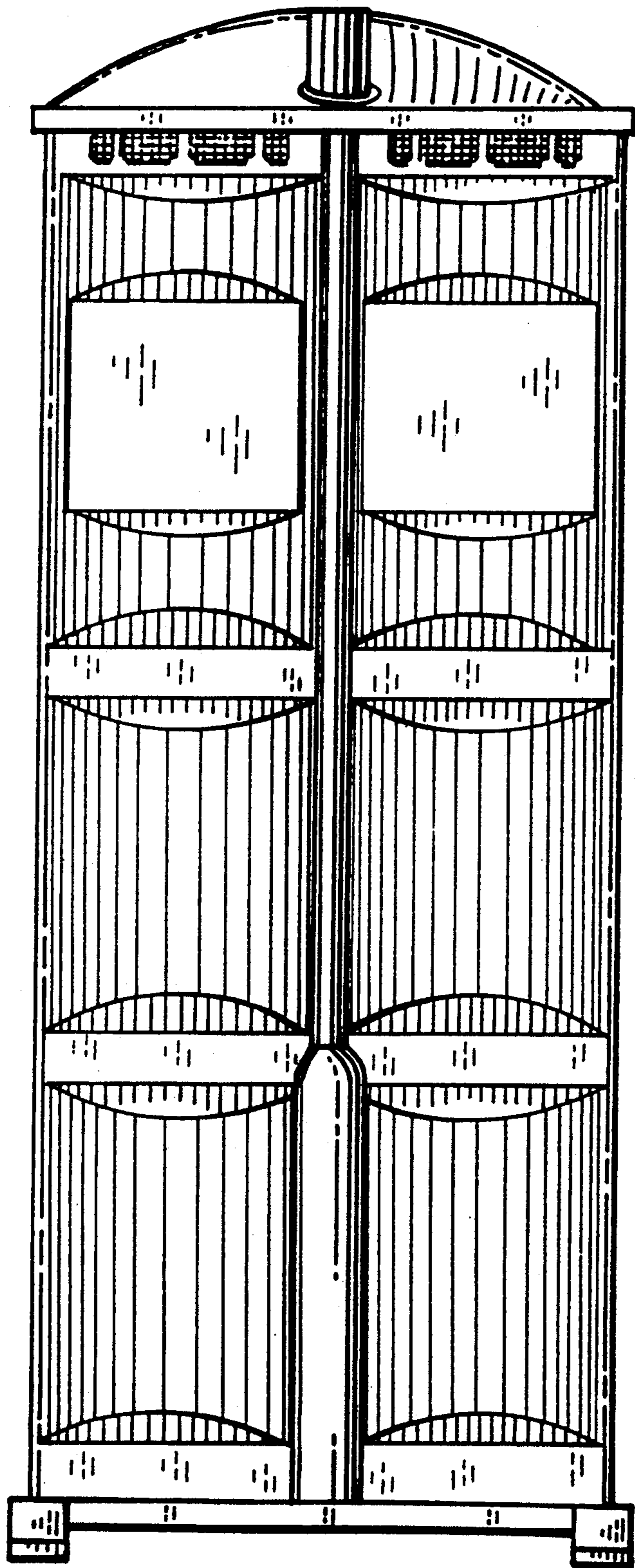

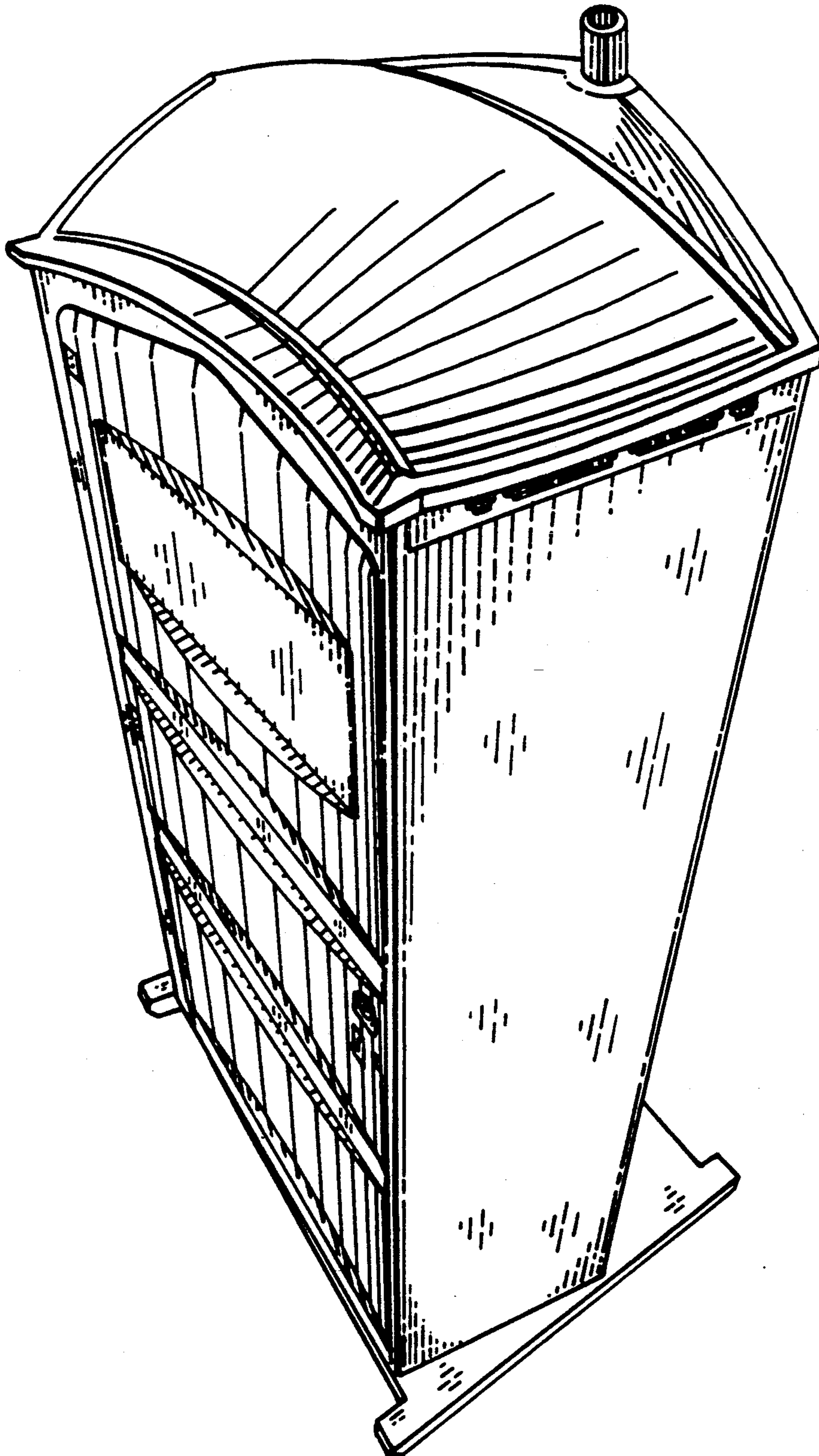

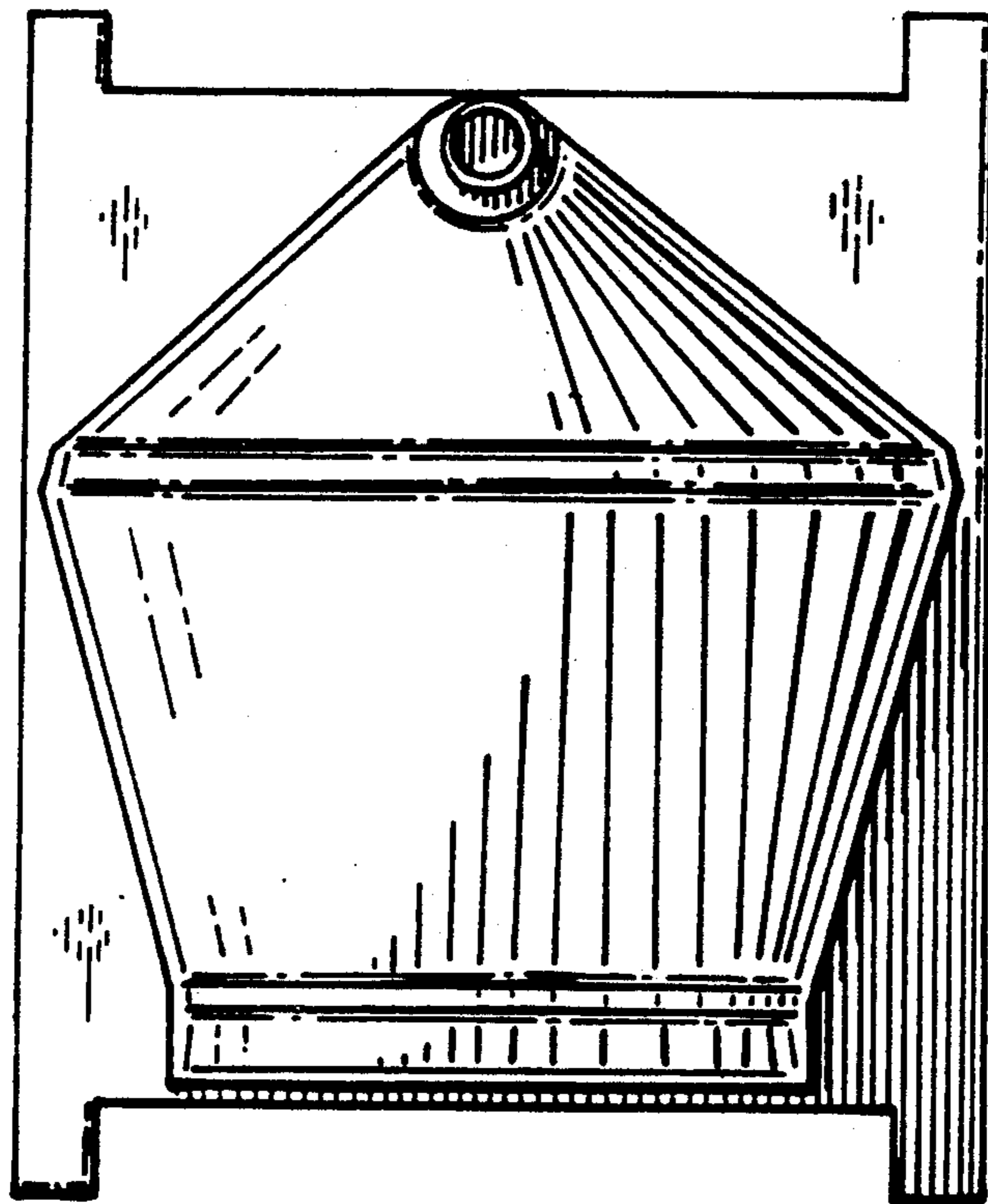

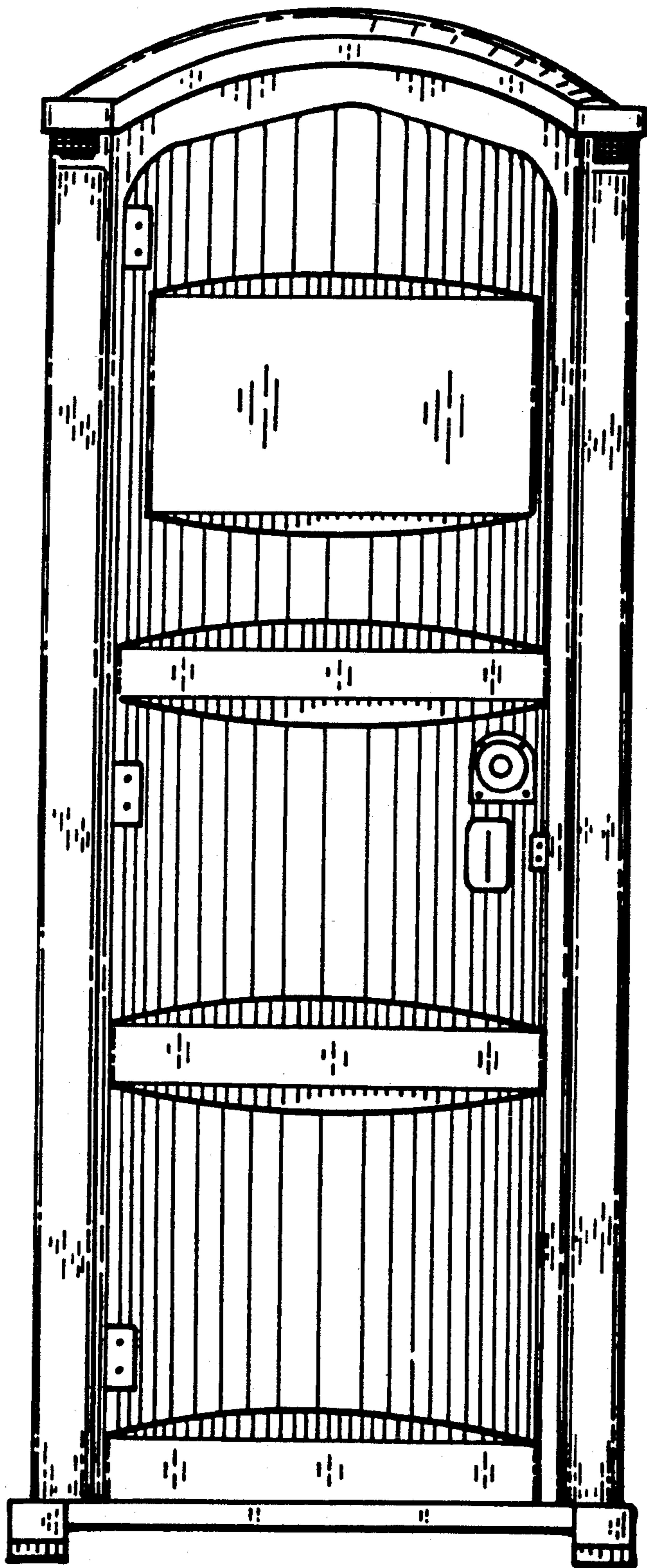

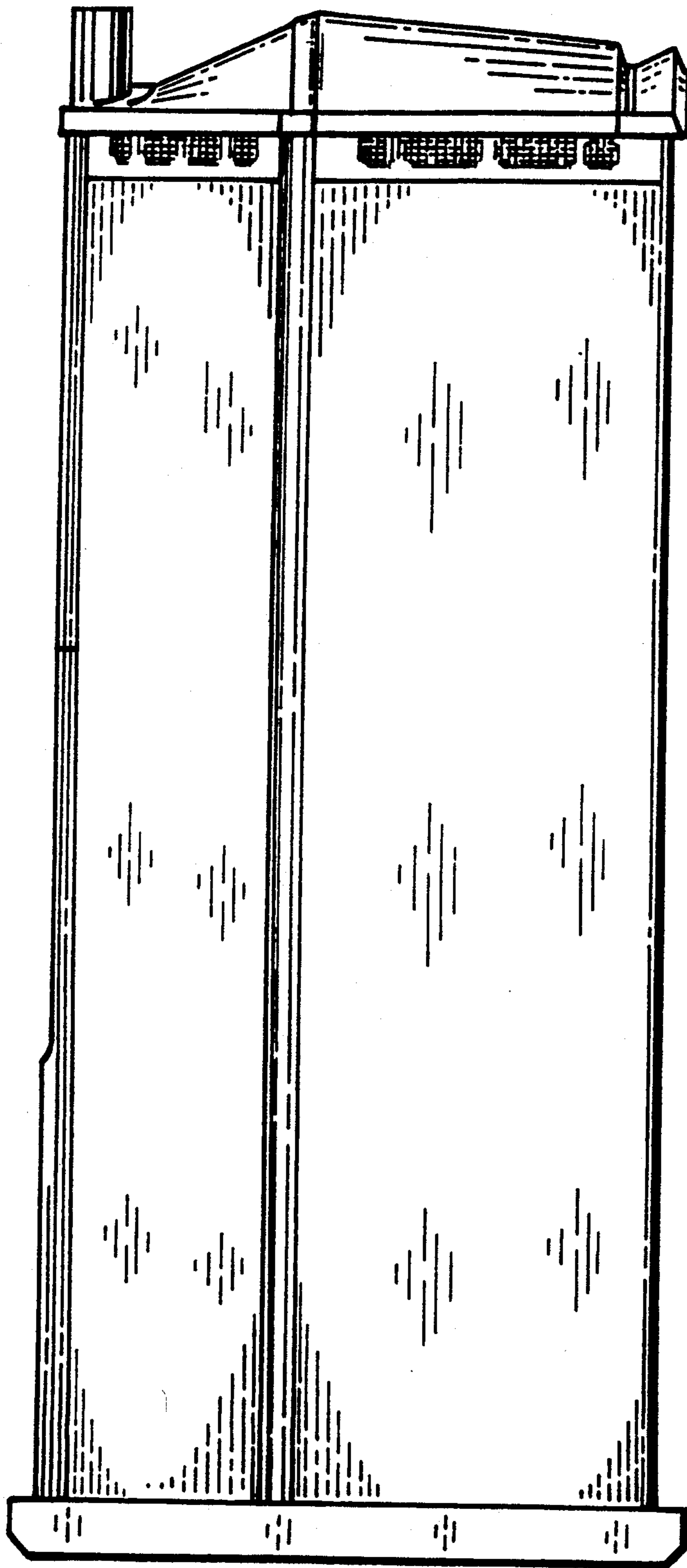

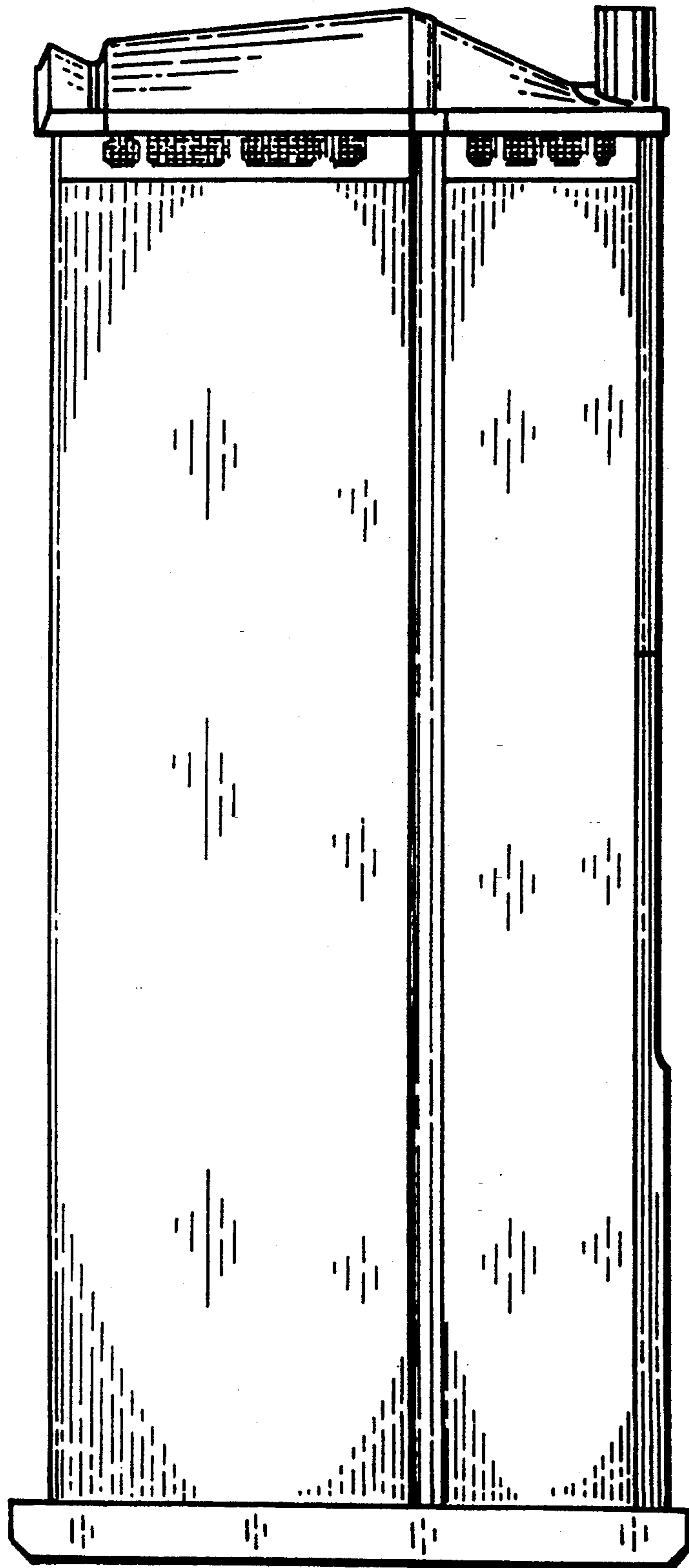

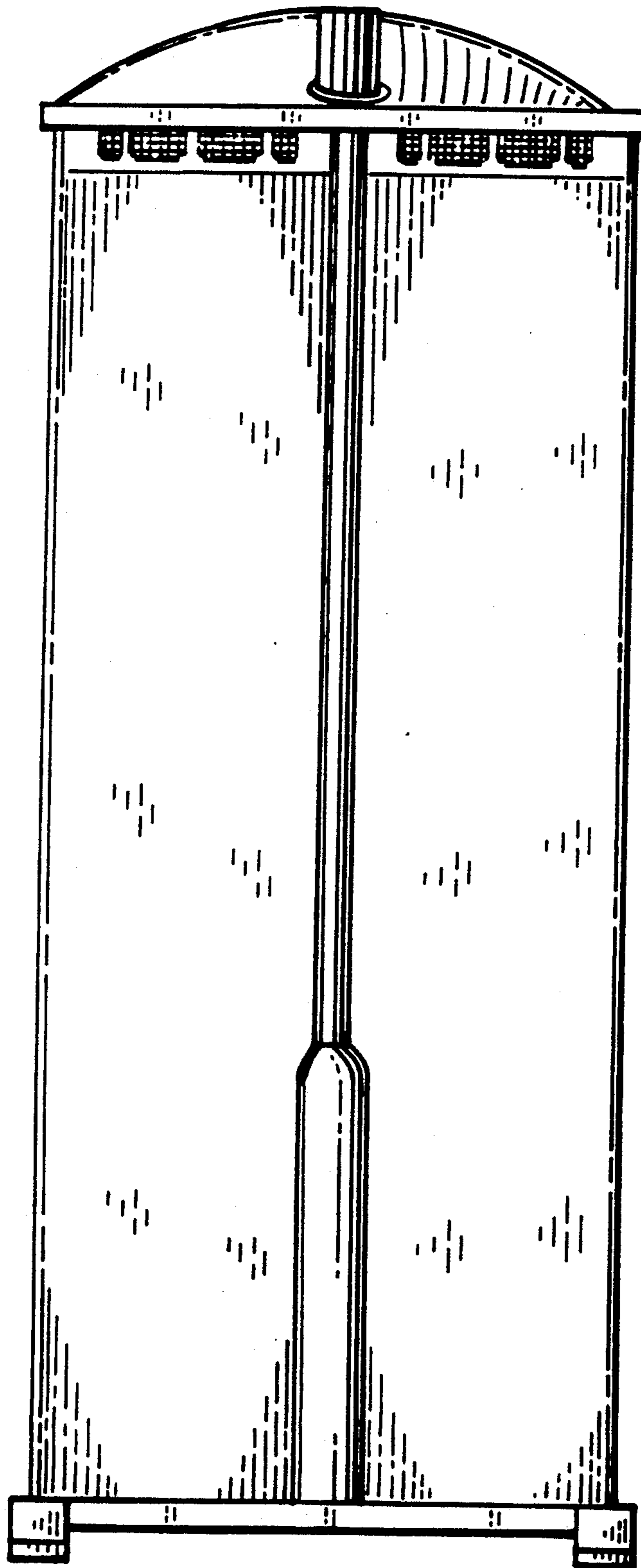

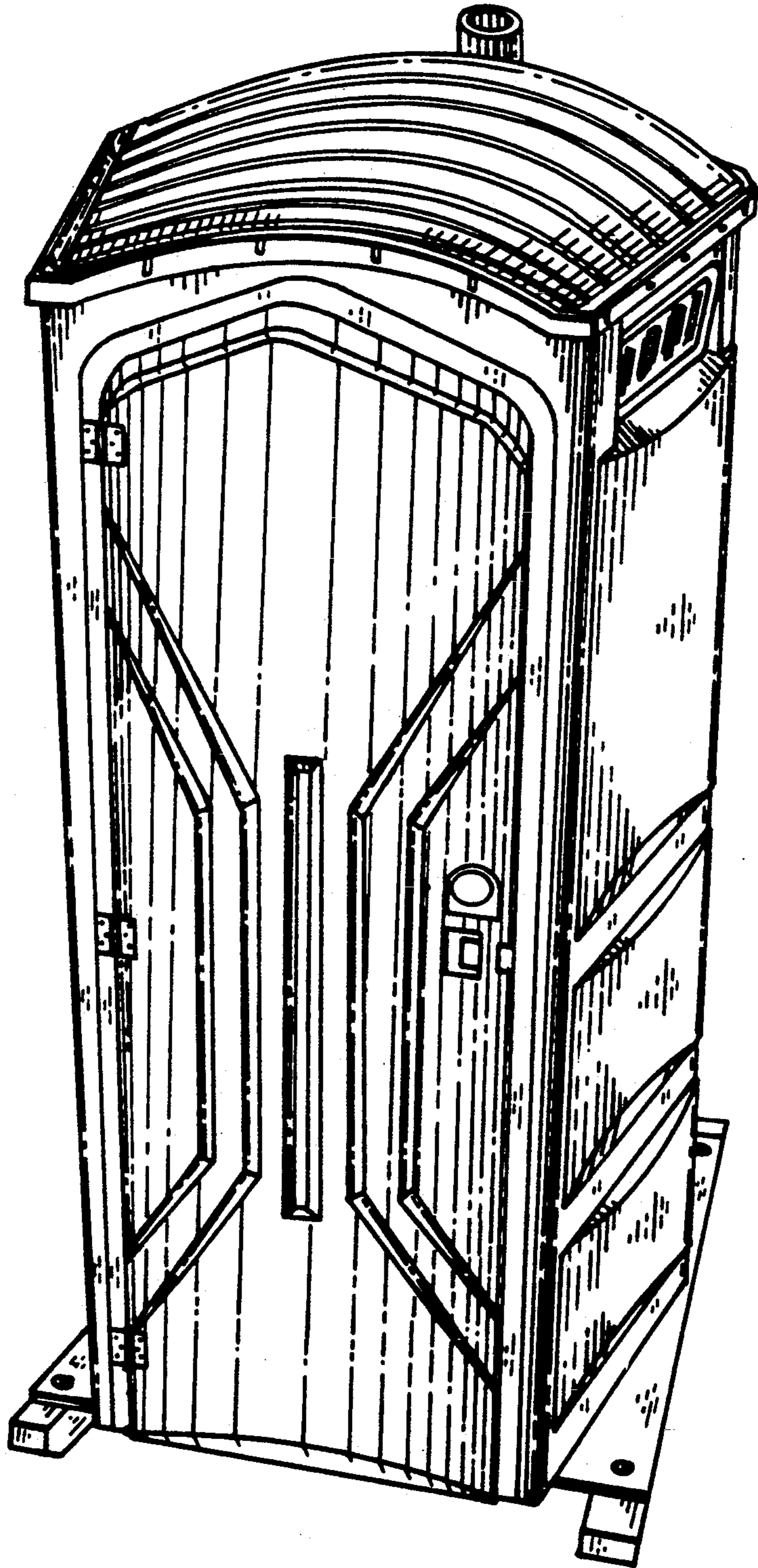

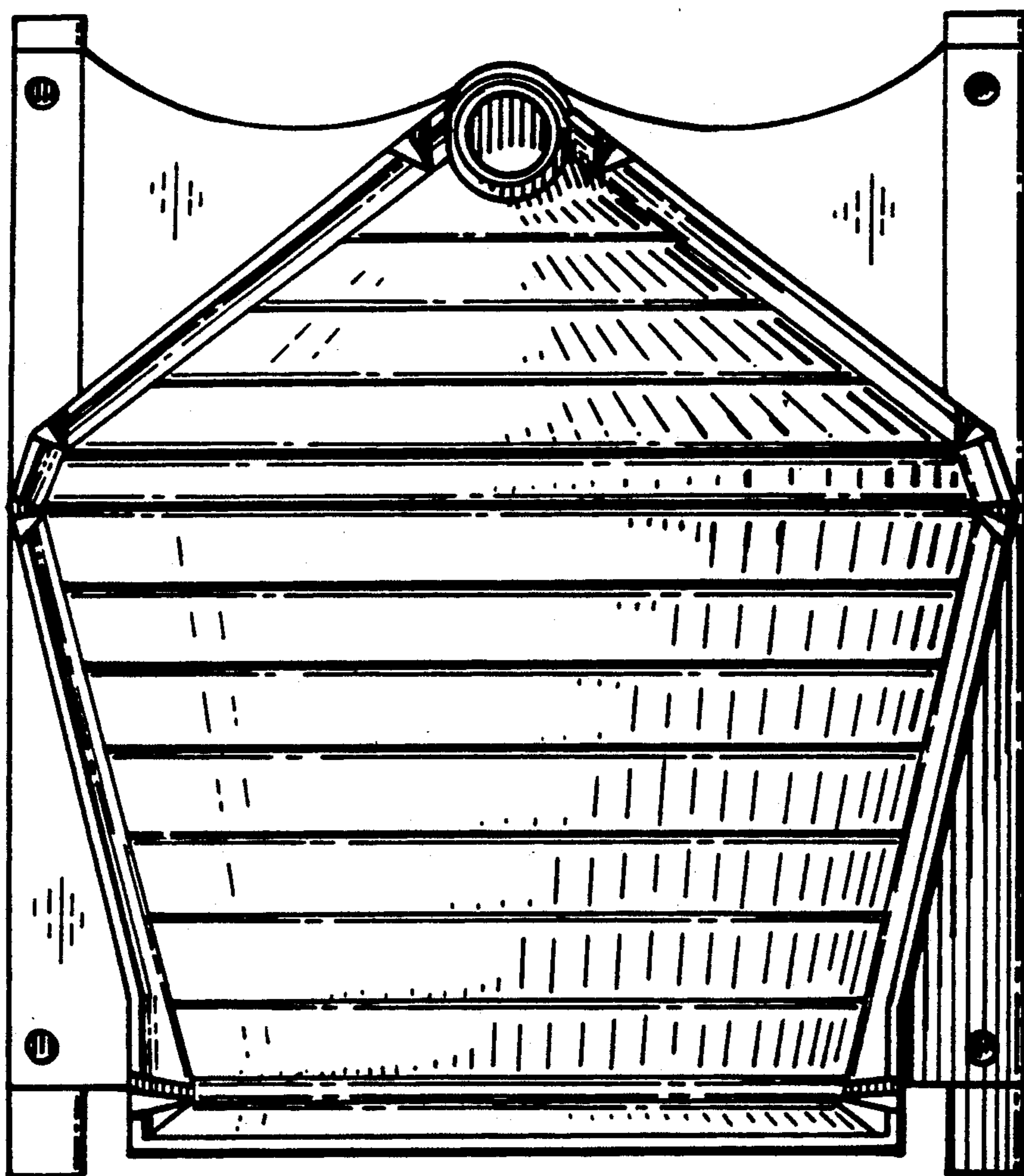

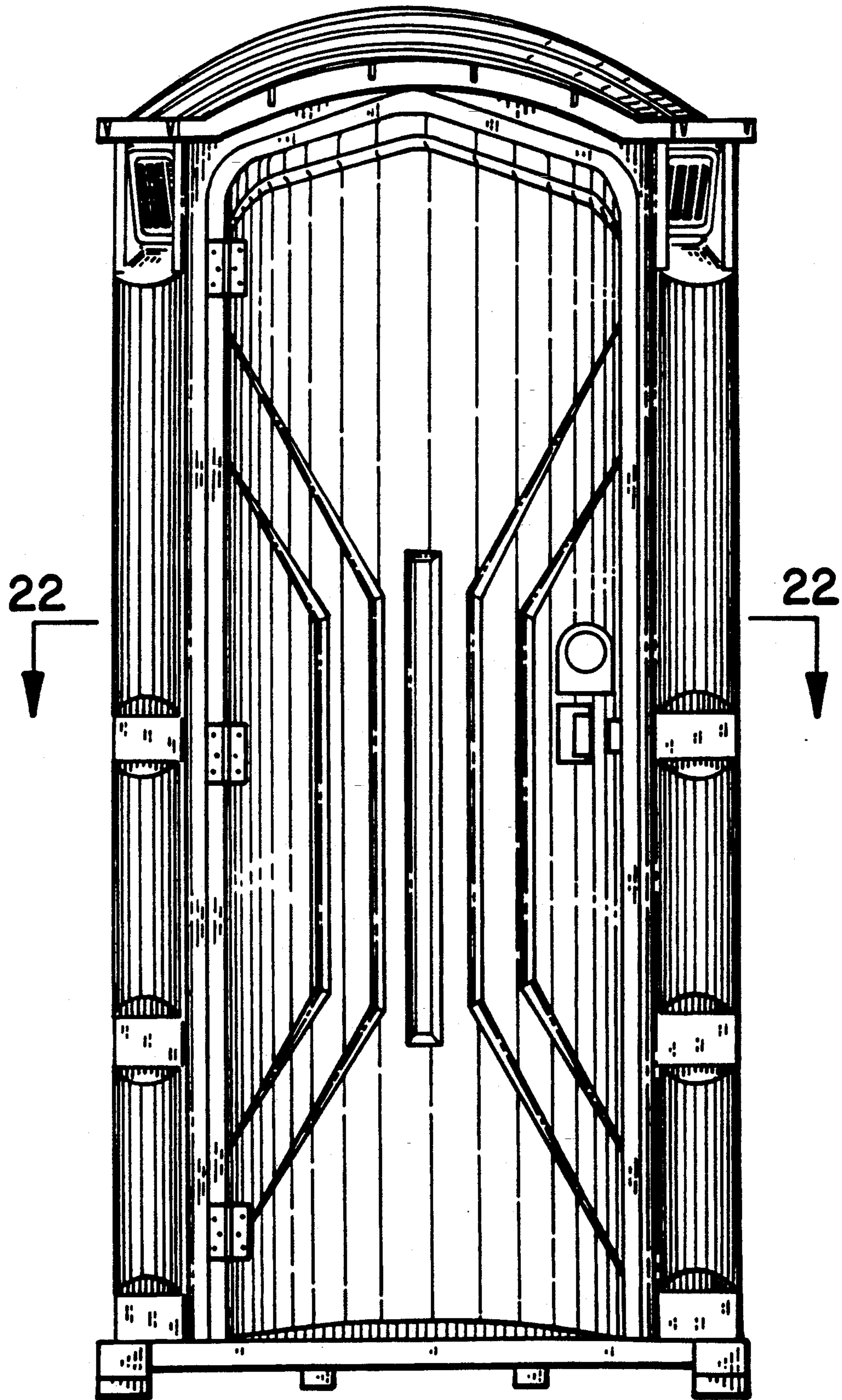

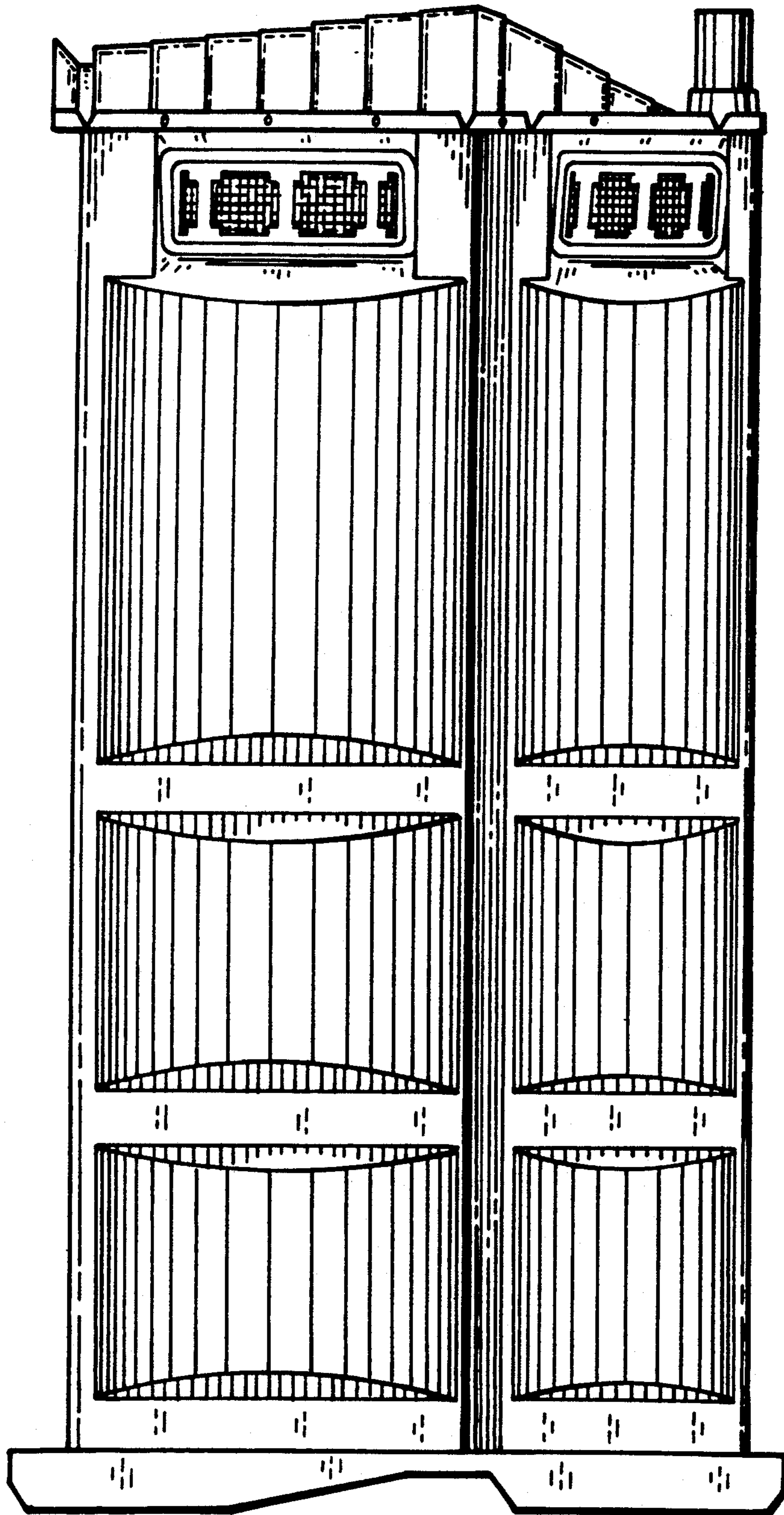

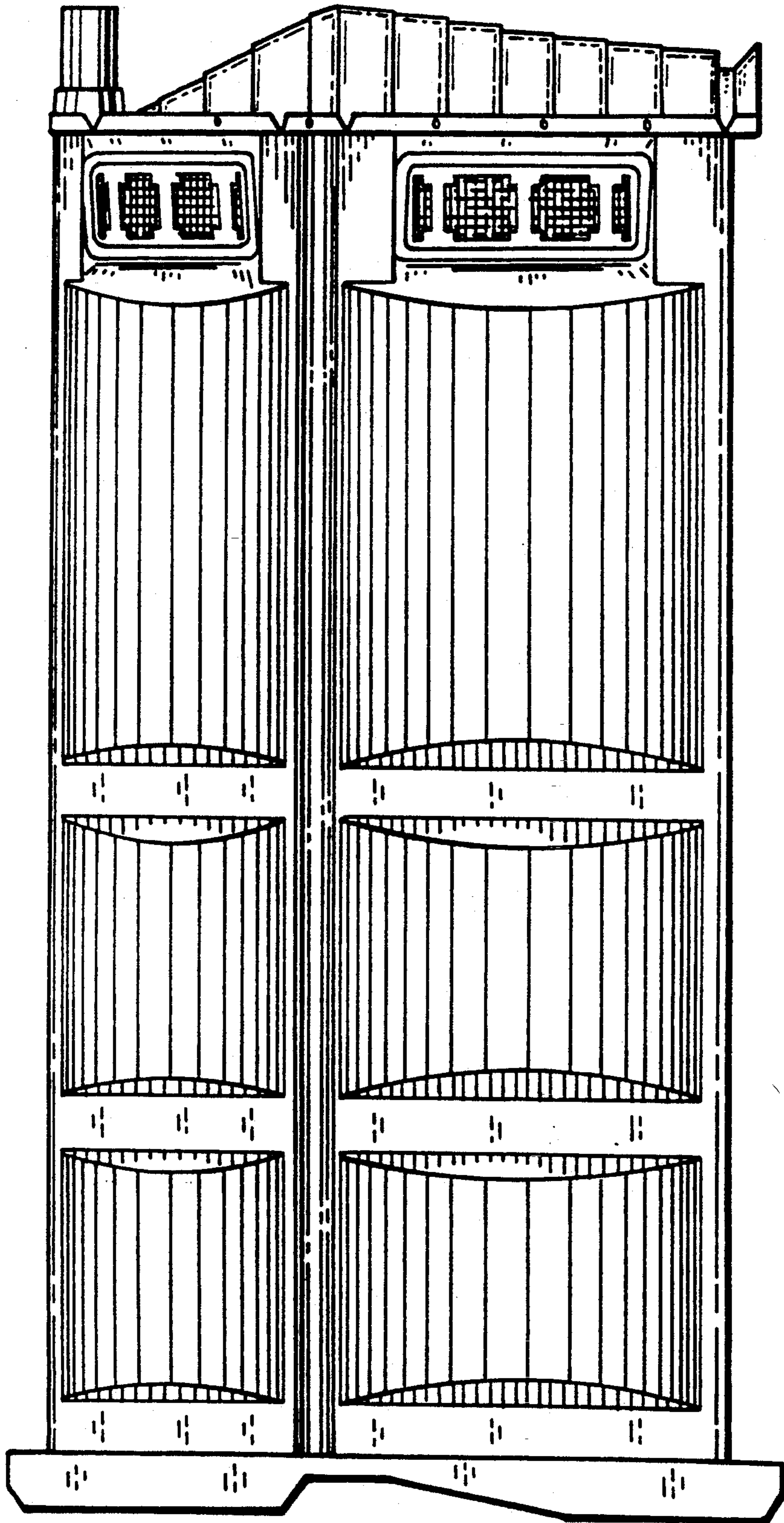

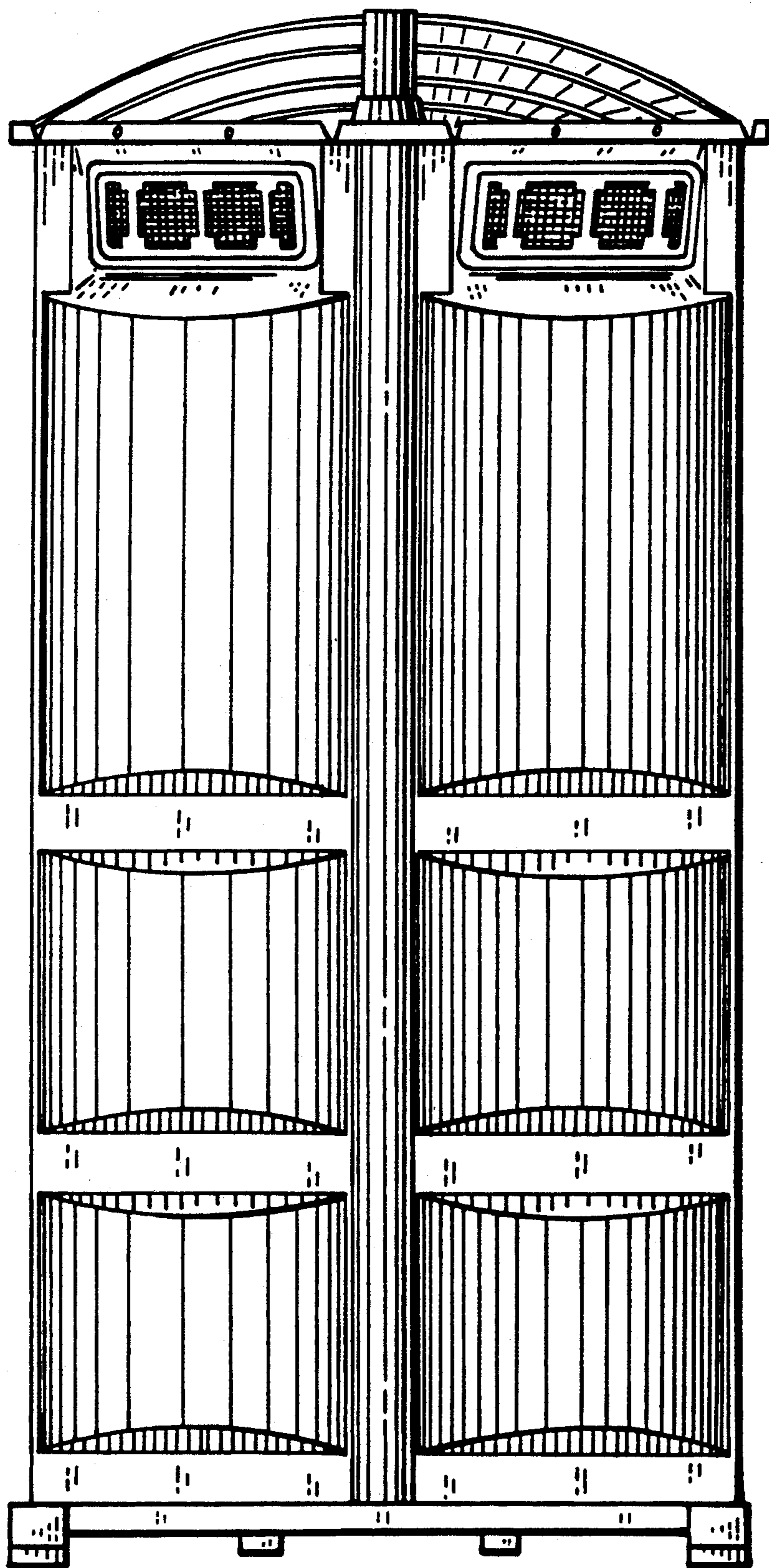

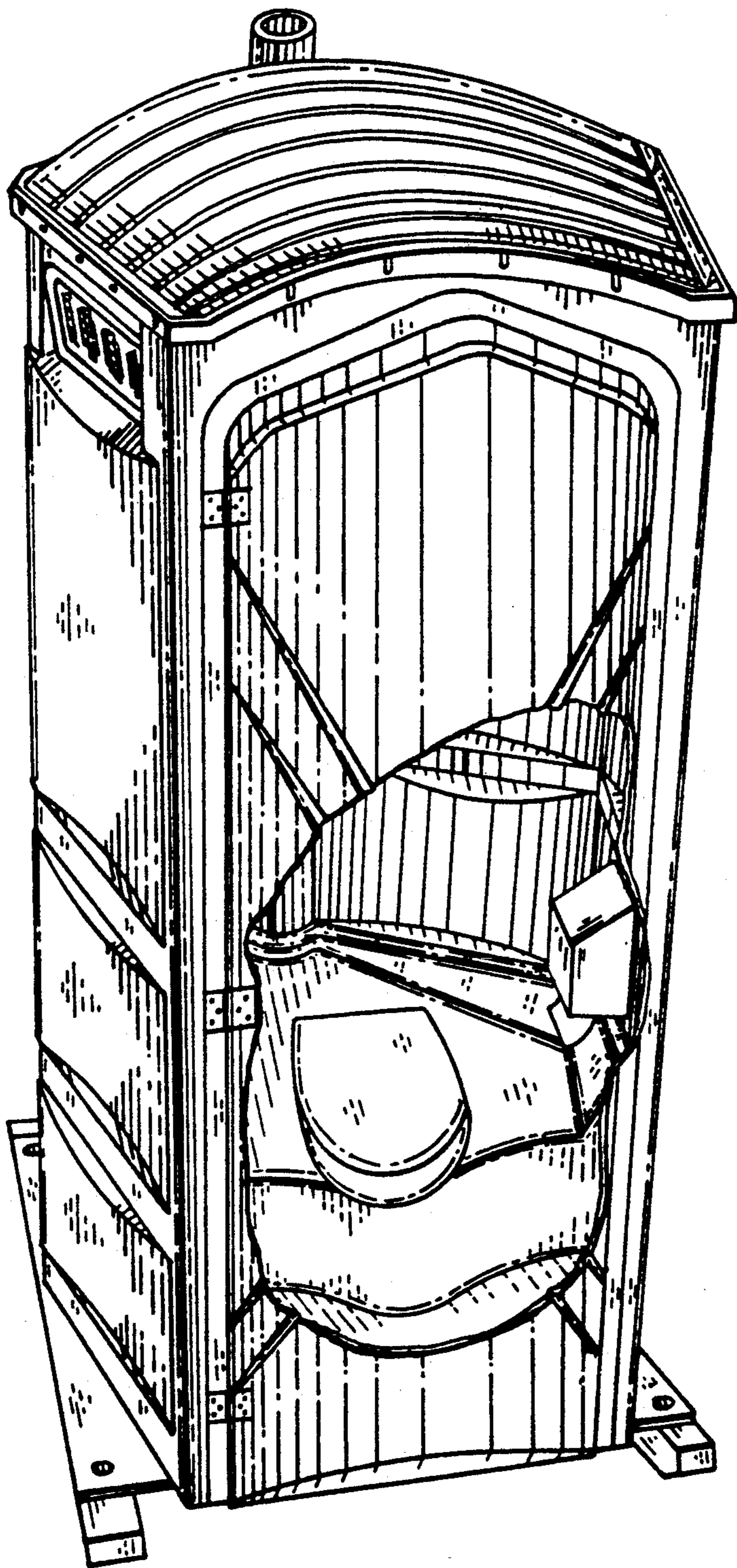

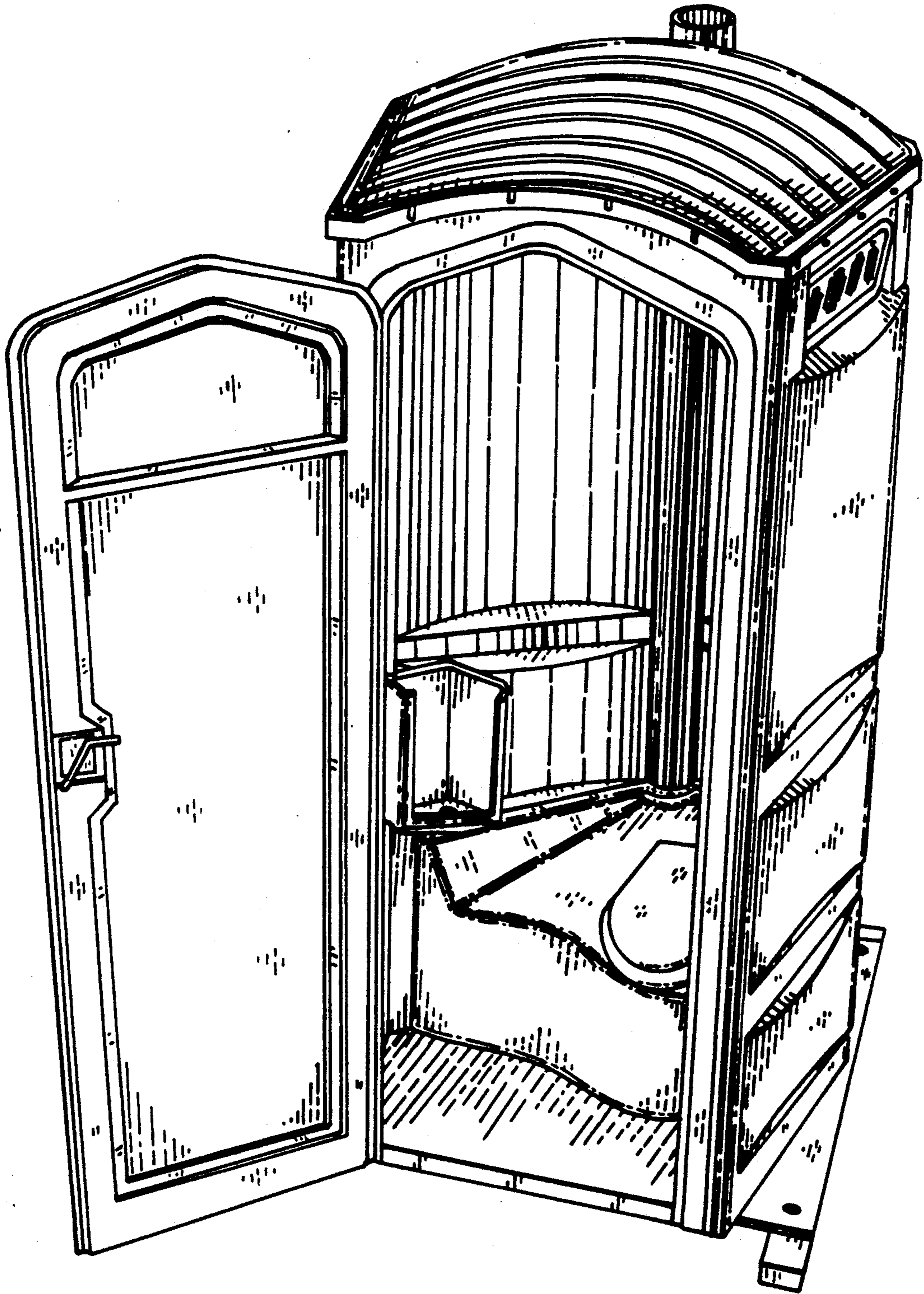

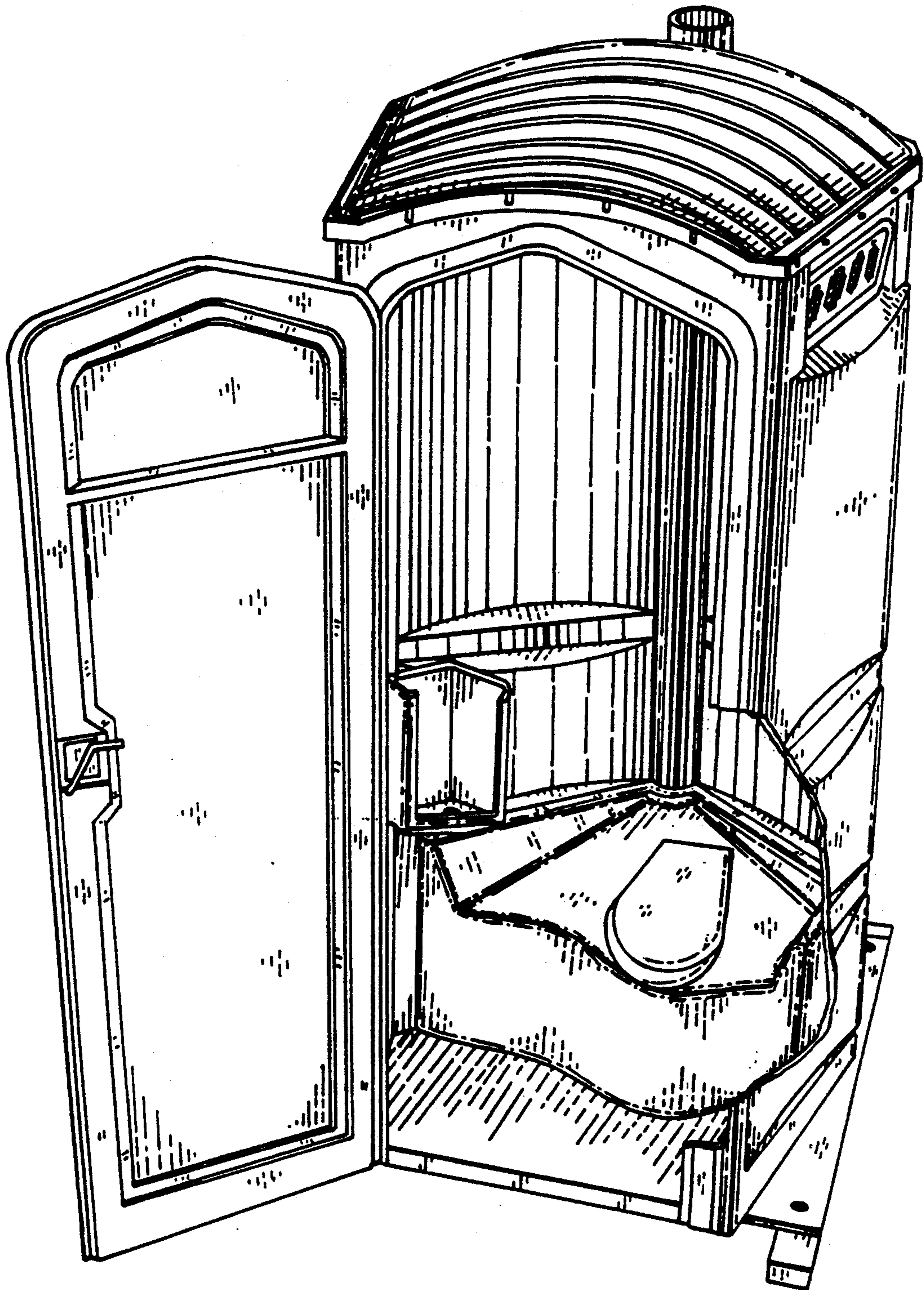

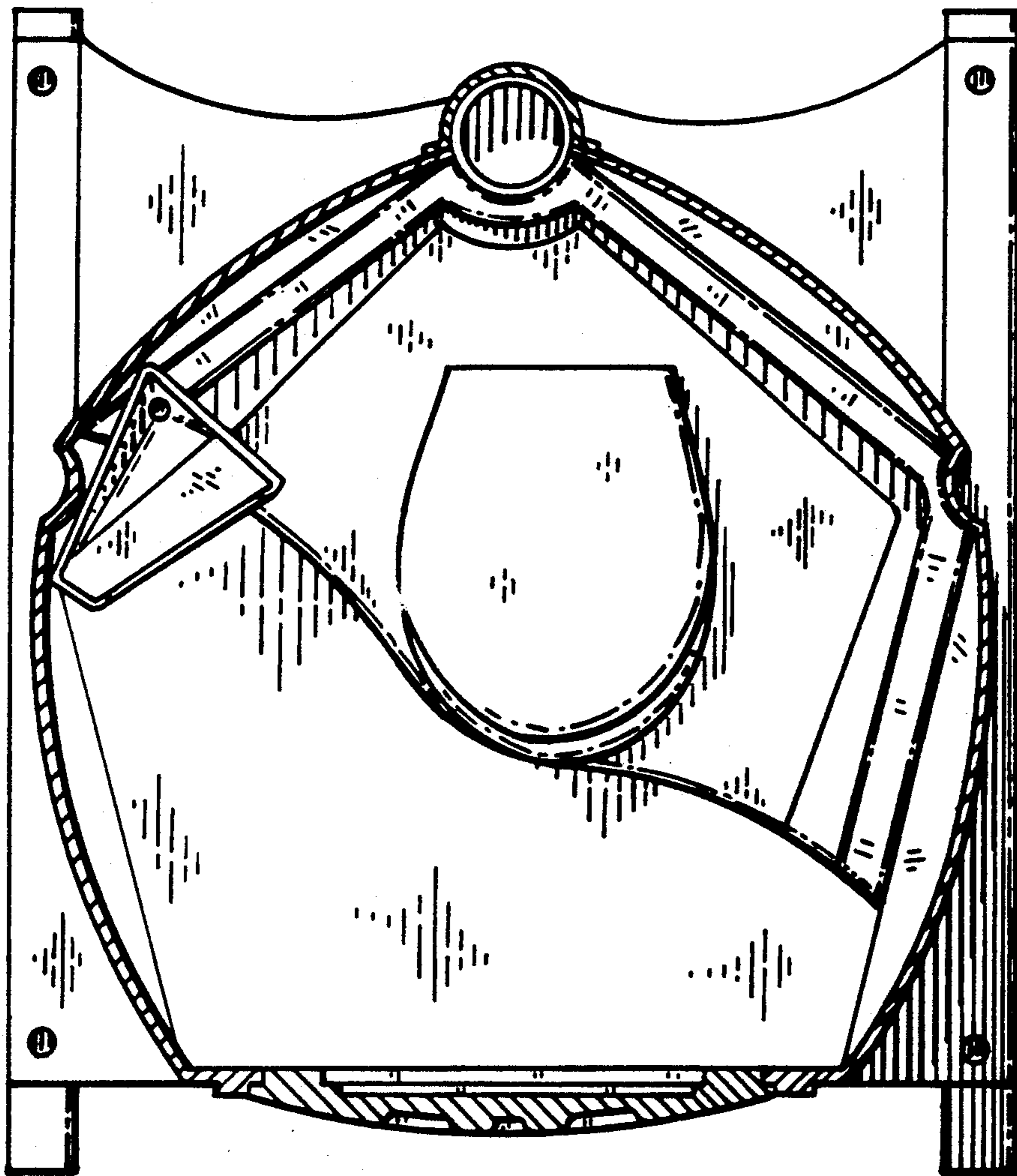
