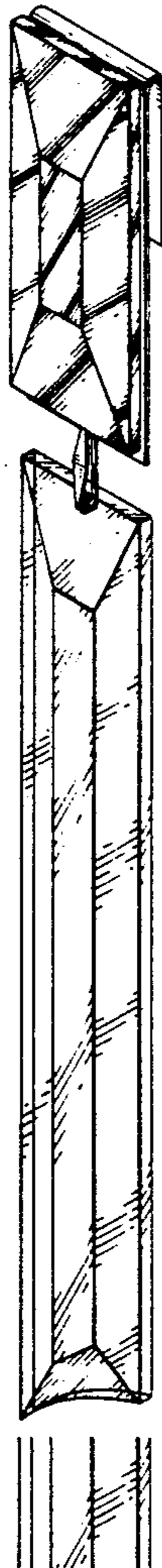

[57] **CLAIM**

The ornamental design for a panel for a lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a panel for a lighting fixture showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a side elevational view thereof; and,
FIG. 7 is an opposite side elevational view thereof.



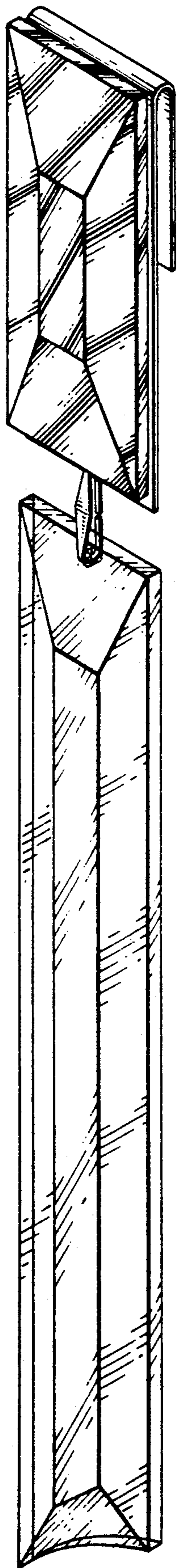

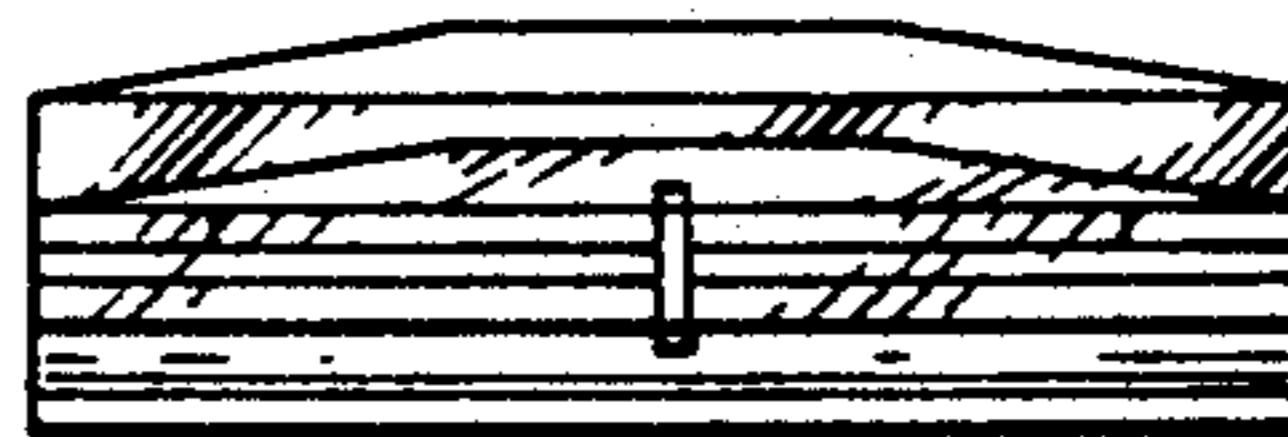

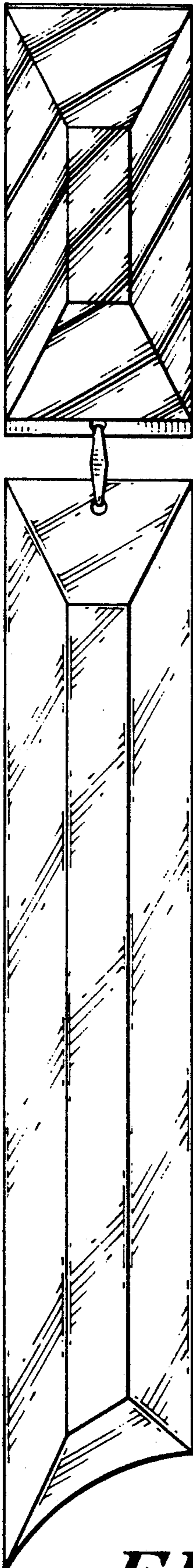

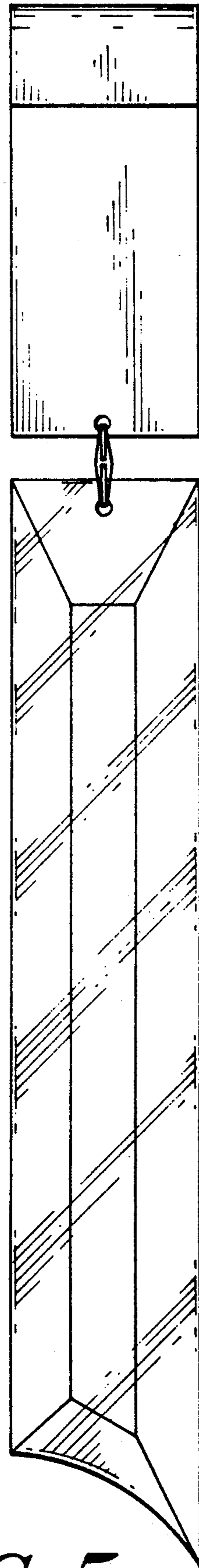

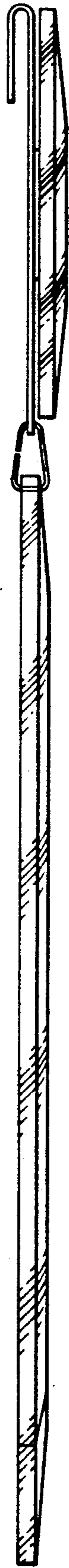
