The ornamental design for an anti flea coat for dogs, as shown and described.

## DESCRIPTION

FIG. 1 is a front elevational view of the anti flea coat for dogs showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is another front elevational view thereof, the broken lines are for purposes of illustration only and form no part of the claim design.

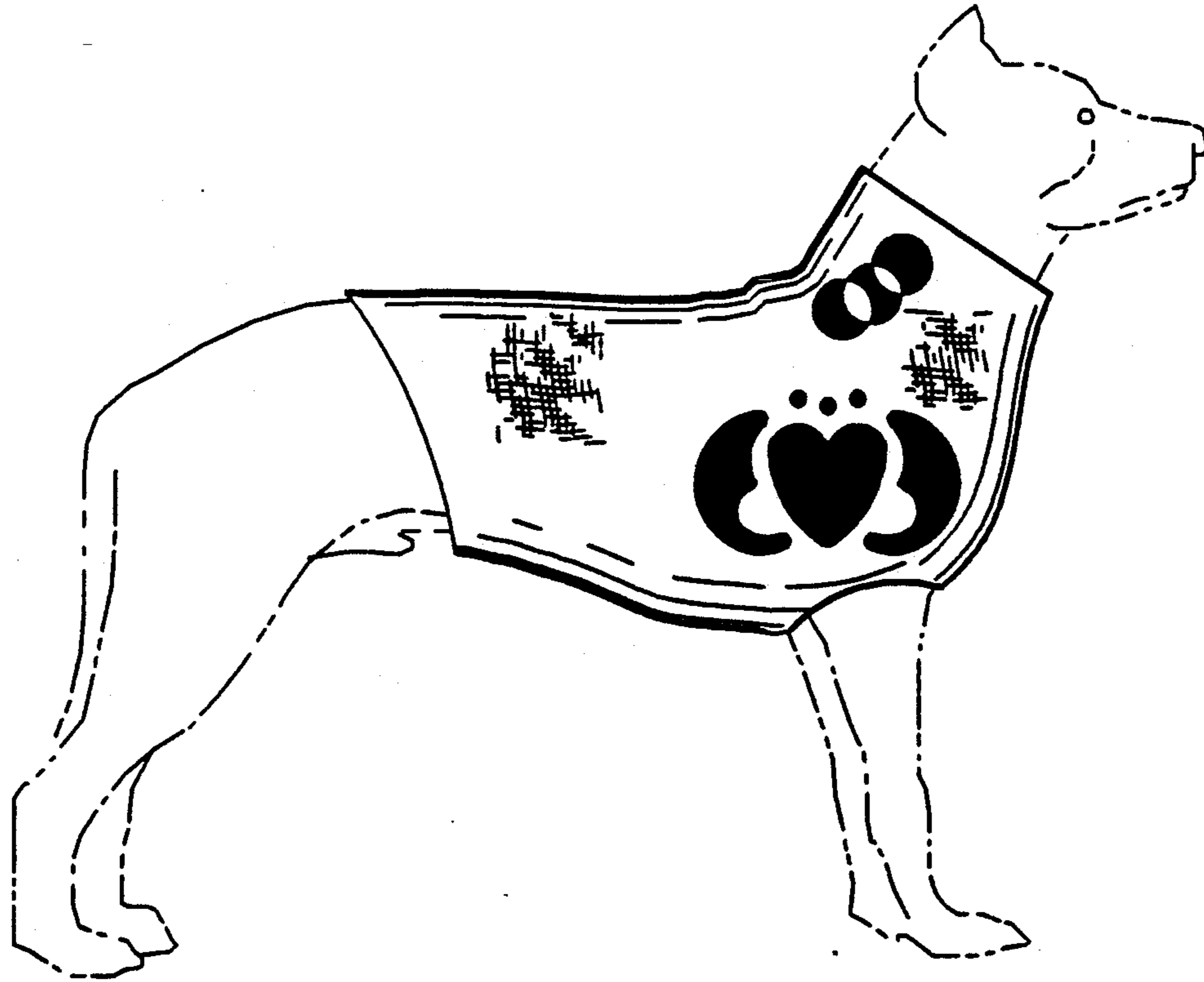

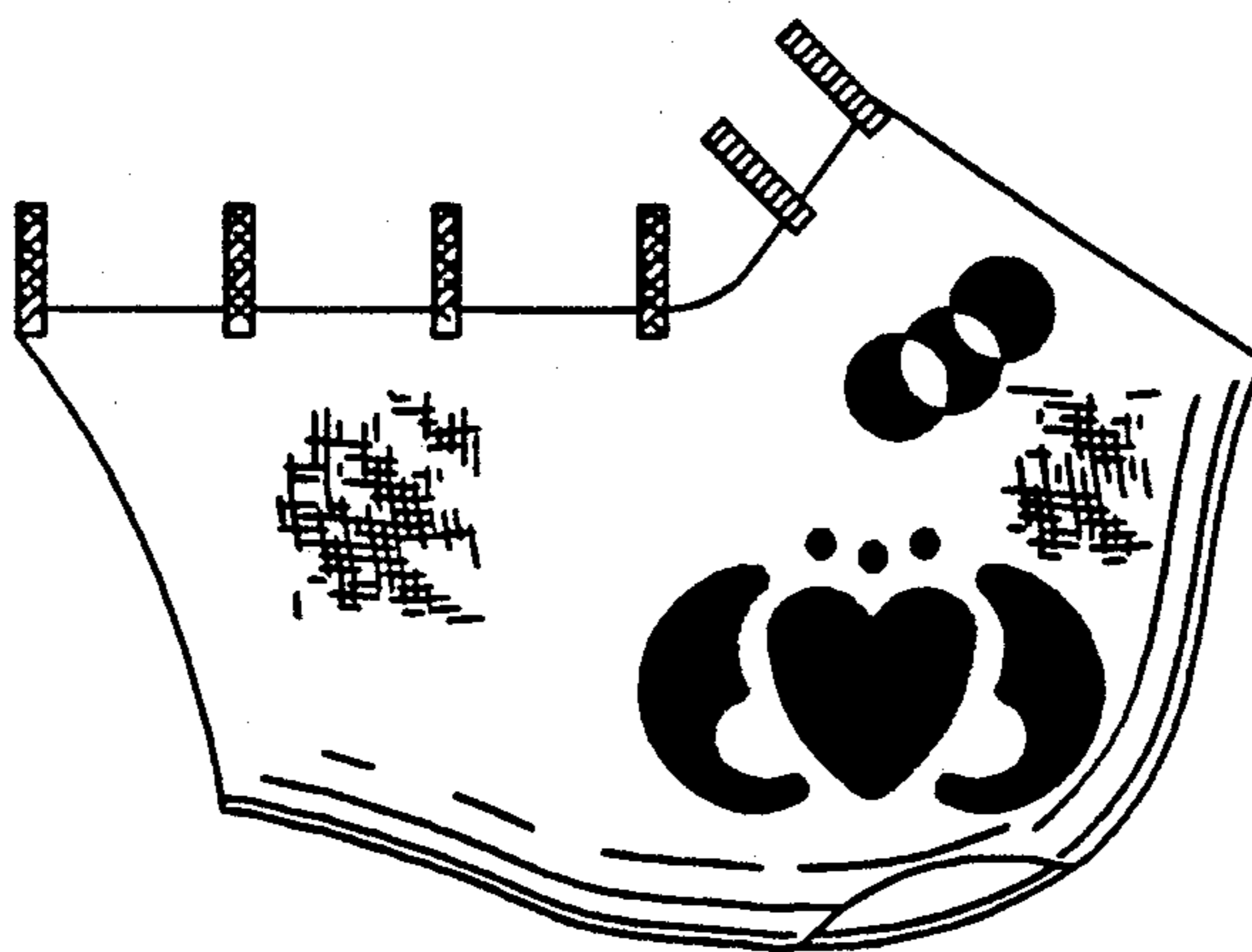

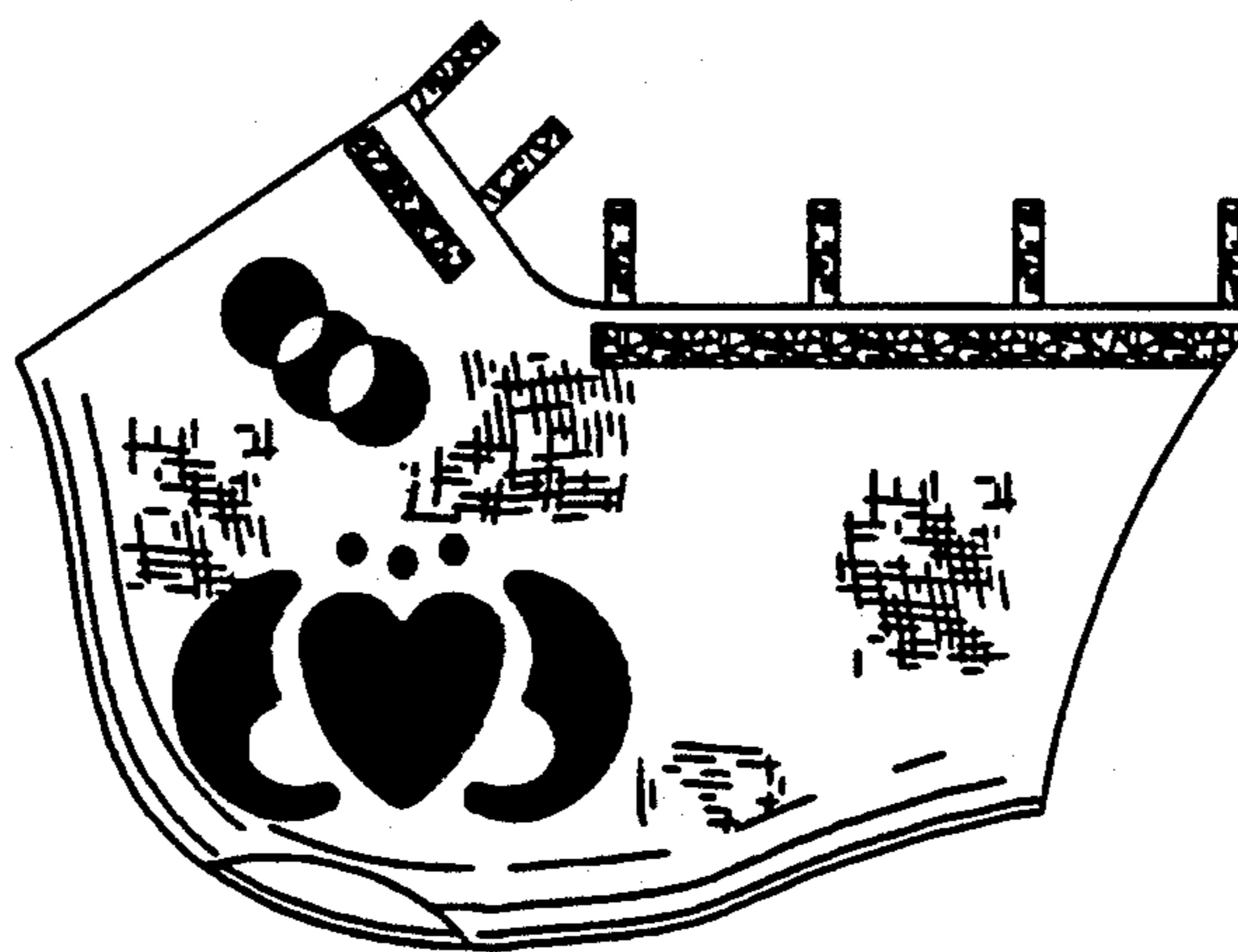

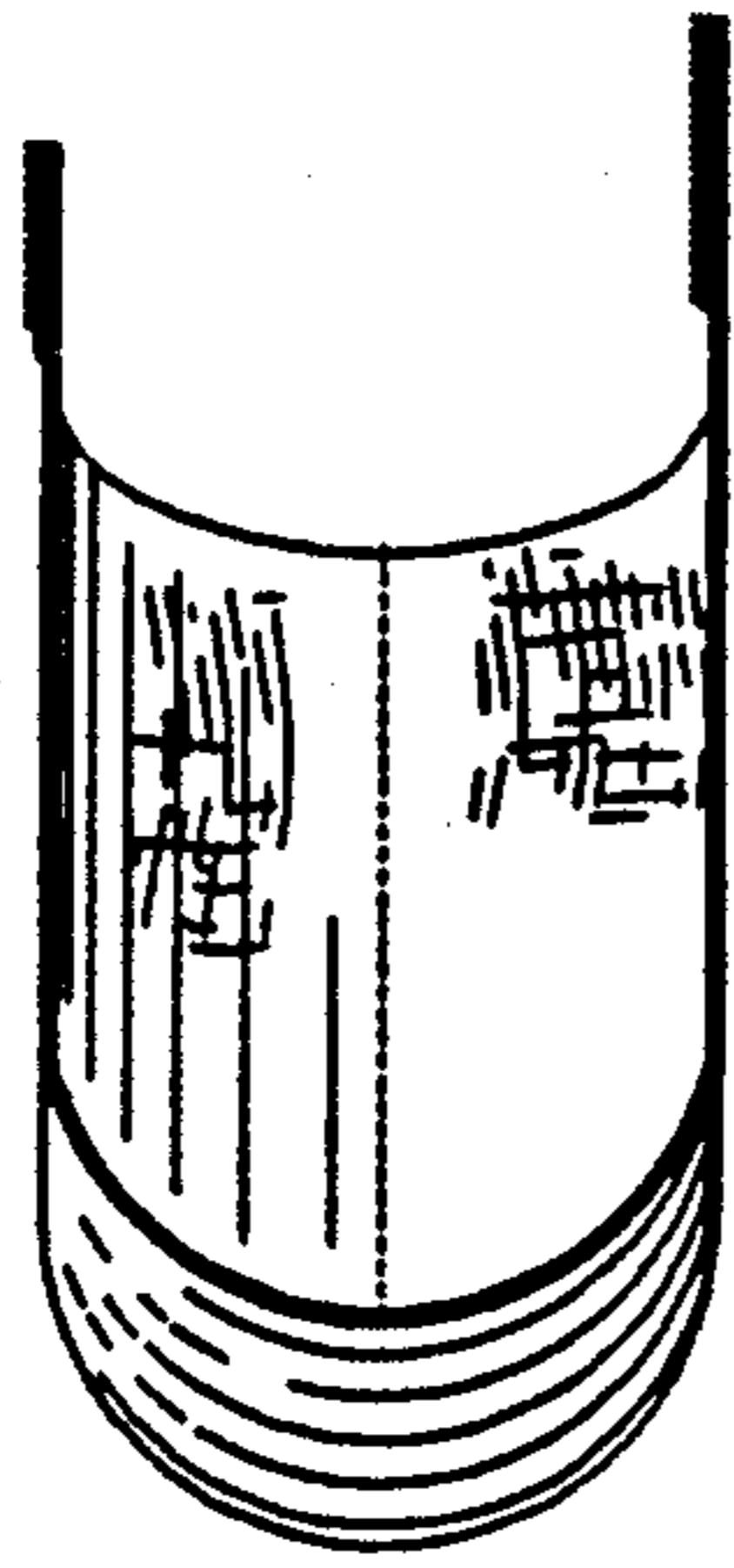

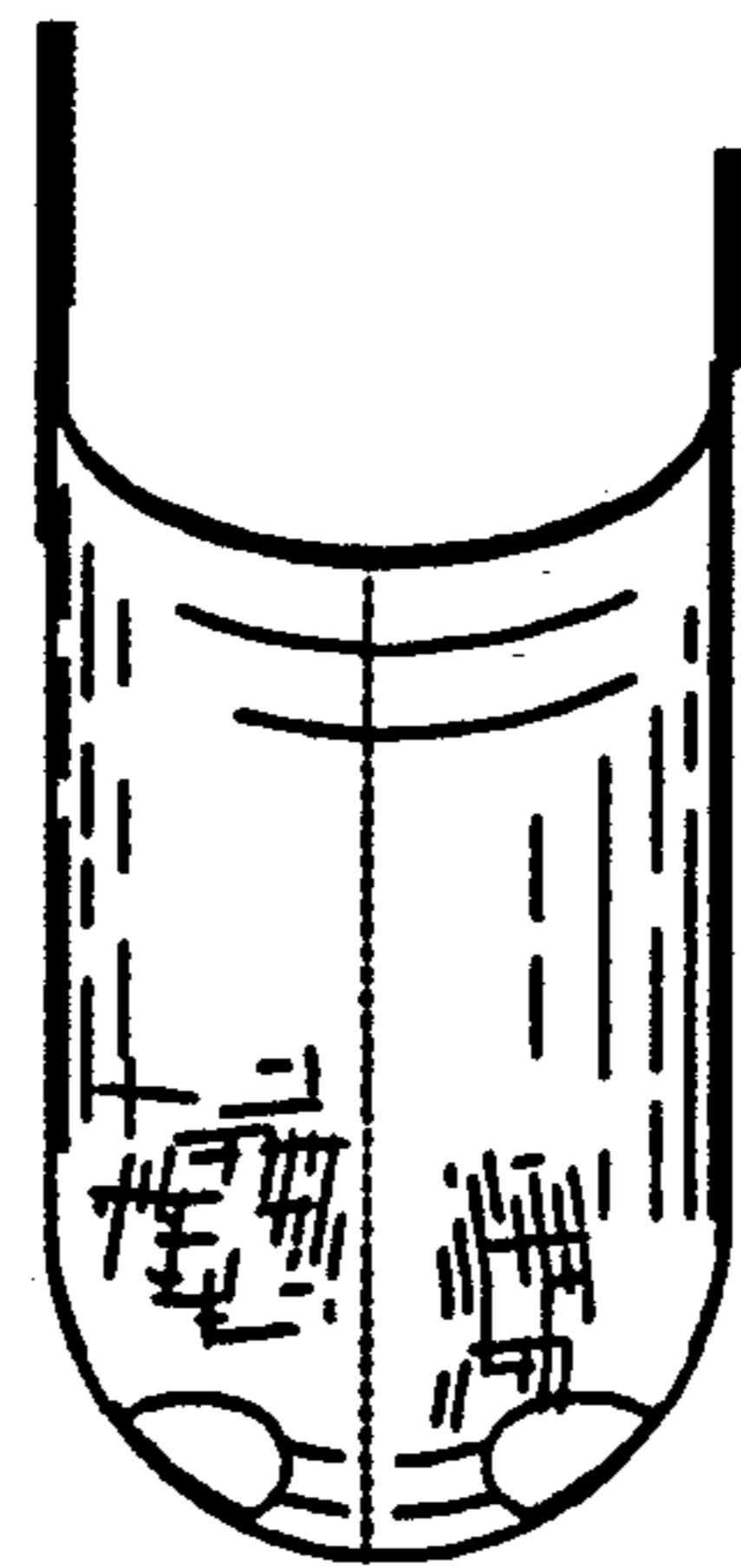

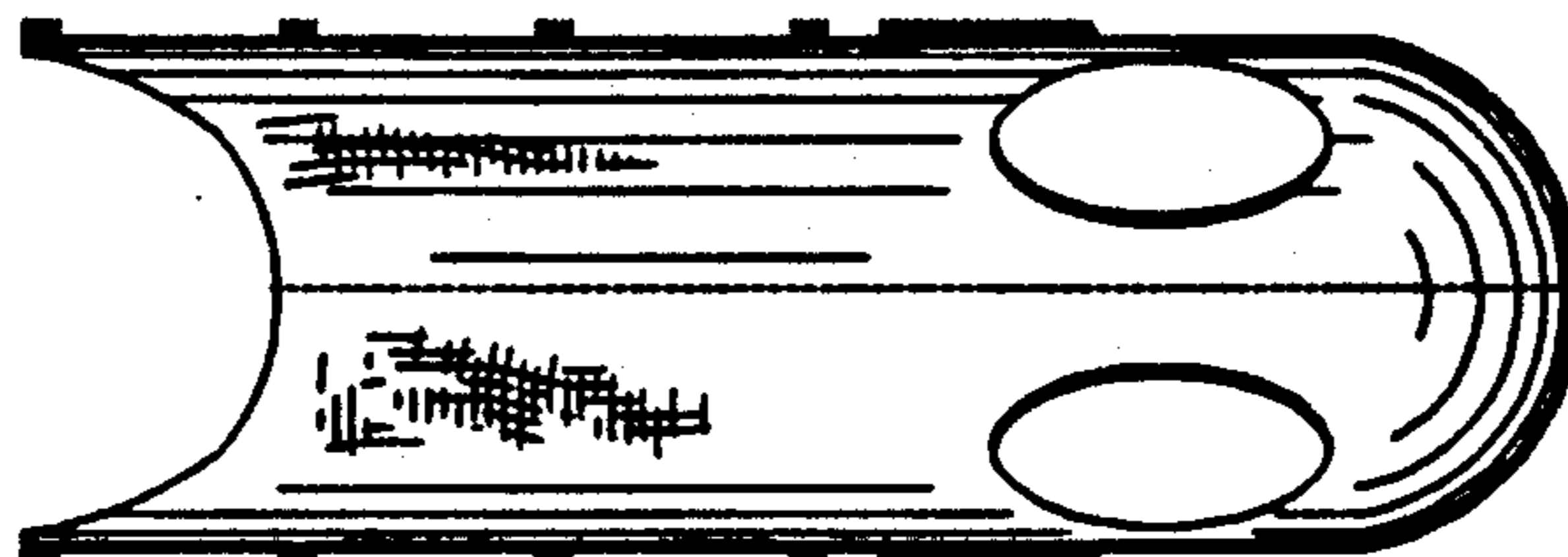

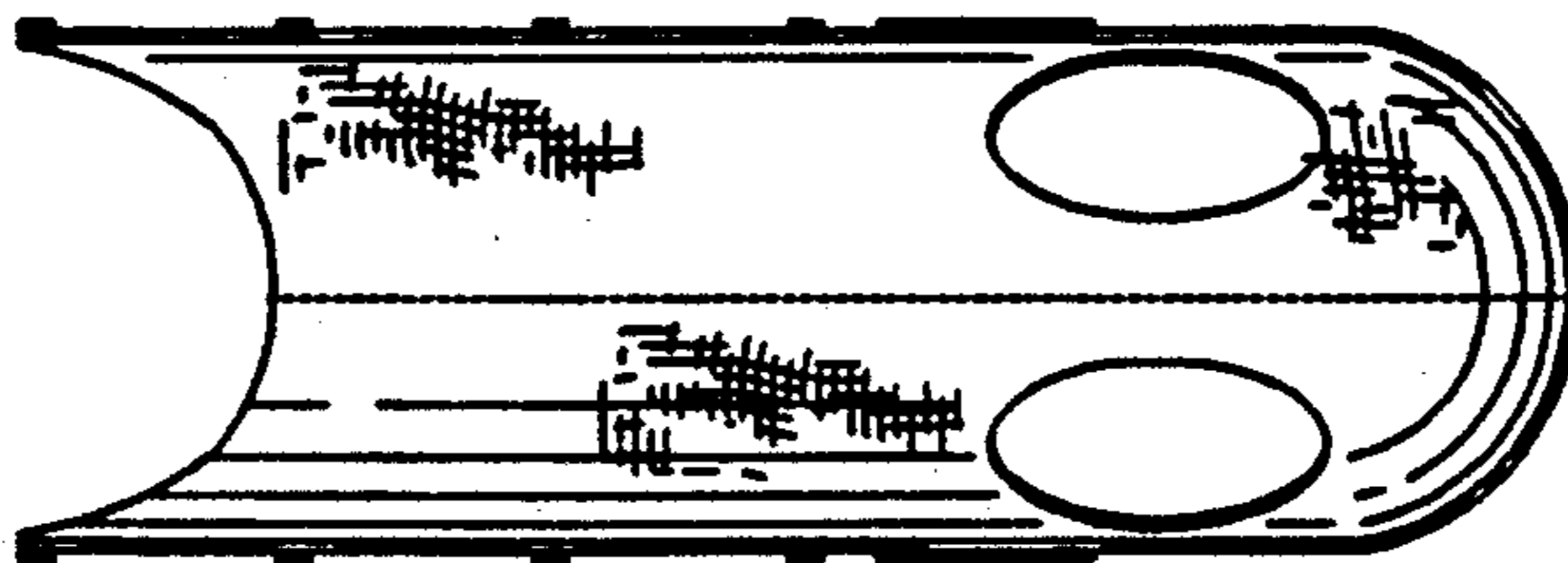
