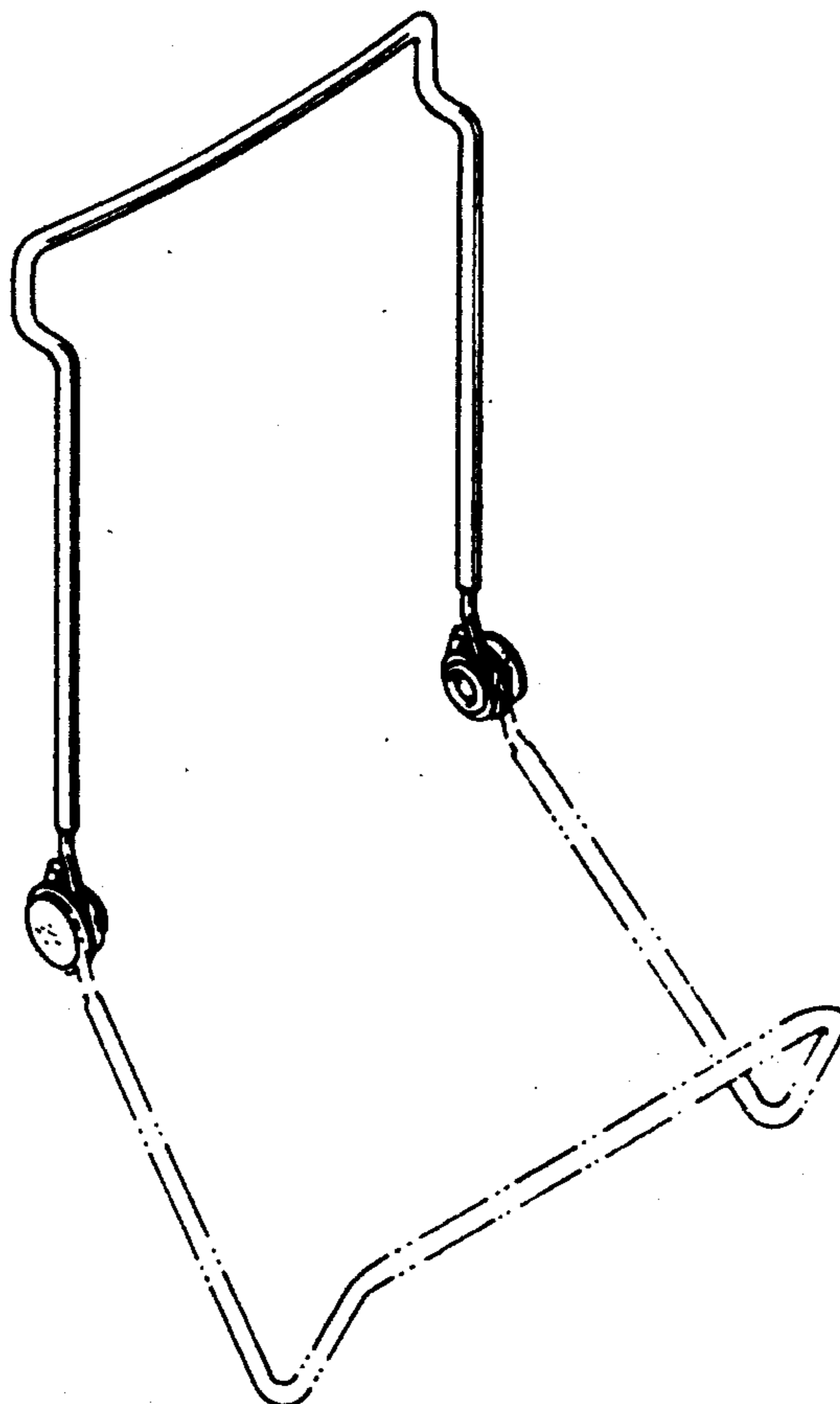

[57] CLAIM

The ornamental design for a portion of a slatwall holder for plates, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of the portion of a slatwall holder for plates of the invention;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a left side elevation view thereof with the right side being a mirror image thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom plan view thereof.
 The broken-line disclosure is for illustrative purposes only and forms no part of the claimed design.



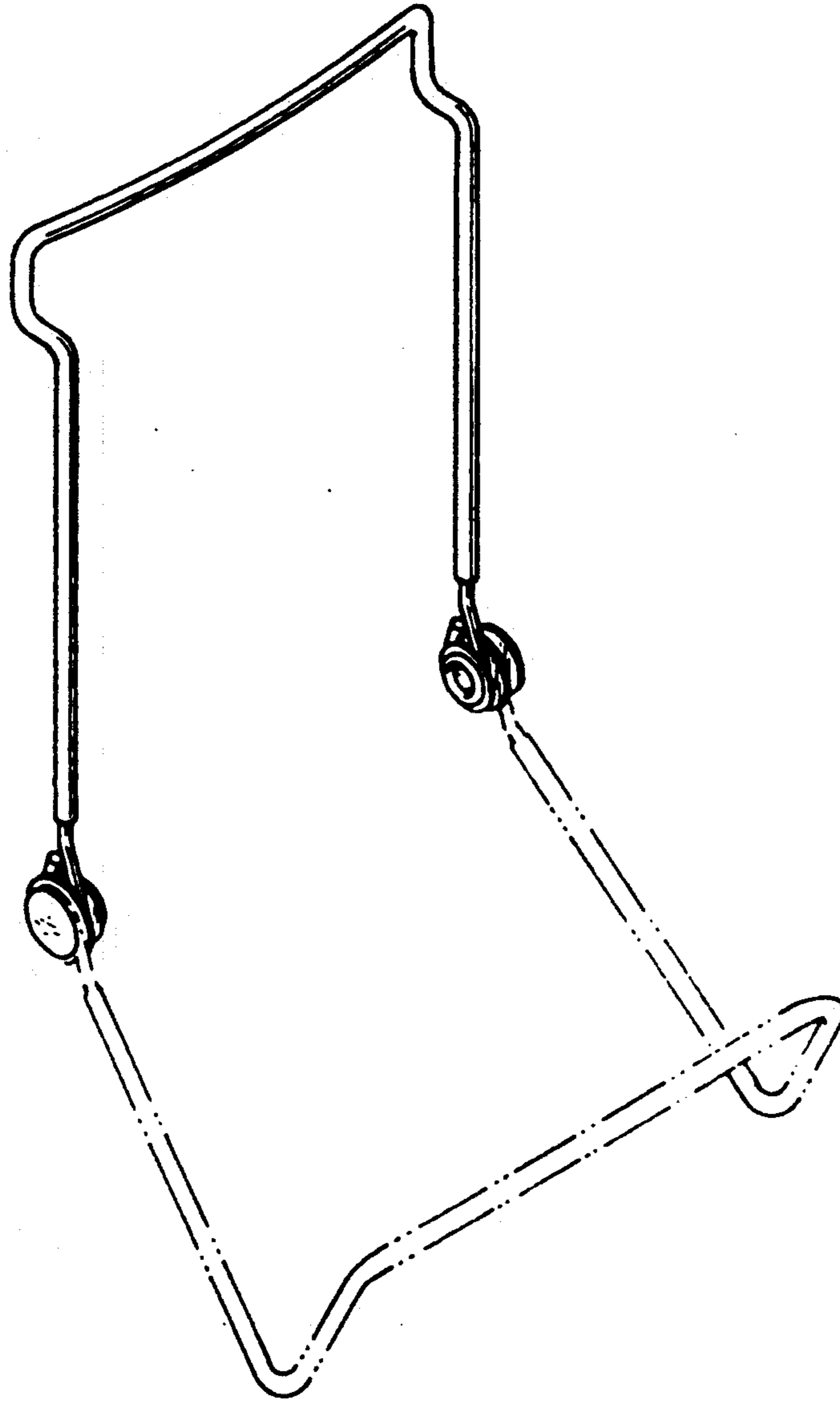

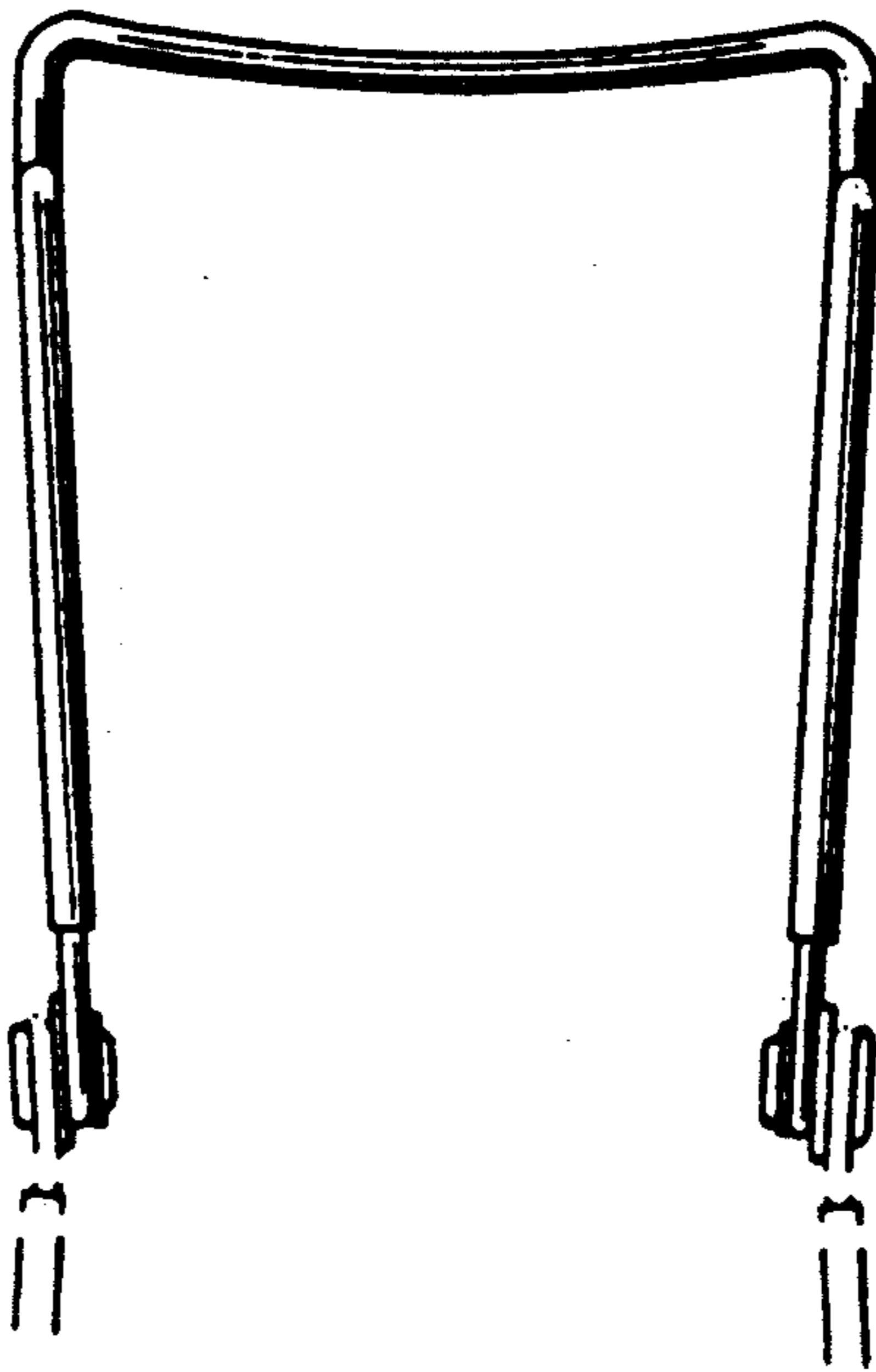

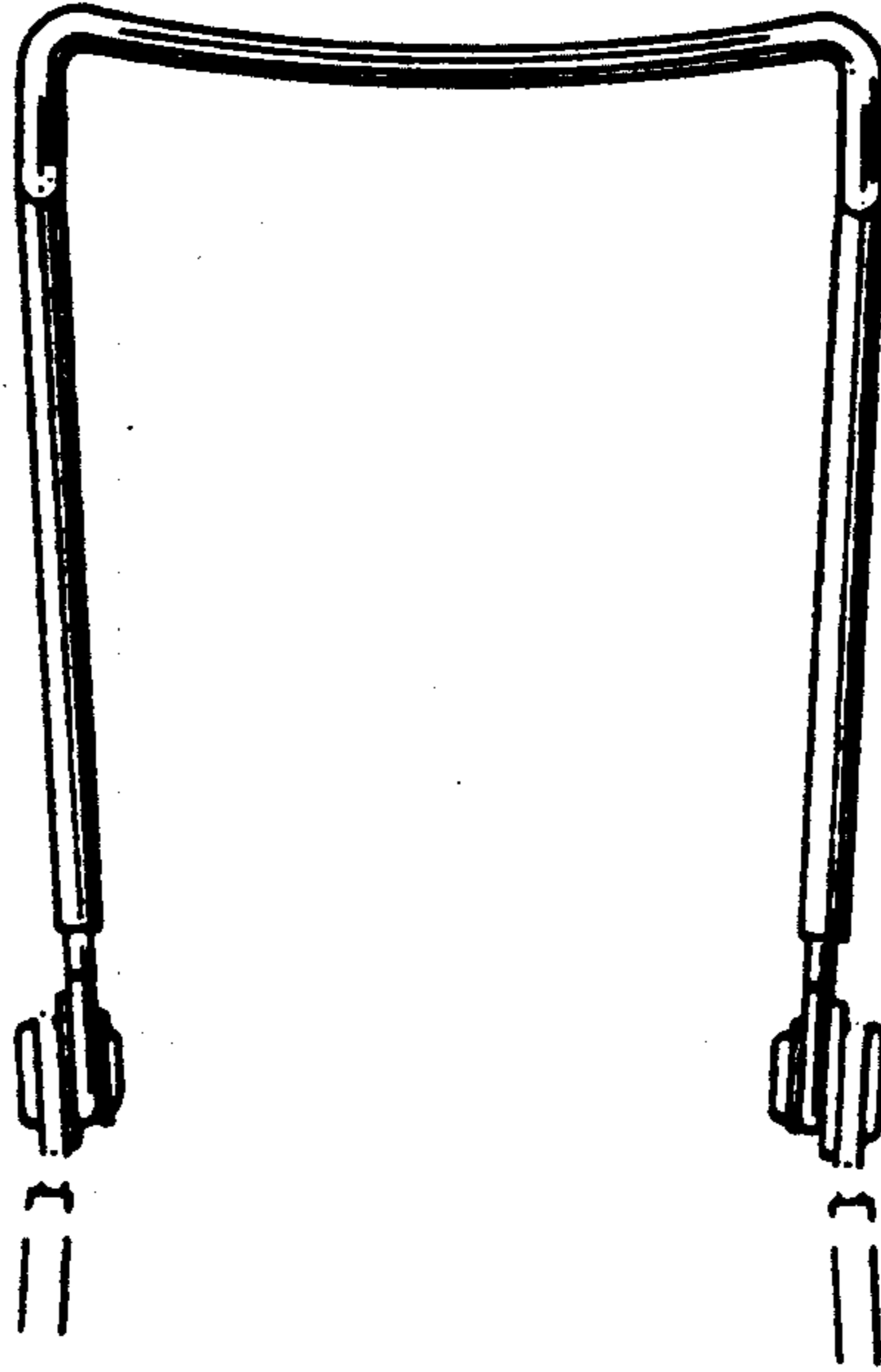

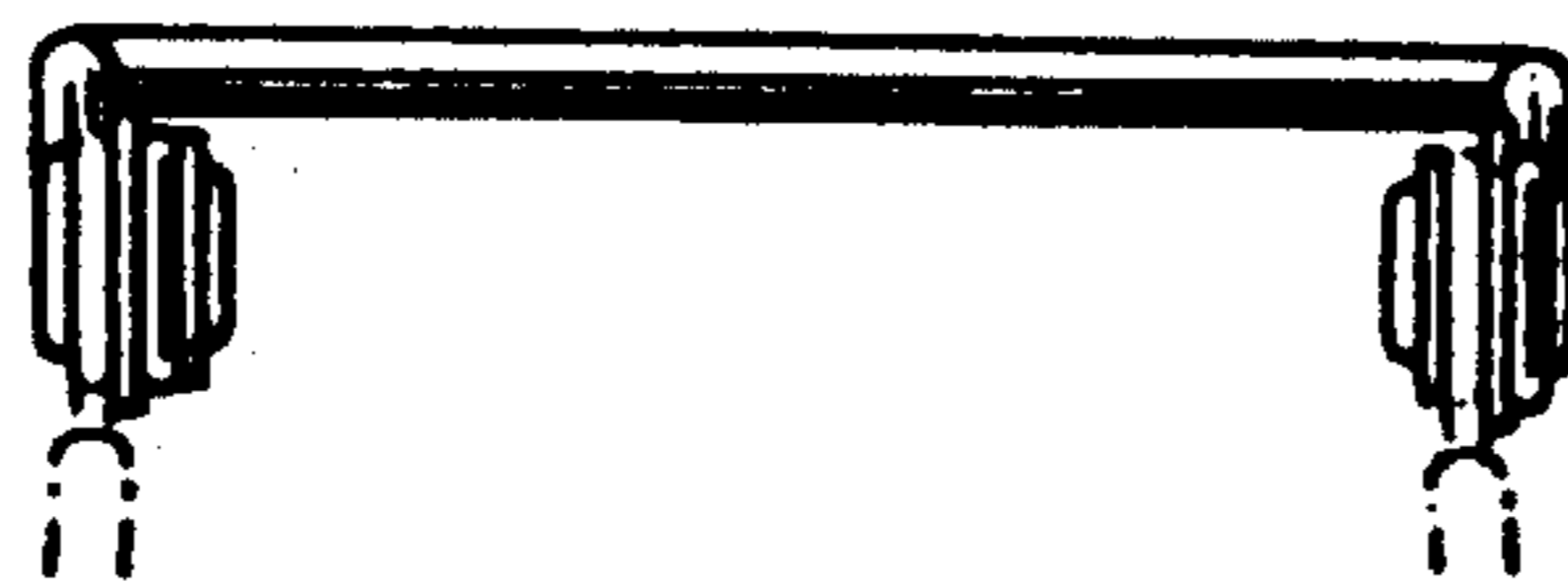
