FIG. 1 is a front view of a holder for carrying wafers showing our new design;

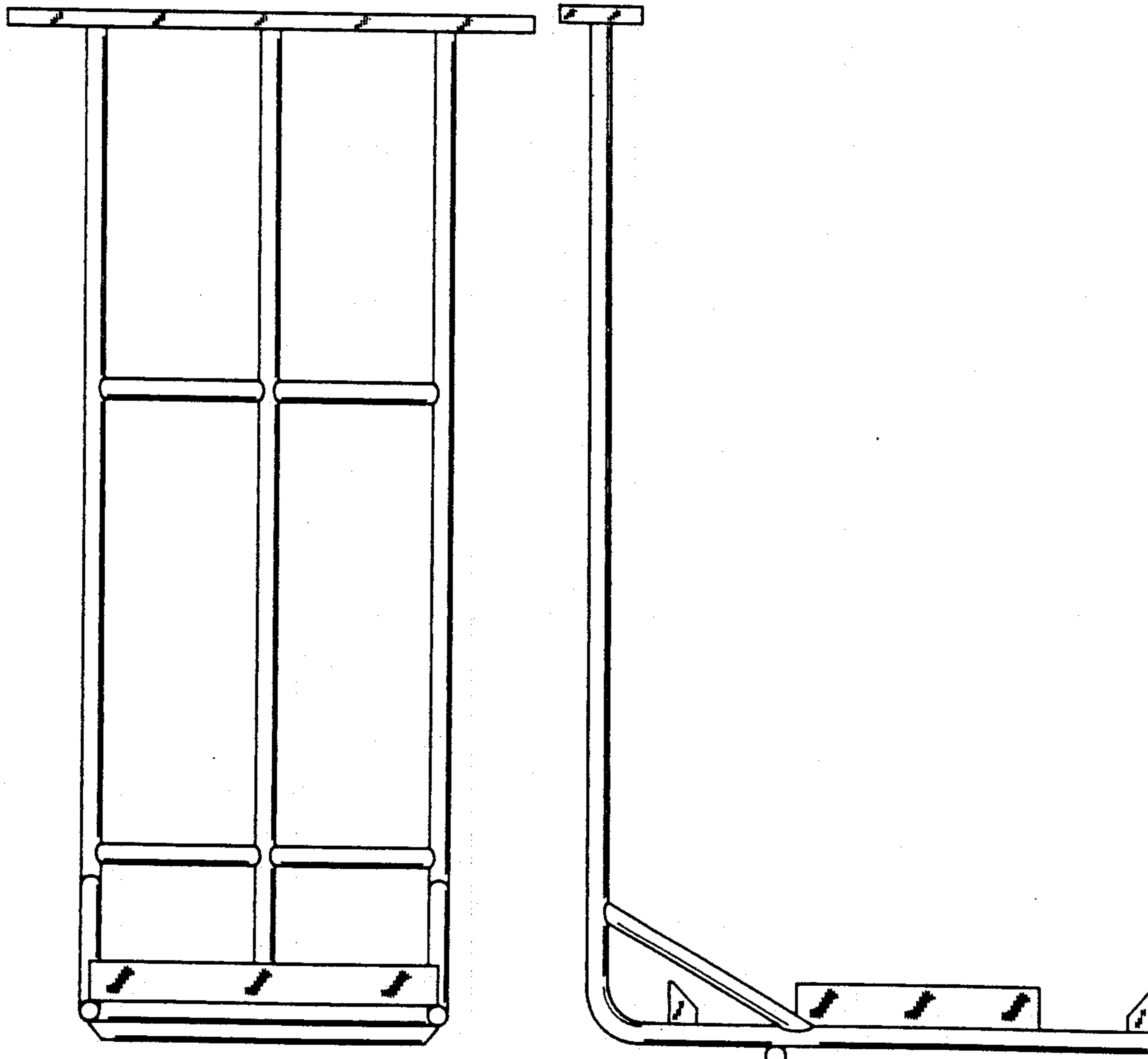
FIG. 2 is a left side view thereof;

FIG. 6 is a back view thereof.



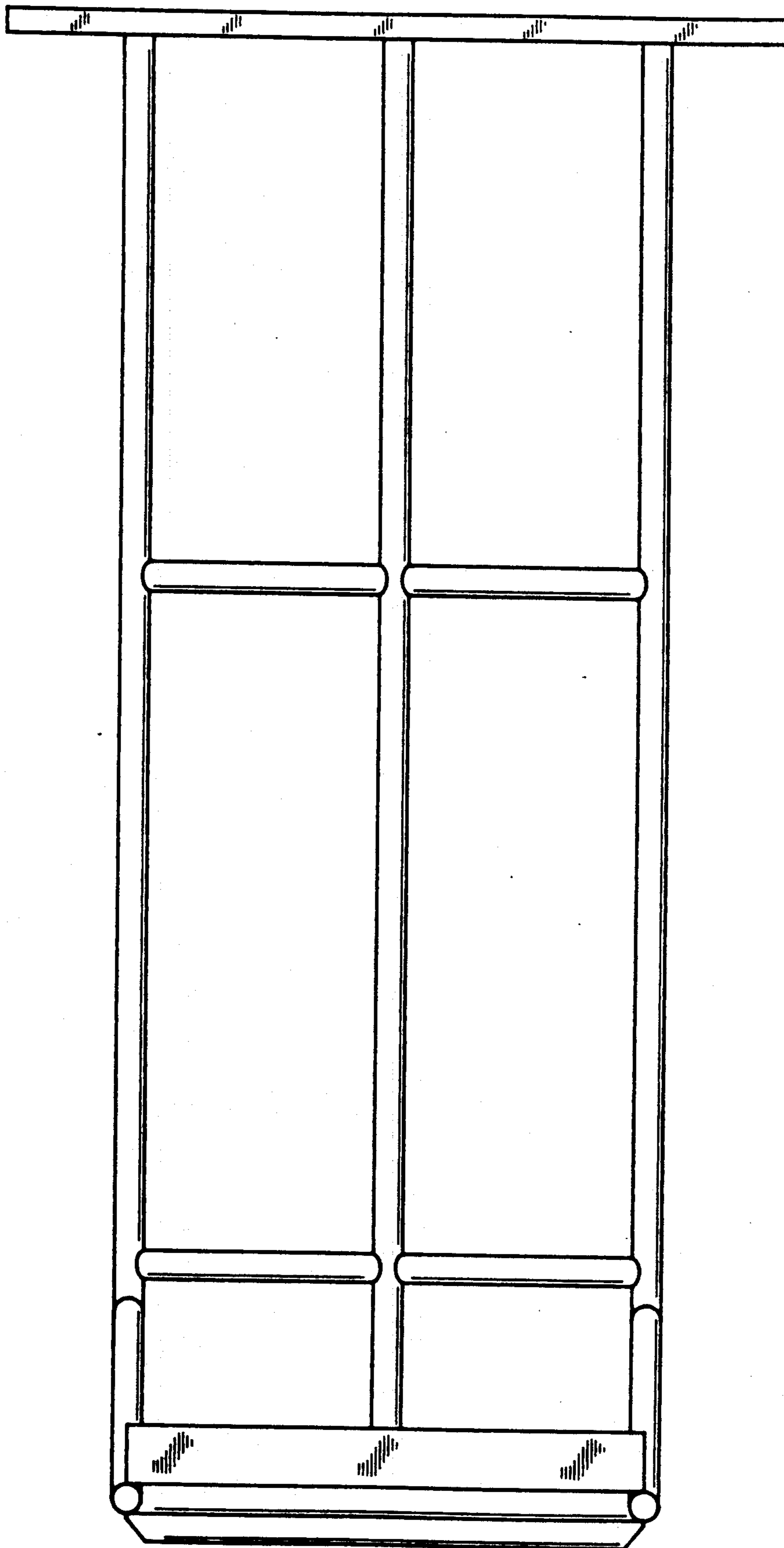

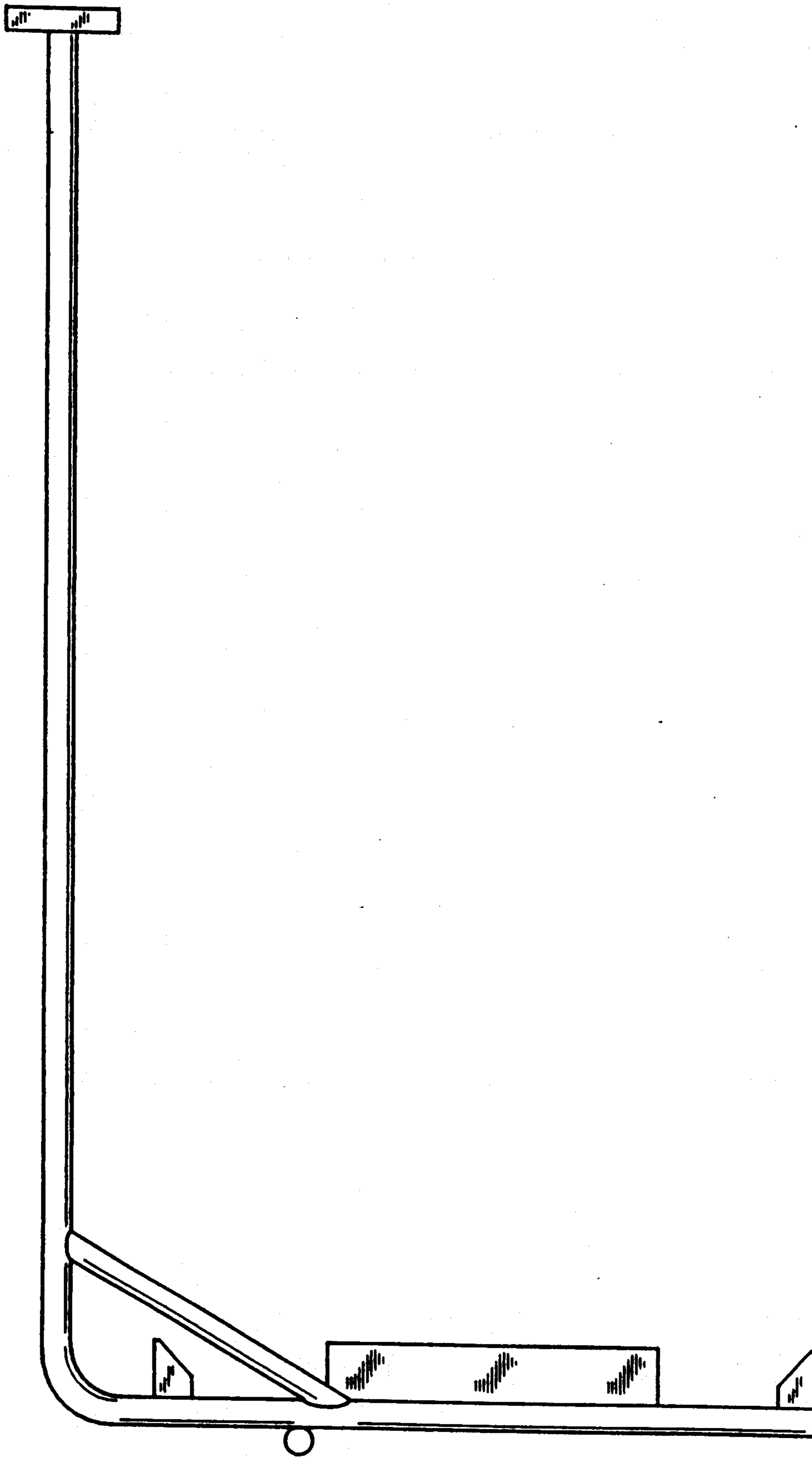

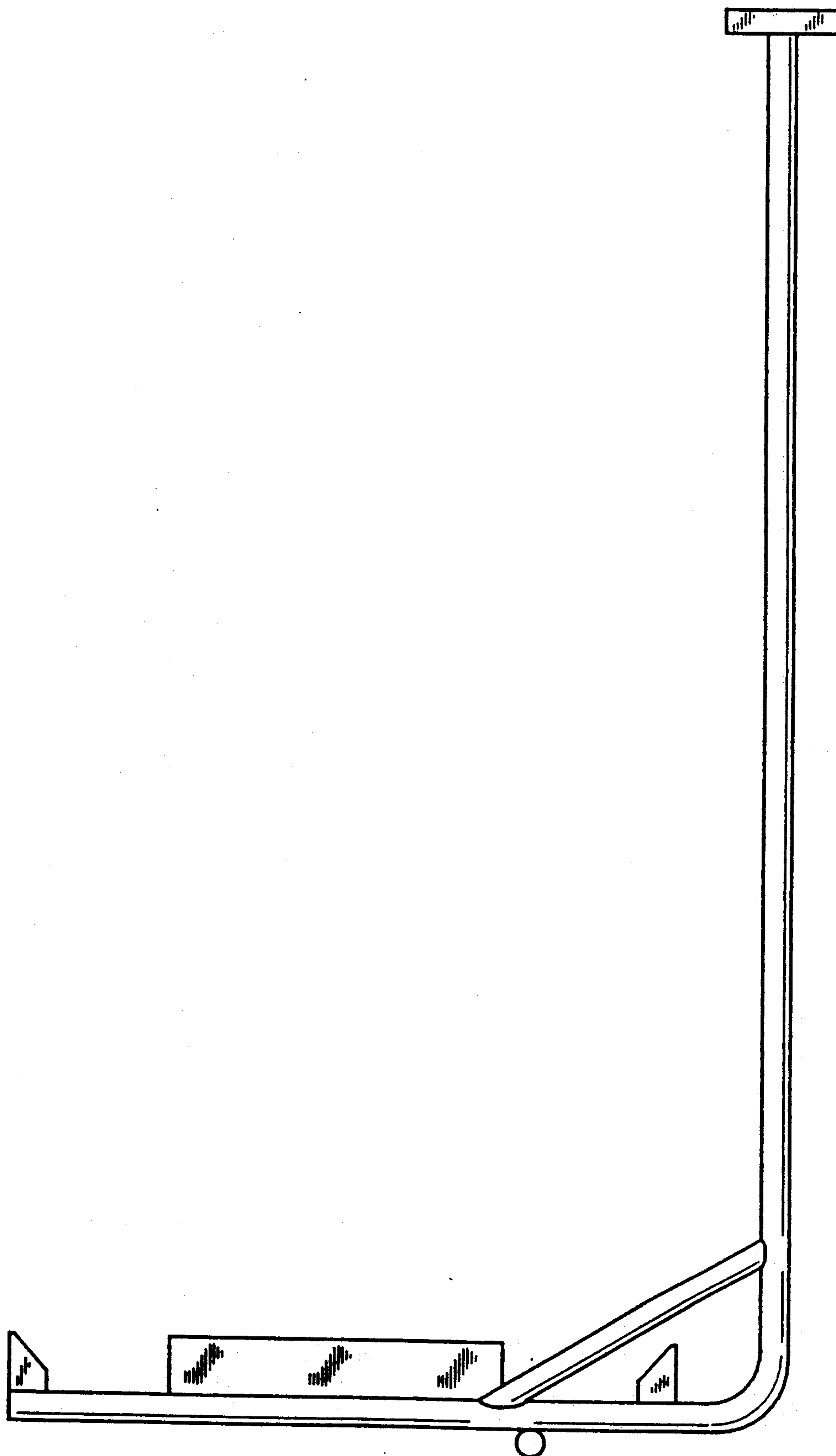

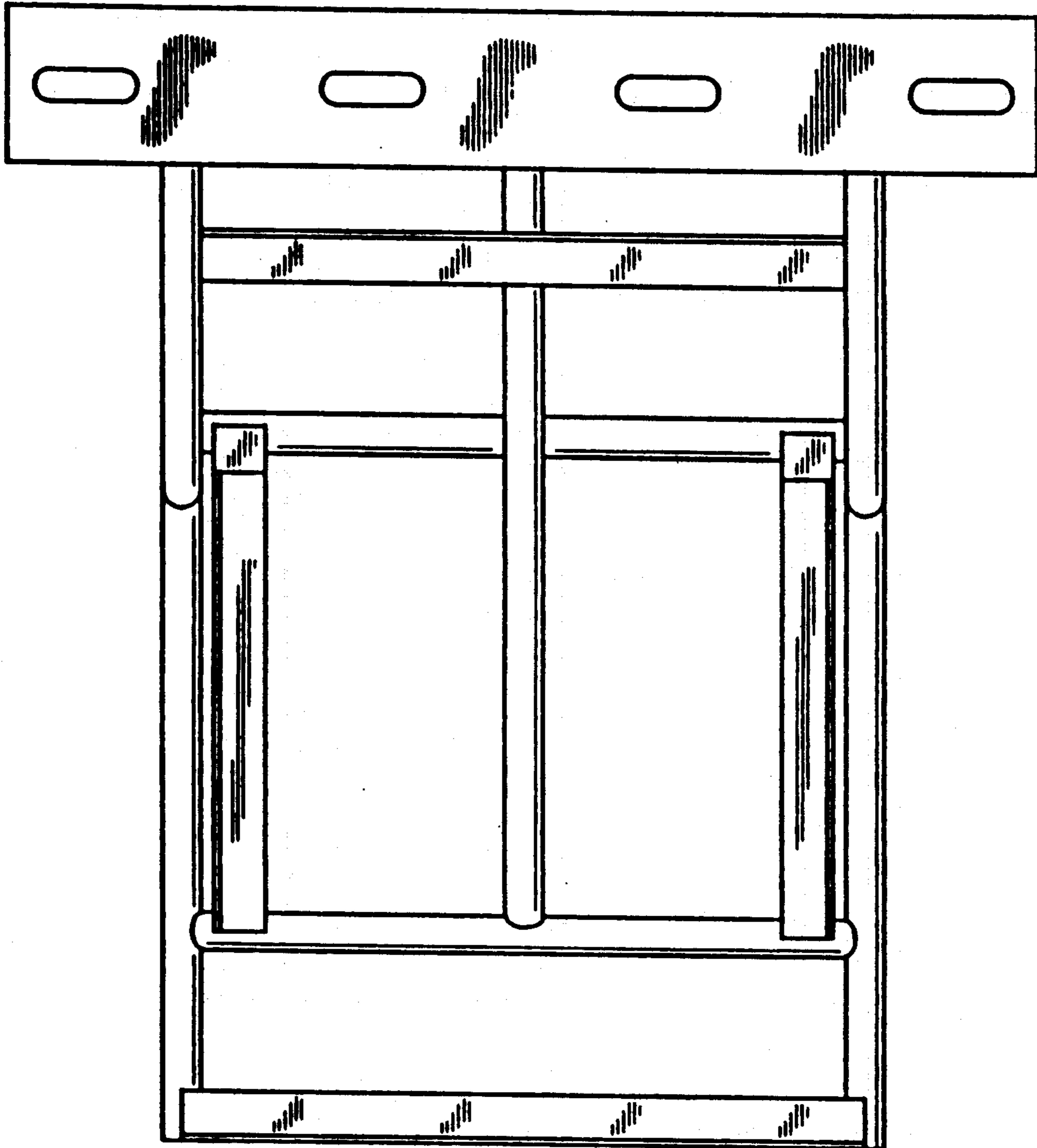

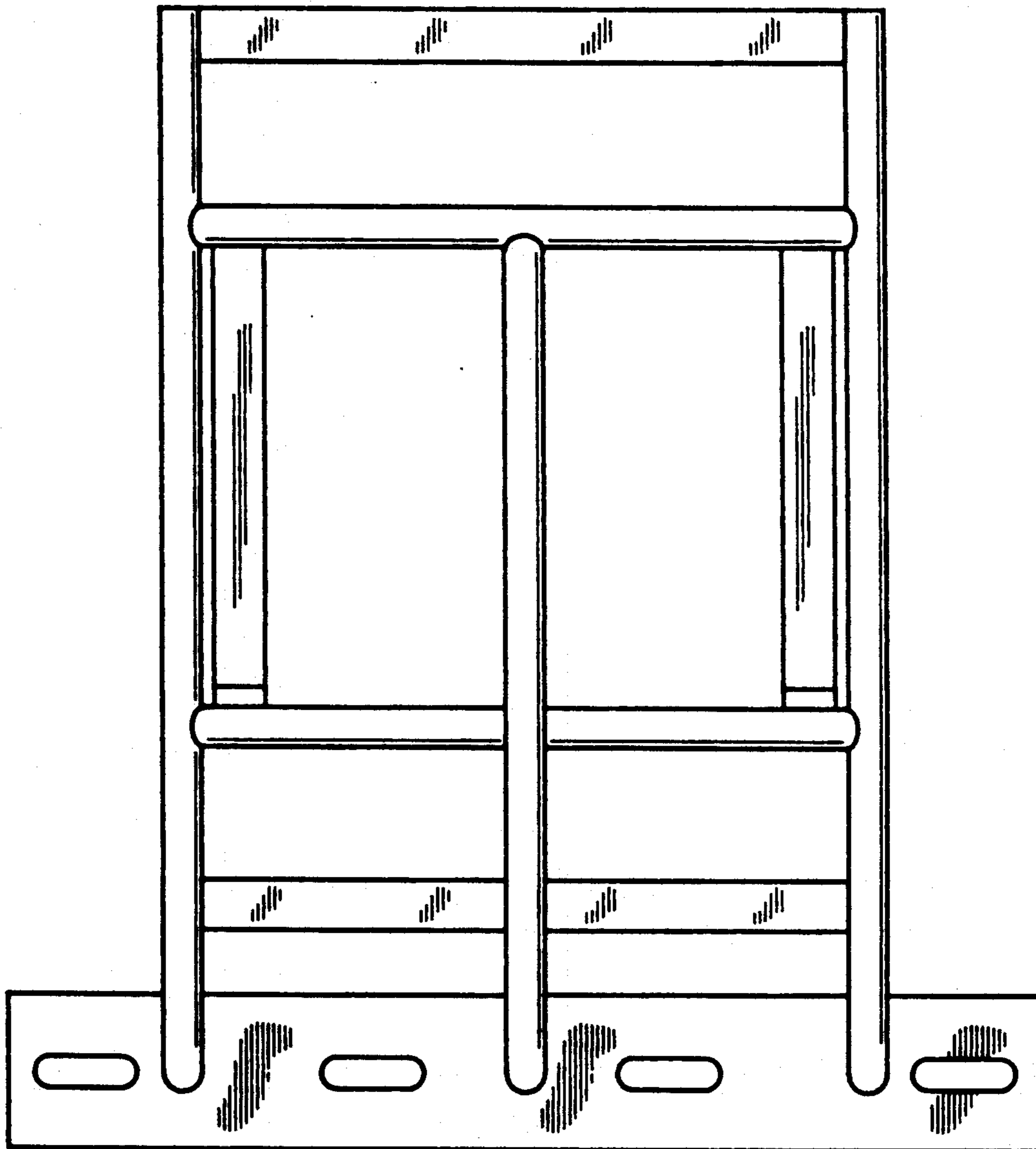

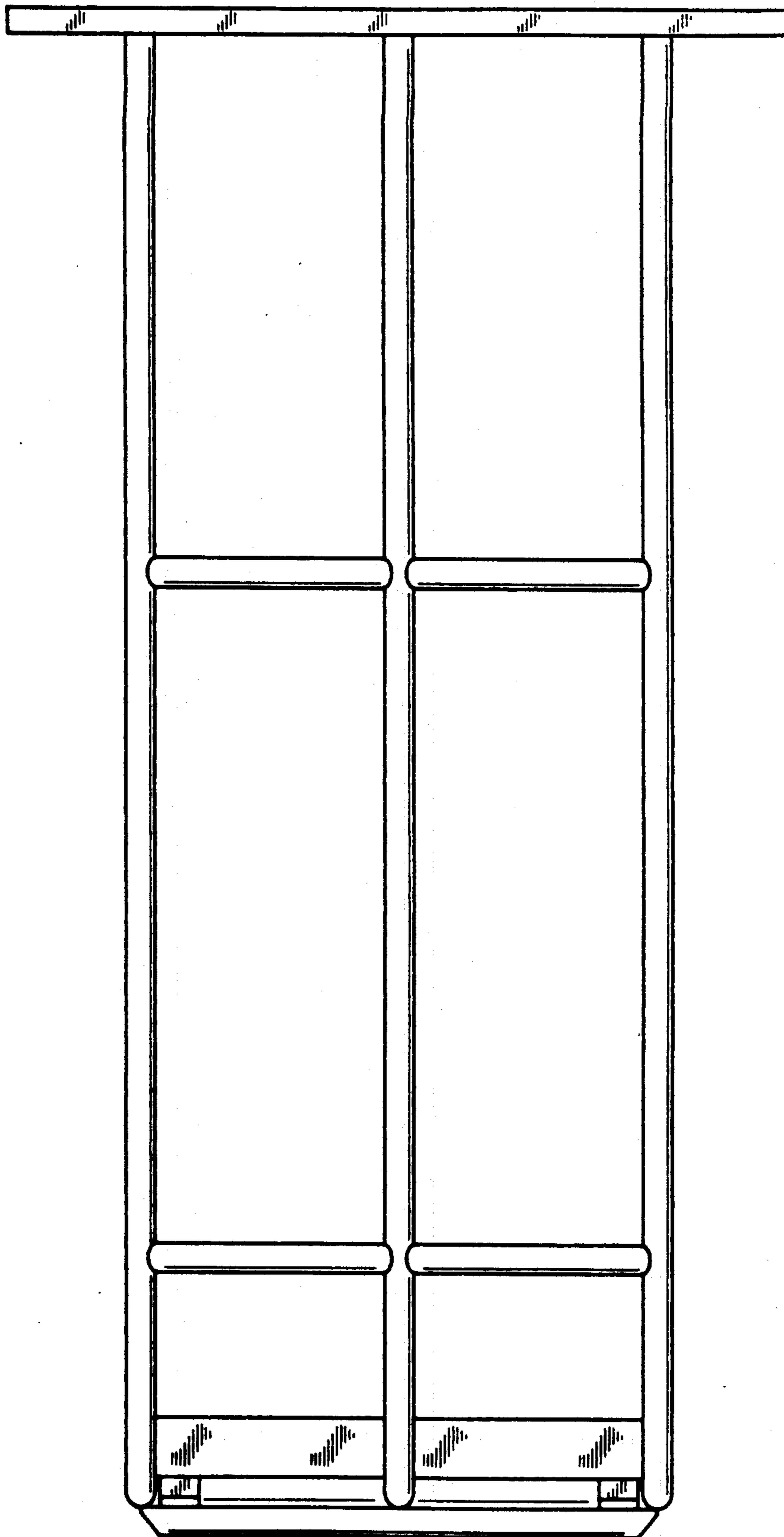
