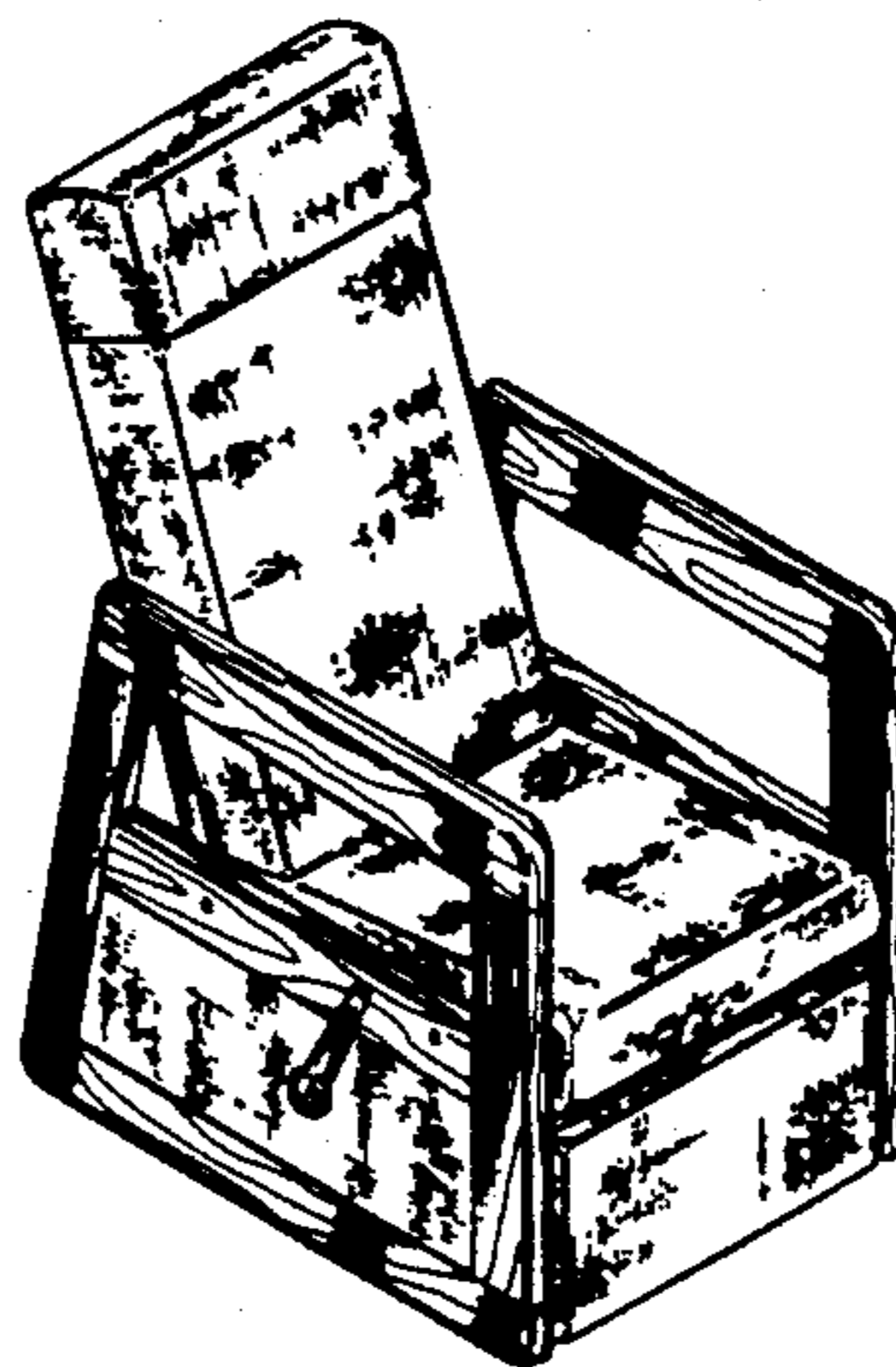

The ornamental design for a reclining chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a reclining chair in its upright position showing my new design;
 FIG. 2 is a right side elevation view;
 FIG. 3 is a left side elevation view;
 FIG. 4 is a front elevation view;
 FIG. 5 is a rear elevation view;
 FIG. 6 is a top view;
 FIG. 7 is a bottom view; and,
 FIG. 8 is a perspective view of the reclining chair in its fully reclined position.



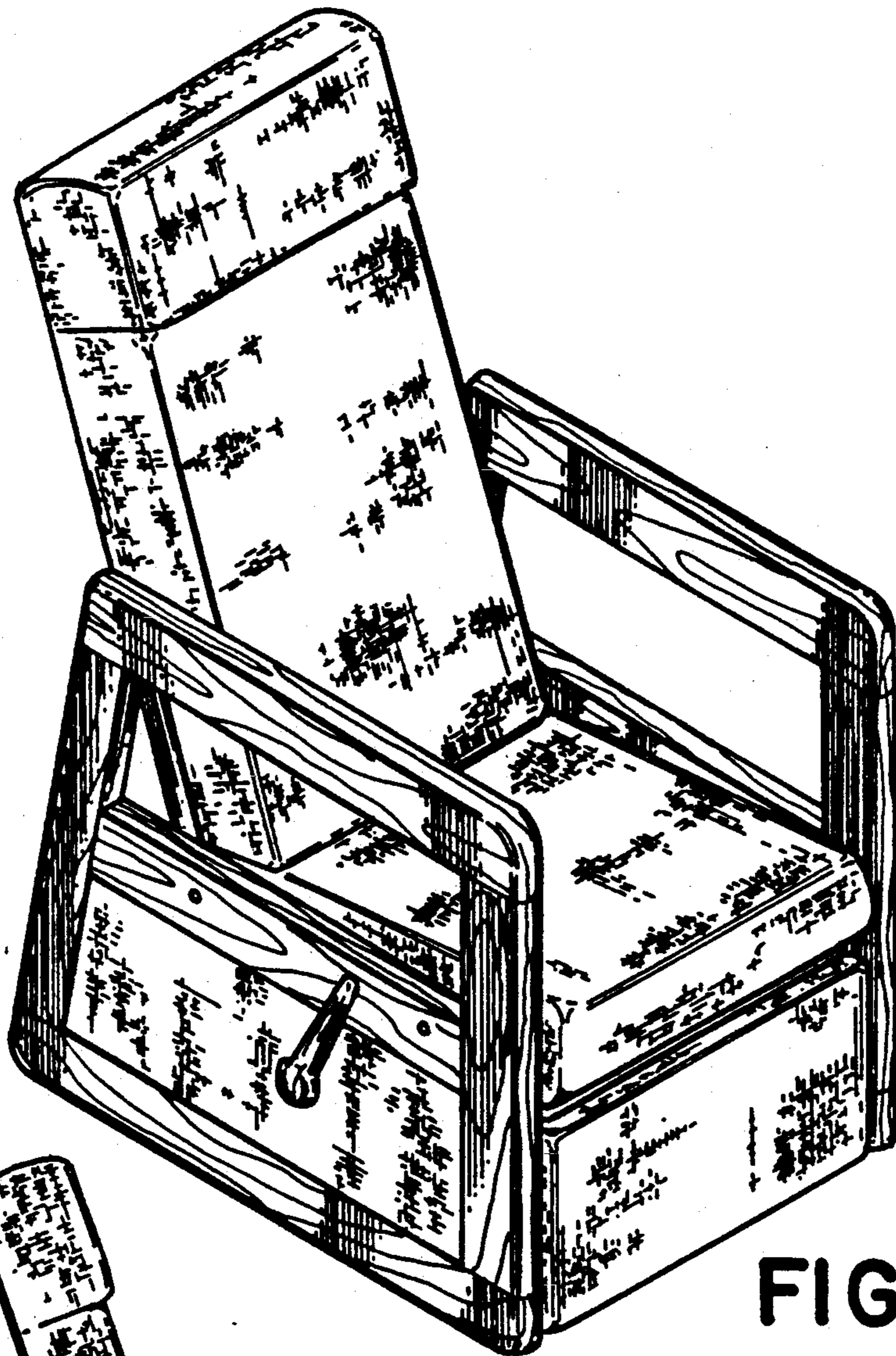

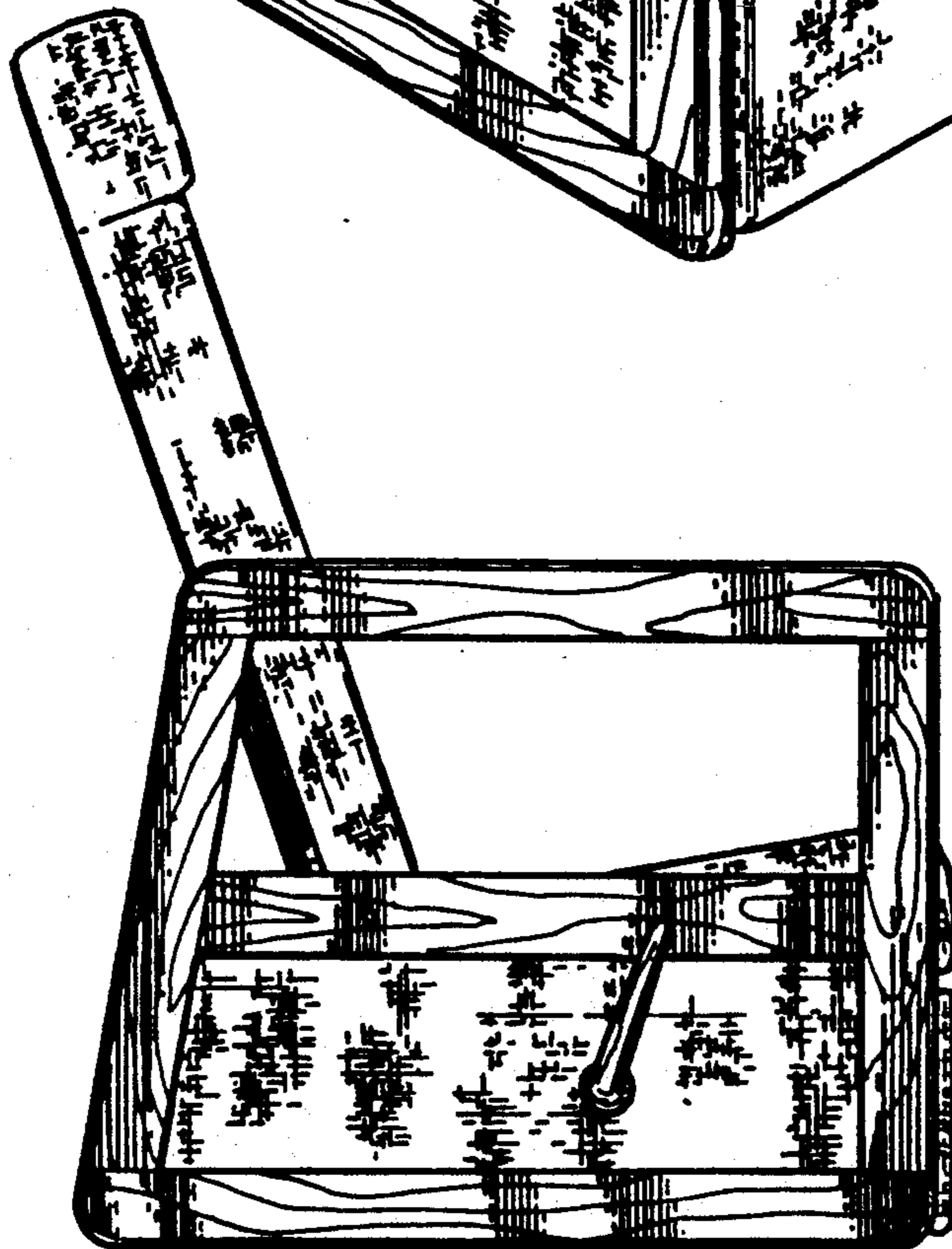

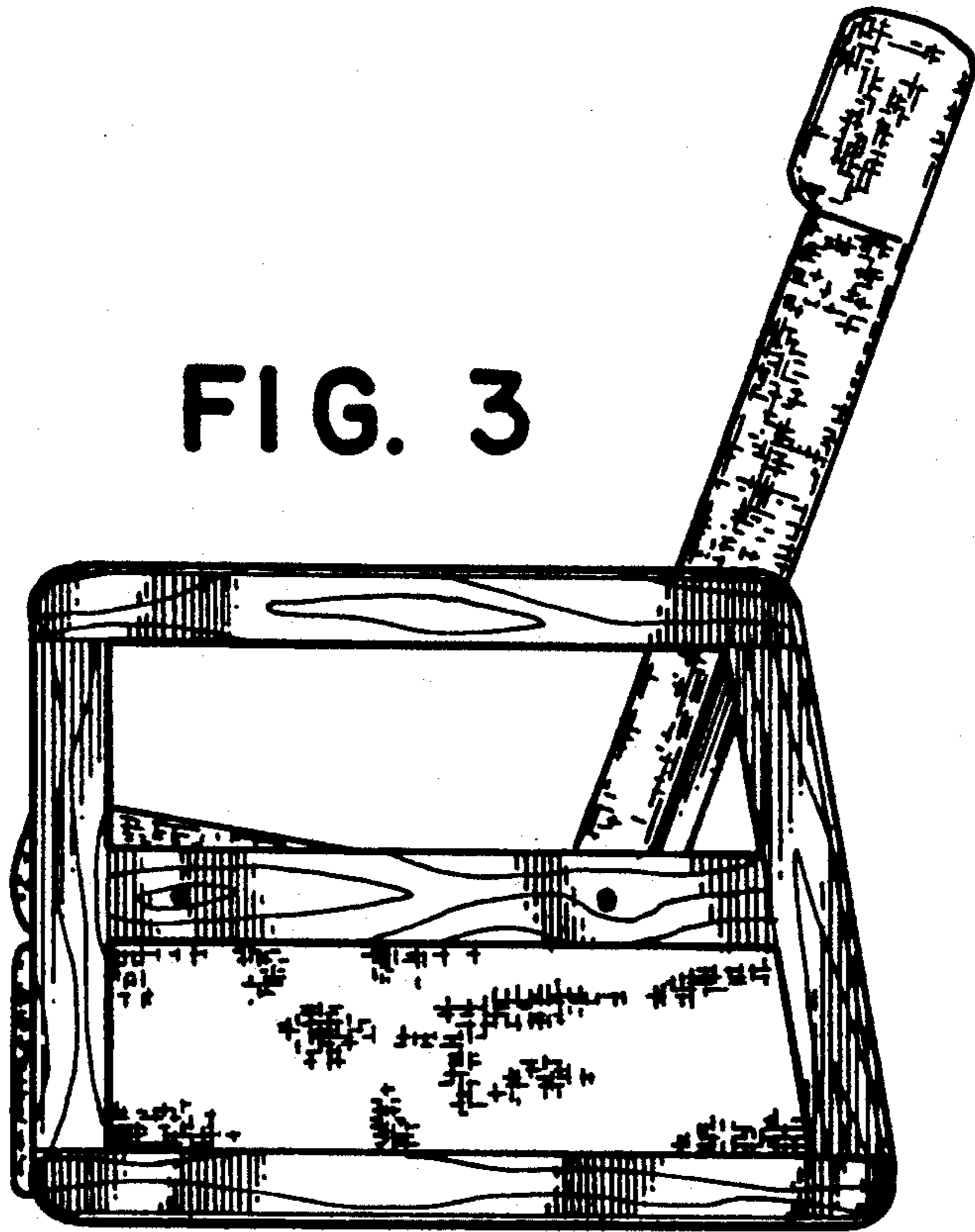

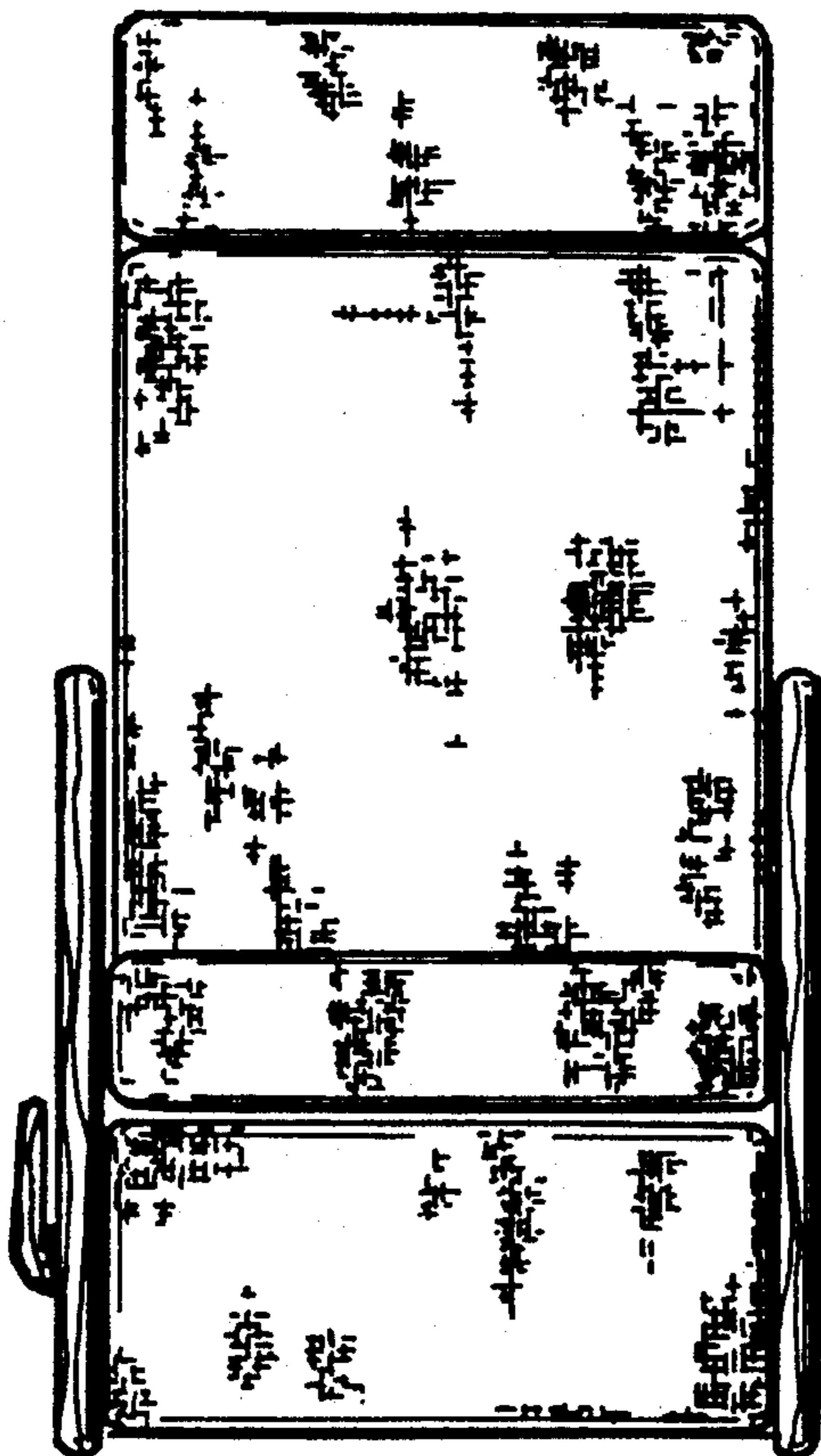
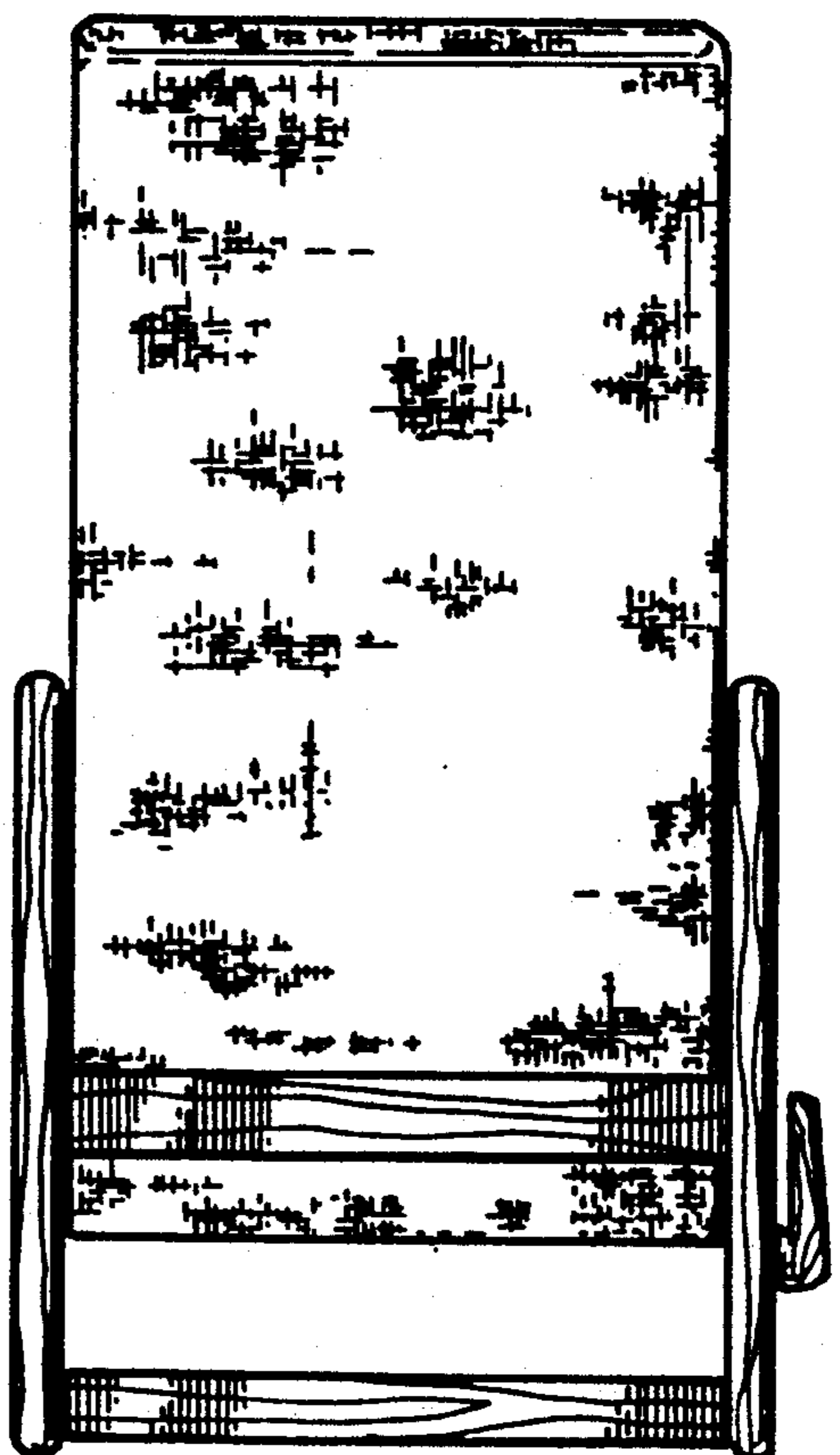

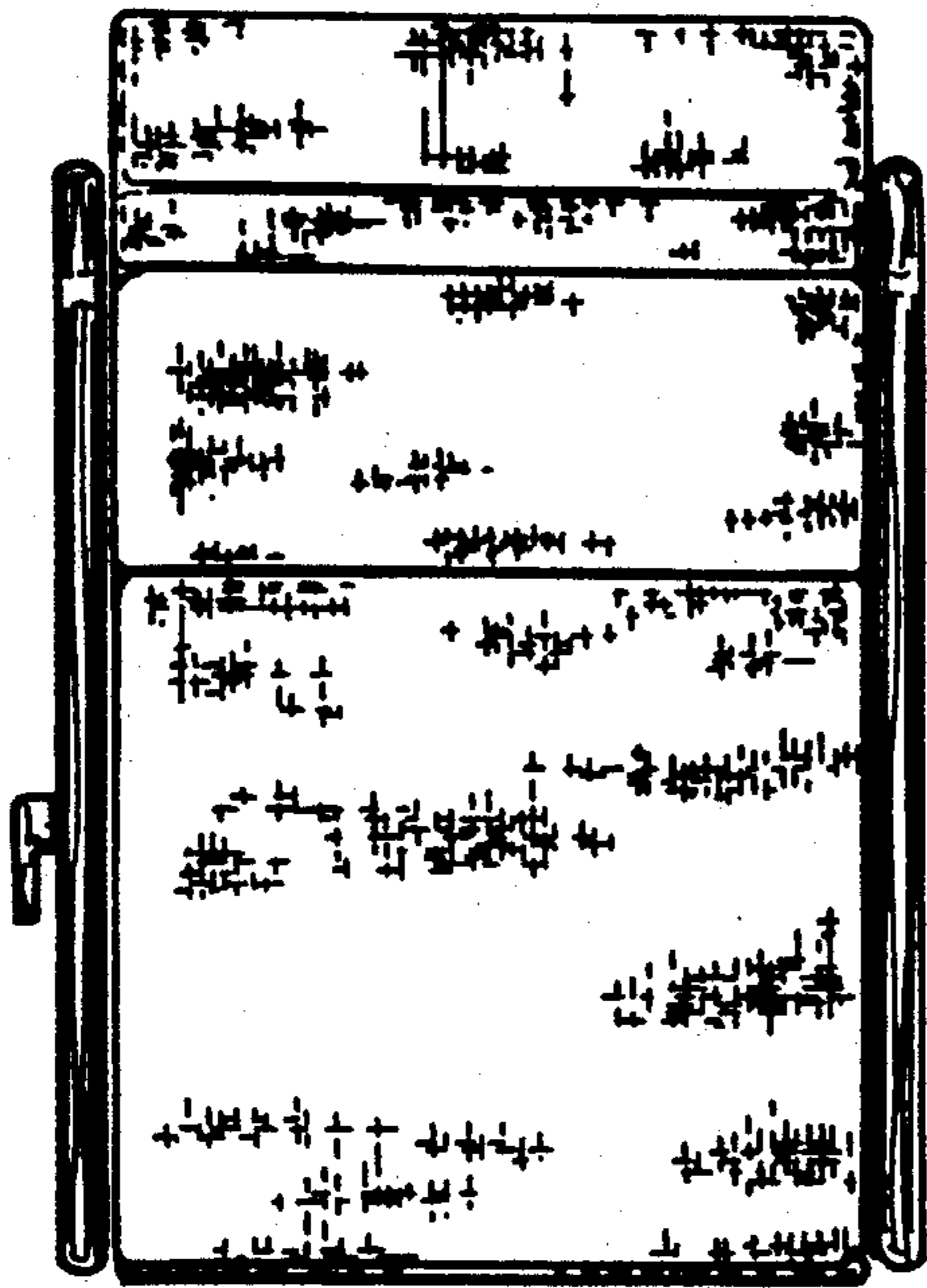

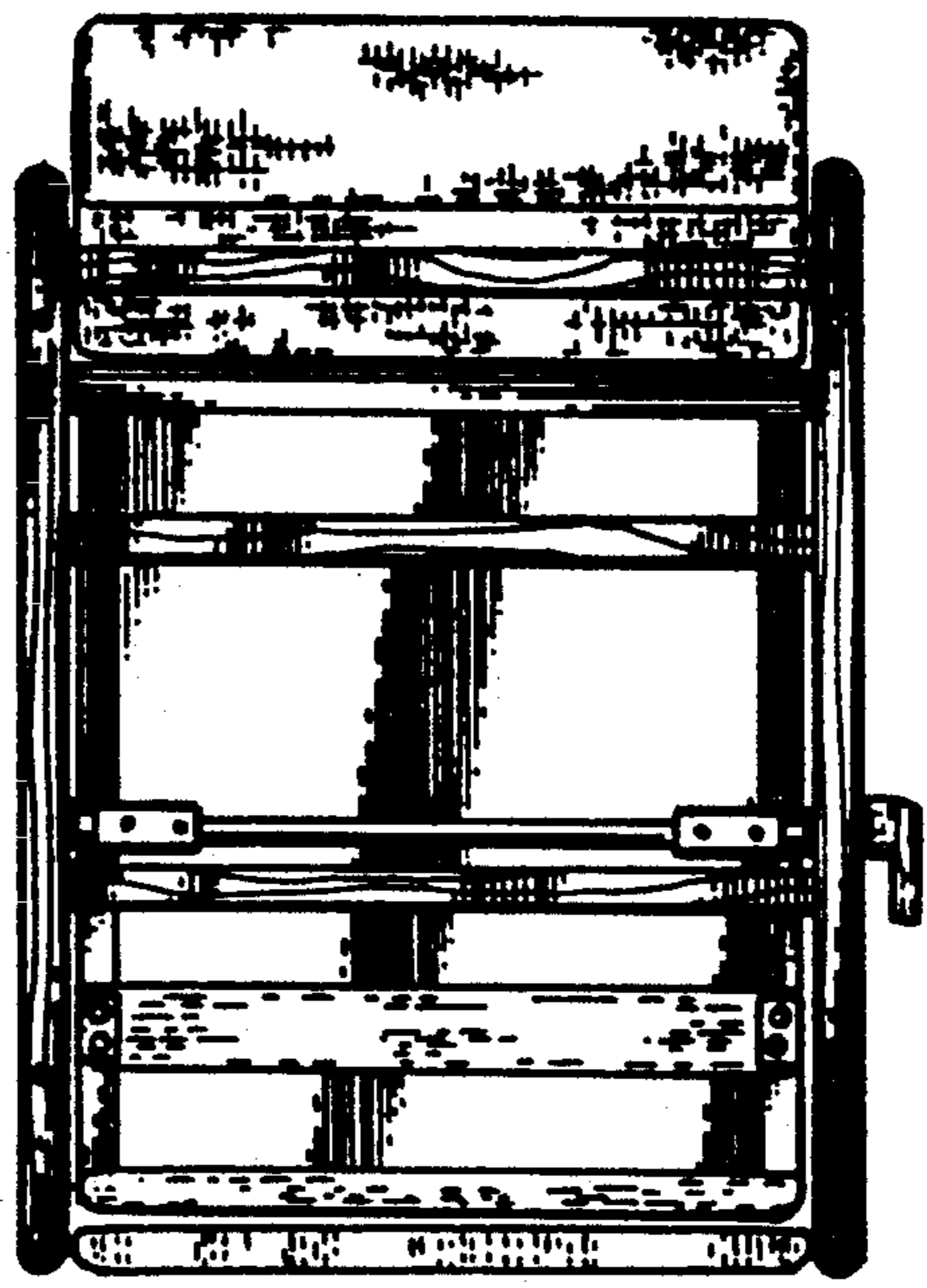

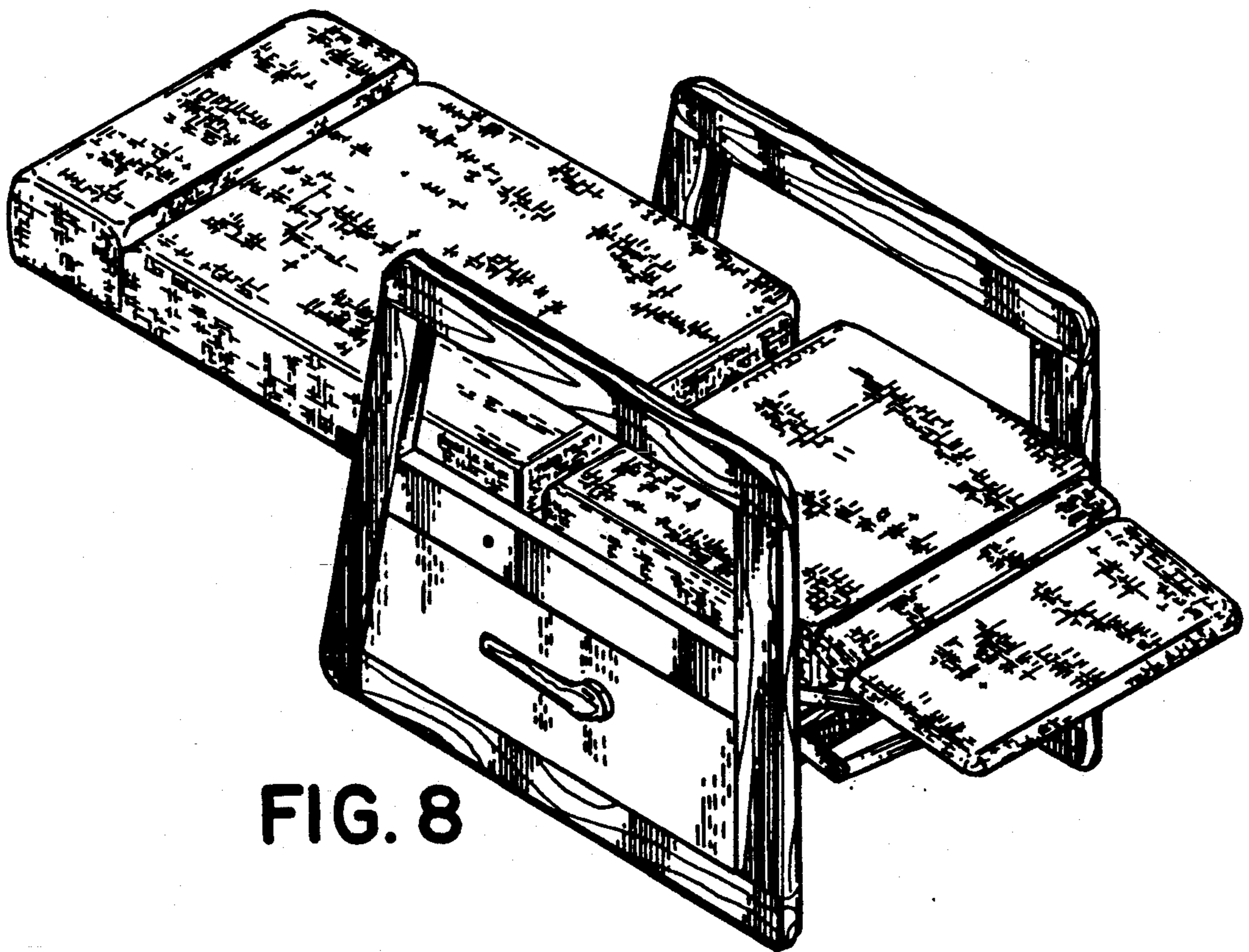
