DESCRIPTION

FIG. 27 is a bottom plan view of the fifth embodiment.

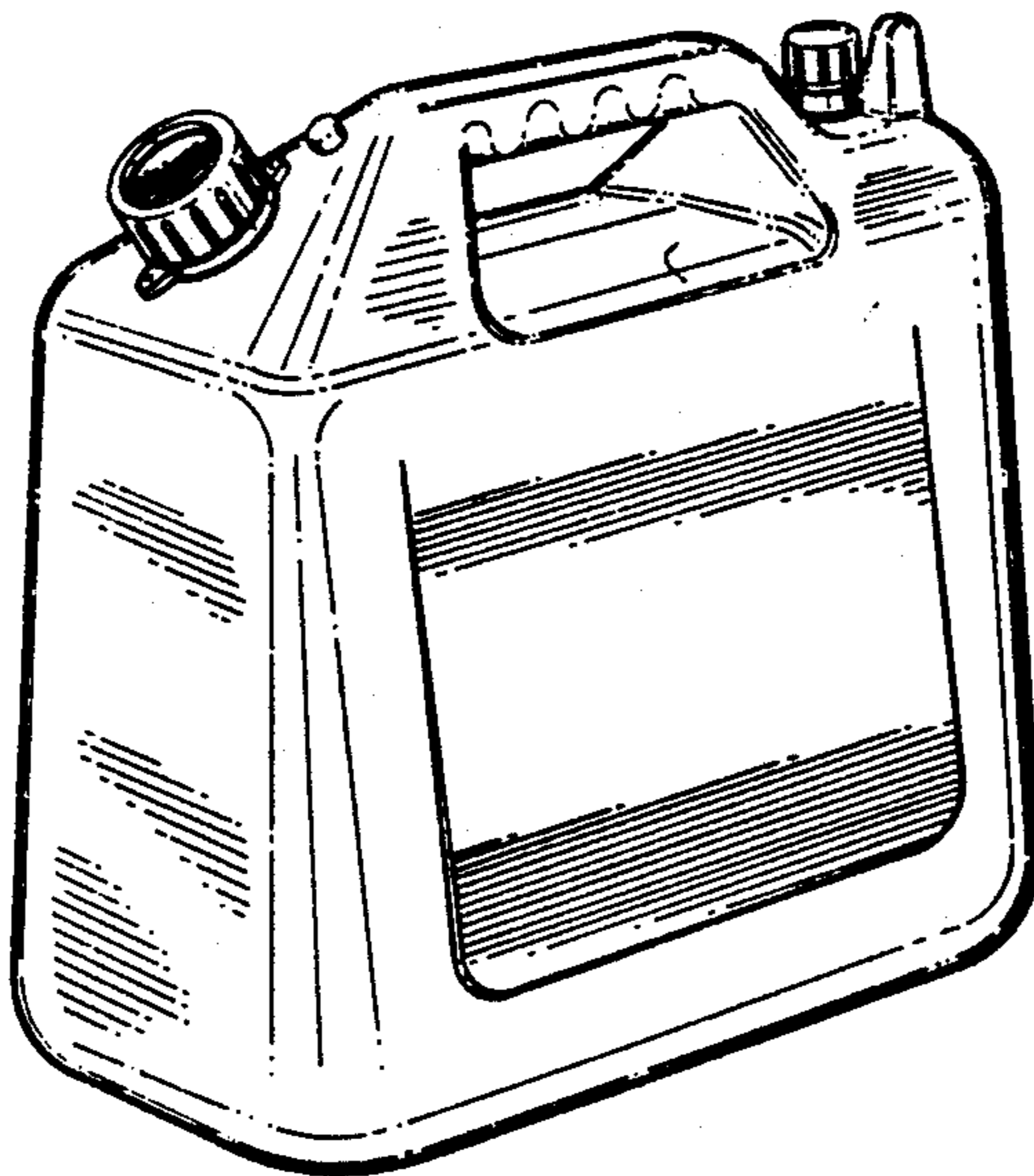

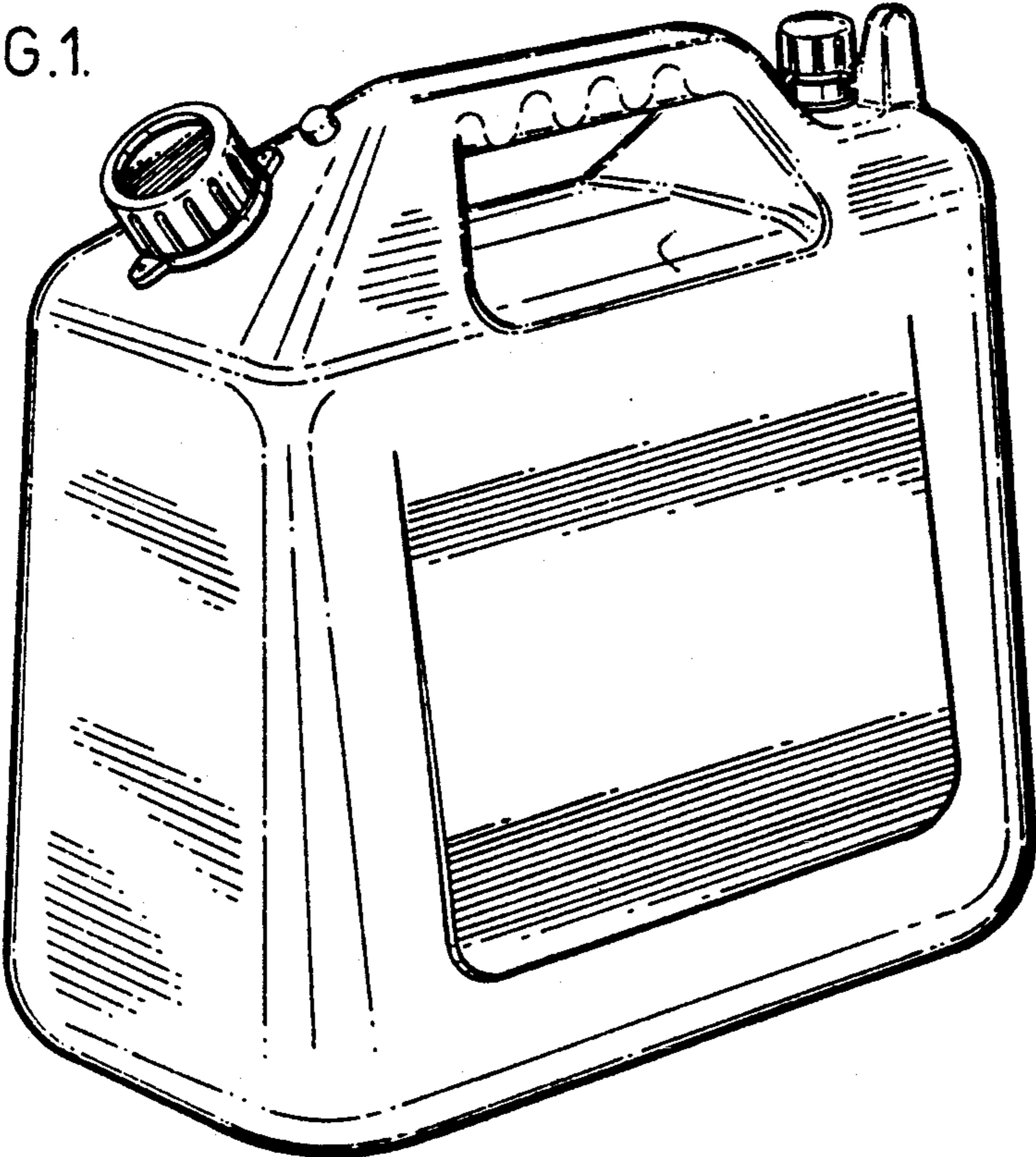

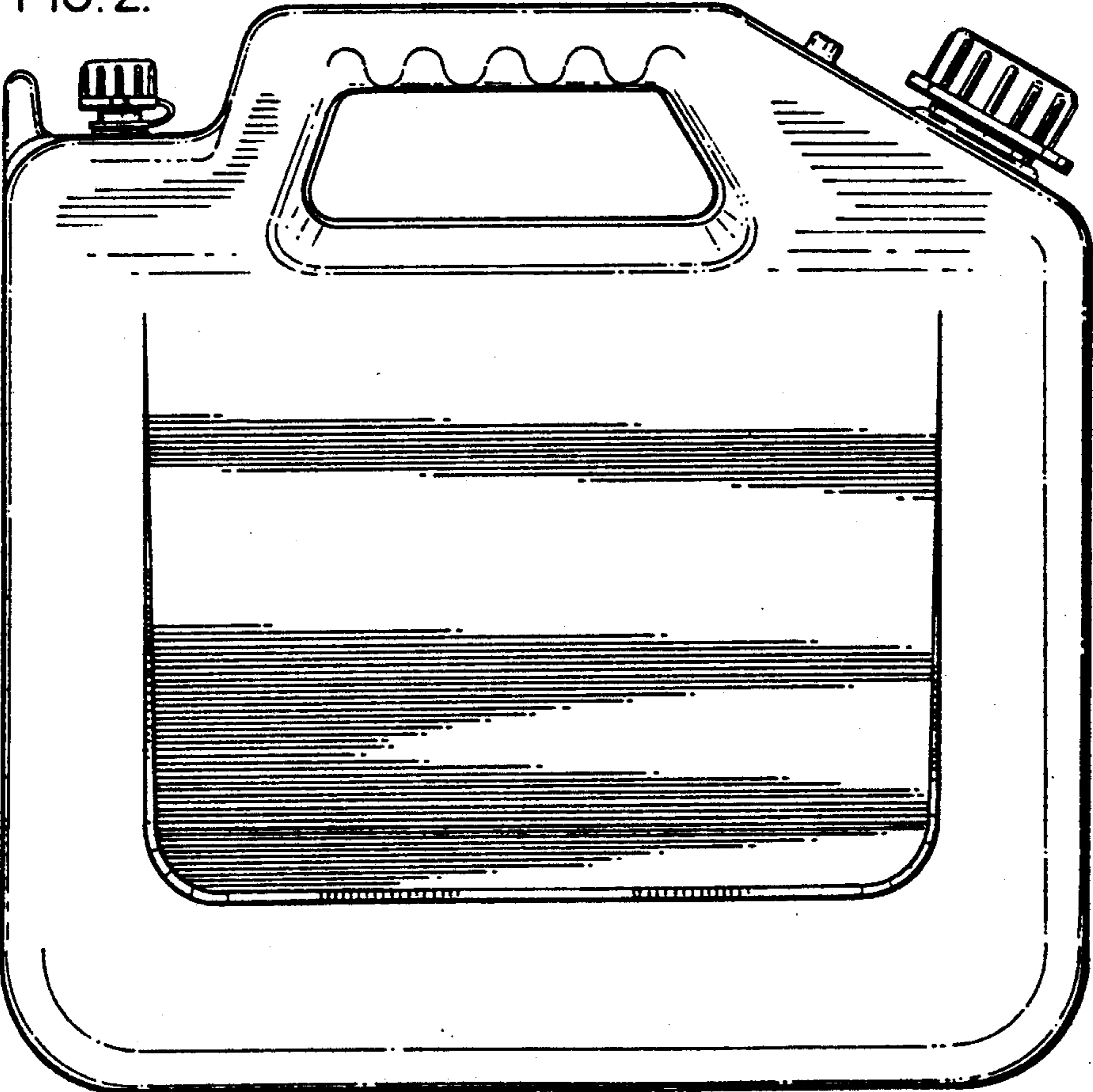

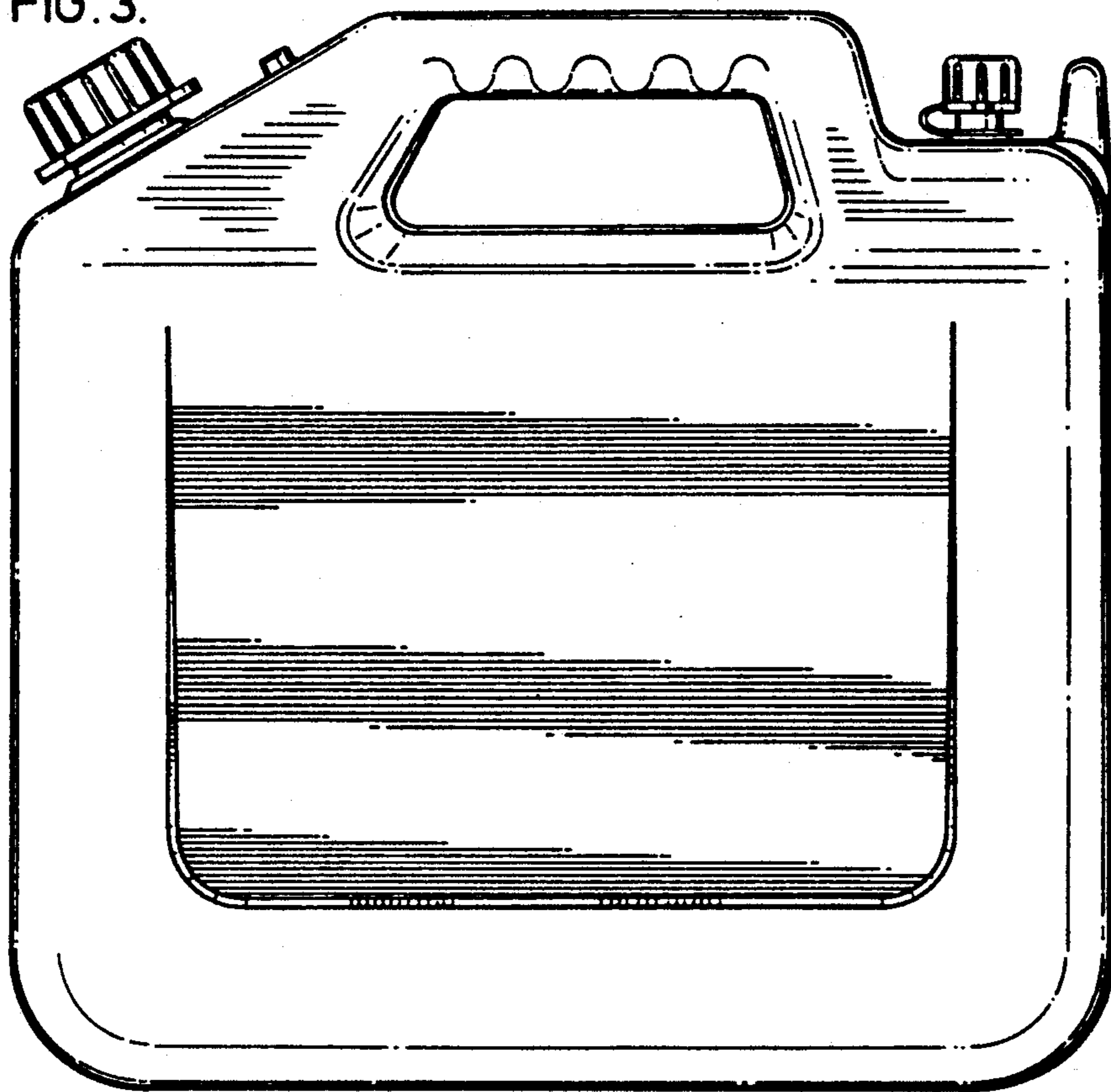

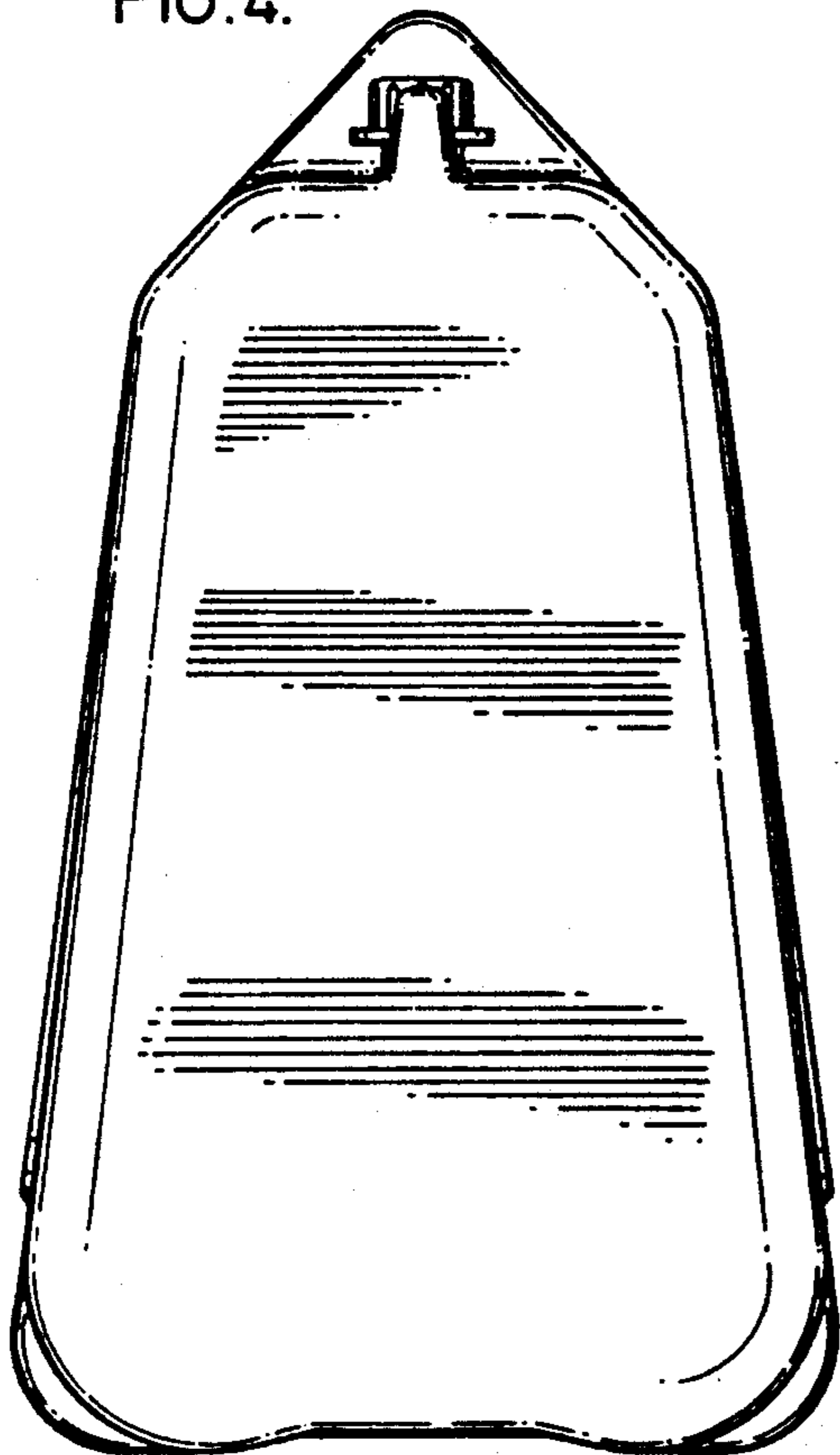

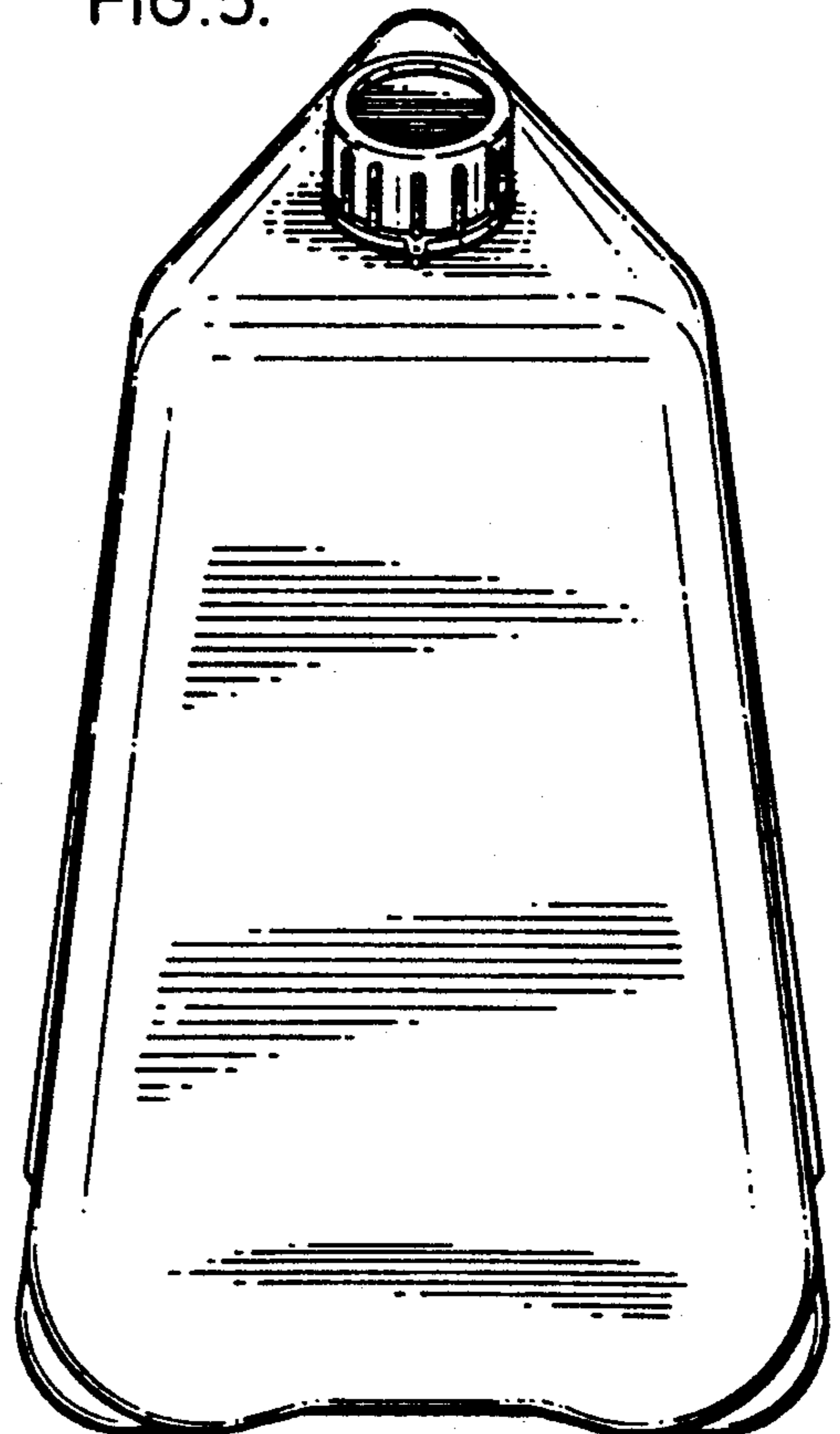

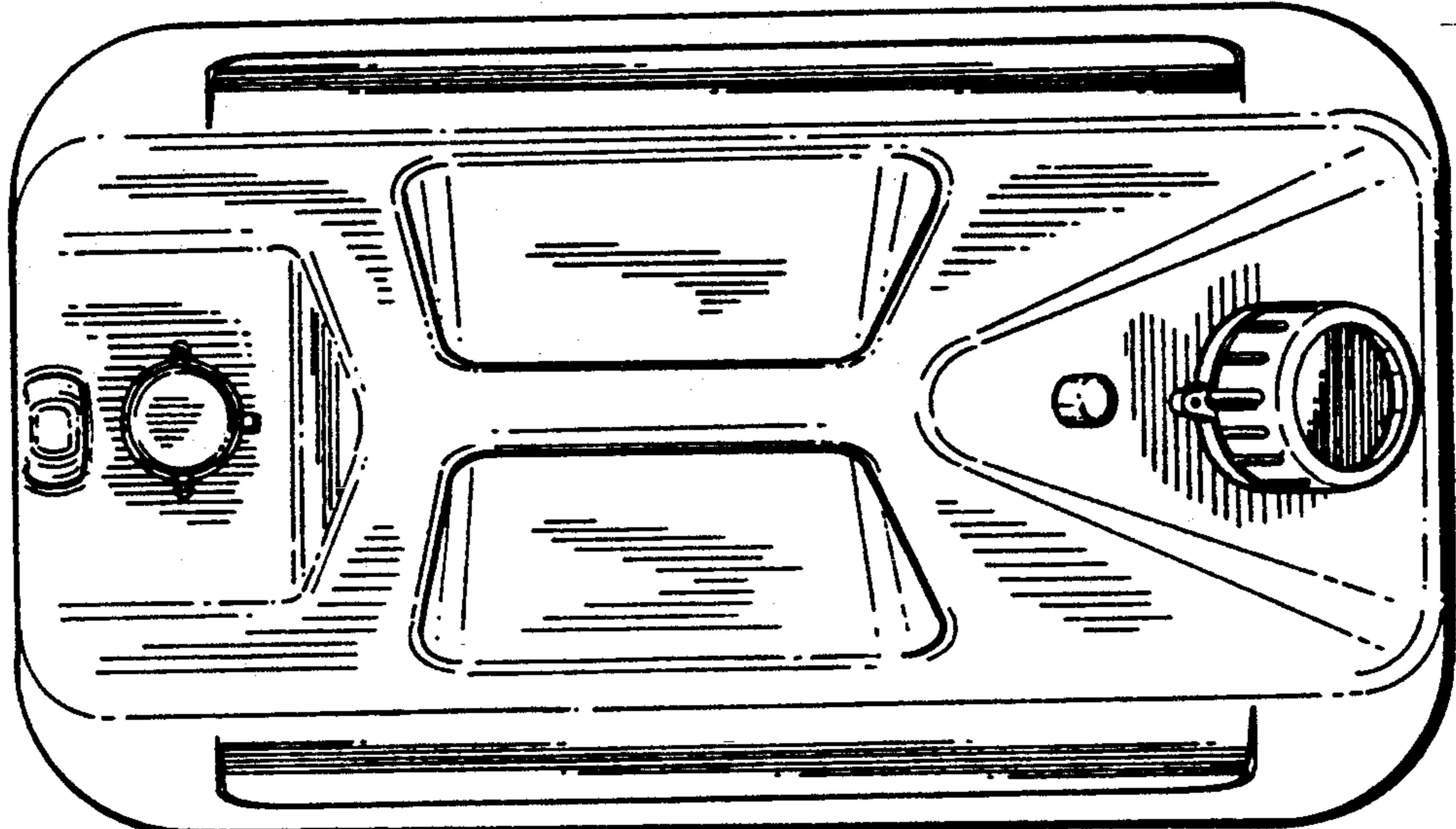

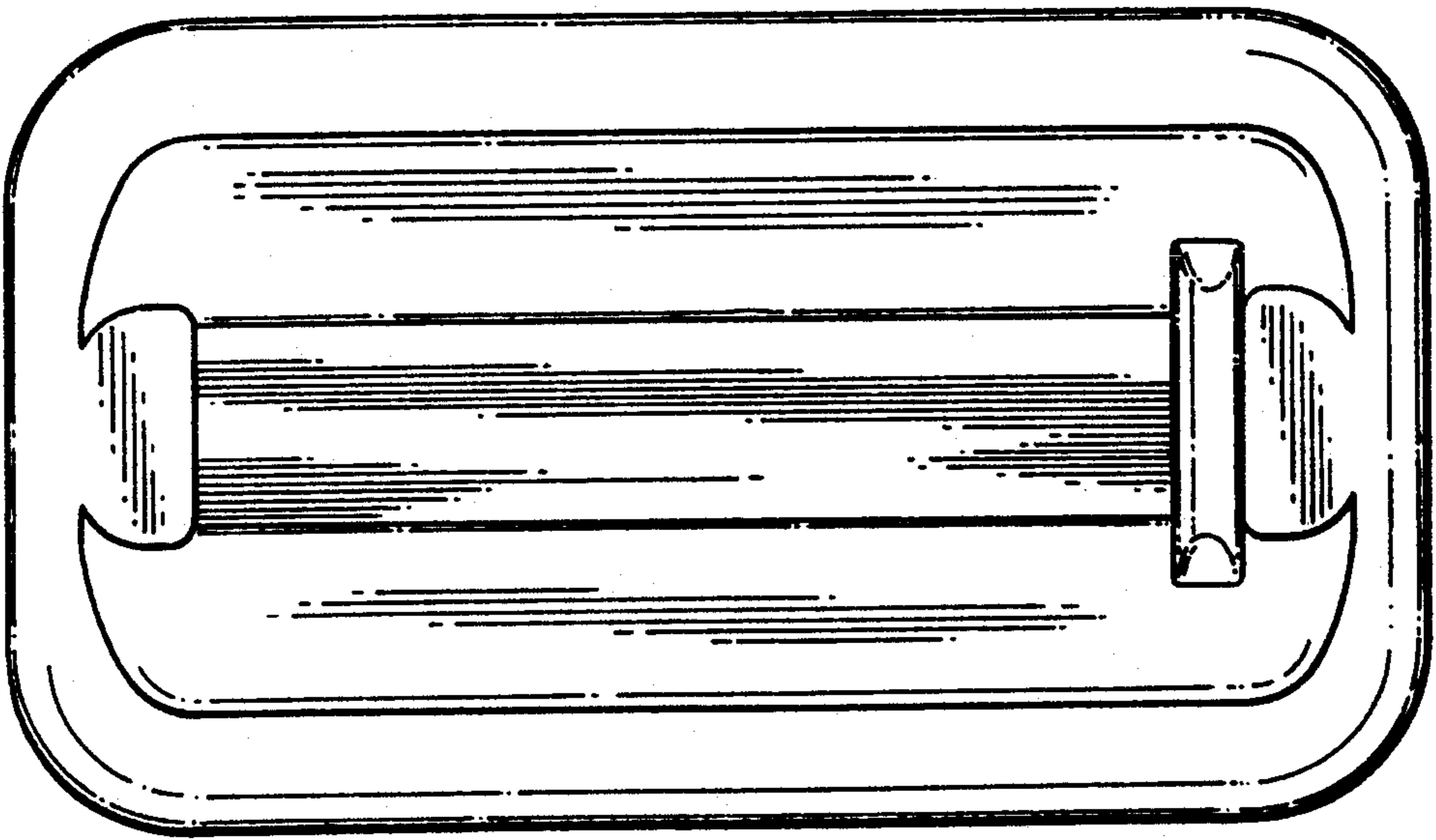

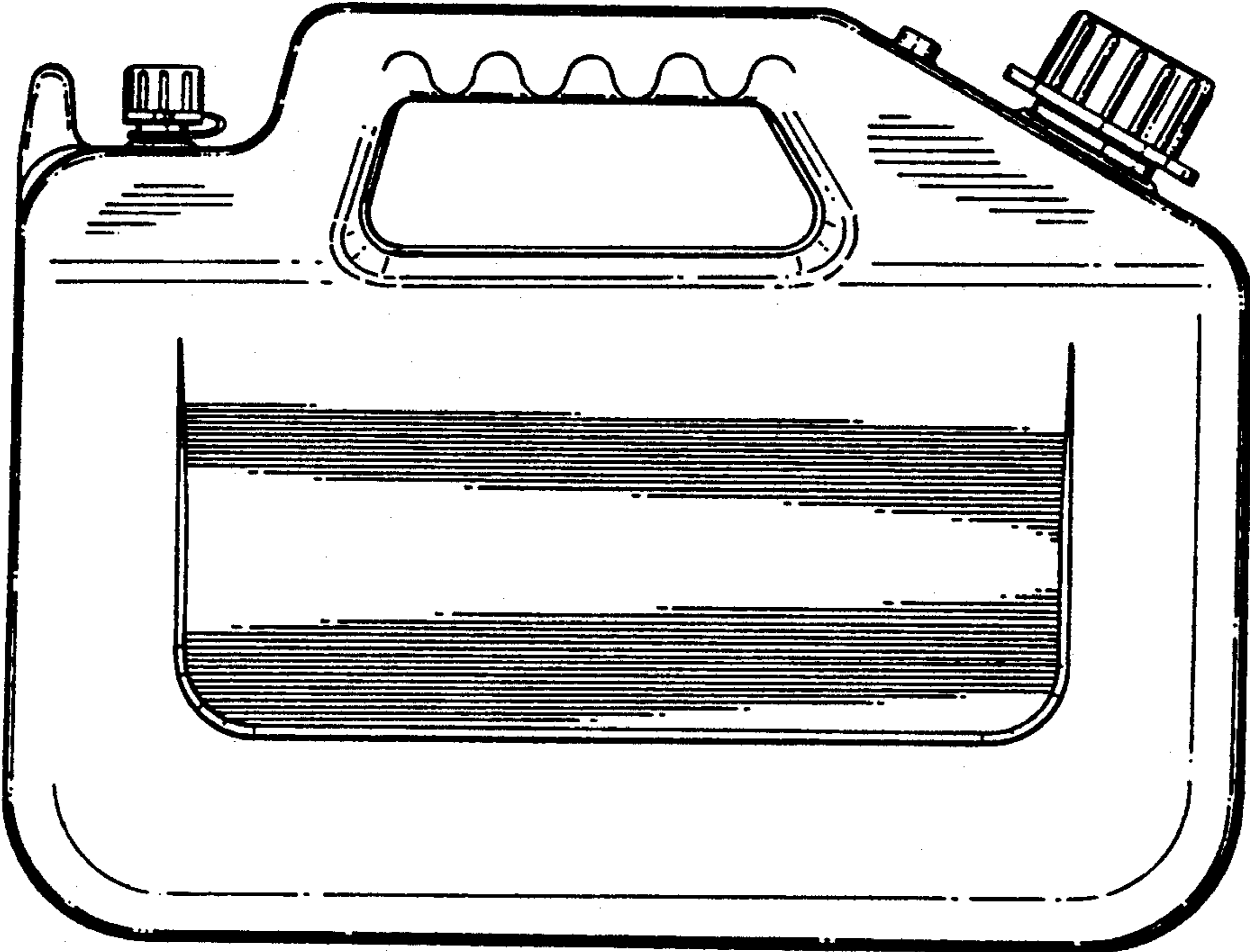

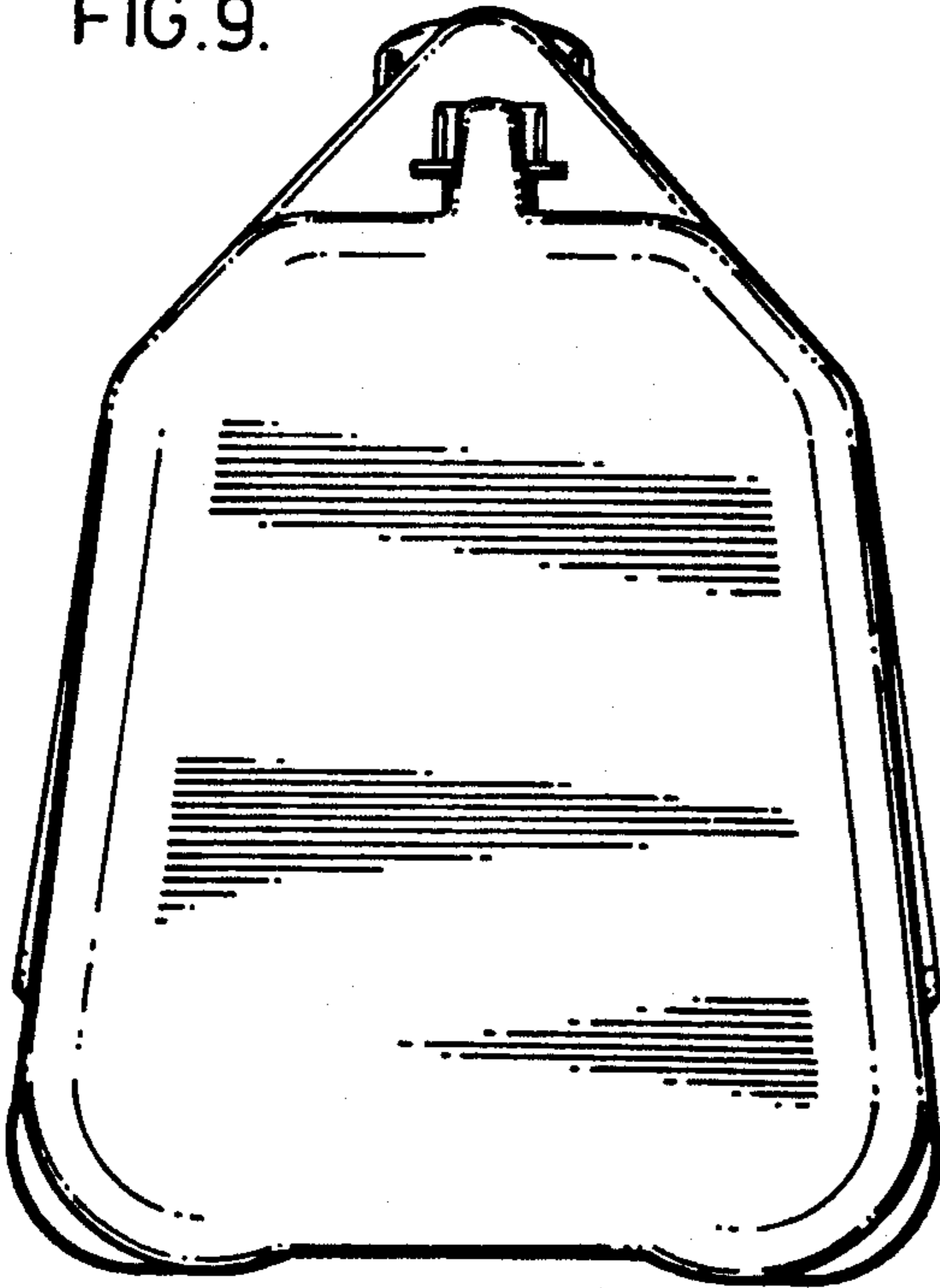

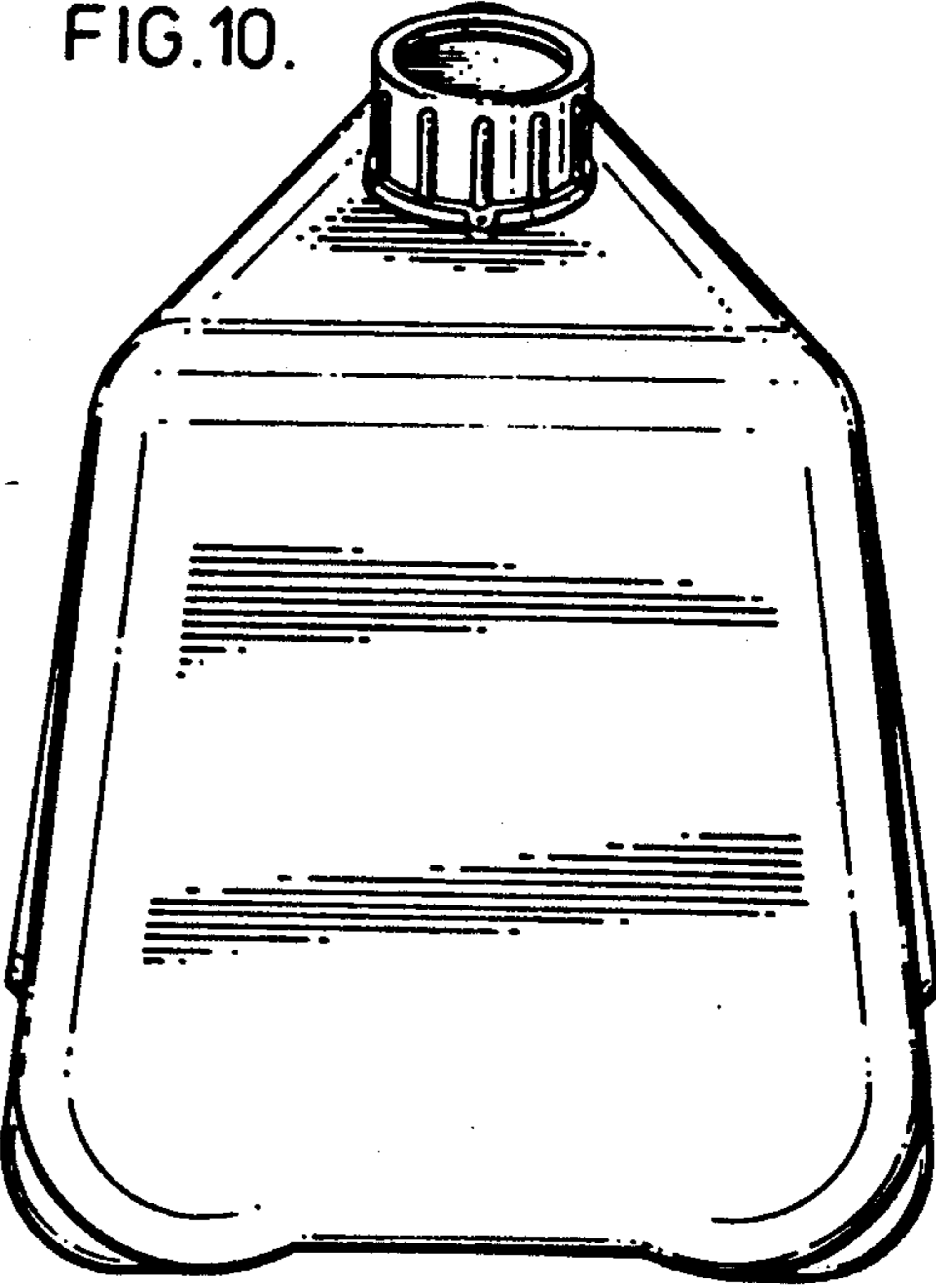

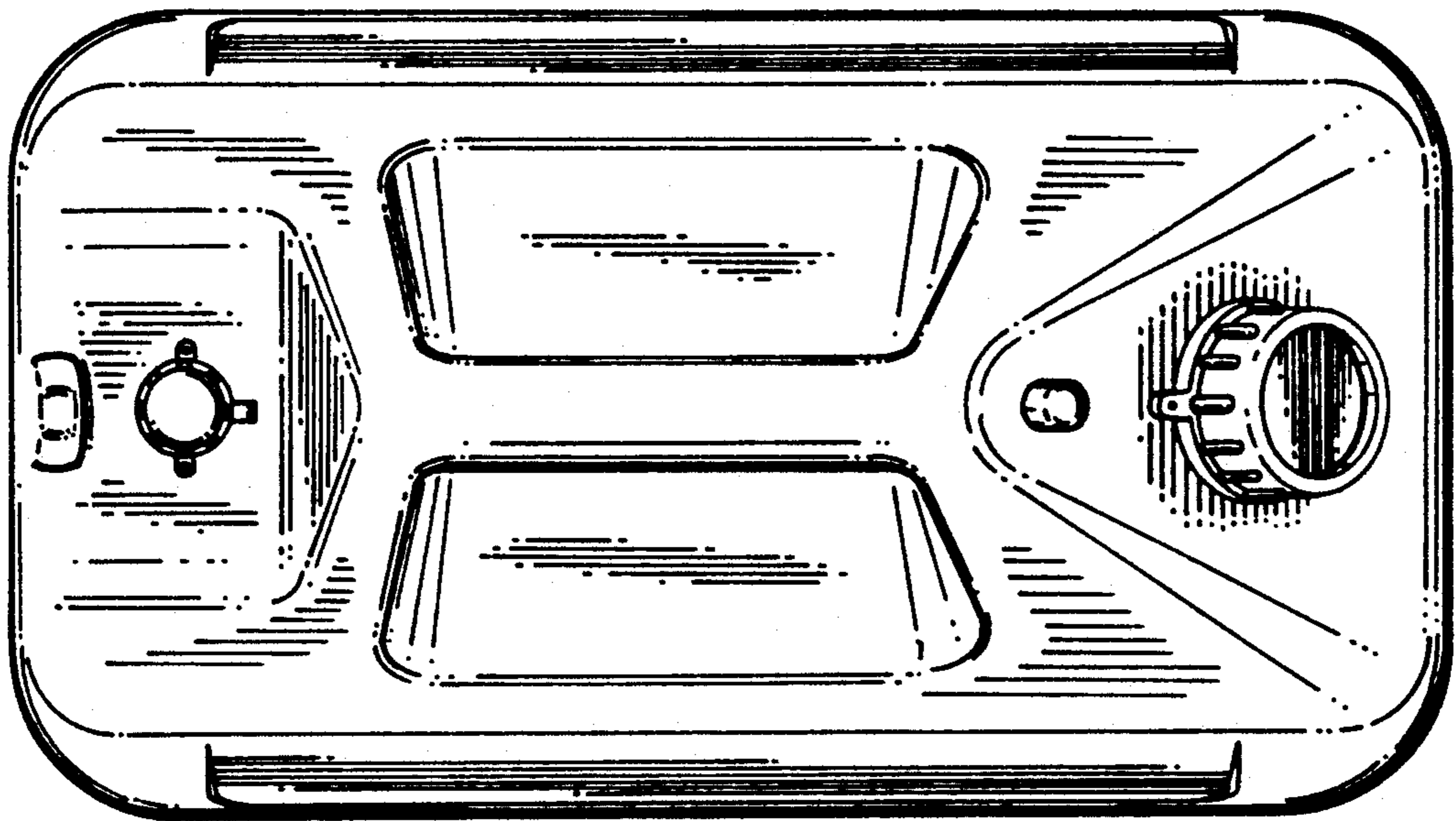

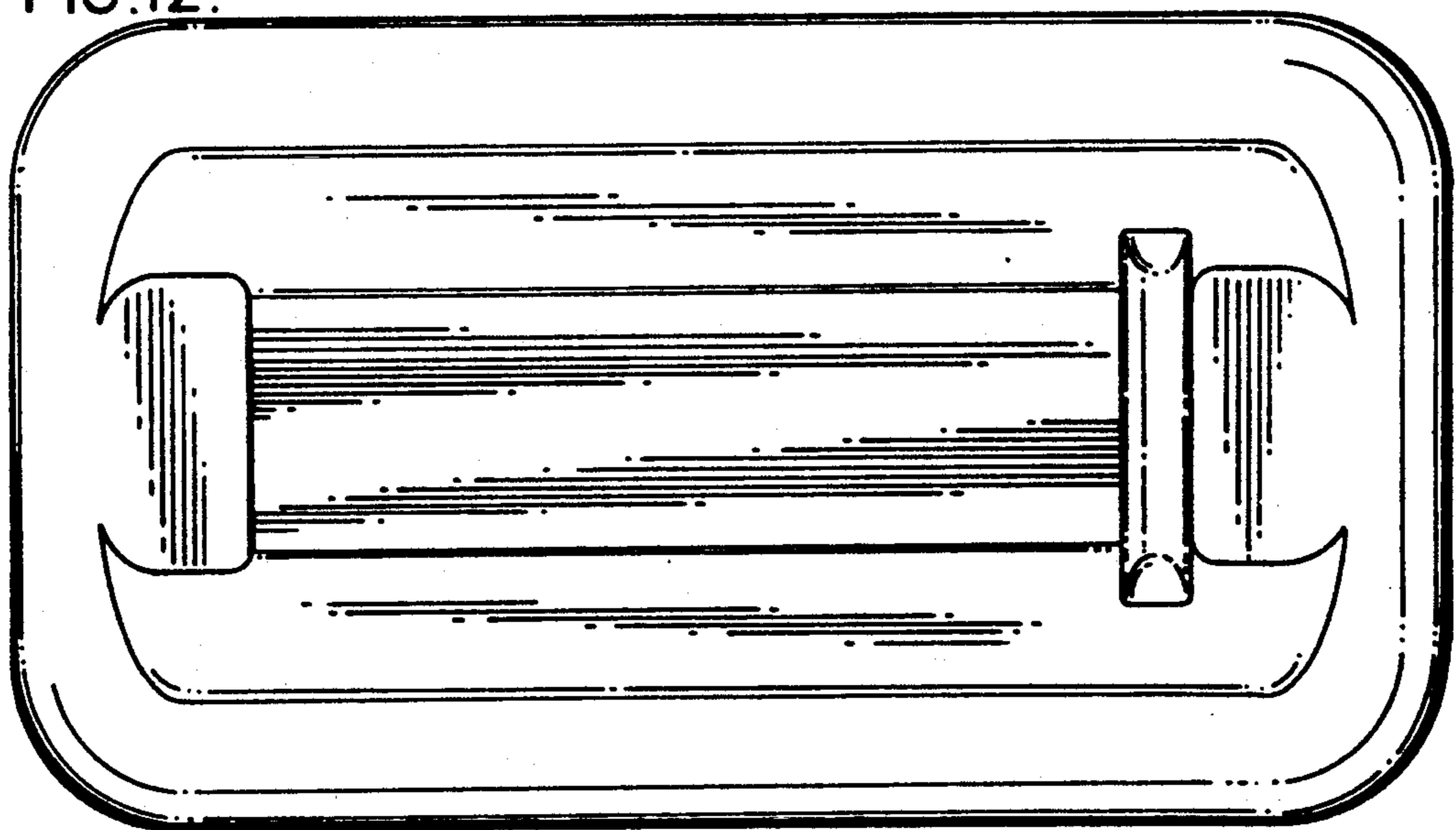

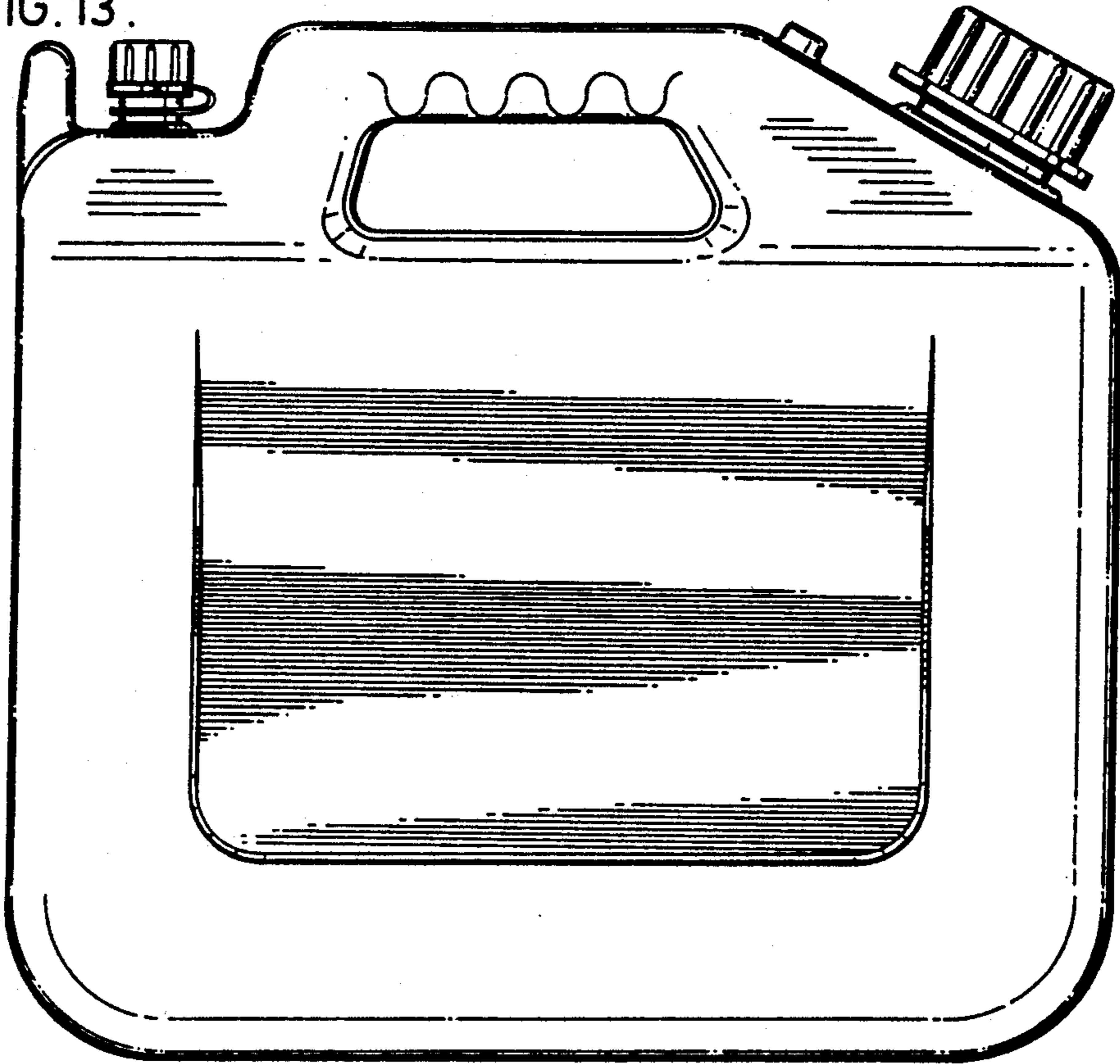

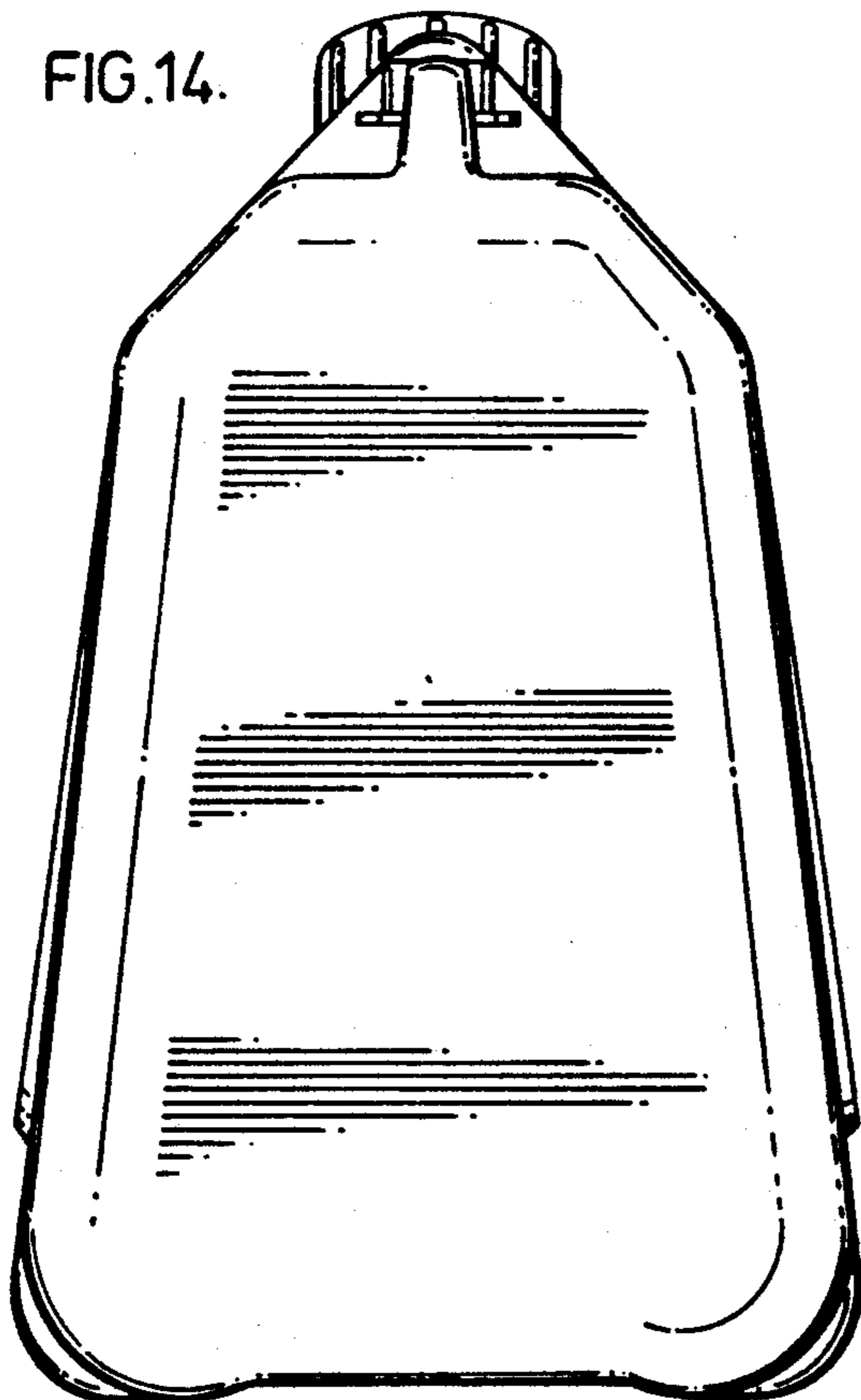

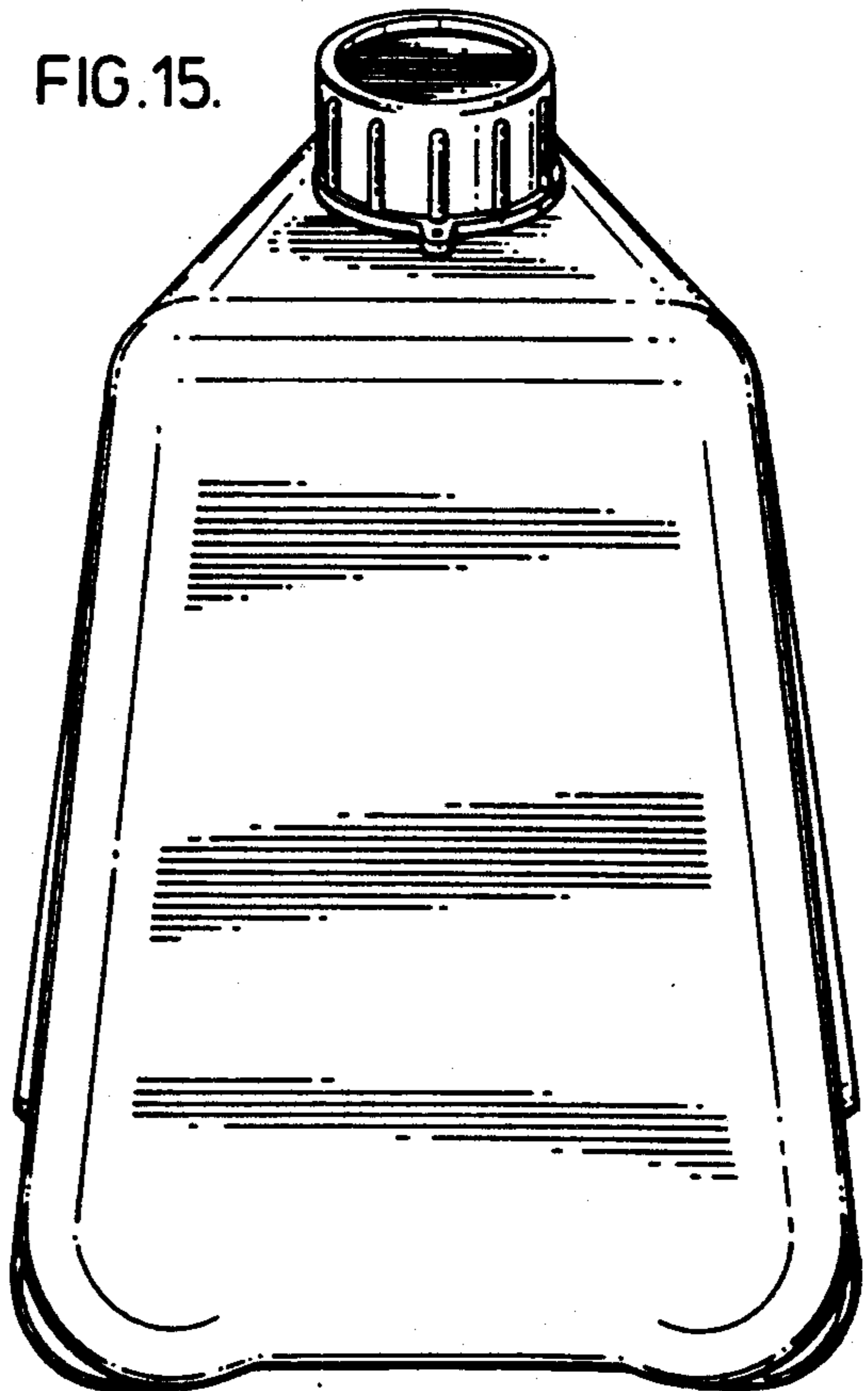

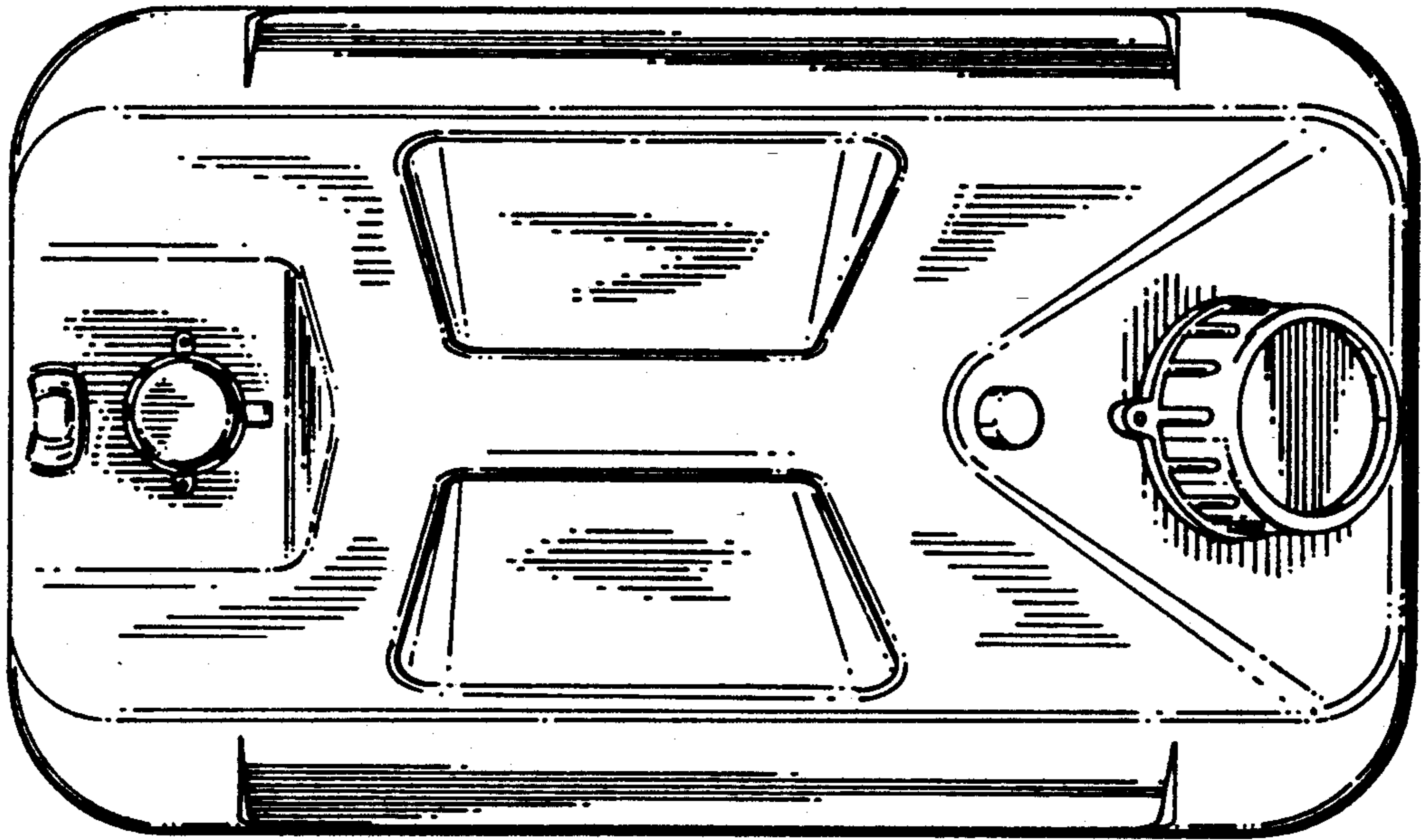

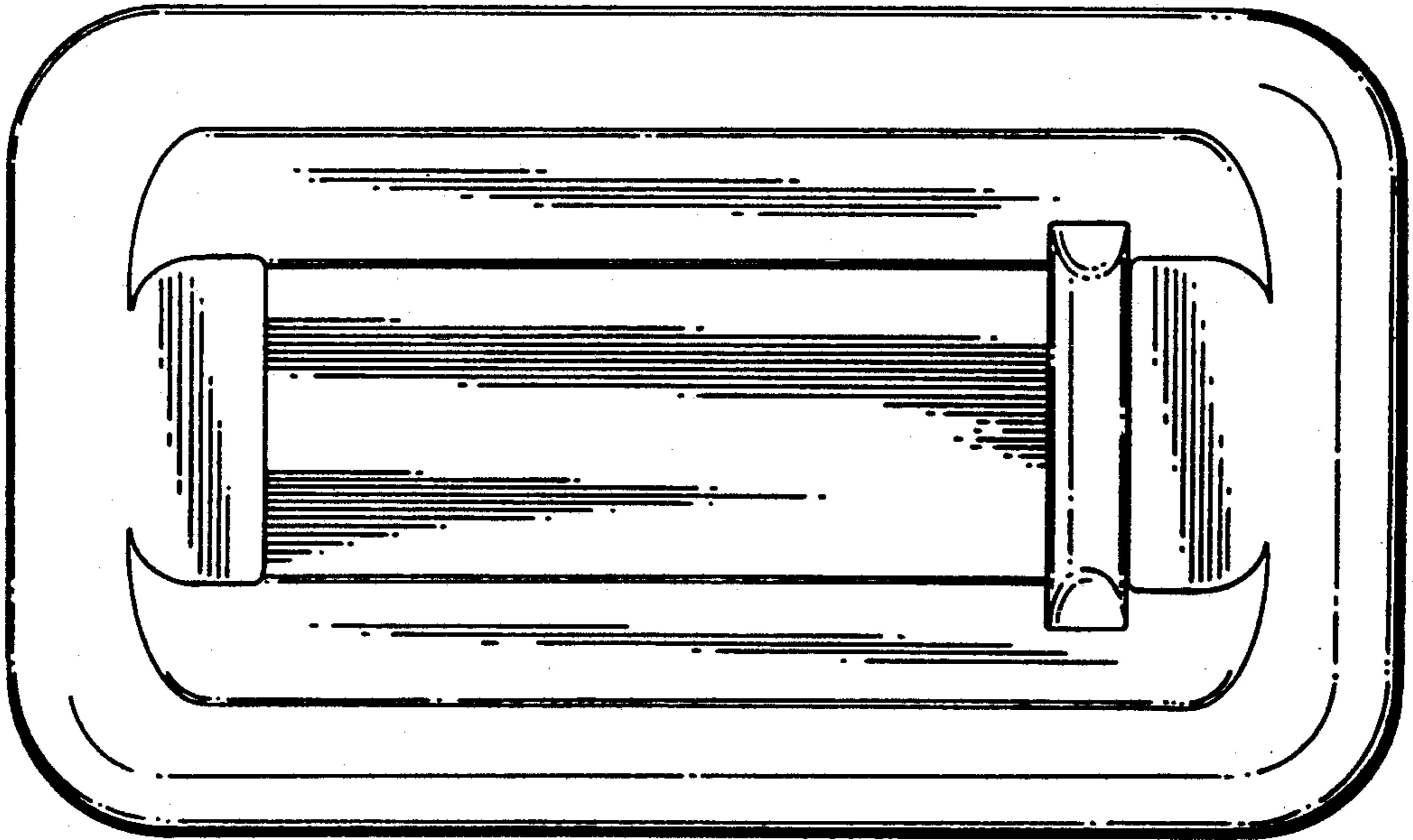

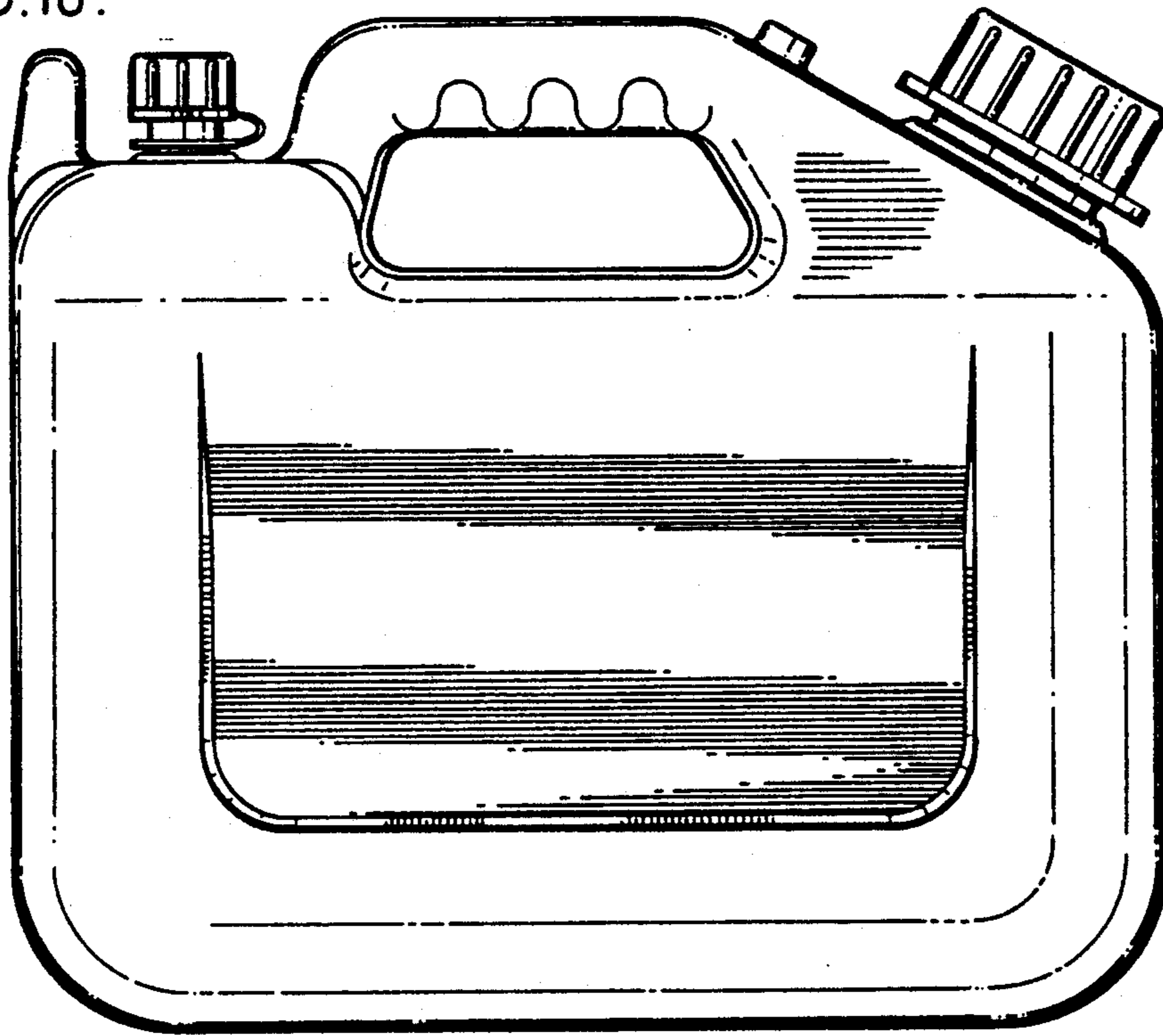

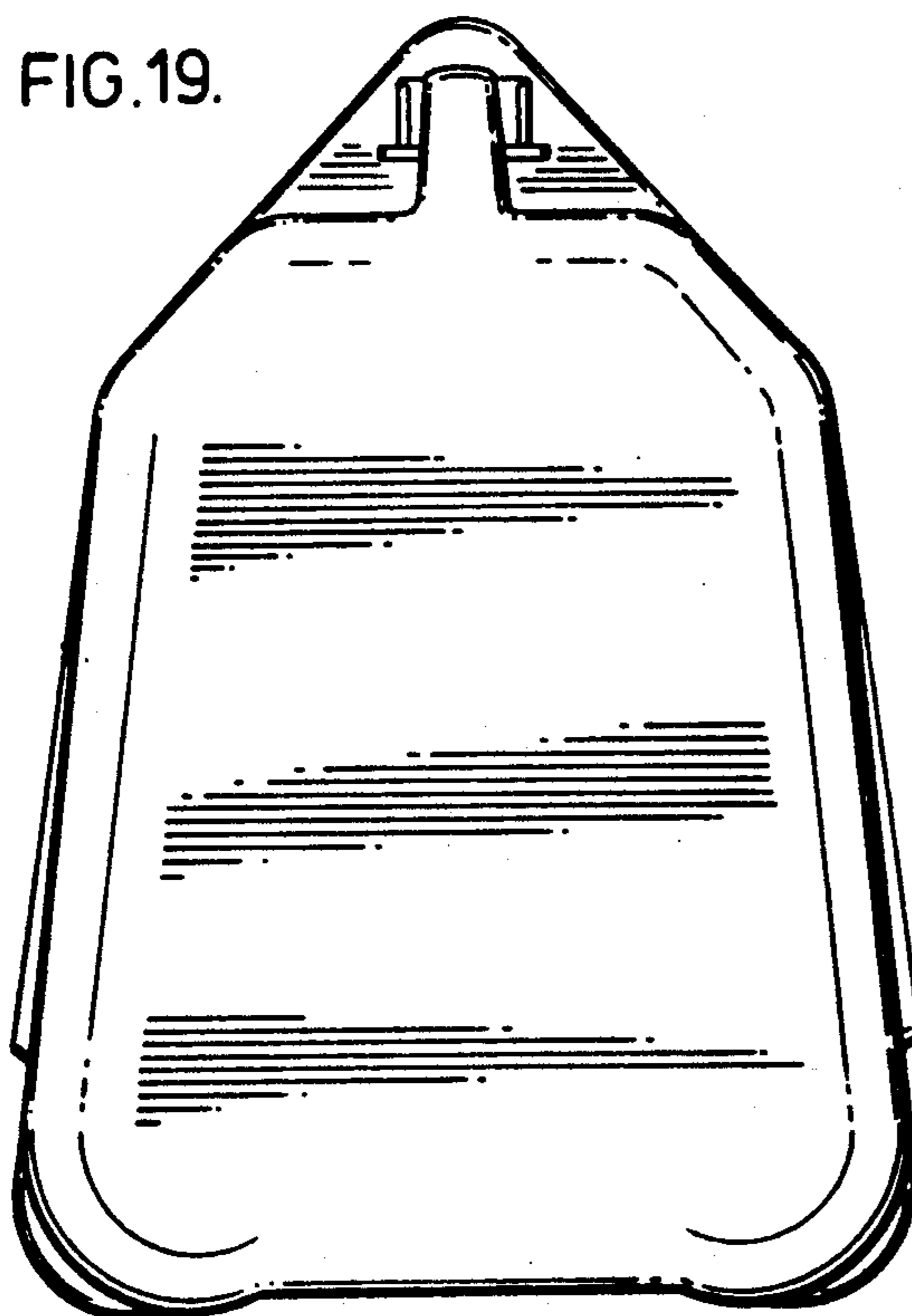

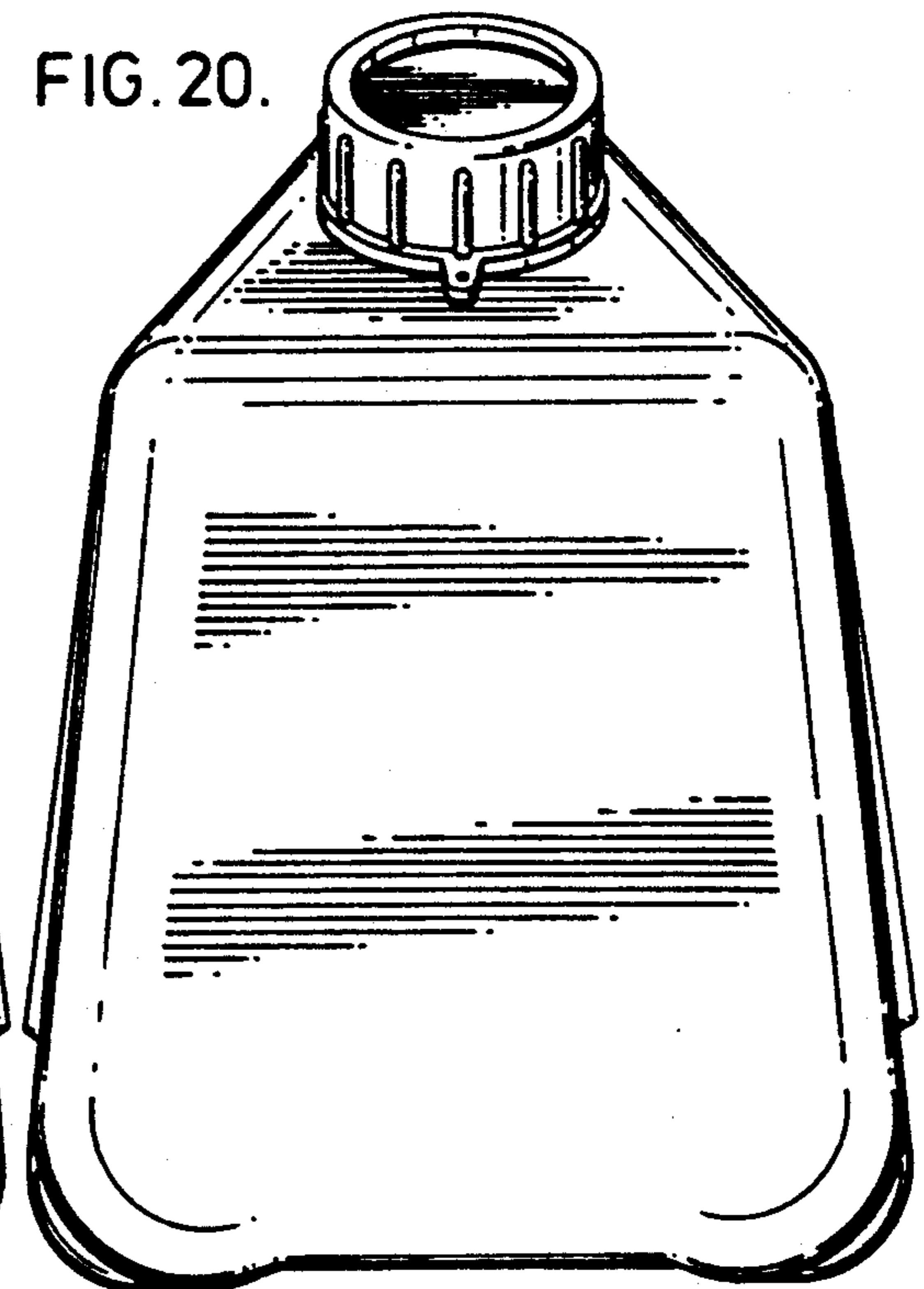

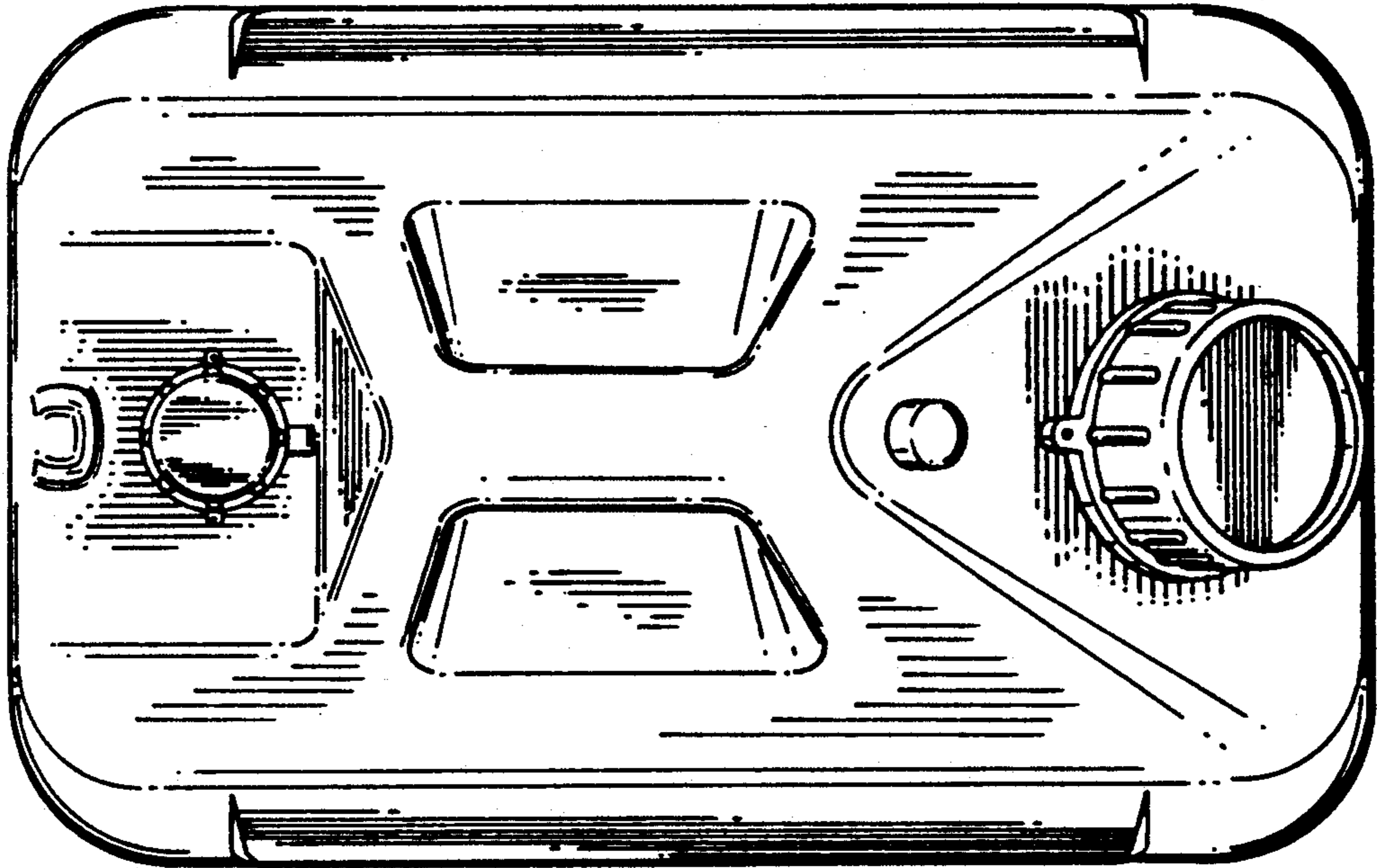

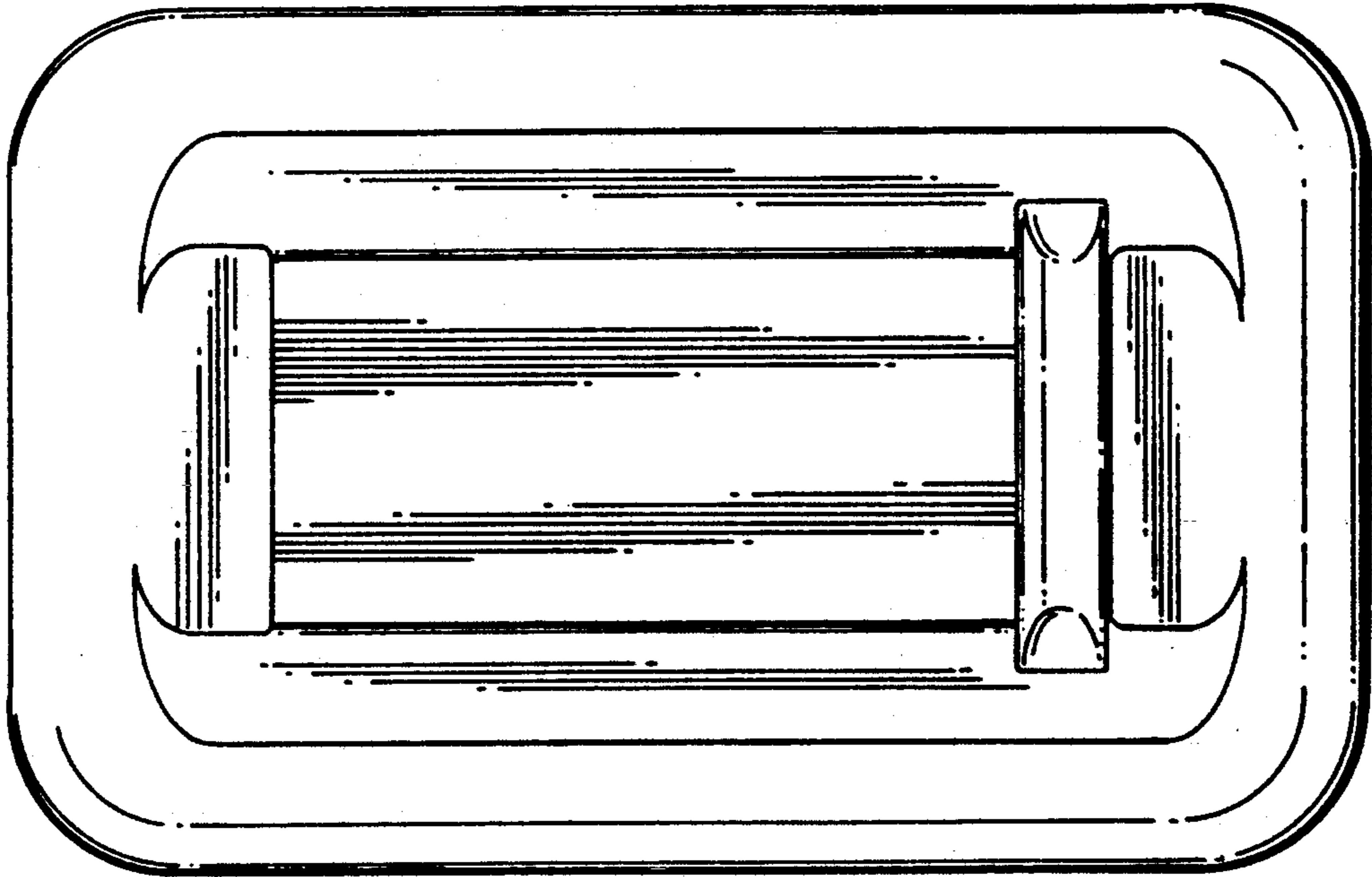

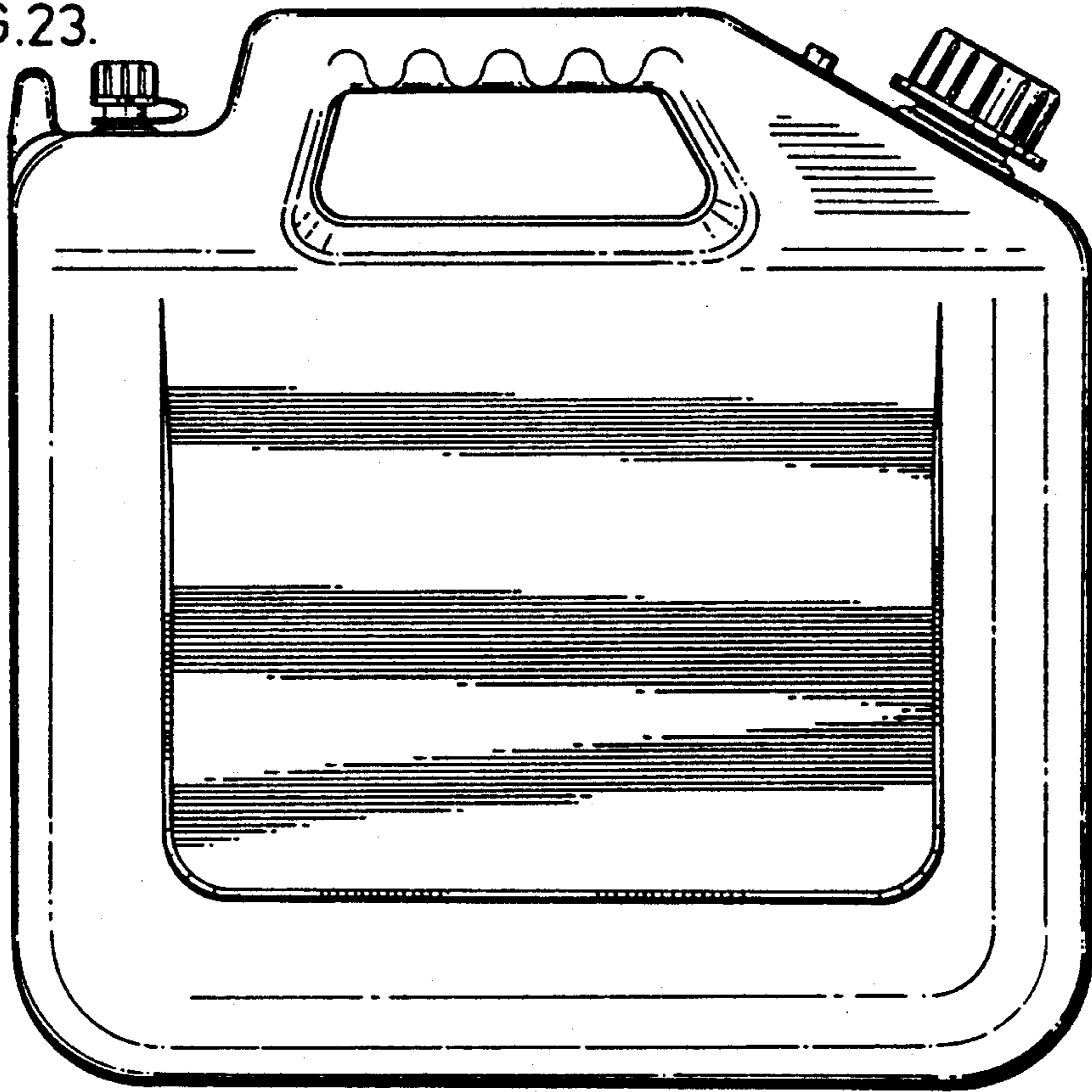

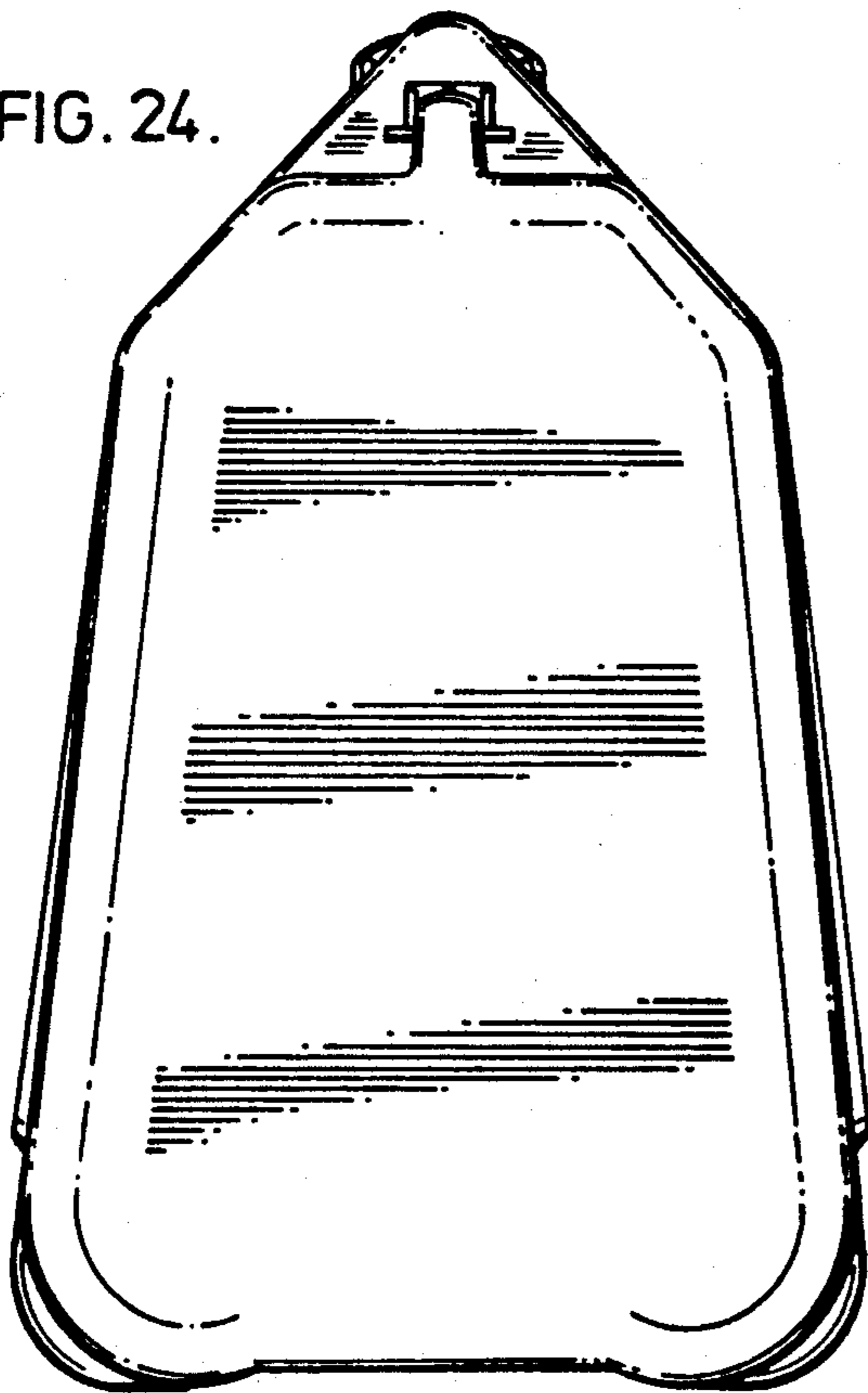

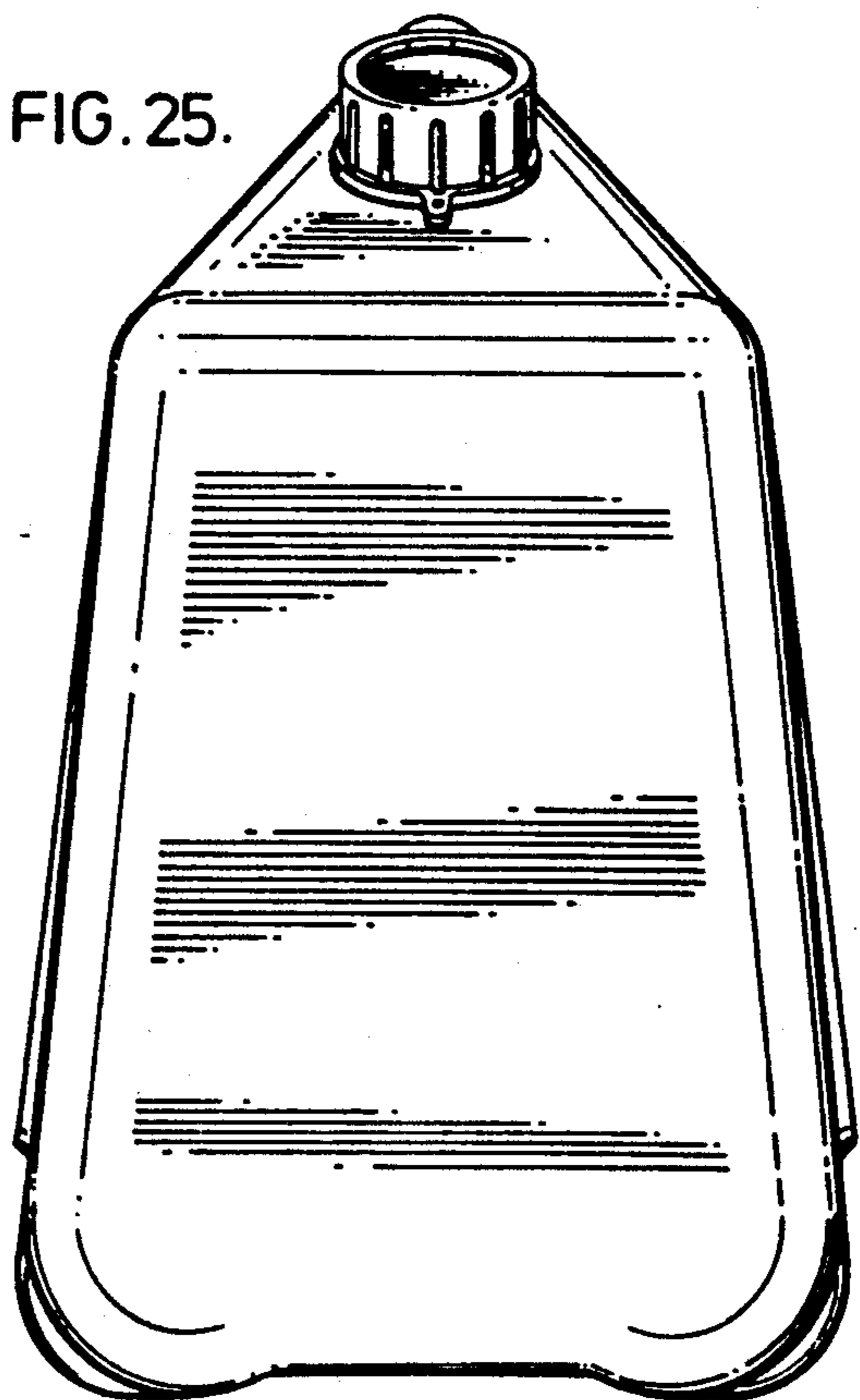

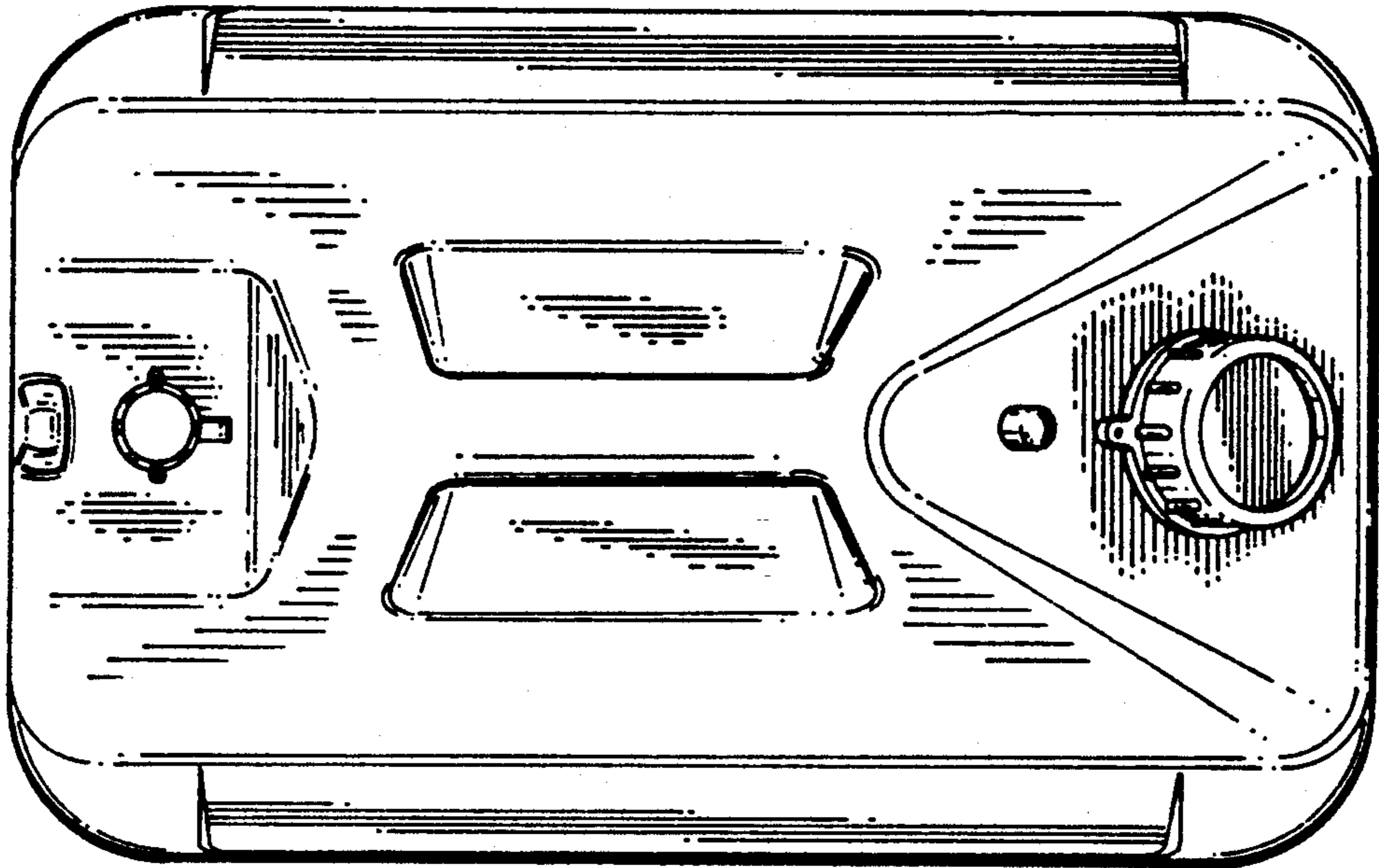
