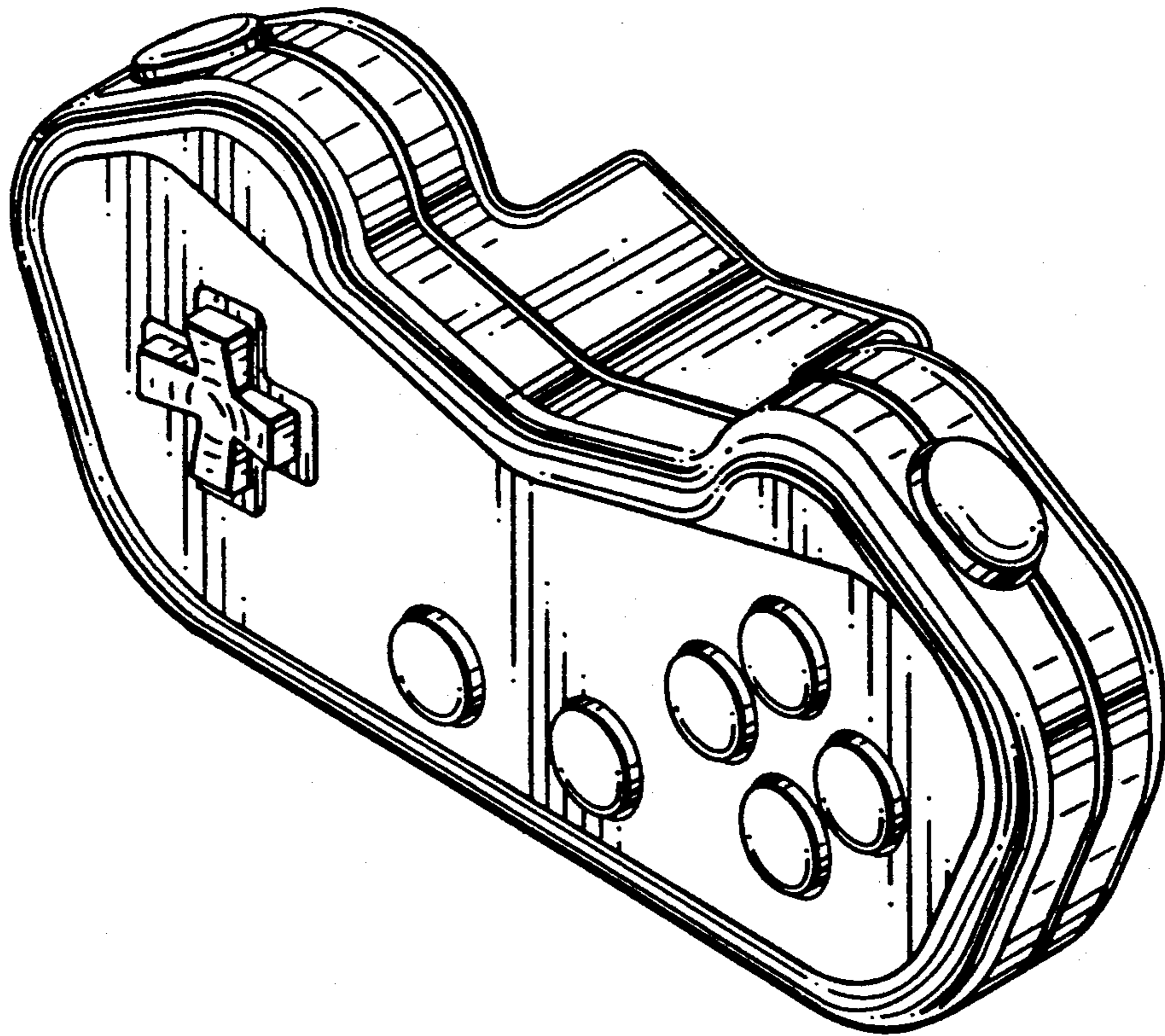

[57] CLAIM

The ornamental design for a video game control module, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a video game control module showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view of a second embodiment of FIG. 1;
FIG. 9 is a top plan view of FIG. 8;
FIG. 10 is a front elevational view of FIG. 8;
FIG. 11 is a right side elevational view of FIG. 8;
FIG. 12 is a rear elevational view of FIG. 8;
FIG. 13 is a left side elevational view of FIG. 8;
FIG. 14 is a bottom plan view of FIG. 8; and,
FIG. 15 is a reduced scale perspective view of FIG. 1 shown in its environmental use for clarity of illustration. The broken line showing of a video game machine and another video game control module is for illustrative purpose only and forms no part of the claim.



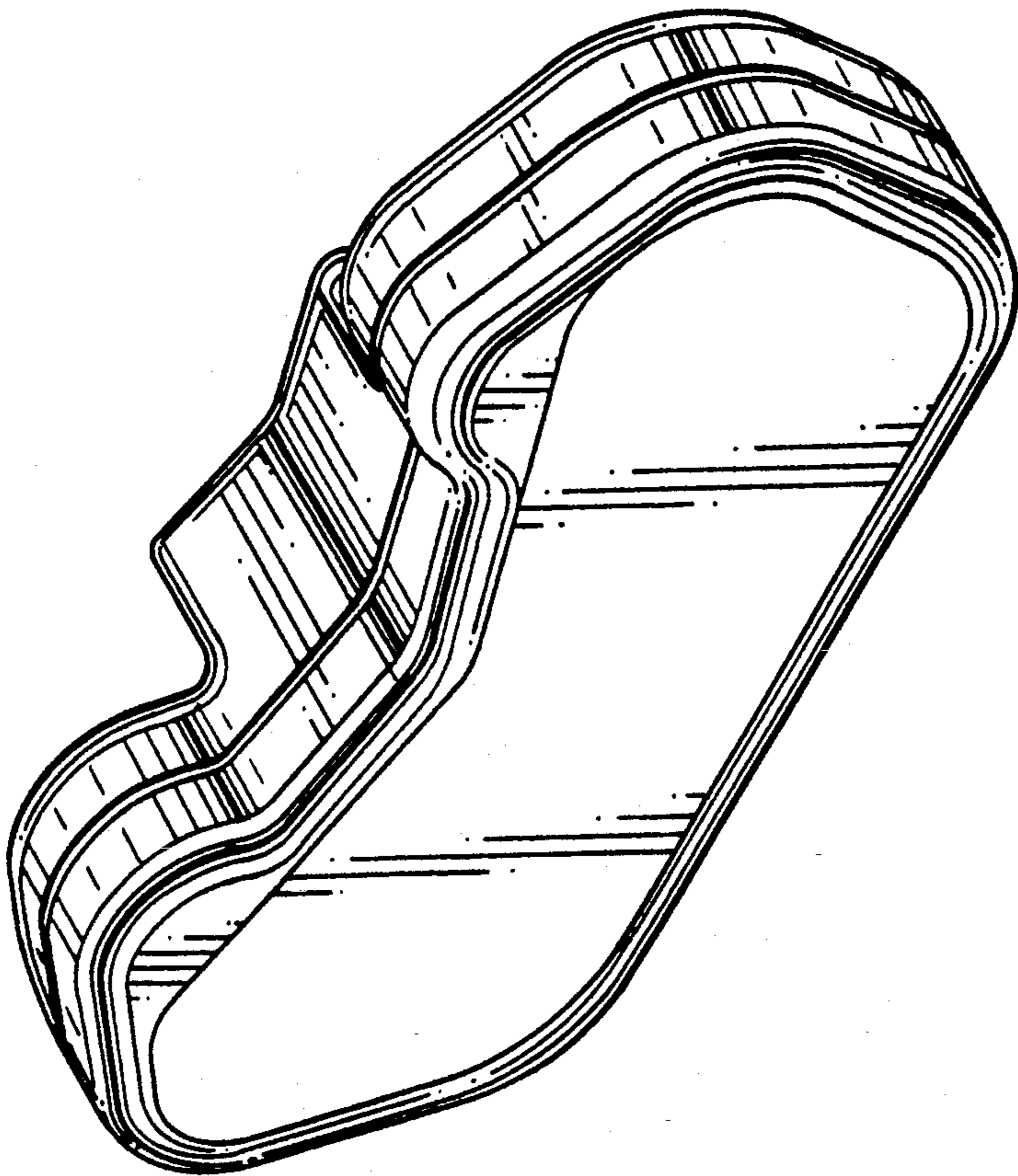

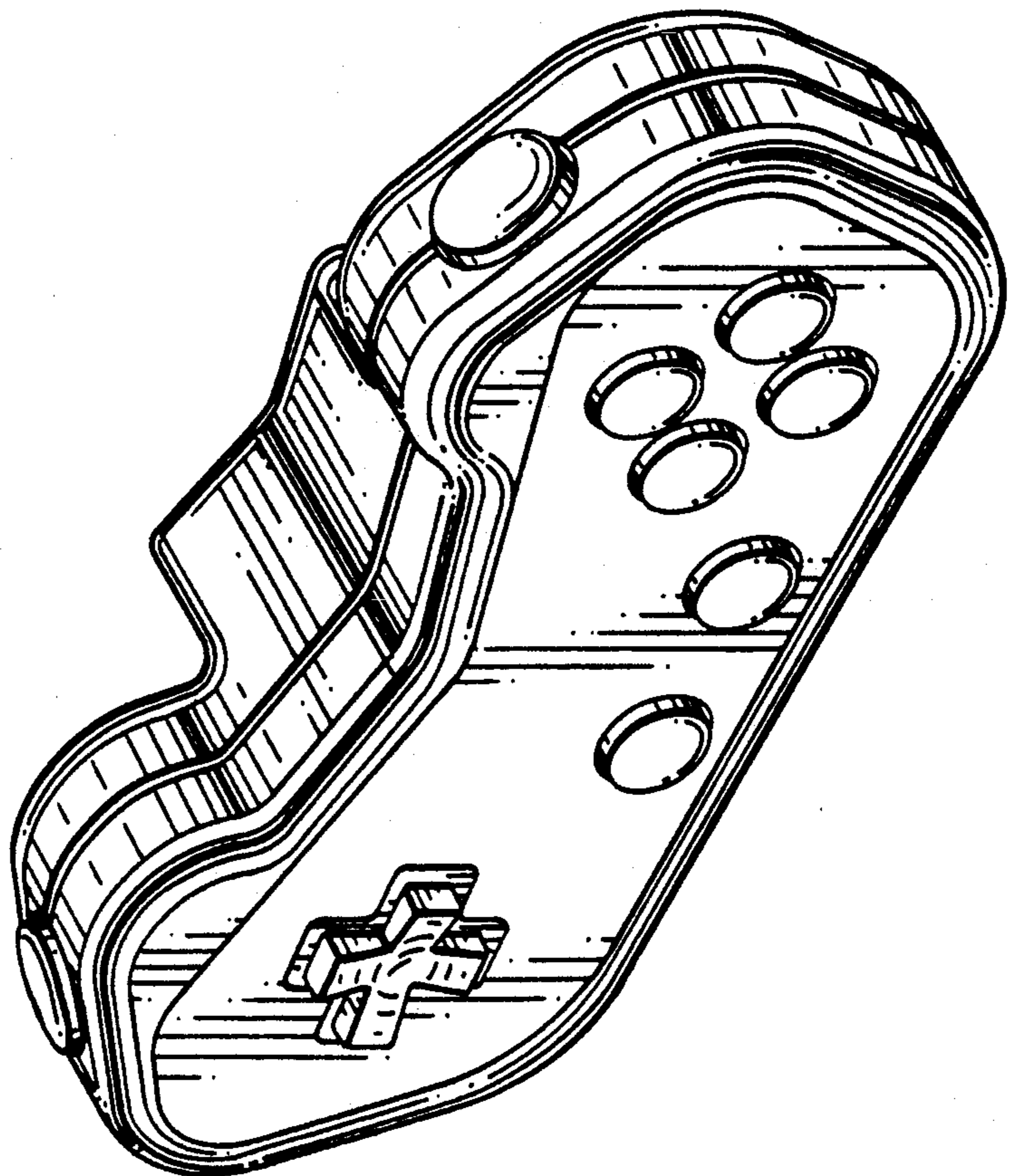

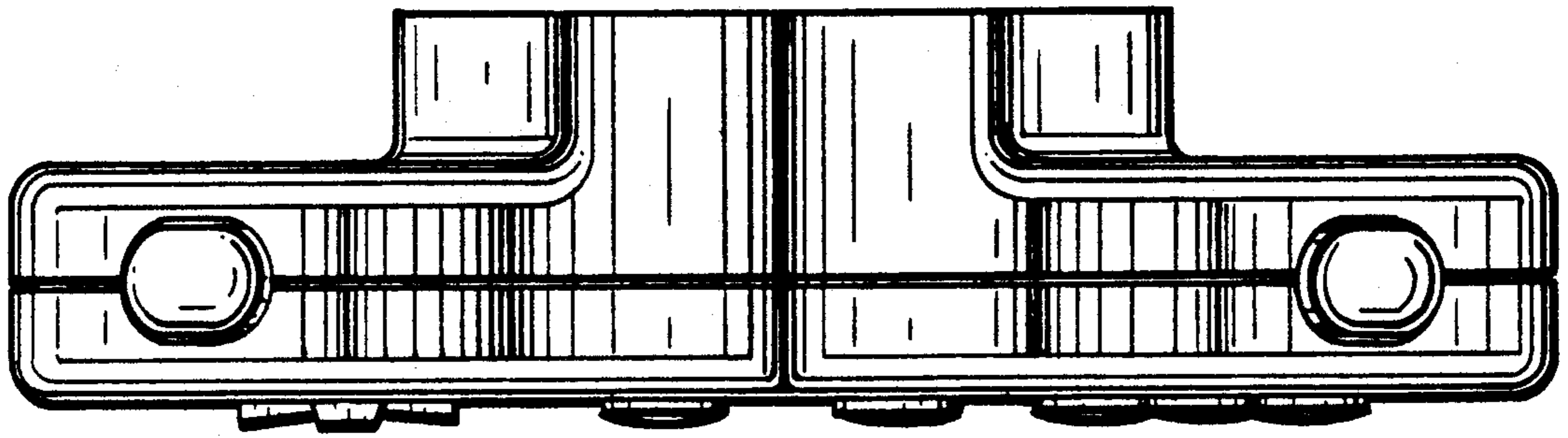

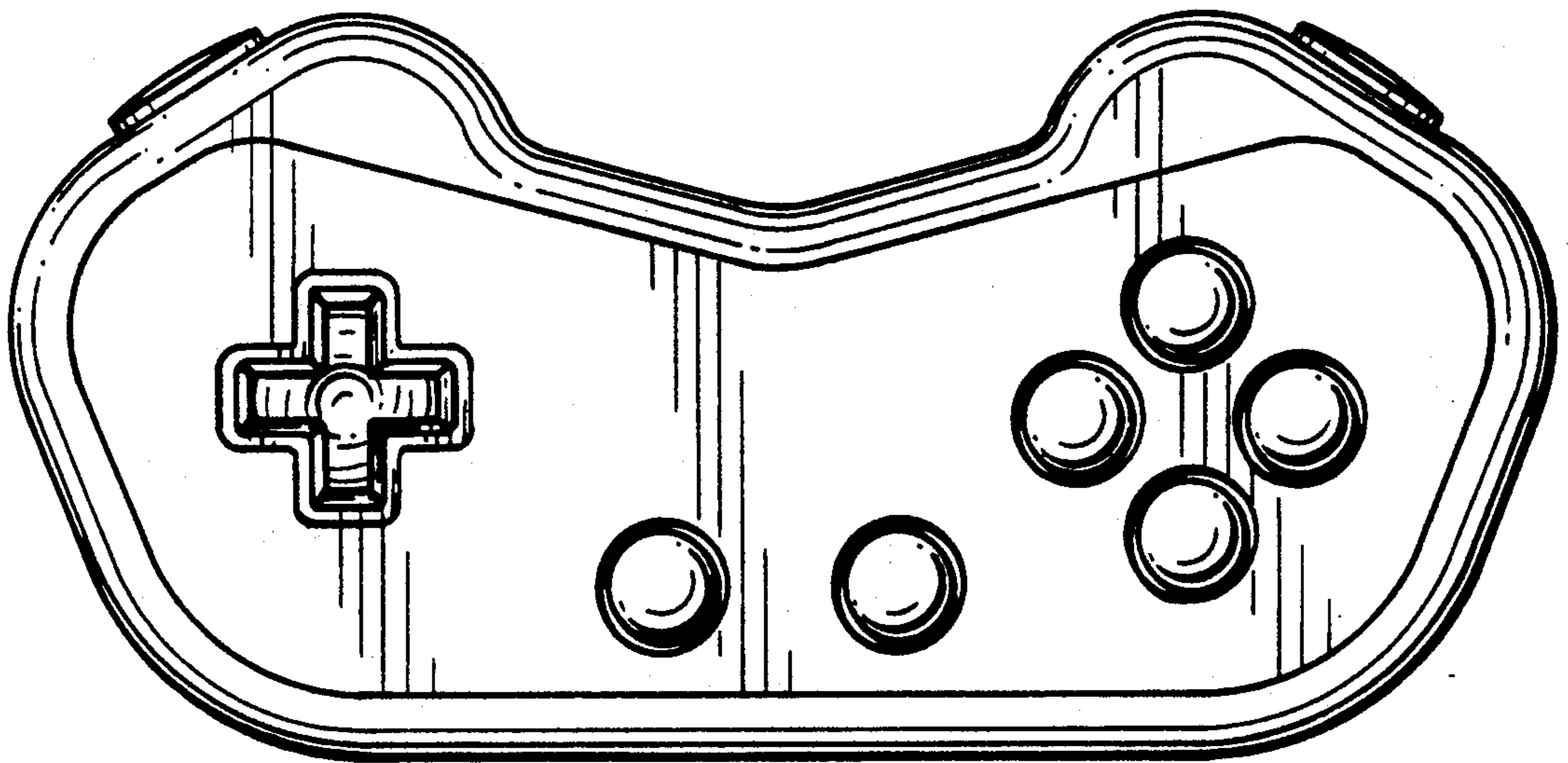

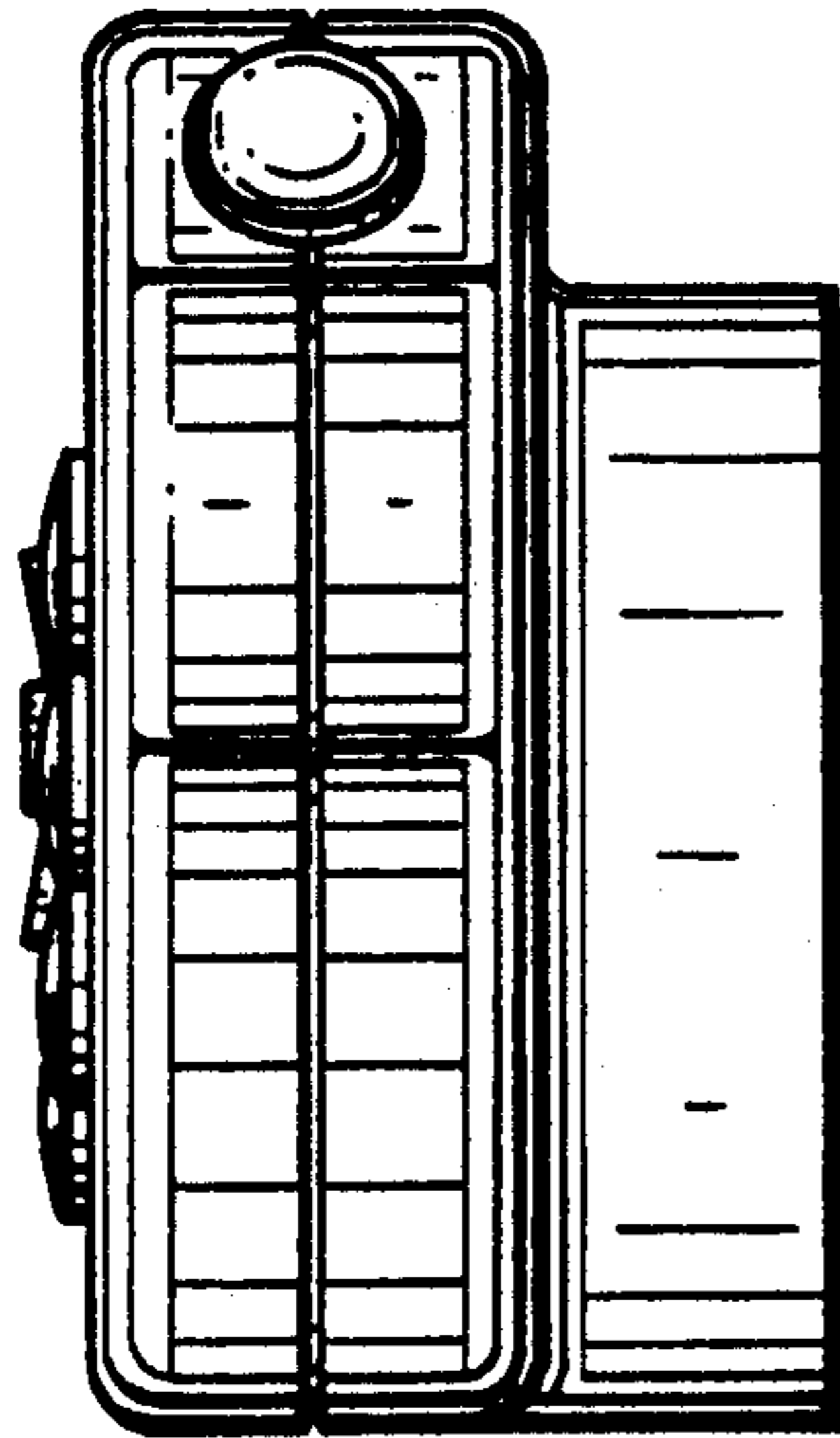

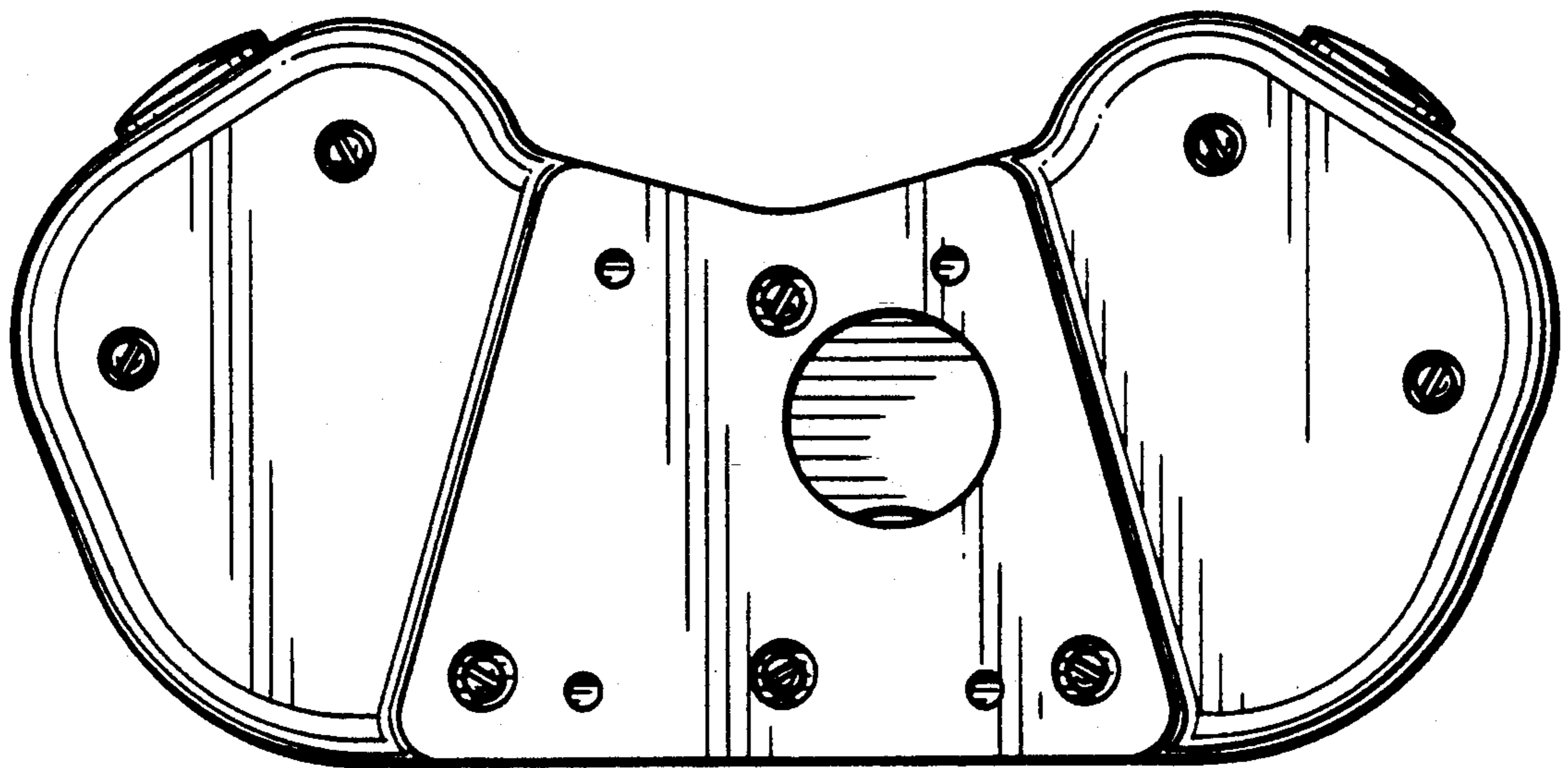
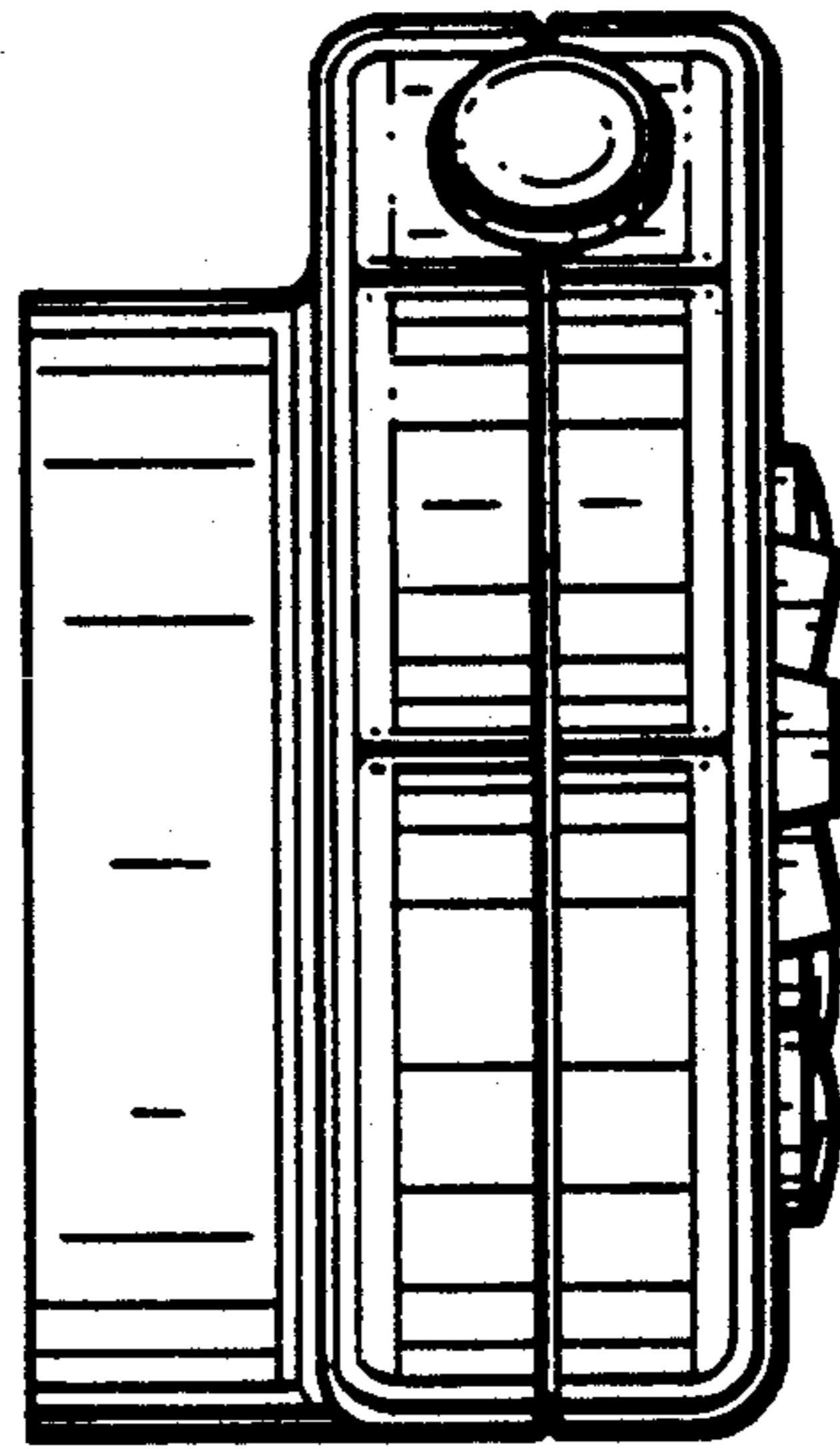

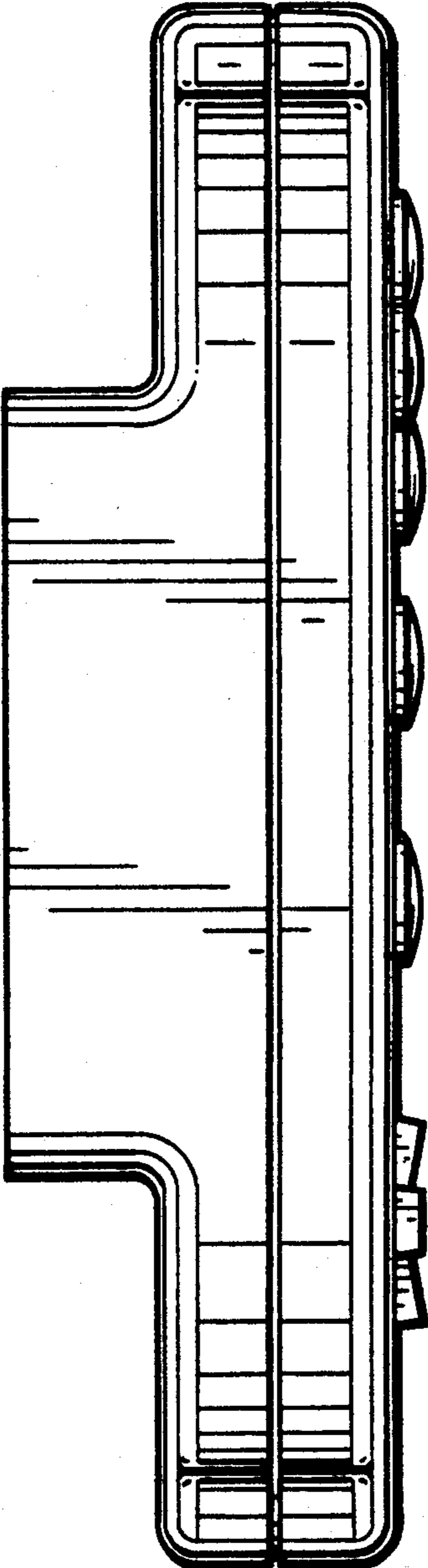

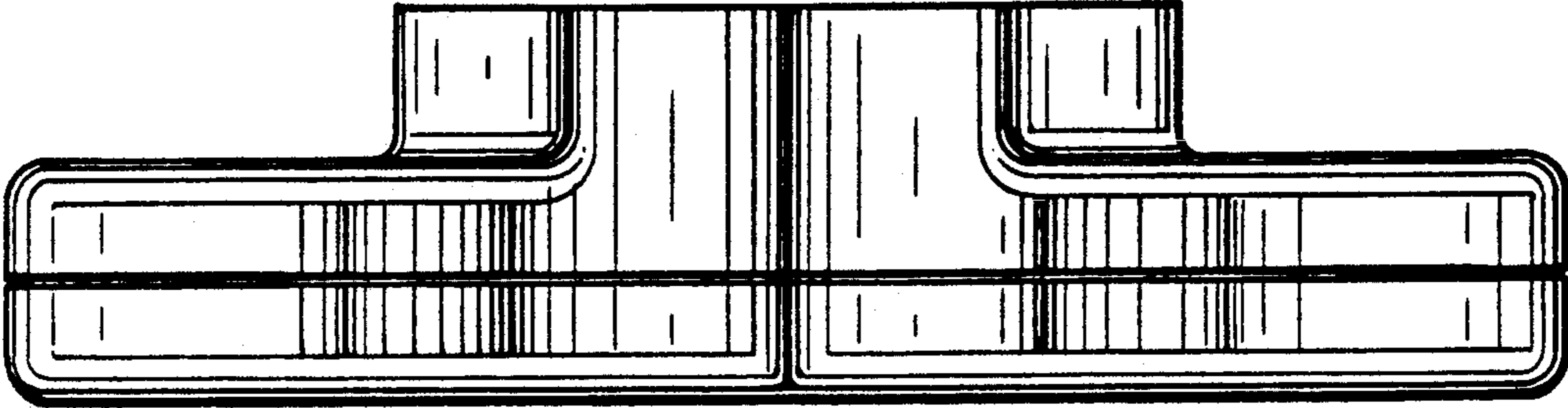

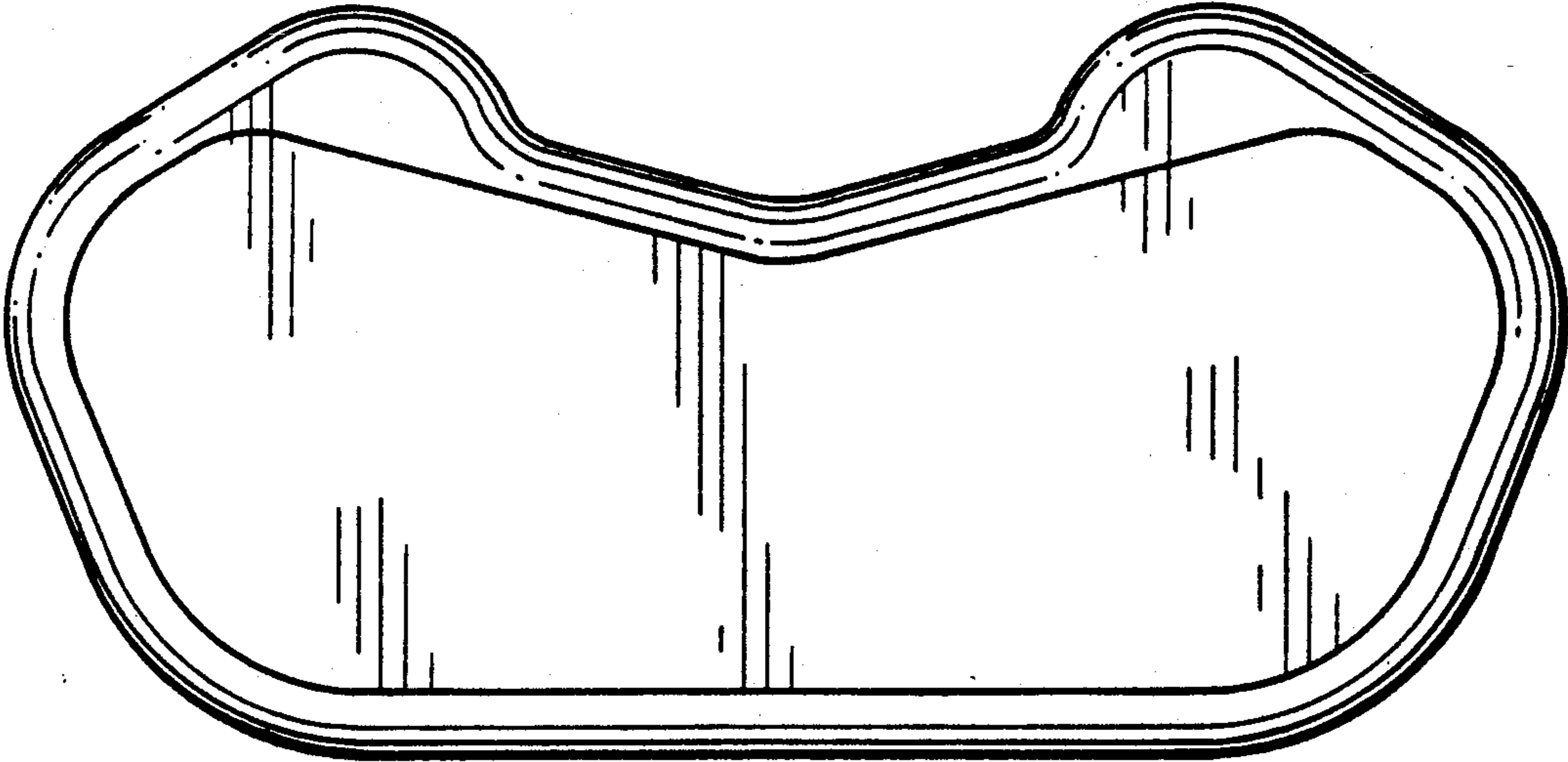

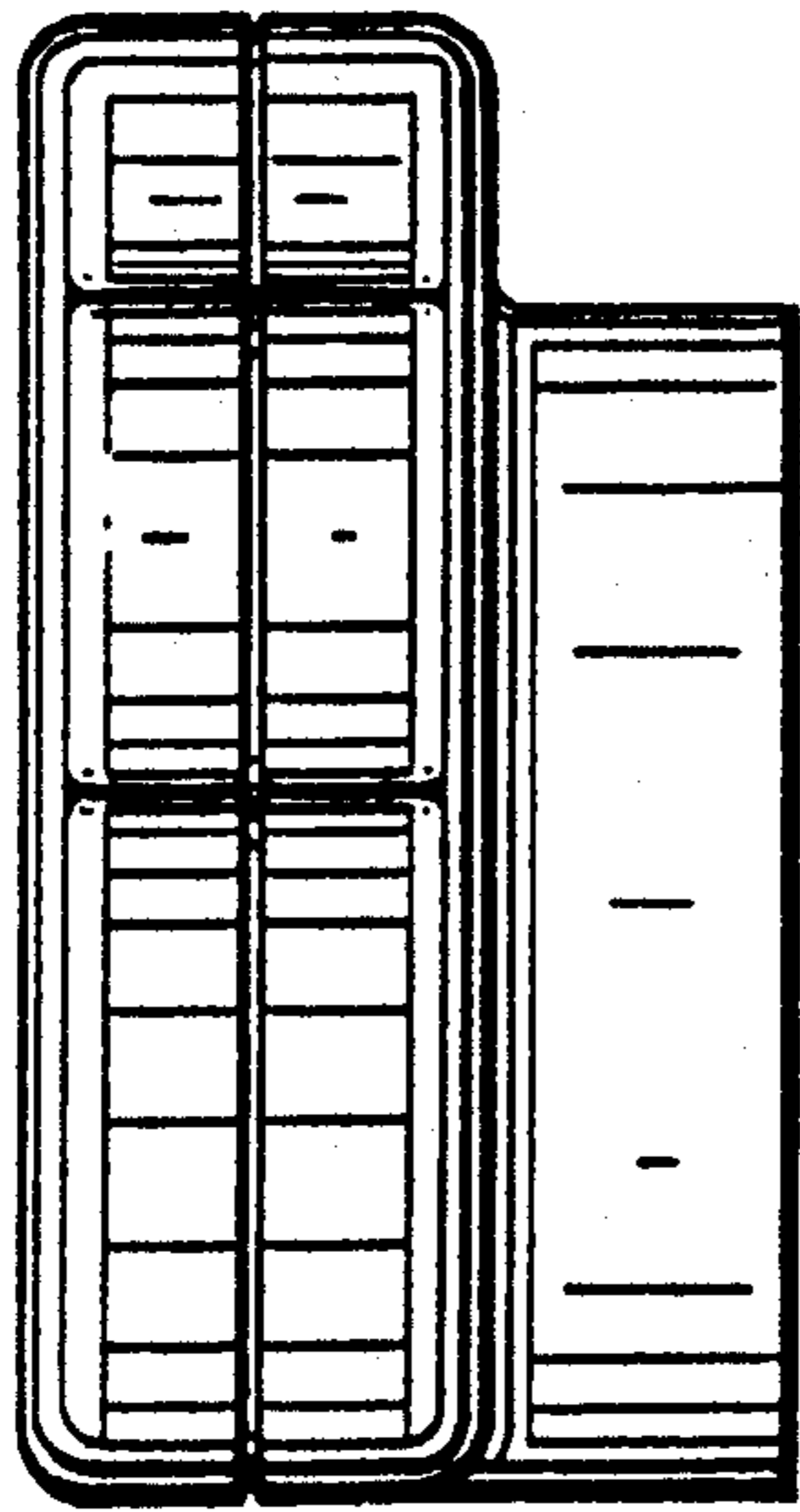

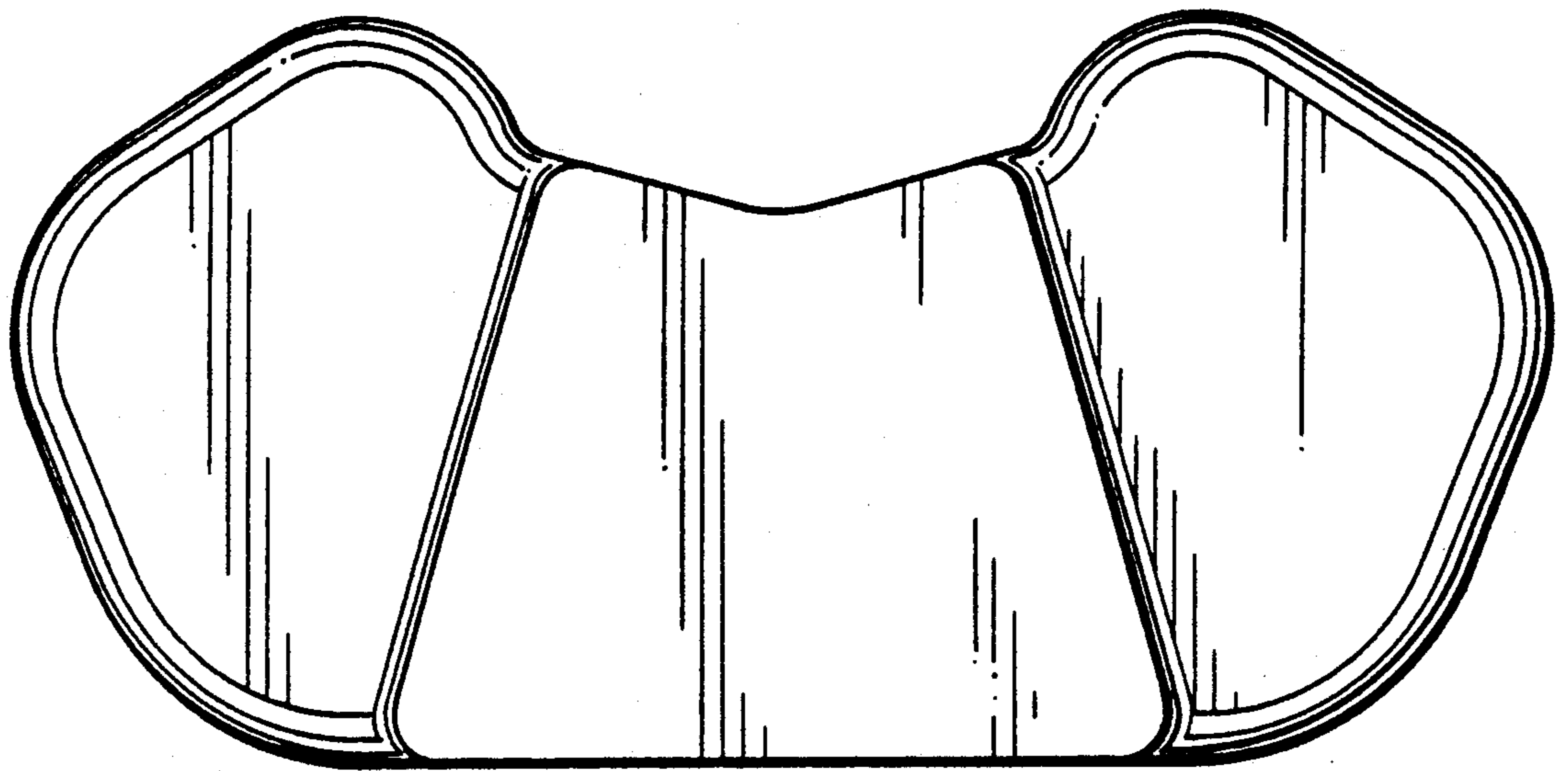
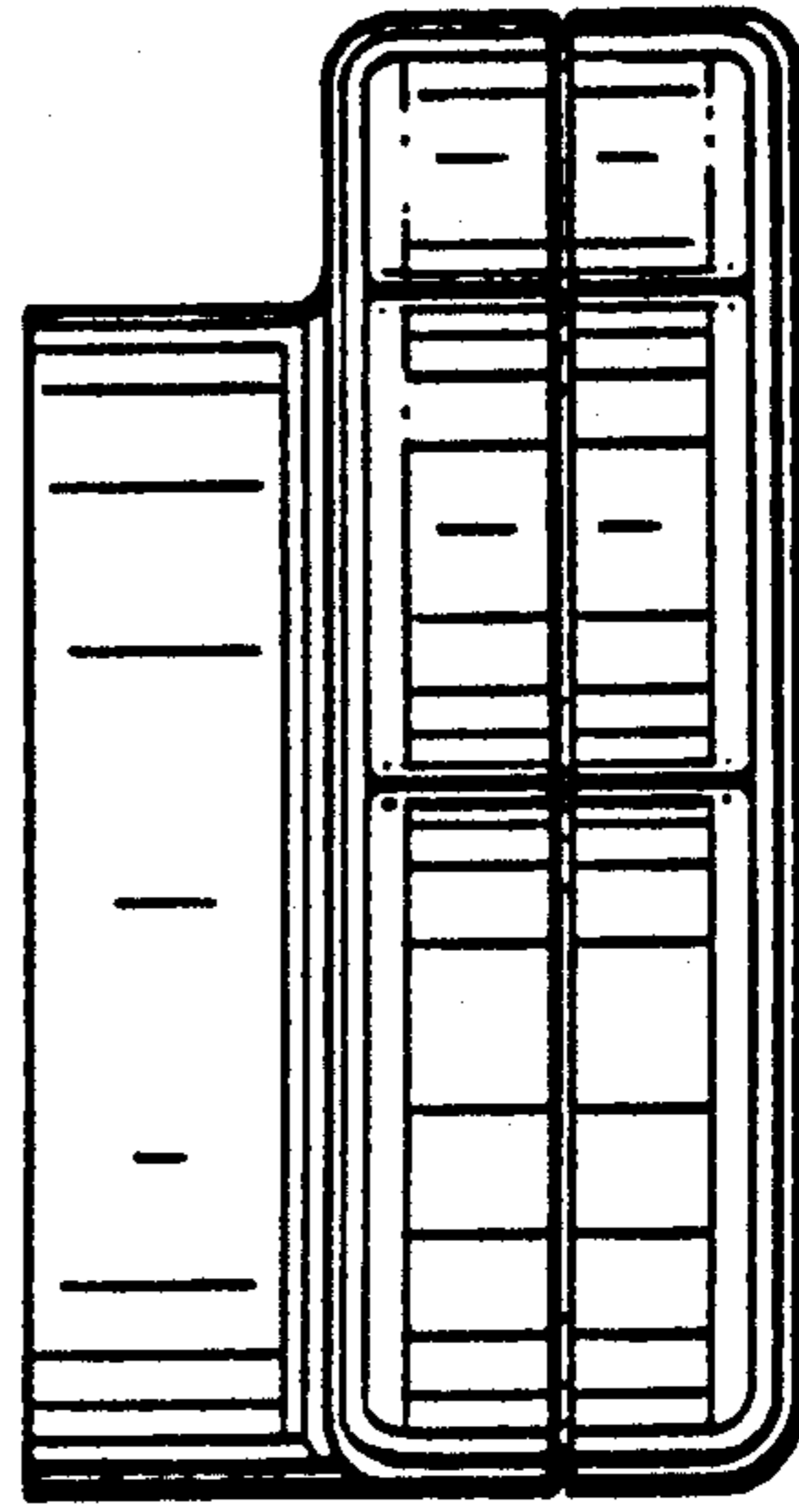

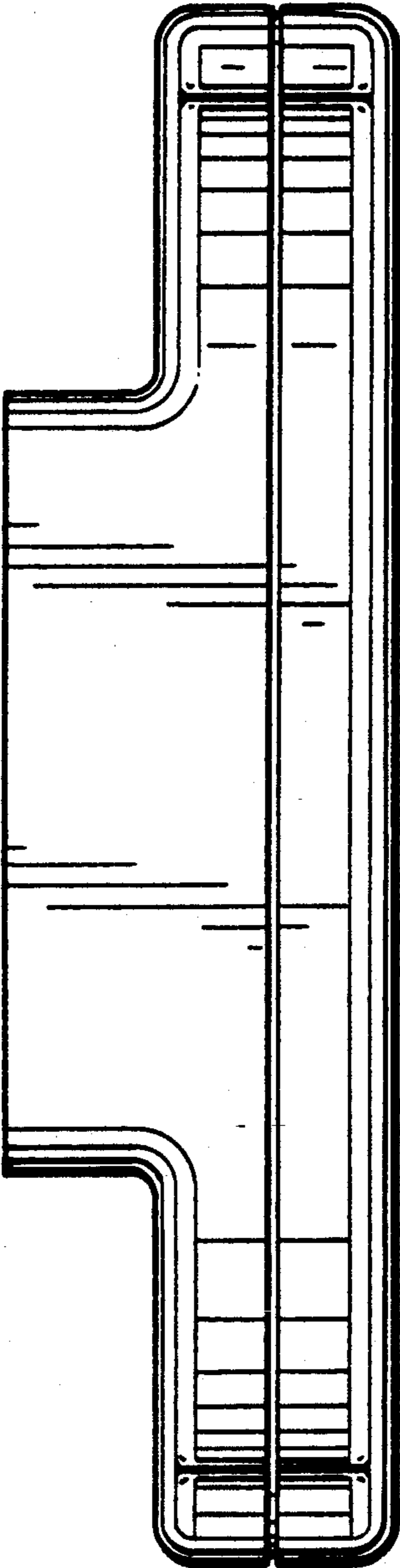
