[57] CLAIM

The ornamental design for a forefoot strap for a sandal, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one side of the forefoot strap for a sandal showing our new design;

FIG. 2 is a side elevational view of the other side of the forefoot strap shown in FIG. 1;

FIG. 3 is a top plan view of the forefoot strap shown in FIG. 1;

FIG. 4 is a front elevational view of the forefoot strap shown in FIG. 1; and,

FIG. 5 is a rear elevational view of the forefoot strap shown in FIG. 1.

The broken line showing of a sole periphery and the remaining parts of the sandal in FIGS. 1-5 are for illustrative purposes and form no part of the claimed design.

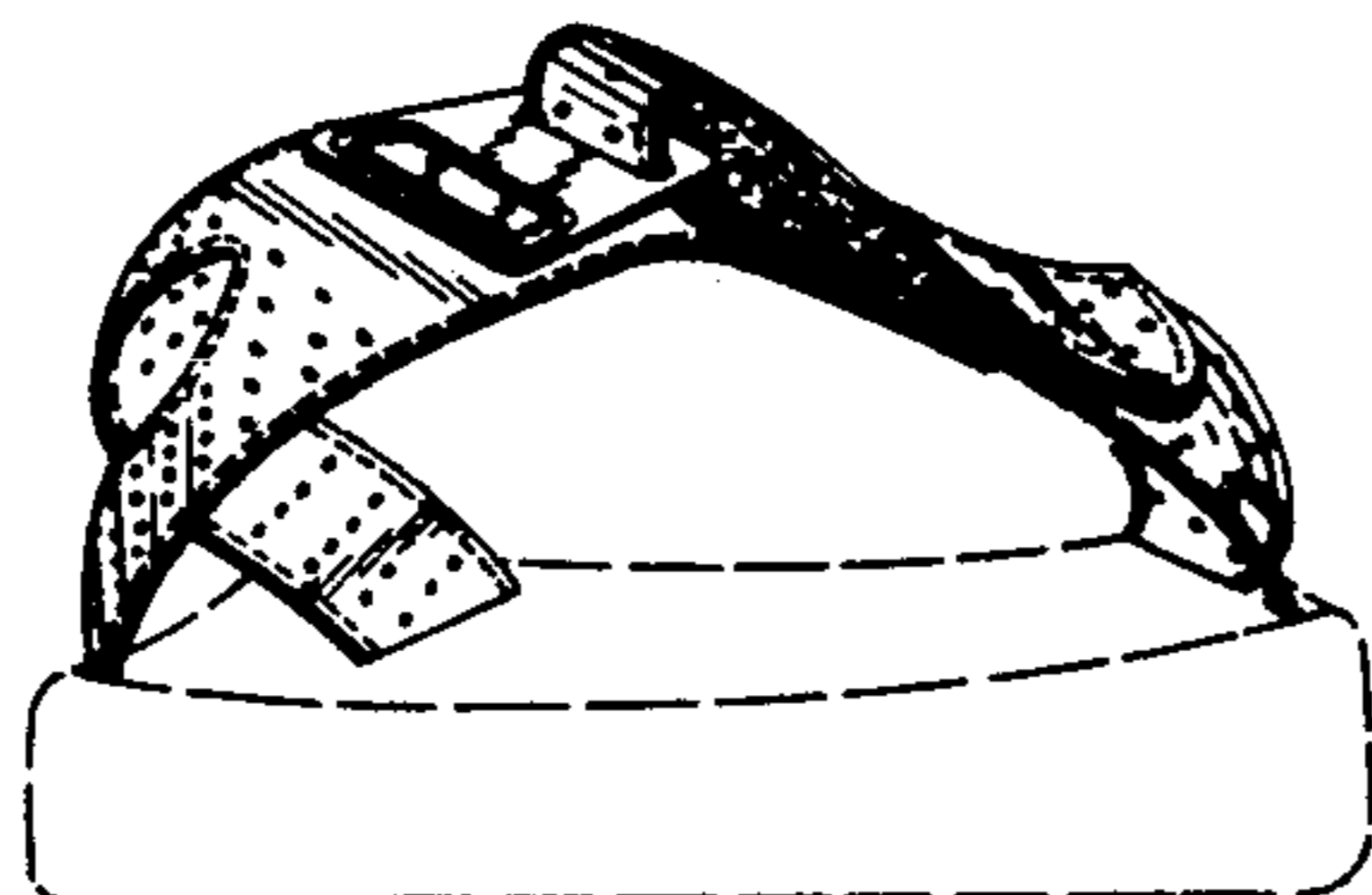
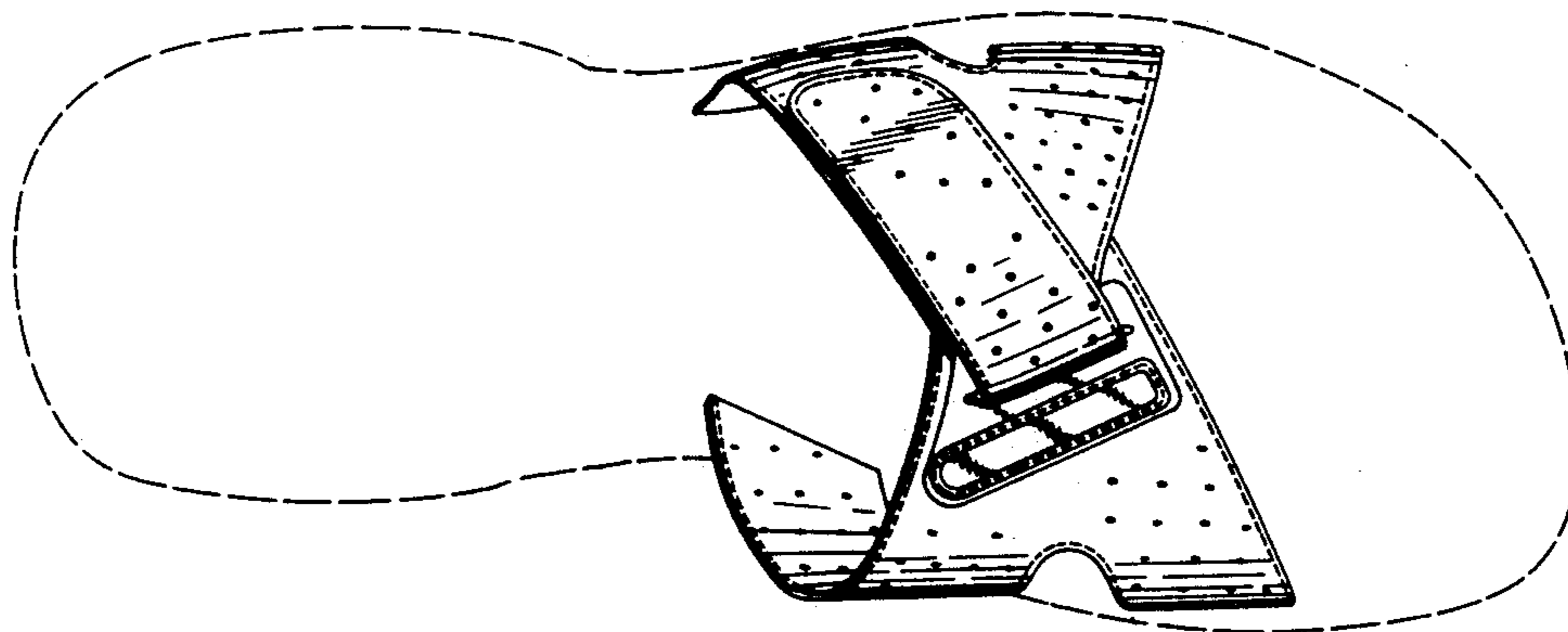

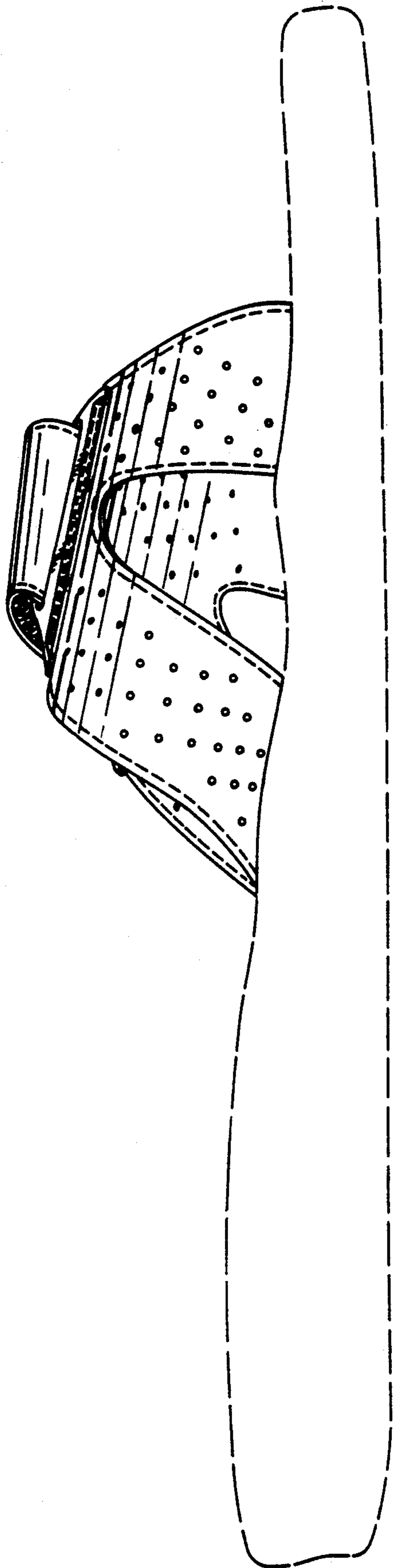

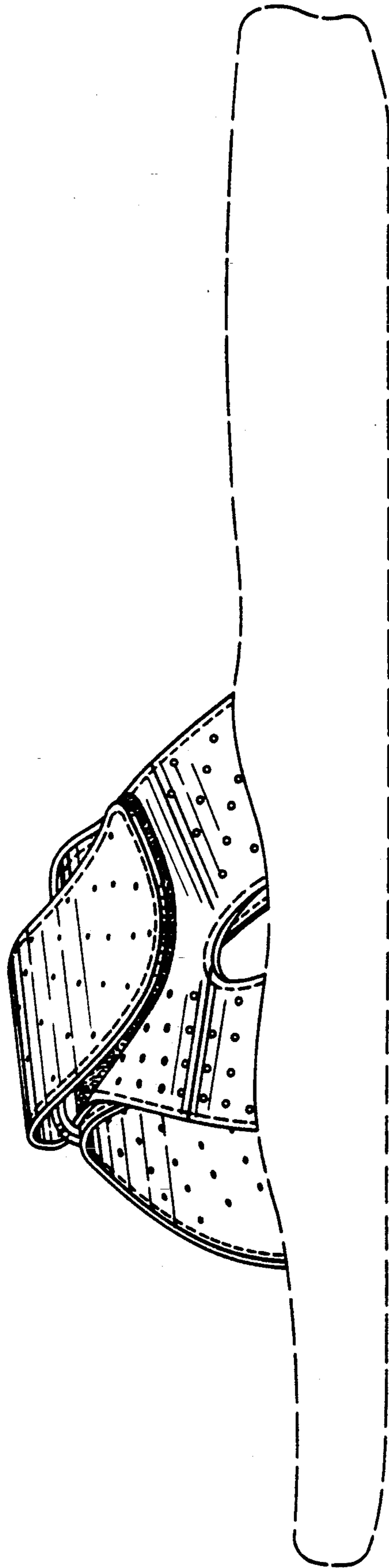

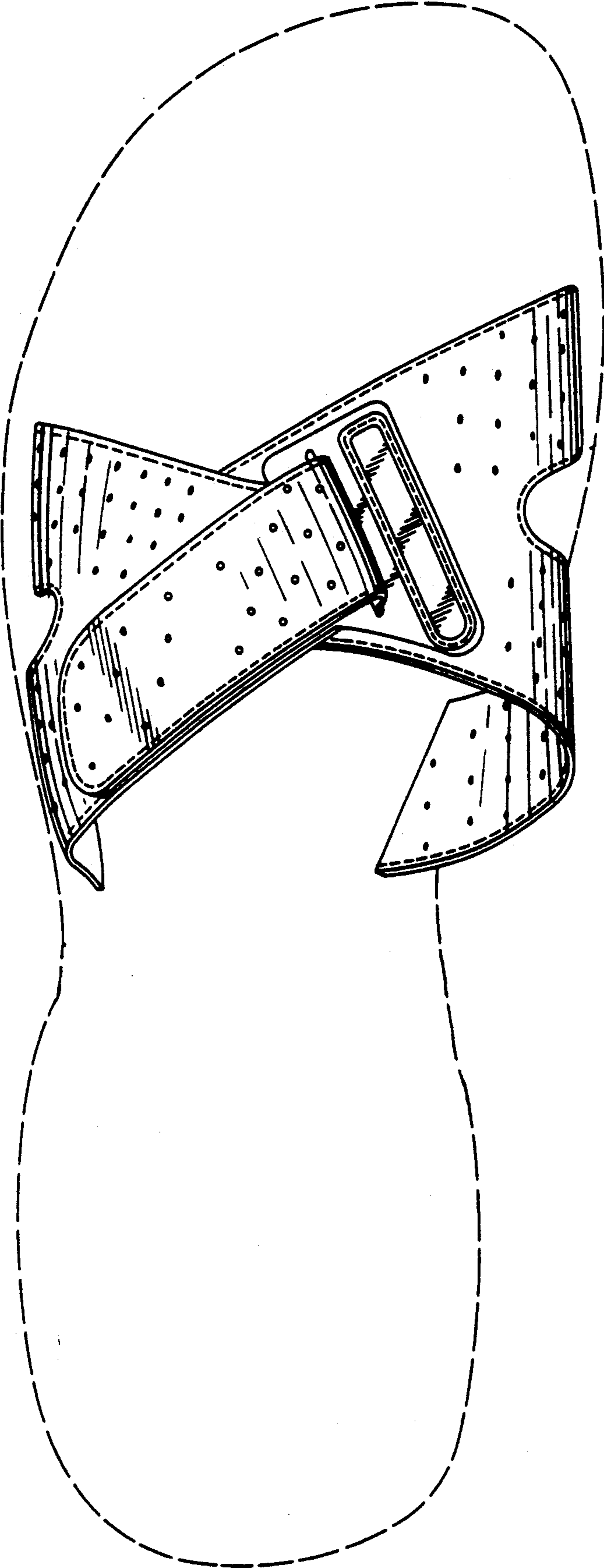

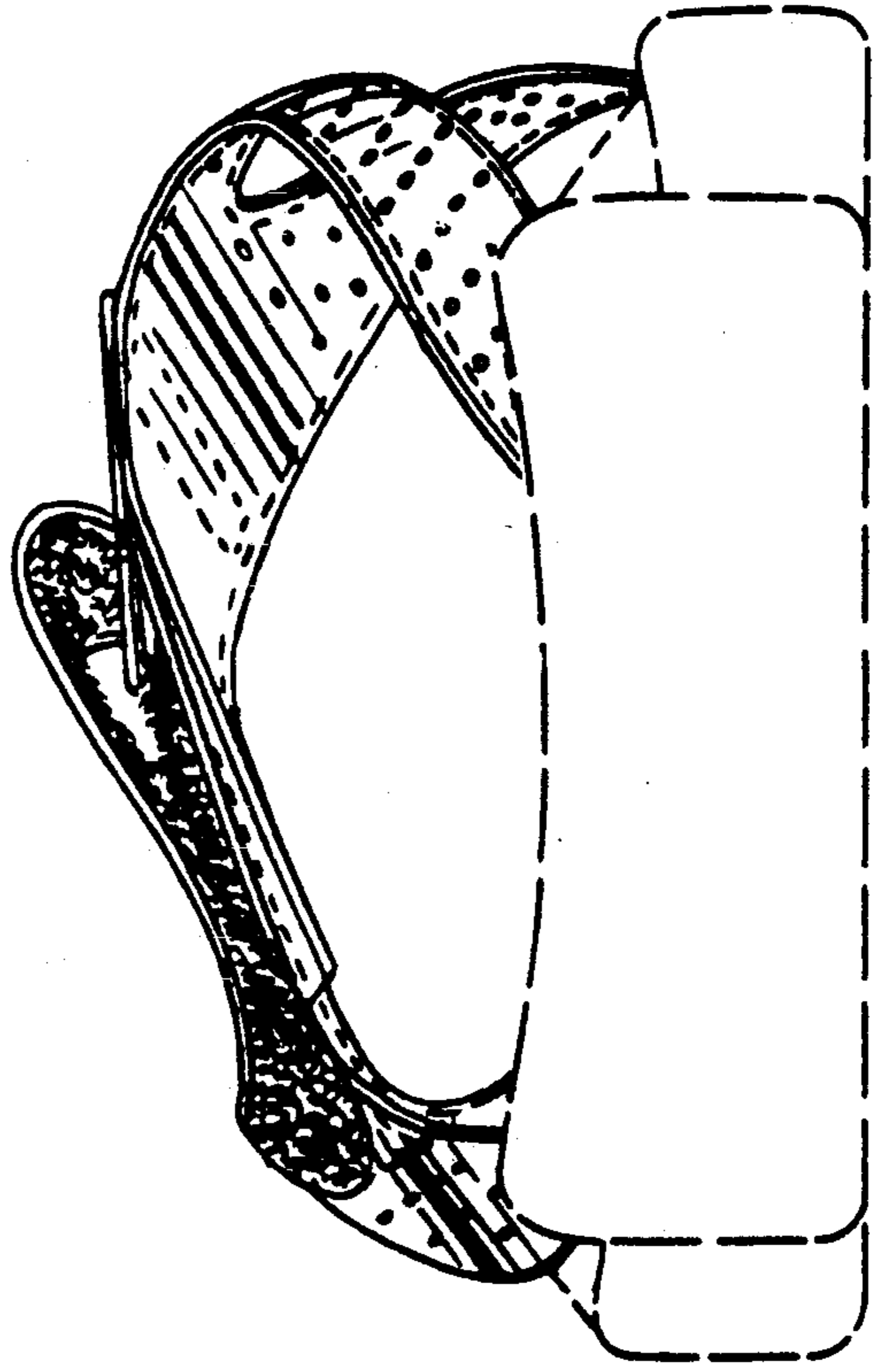
