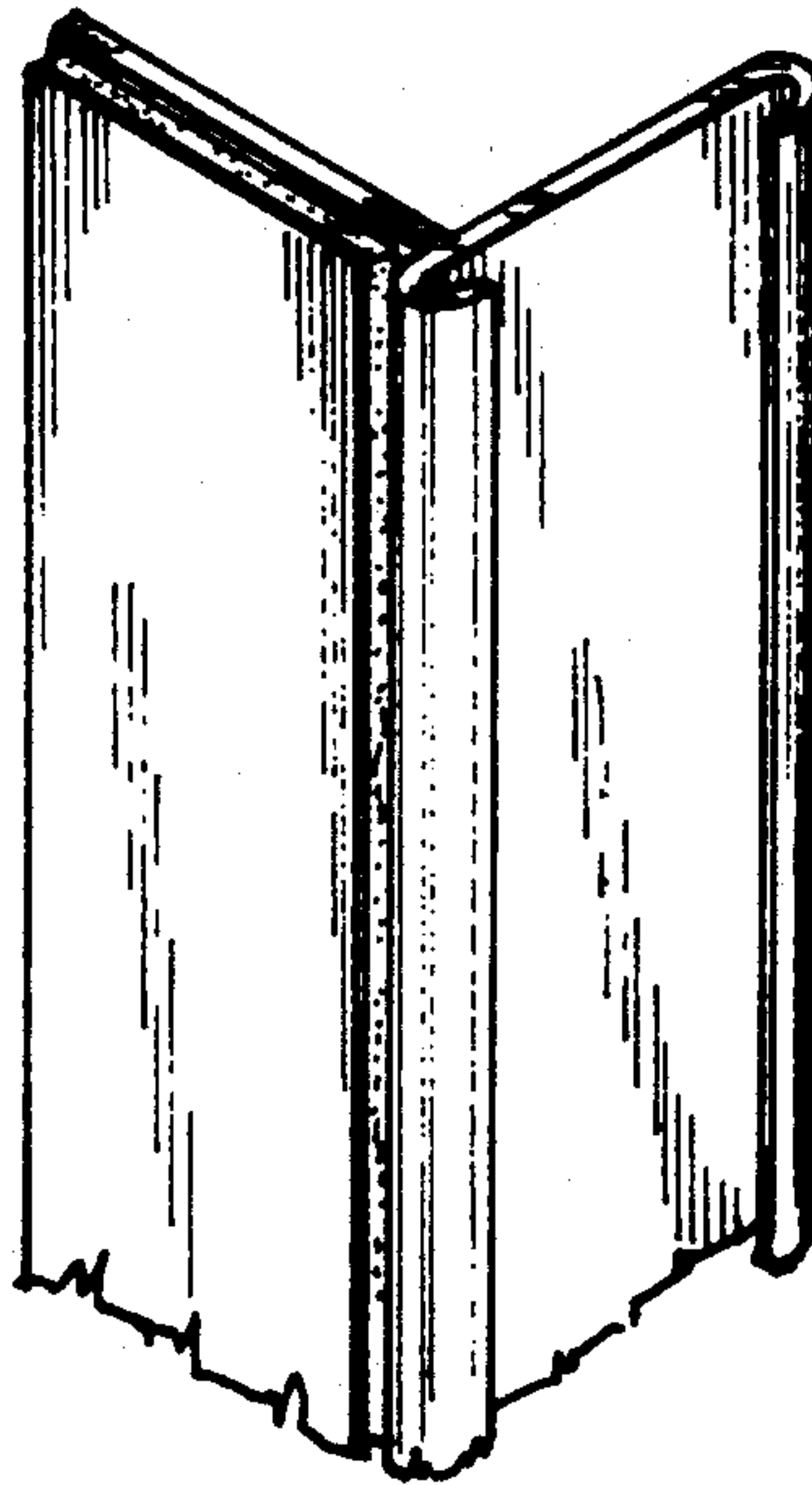
The ornamental design for the decorative window trim strip, as shown and described.

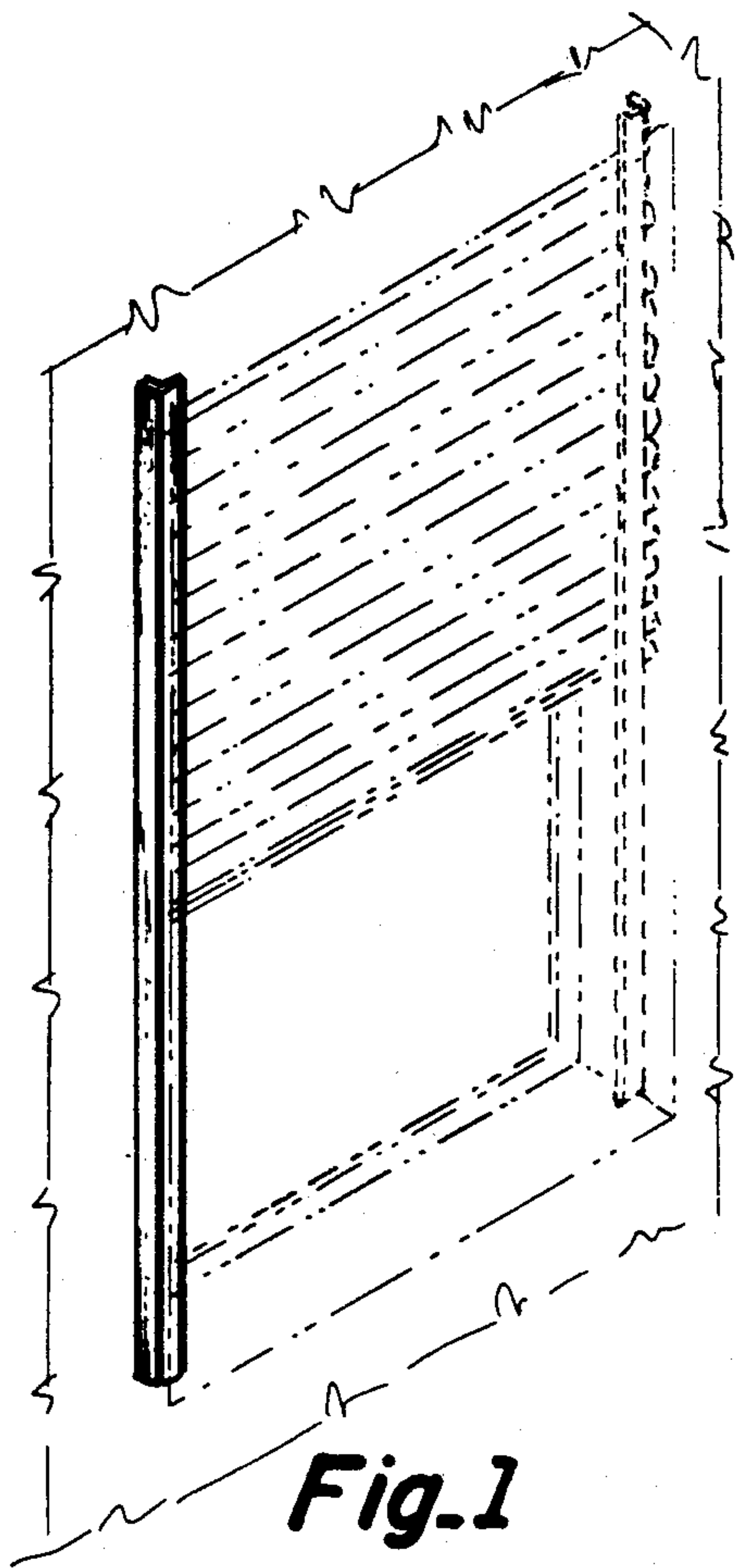
**DESCRIPTION**

FIG. 1 is a perspective view of a decorative window trim strip of this invention, the broken lines showing a window frame and a shutter are for illustrative purposes only and form no part of the claimed design;  
 FIG. 2 is a fragmentary perspective view from the outside corner;  
 FIG. 3 is a fragmentary perspective view from the inside corner;  
 FIG. 4 is a top plan view, the bottom being identical thereto, the broken lines showing a shutter louver are for illustrative purposes only and form no part of the claimed design;  
 FIG. 5 is a fragmentary left outside view of FIG. 2;  
 FIG. 6 is a fragmentary right outside of FIG. 2;  
 FIG. 7 is a fragmentary left inside view of FIG. 2; and,  
 FIG. 8 is a fragmentary right inside view of FIG. 2.

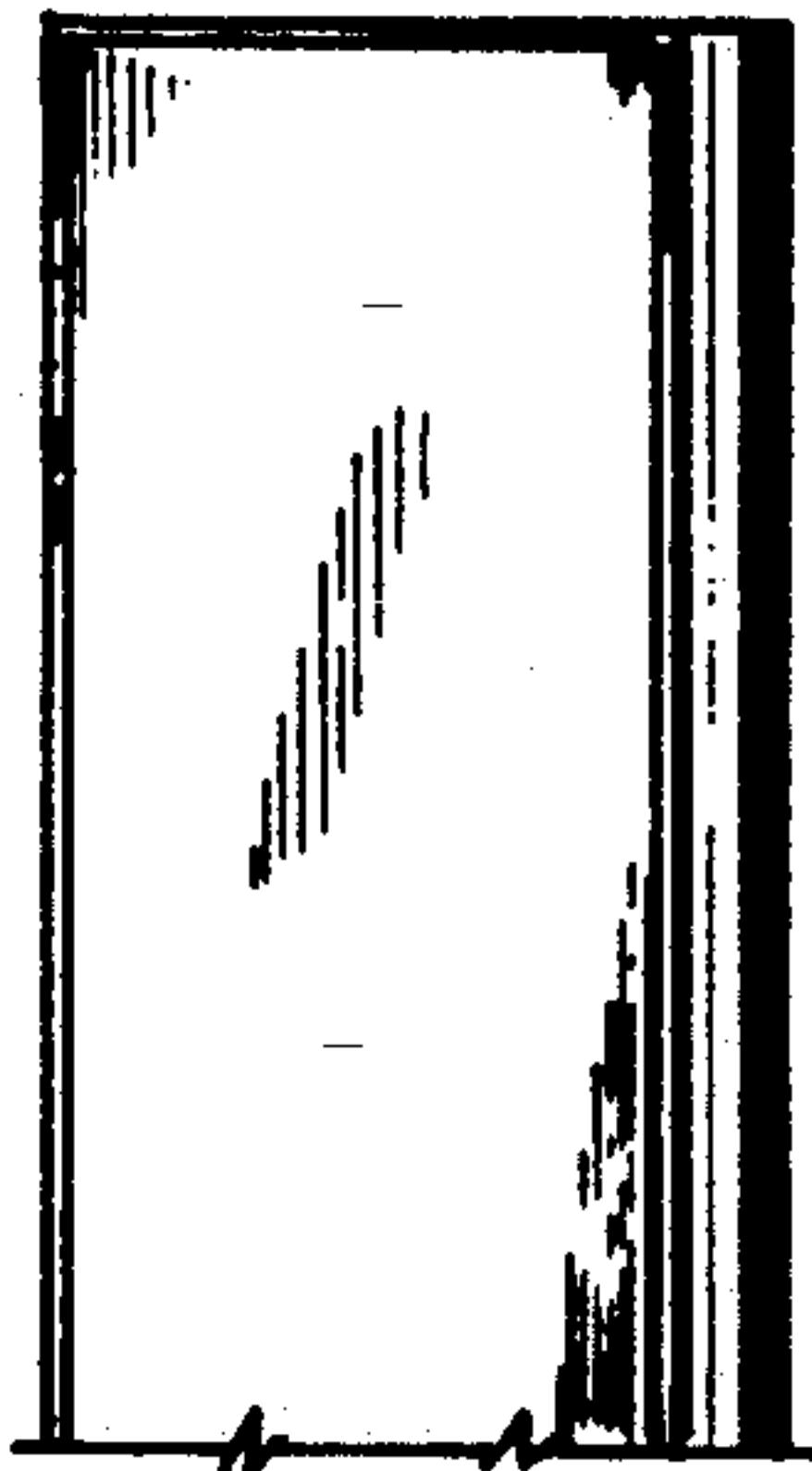

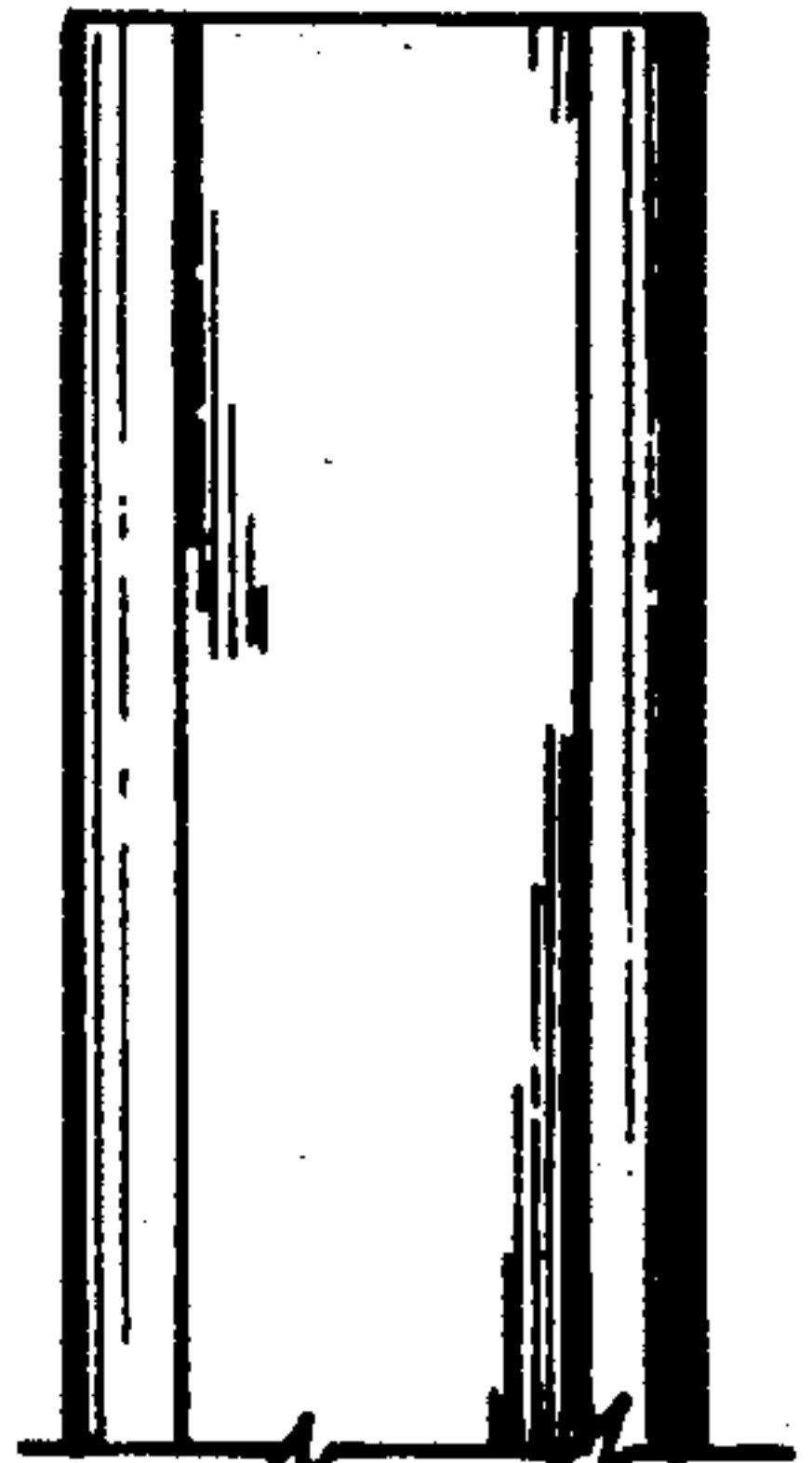




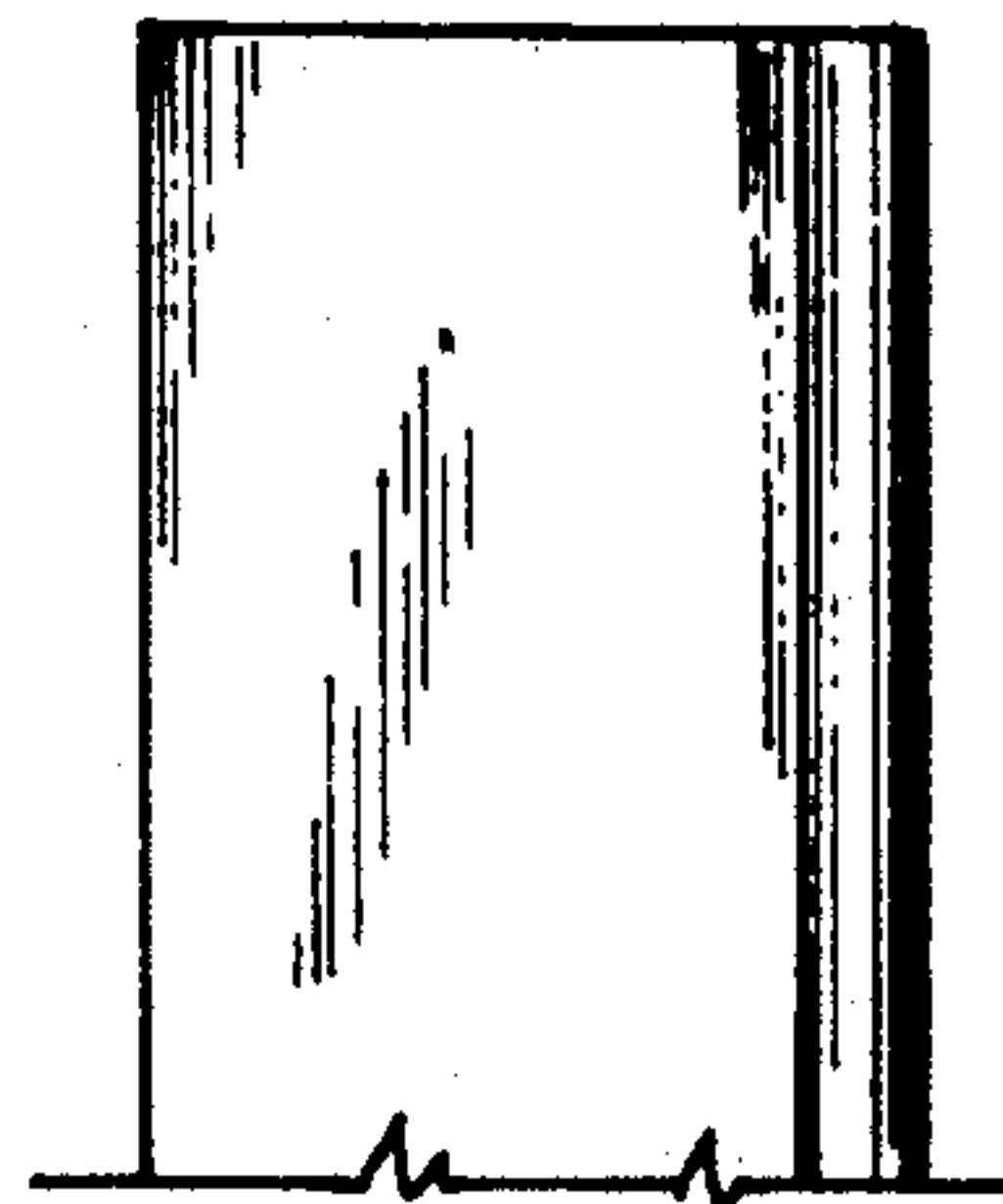

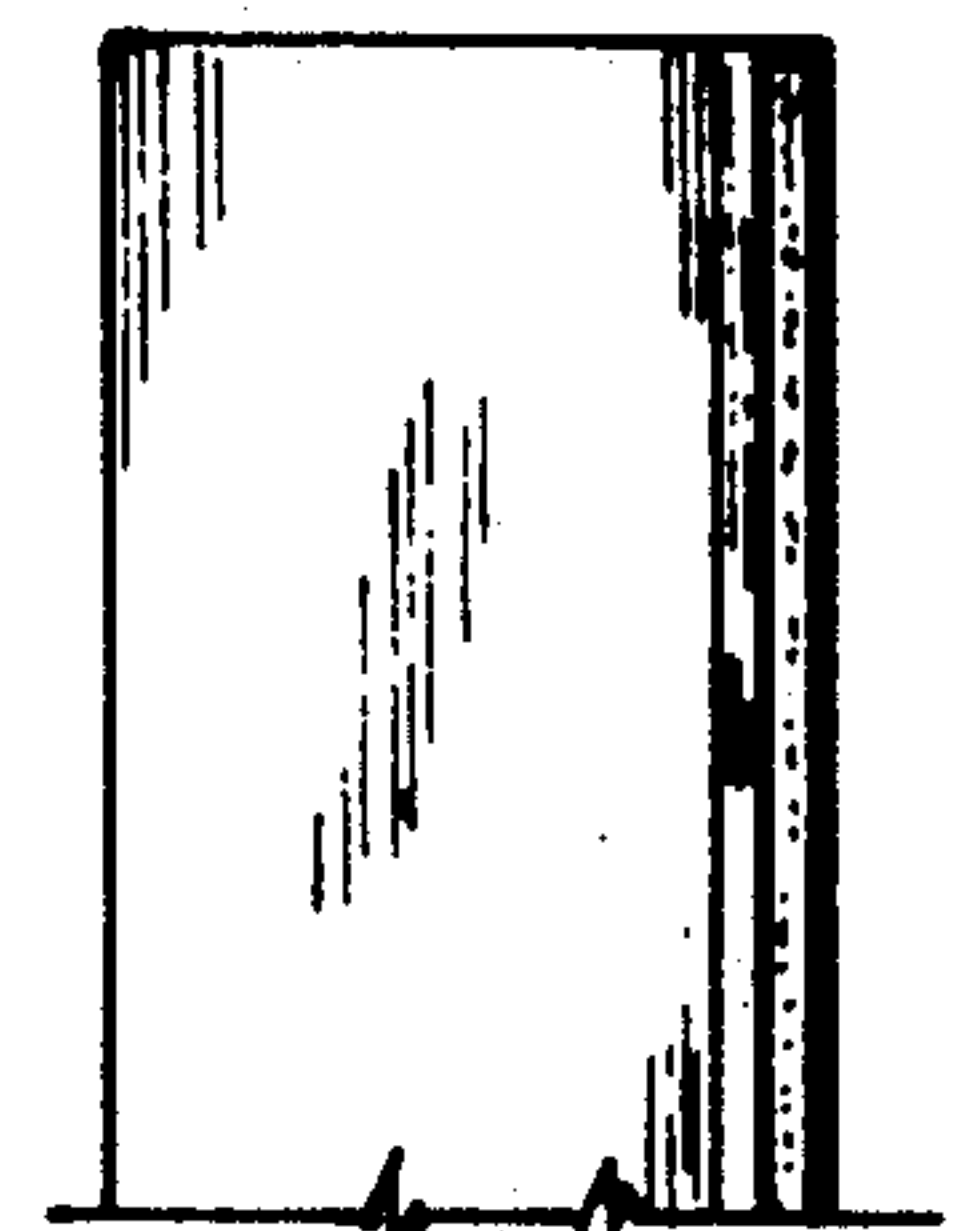

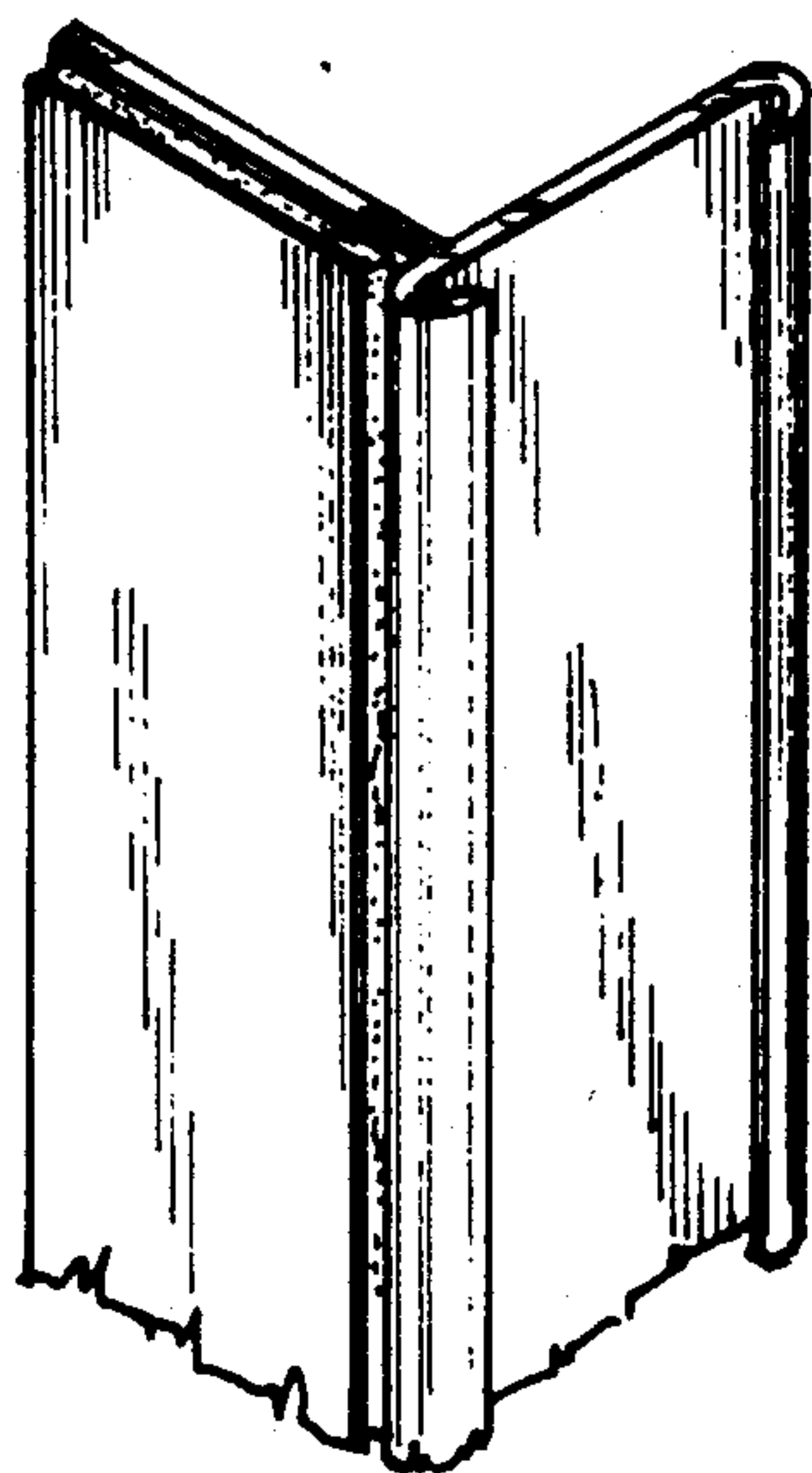

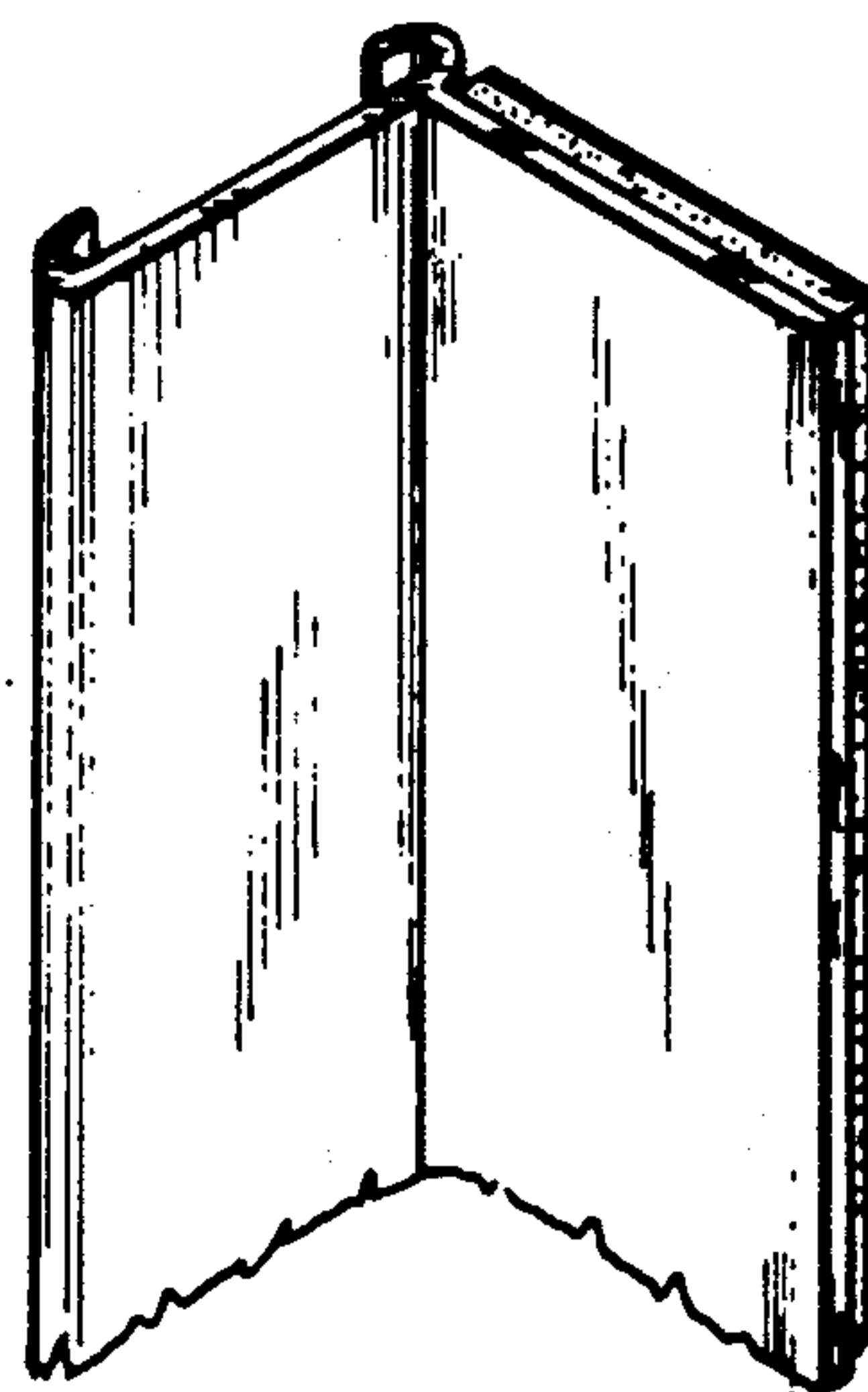

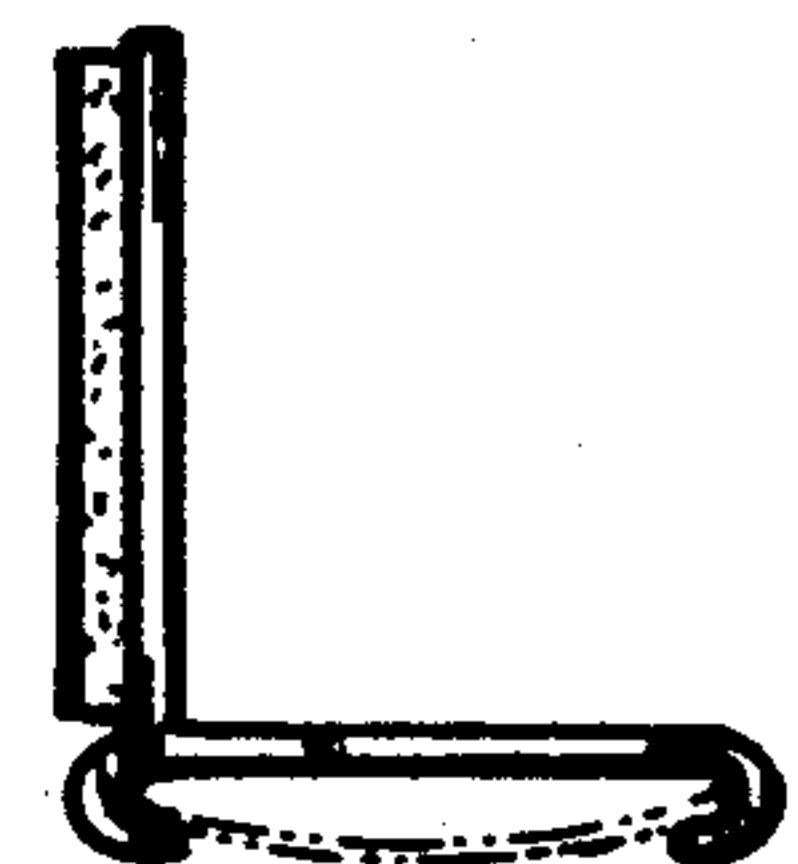
