DESCRIPTION

FIG. 1 is a front elevational view of a combined bottle and stopper showing my new design;

 The broken lines are shown for illustrative purposes only.

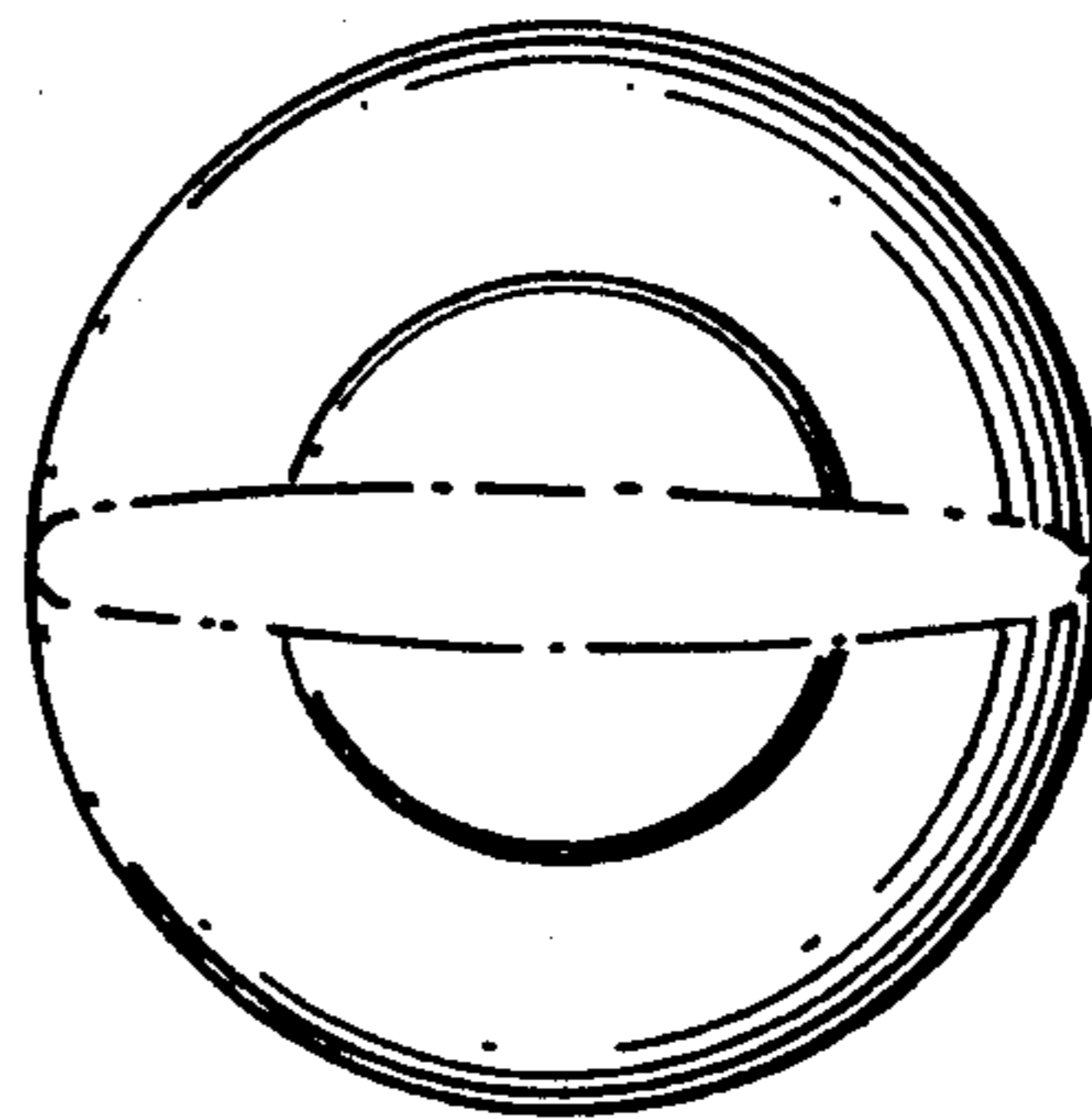
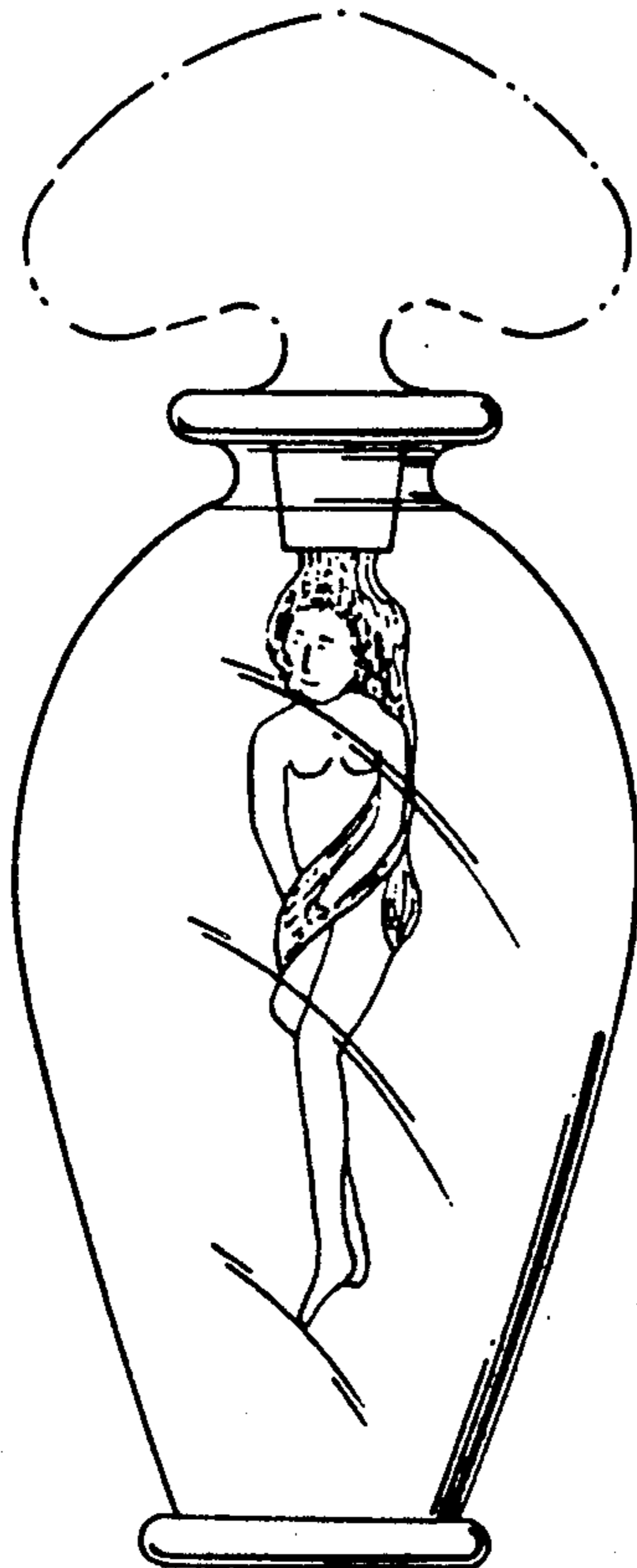

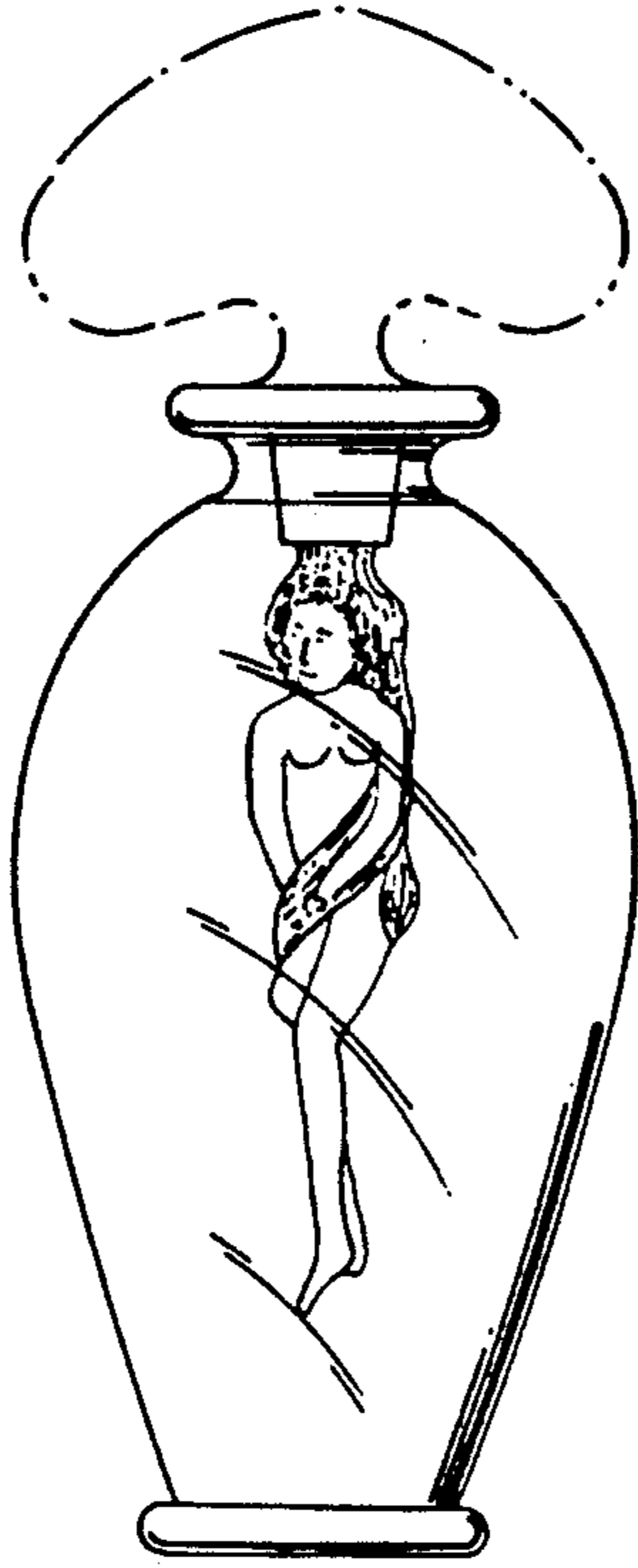

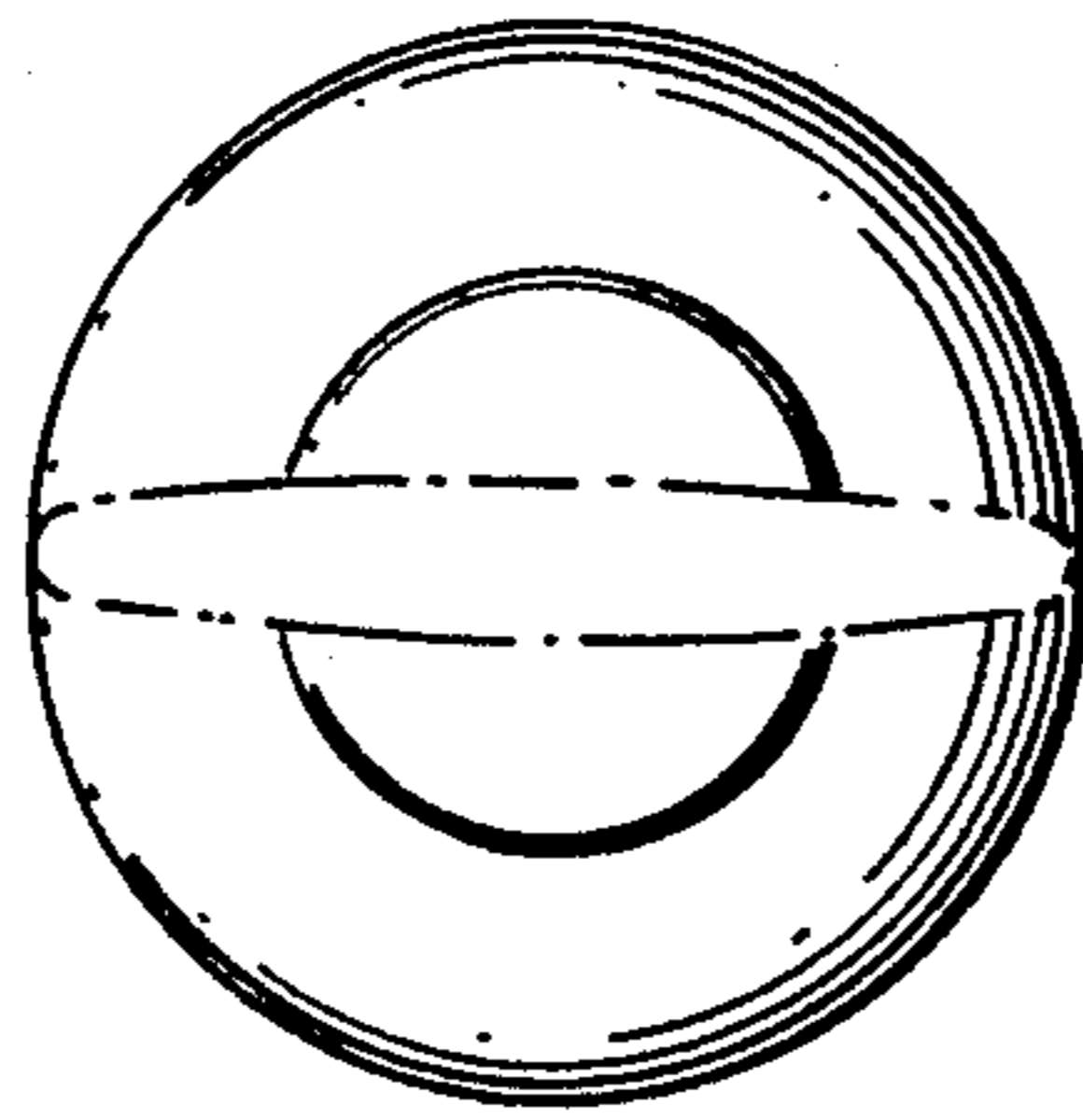
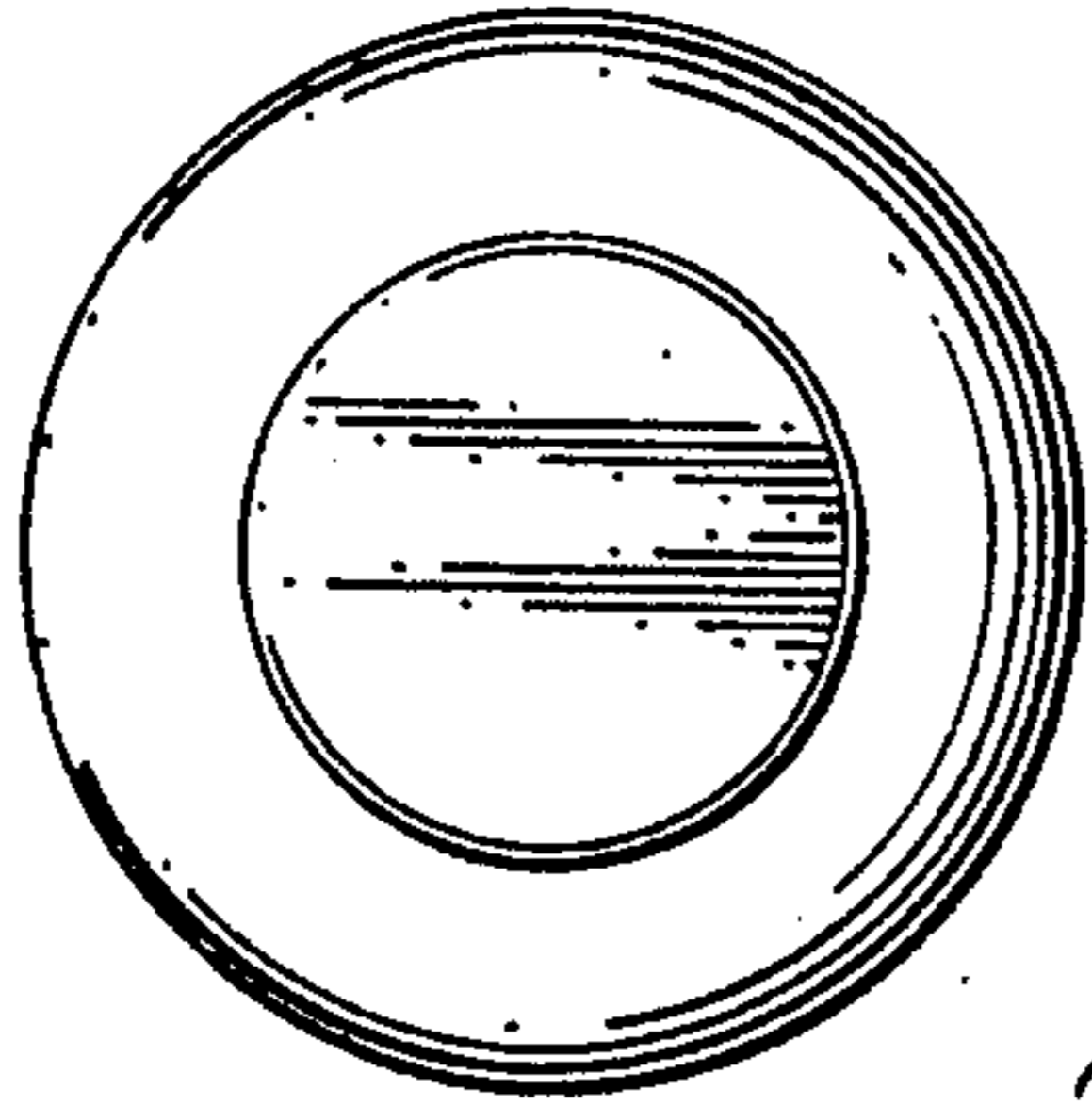
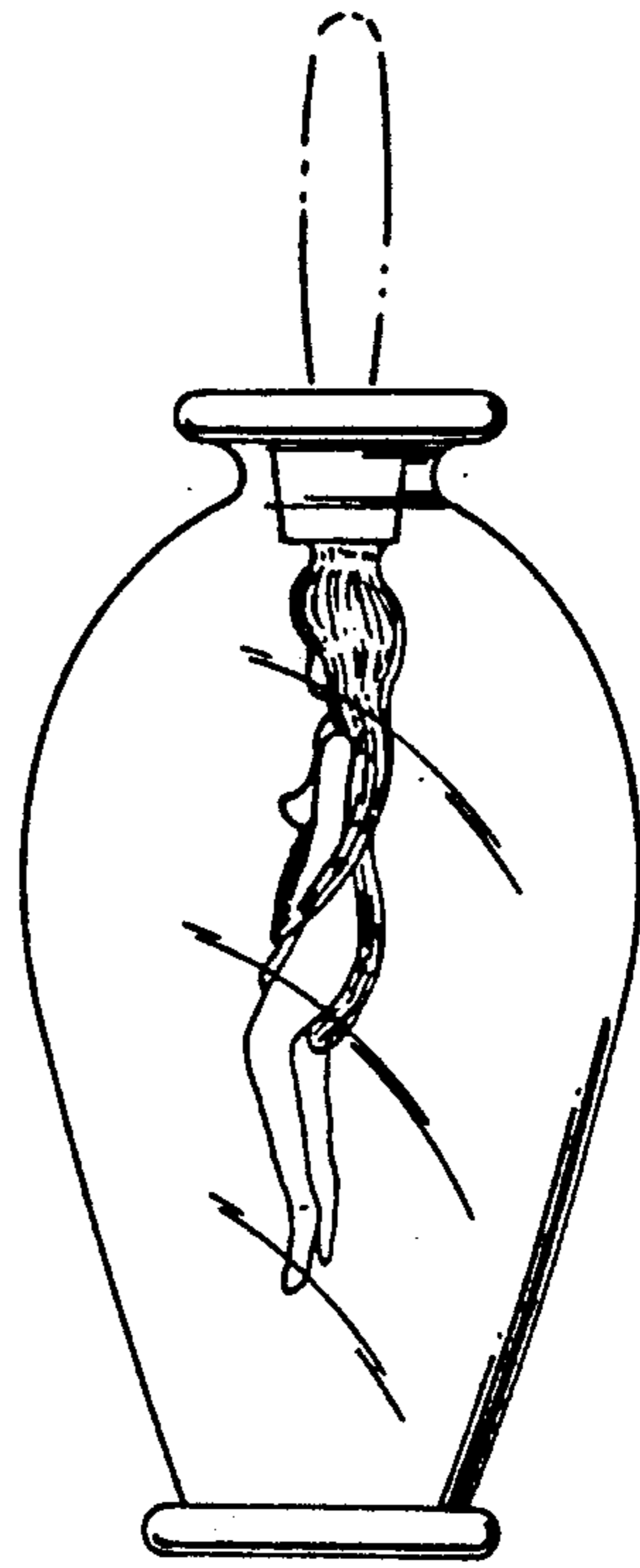

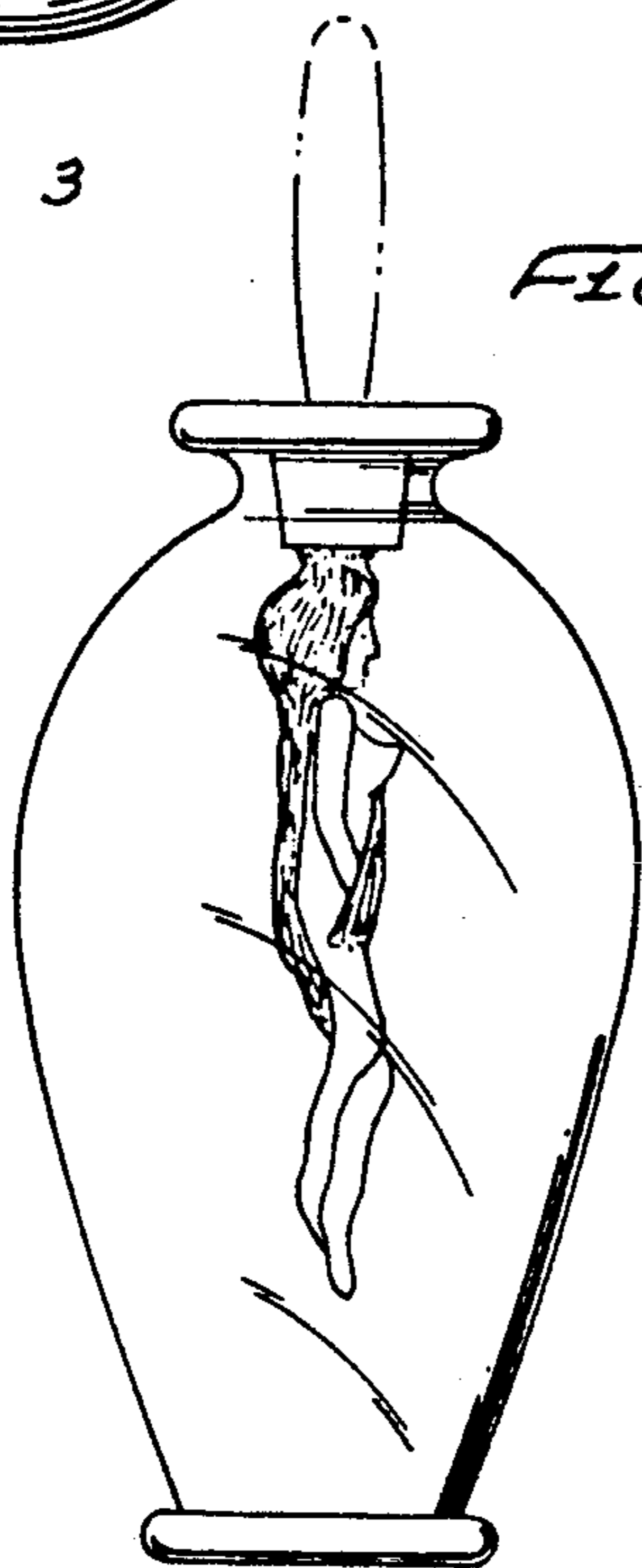

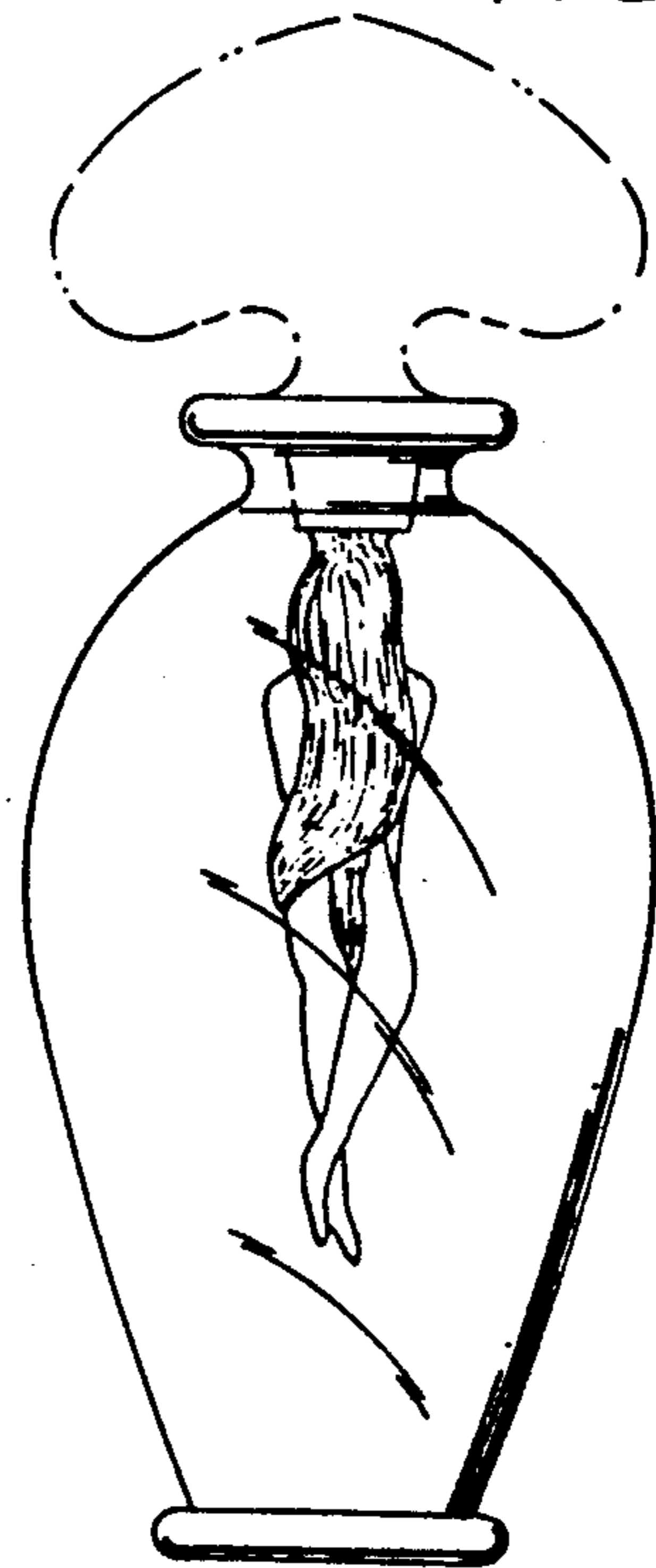

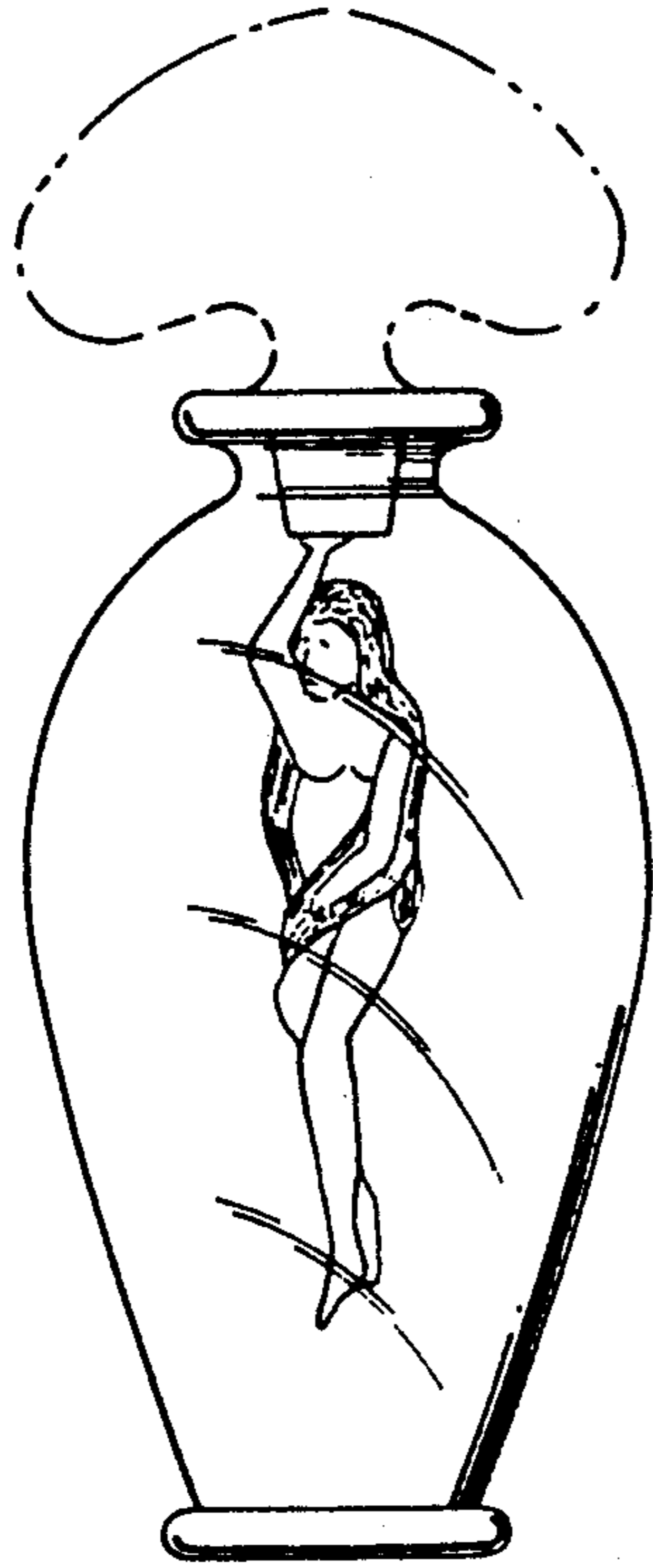

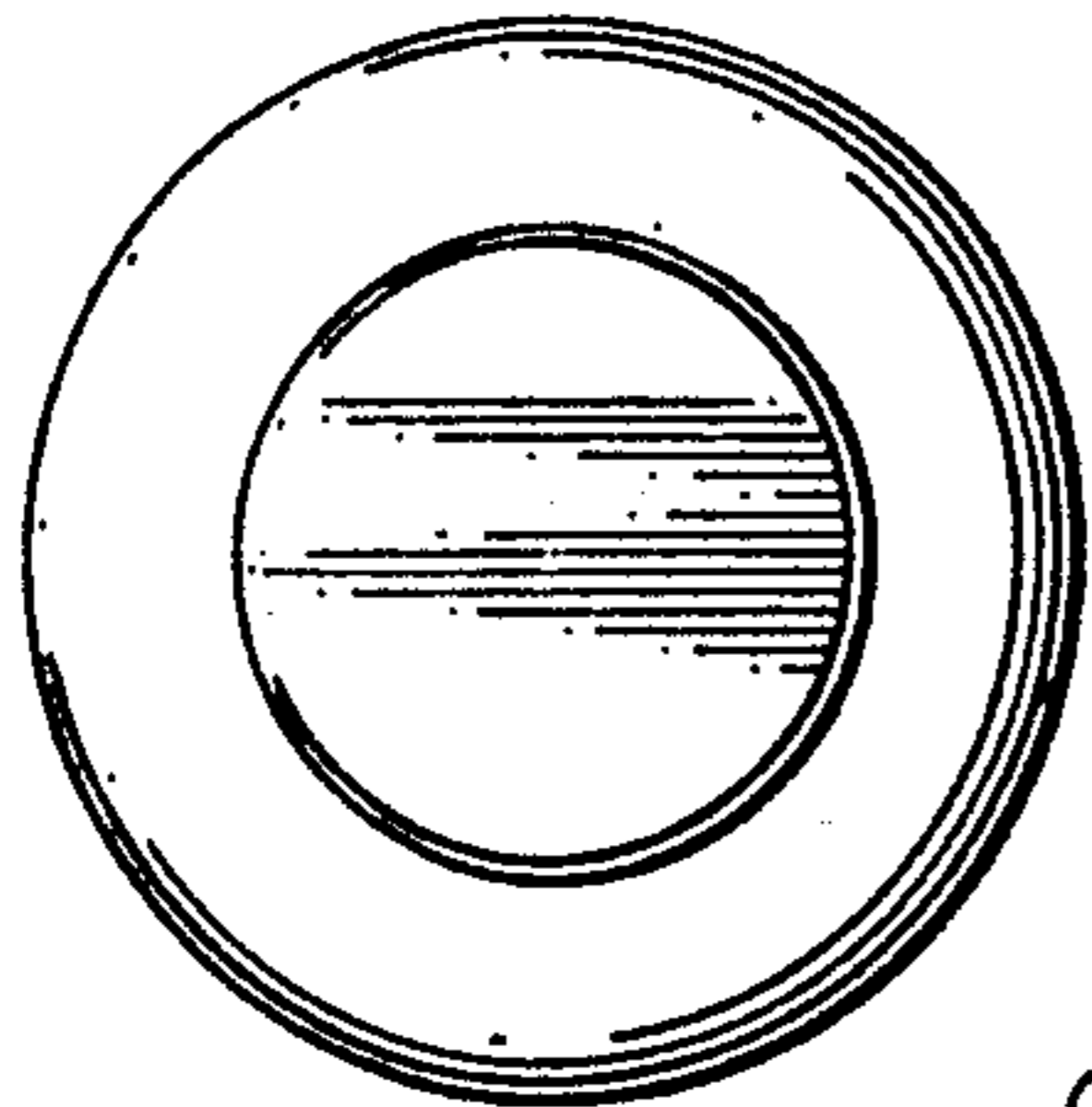
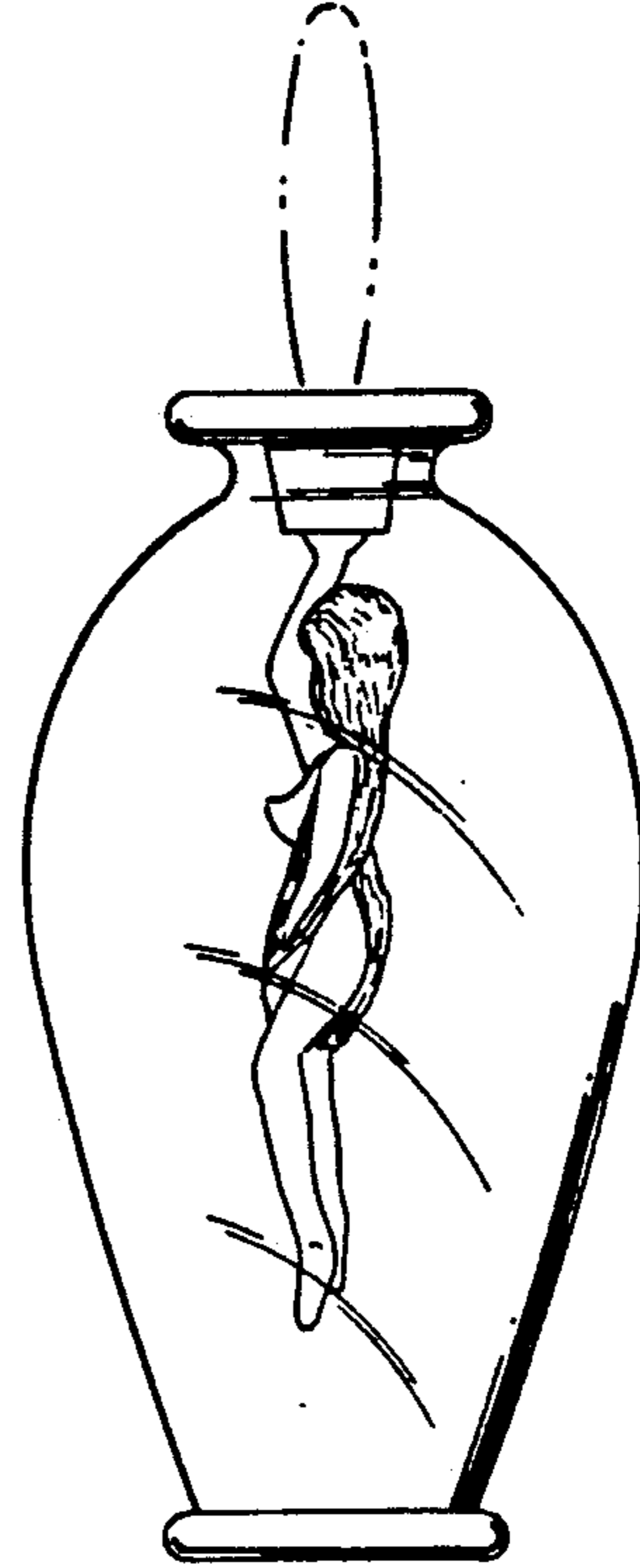

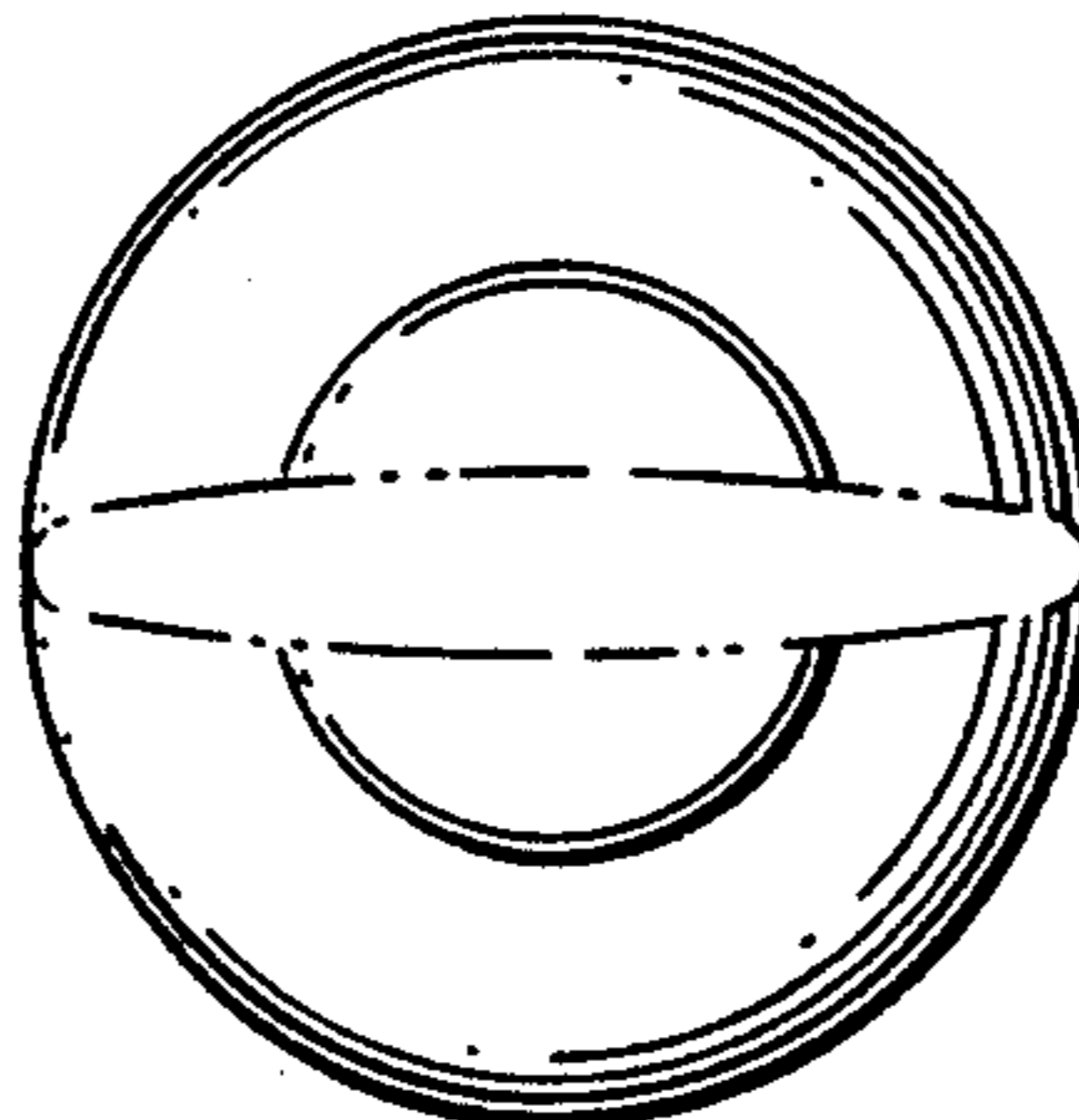

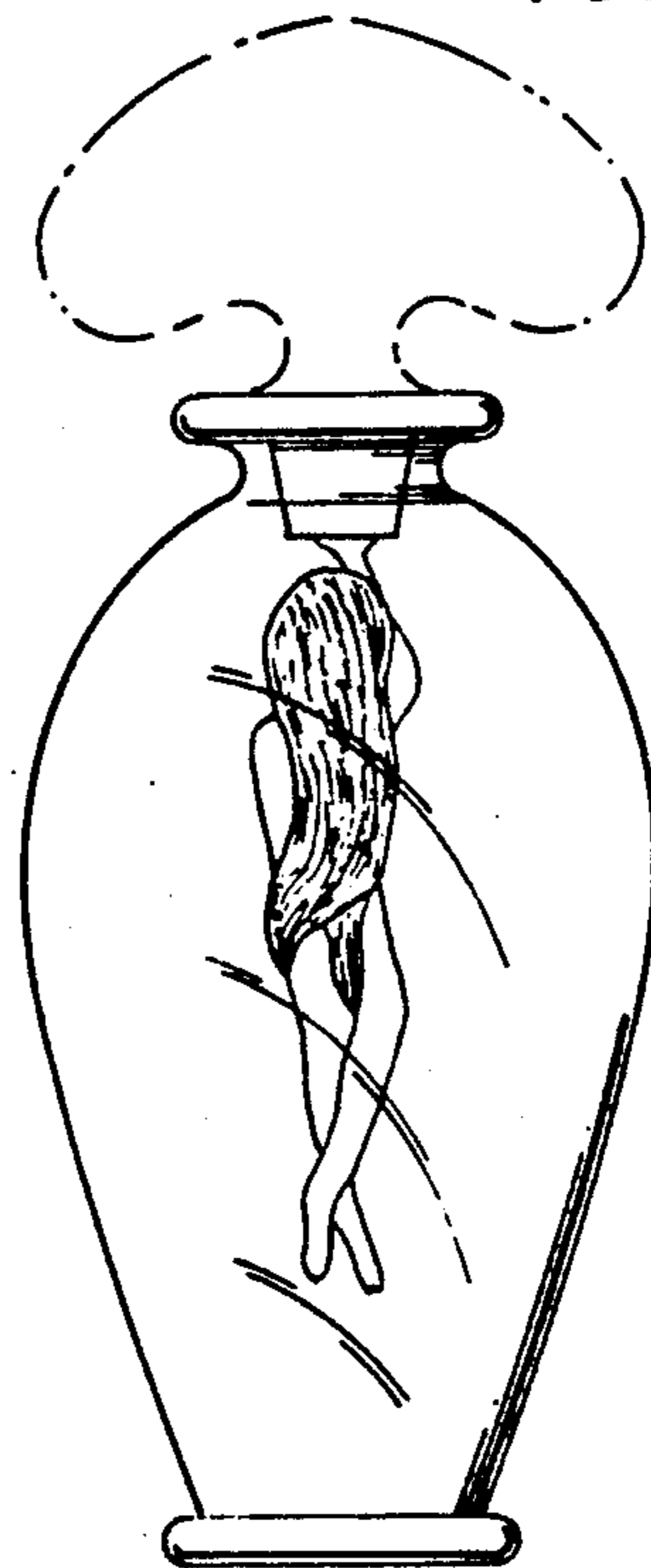
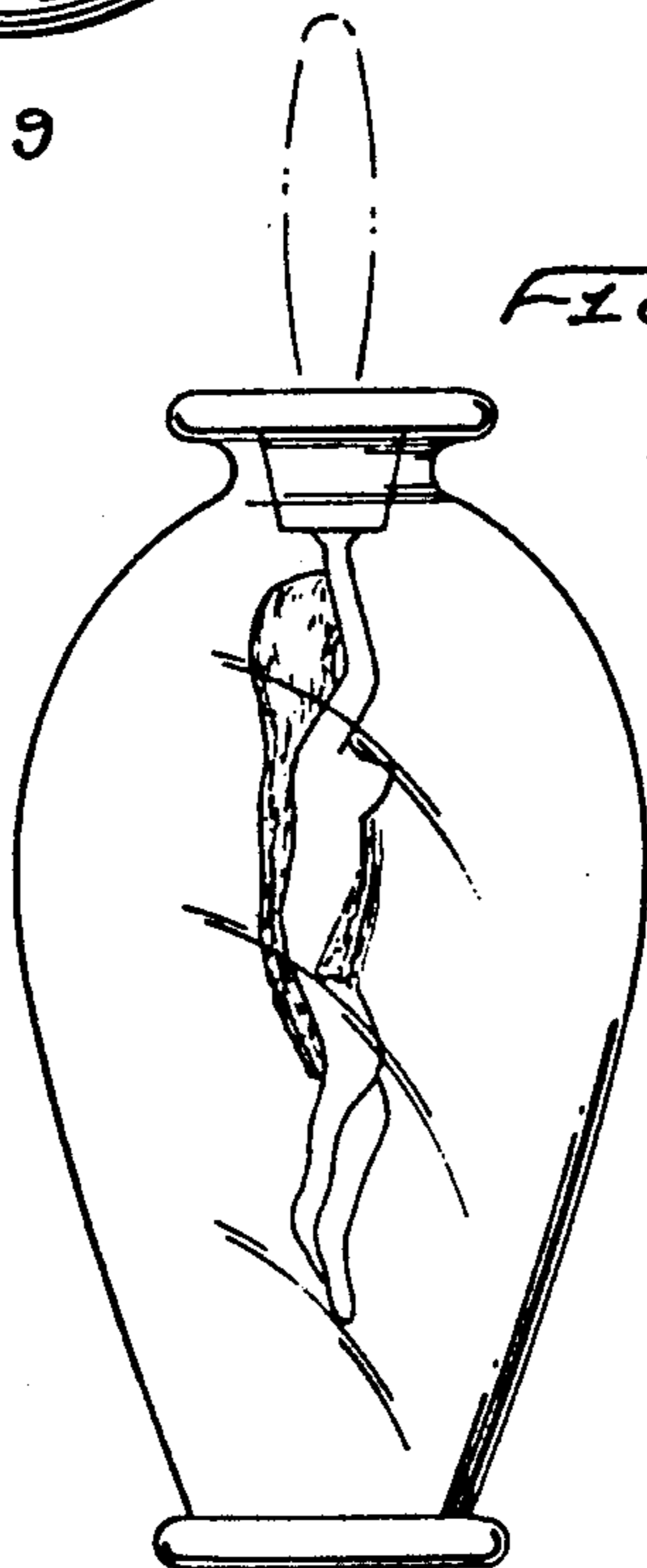

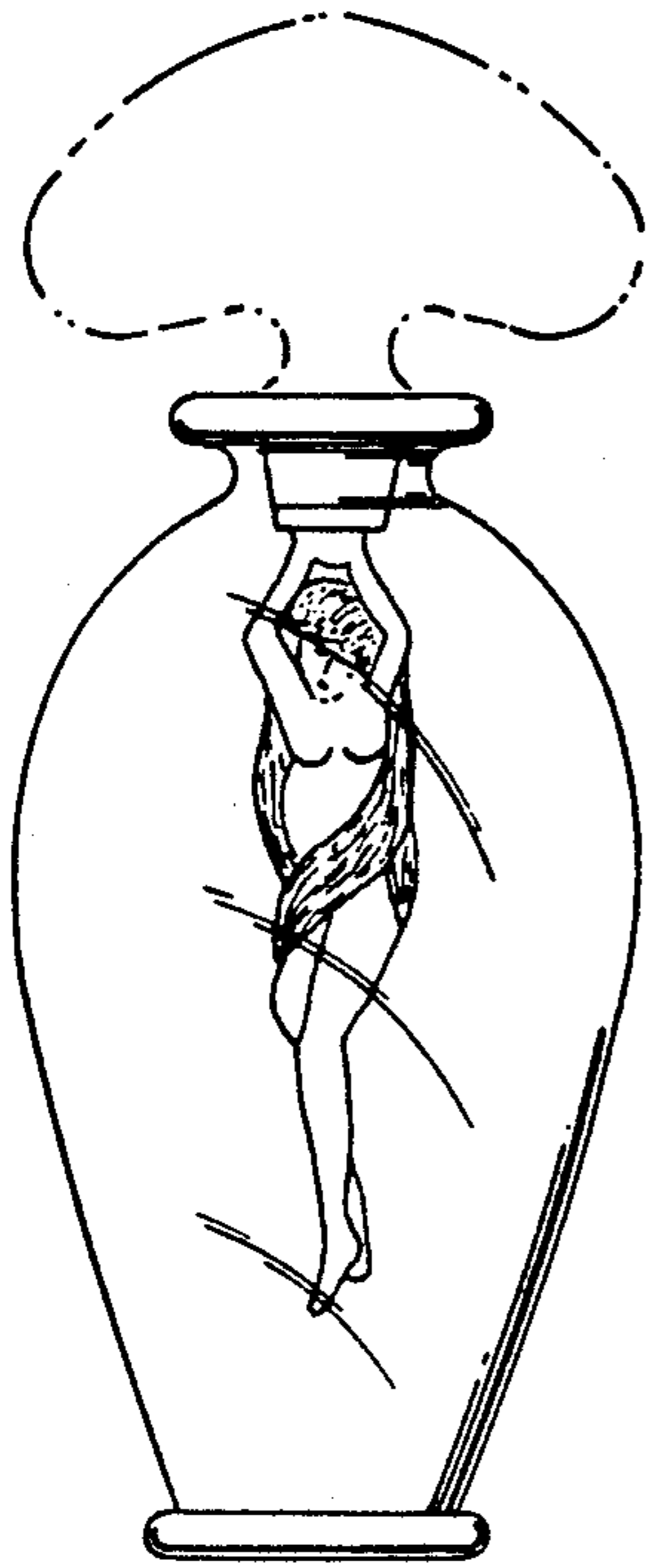

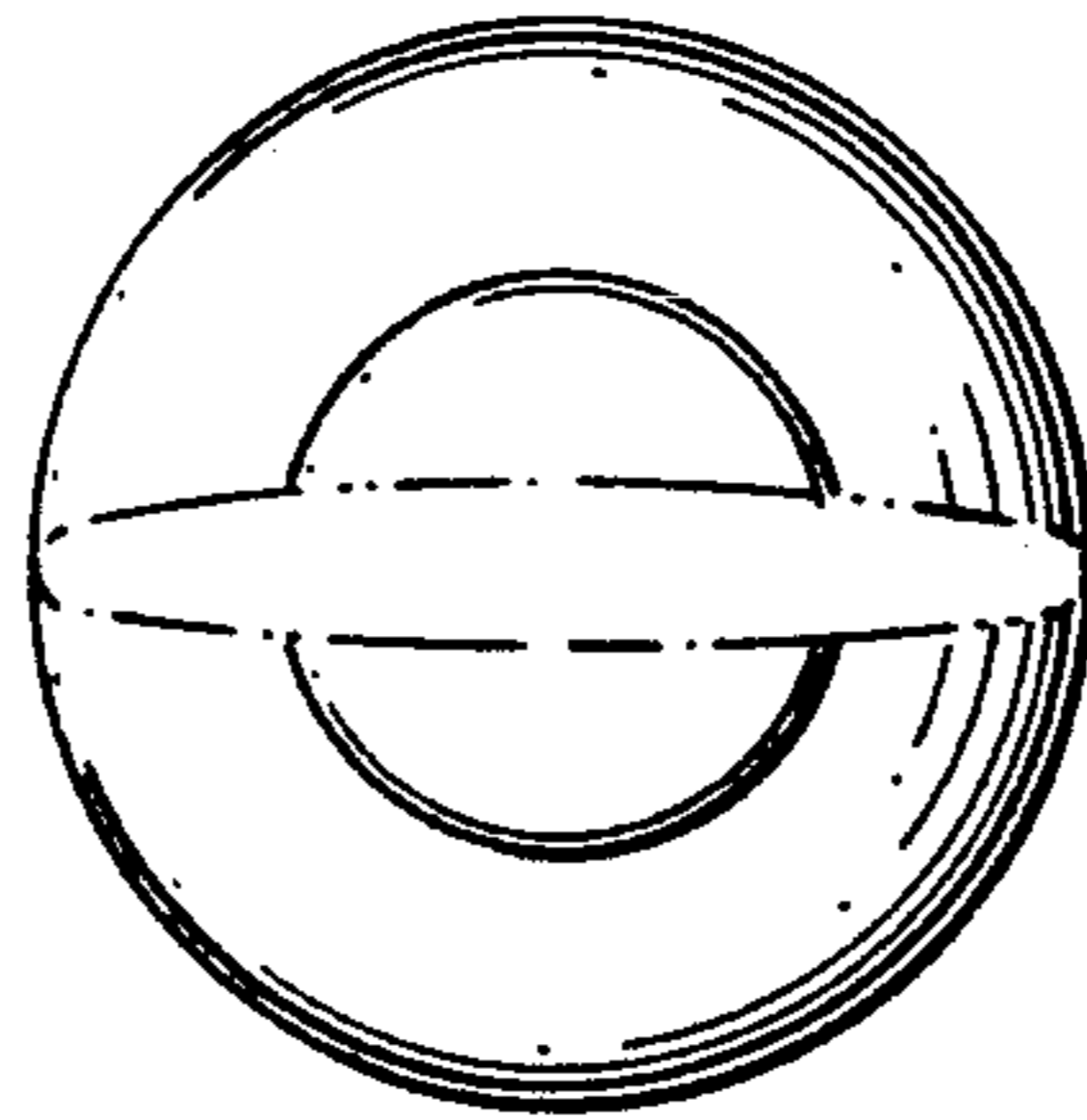
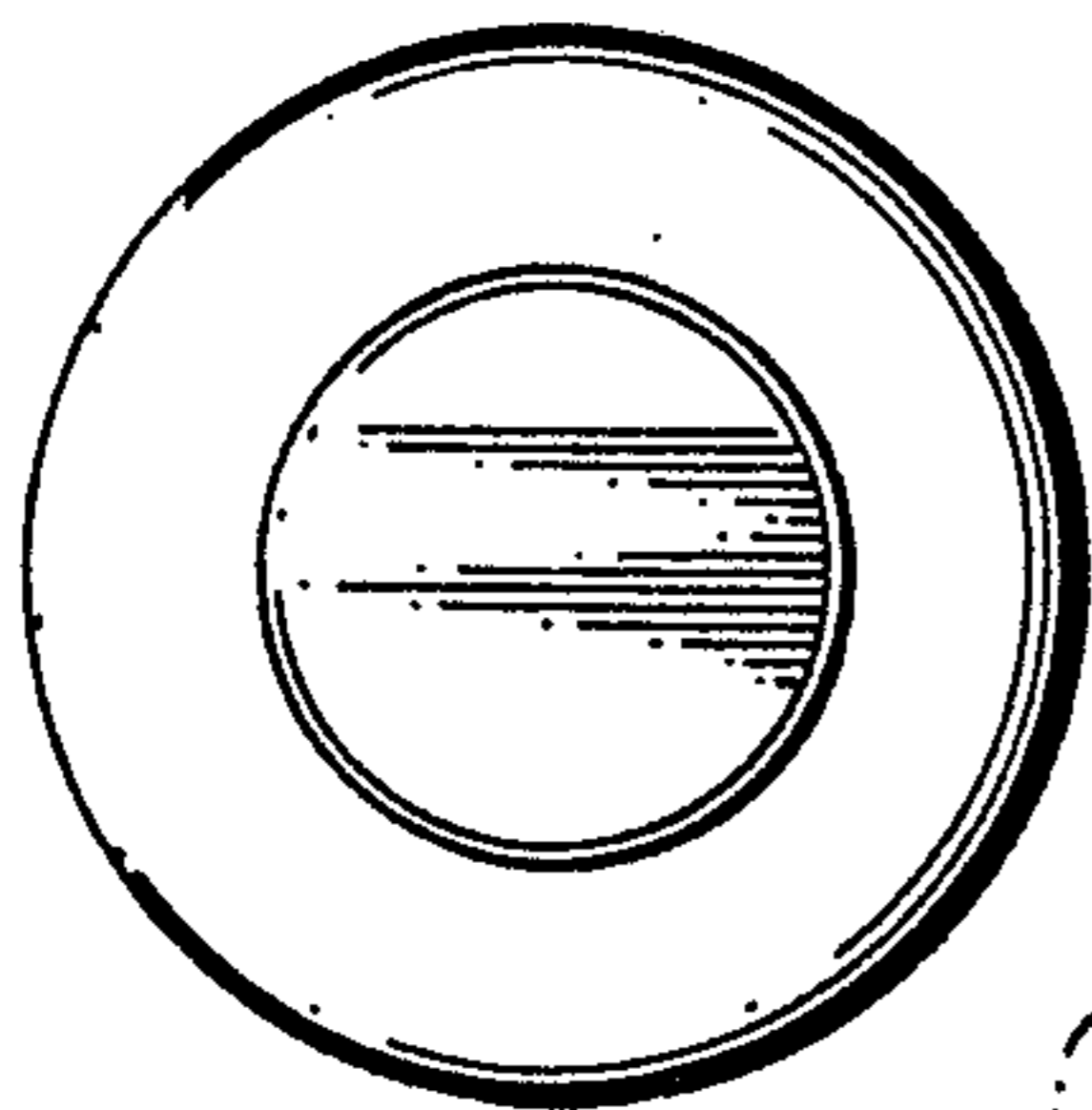
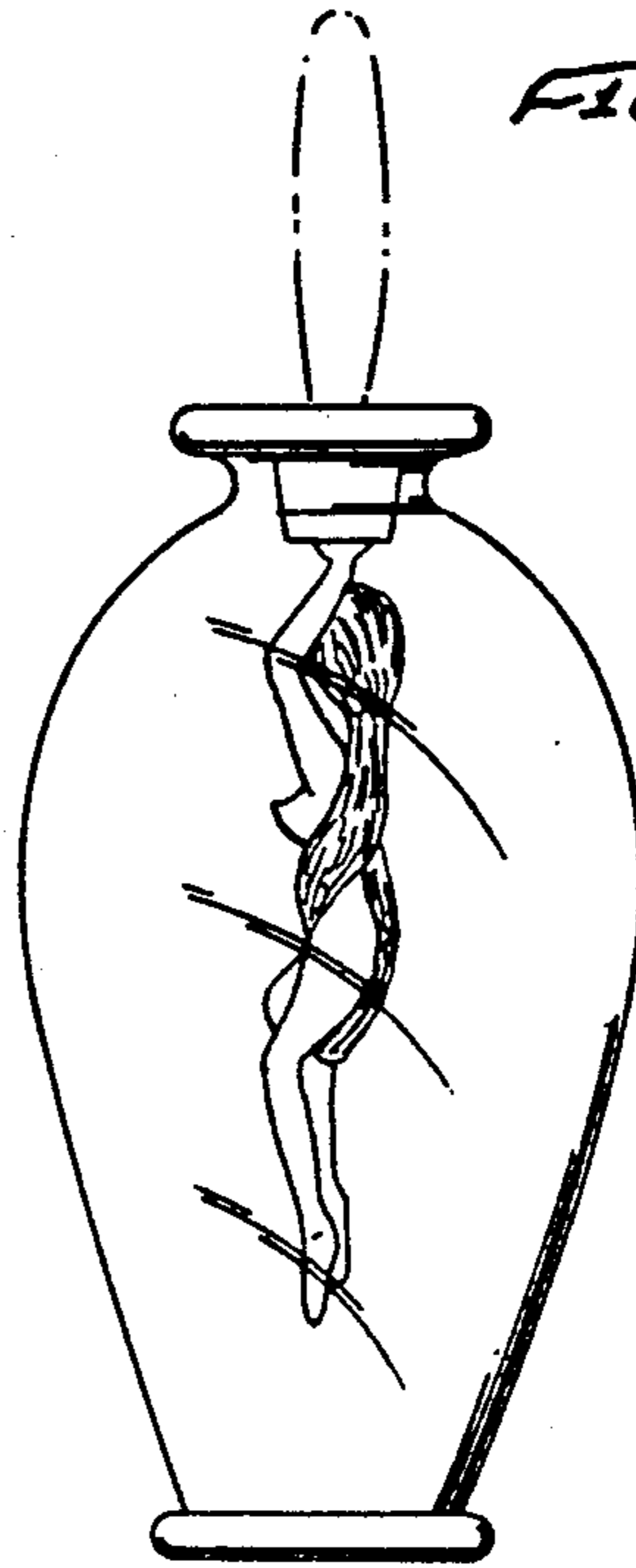

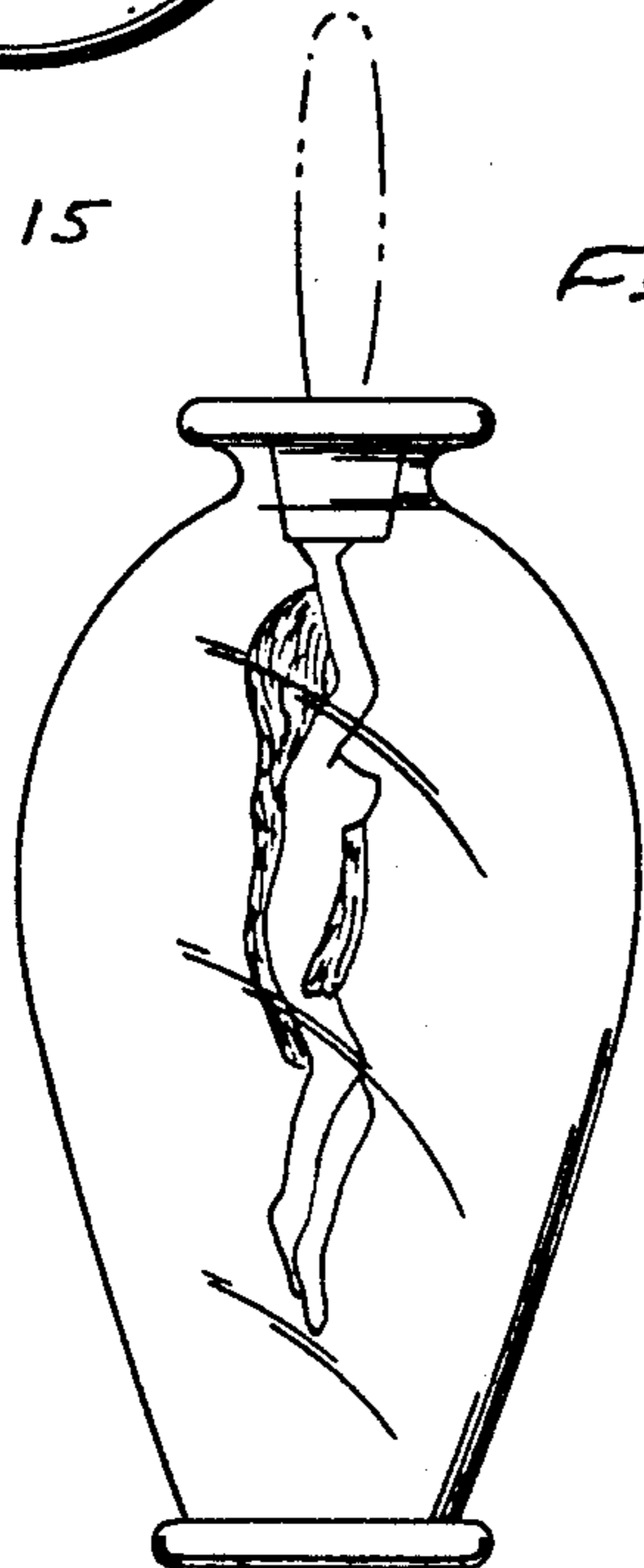
