The ornamental design for a combined cuticle pusher and scoop, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, top and right side of a combined cuticle pusher and scoop embodying my new design;

FIG. 9 is a right-side elevational view thereof;

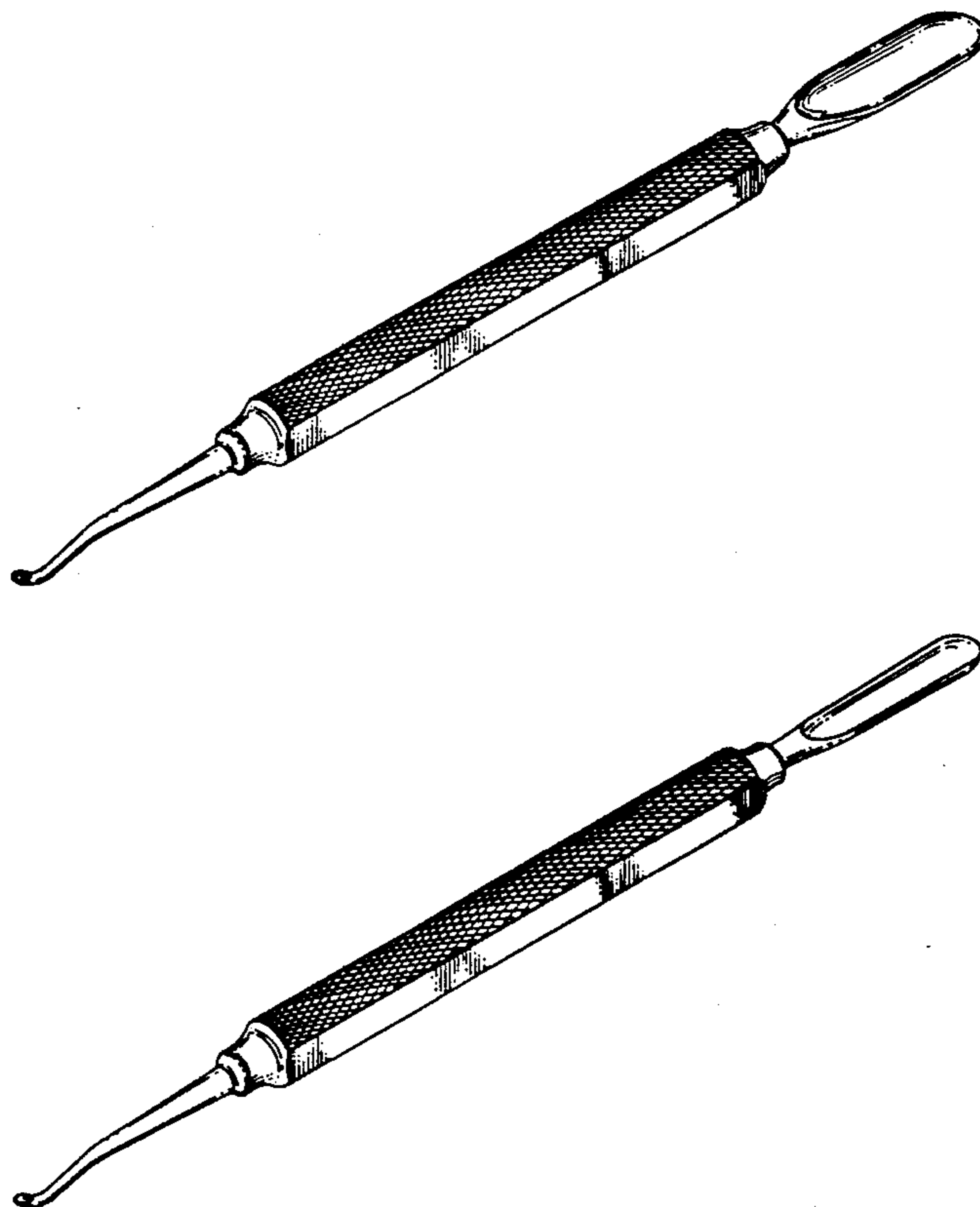
FIG. 10 is a top plan view thereof;

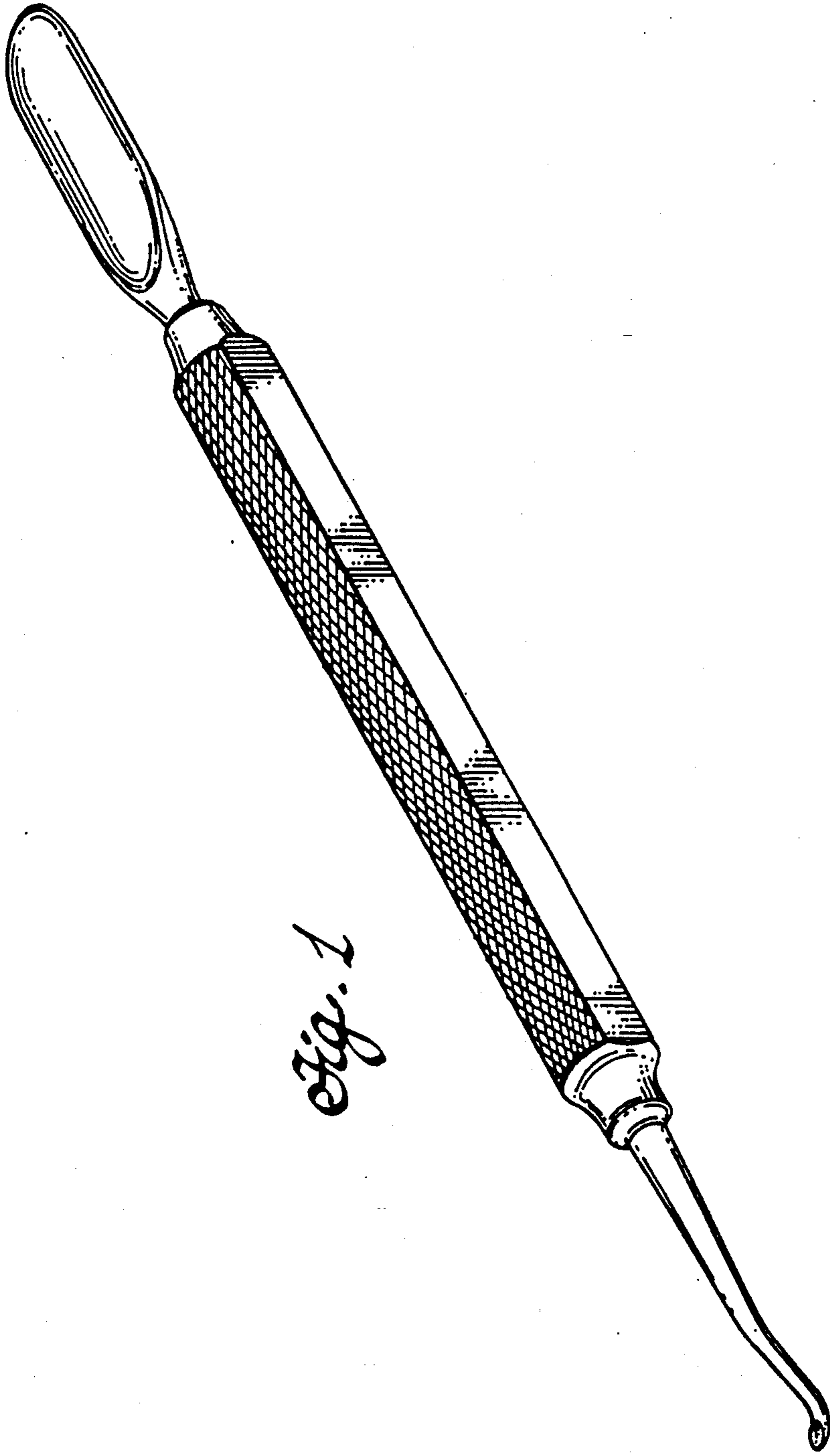
FIG. 11 is a left-side elevational view thereof;

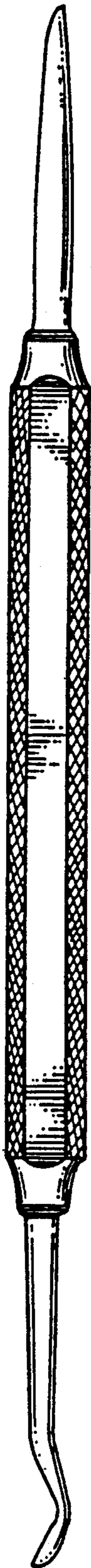

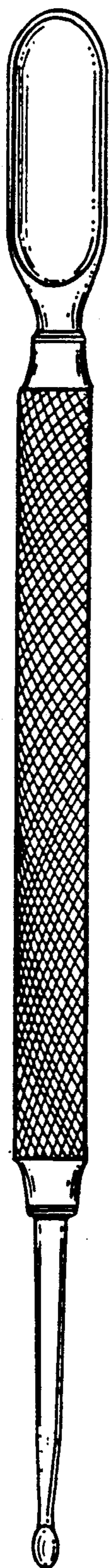

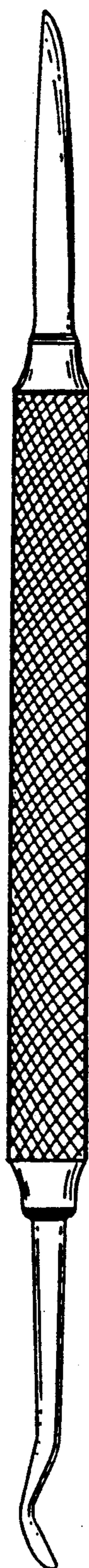

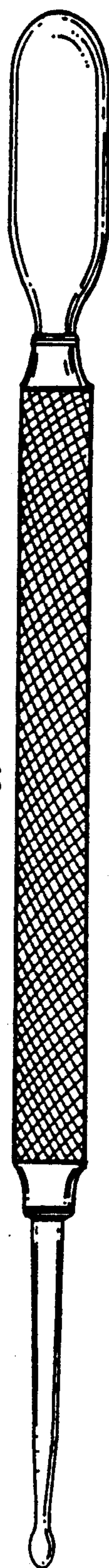

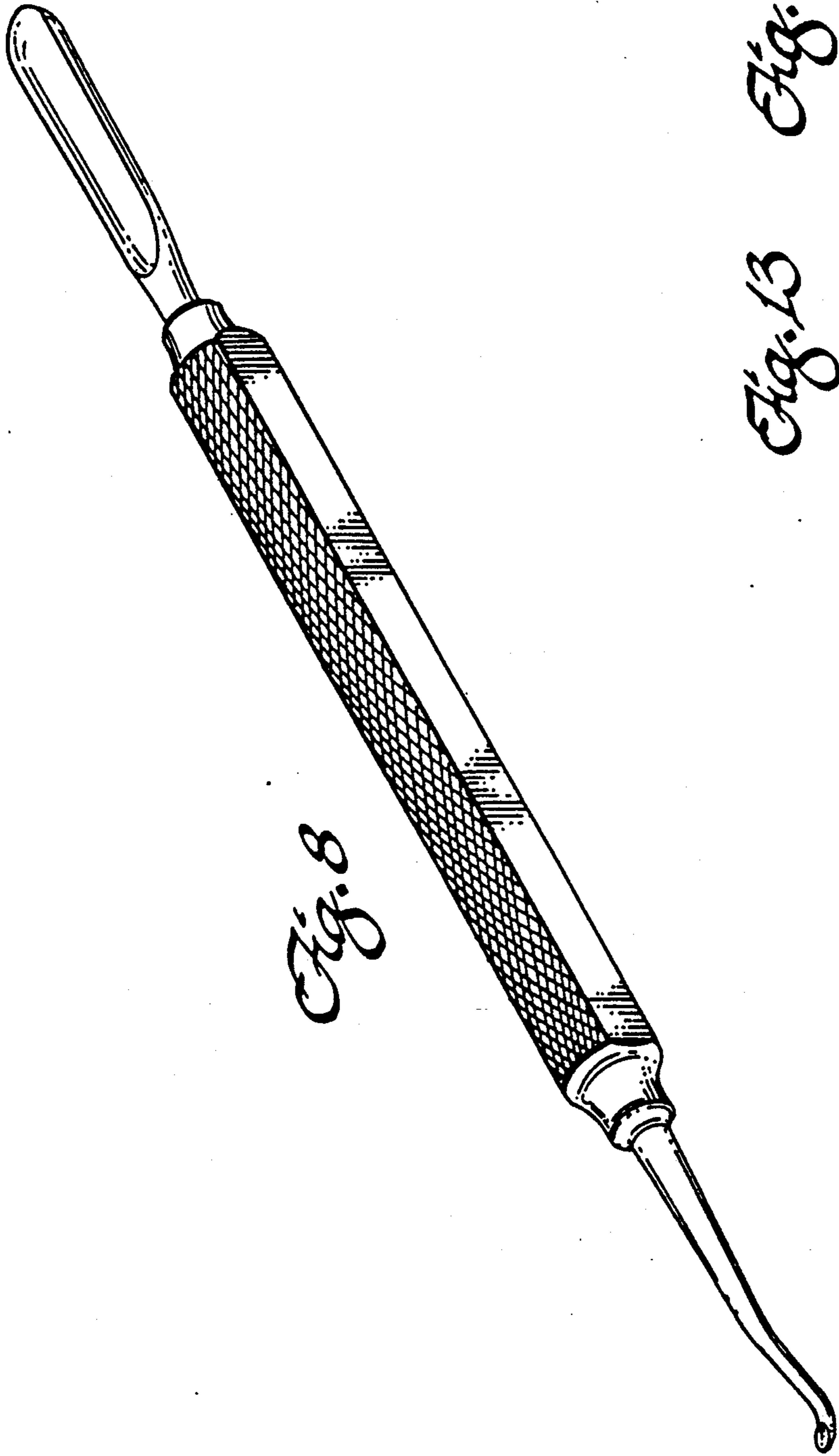

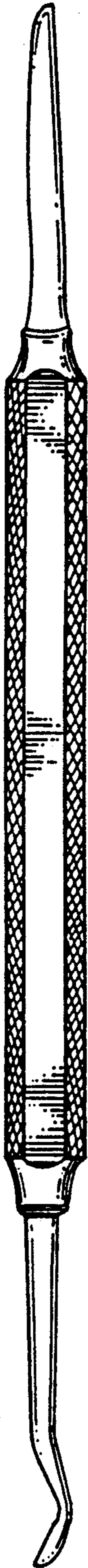

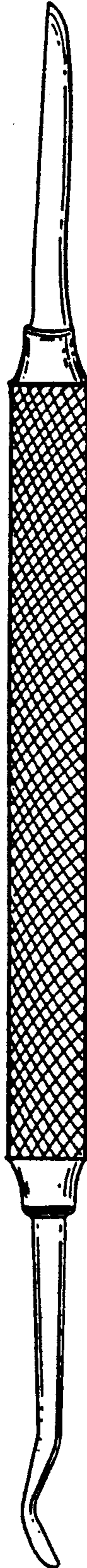

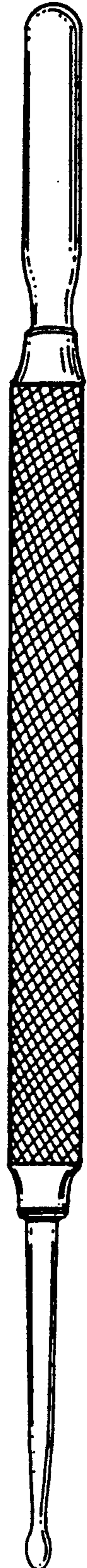
