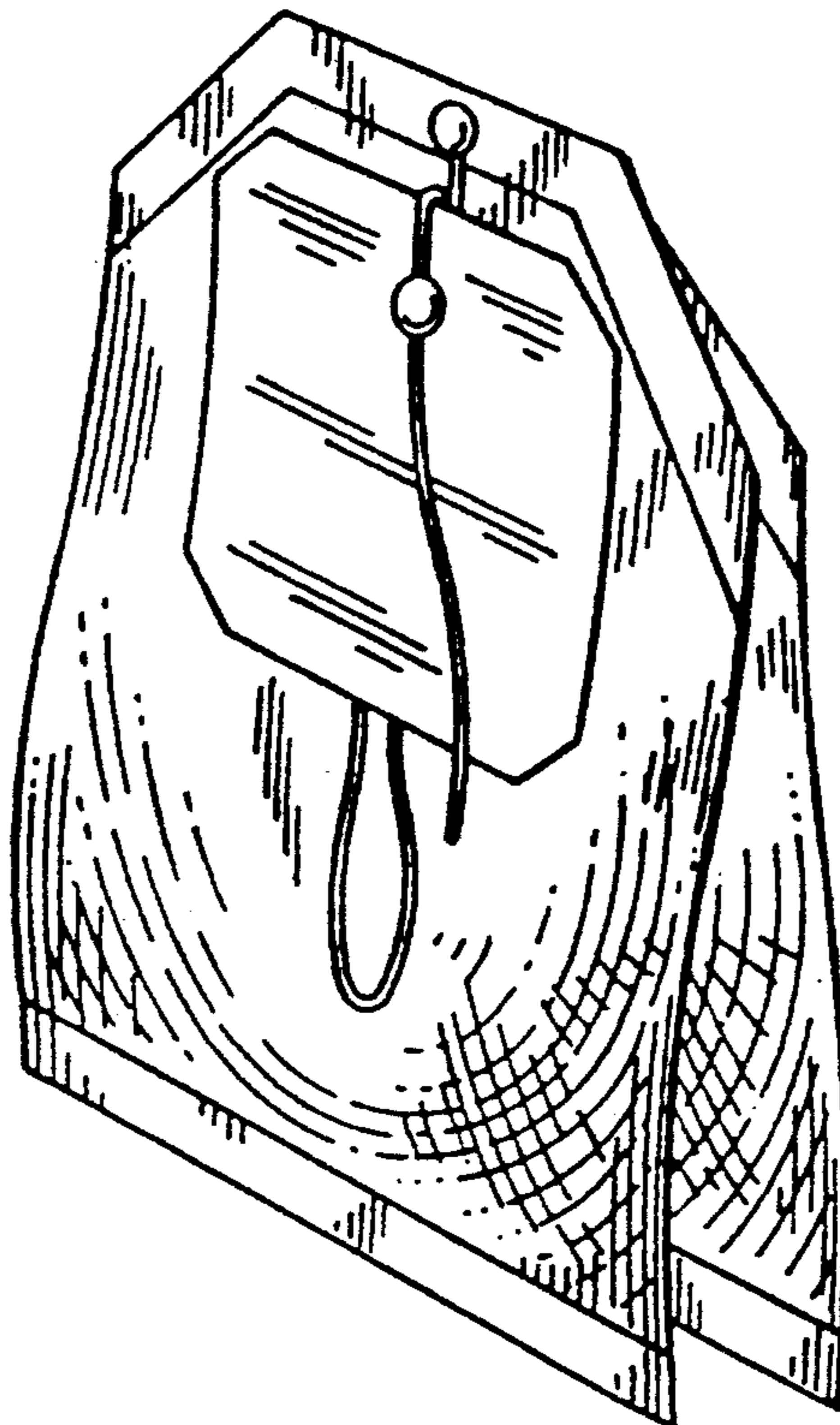

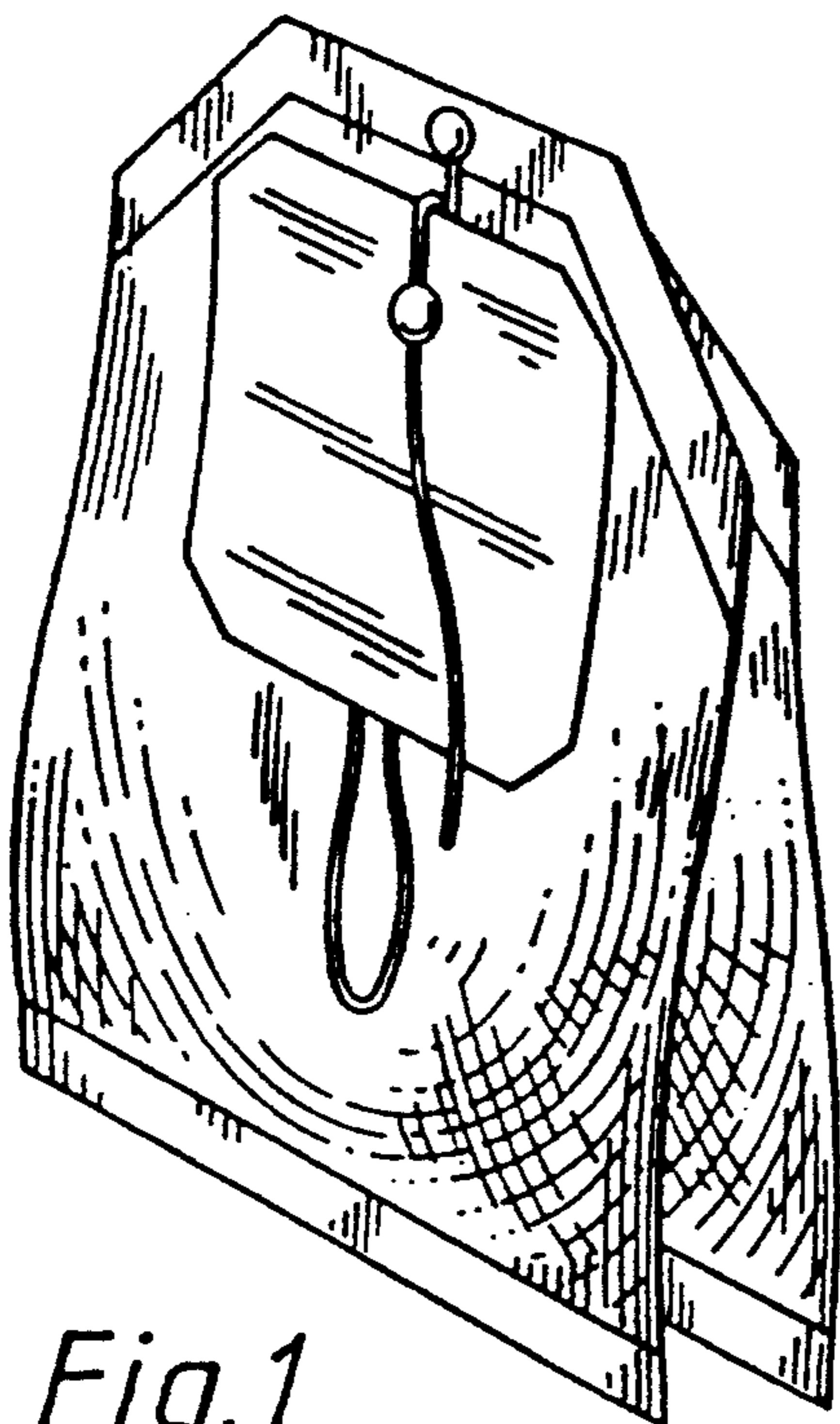
[57] **CLAIM**

The ornamental design for an infusion packet, as shown and described.

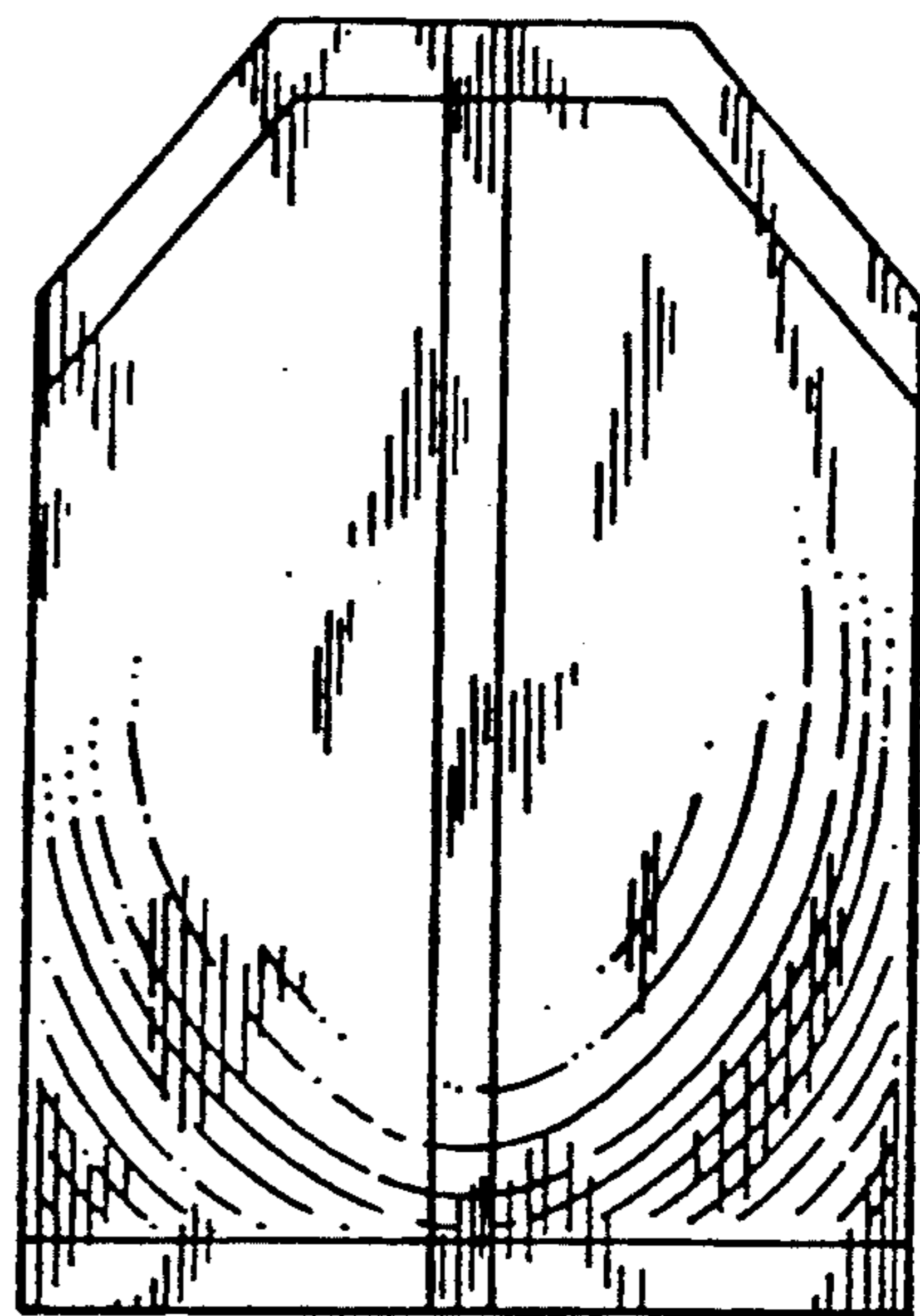
### DESCRIPTION

 FIG. 4 is a bottom plan view.

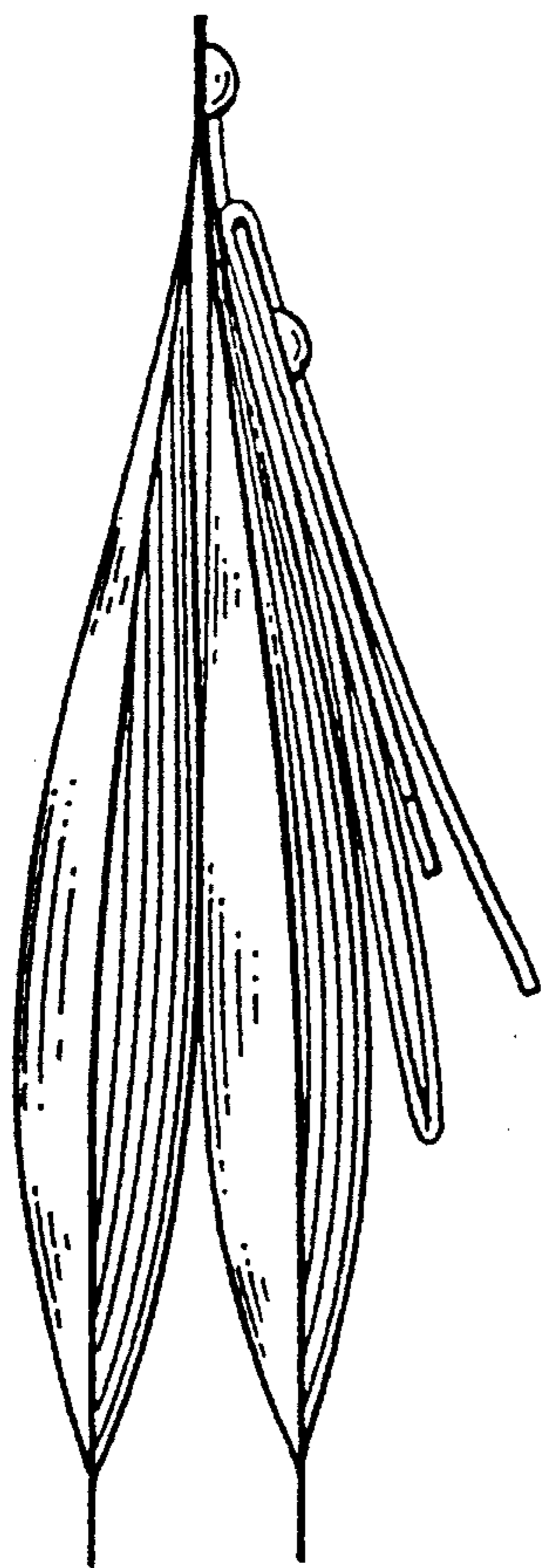




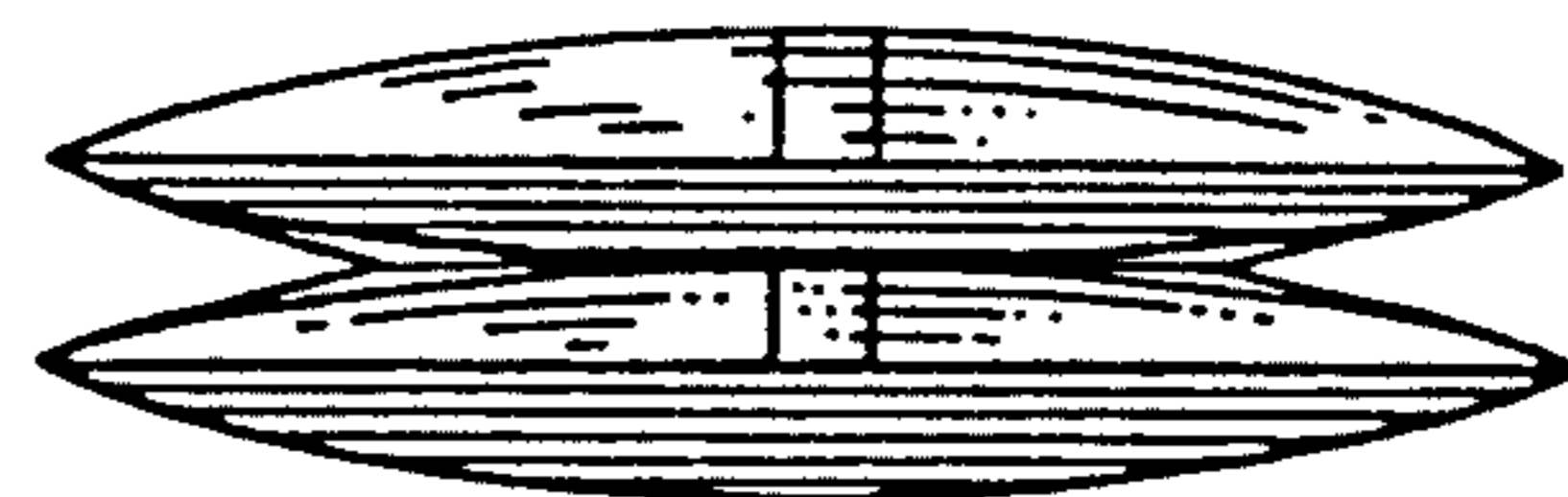
