The ornamental design for a writing instrument, as shown.

DESCRIPTION

FIG. 1 is a top, left front perspective view of a writing instrument showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof, the left side being a mirror image of the right side as shown;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

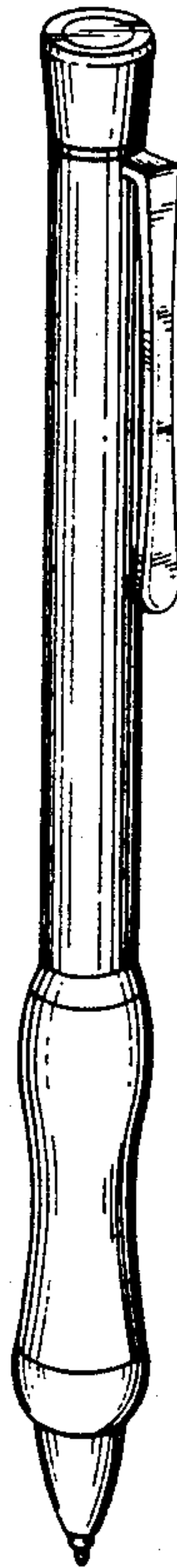

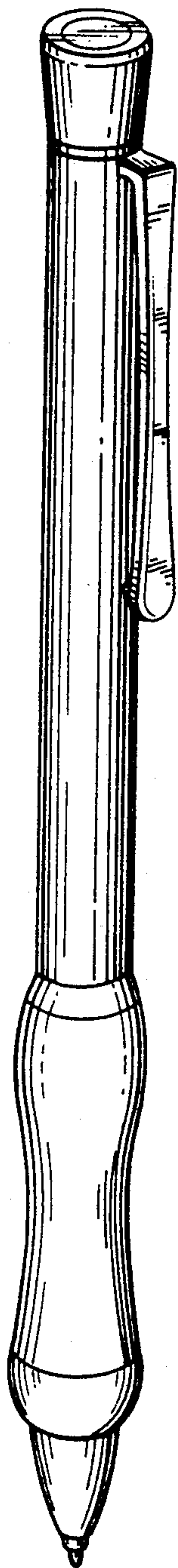

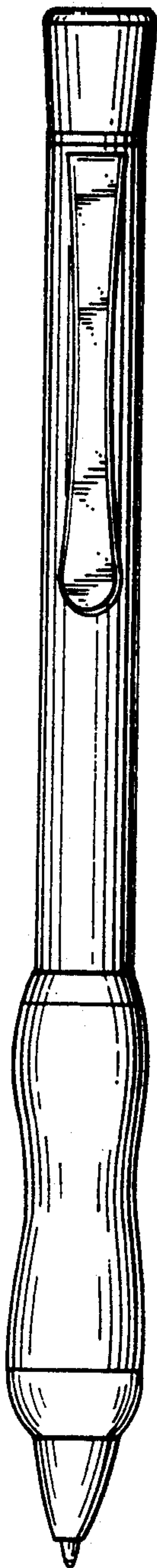

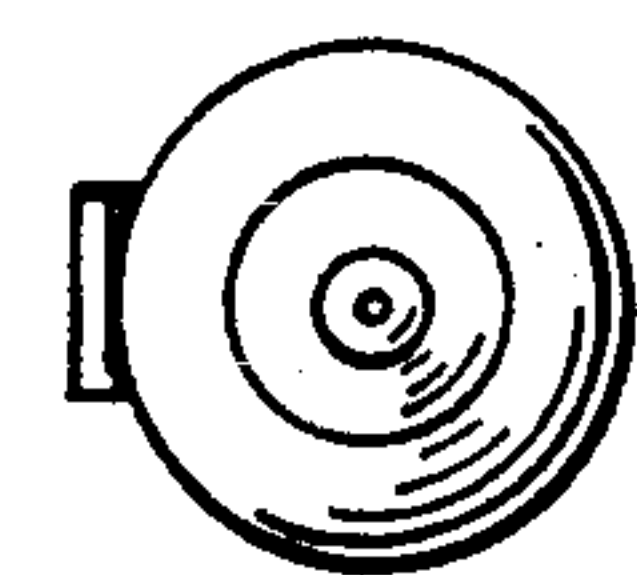
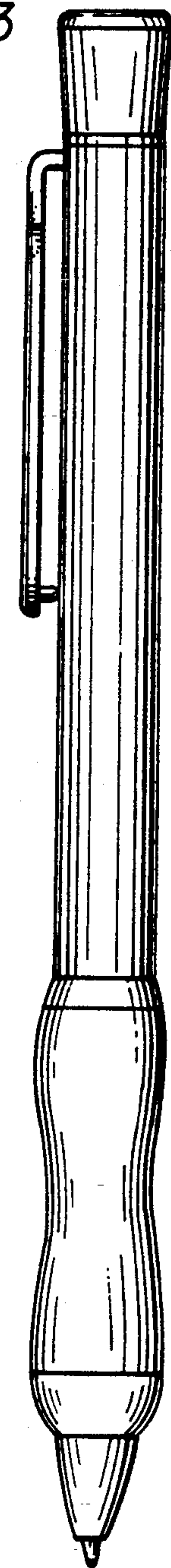

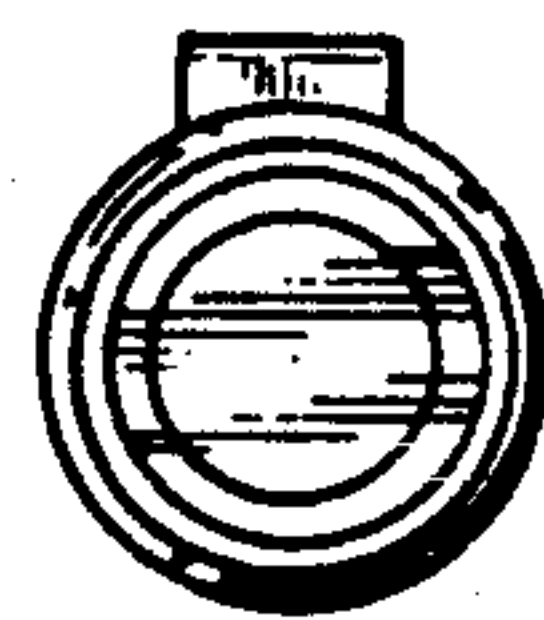
